FIG. 4 is a bottom plan view thereof;

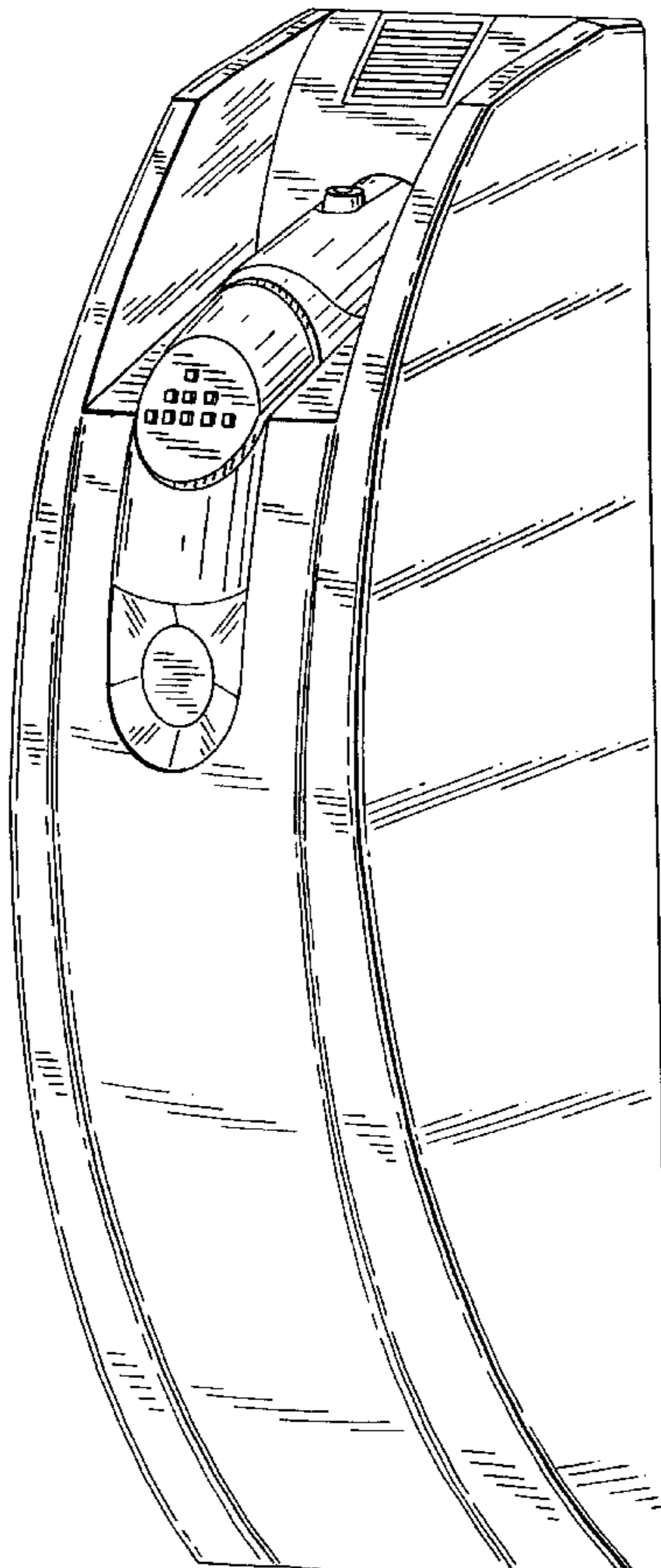
FIG. 5 is a perspective view thereof from the front right;

FIG. 6 is a rear plan thereof; and,

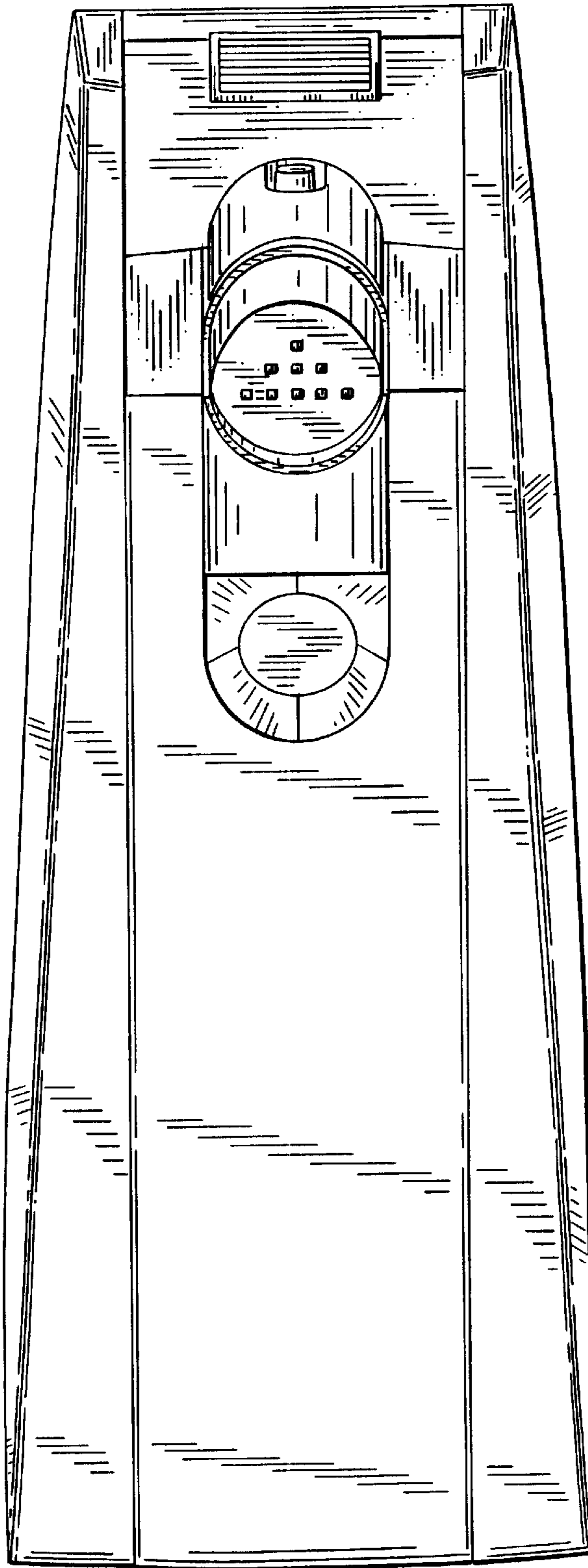
FIG. 7 is a top plan thereof.

The dispenser is for use for example in the bathroom or kitchen. The dispenser can be filled with soap, shampoo, or other products related to personal hygiene or cleaning.

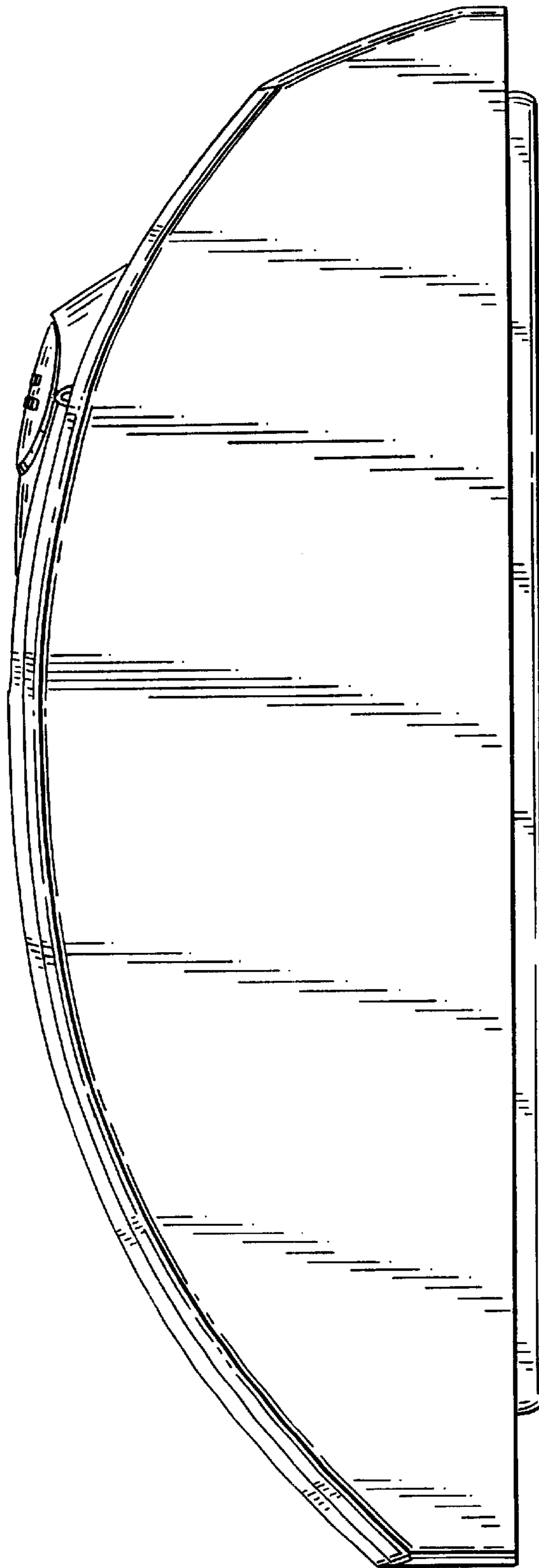

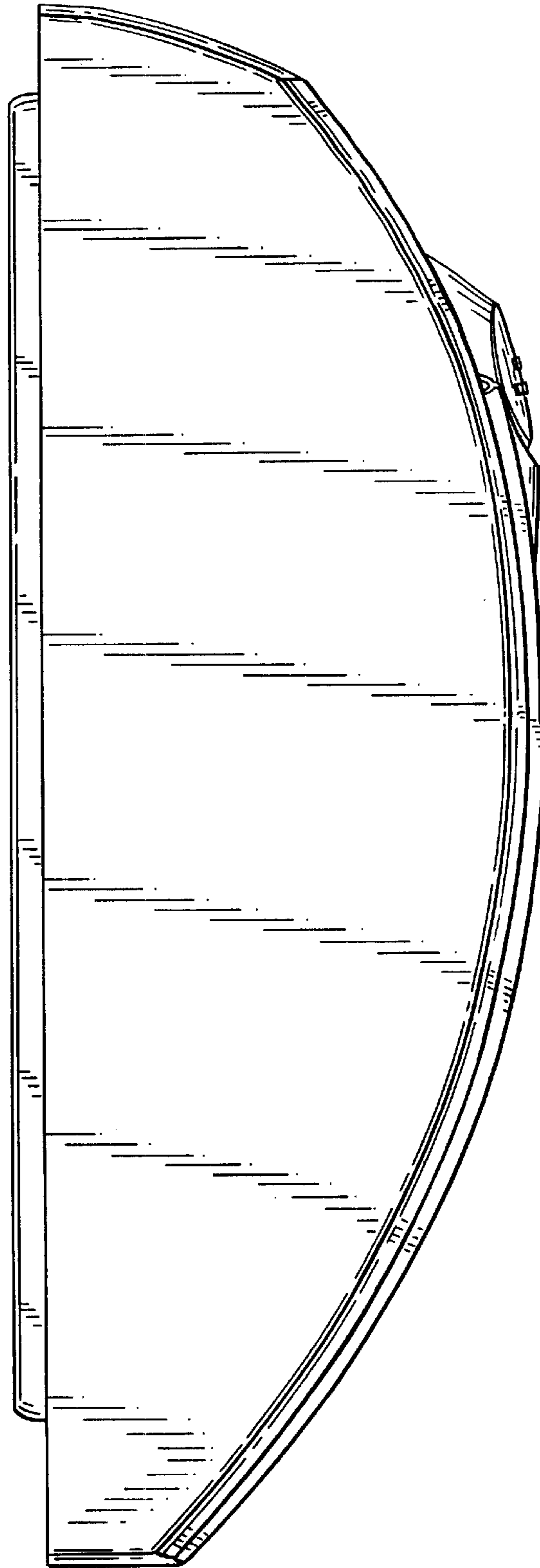

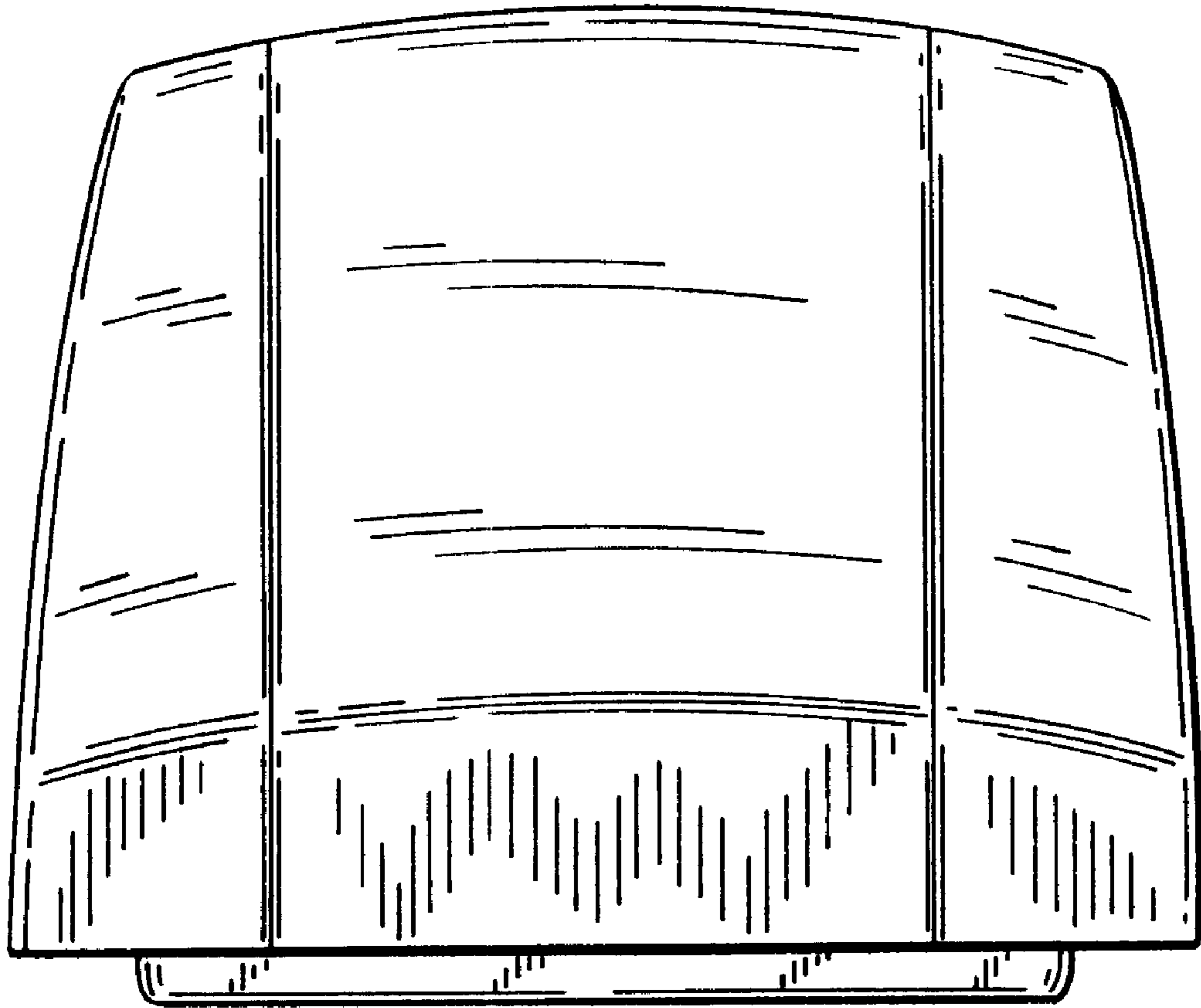

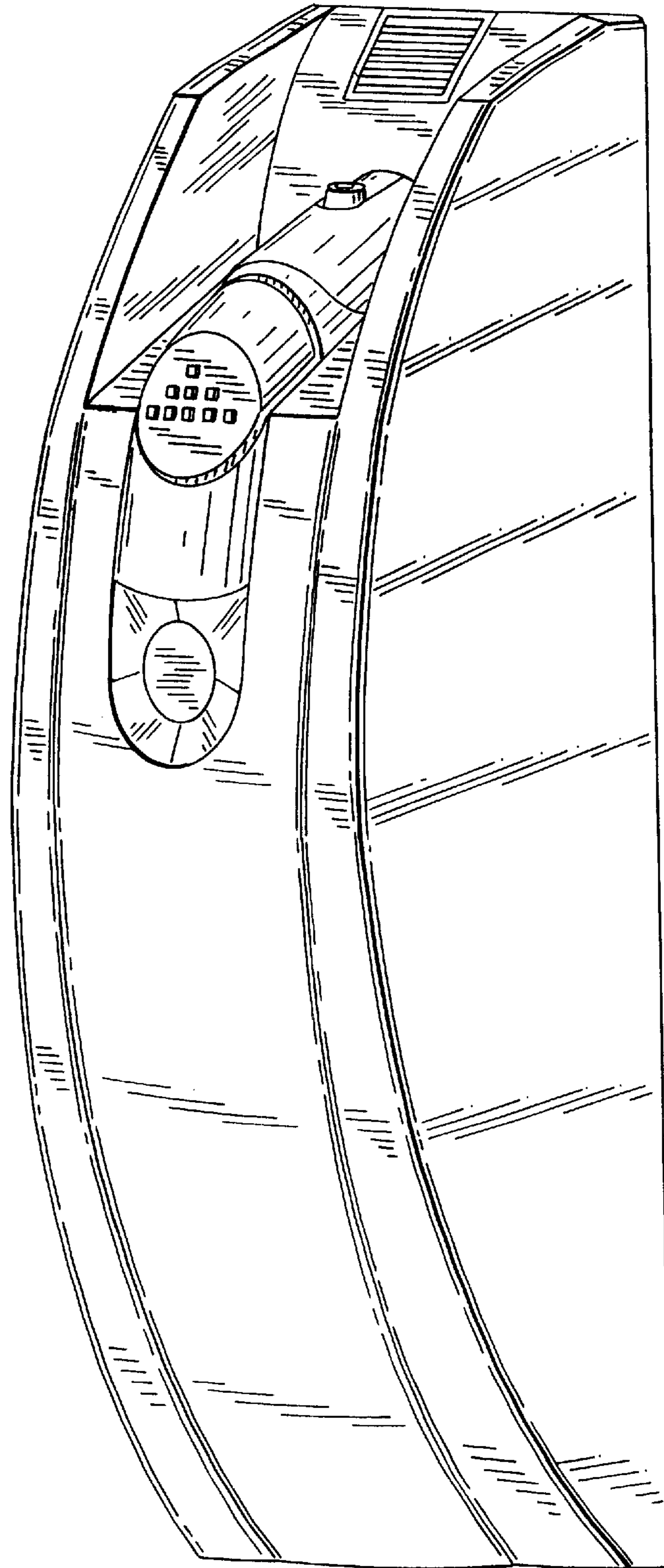

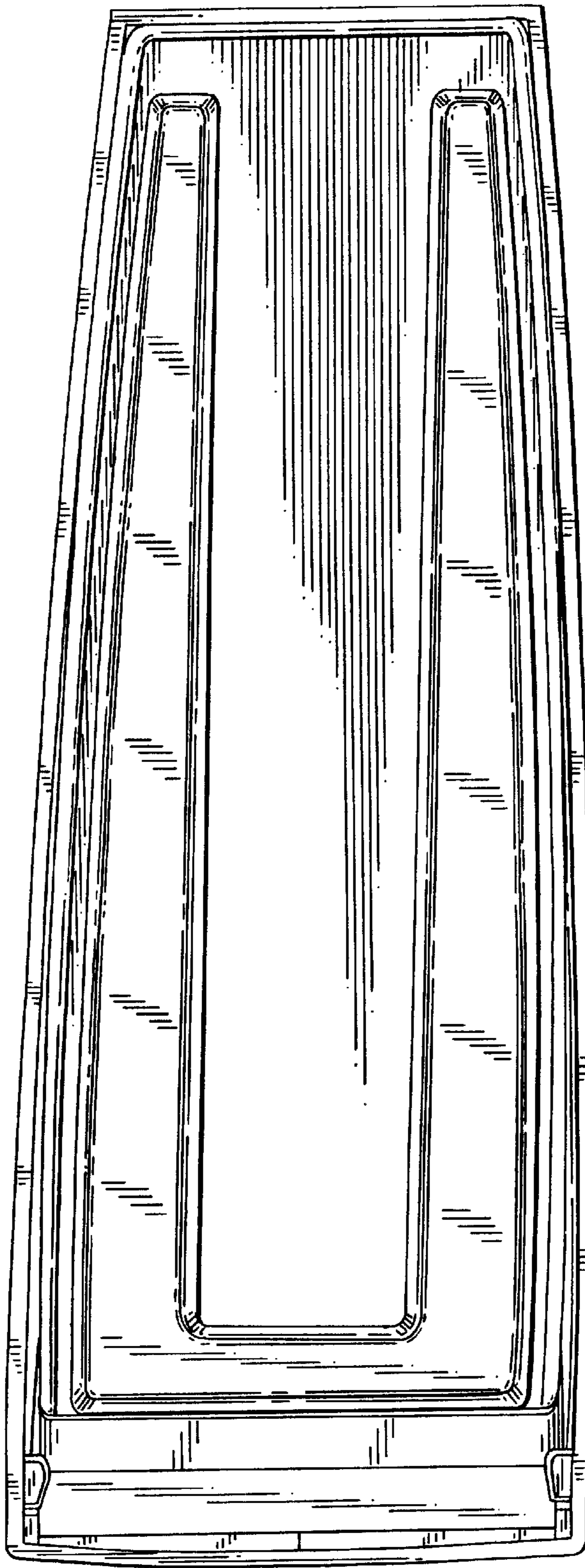
