The ornamental design for a handle for a utensil, as shown and described.

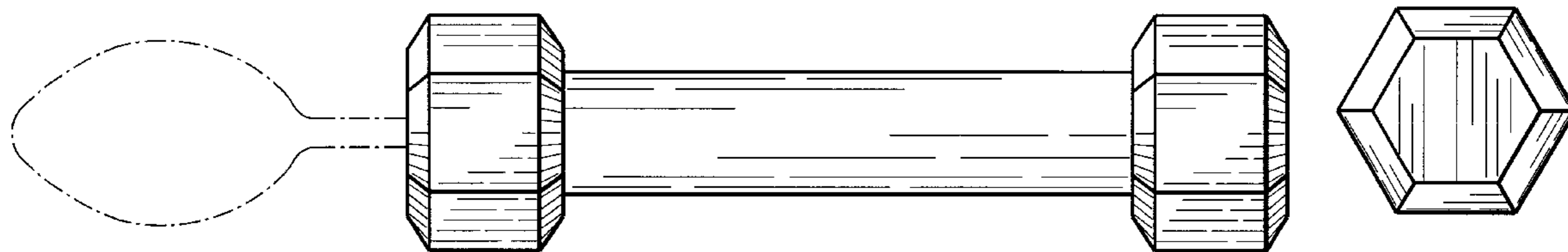
**DESCRIPTION**

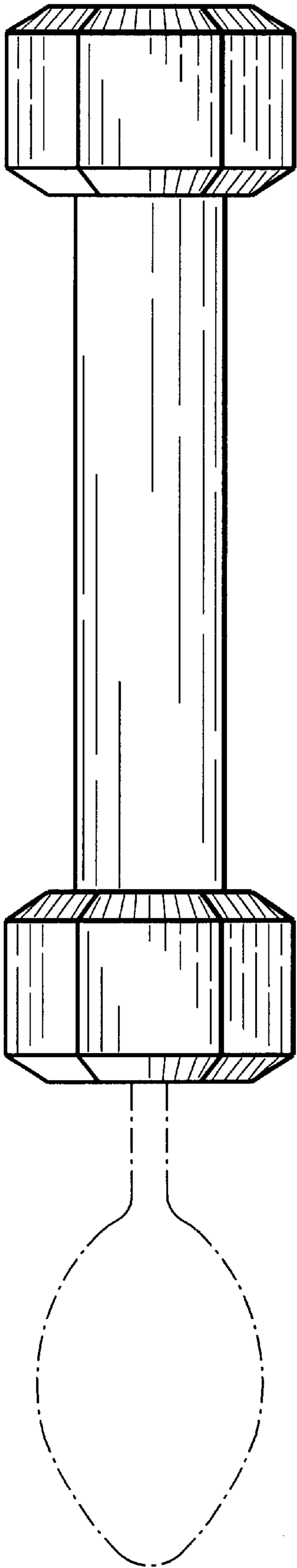
FIG. 1 is a top view of a handle for a utensil, showing environmental structure comprising a spoon;

The broken lines showing a spoon, fork, and knife in FIGS. 1-16 are for illustrative purposes only and form no part of the claimed design.

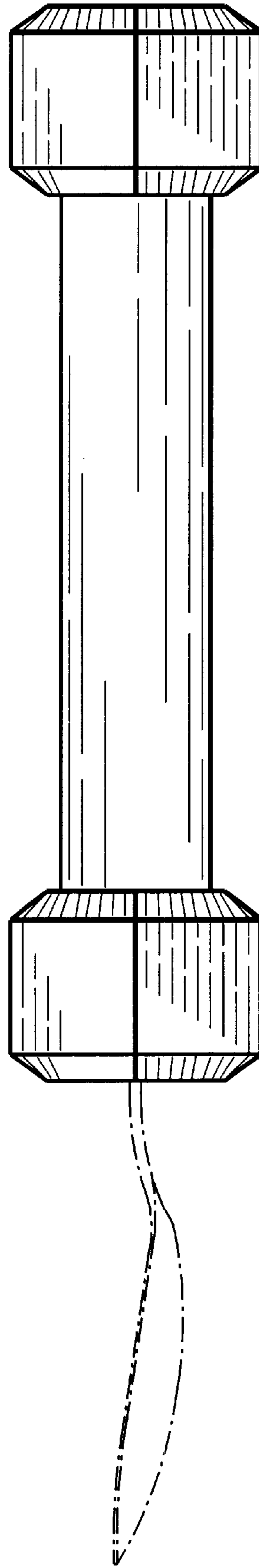
FIGS. 11-16 are drawn on a reduced scale from FIGS. 1-10.

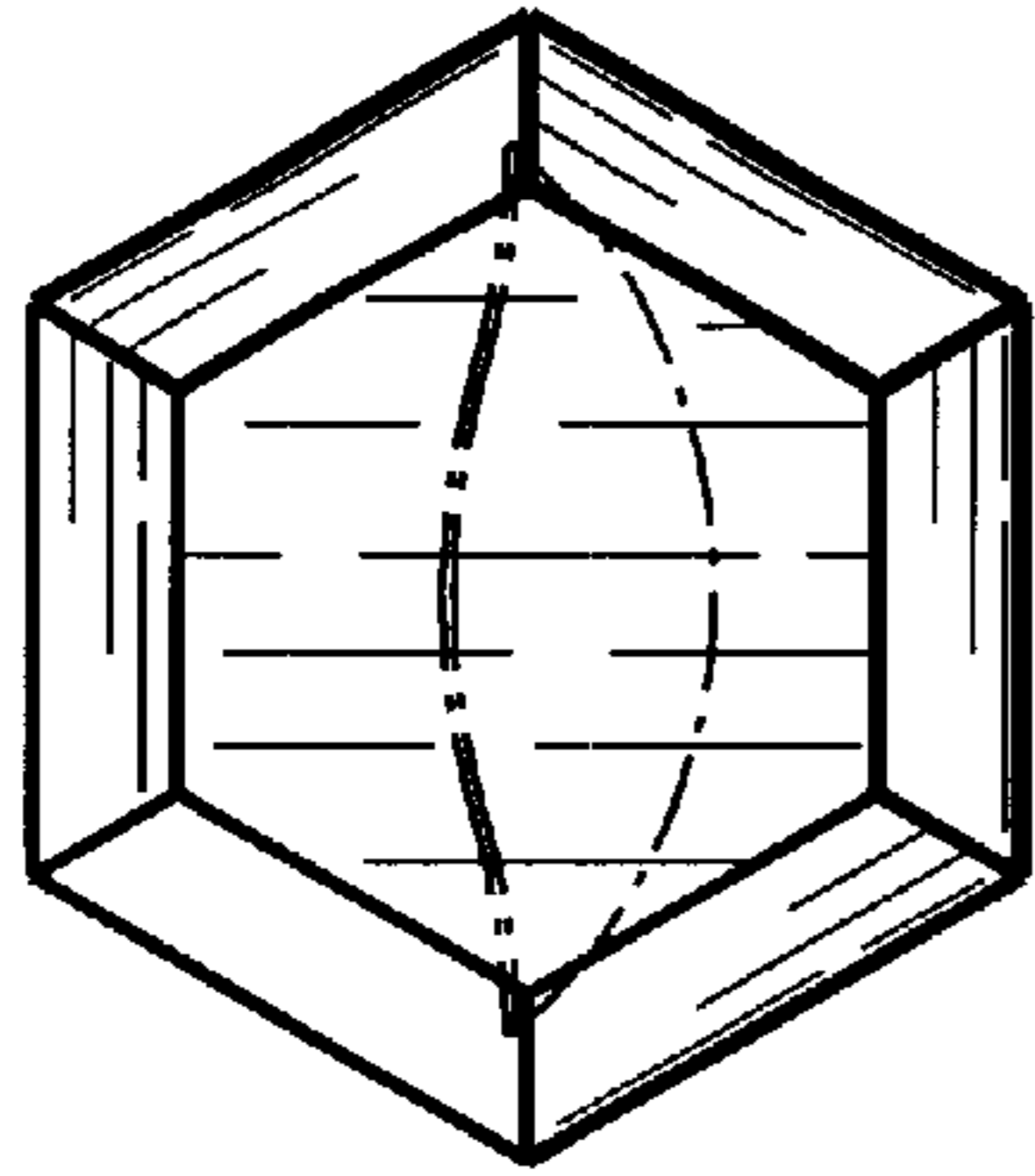

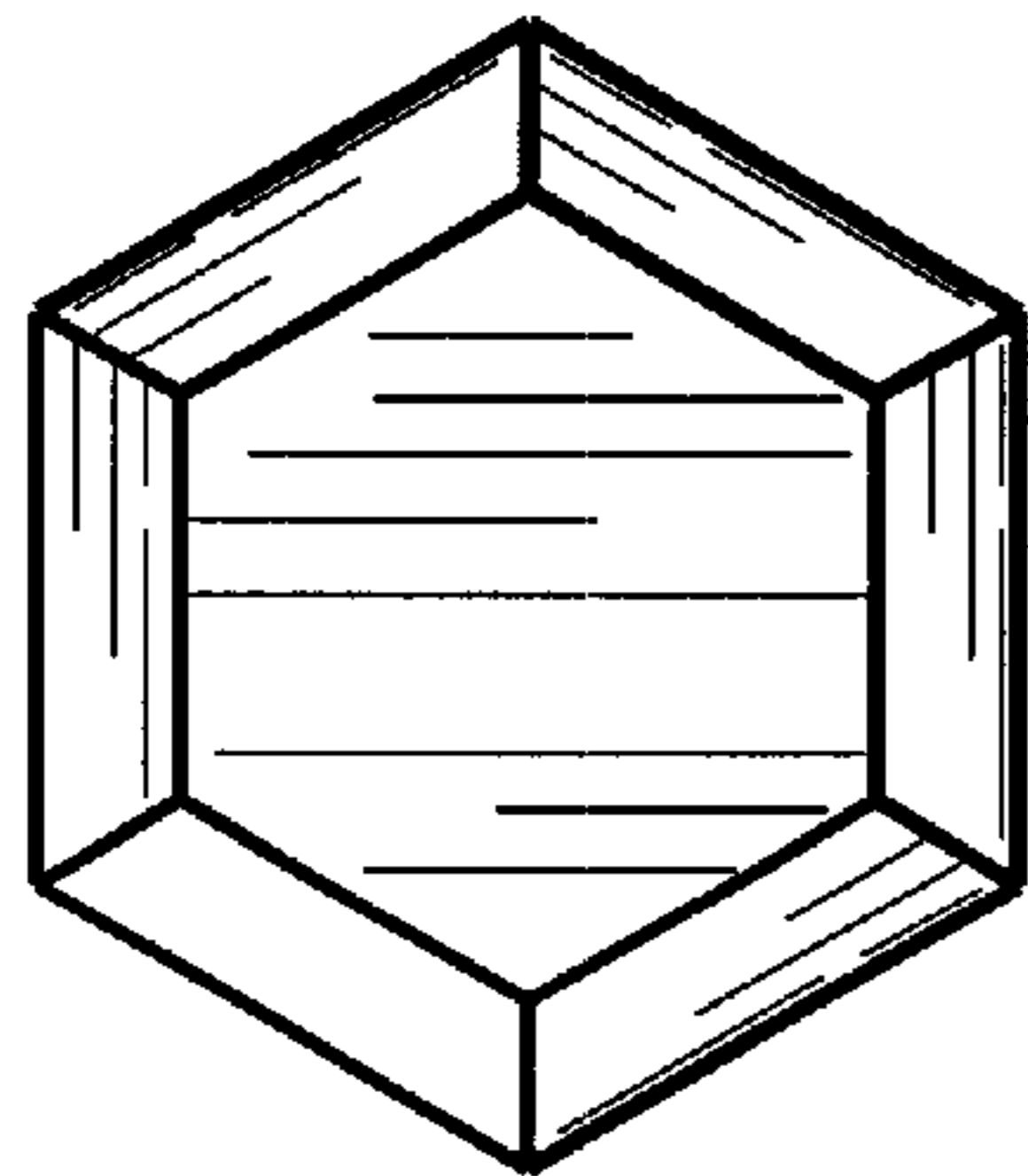

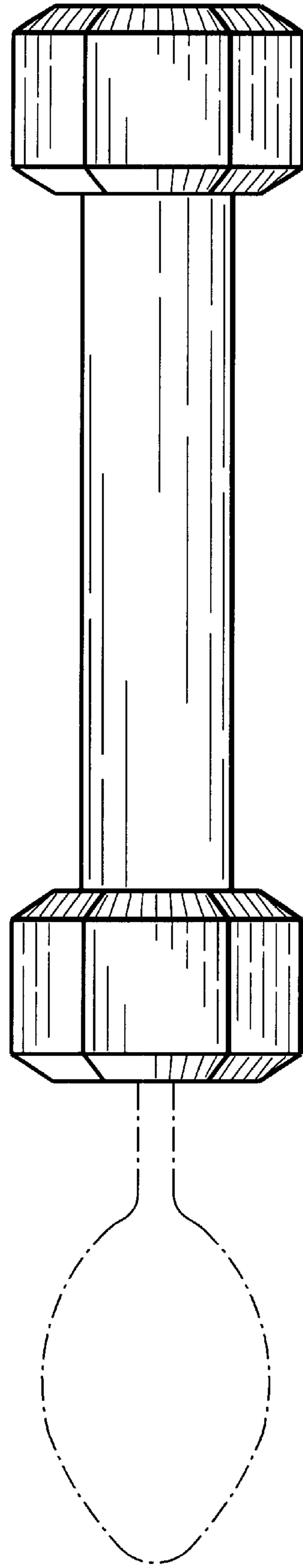
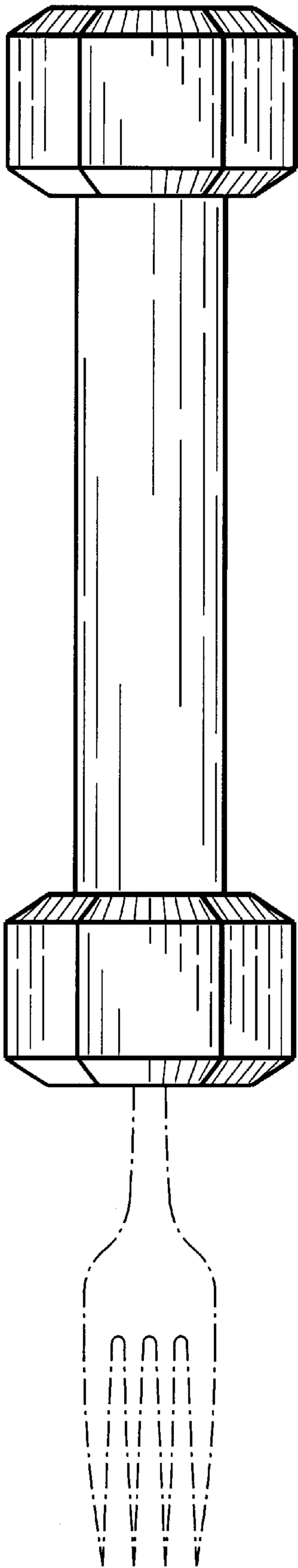
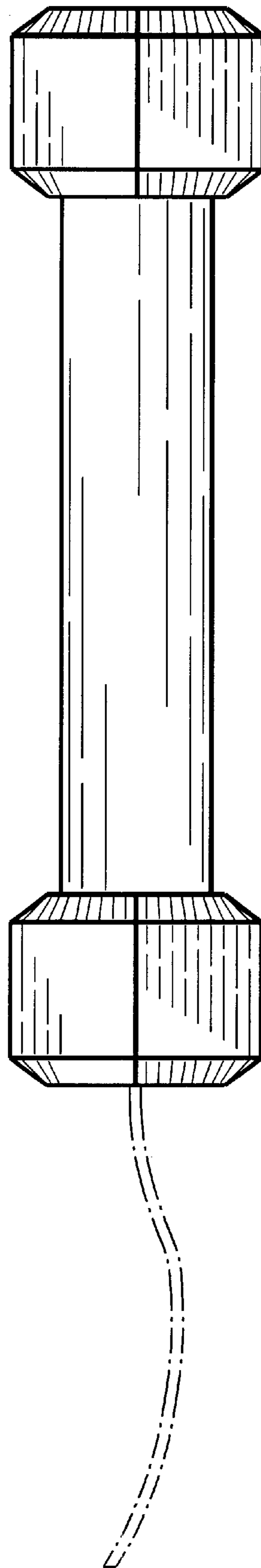

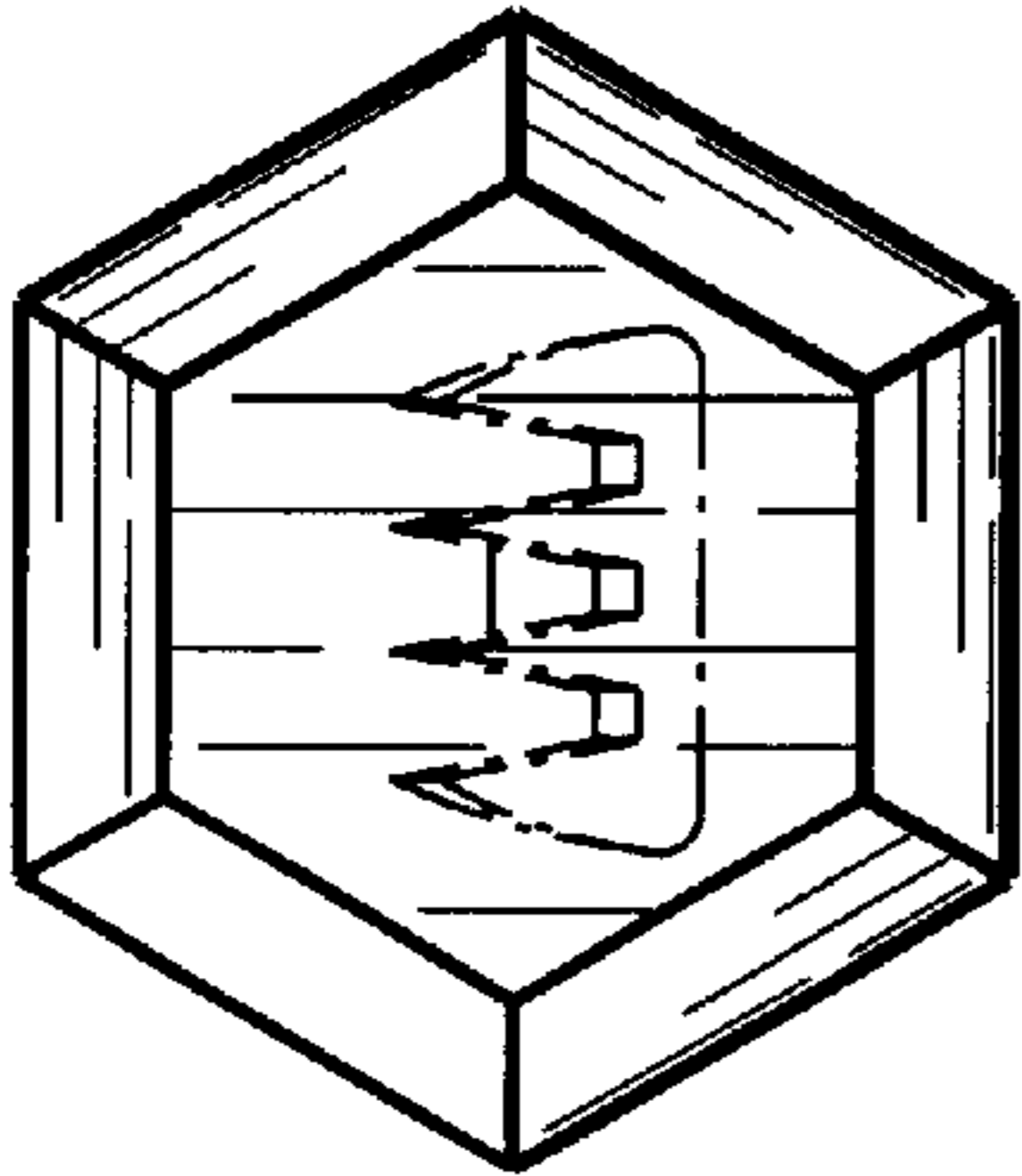

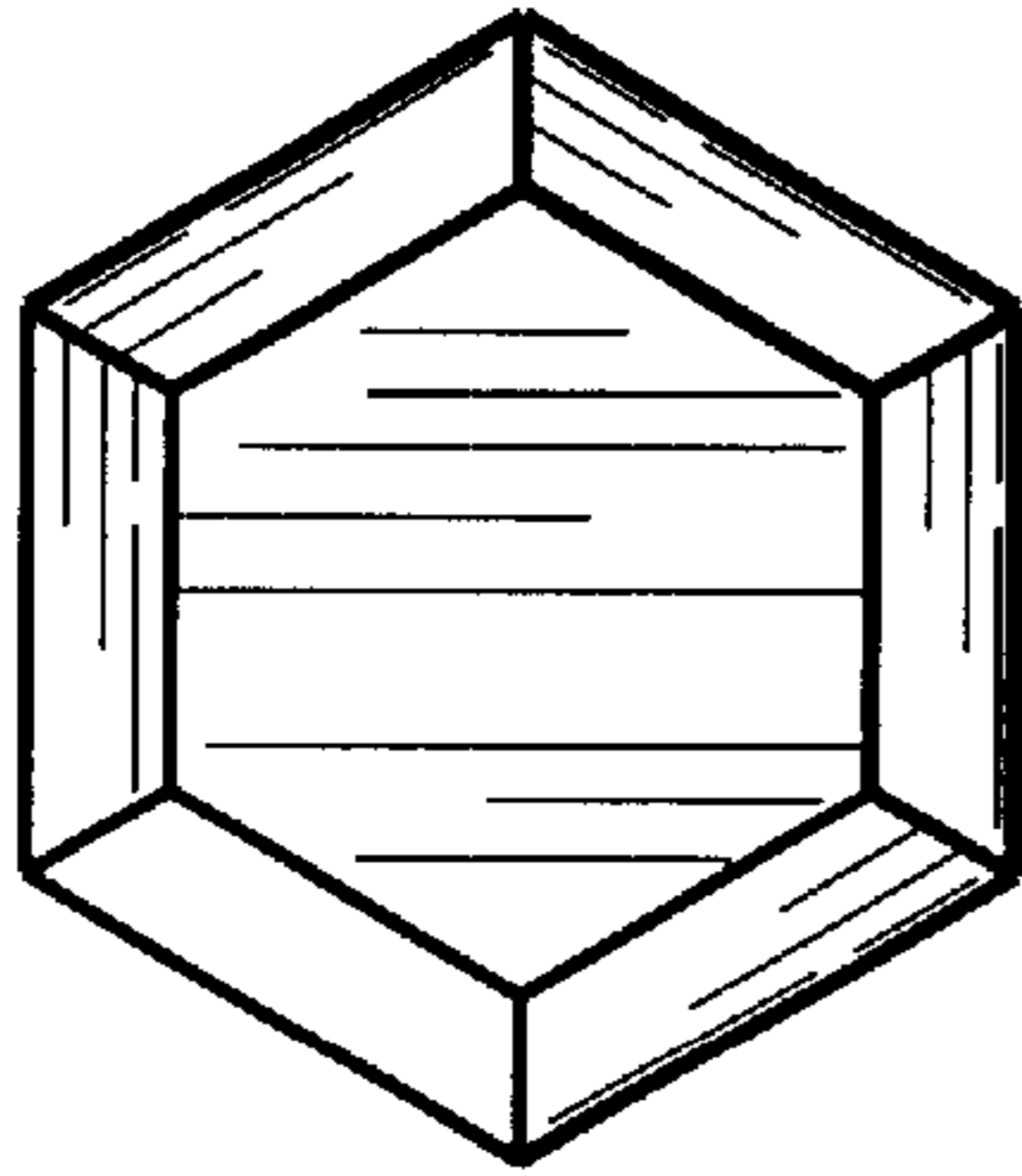

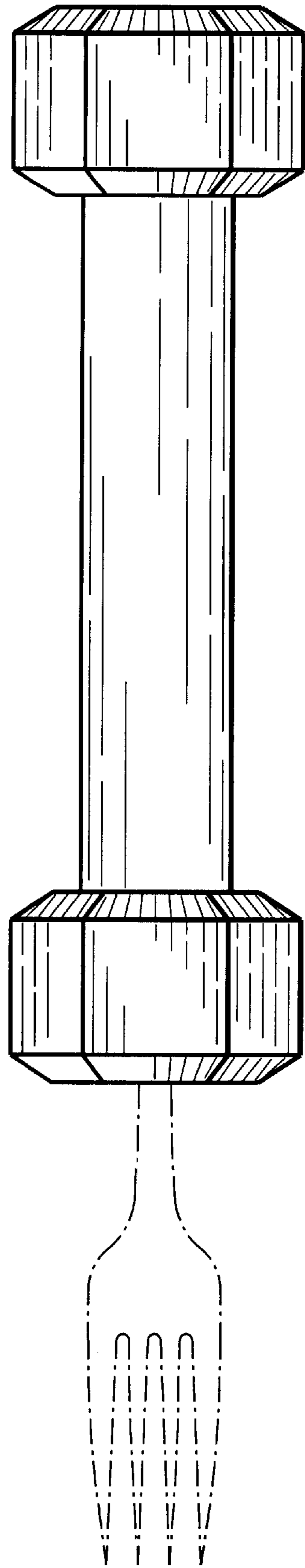
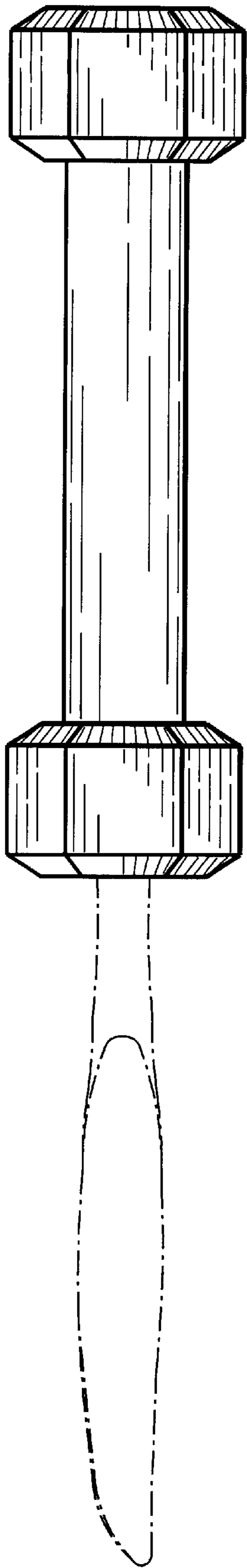
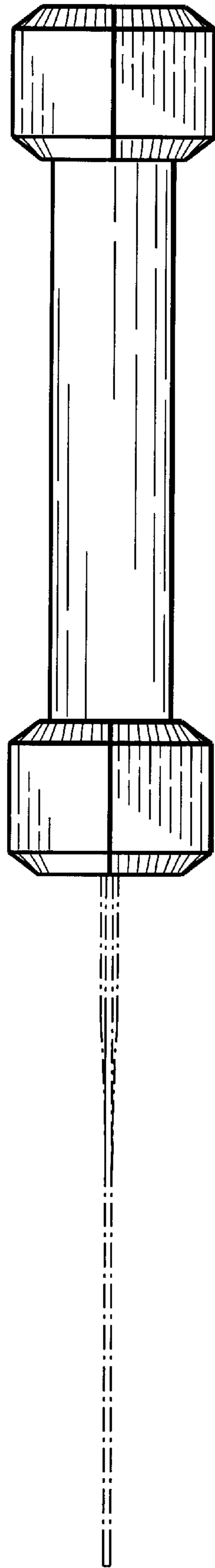

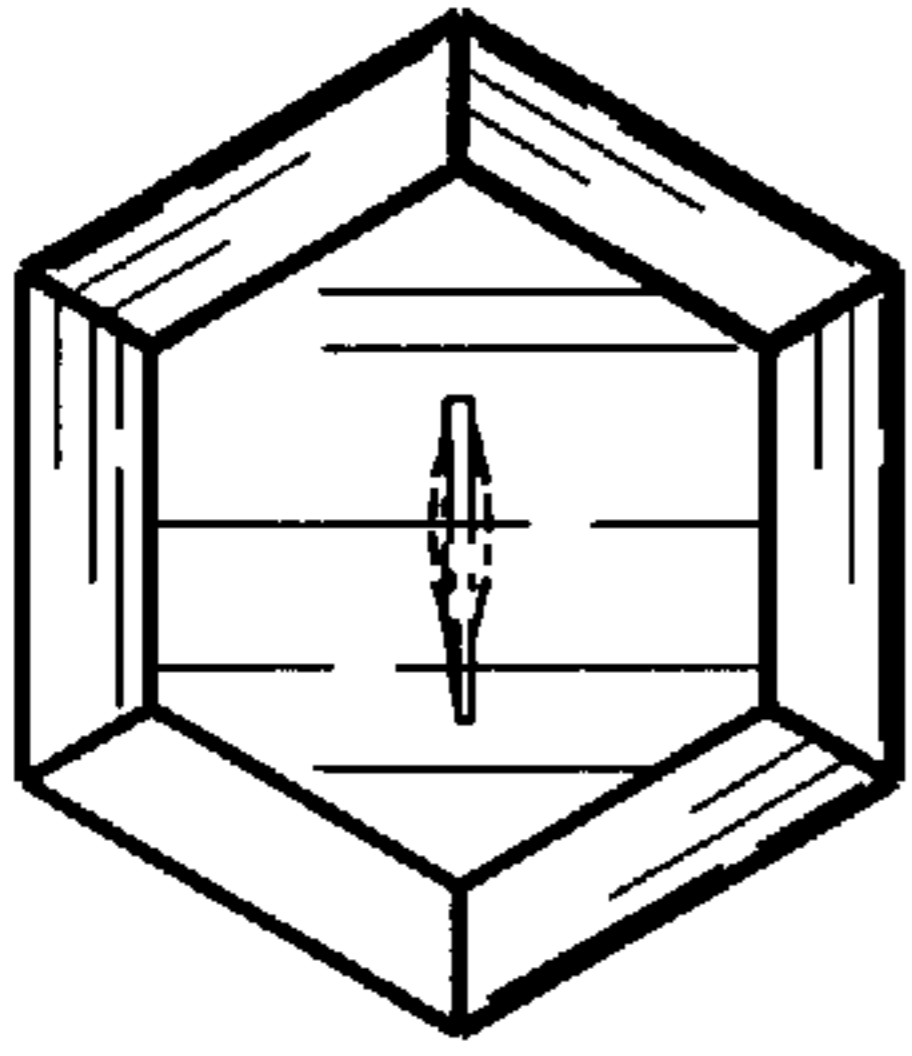

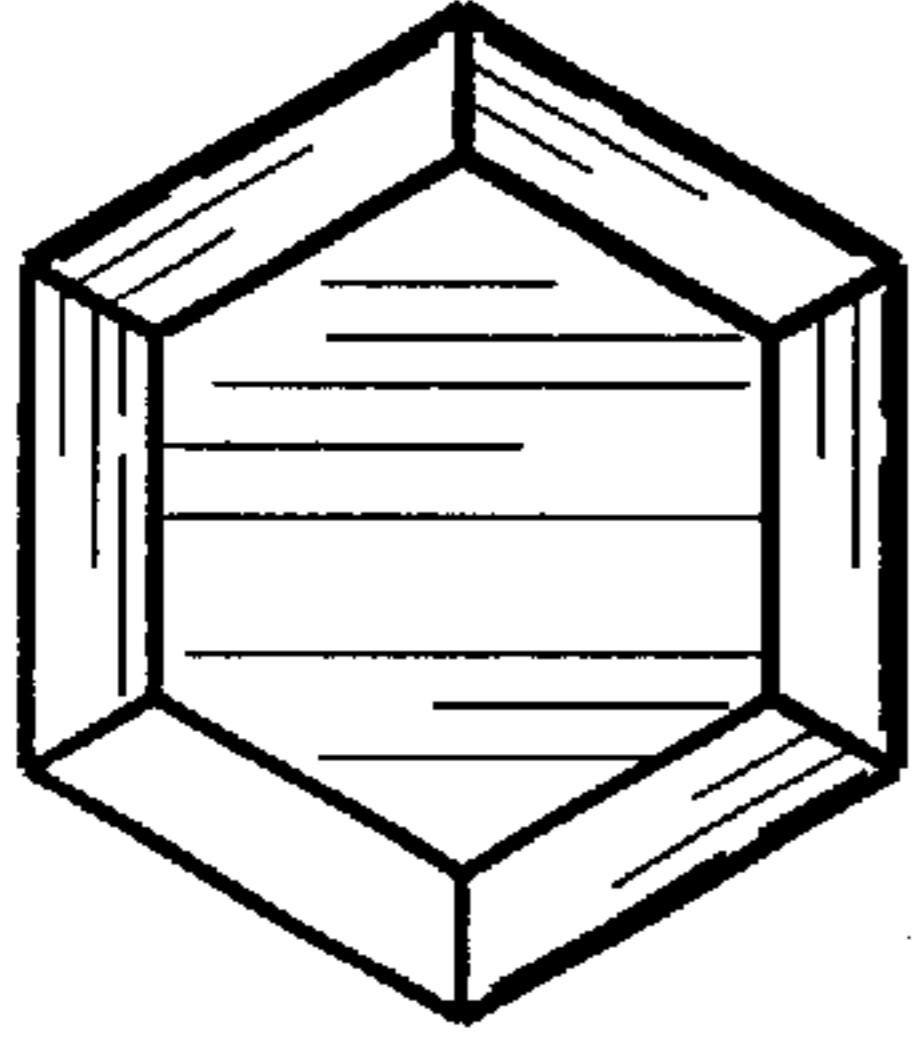

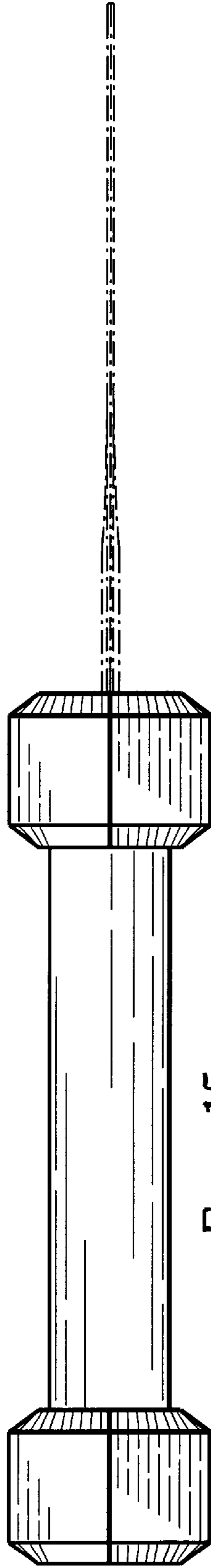

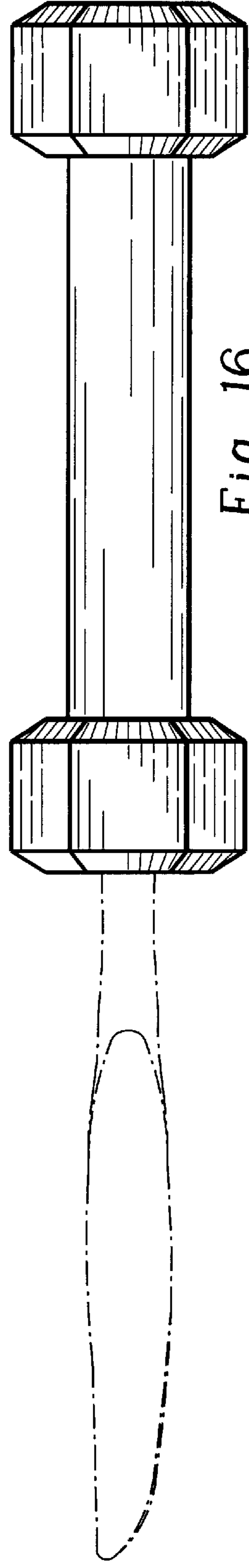
