(57) **CLAIM**

The ornamental design for a utility lighter, as shown and described in the attached drawings.

DESCRIPTION

FIG. 1 is a back perspective view of a utility lighter illustrating my new design, wherein the lighter is in a closed position;

FIG. 2 is a front, perspective view of the utility lighter in FIG. 1;

FIG. 3 is a back view of the utility lighter shown in FIG. 1; FIG. 4 is another front, perspective view of the utility lighter shown in FIG. 1;

FIG. 5 is a top view of the utility lighter shown in FIG. 1; FIG. 6 is a bottom view of the utility lighter shown in FIG. 1;

FIG. 7 is an end view of the utility lighter shown in FIG. 1; FIG. 8 is the other view of the utility lighter shown in FIG. 1;

FIG. 9 is a back perspective view of the utility lighter in FIG. 1, wherein the lighter is in an open position;

FIG. 10 is a back view of the utility lighter in FIG. 9; and, FIG. 11 is a side view of the utility lighter shown in FIG. 9.

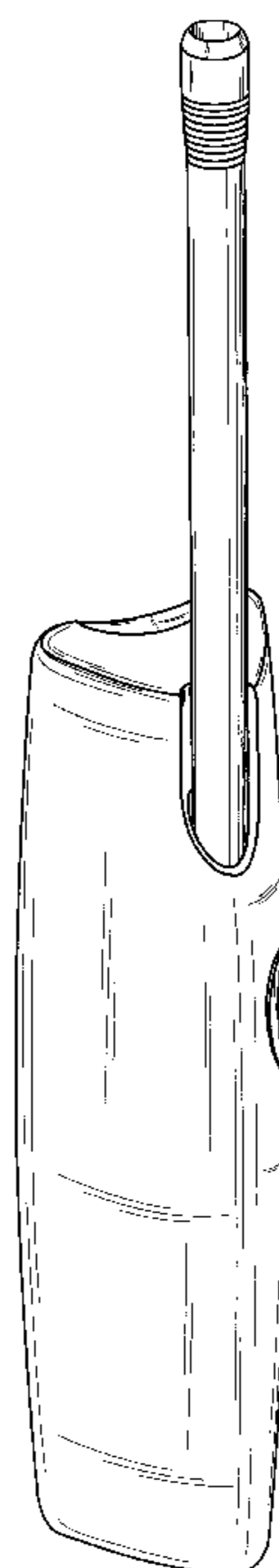

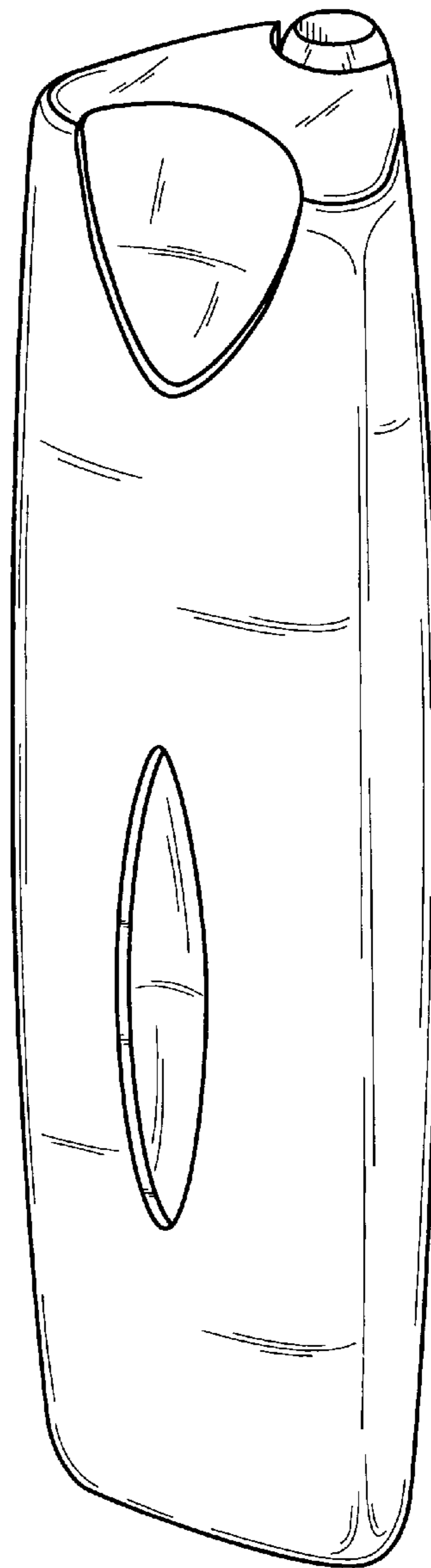

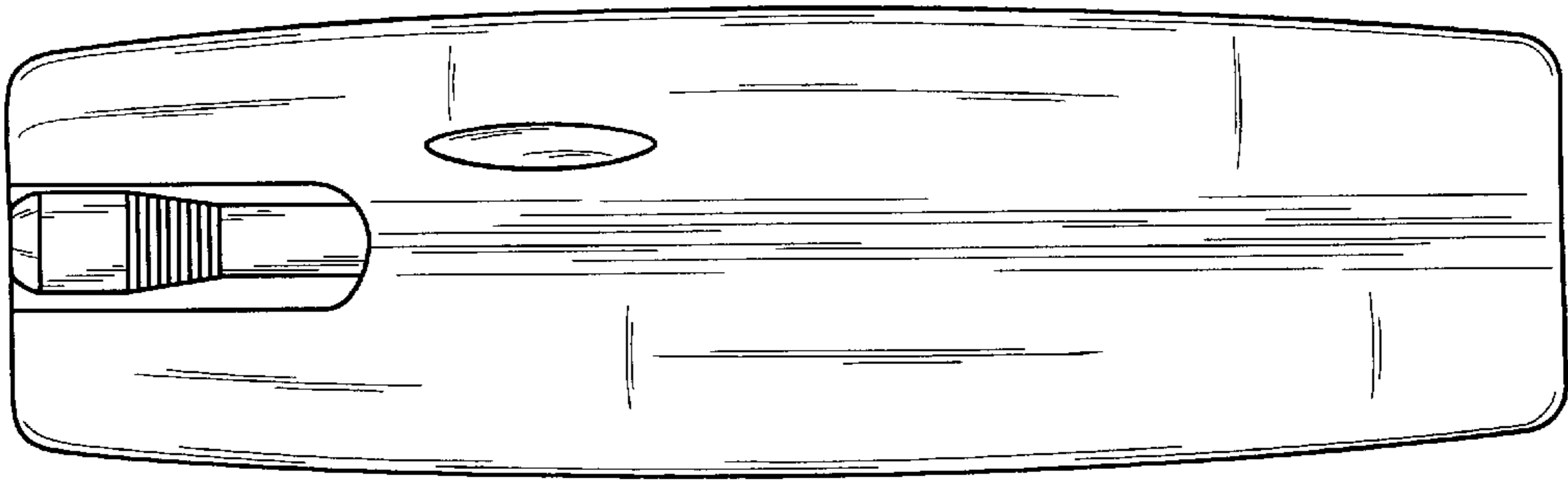

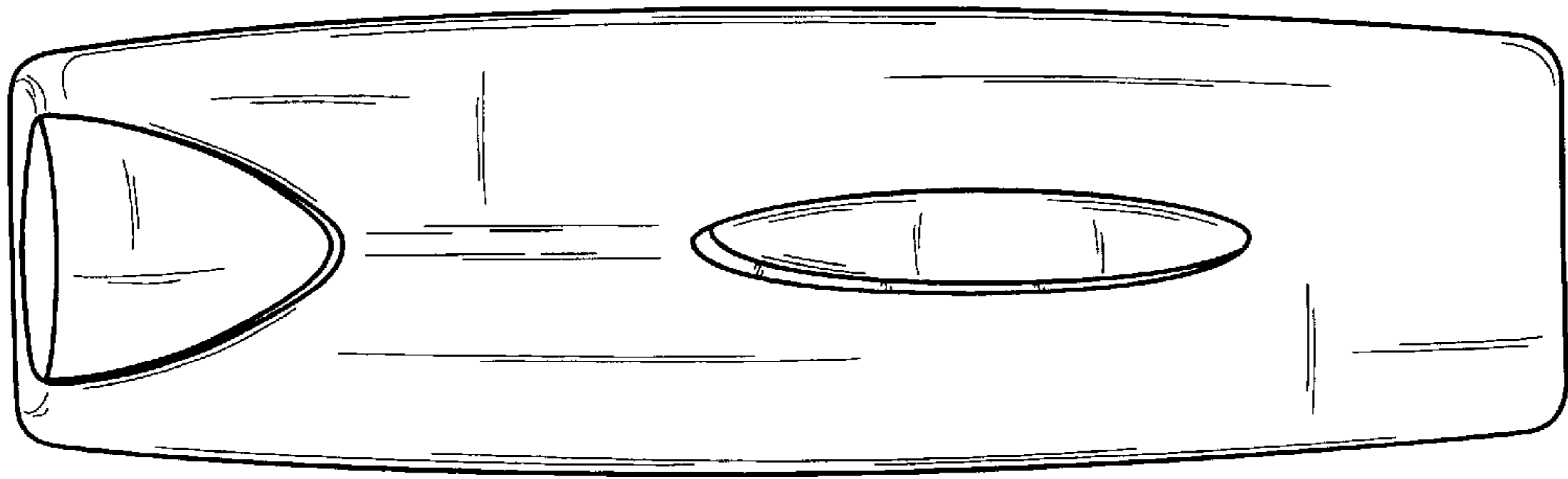

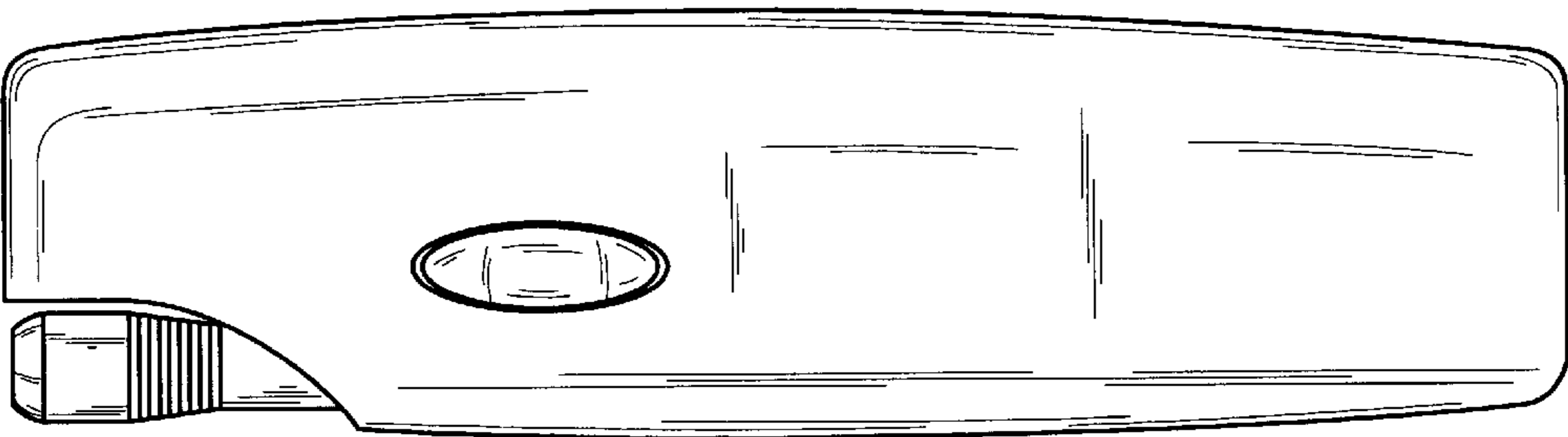

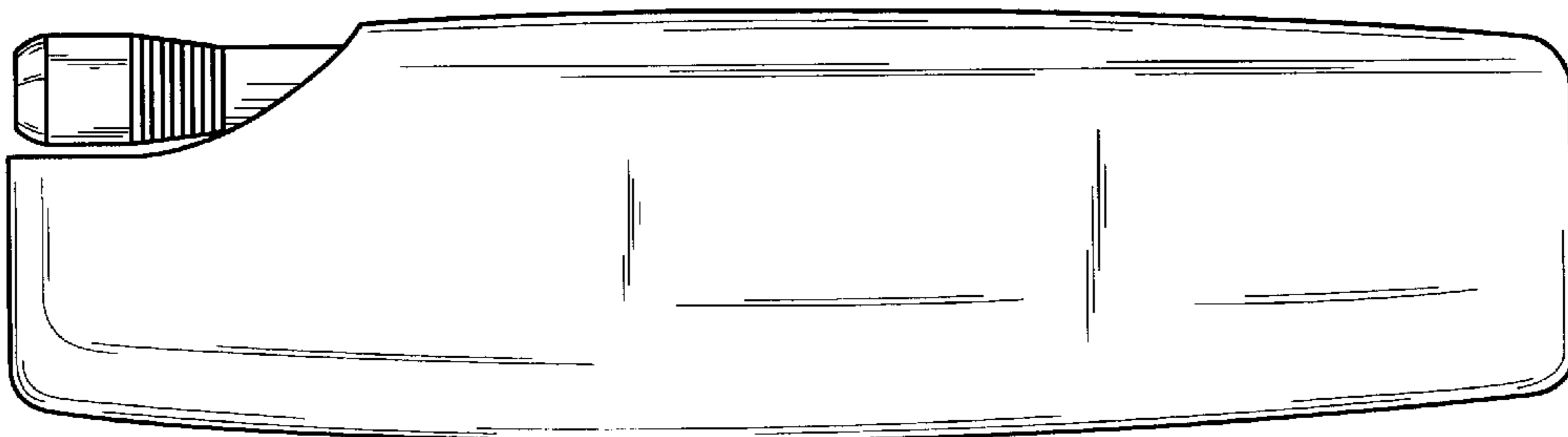

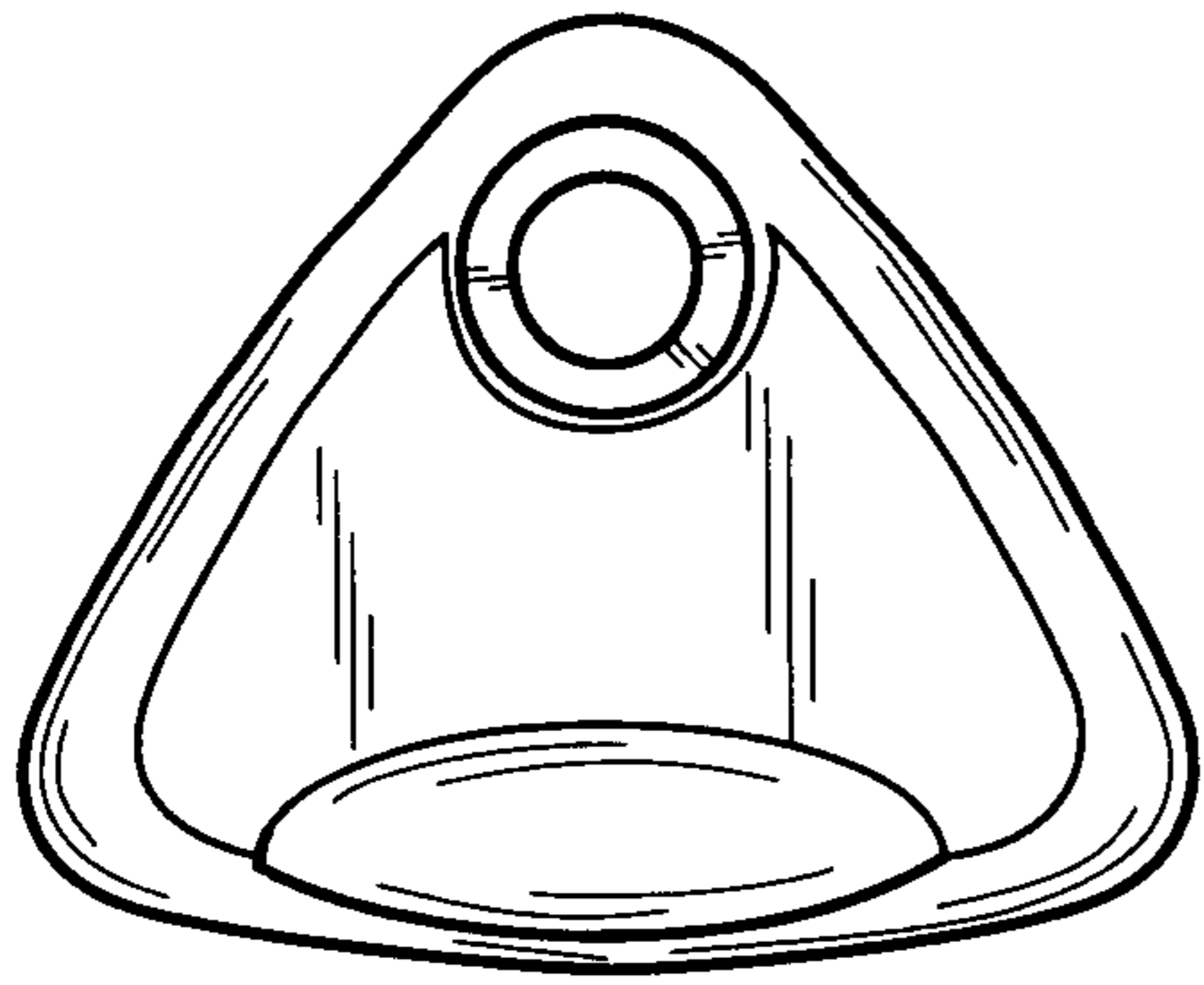

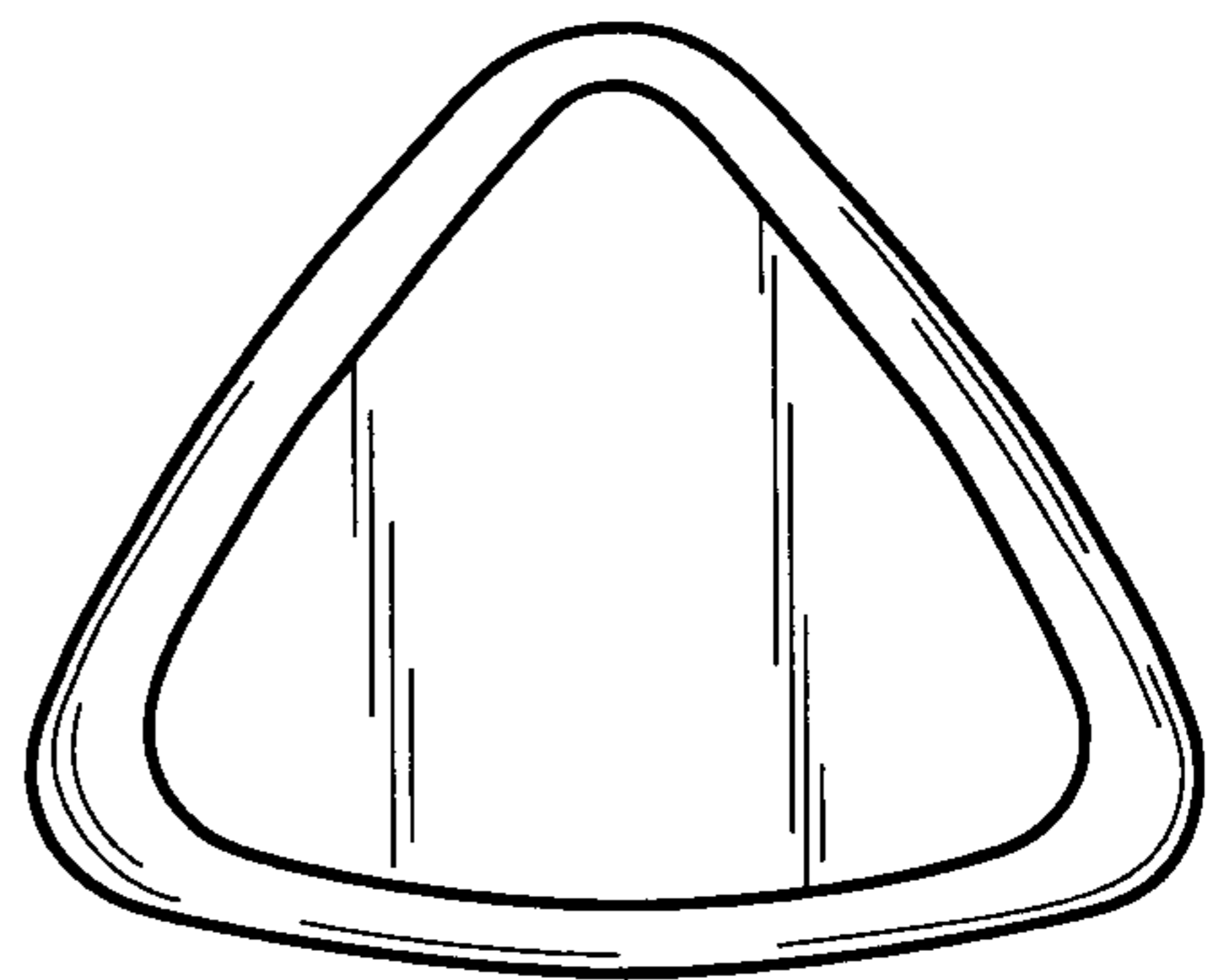

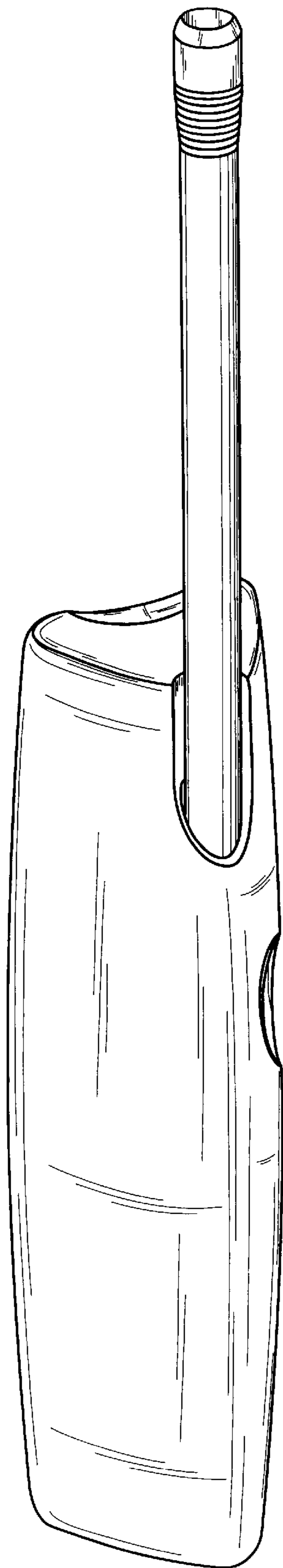

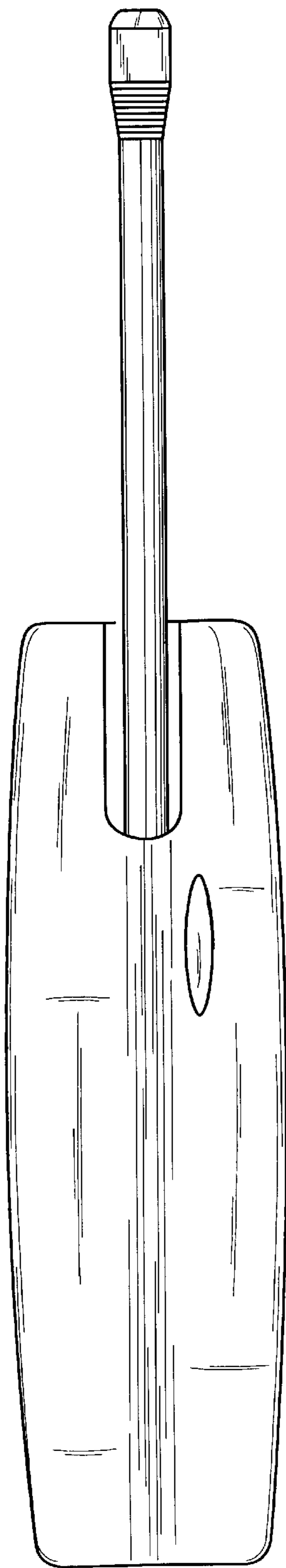

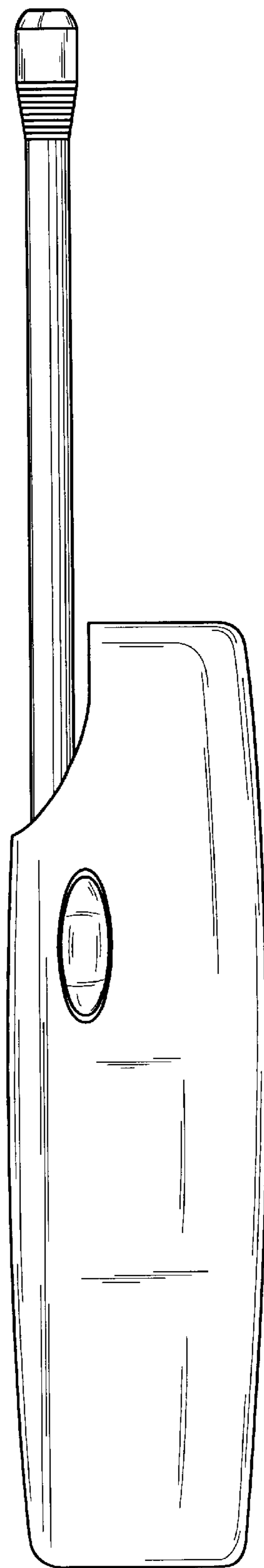
