(57) **CLAIM**

The ornamental design for a sweat band with identifier, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a sweat band with identifier shown in condition of use on a human arm;

FIG. 2 is a top plan view thereof.

FIG. 3 is a bottom plan view thereof; and,

FIG. 4 is a rear perspective view thereof shown in condition of use on a human arm.

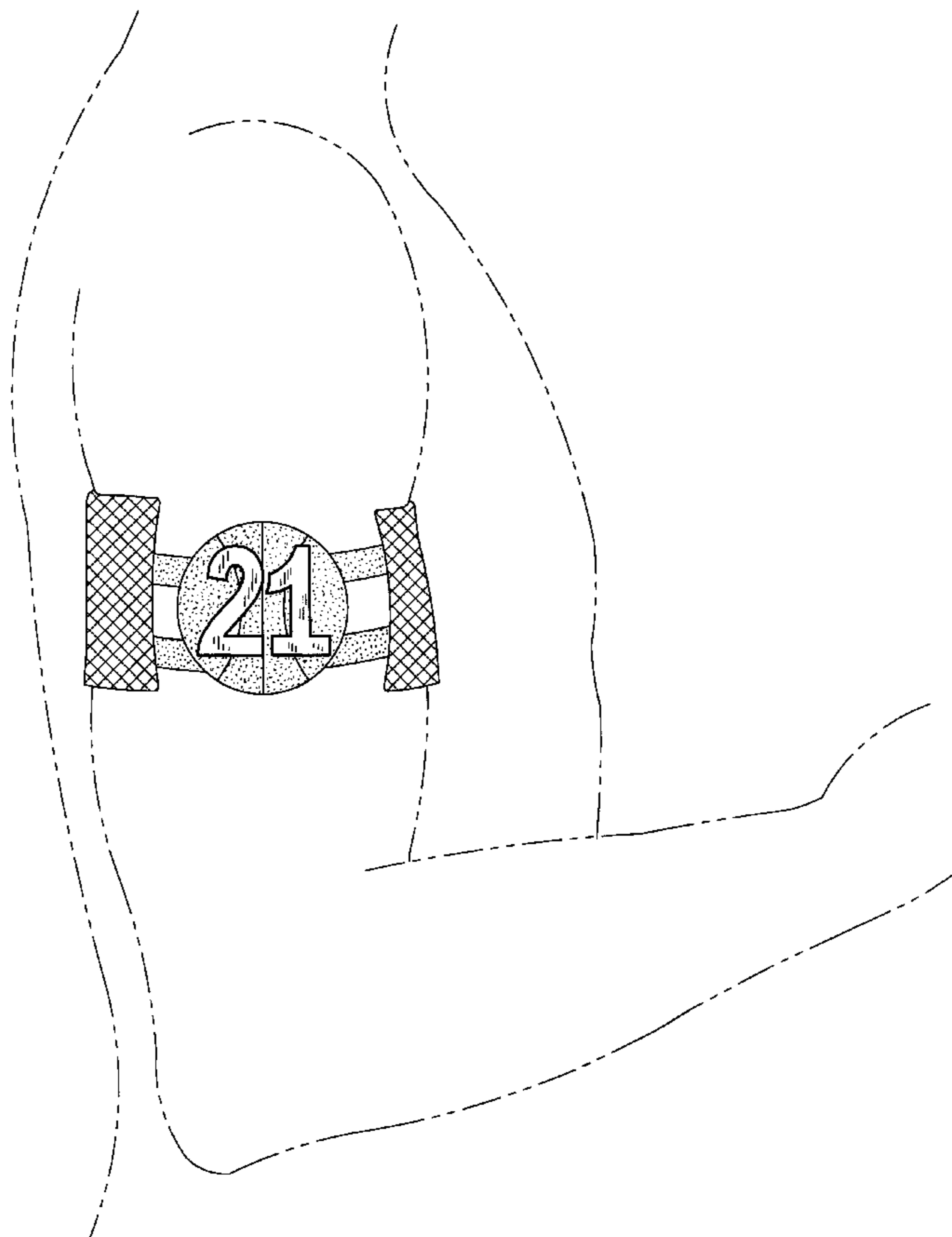

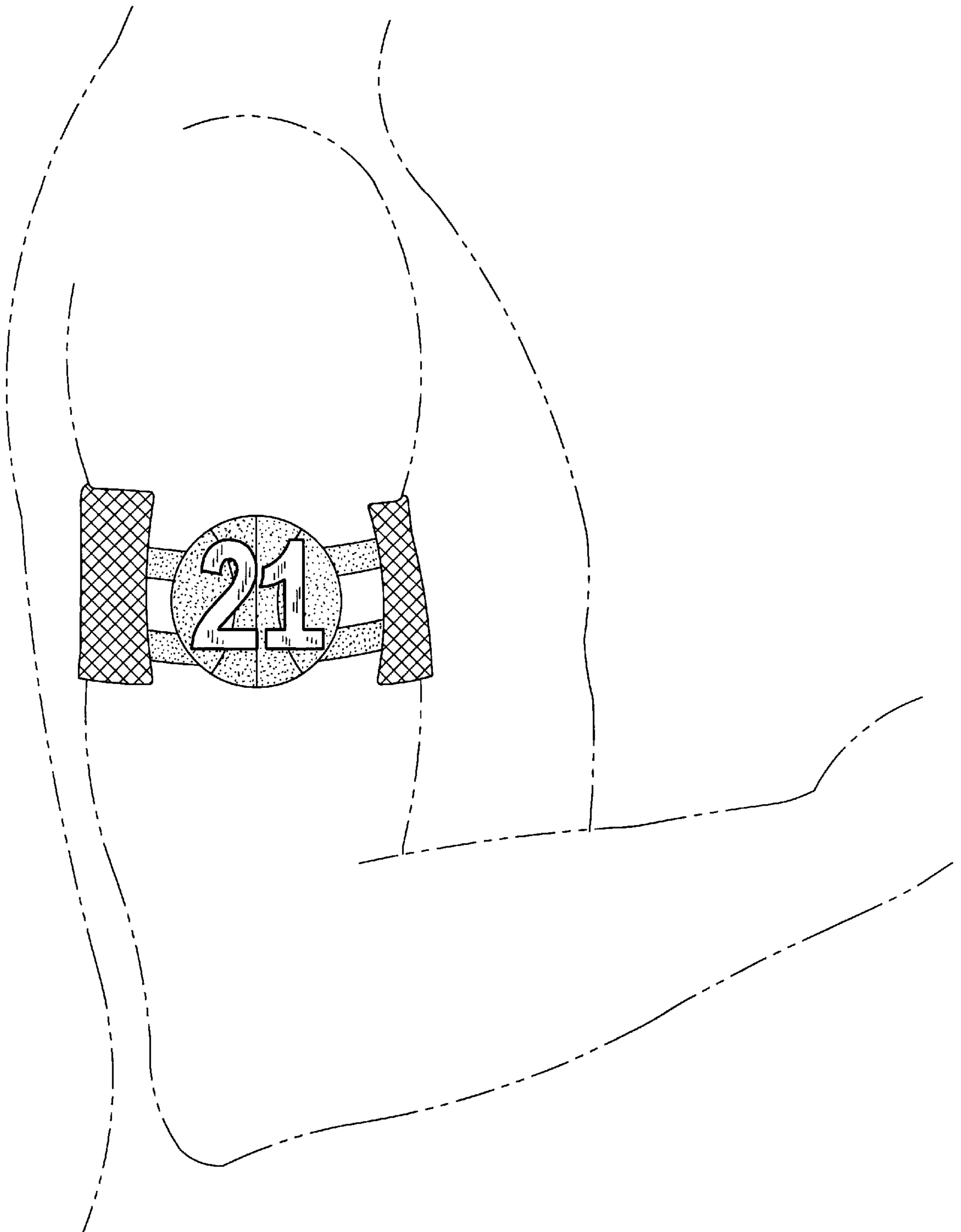

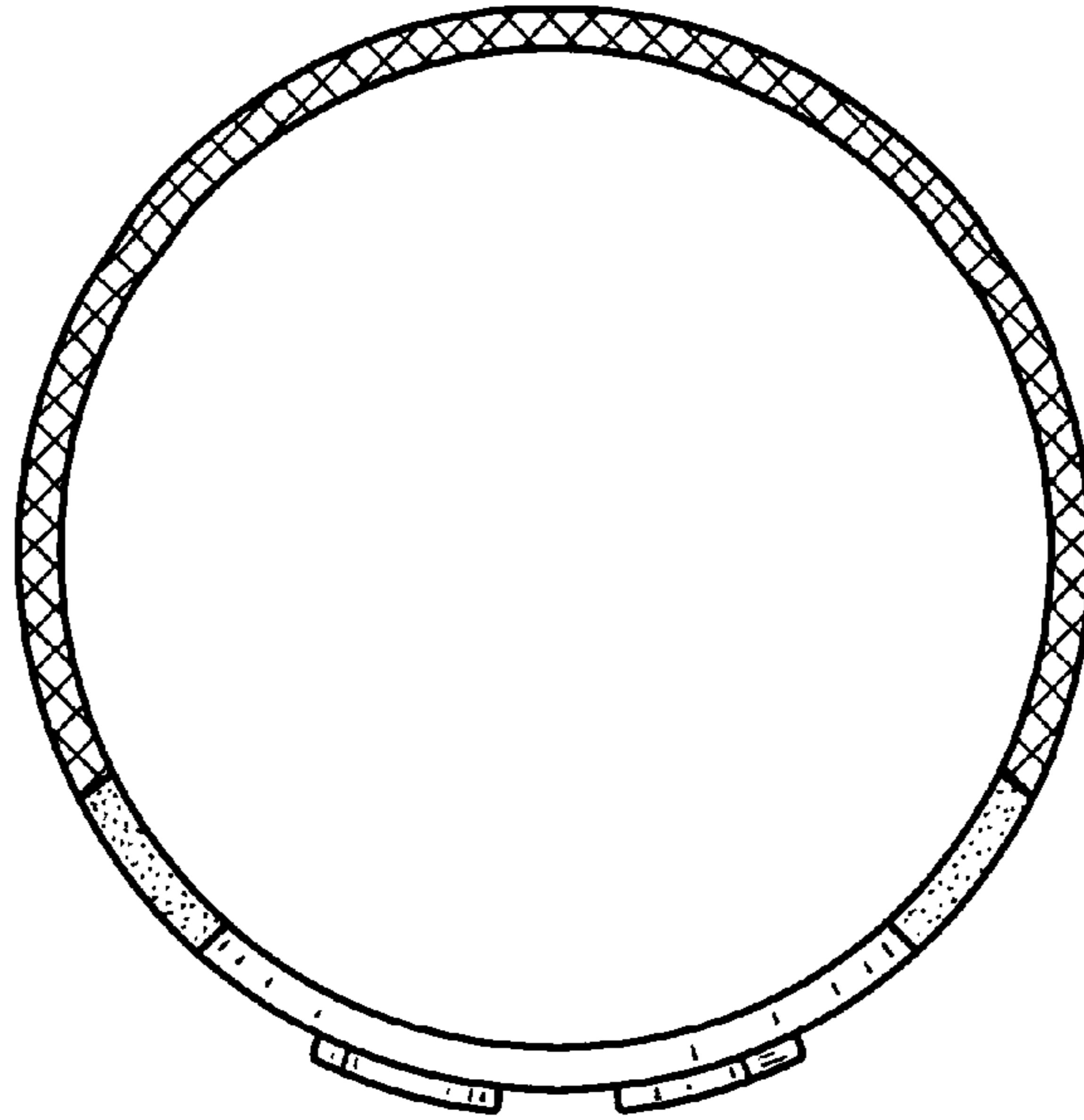

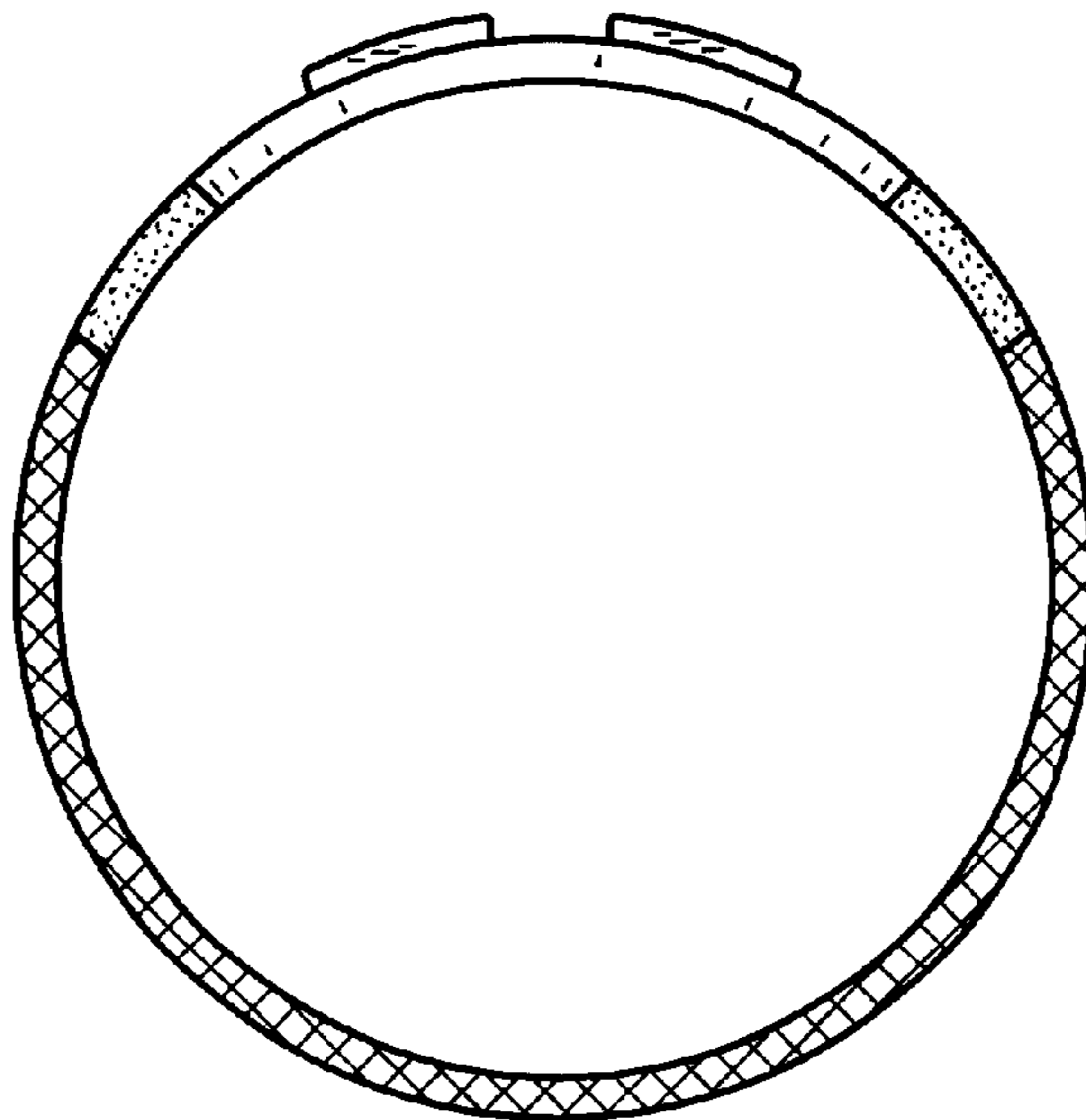
