(57) **CLAIM**

I claim the ornamental design for the article tissue box cover with windows, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of a tissue box cover with windows illustrating my new design;  
 FIG. 2 is a side elevational view thereof, it being underside that the view from all sides is identical;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a perspective view of an alternative embodiment of a tissue box cover with windows showing my new design;  
 FIG. 6 is a side elevational view thereof, it being understood that the view from all sides is identical;  
 FIG. 7 is a top plan view thereof;  
 FIG. 8 is a top plan view of an alternate embodiment thereof, the front, rear, right and left sides being identical in appearance to the previous embodiment;  
 FIG. 9 is a perspective view of an alternative embodiment of a tissue box cover with windows showing my new design;  
 FIG. 10 is a side elevational view thereof, it being understood that the view from all sides is identical;  
 FIG. 11 is a top plan view thereof;  
 FIG. 12 is a bottom plan view thereof;  
 FIG. 13 is a perspective view of an alternative embodiment of a tissue box cover with windows showing my new design;  
 FIG. 14 is a side elevational view thereof, it being understood that the view from all sides is identical;  
 FIG. 15 is a top plan view thereof; and,  
 FIG. 16 is a bottom plan view thereof.

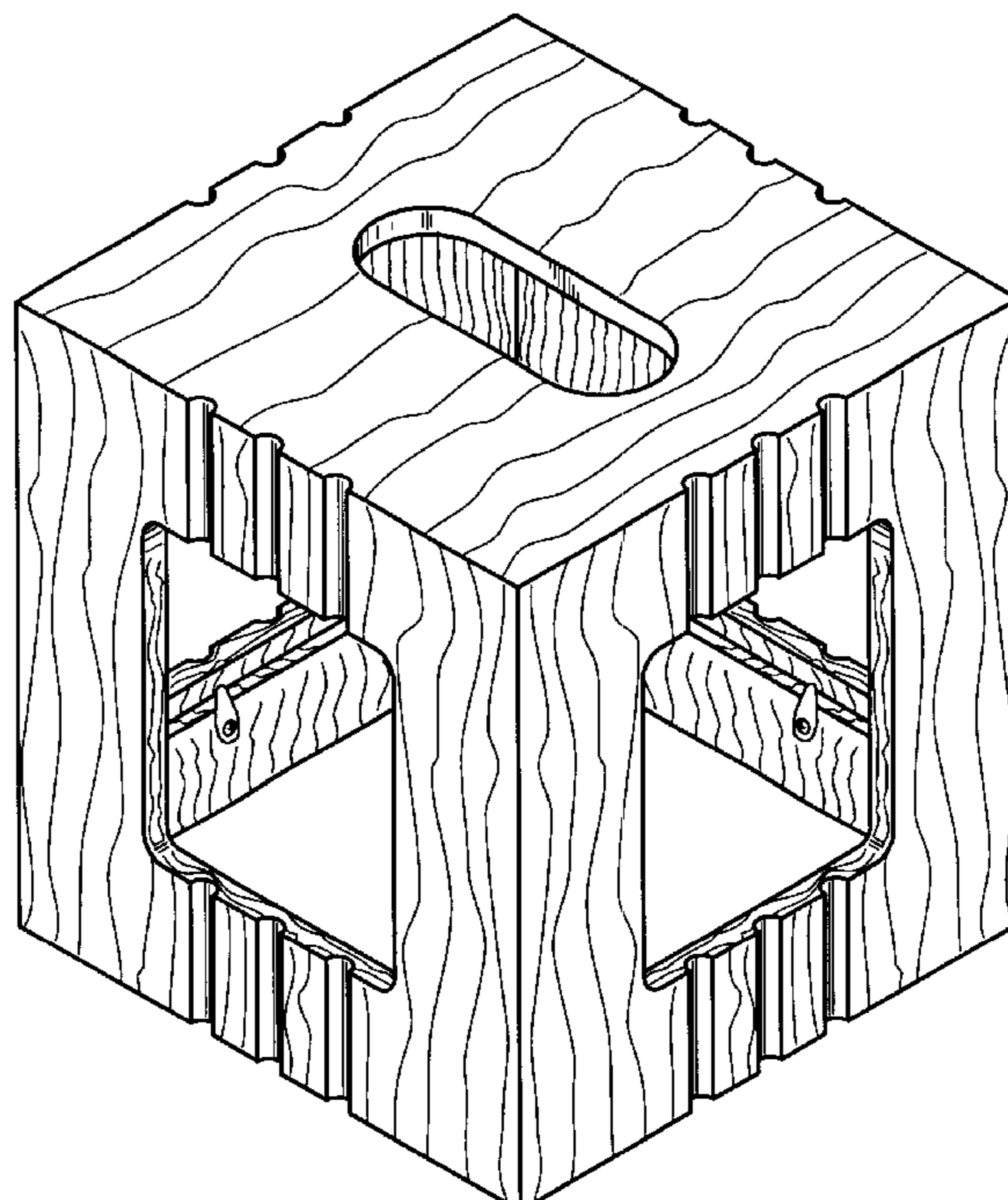

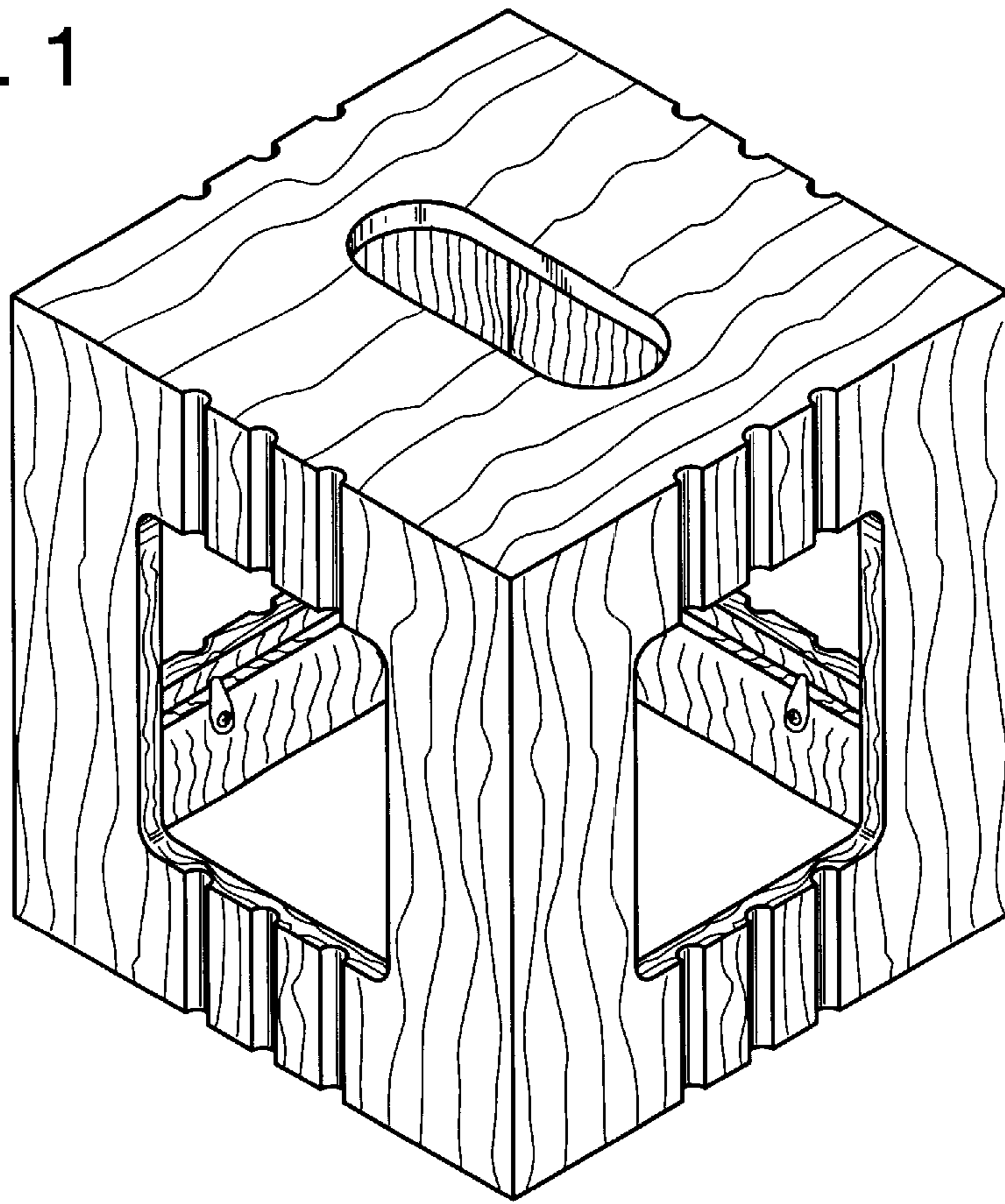

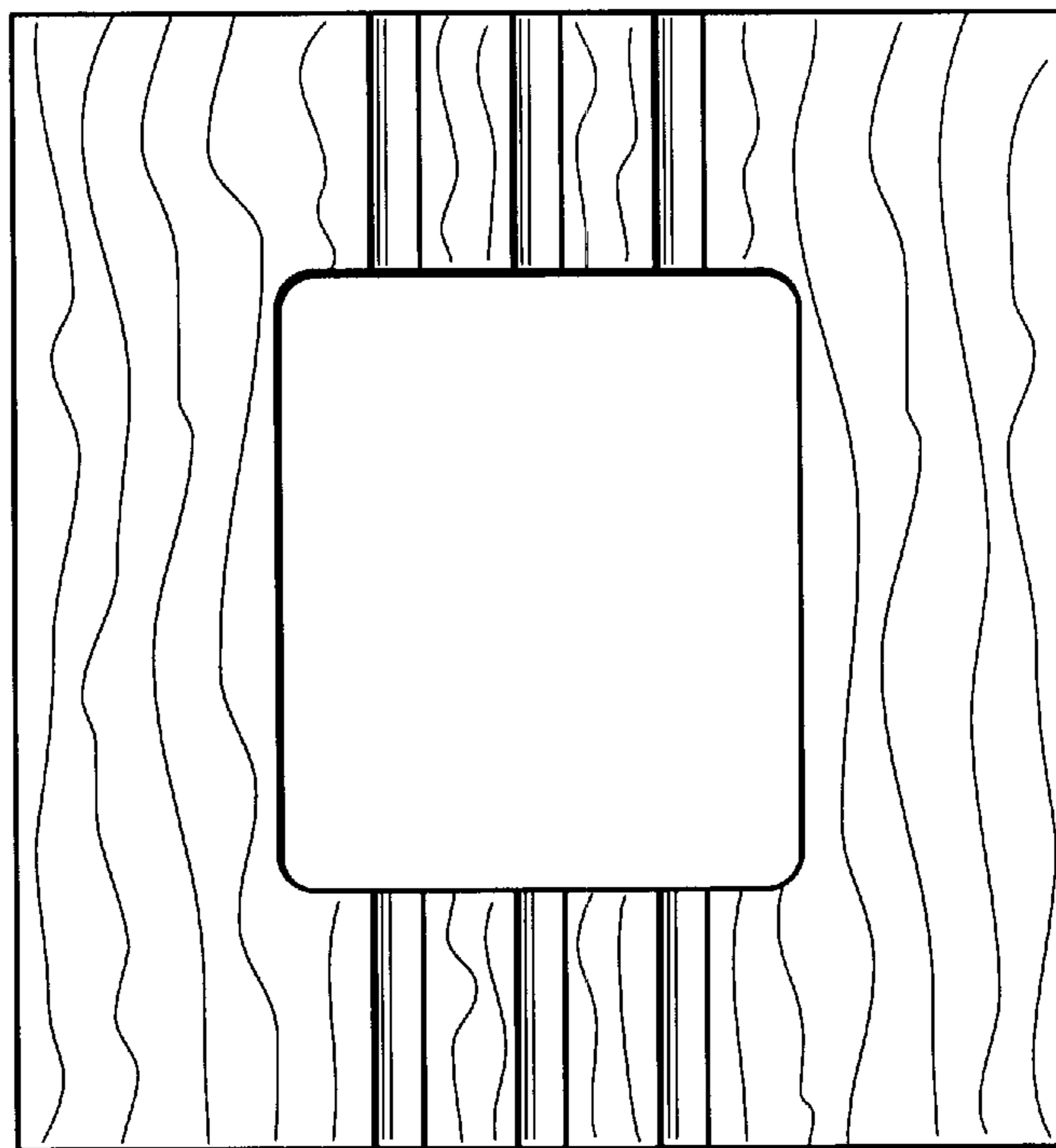

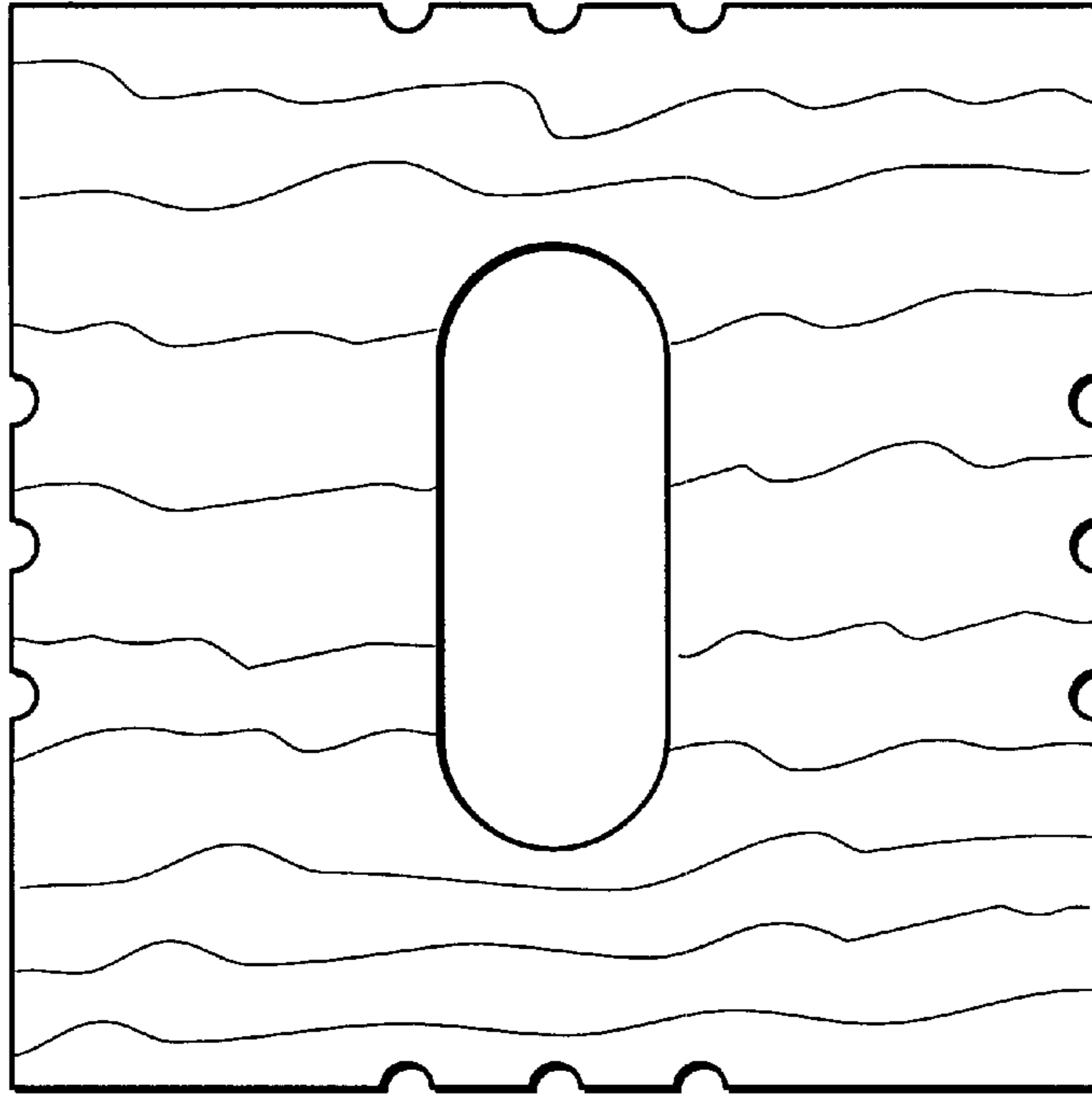

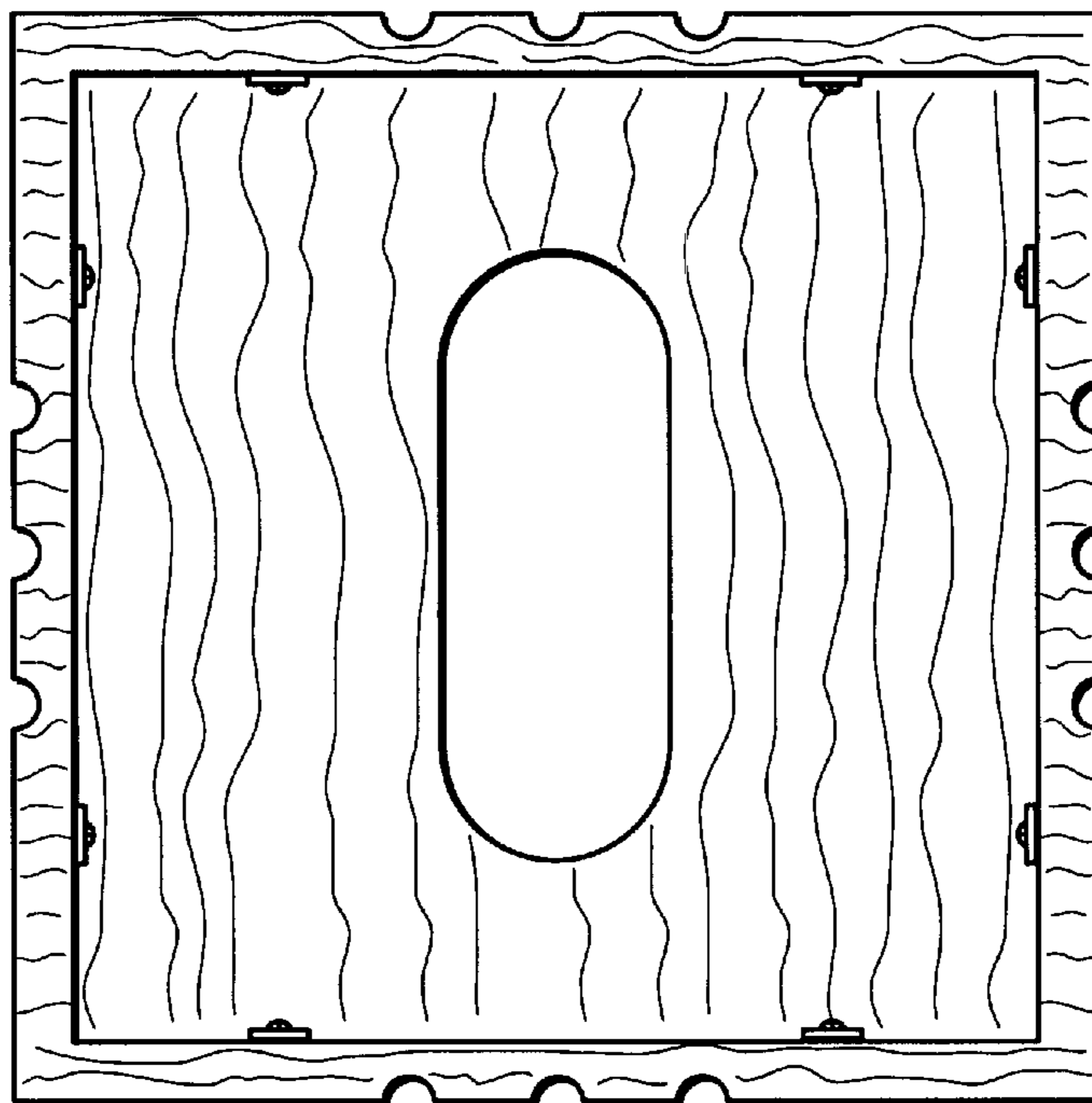

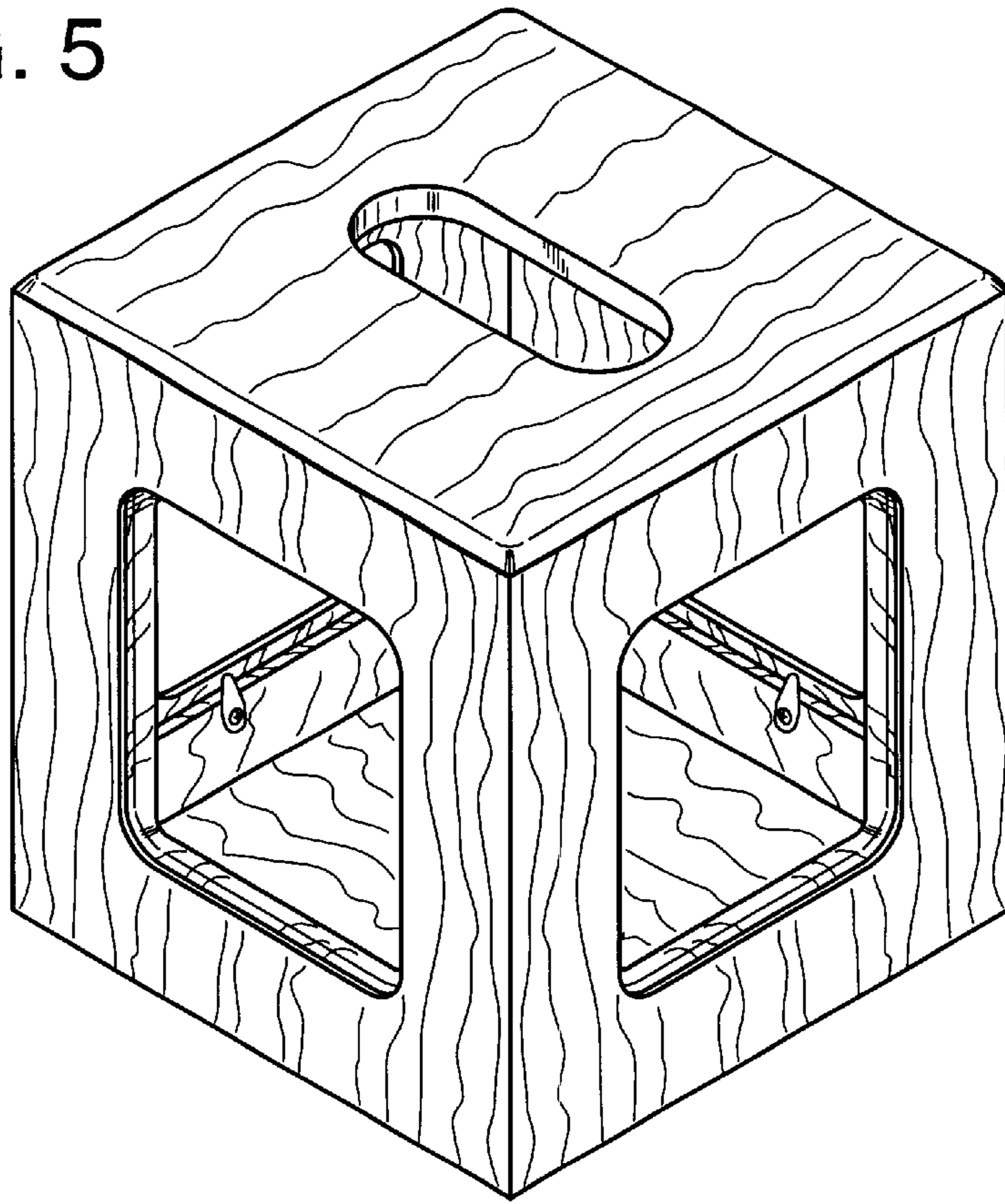

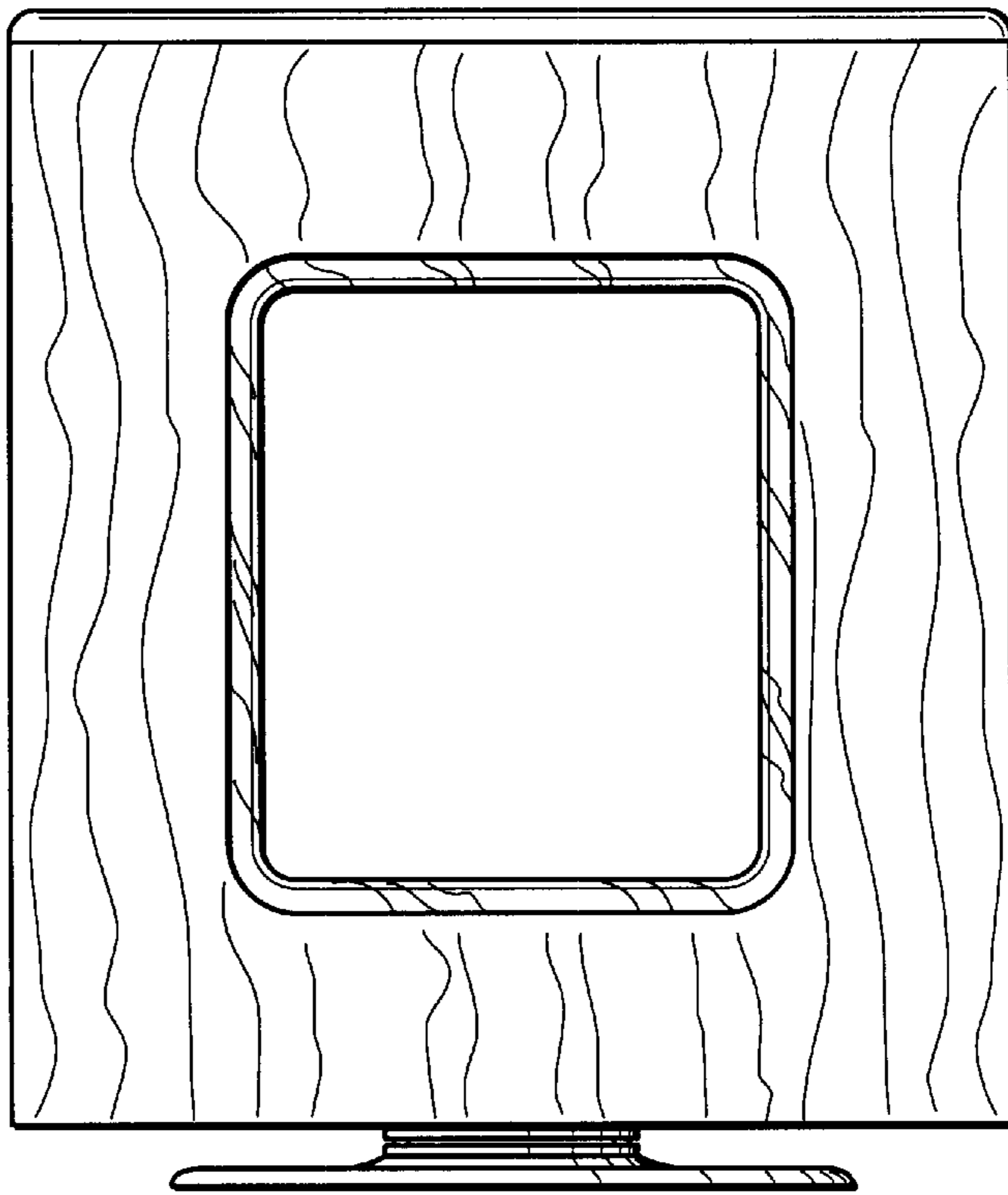

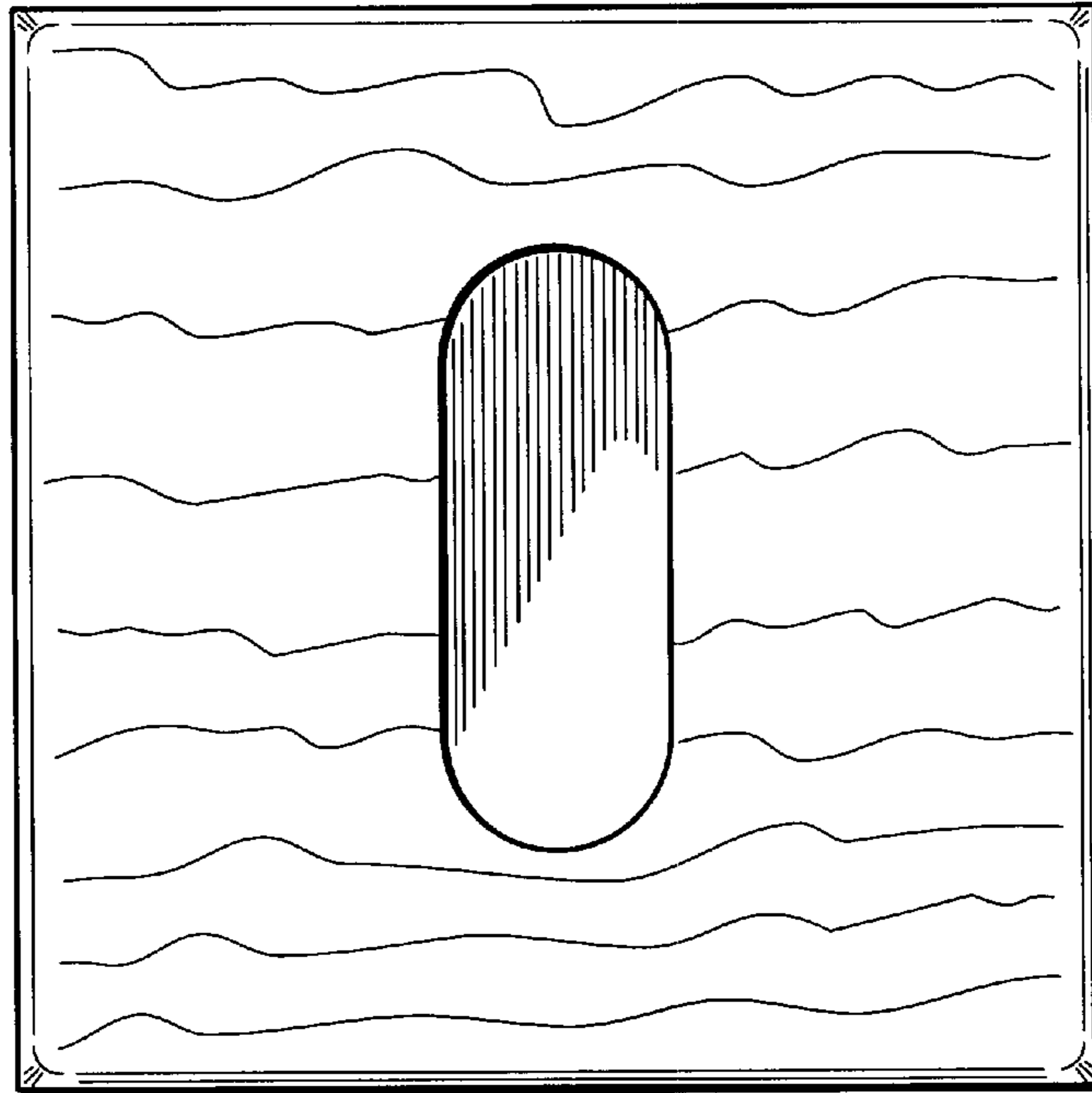

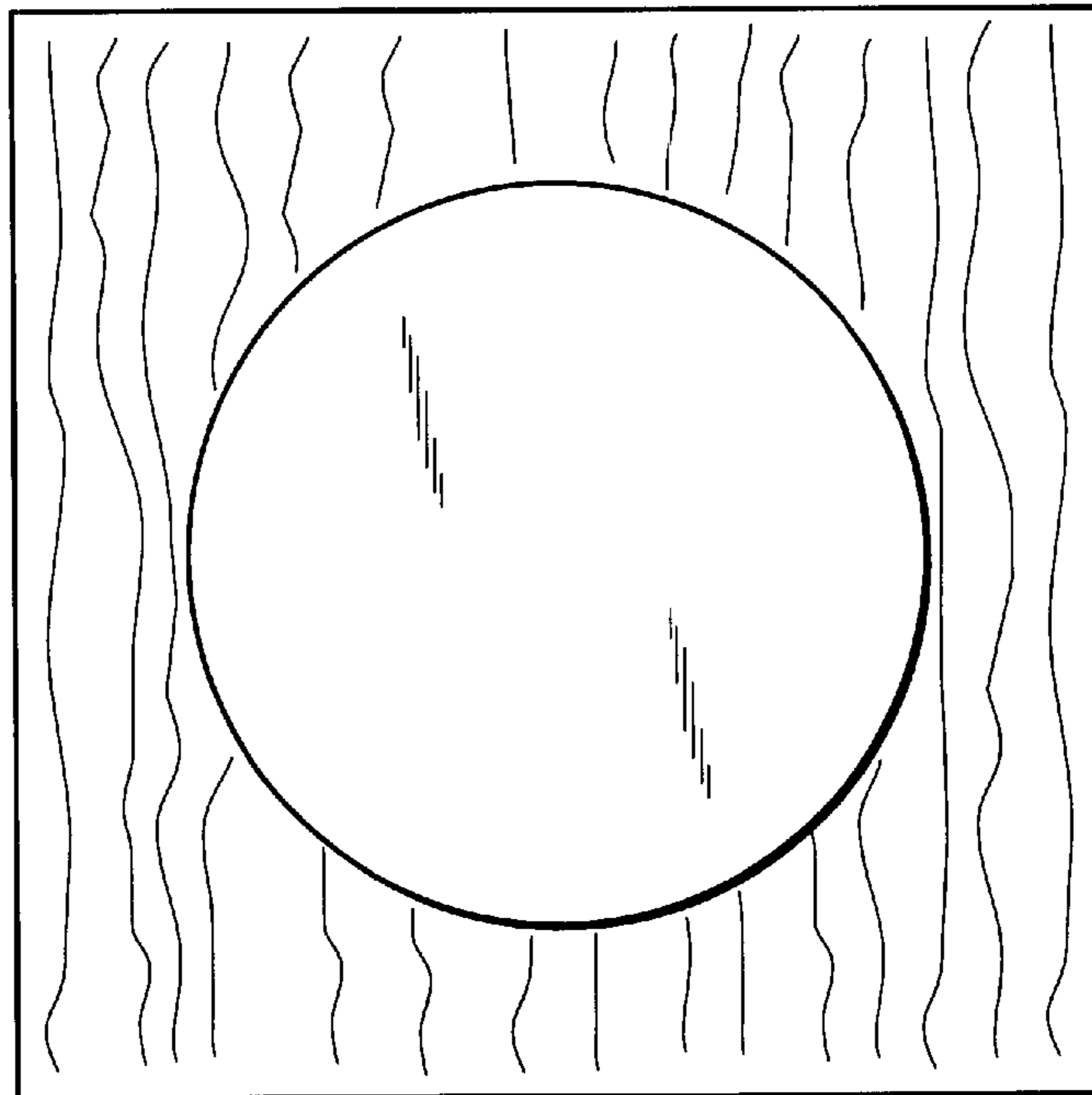

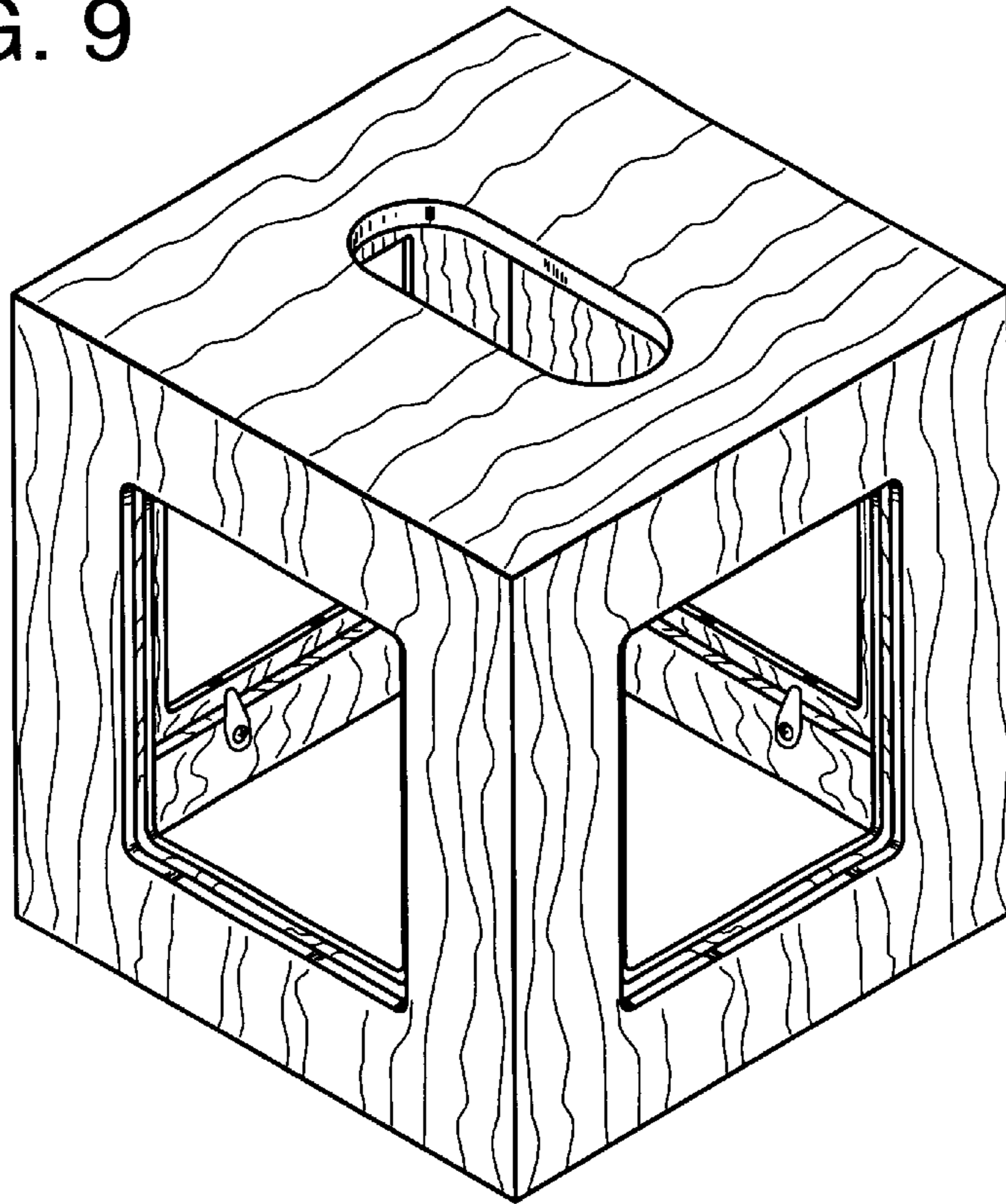

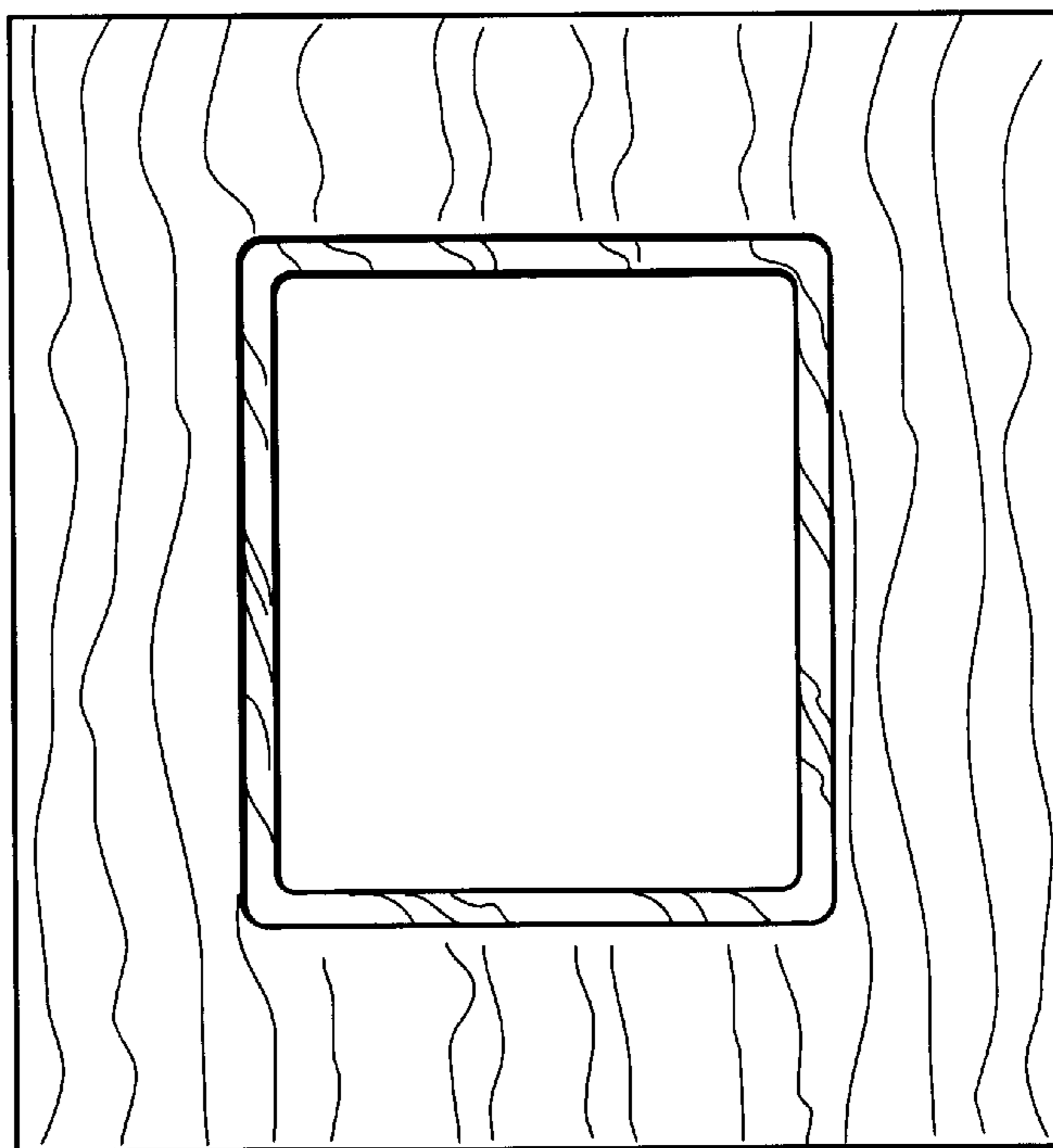

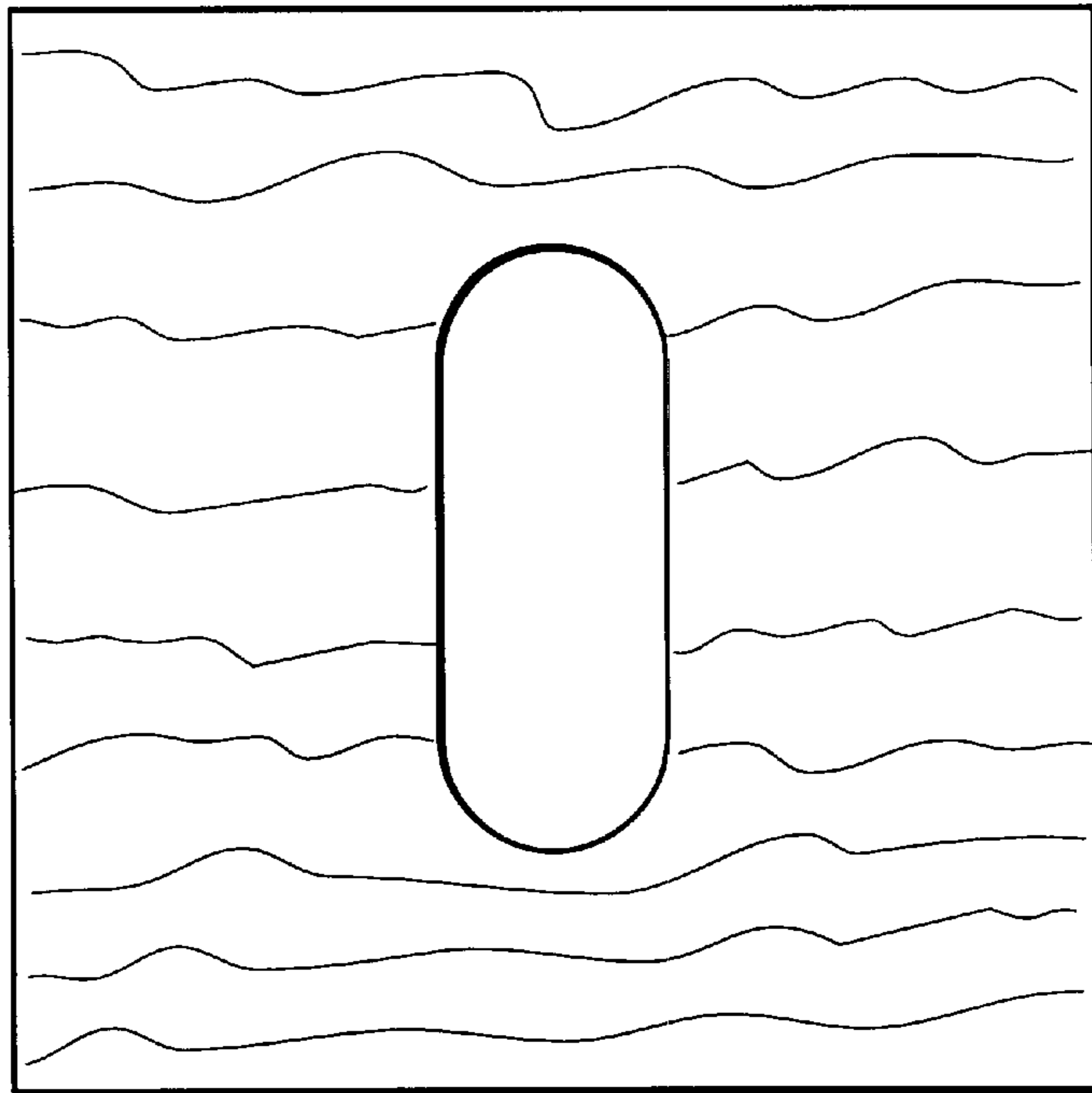

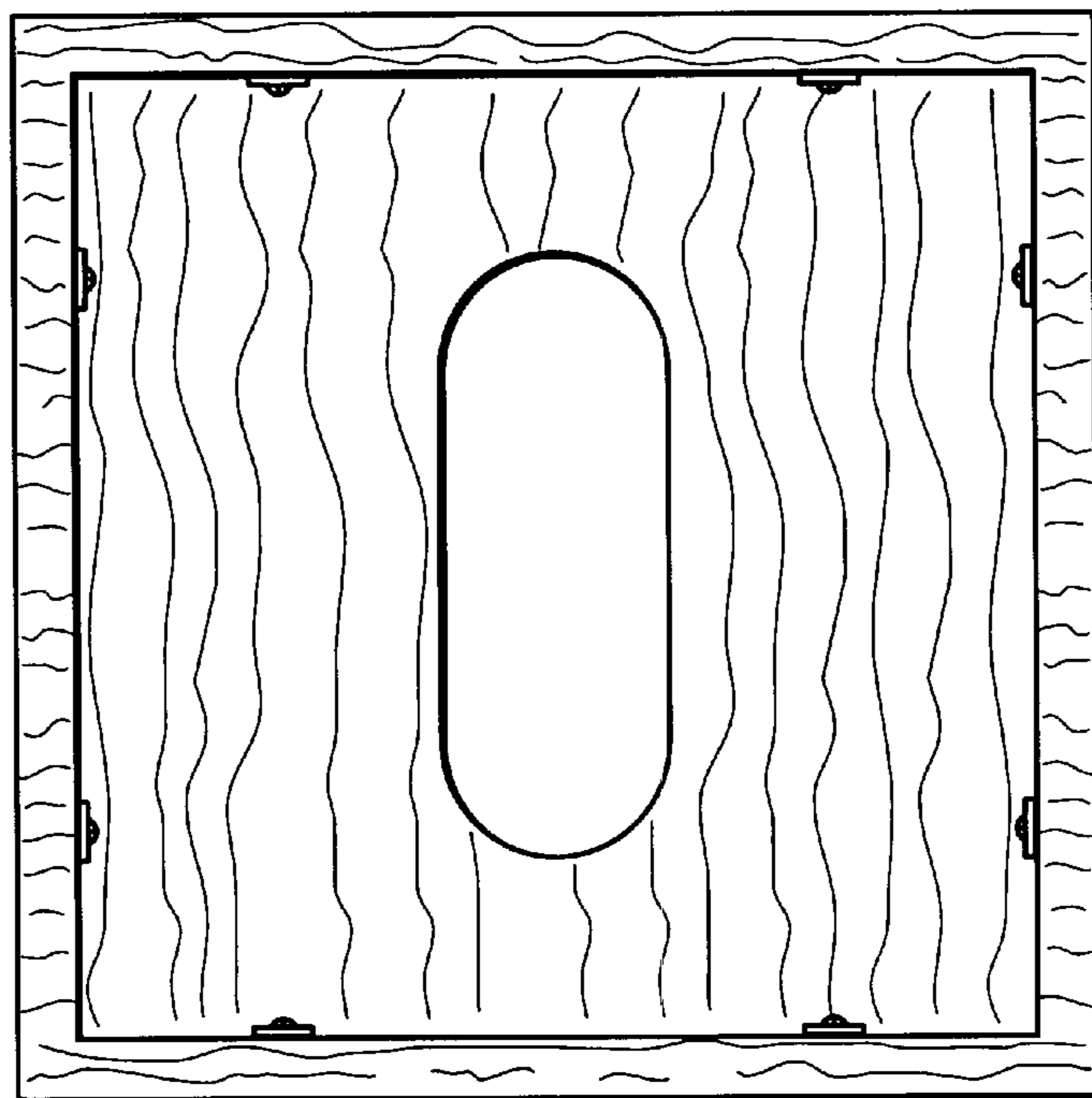

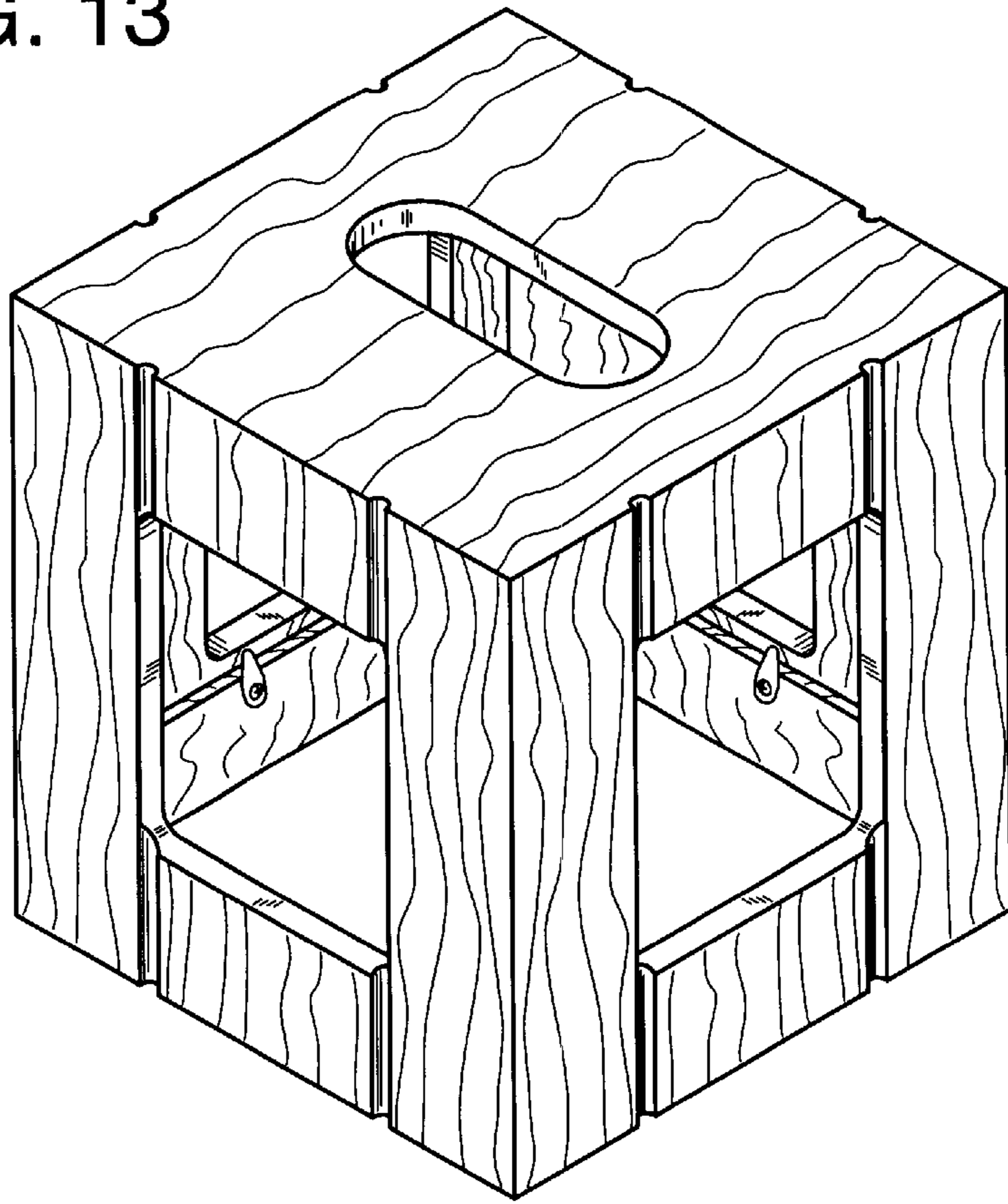

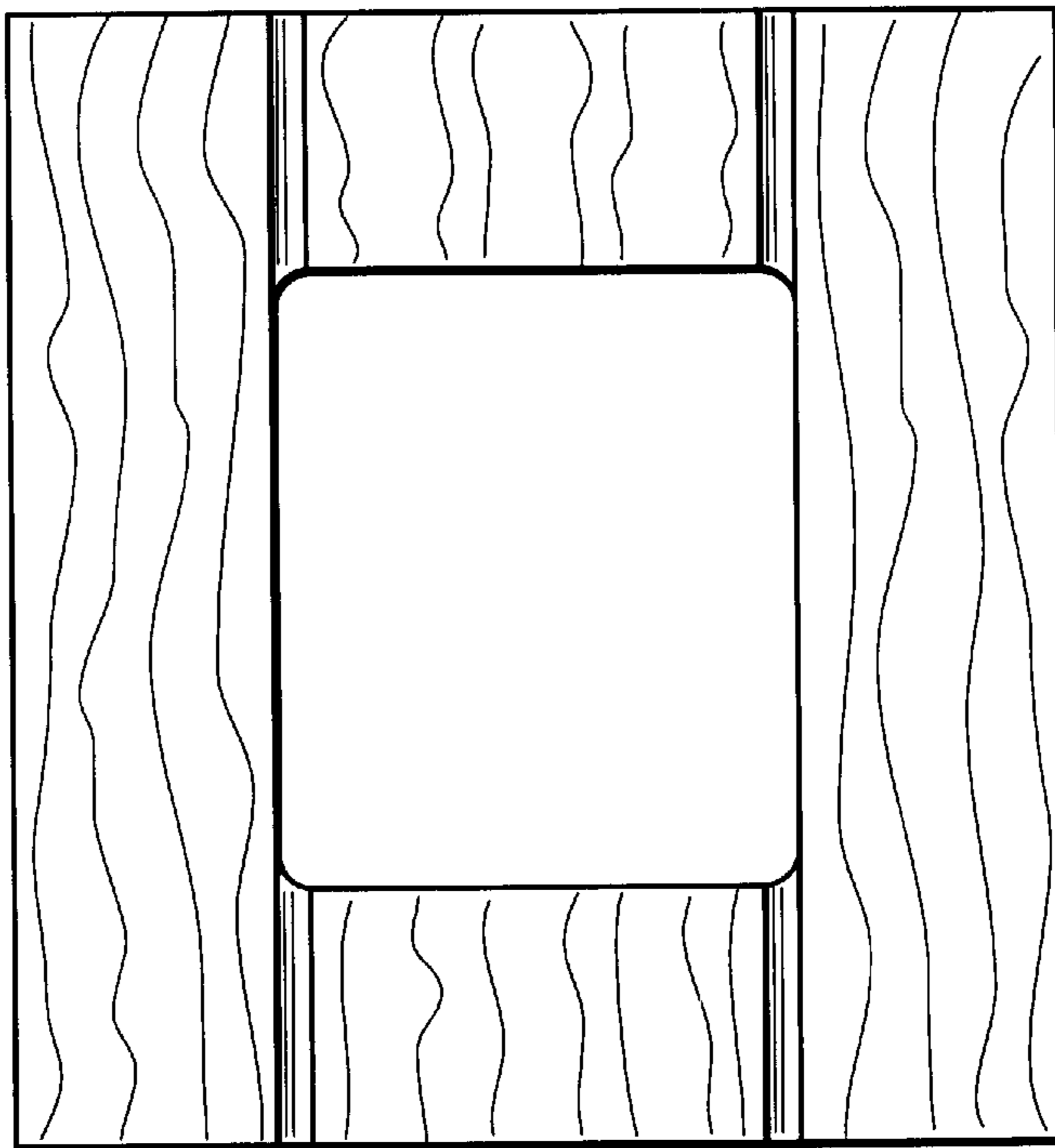

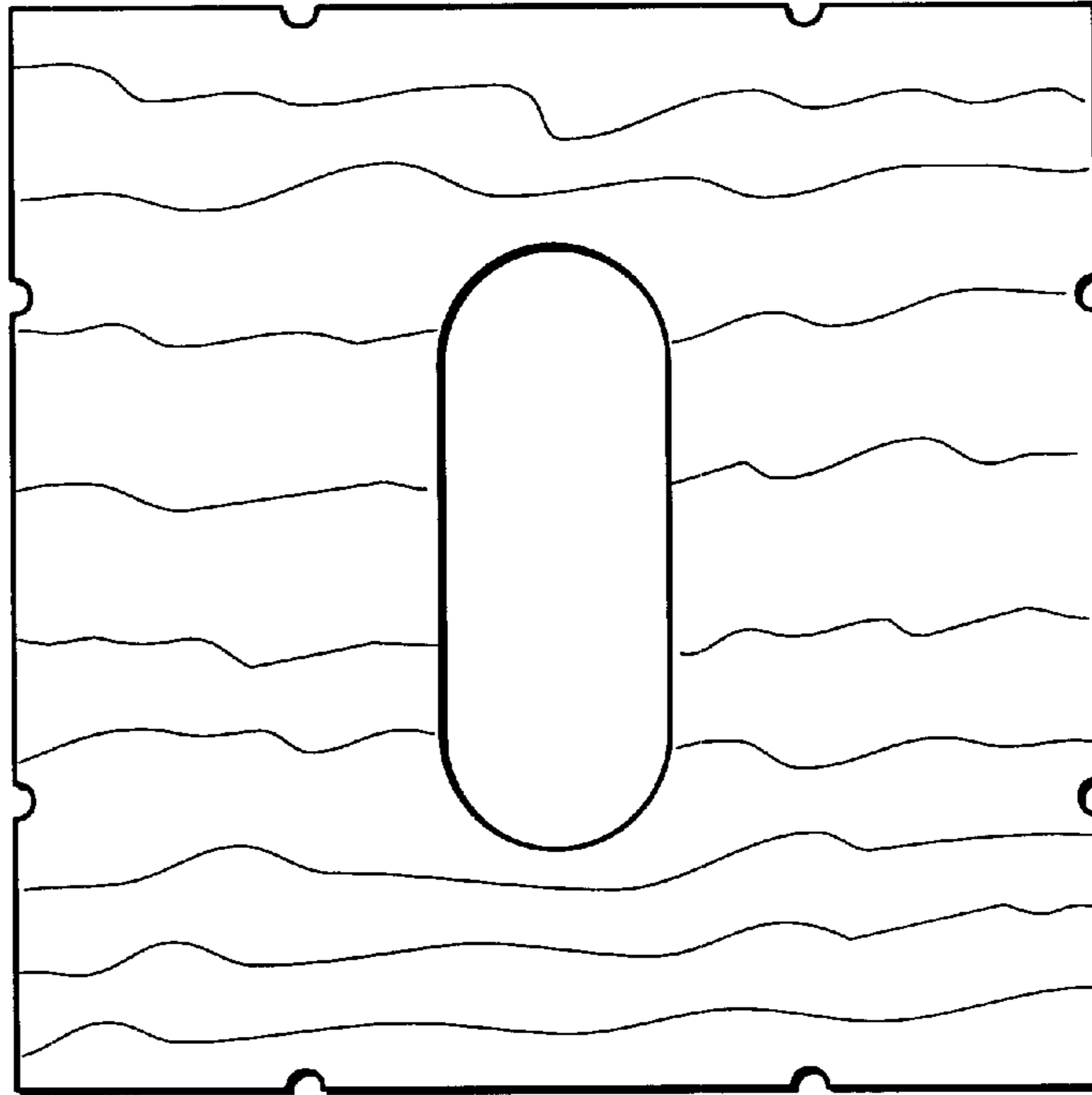
