(57) **CLAIM**

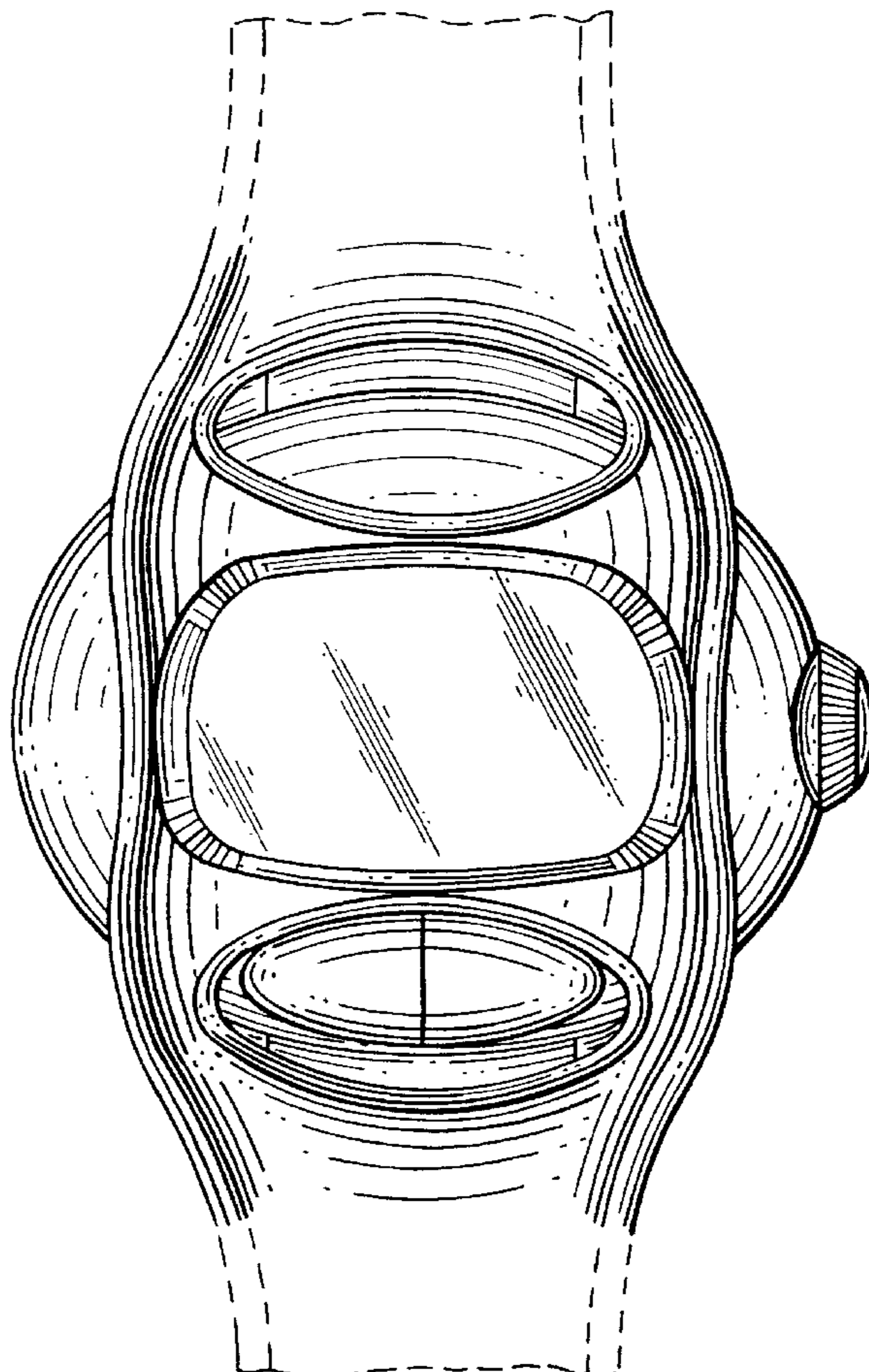
The ornamental design for a watch head and portion of overlying strap member, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a watch head and portion of overlying strap member showing my new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a front end elevational view thereof; FIG. 6 is a second end elevational view thereof; and, FIG. 7 is a bottom plan view.

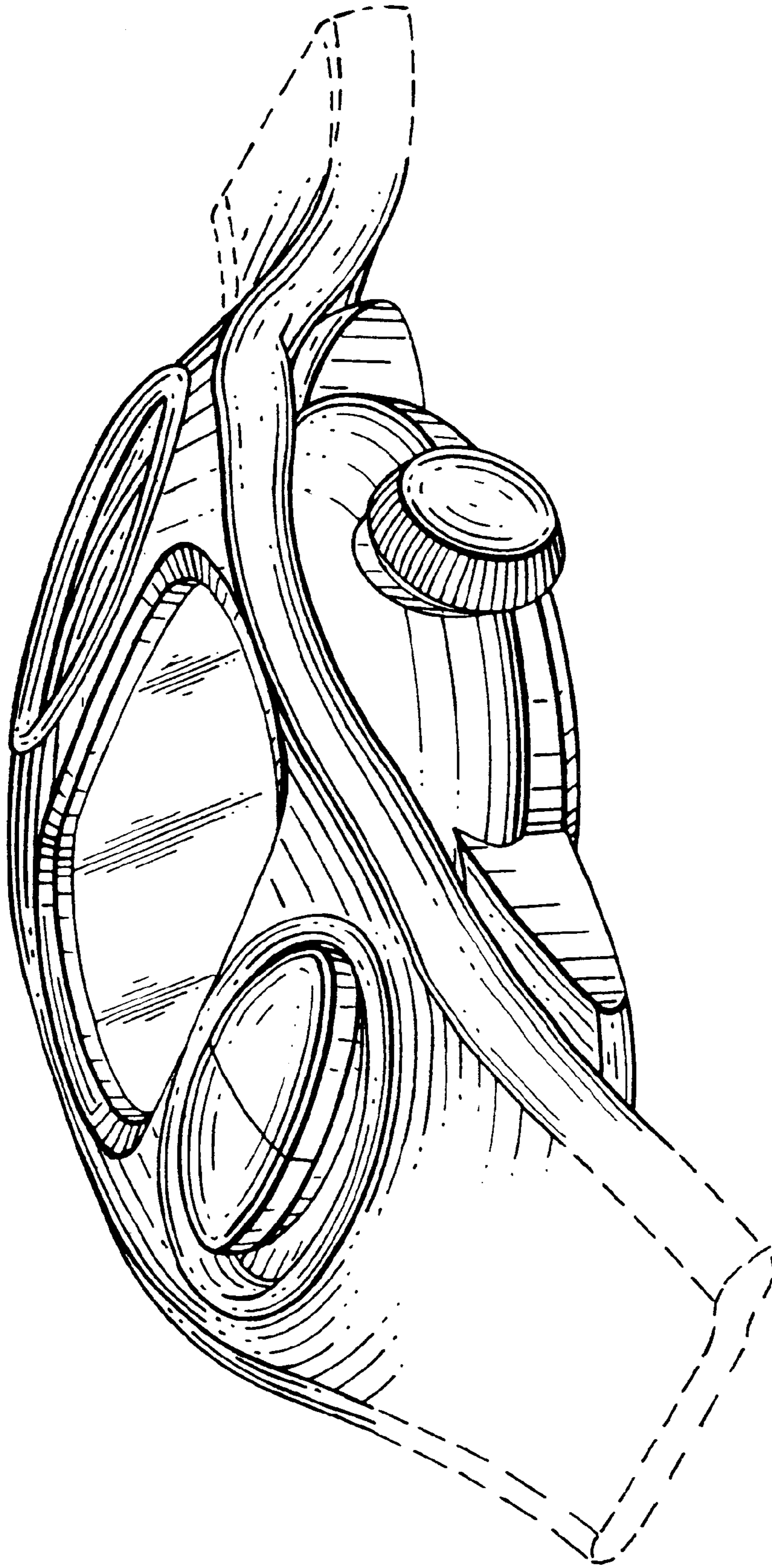

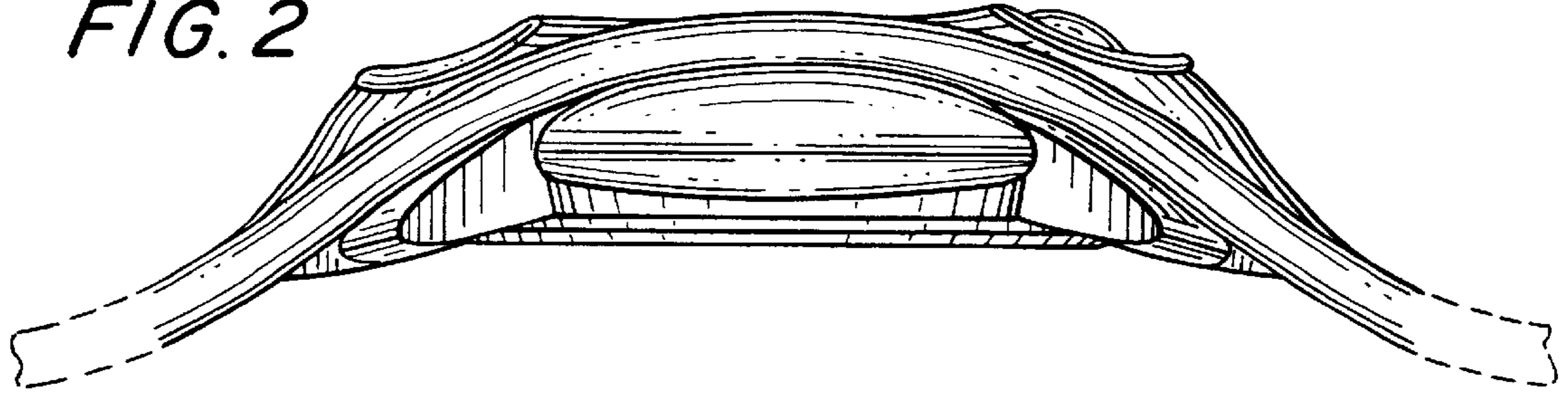

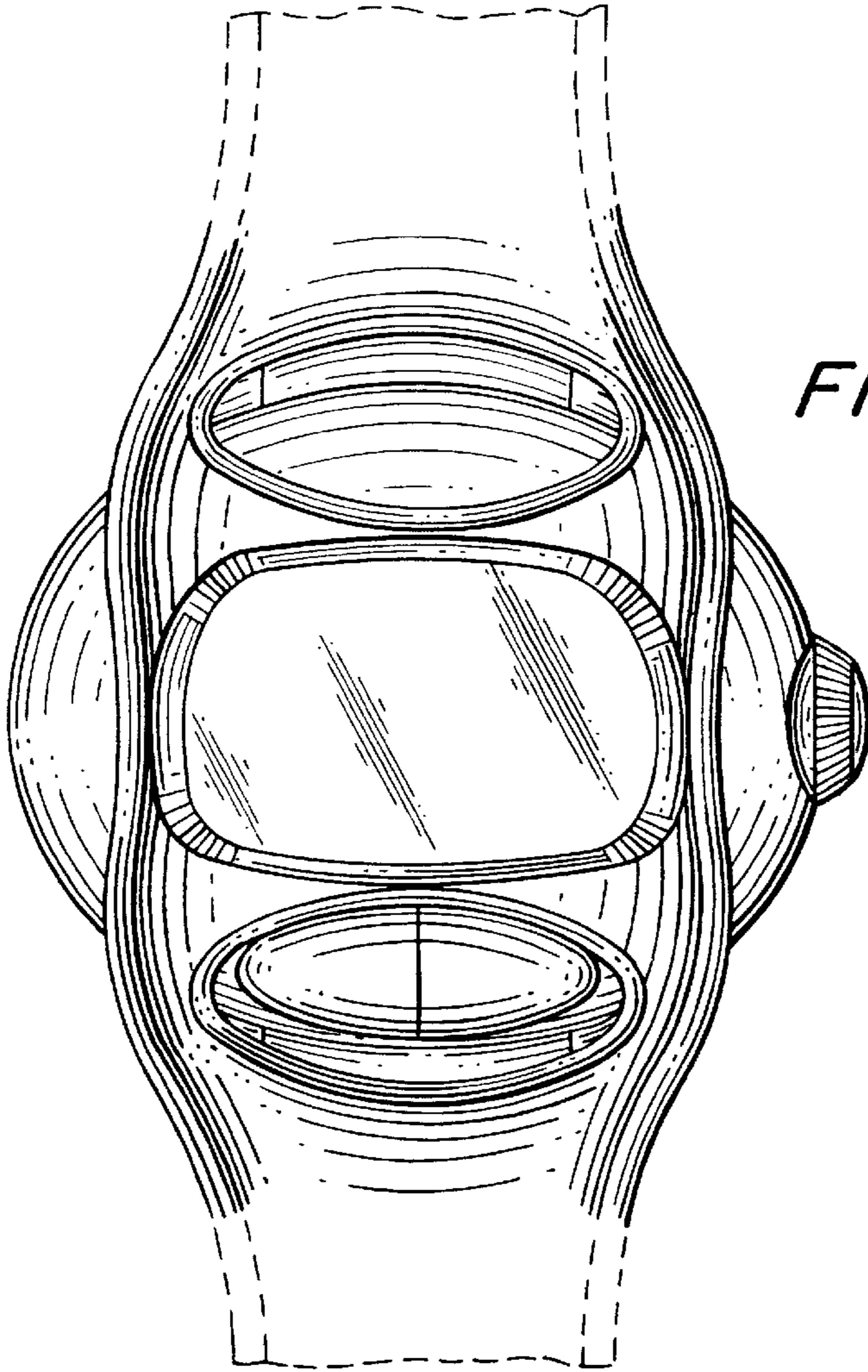

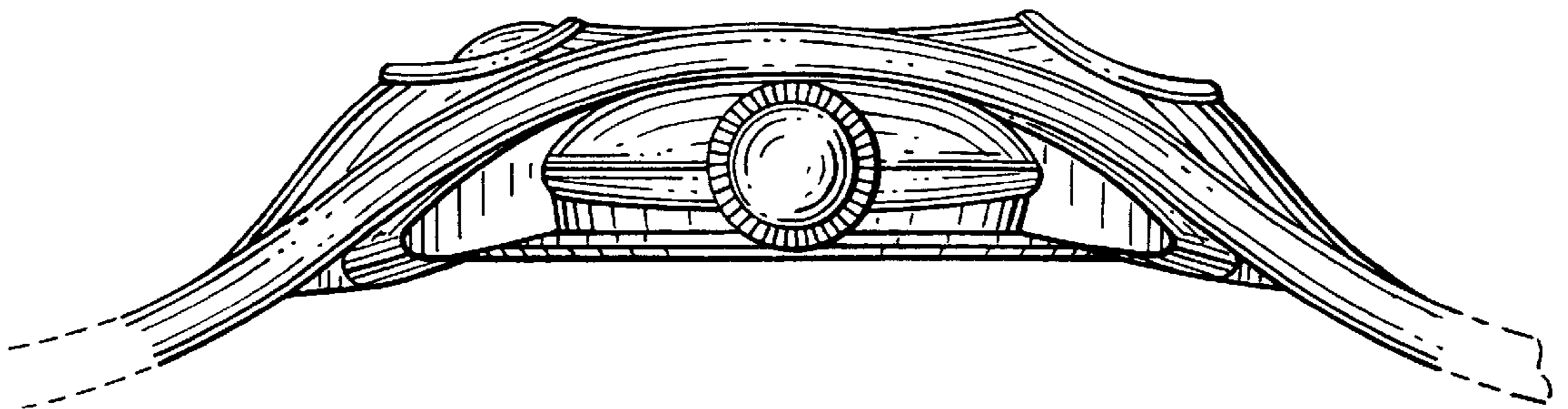

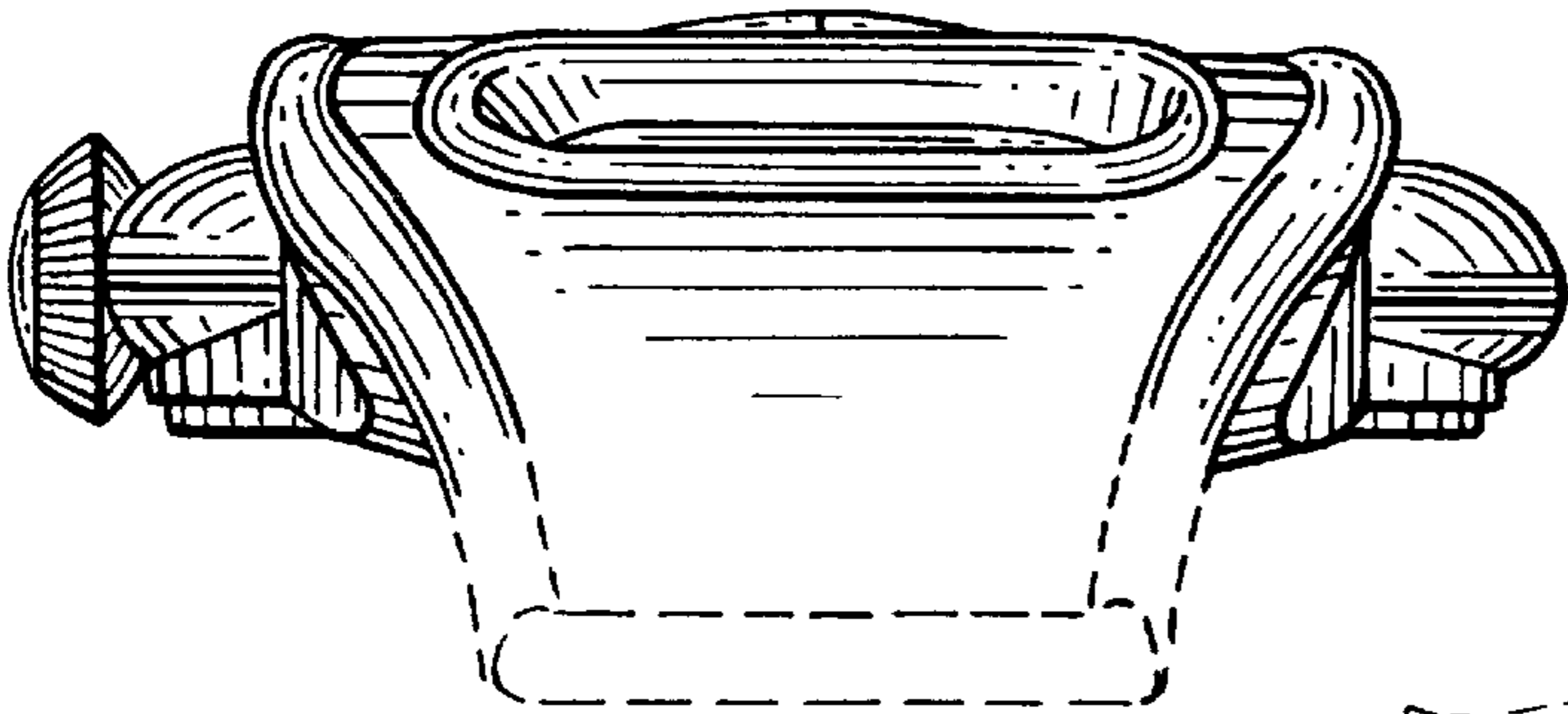
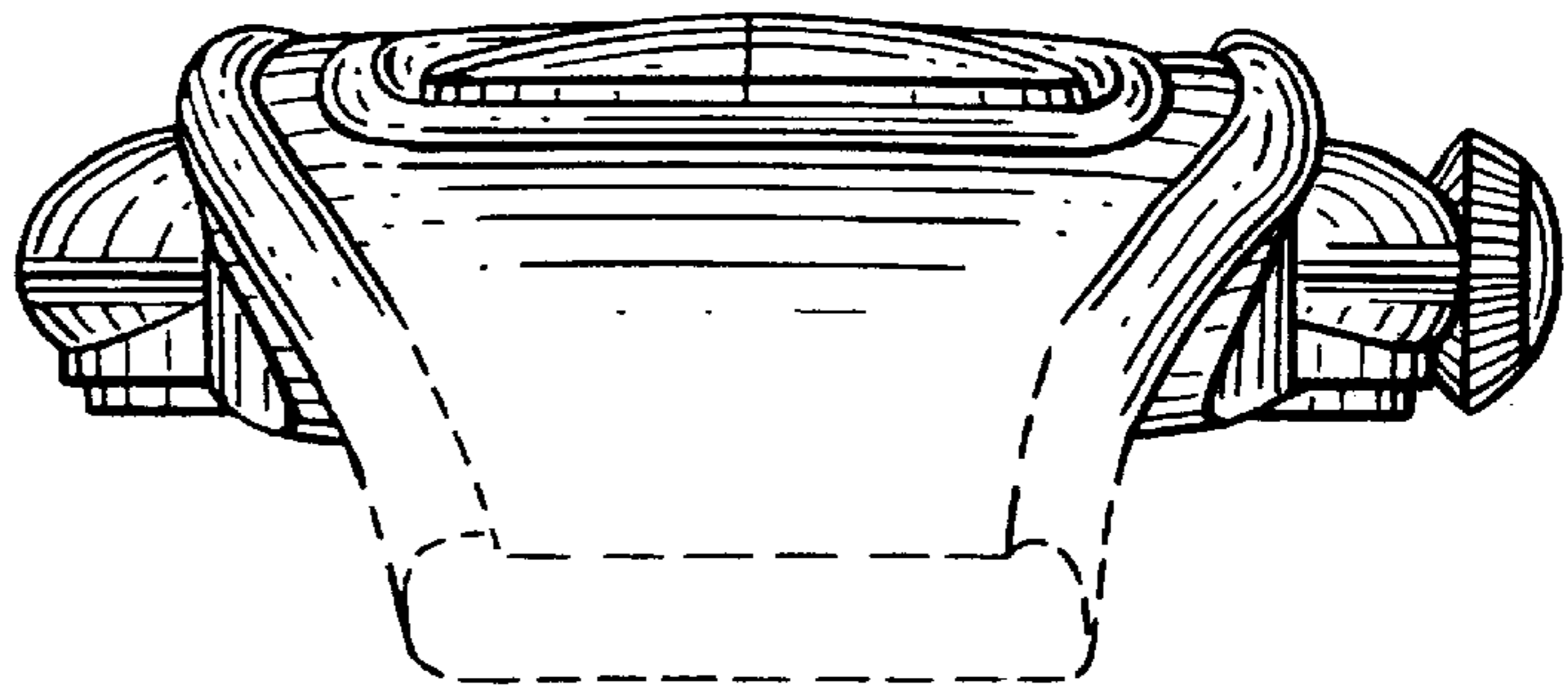
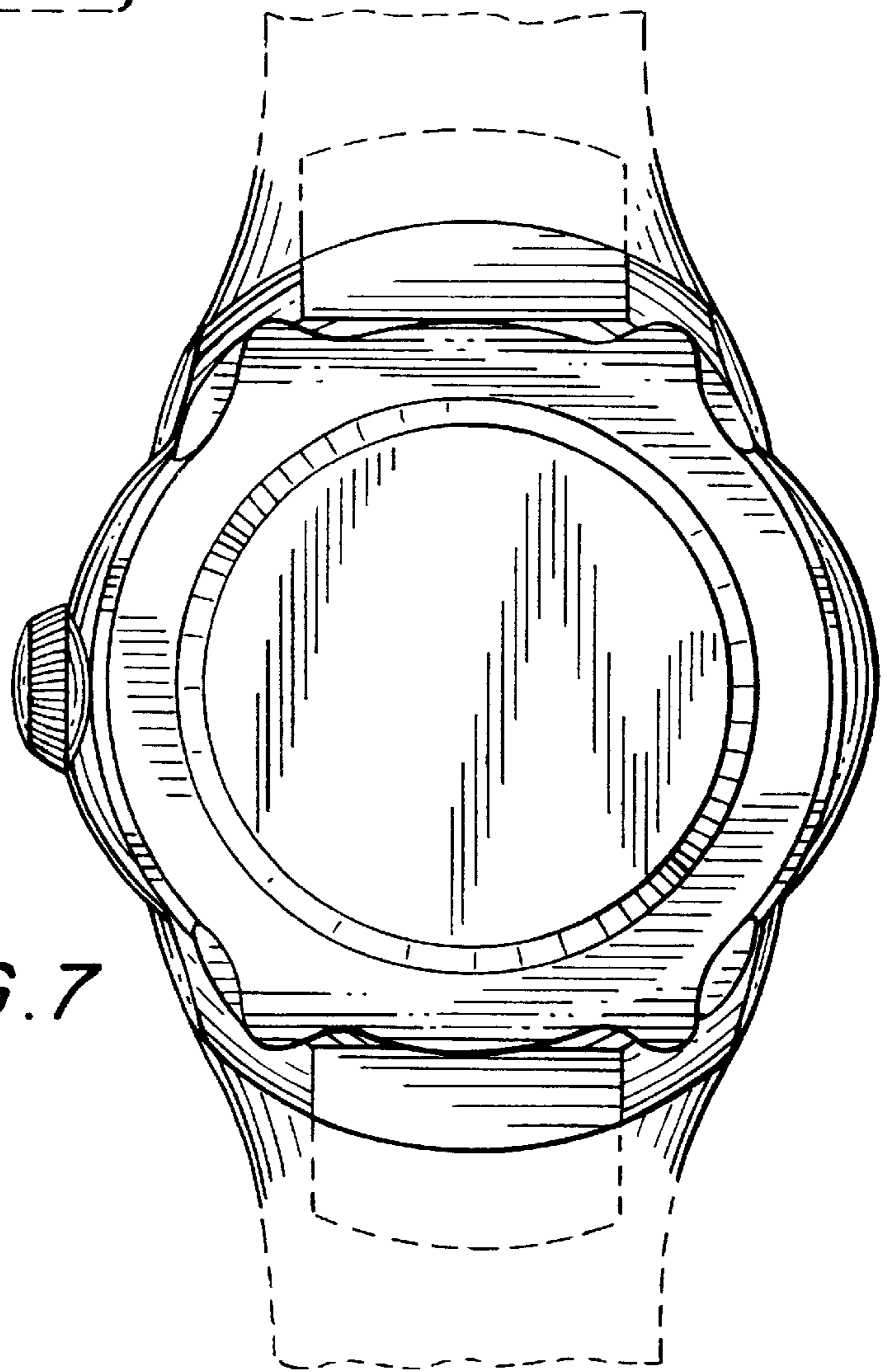
