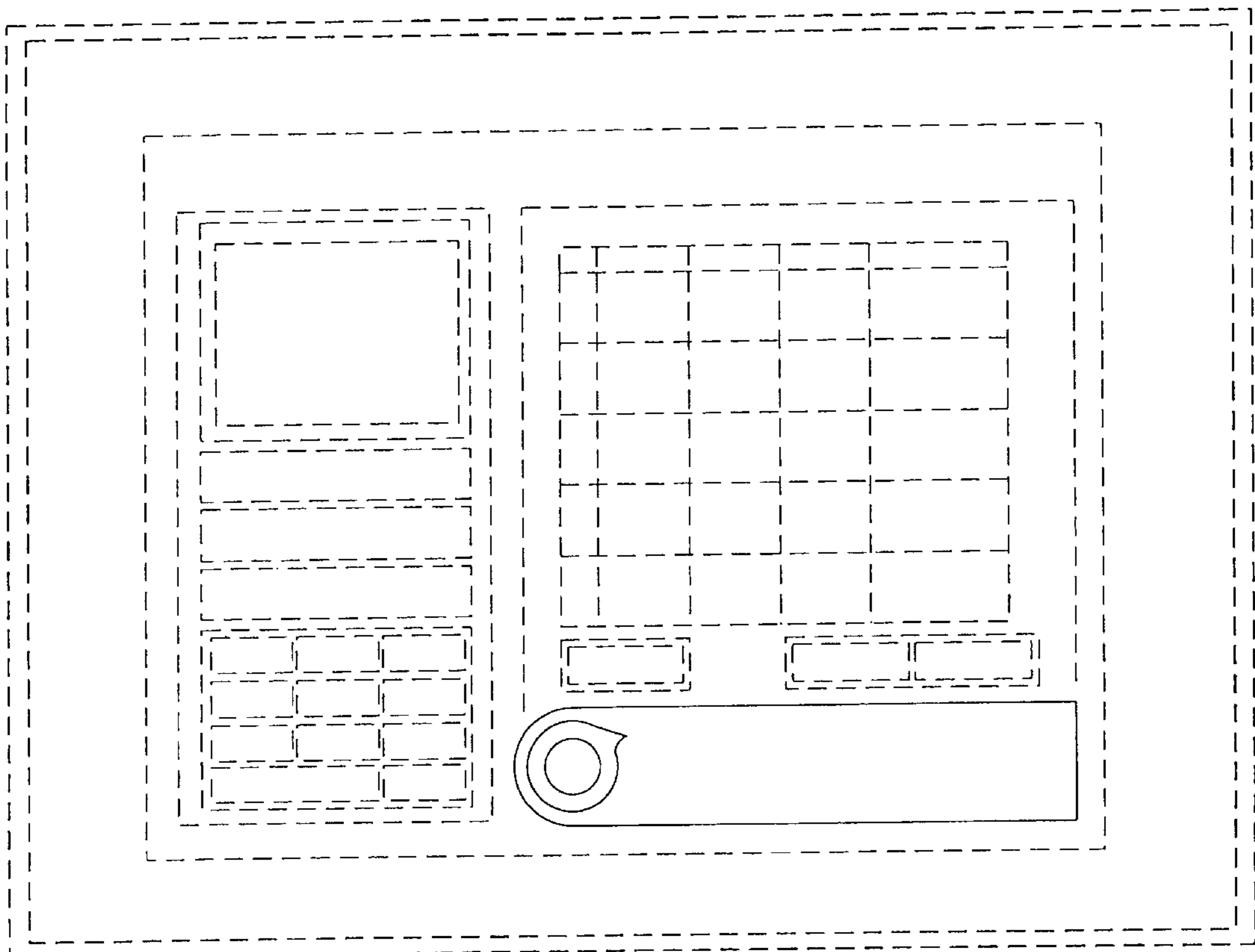

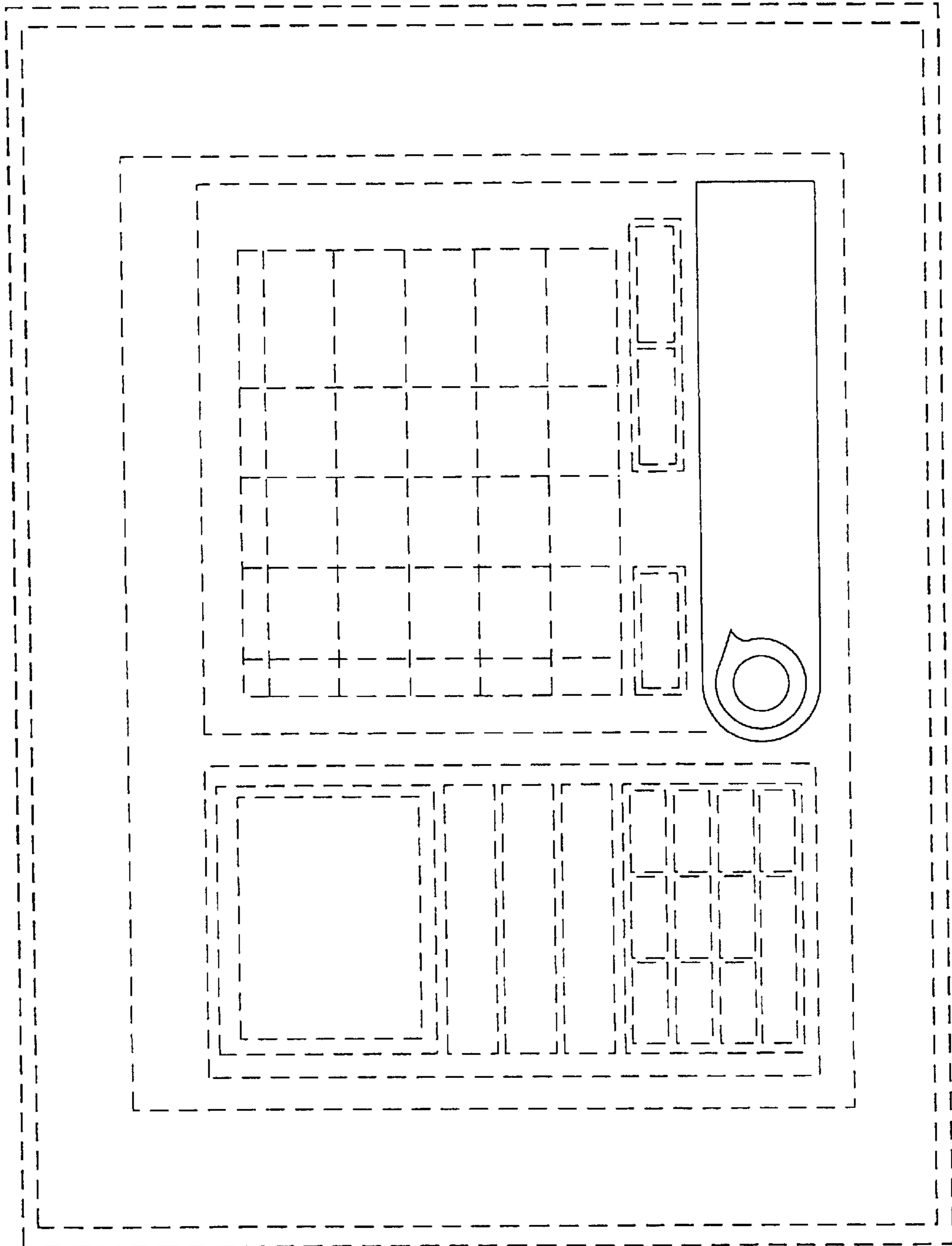
The ornamental design for a computer generated image for display panel or screen, as shown and described.

**DESCRIPTION**

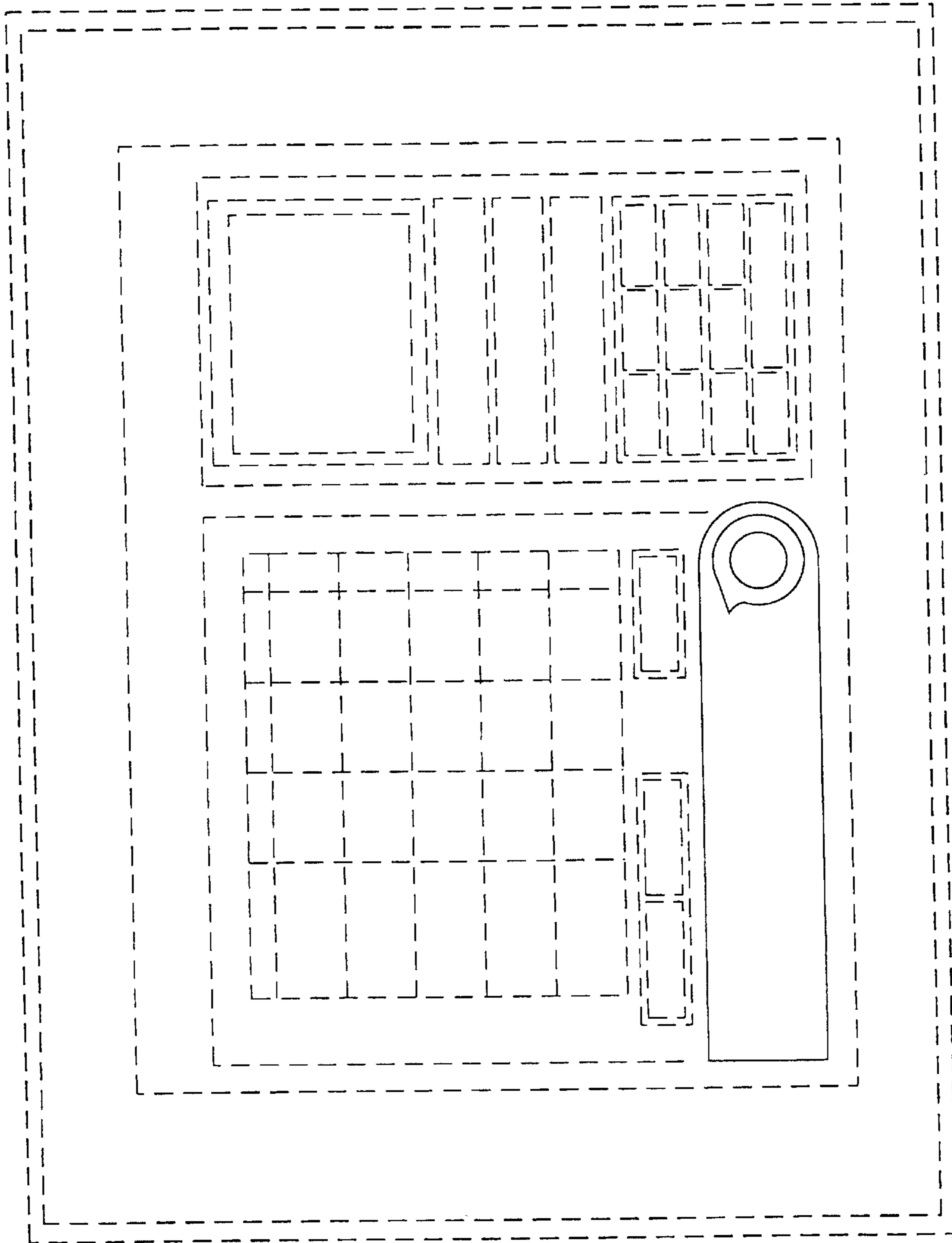
