The ornamental design for an air conditioner condenser housing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the air conditioner condenser housing showing an alternative configuration;

FIG. 2 is a front elevational view of the configuration shown in FIG. 1;

FIG. 3 is a back elevational view of the configuration shown in FIG. 1;

FIG. 4 is a right side elevational view of the configuration shown in FIG. 1;

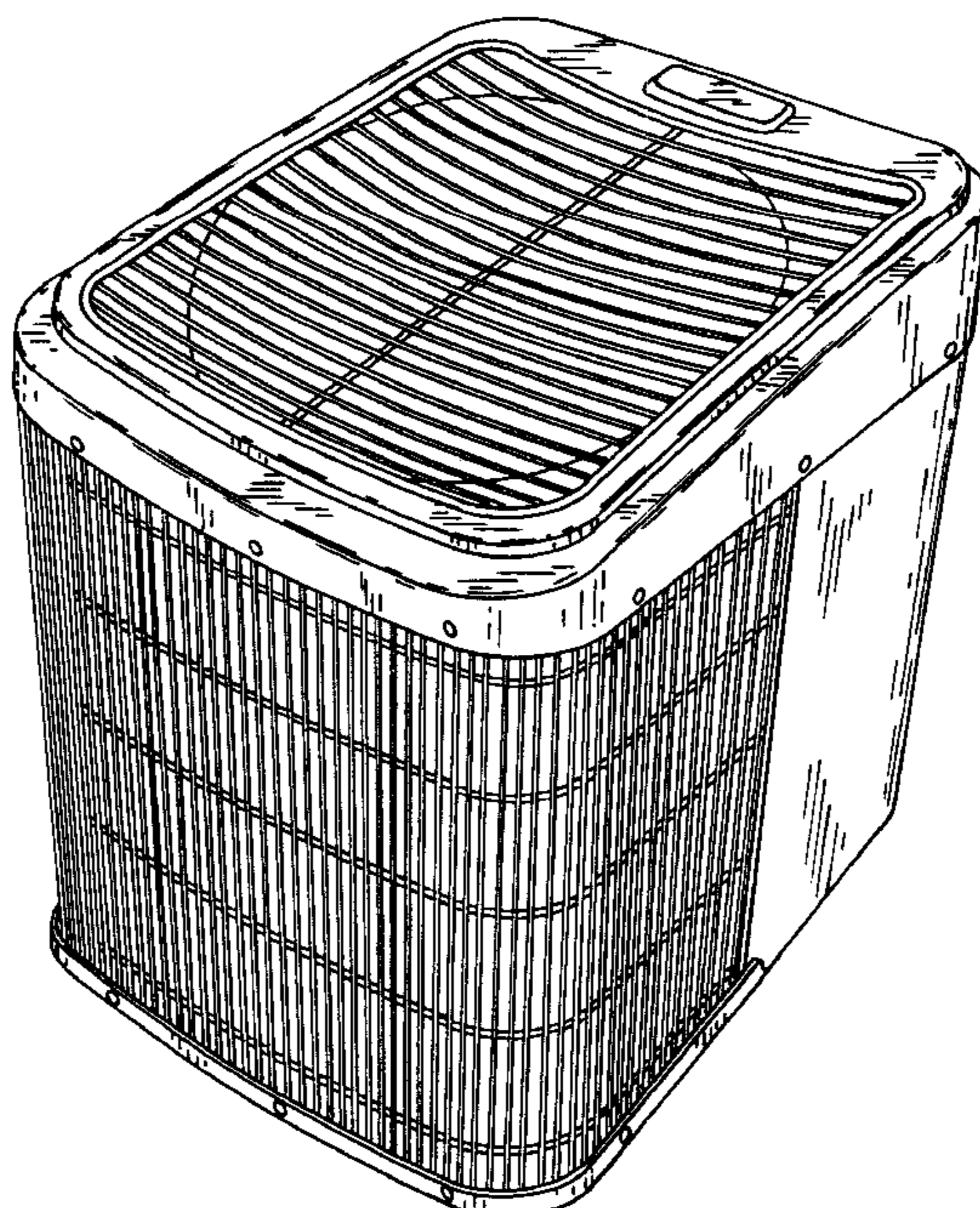
FIG. 5 is a left side elevational view of the configuration shown in FIG. 1;

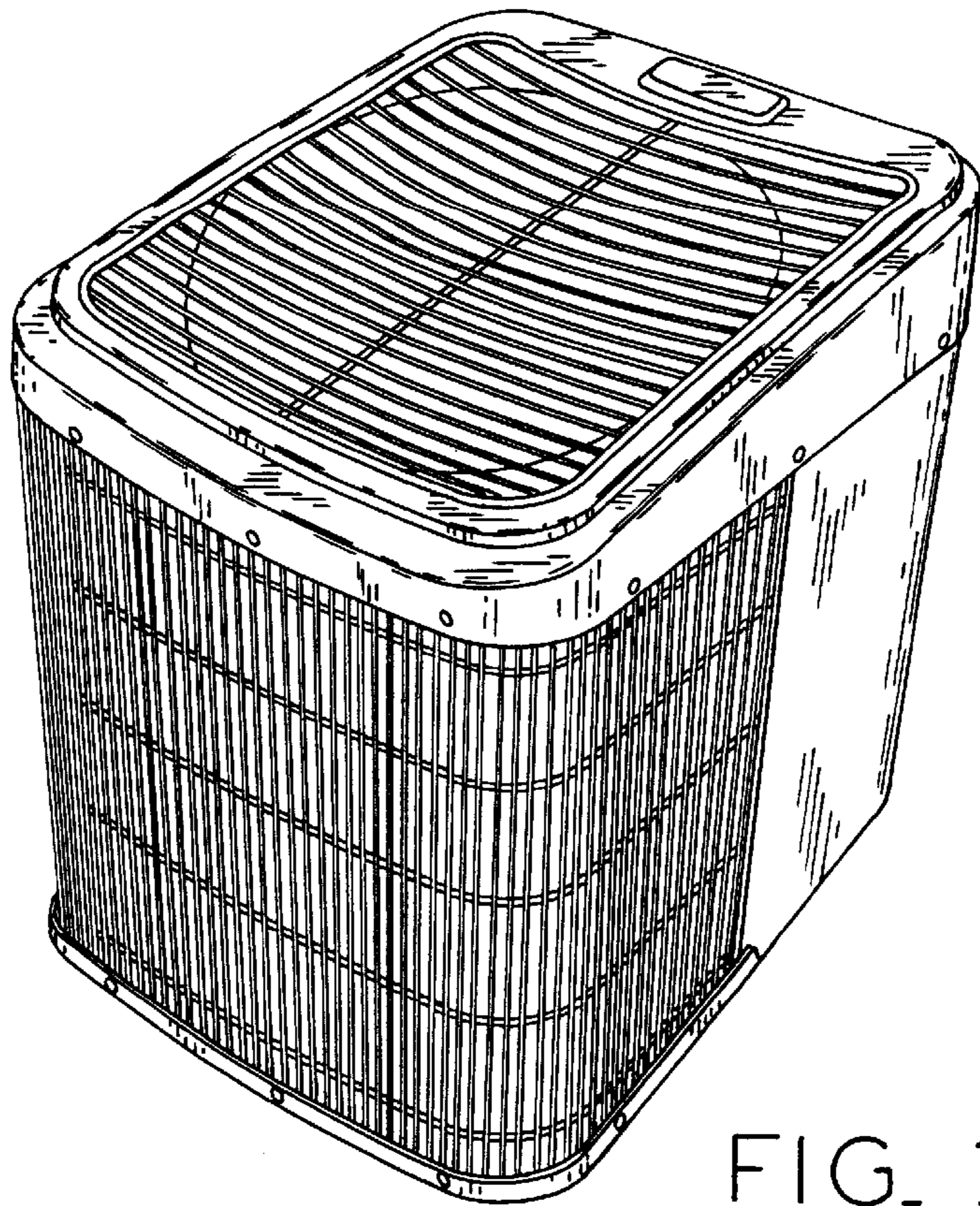

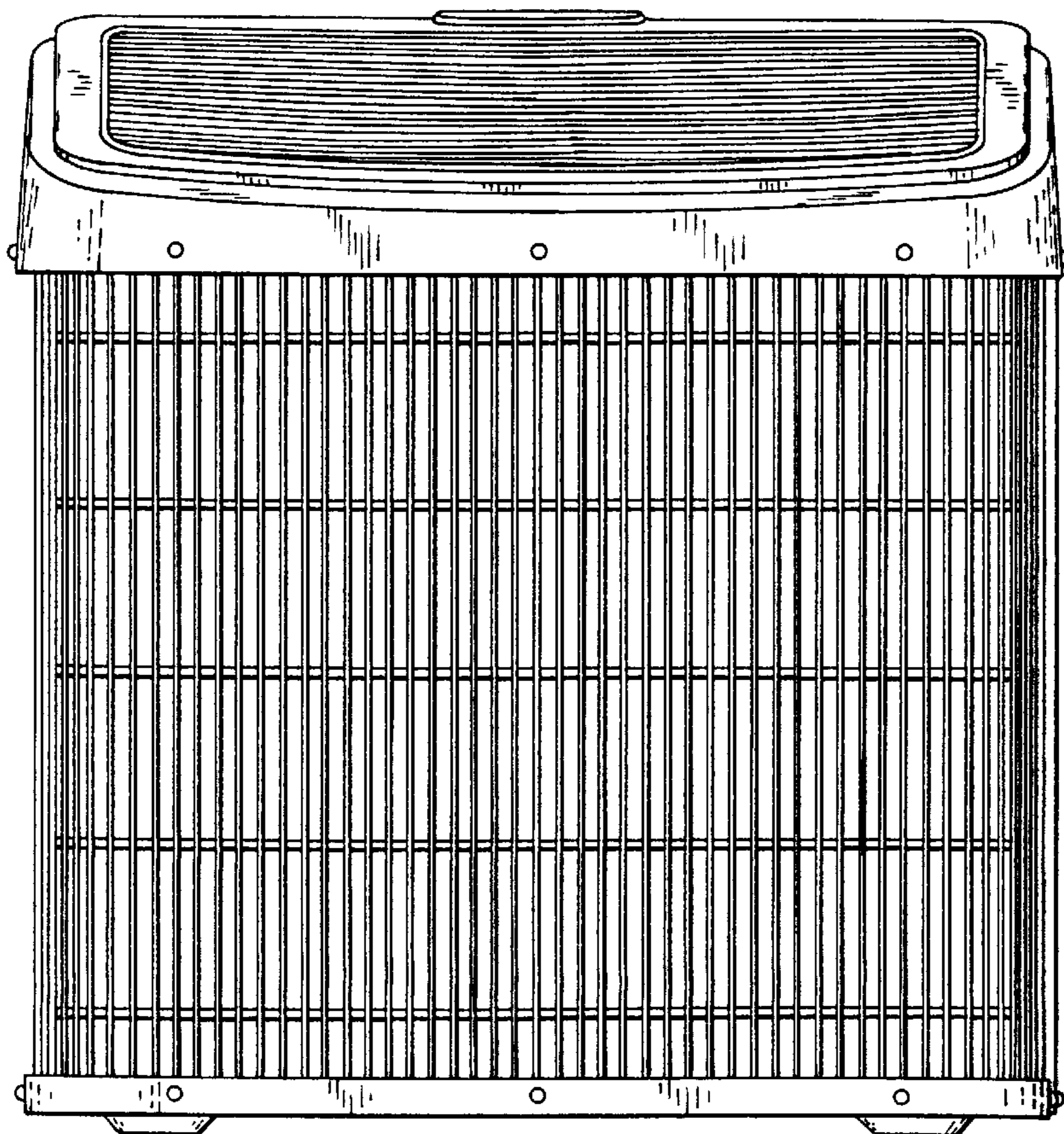

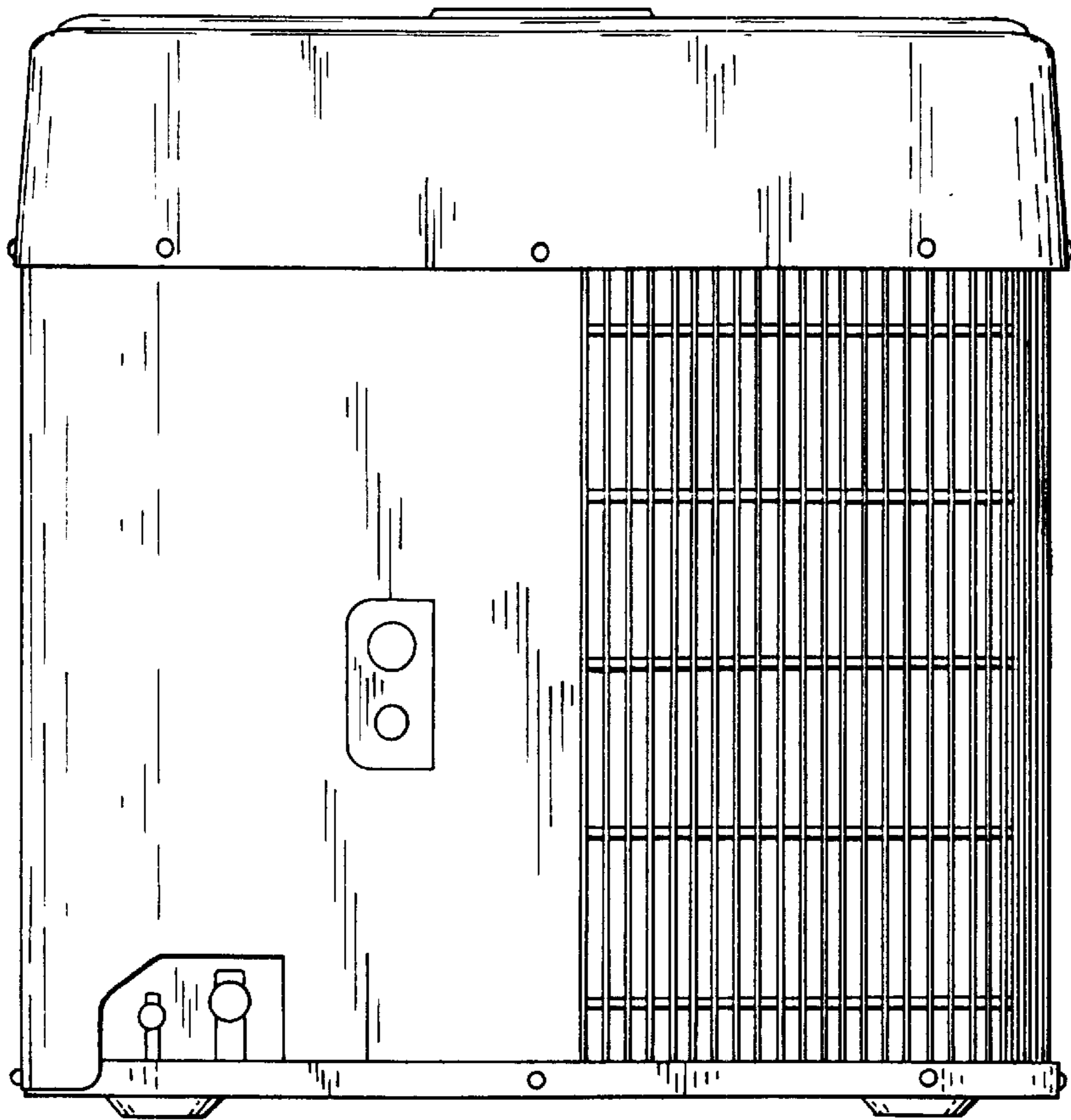

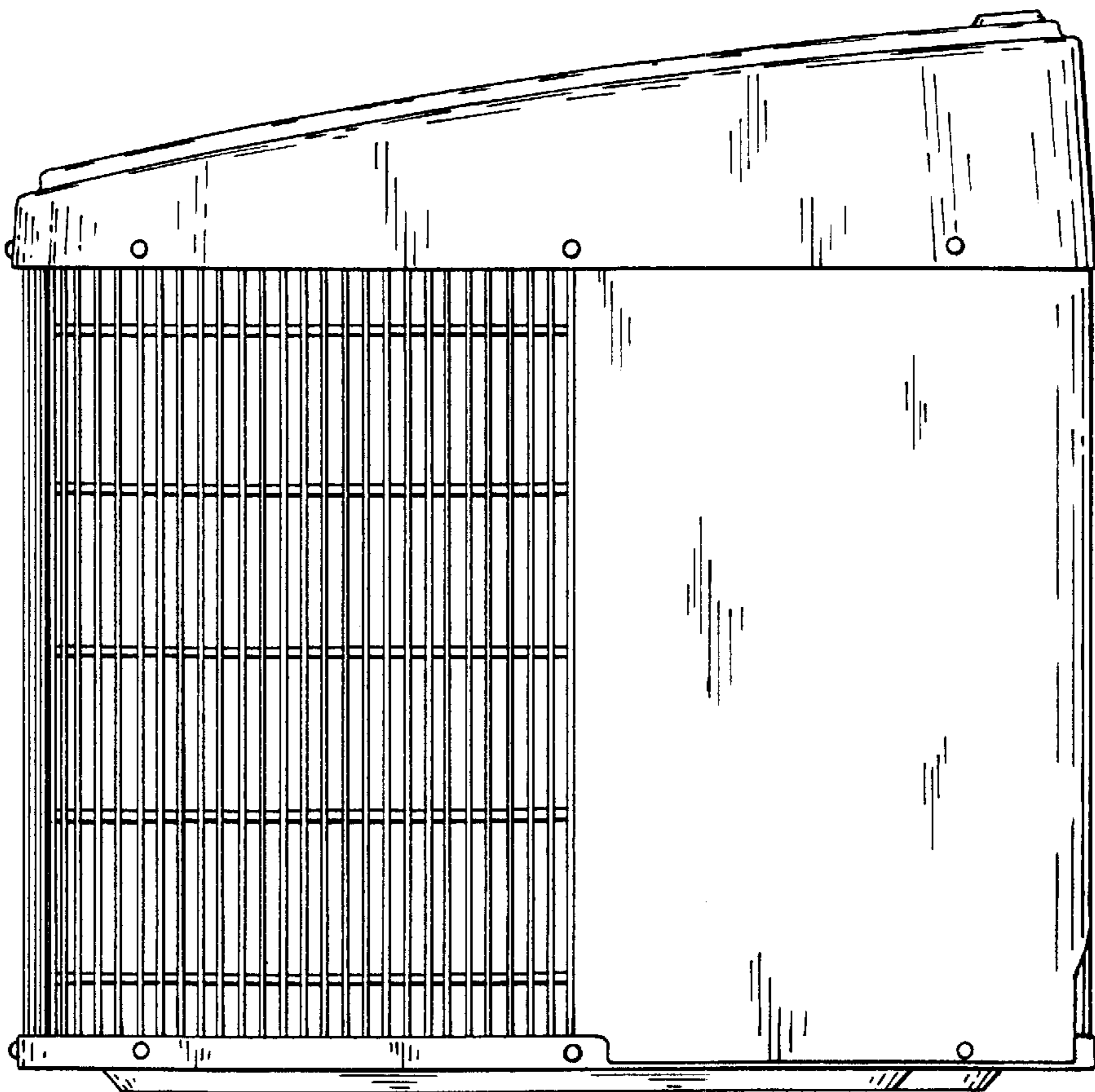

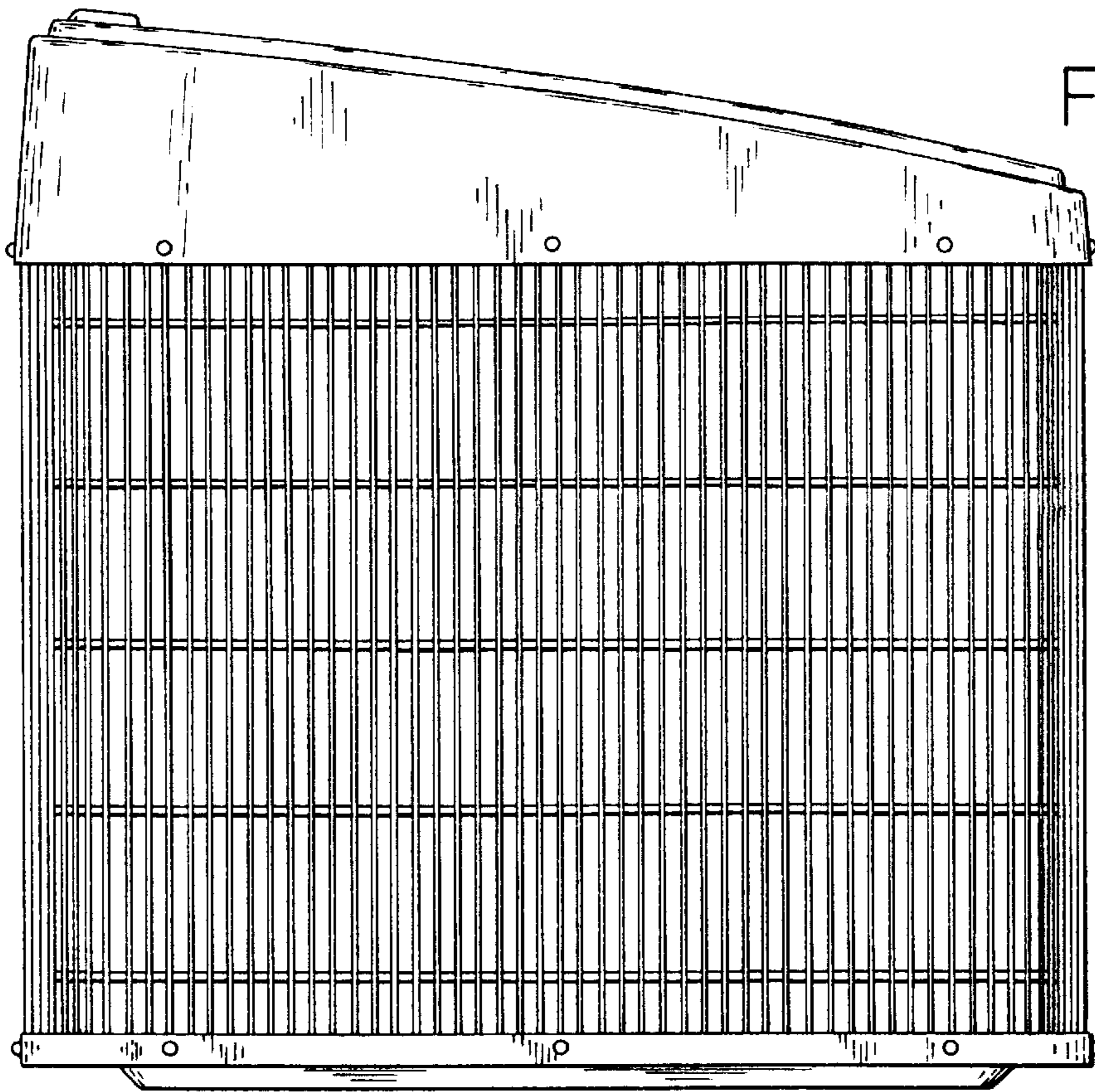

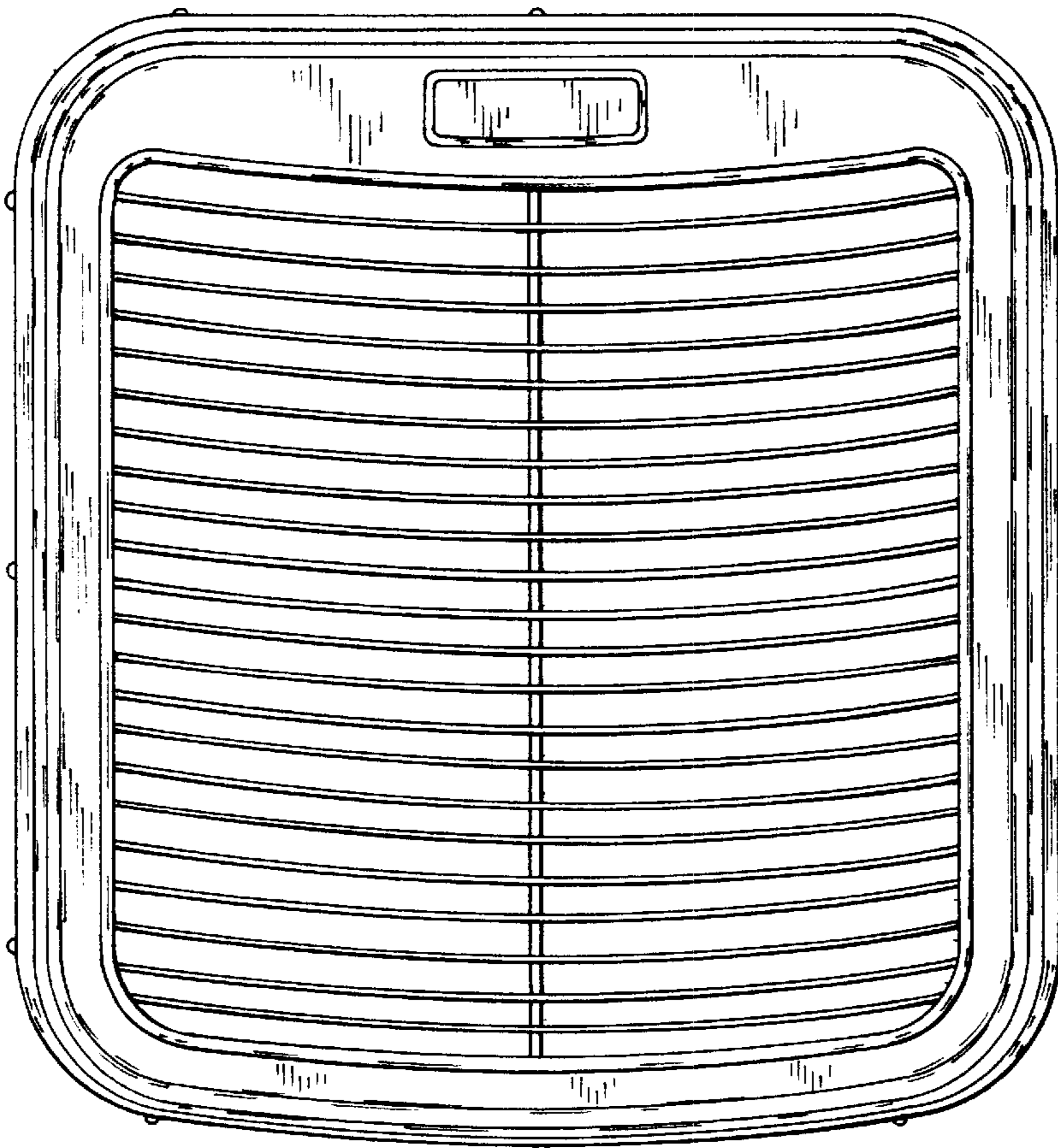

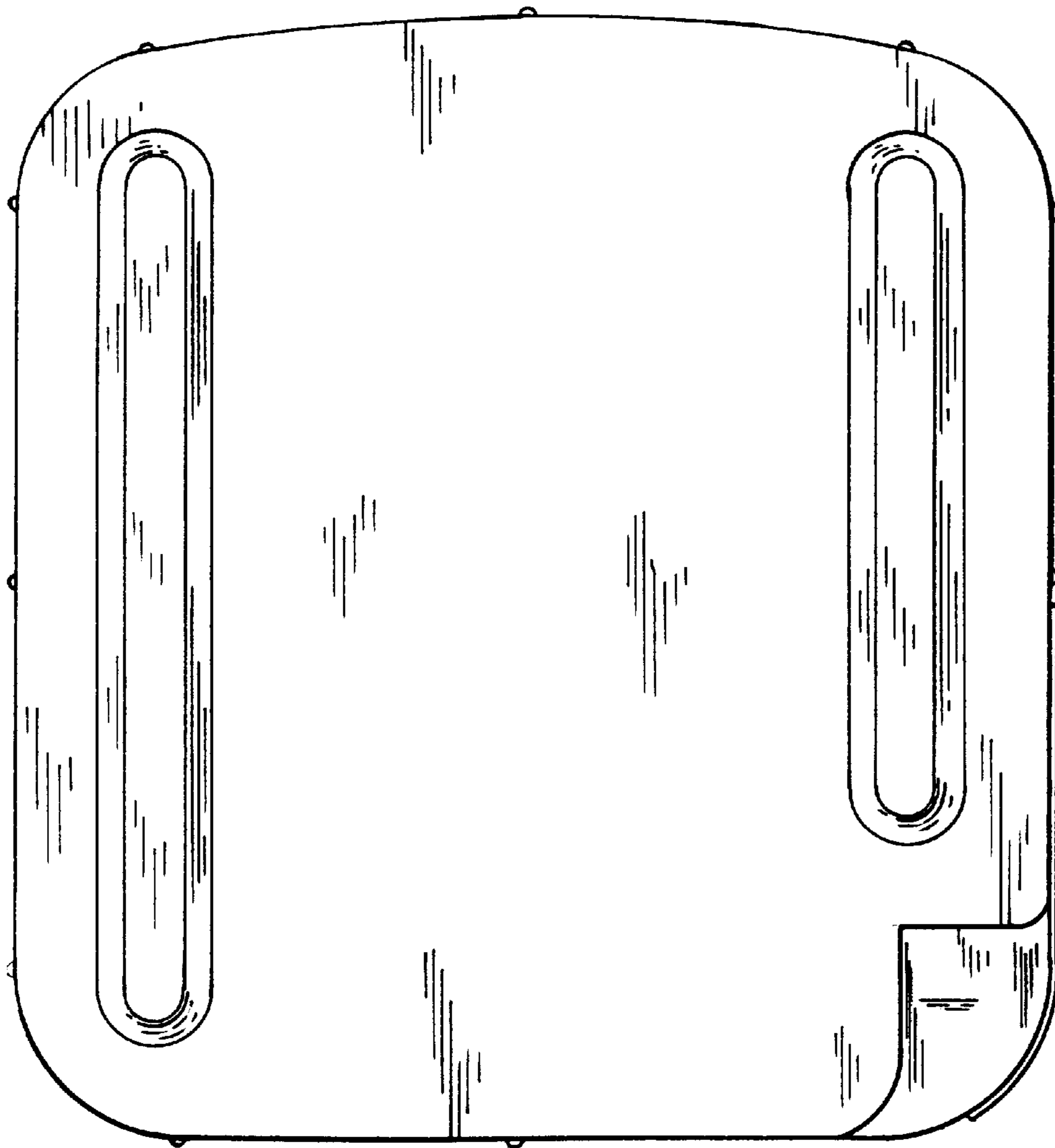
