FIG. 2 is a top view thereof;

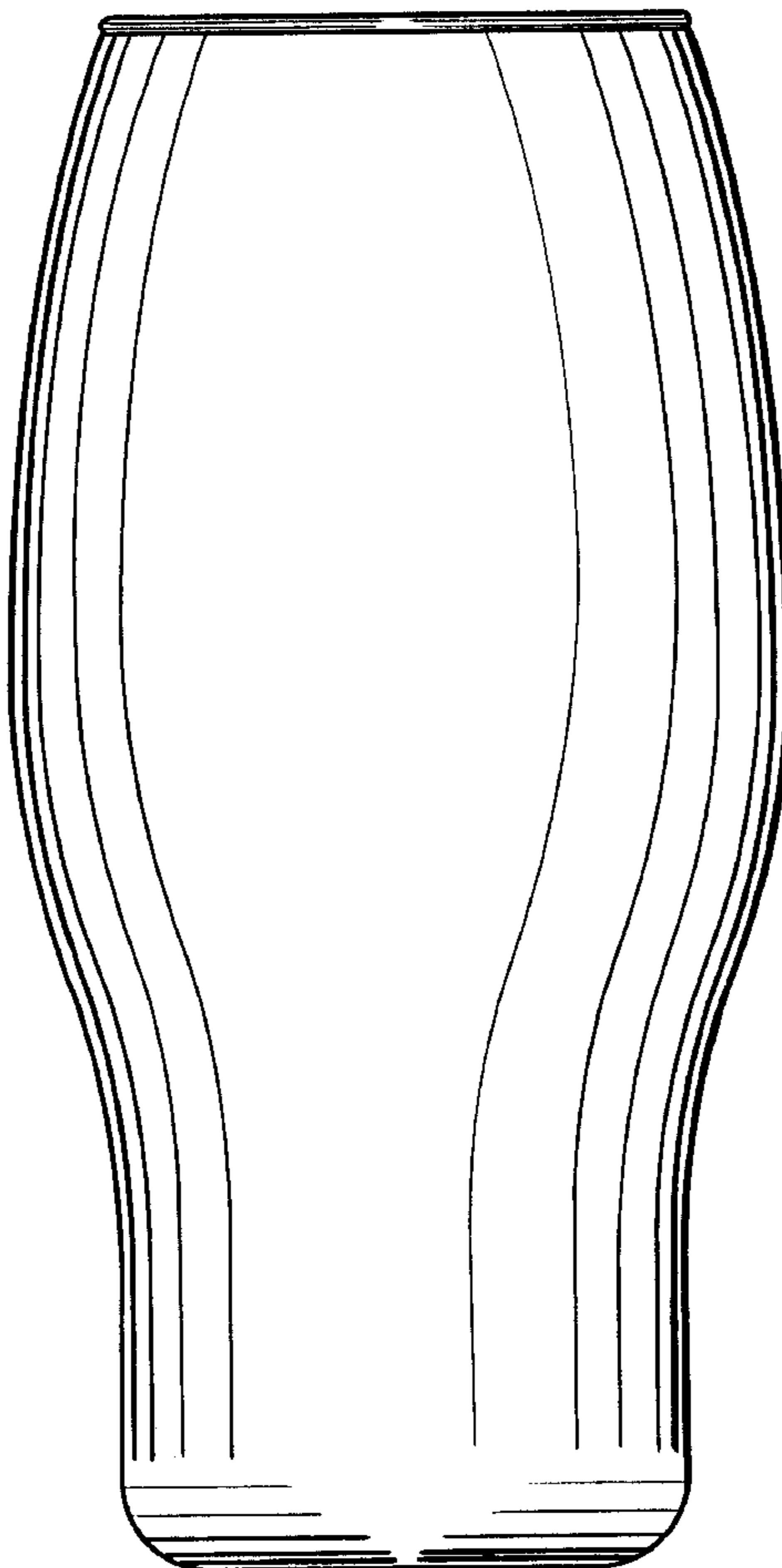
FIG. 3 is a bottom view thereof;

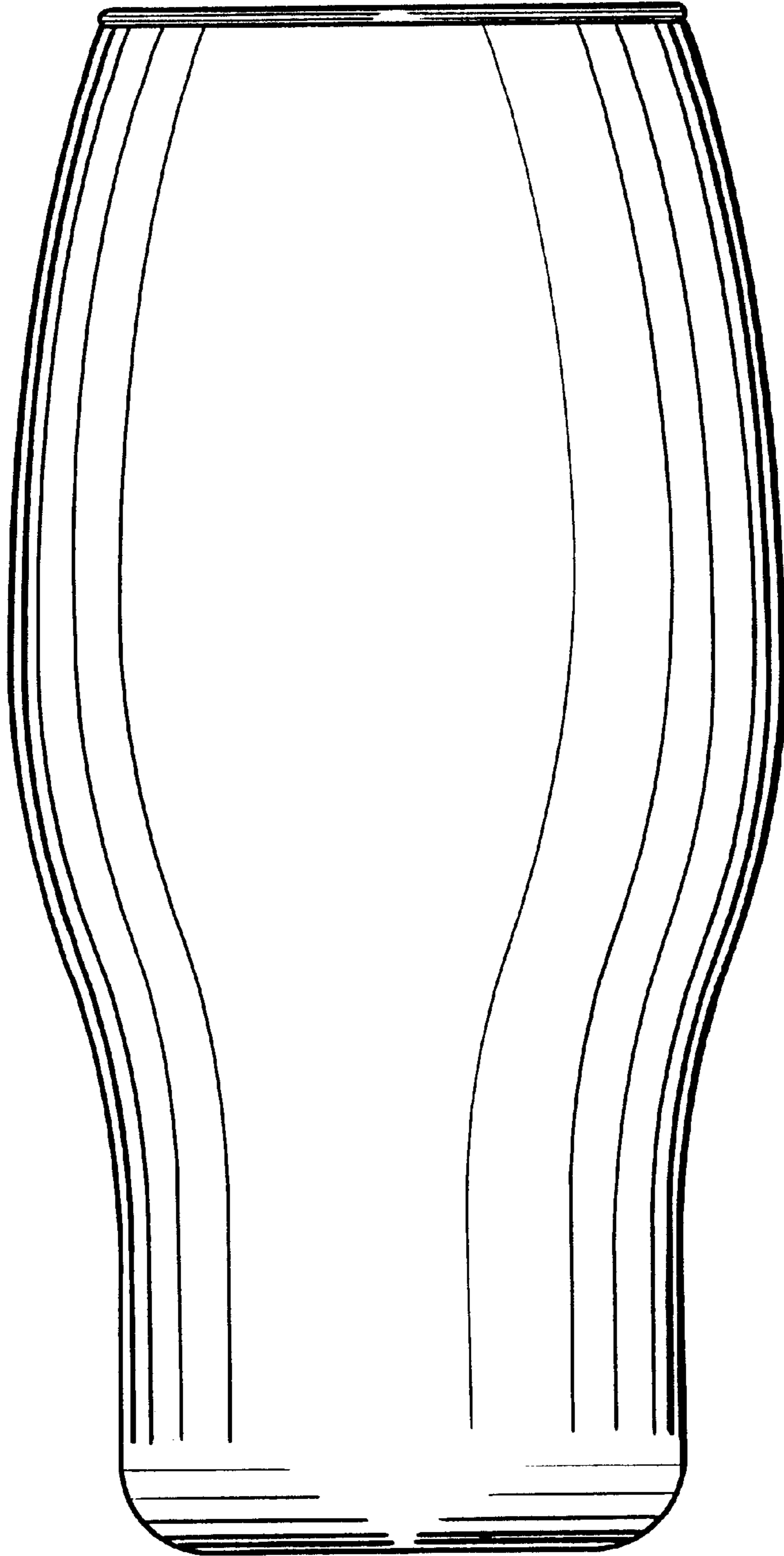
FIG. 4 is a side elevational view of a second embodiment glass according to the present design; the other side elevational views being the same;

FIG. 5 is a top view thereof; and,

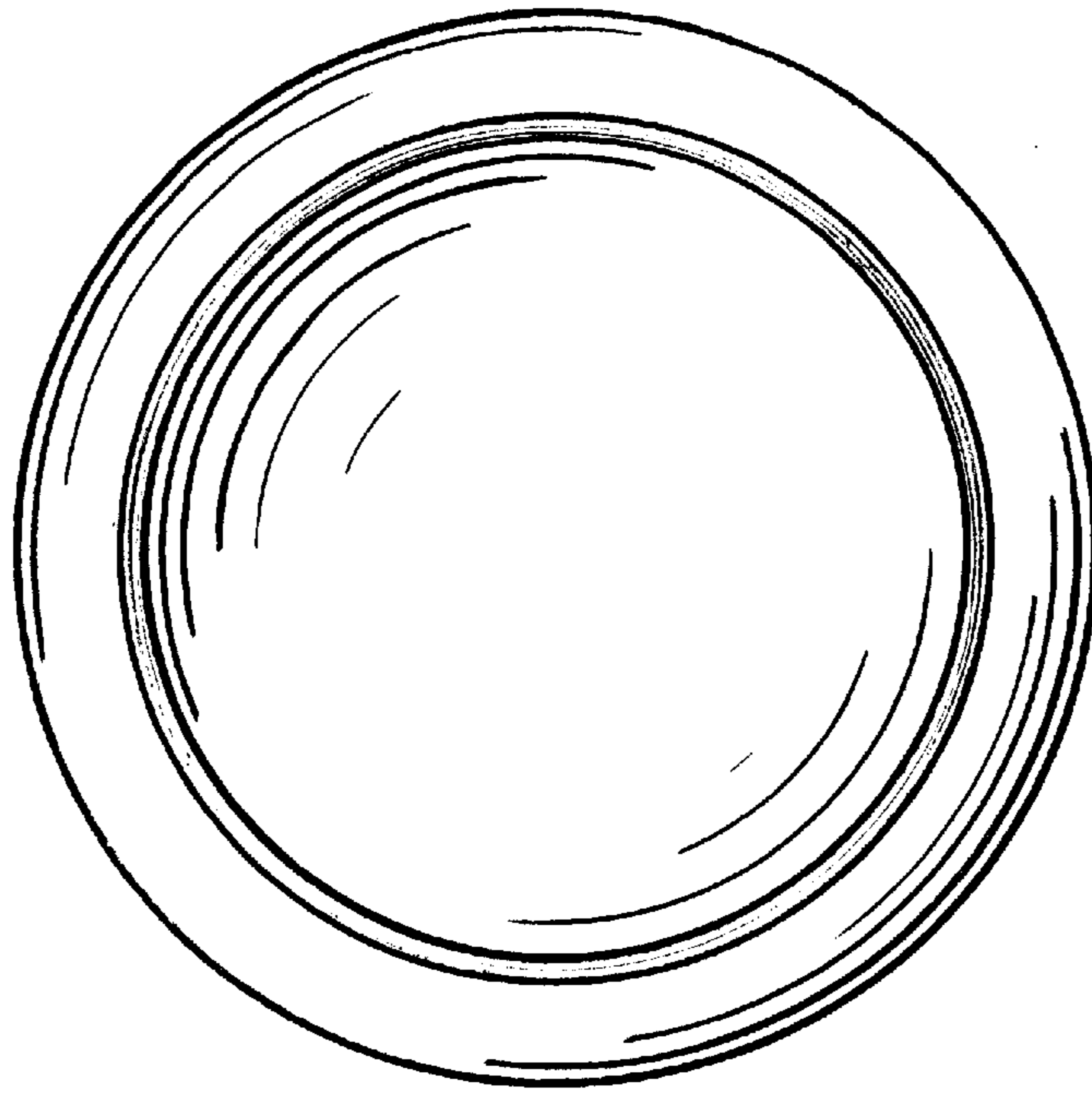
FIG. 6 is a bottom view thereof.

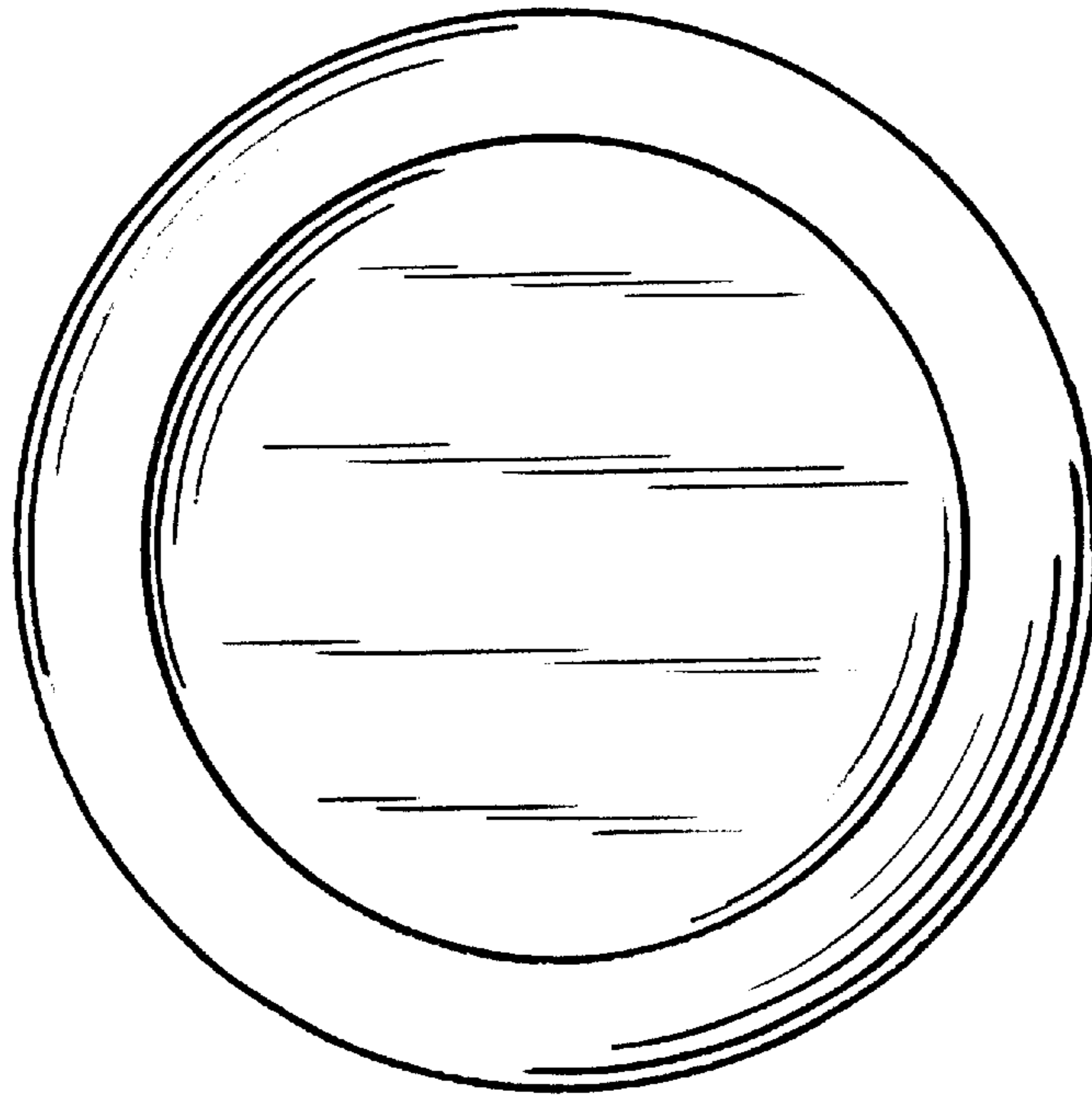




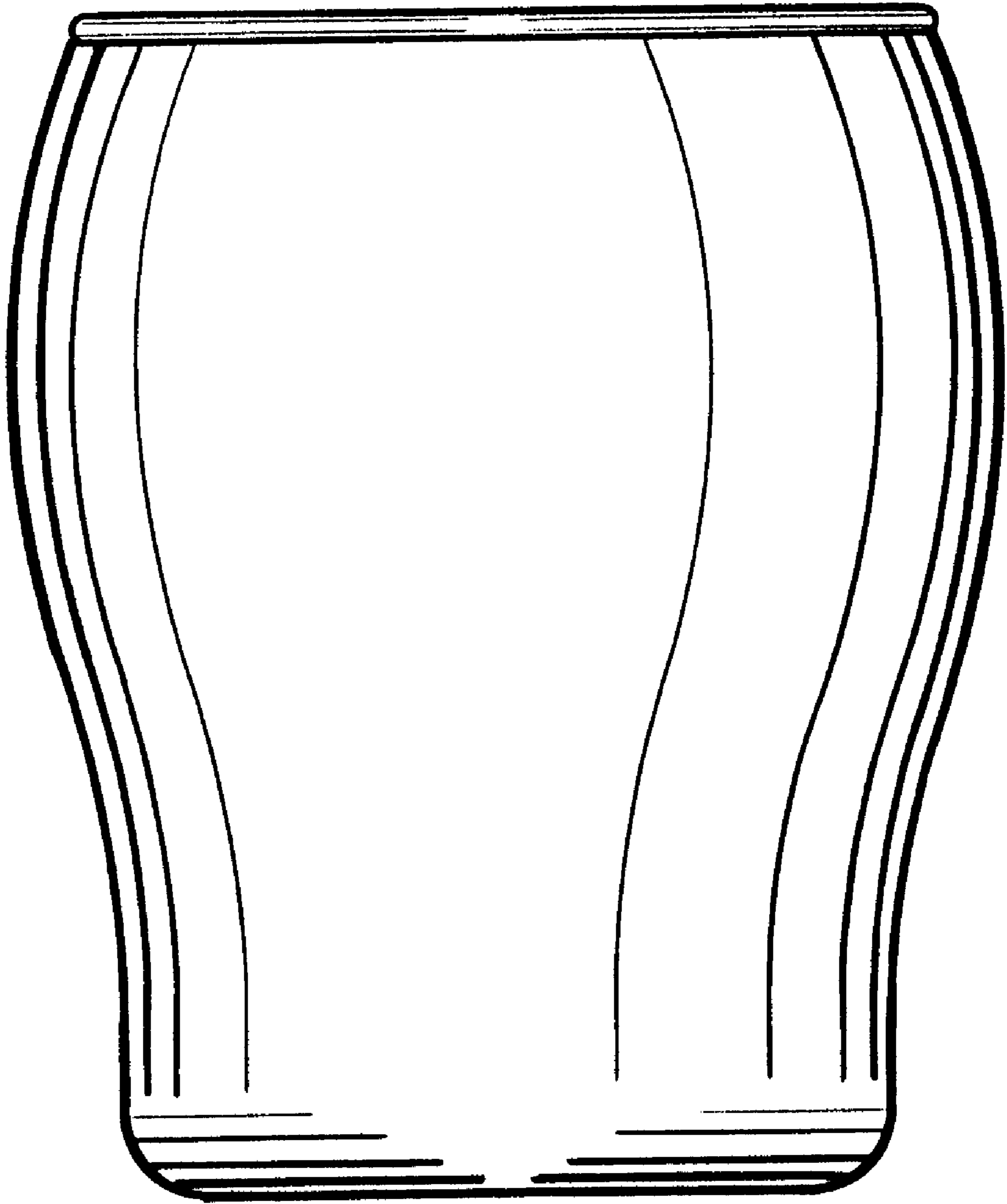

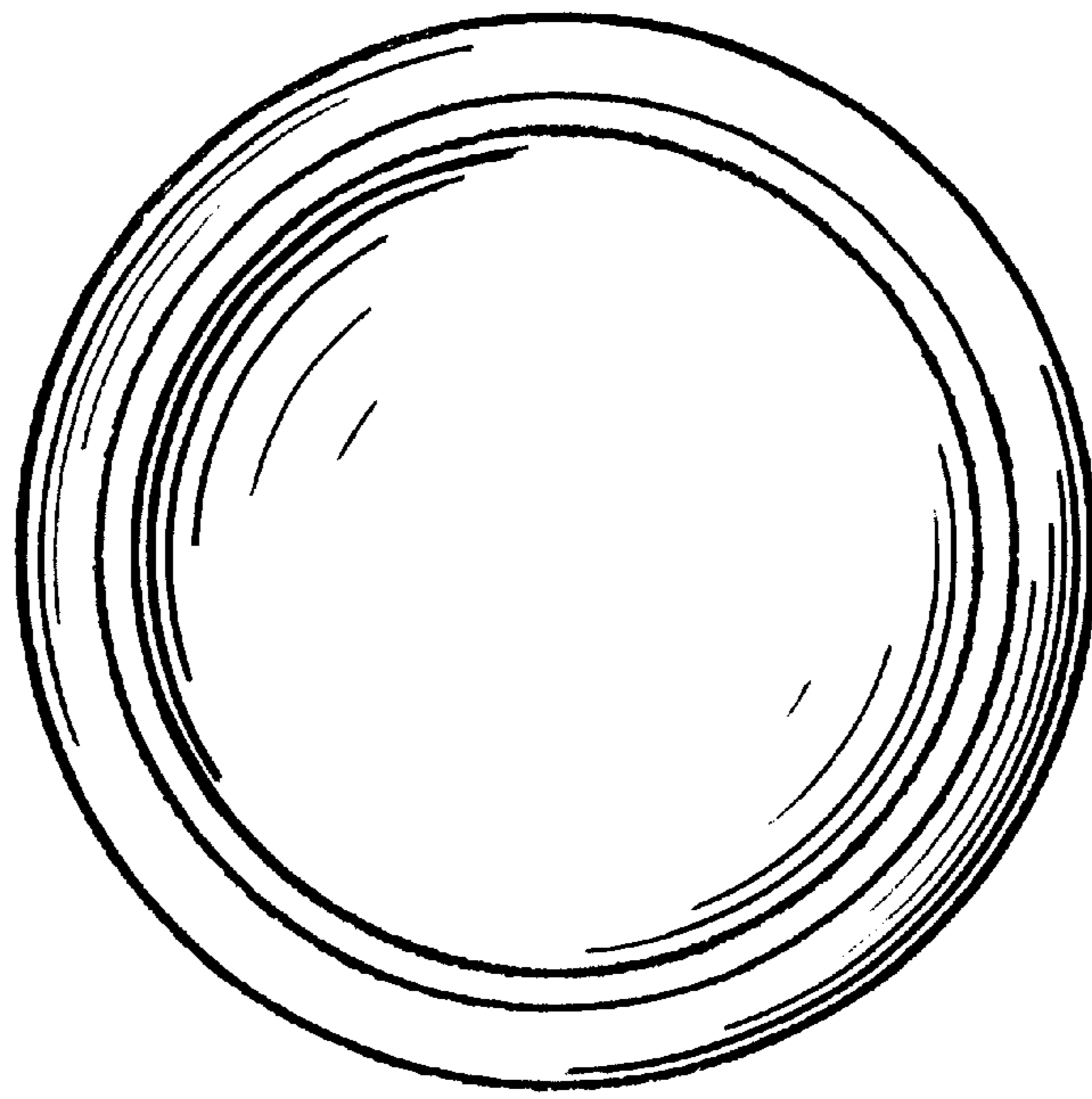

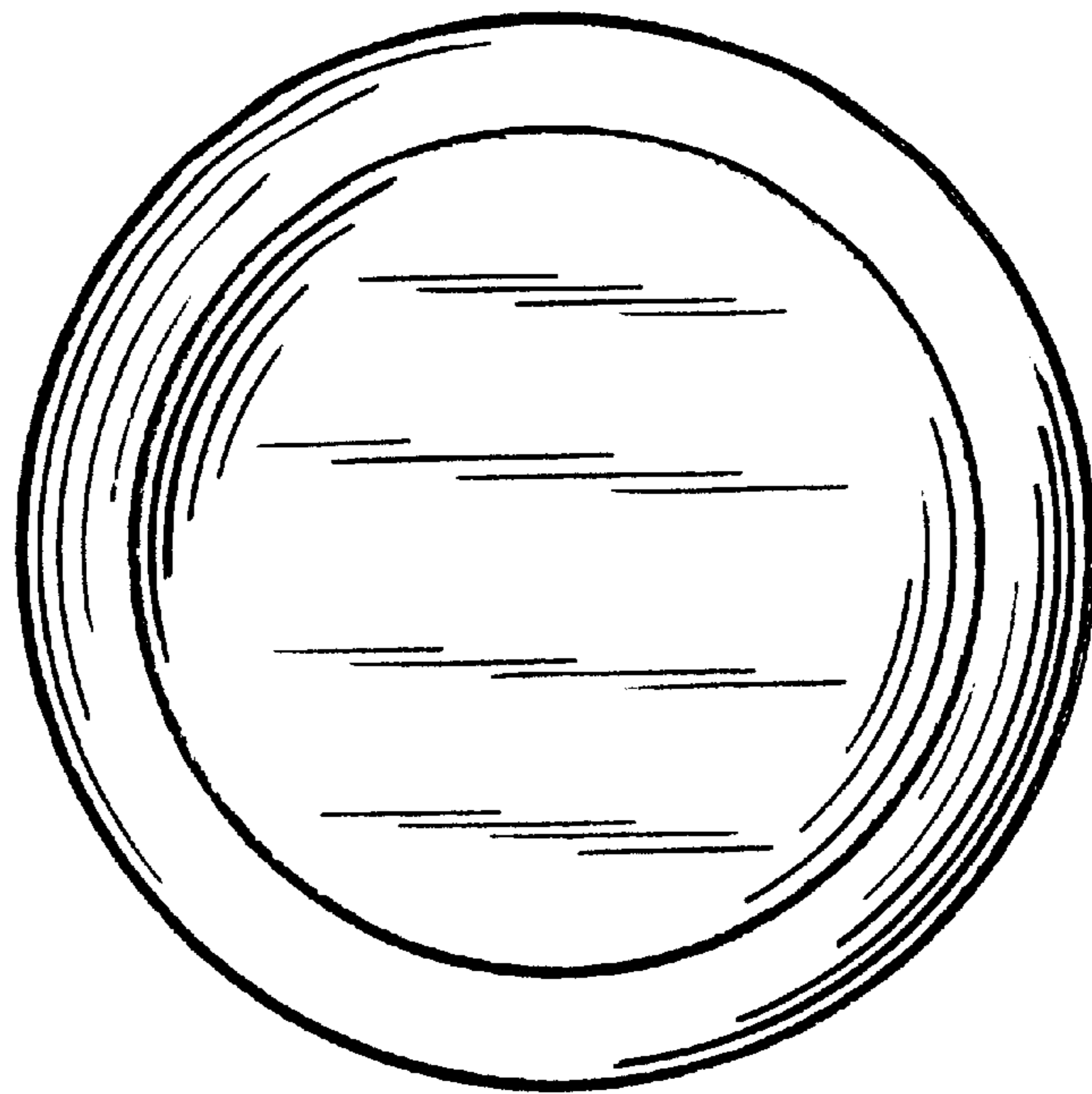
