The ornamental design for a package for liquid foodstuffs, as shown and described.

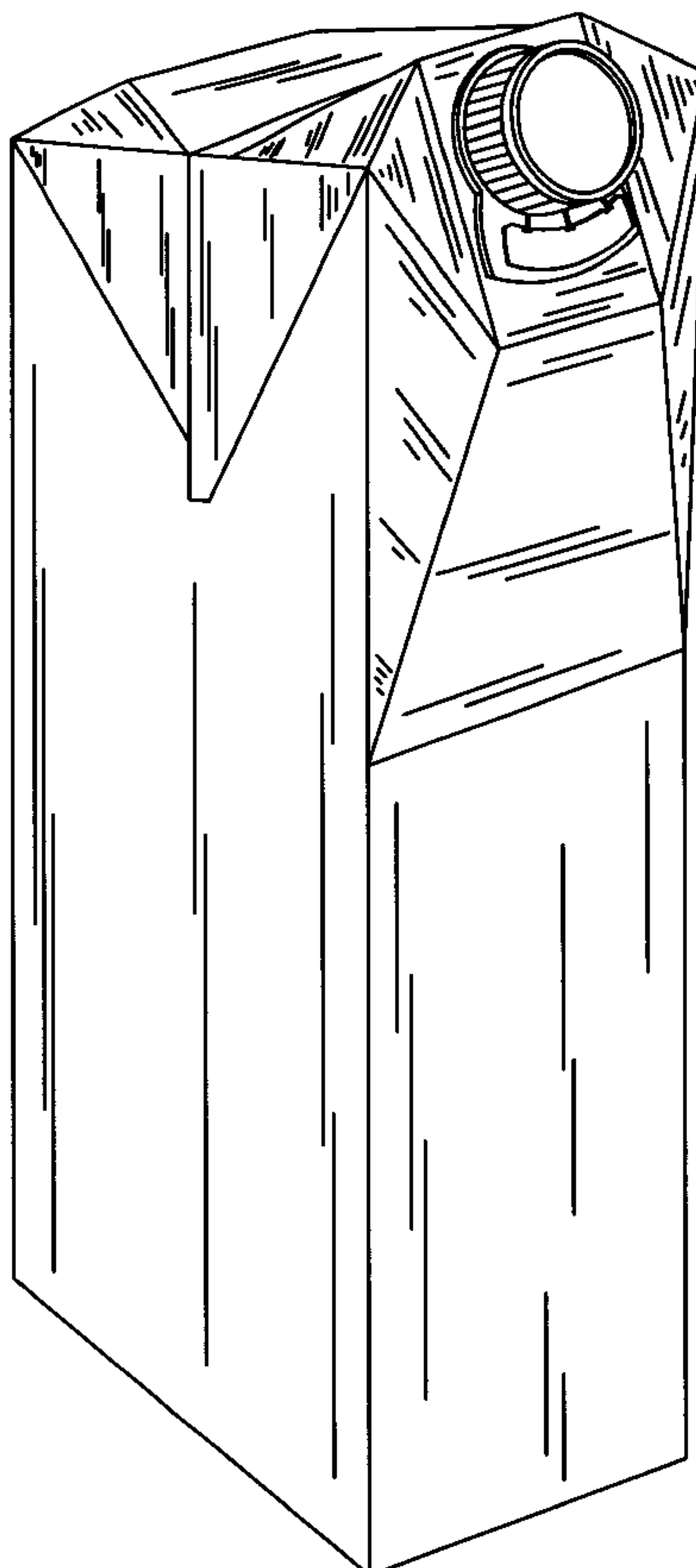
DESCRIPTION

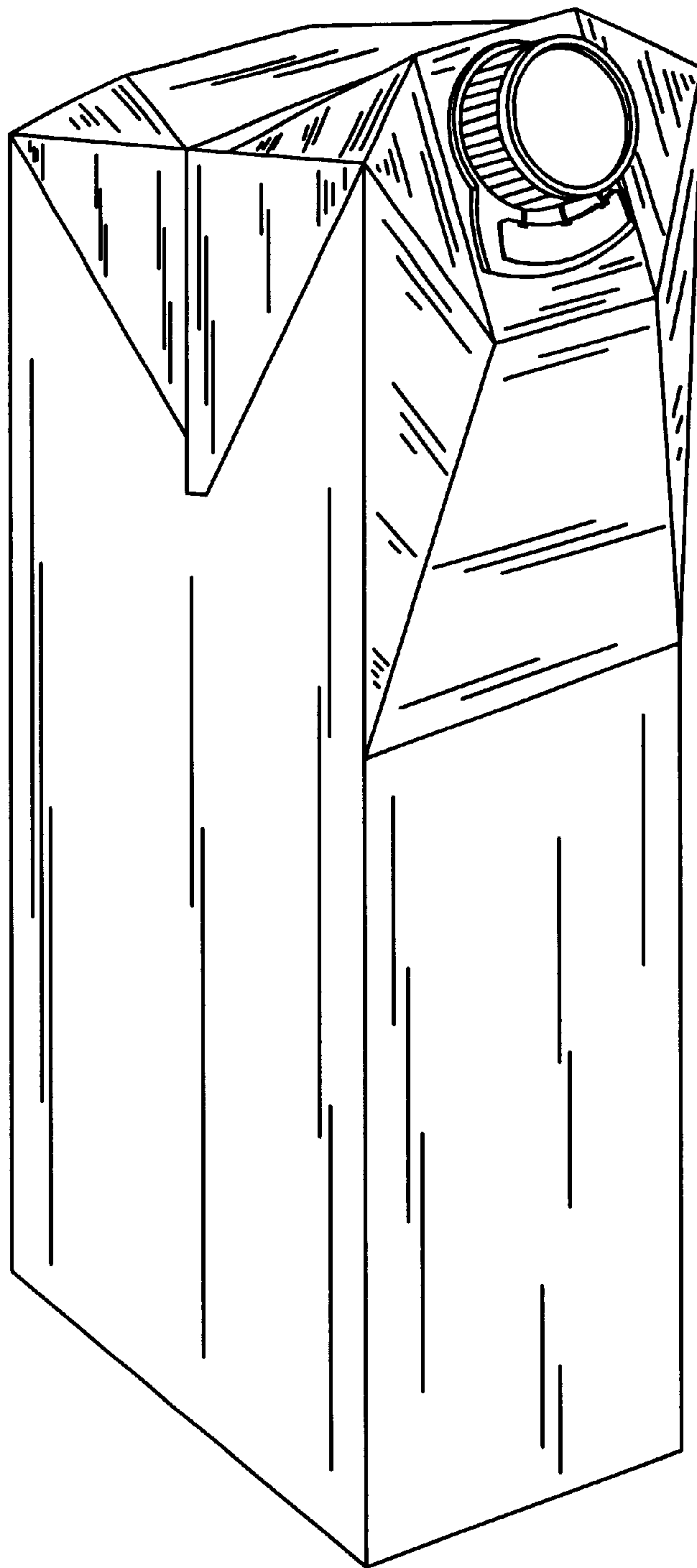

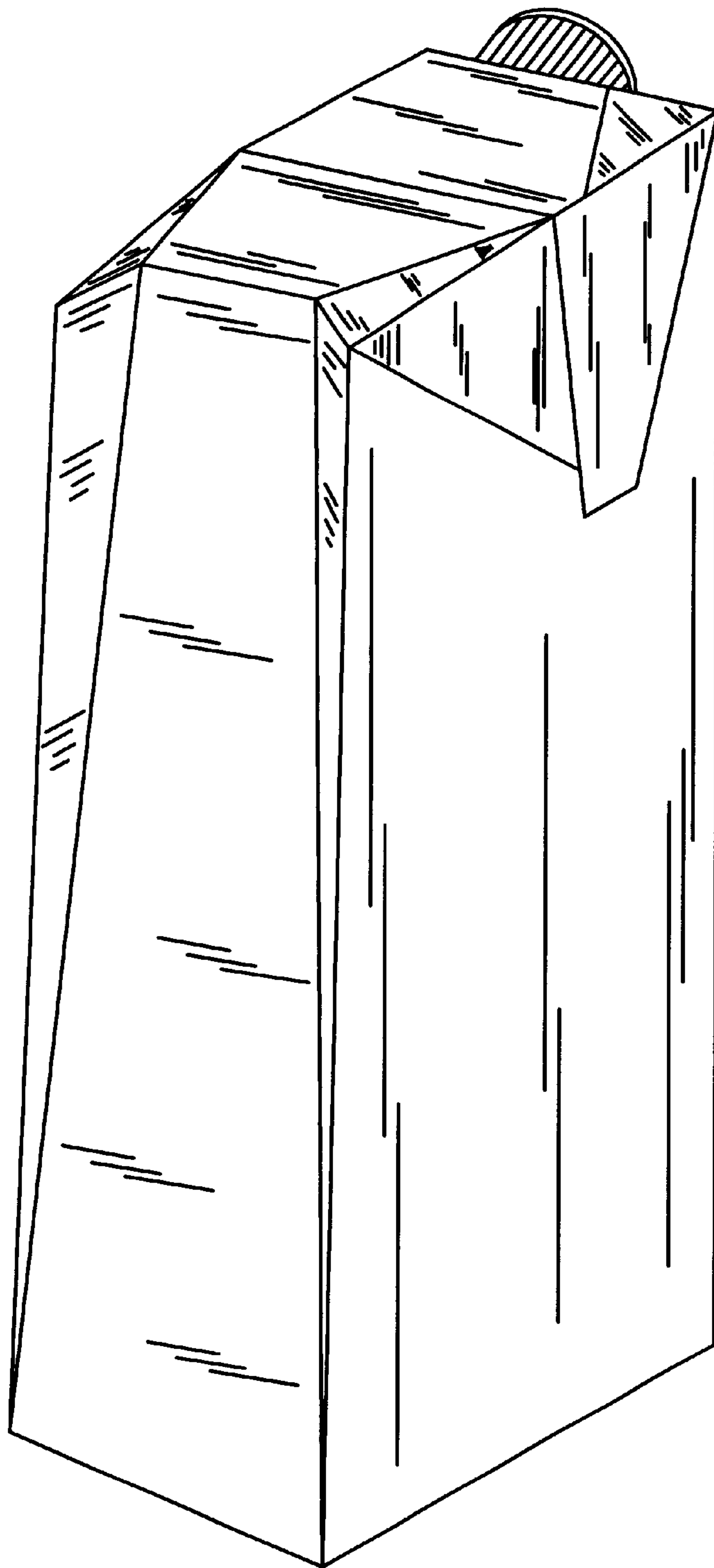

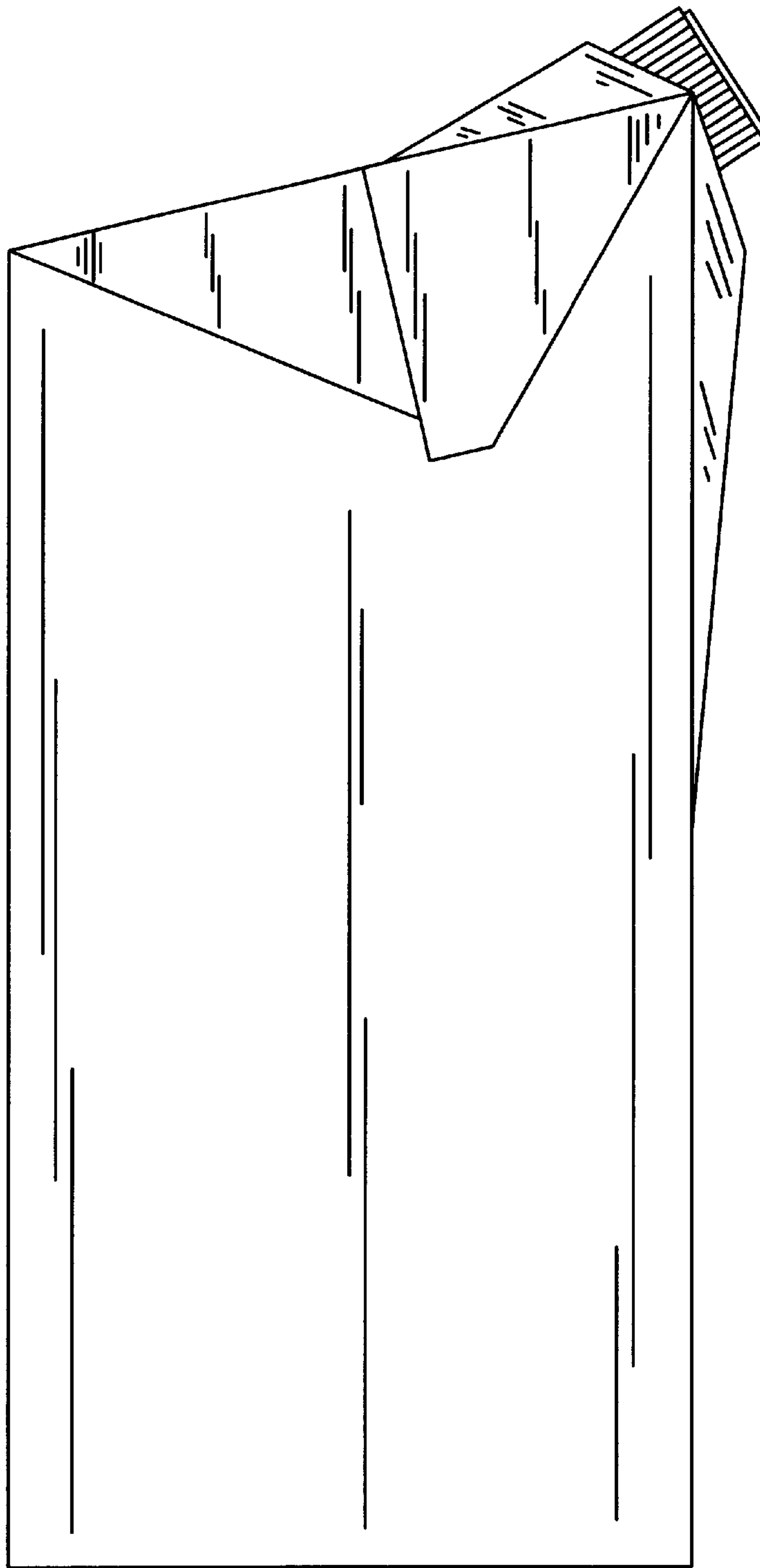
