DESCRIPTION

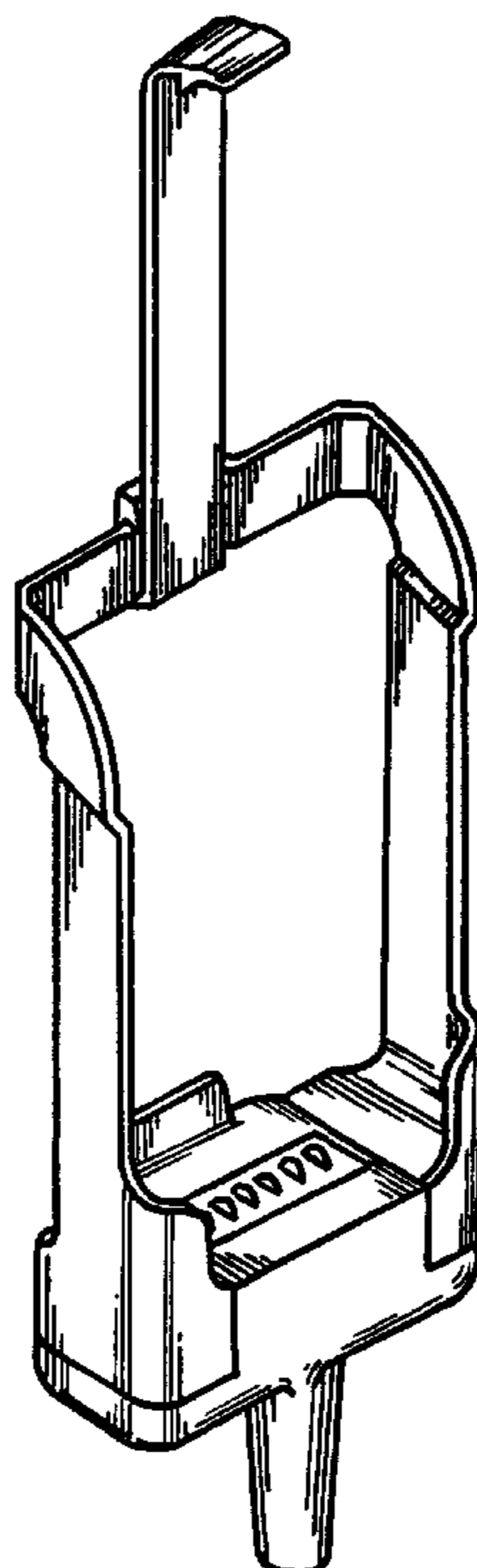
FIG. 1 is a top left perspective view of the present phone connector assembly;

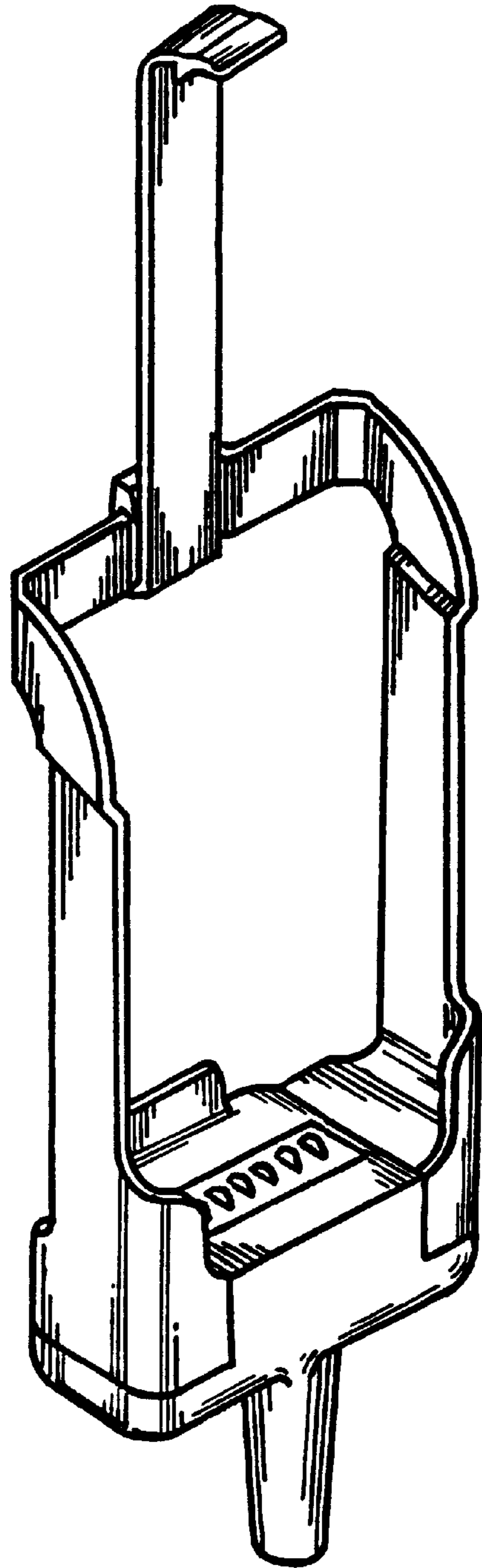

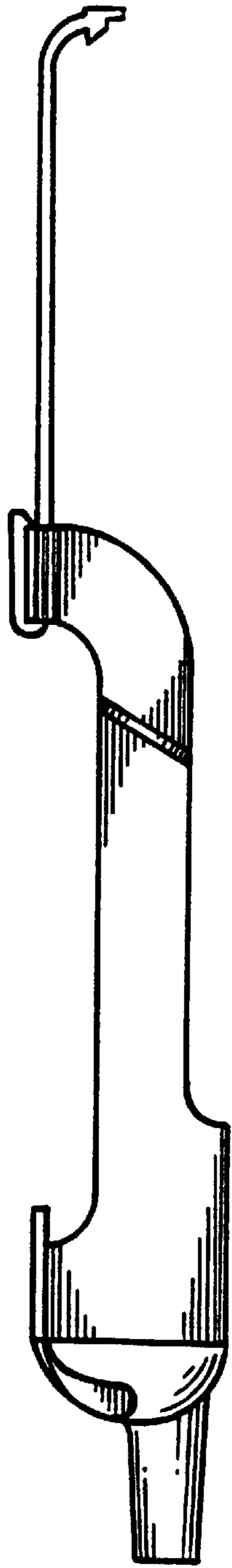

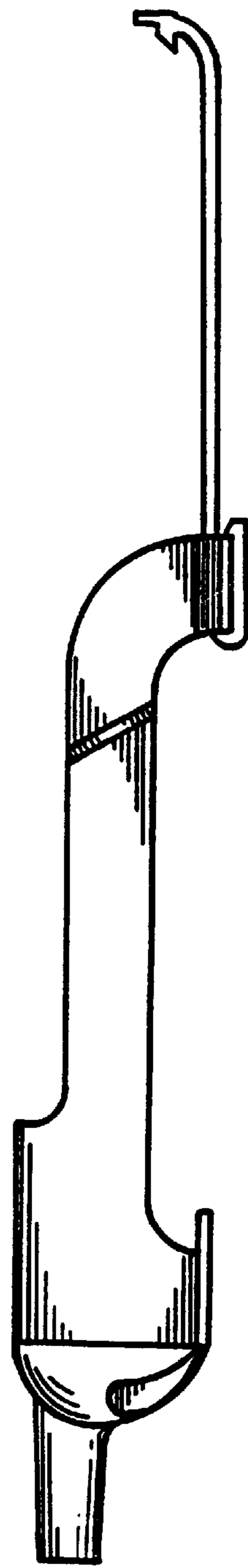

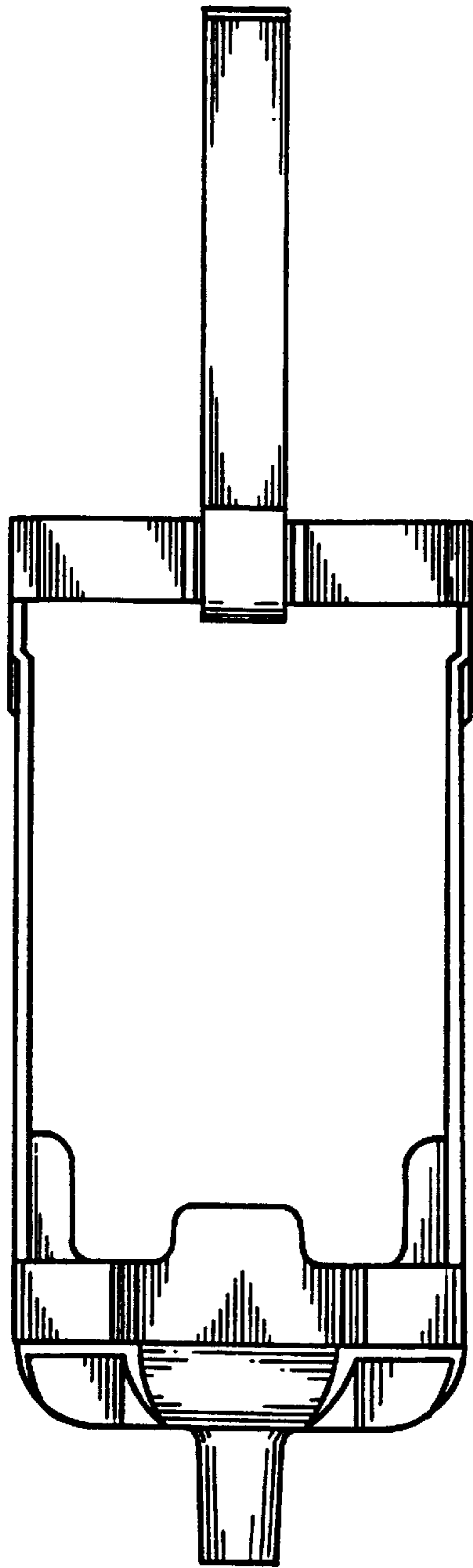

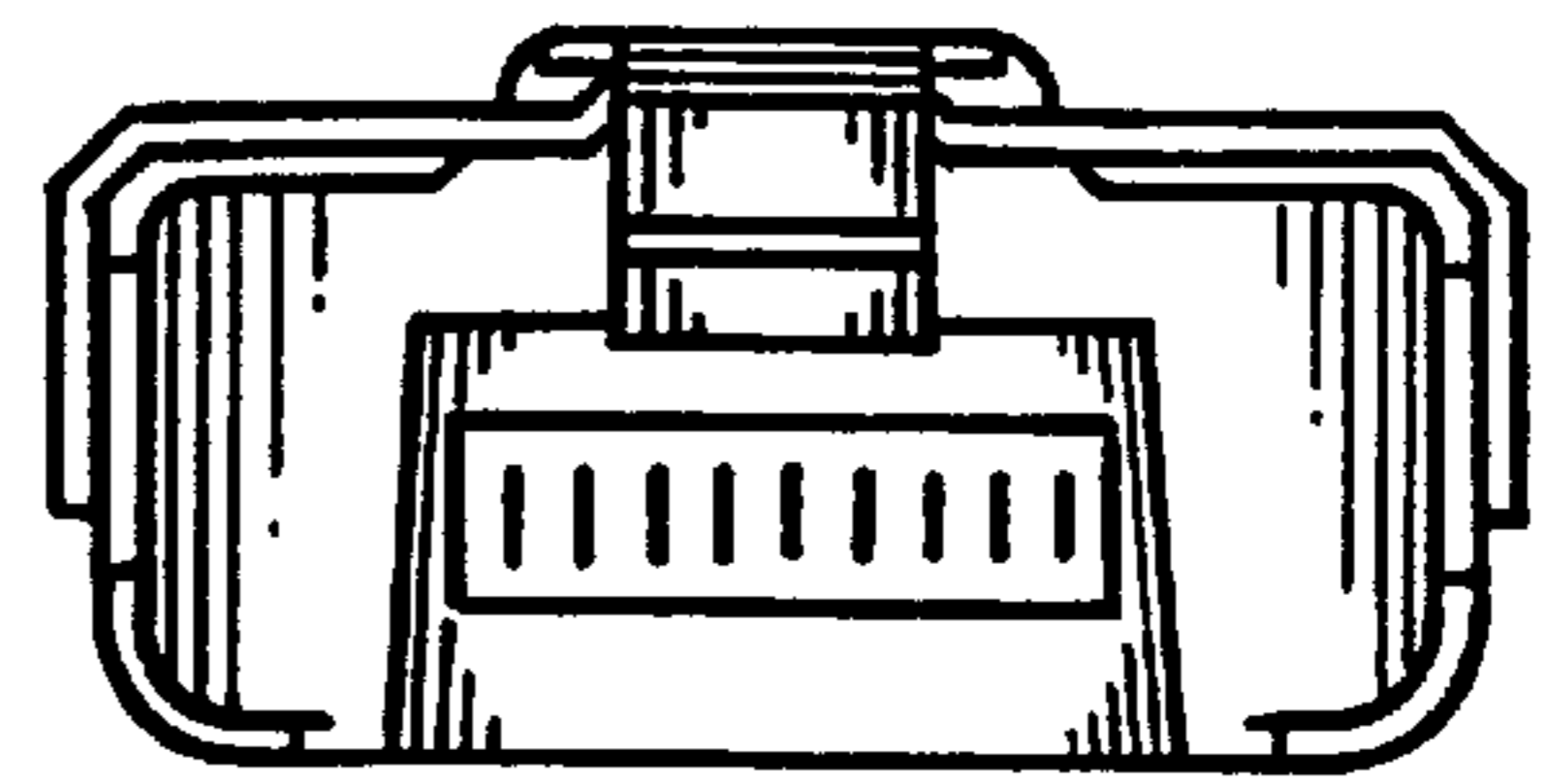

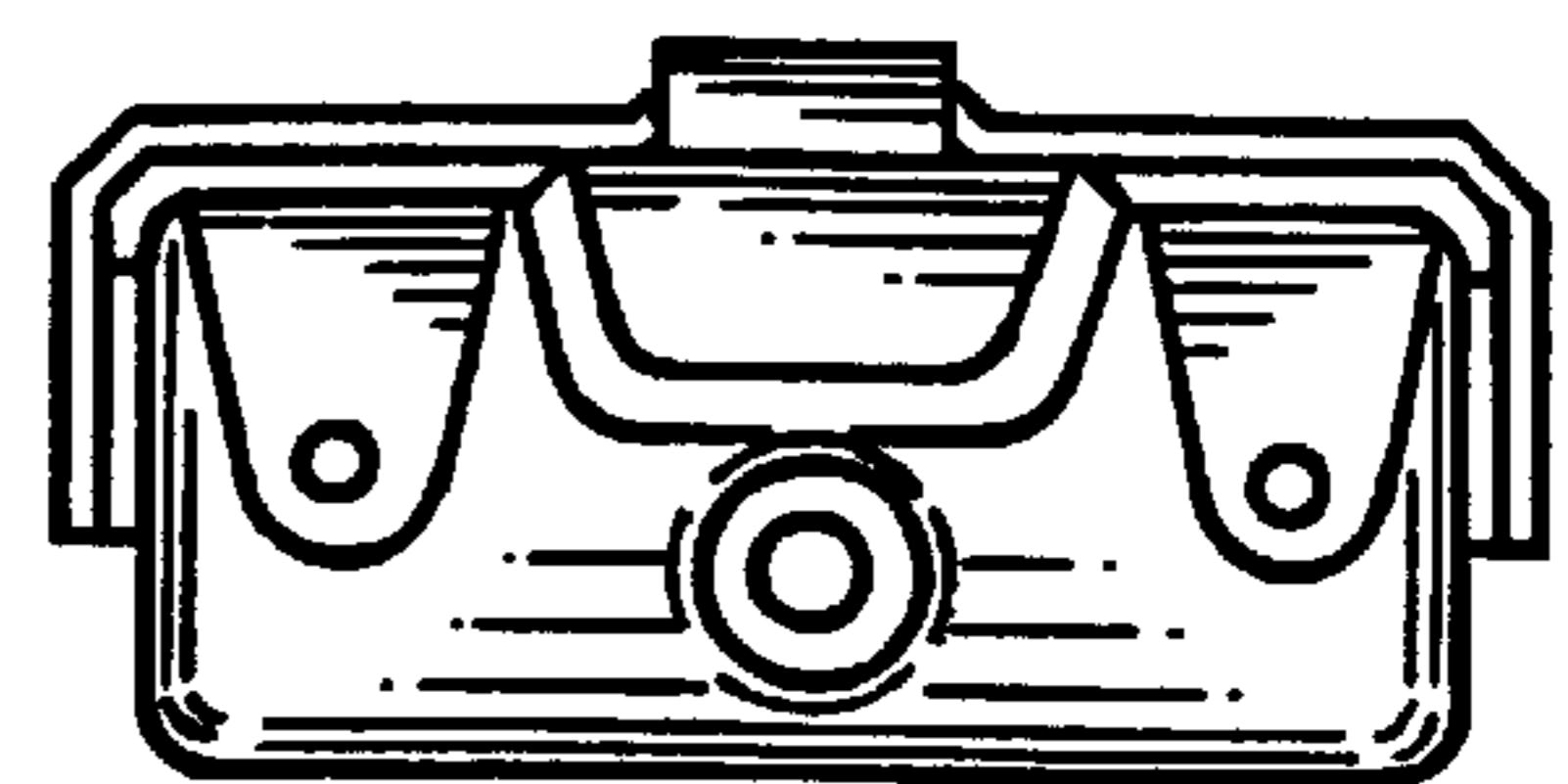
