FIG. 5 is a left side elevational view thereof;

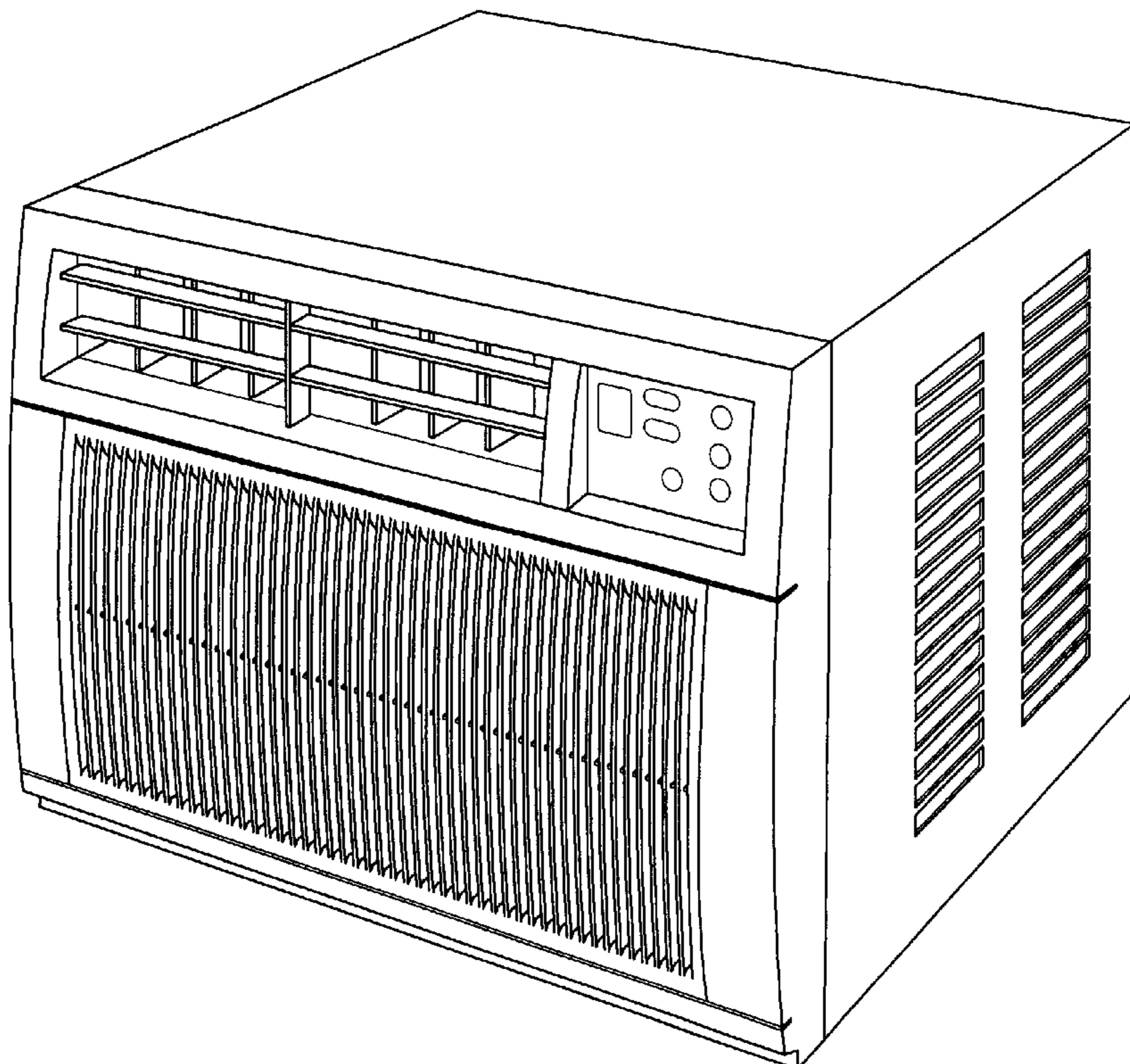
FIG. 6 is a right side elevational view thereof;

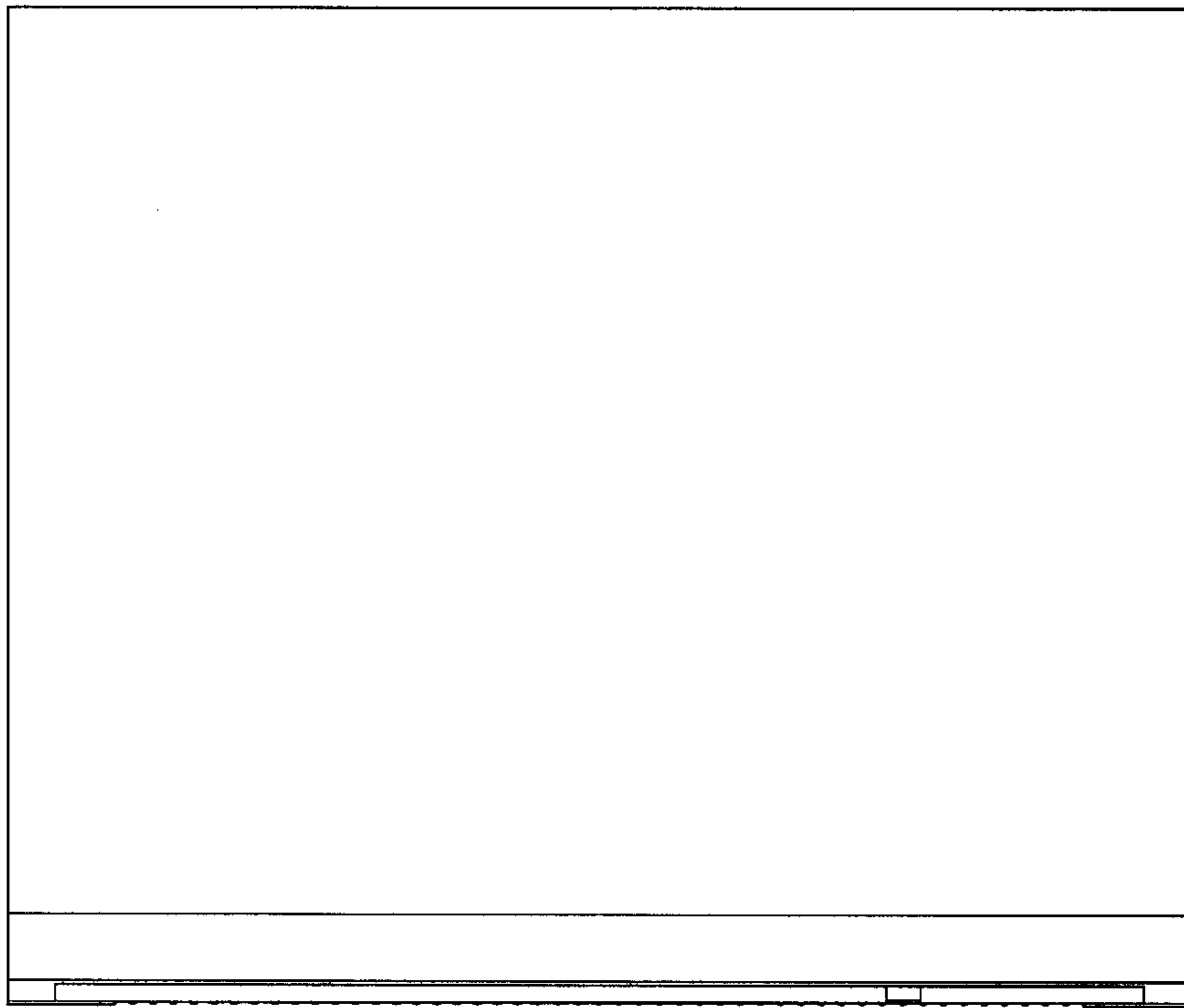
FIG. 7 is a sectional view taken on line 7—7 of FIG. 3 where the internal mechanism has been omitted;

FIG. 8 is a sectional view taken on line 8—8 of FIG. 3 where the internal mechanism has been omitted; and,

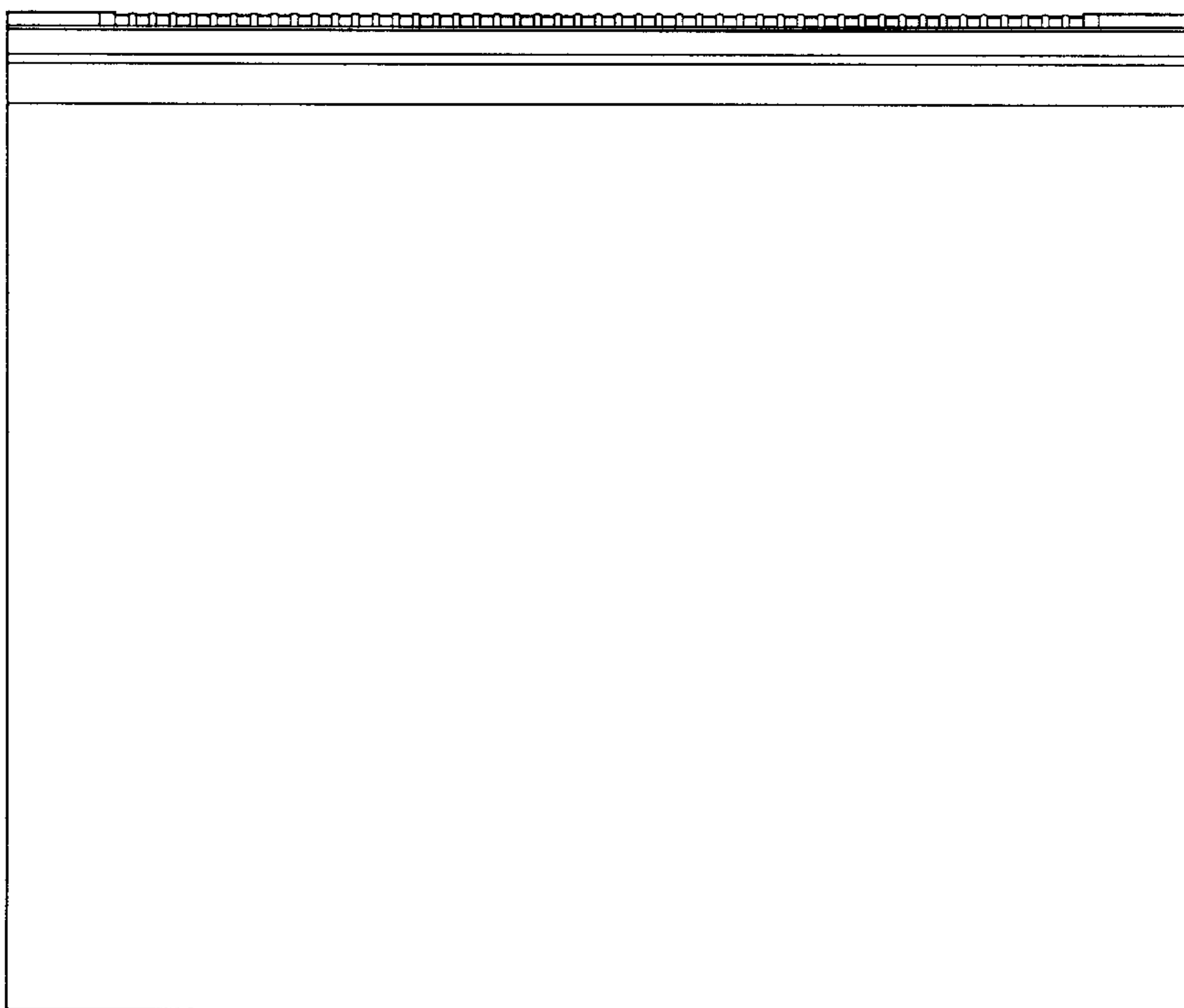
FIG. 9 is a perspective view thereof.

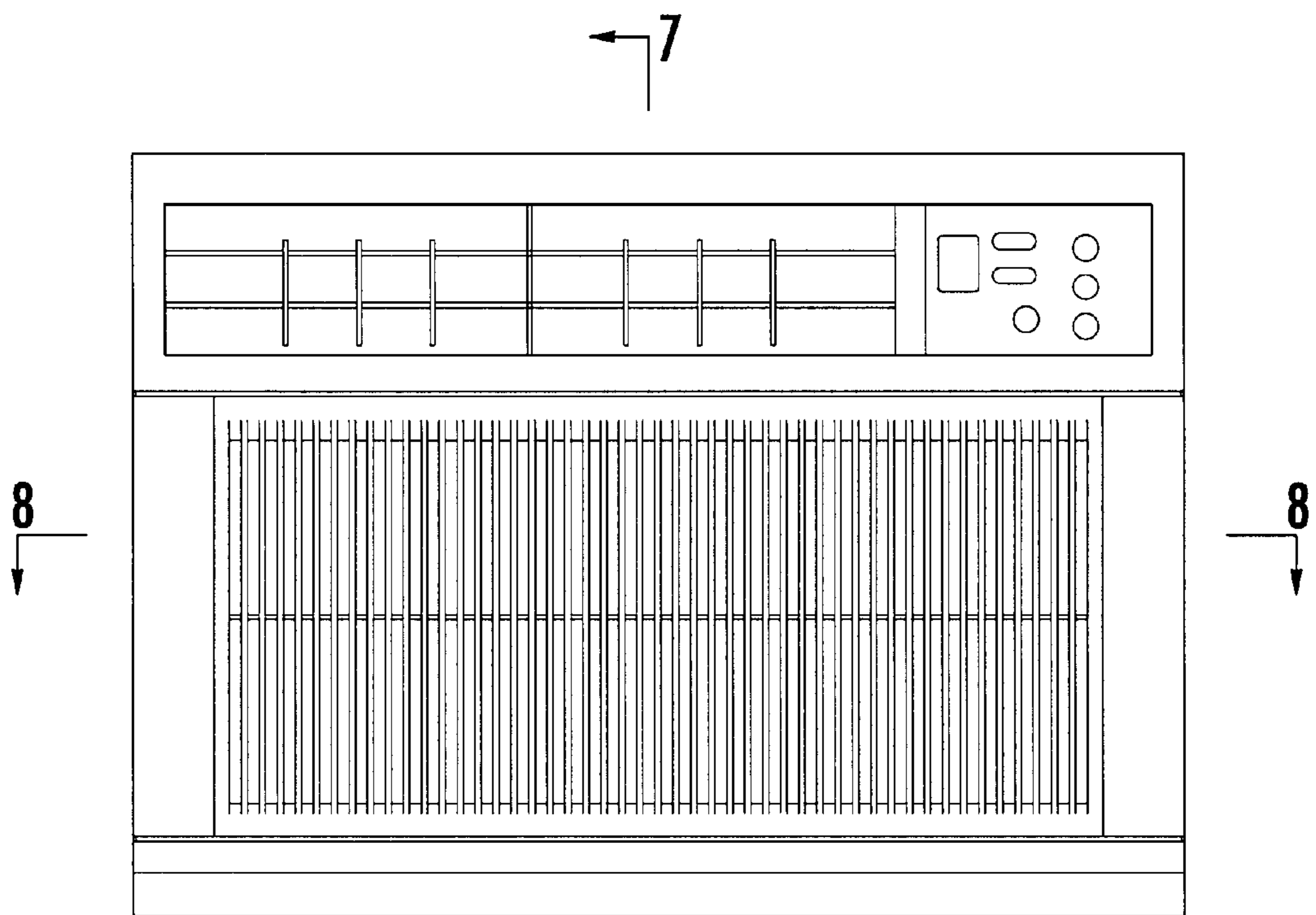




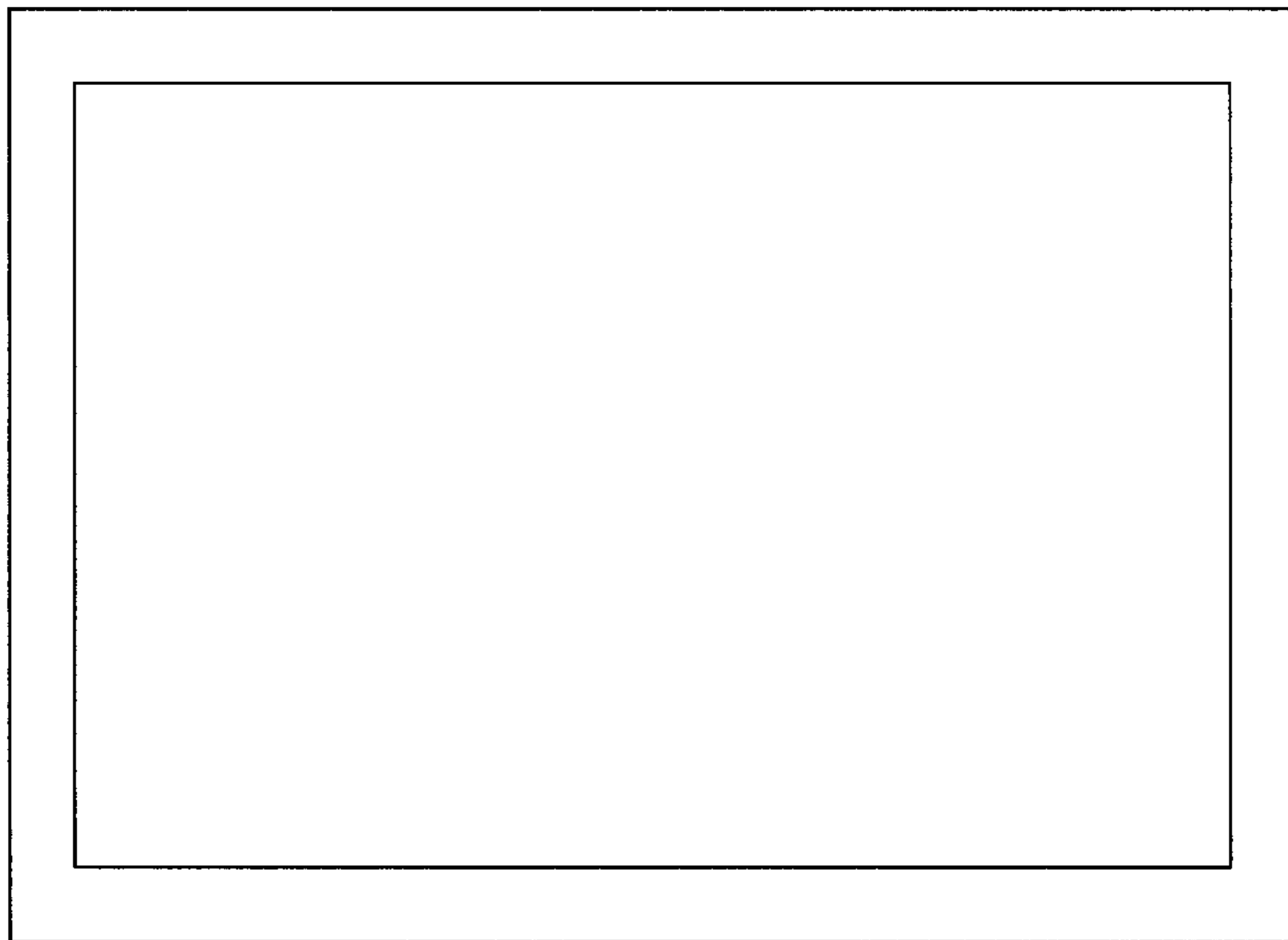

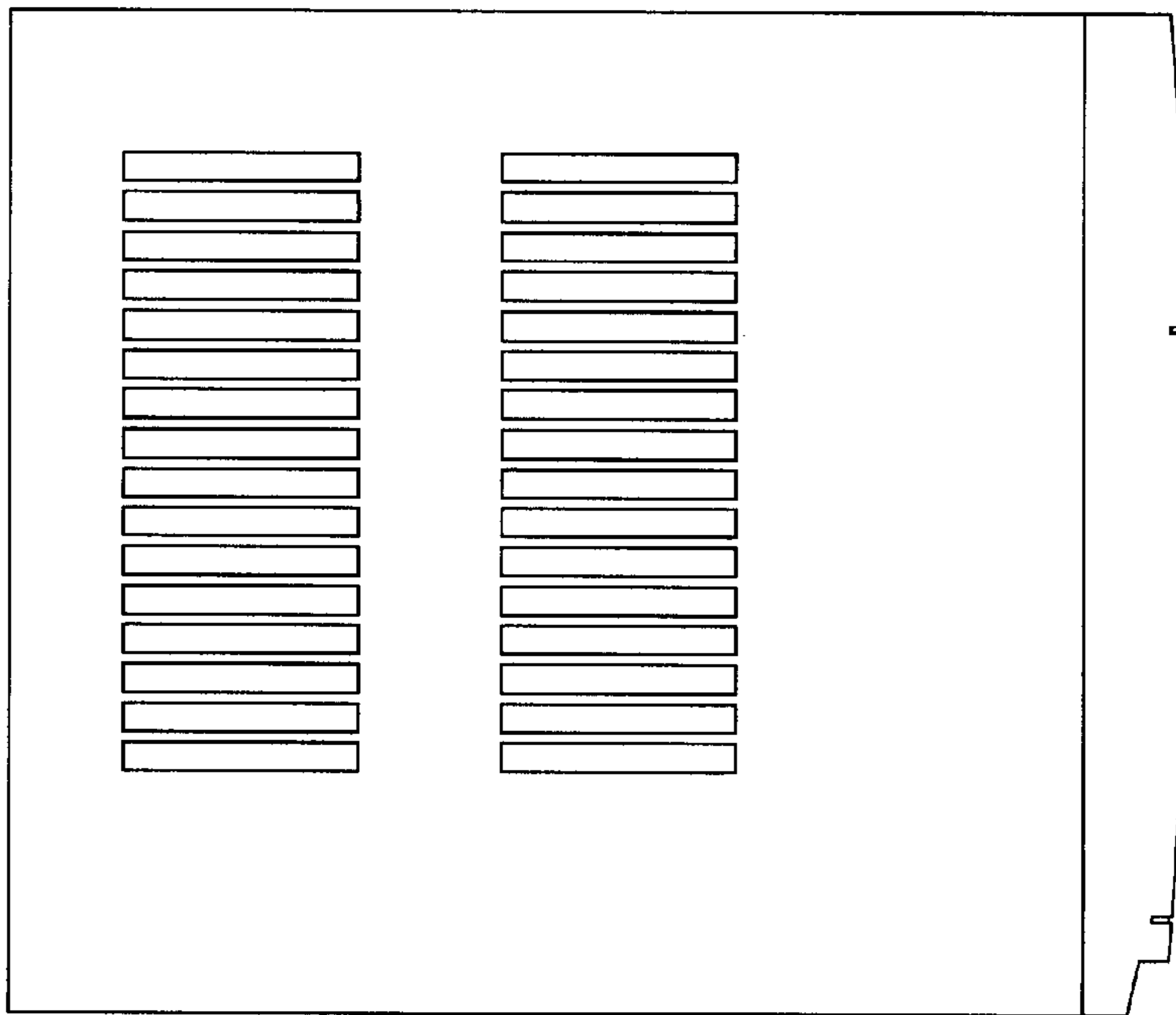

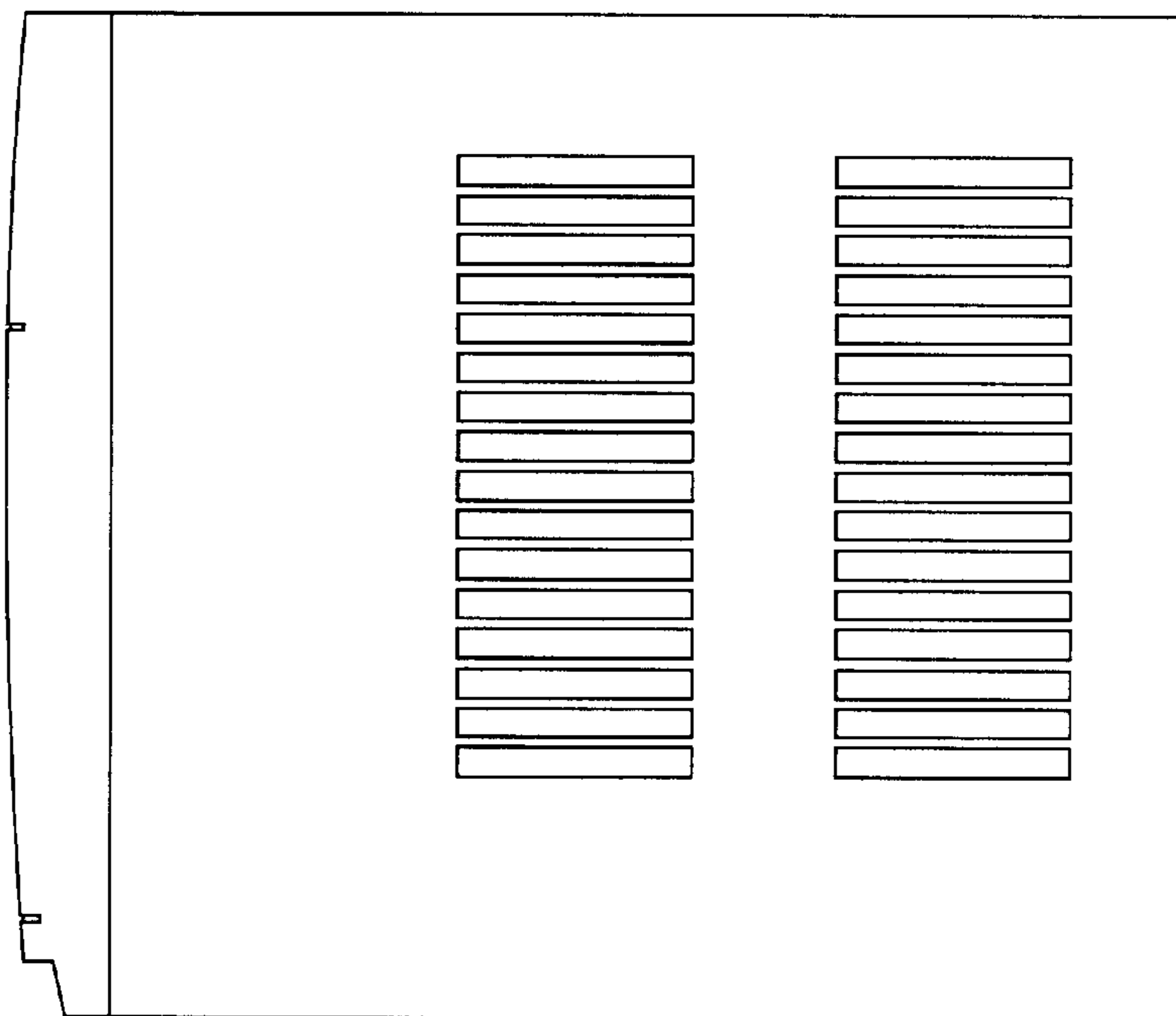

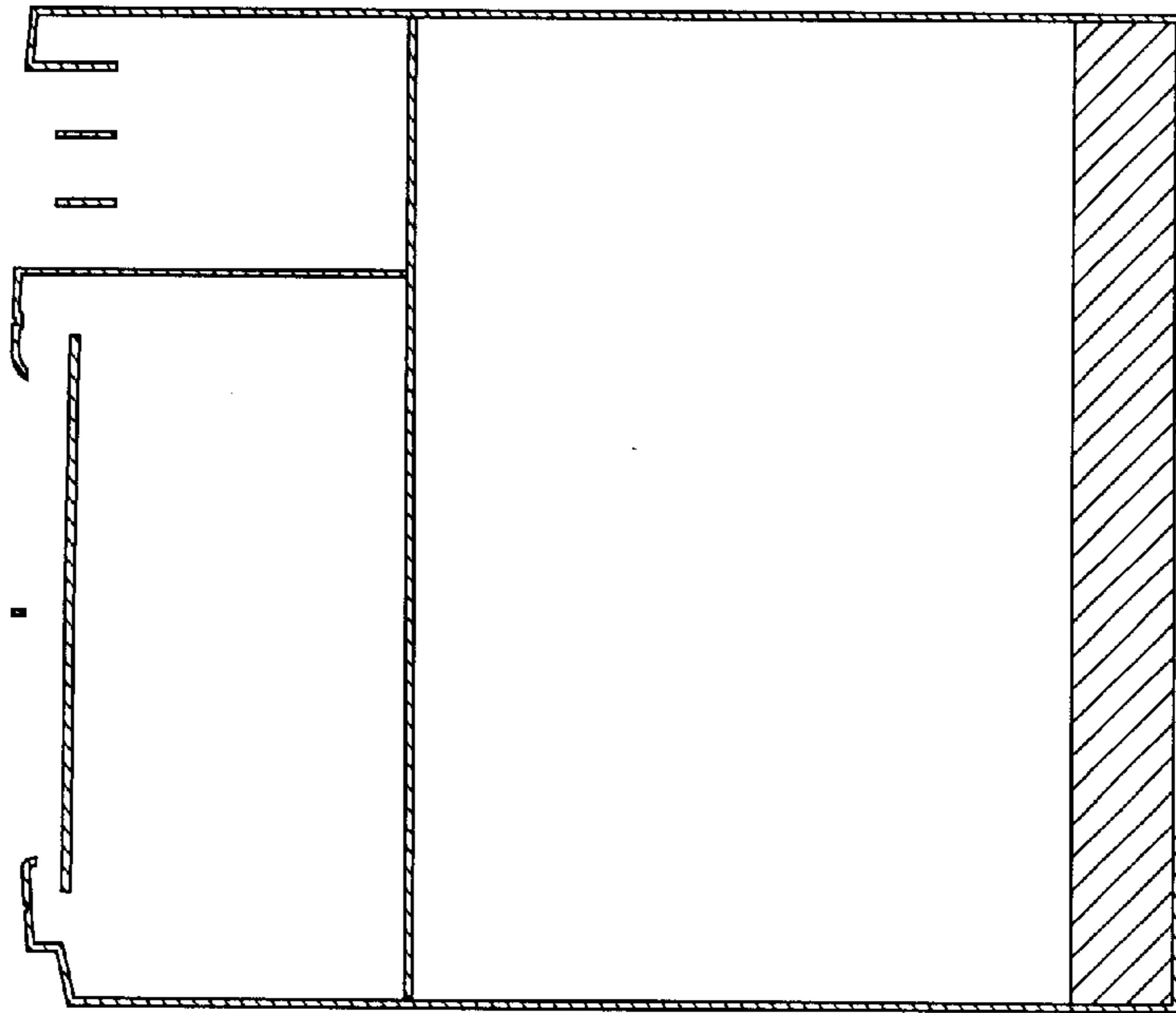

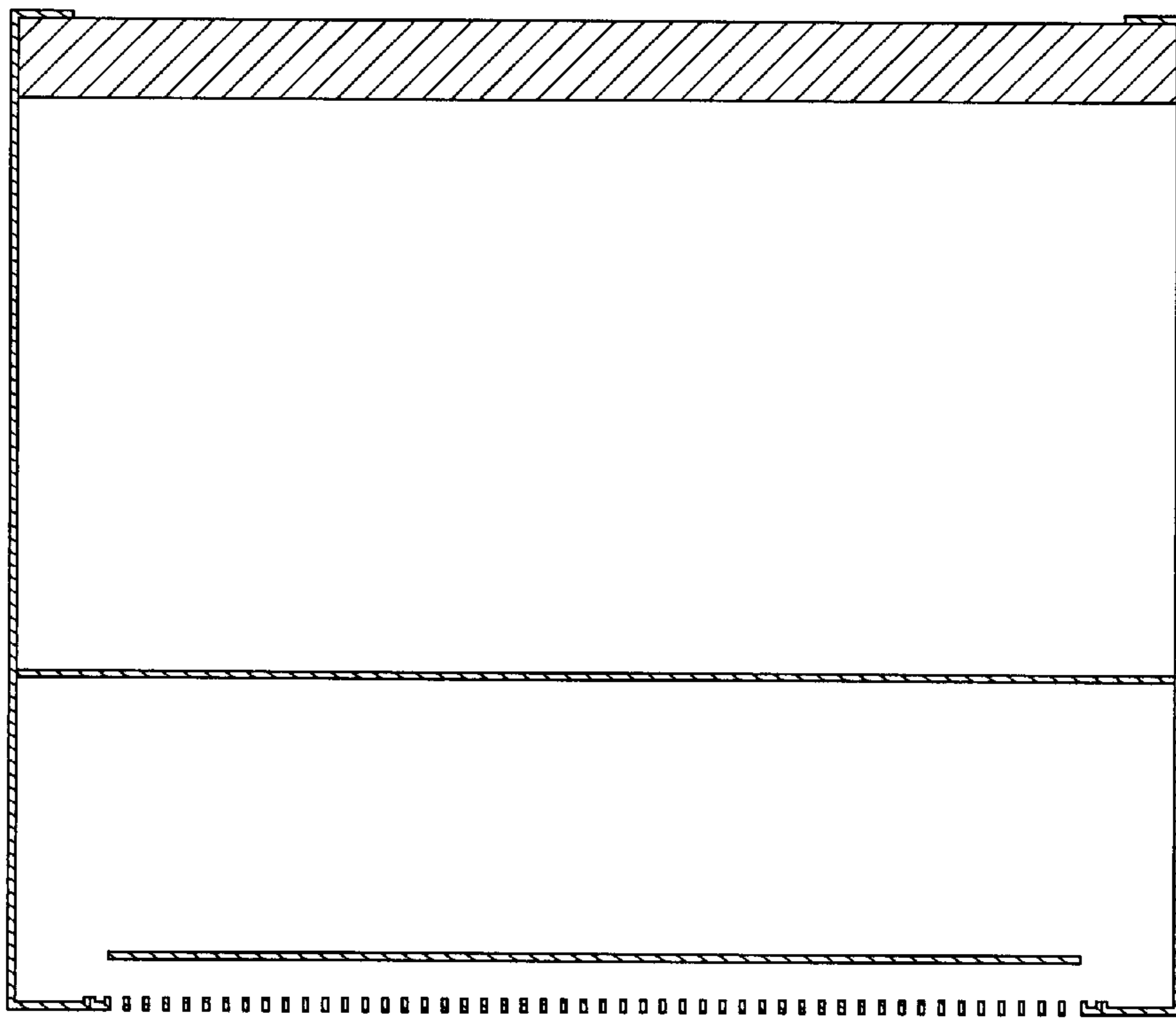

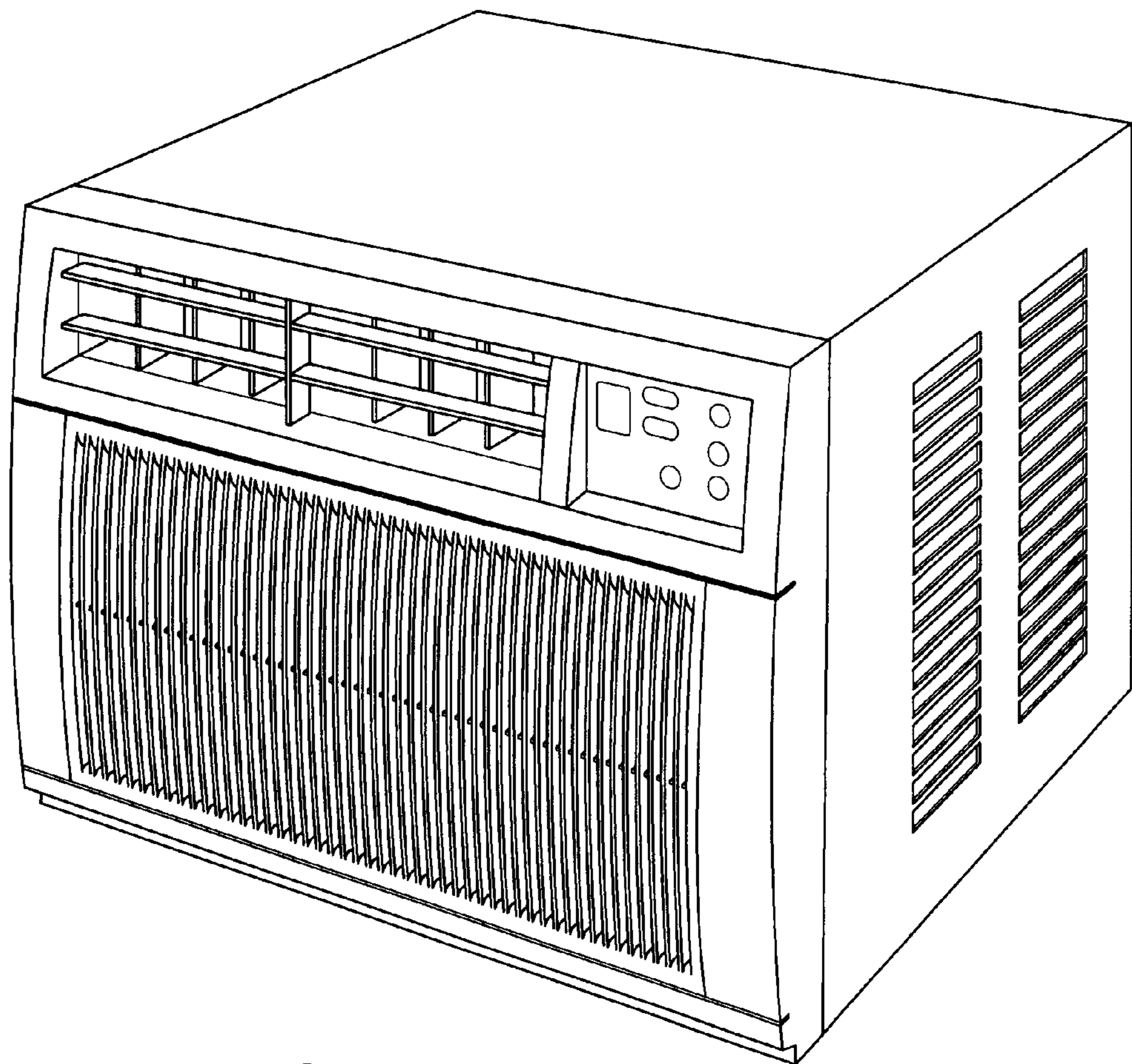
