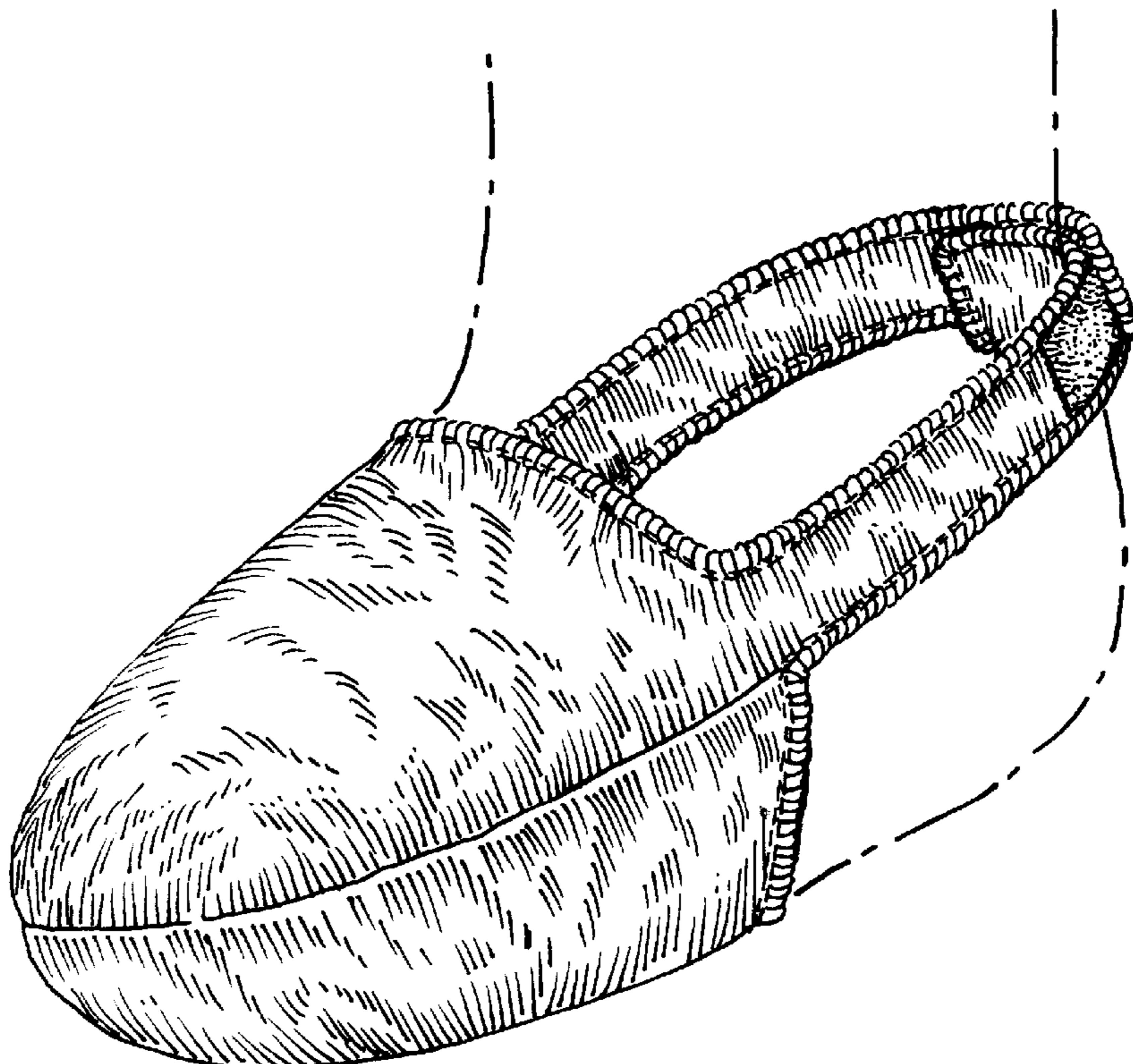

The broken line showing of the extremity in FIG. 7 is for illustrative purposes only and forms no part of the claimed design.

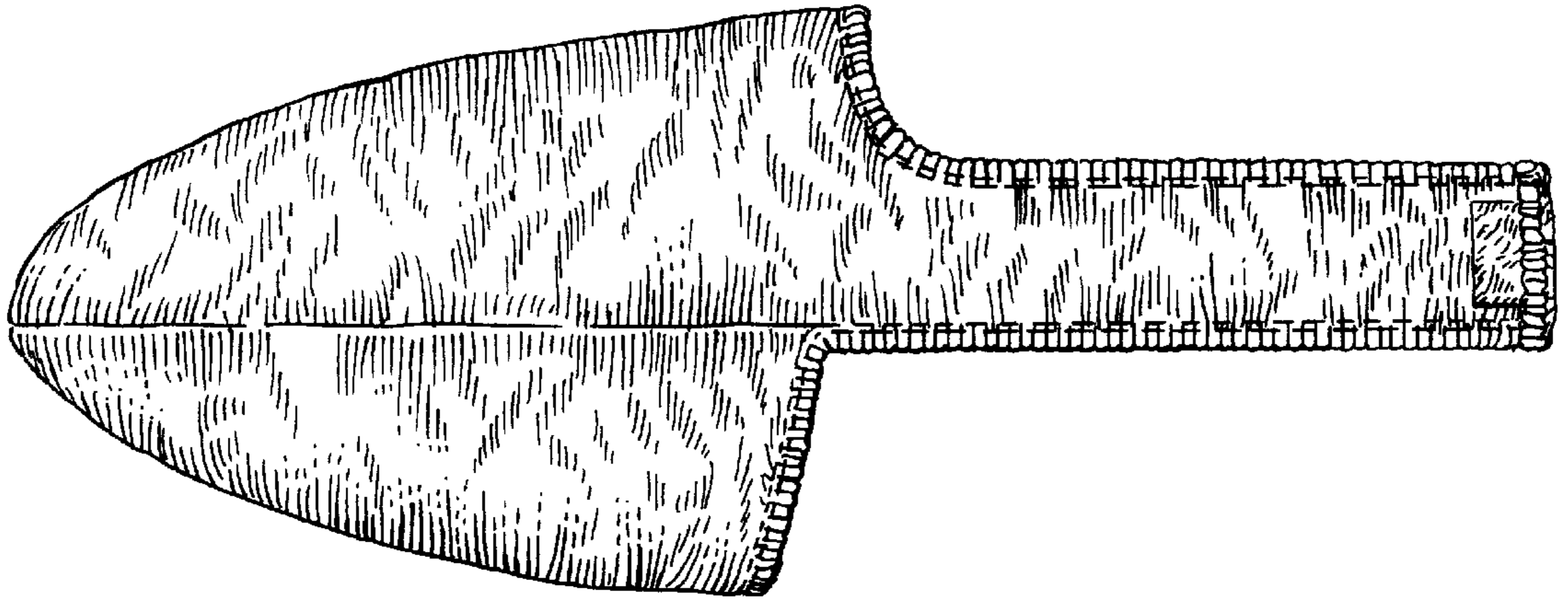

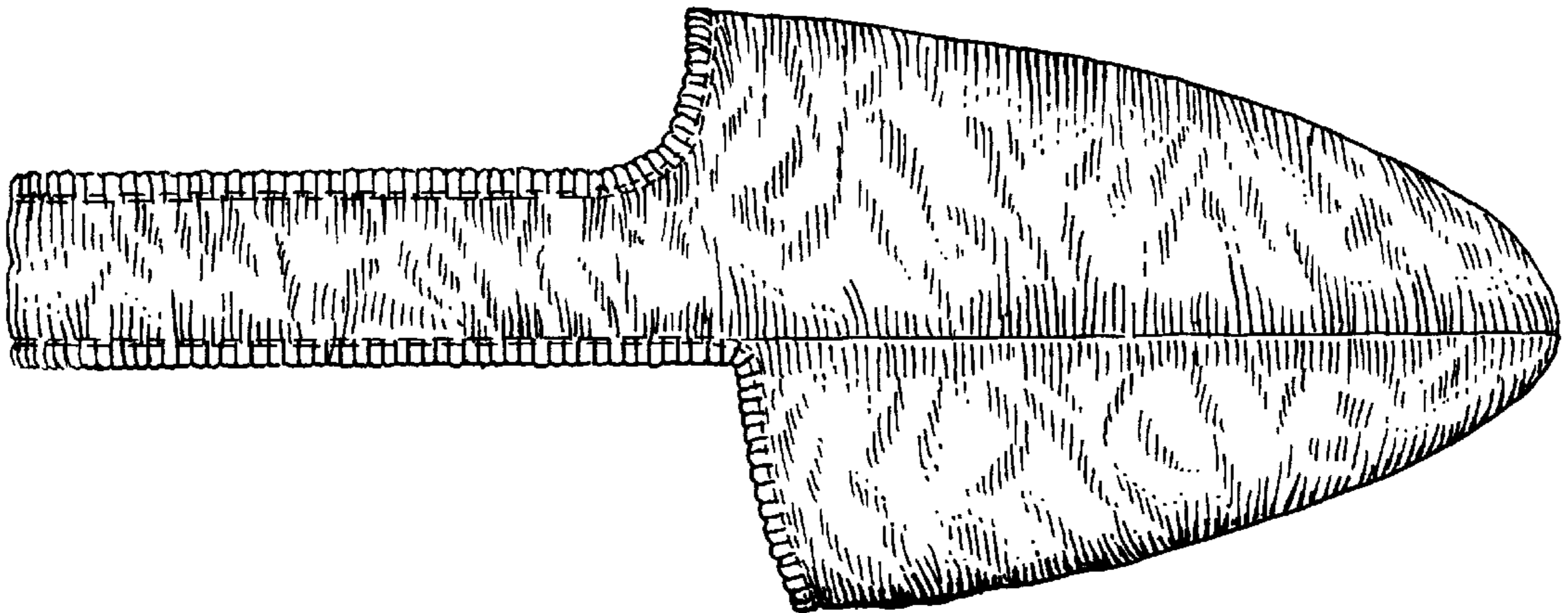

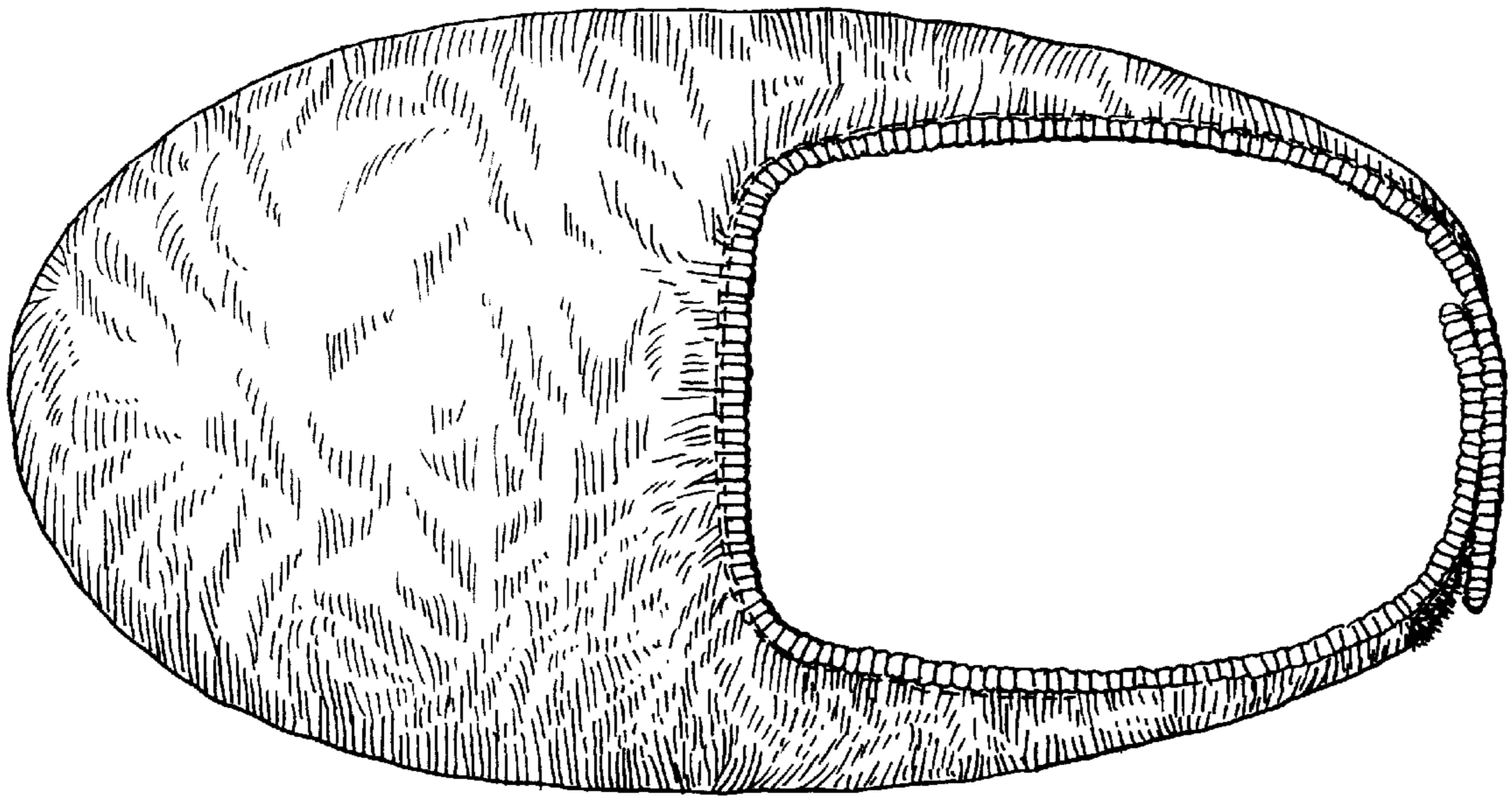

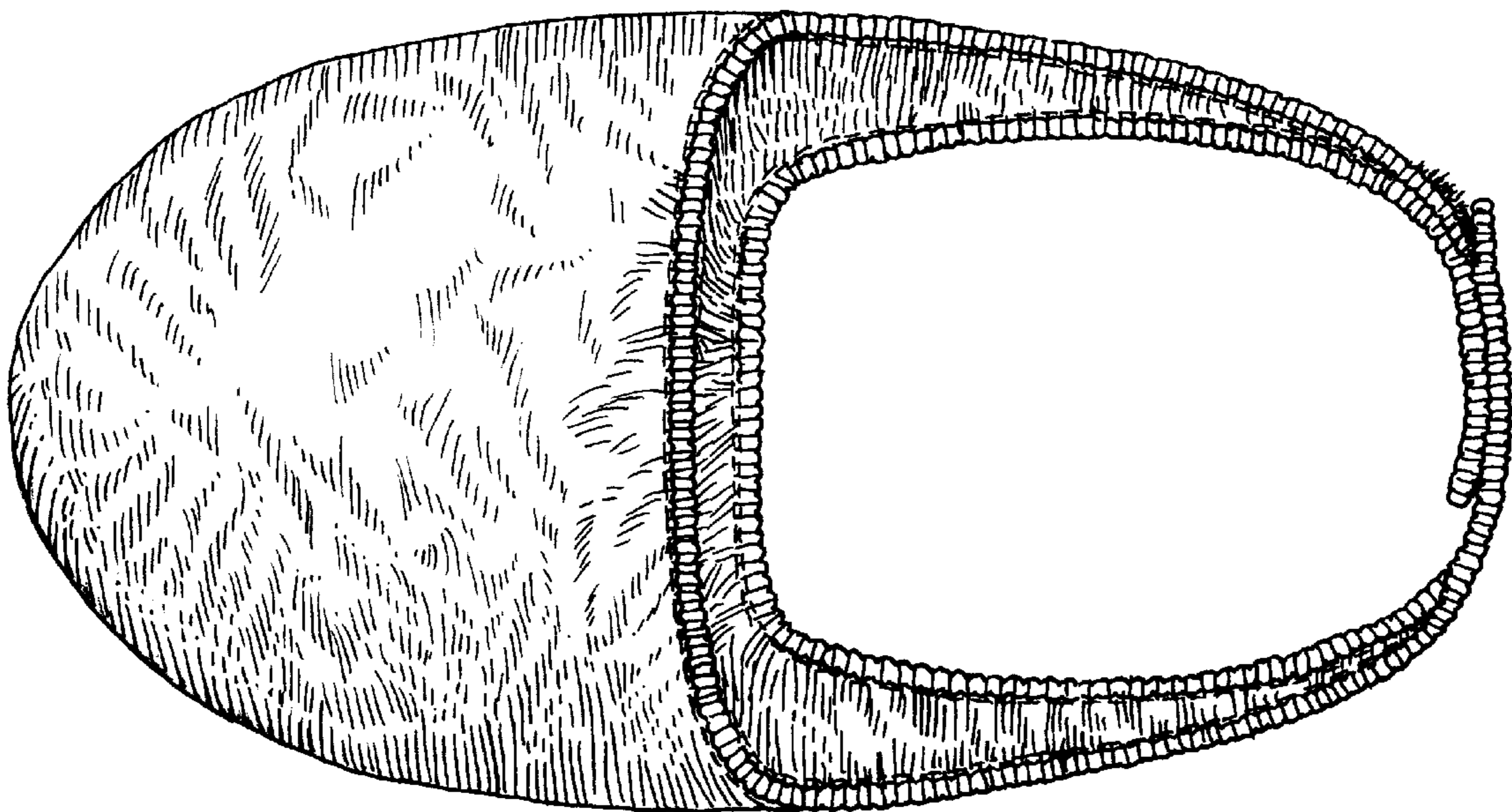

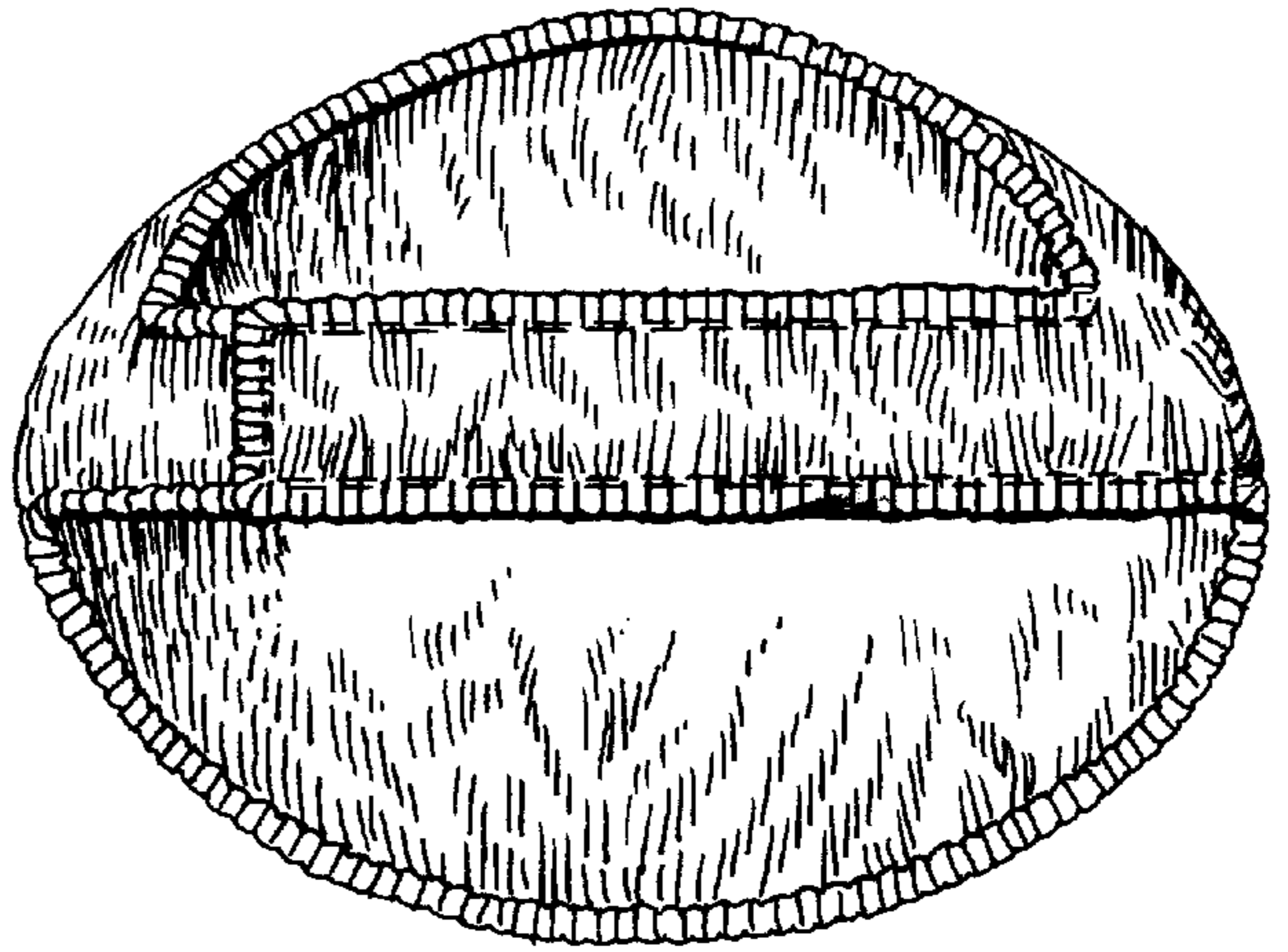

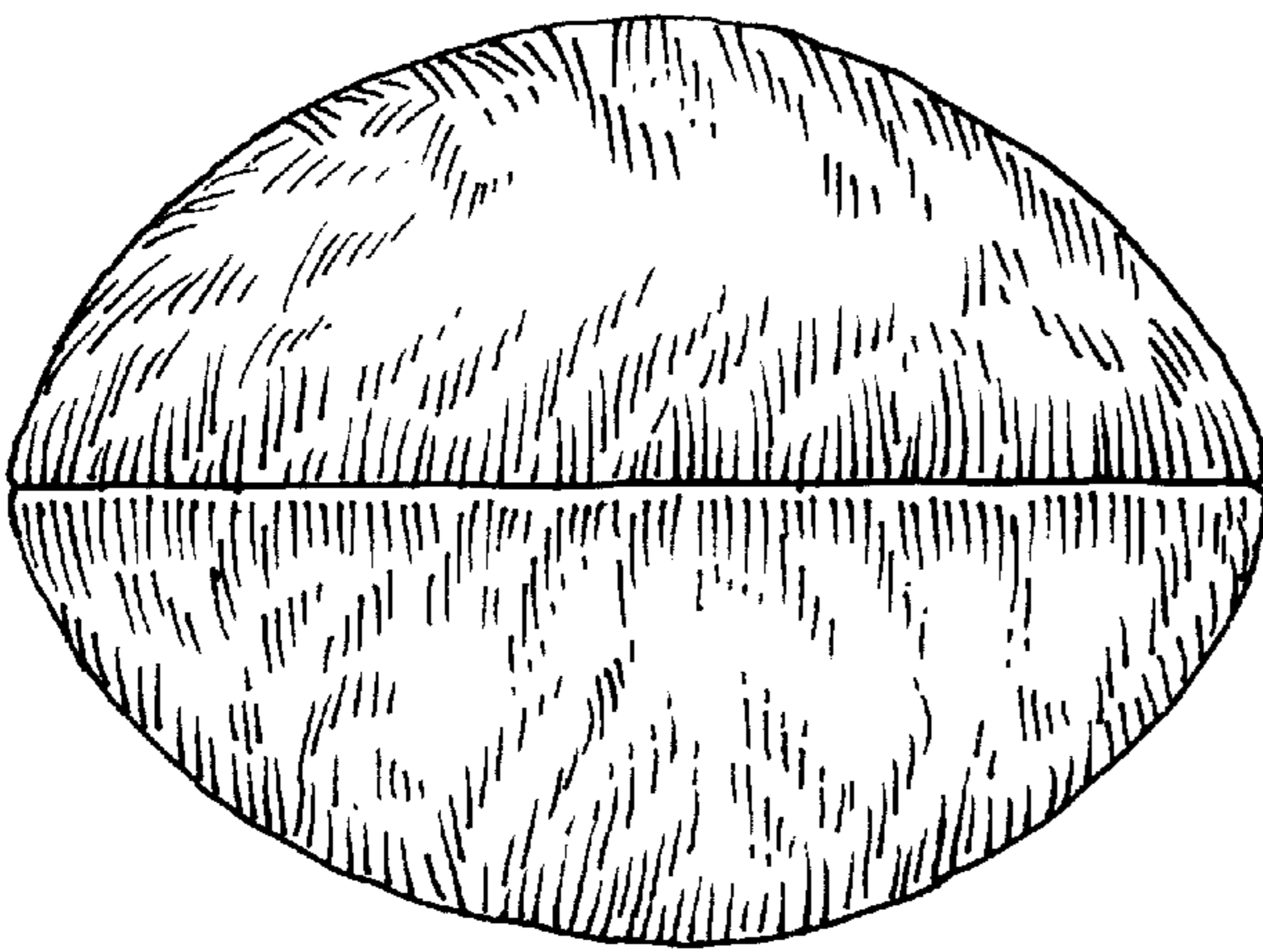

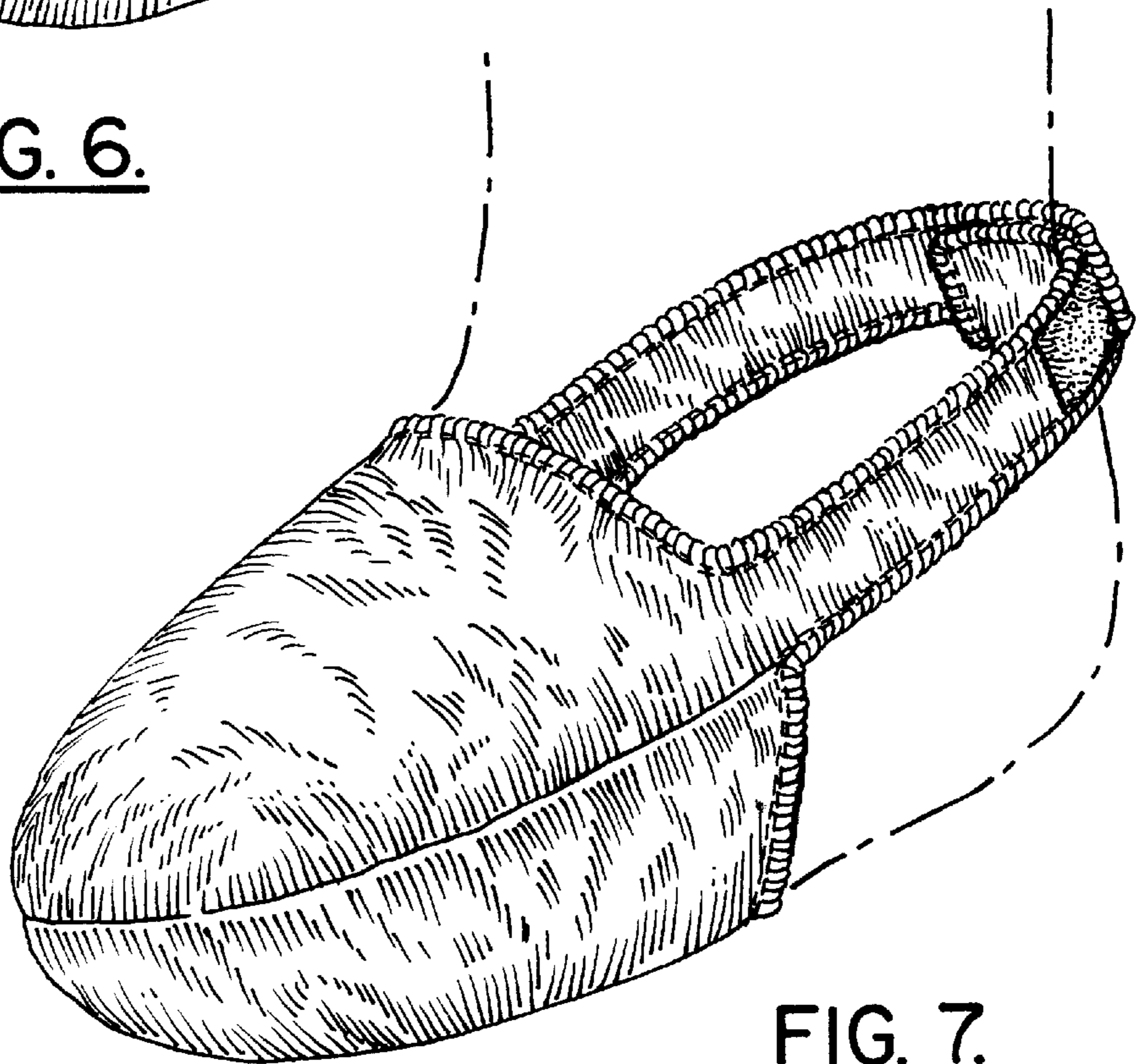

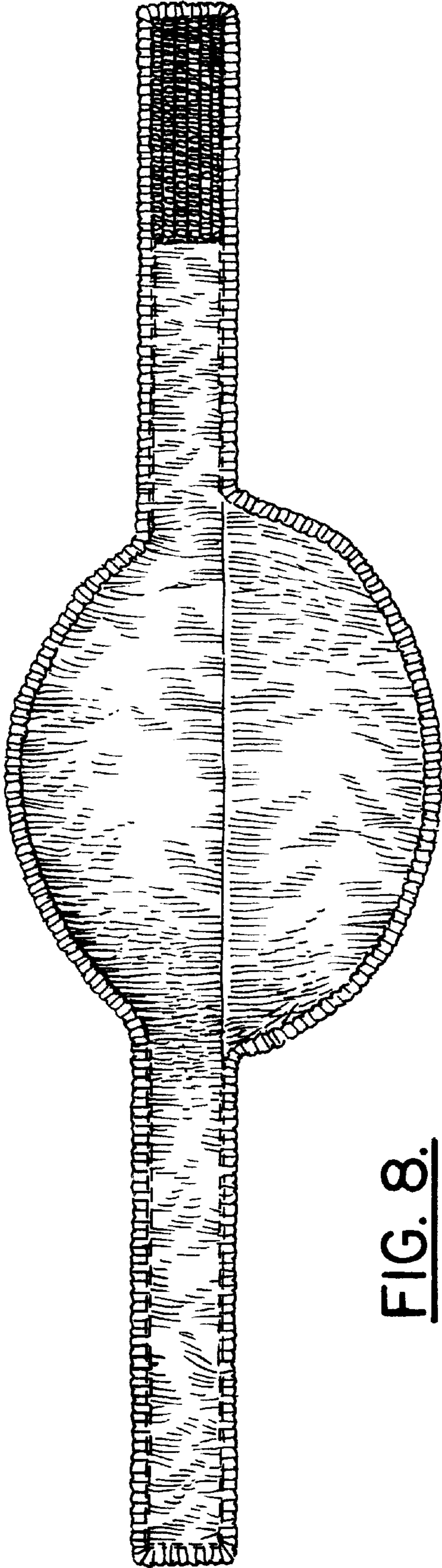

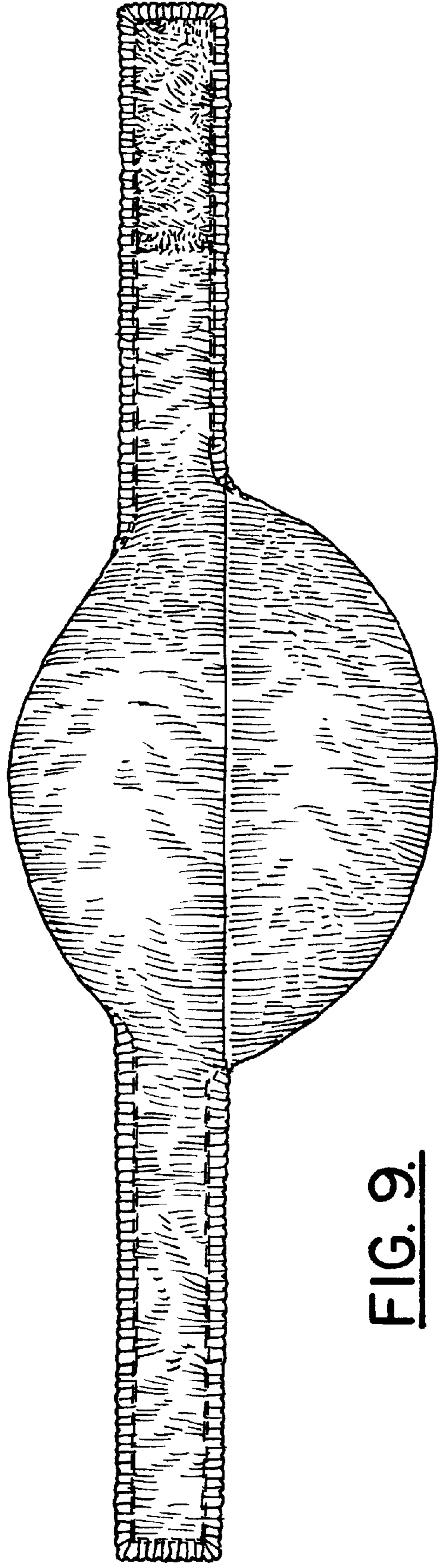
