The ornamental design for pipe tape measure with indicia pattern, as shown and described.

DESCRIPTION

FIG. 13 is an enlarged top plan view of the next adjoining segment of FIG. 1; thereon;

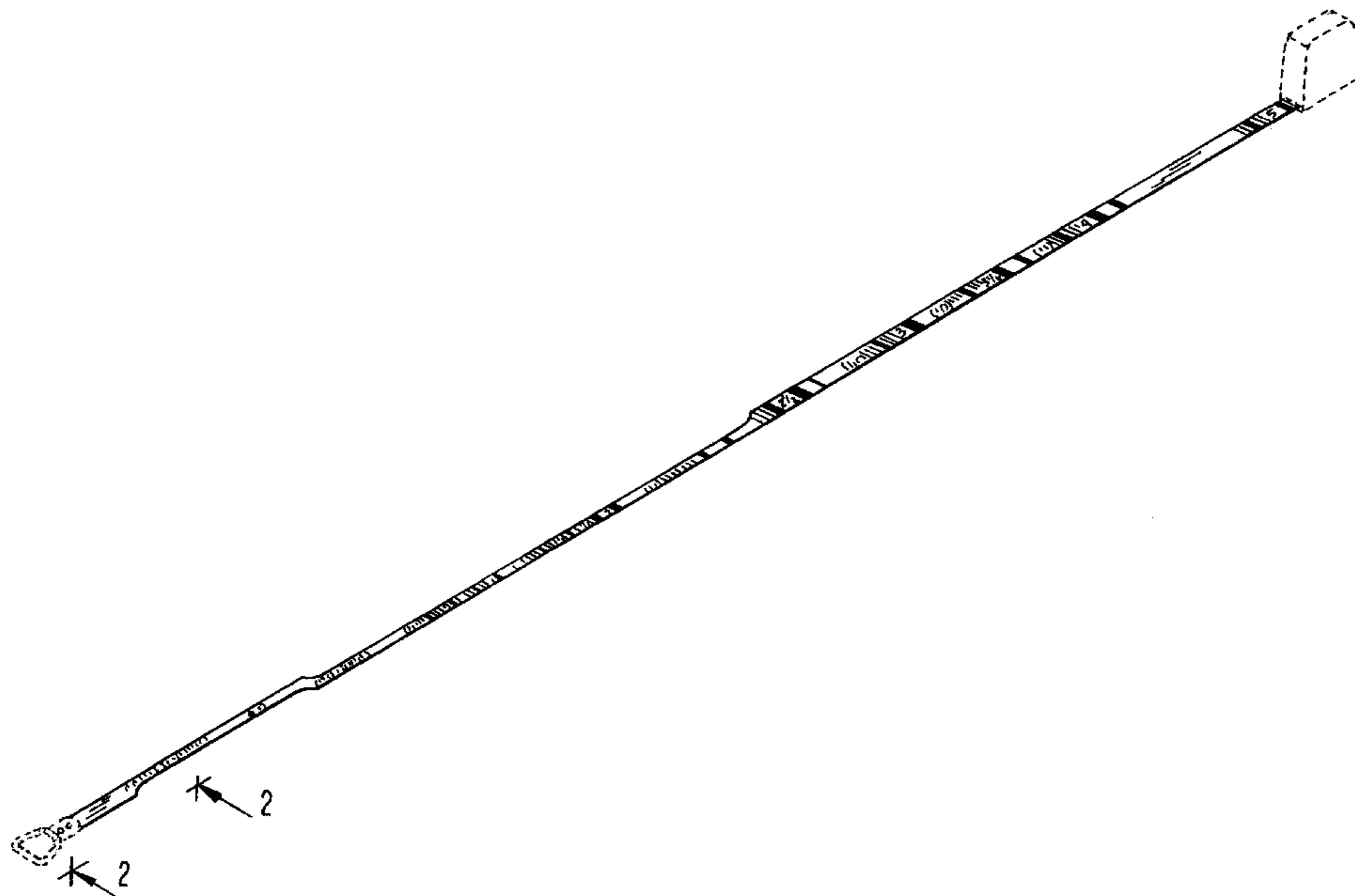
FIG. 14 is an enlarged top plan view of the next adjoining segment of FIG. 1; thereon;

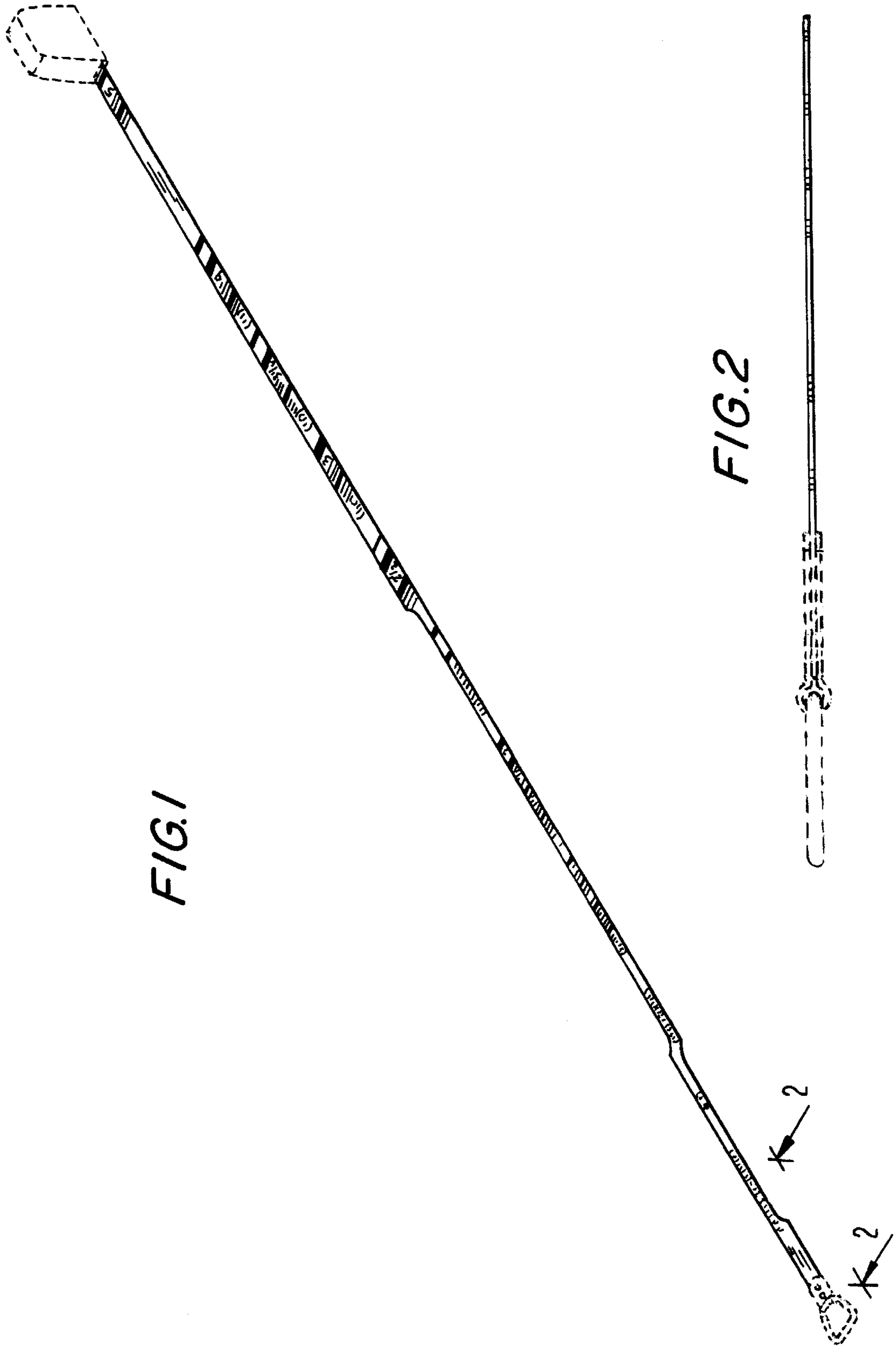

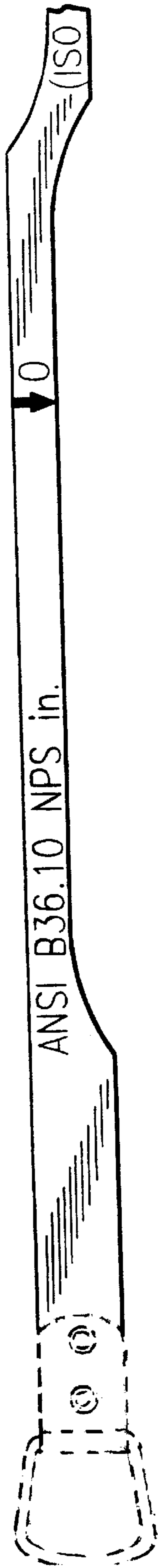

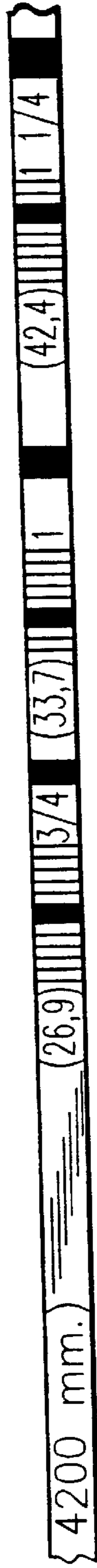

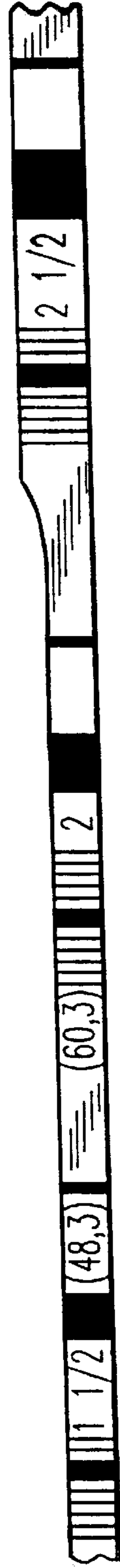

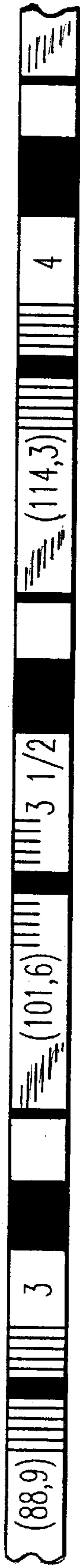

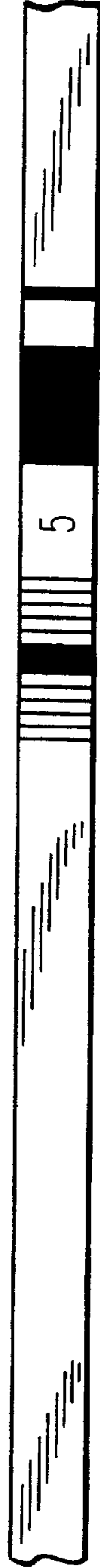
