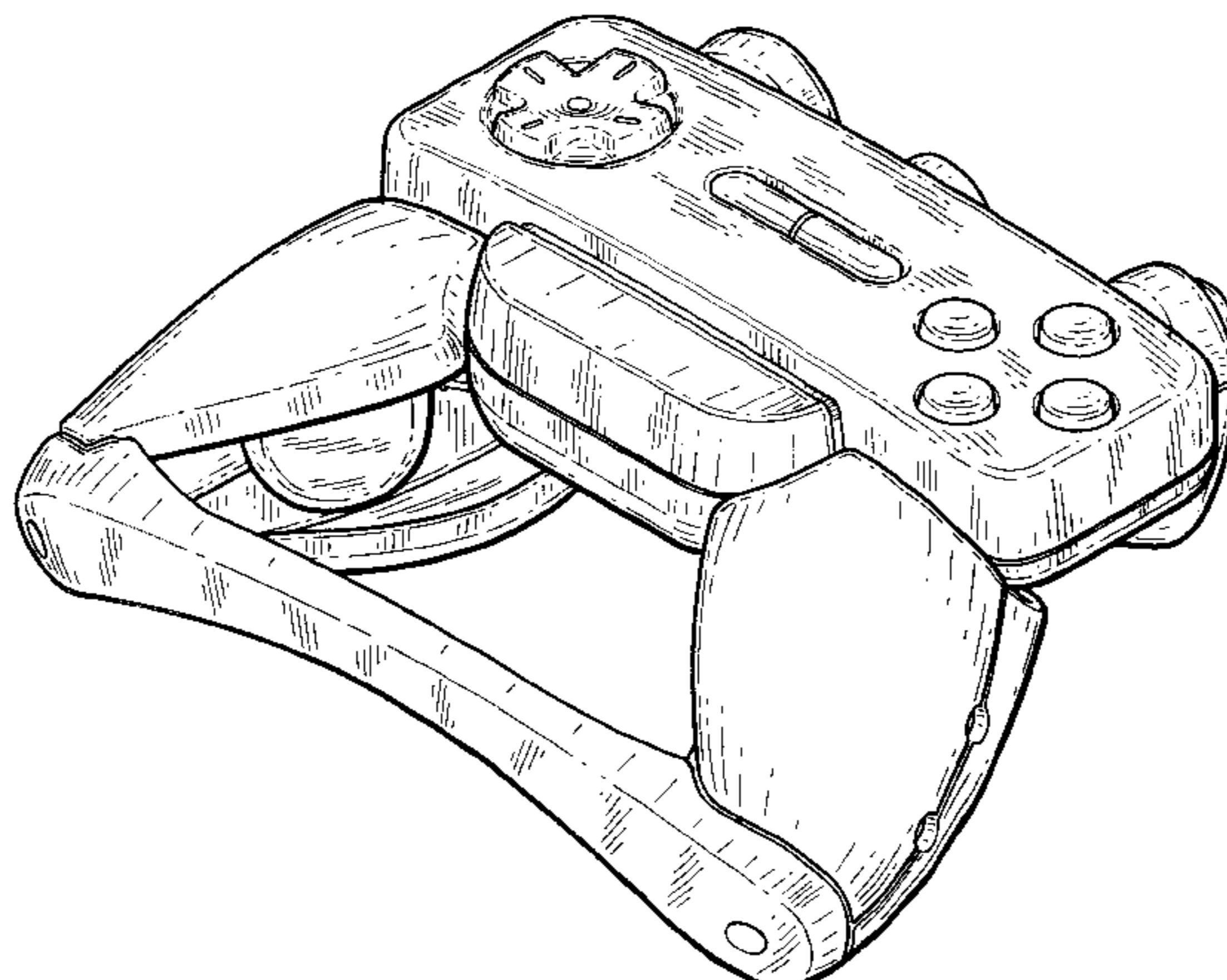
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a game pad;
FIG. 2 is a front elevational view thereof;

FIG. 5 is a right elevational view thereof;

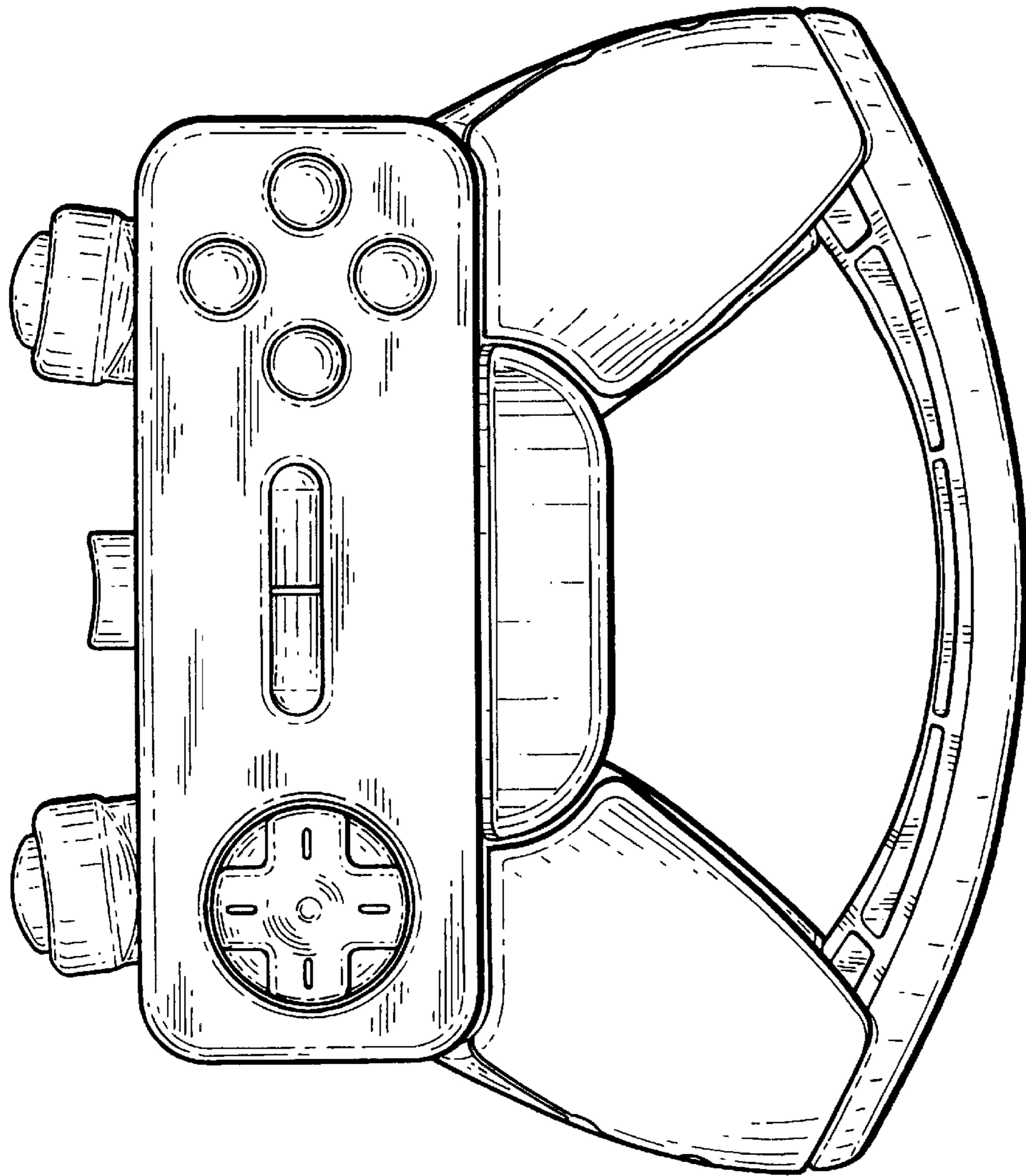

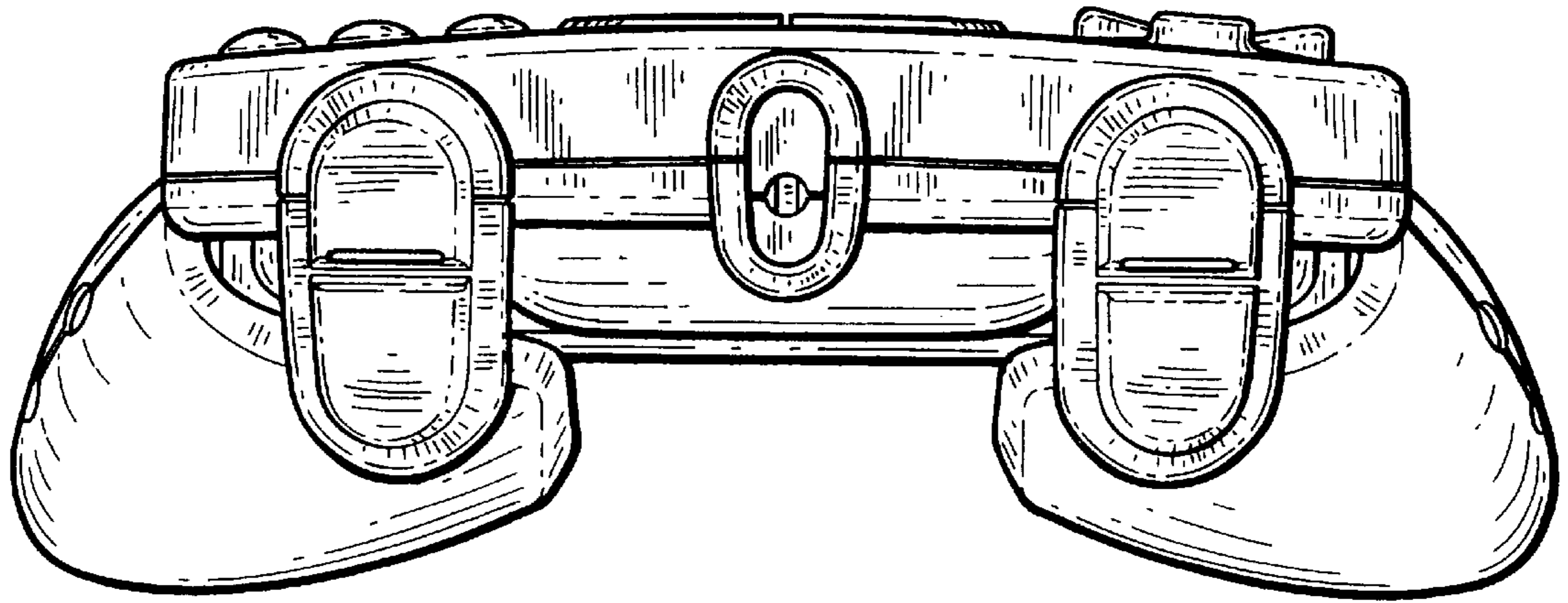

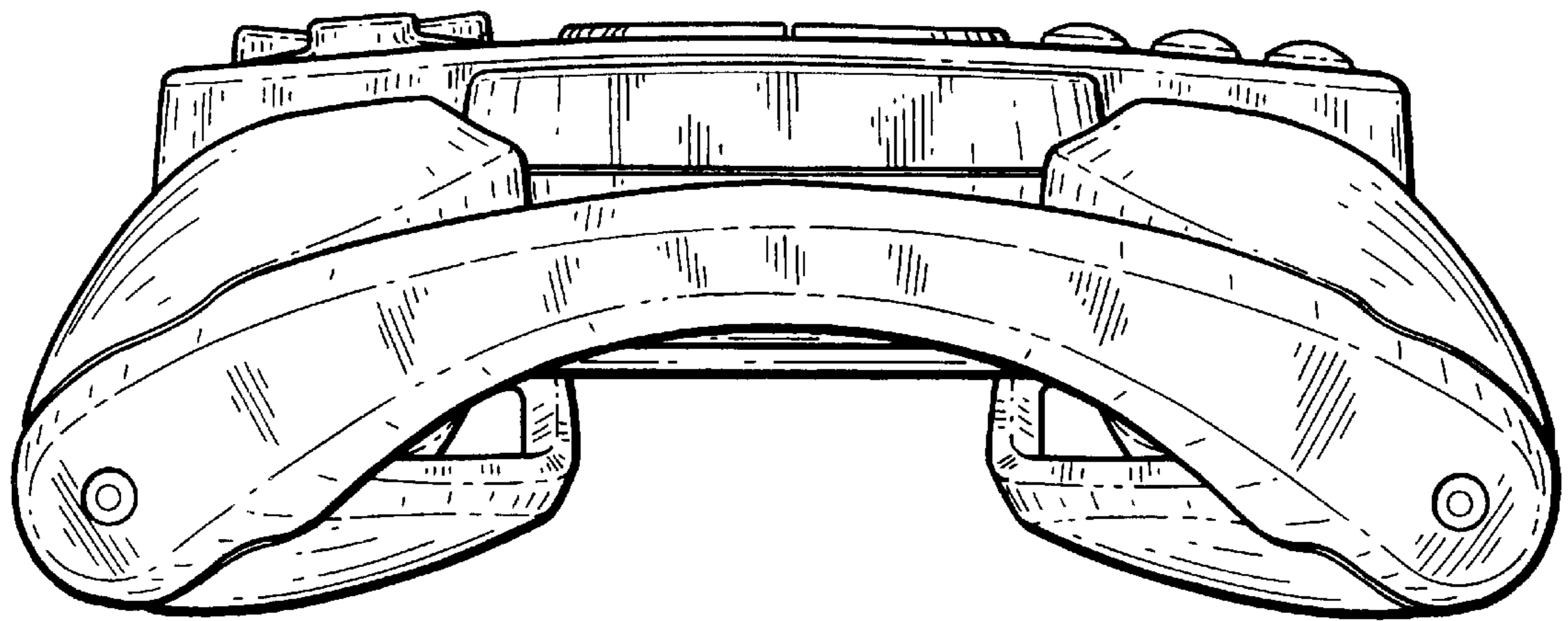

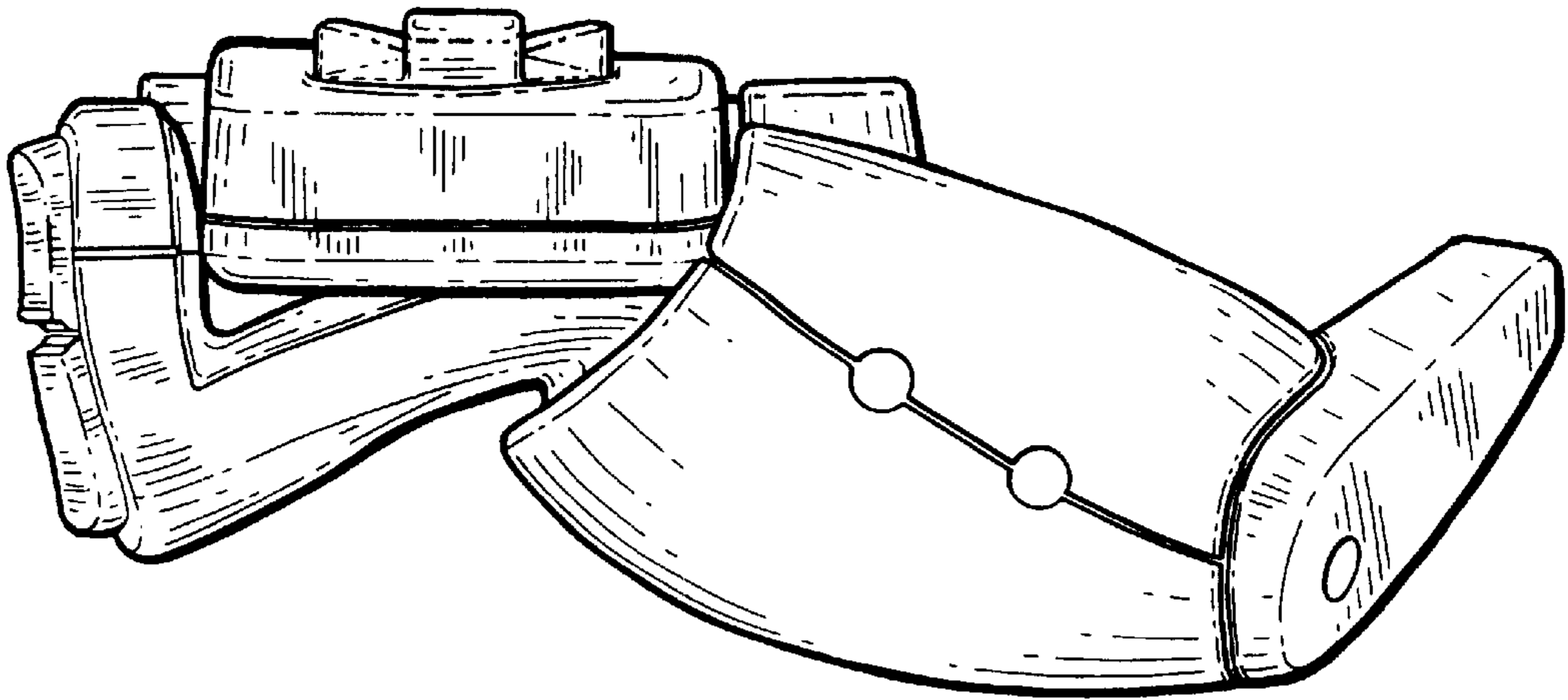

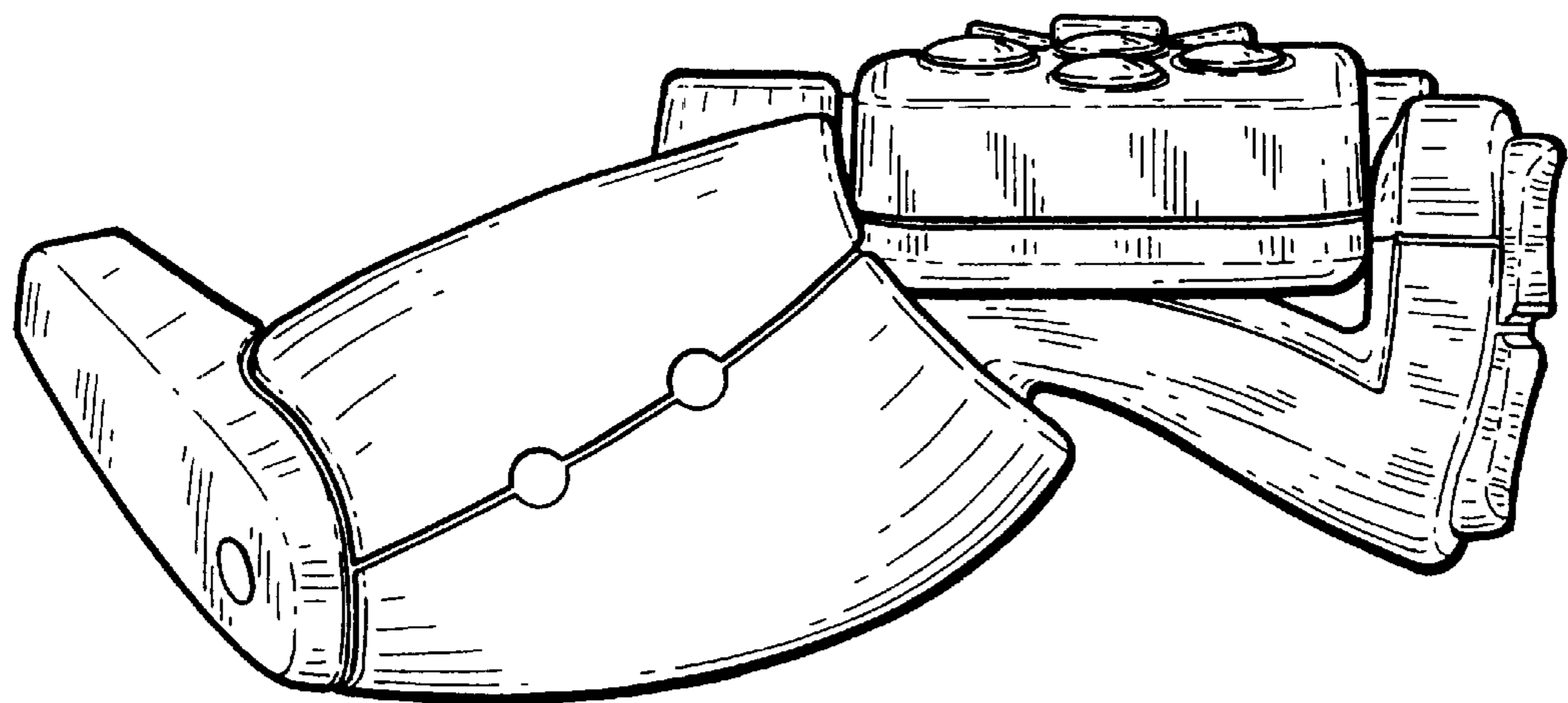

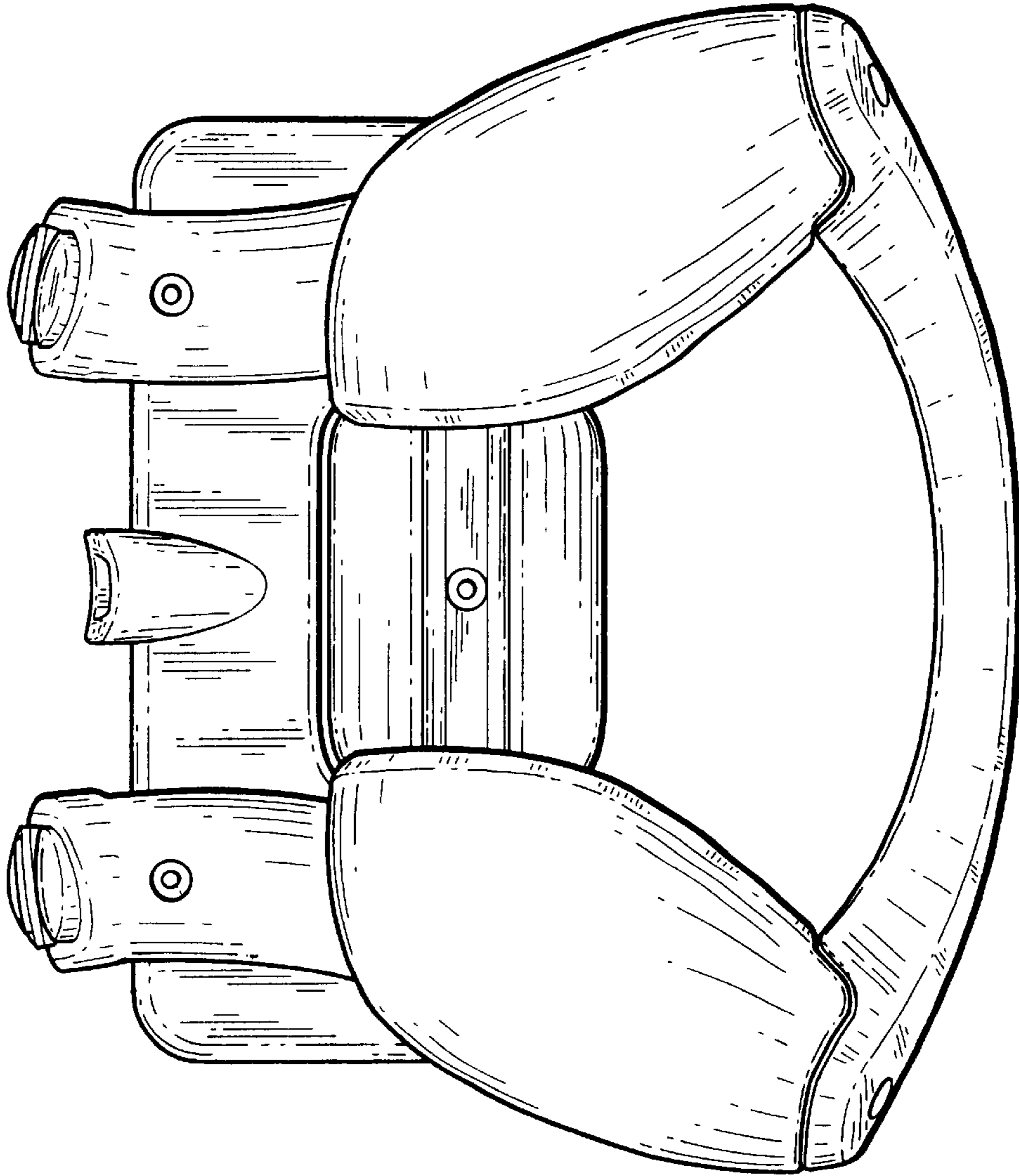

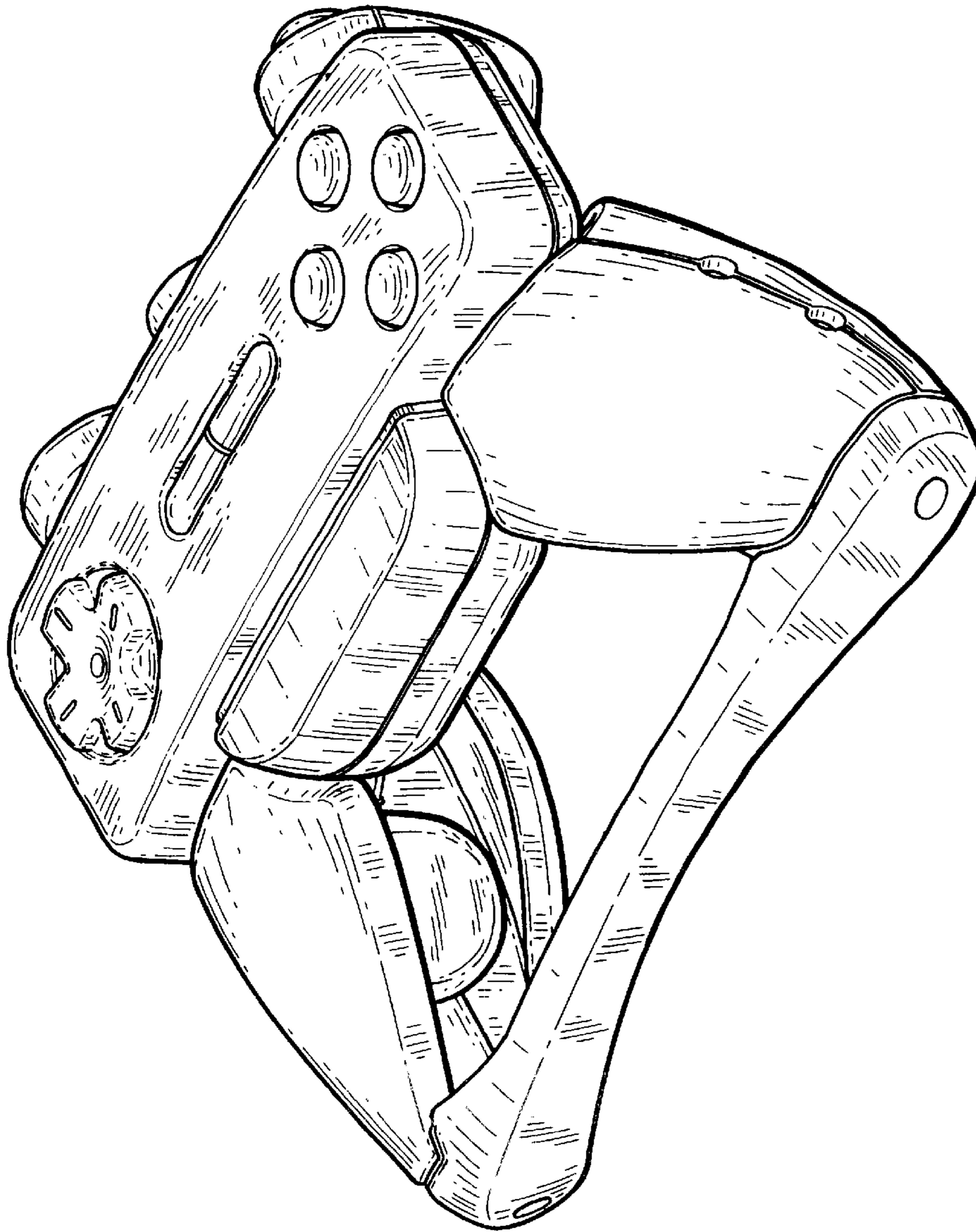

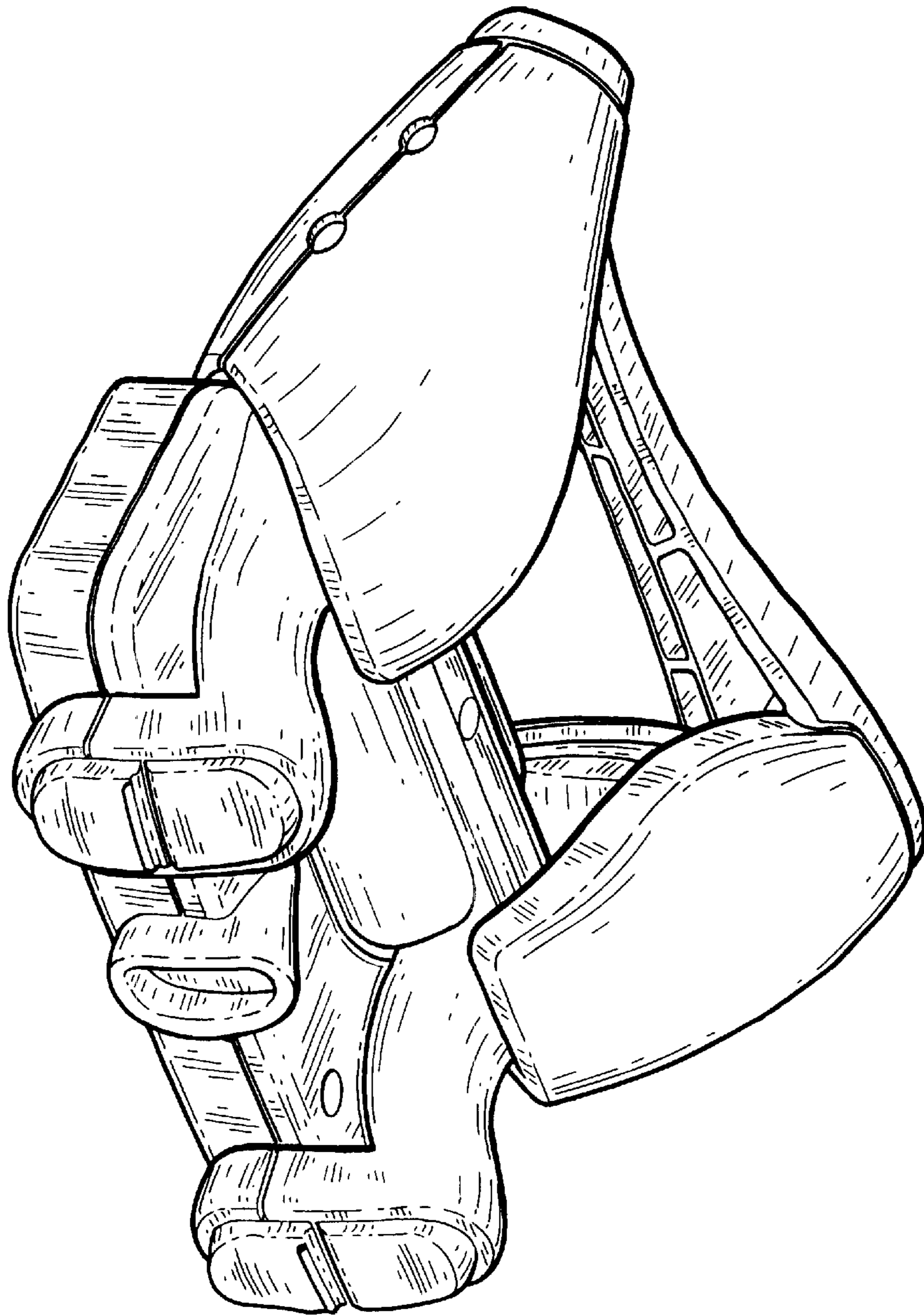
