**DESCRIPTION**

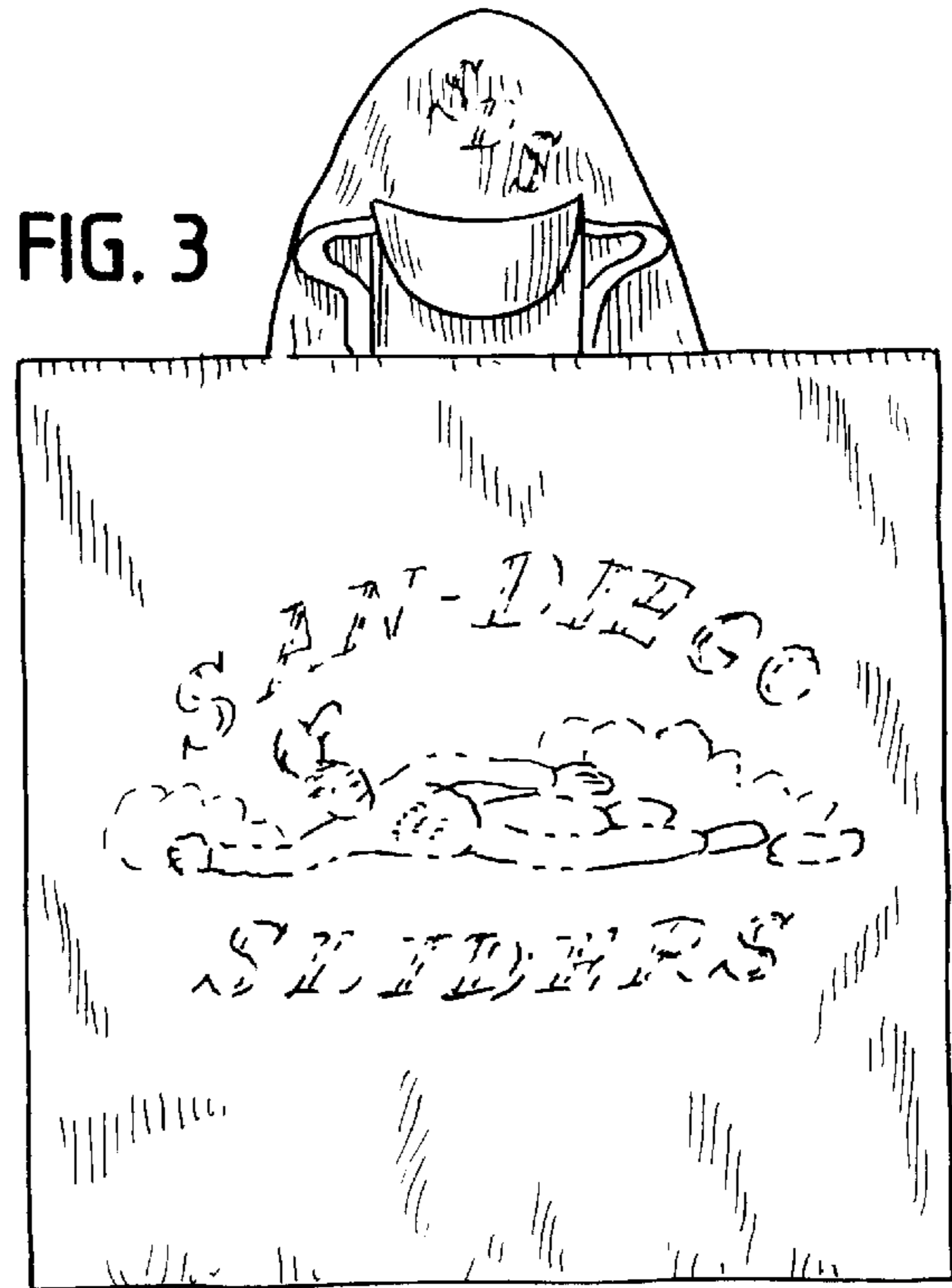
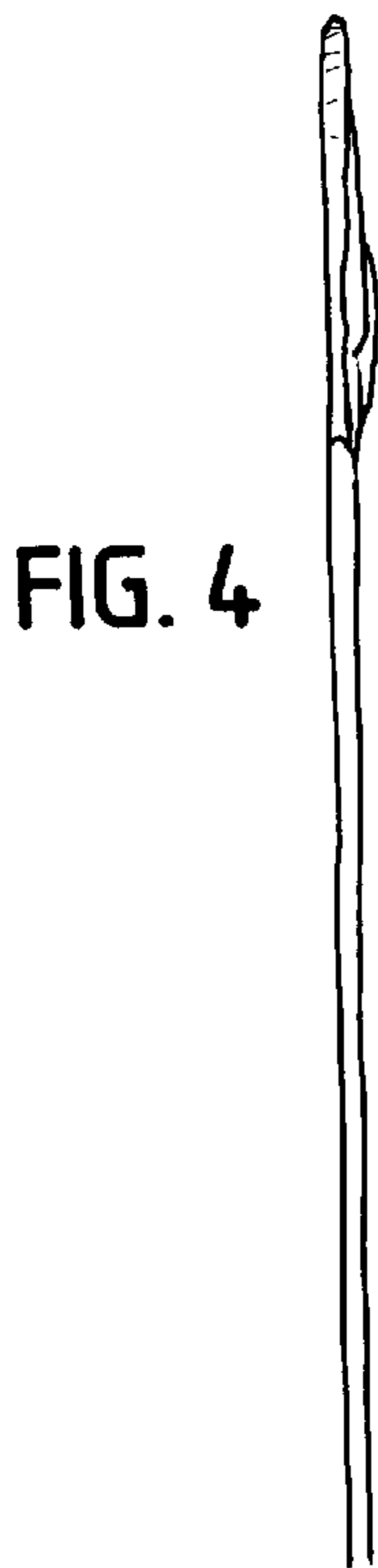
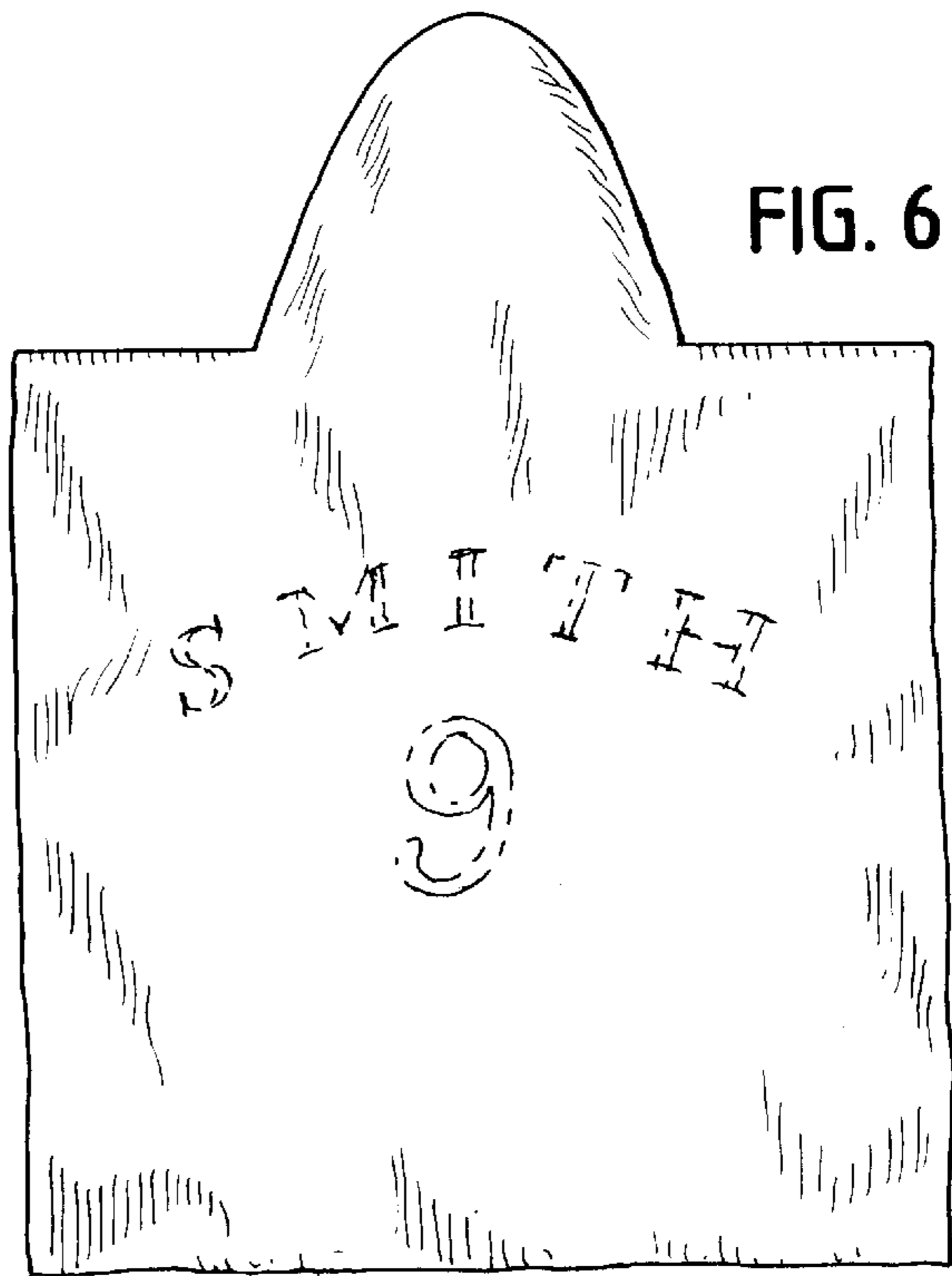
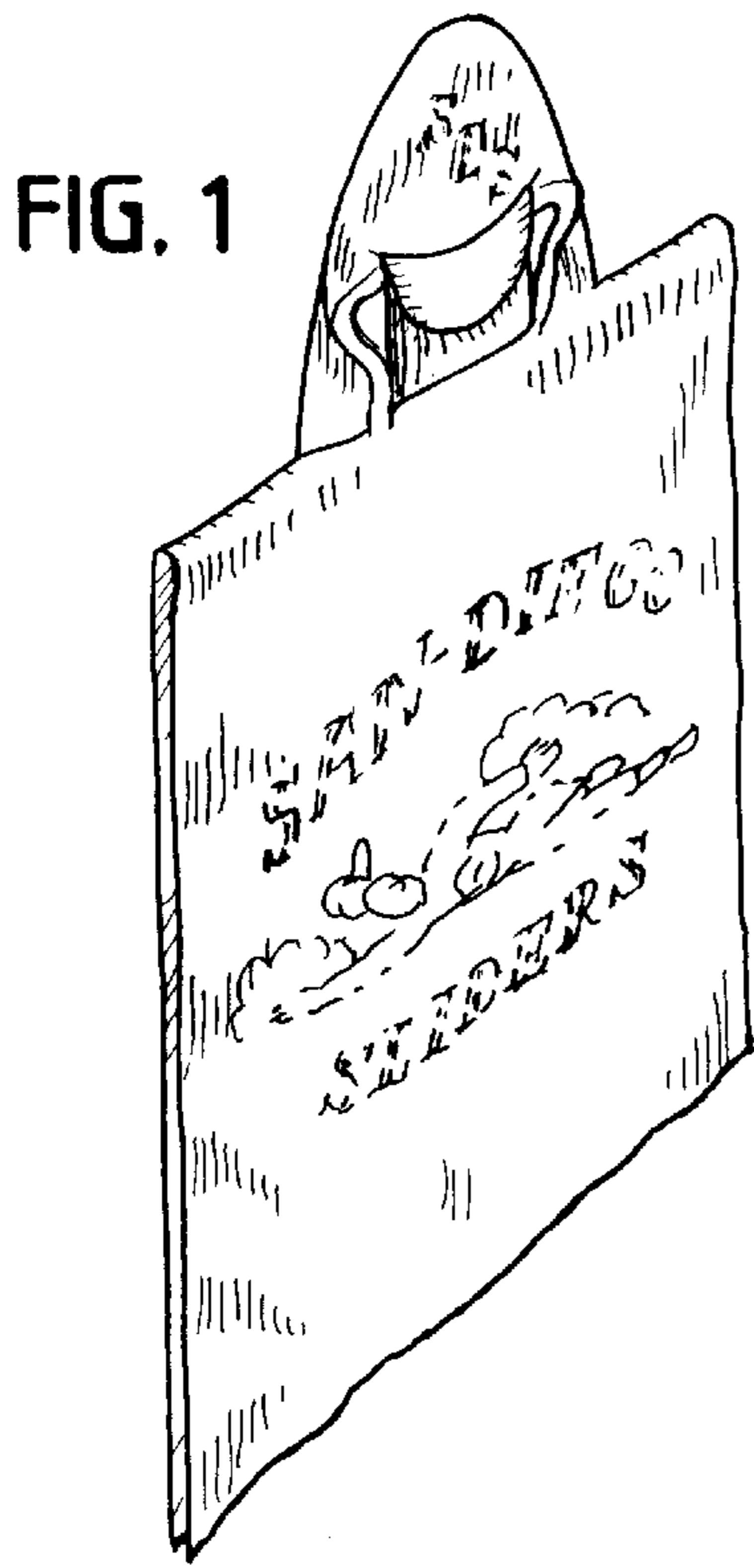
