We claim the ornamental design for a dispensing bottle, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a dispensing bottle showing my new design;

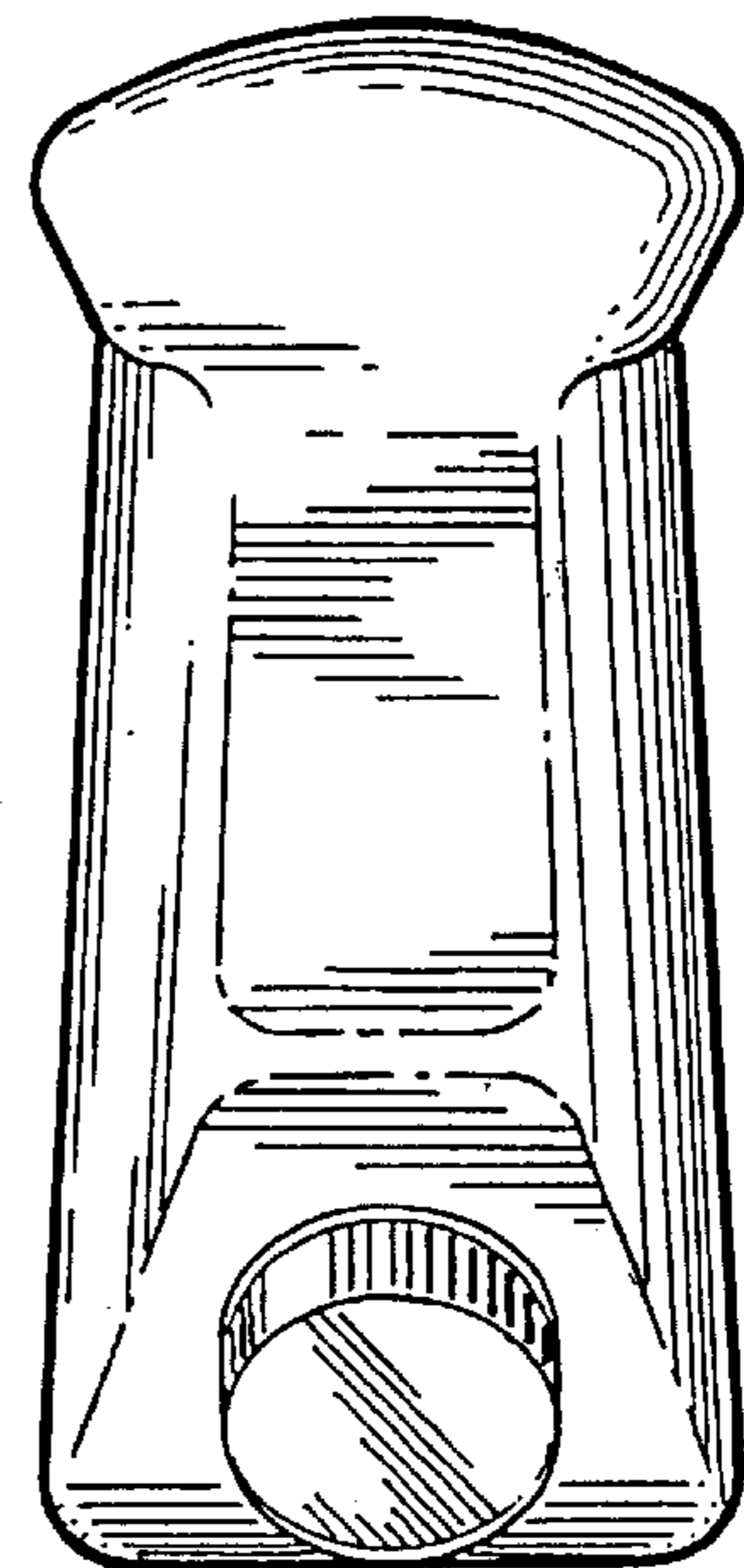
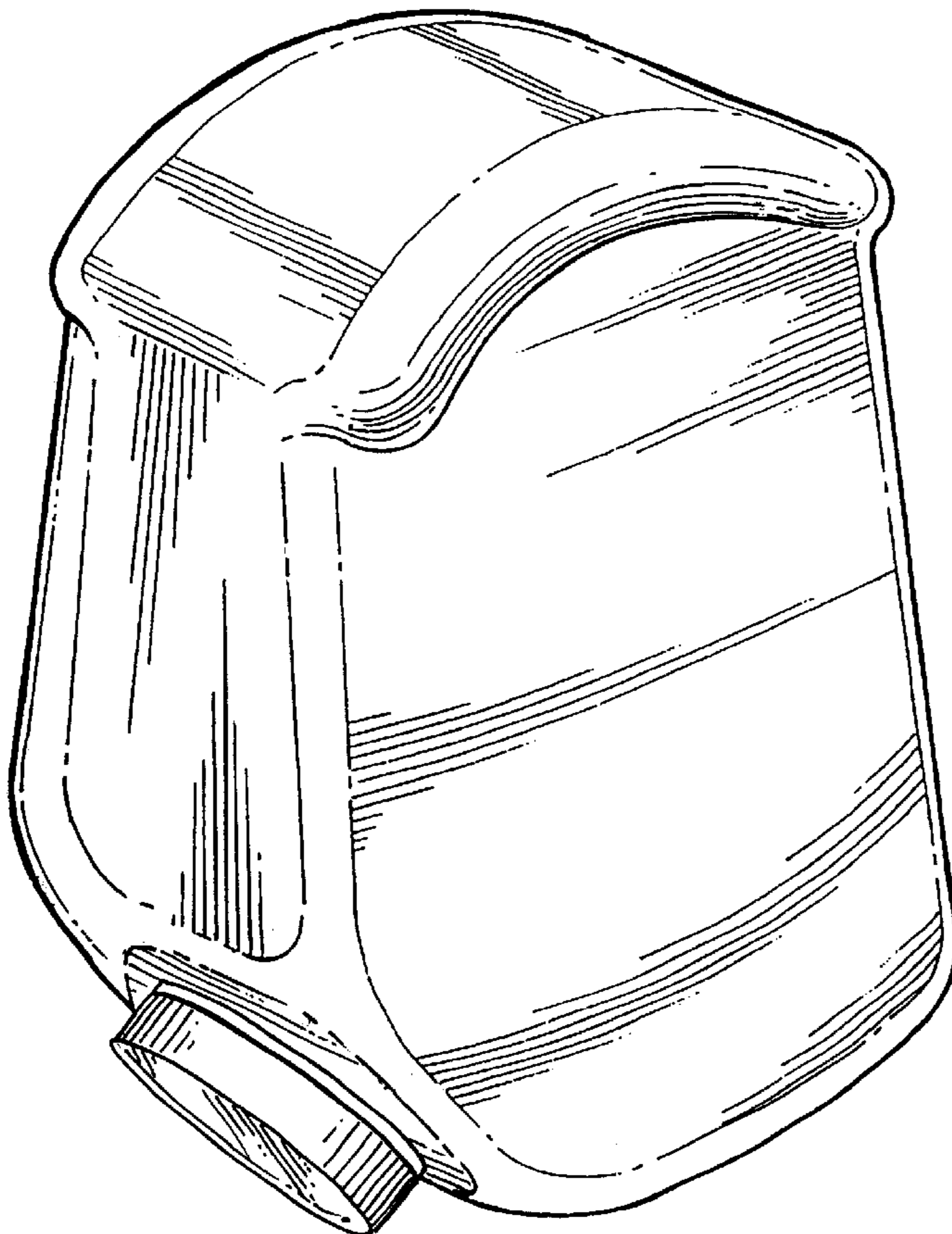
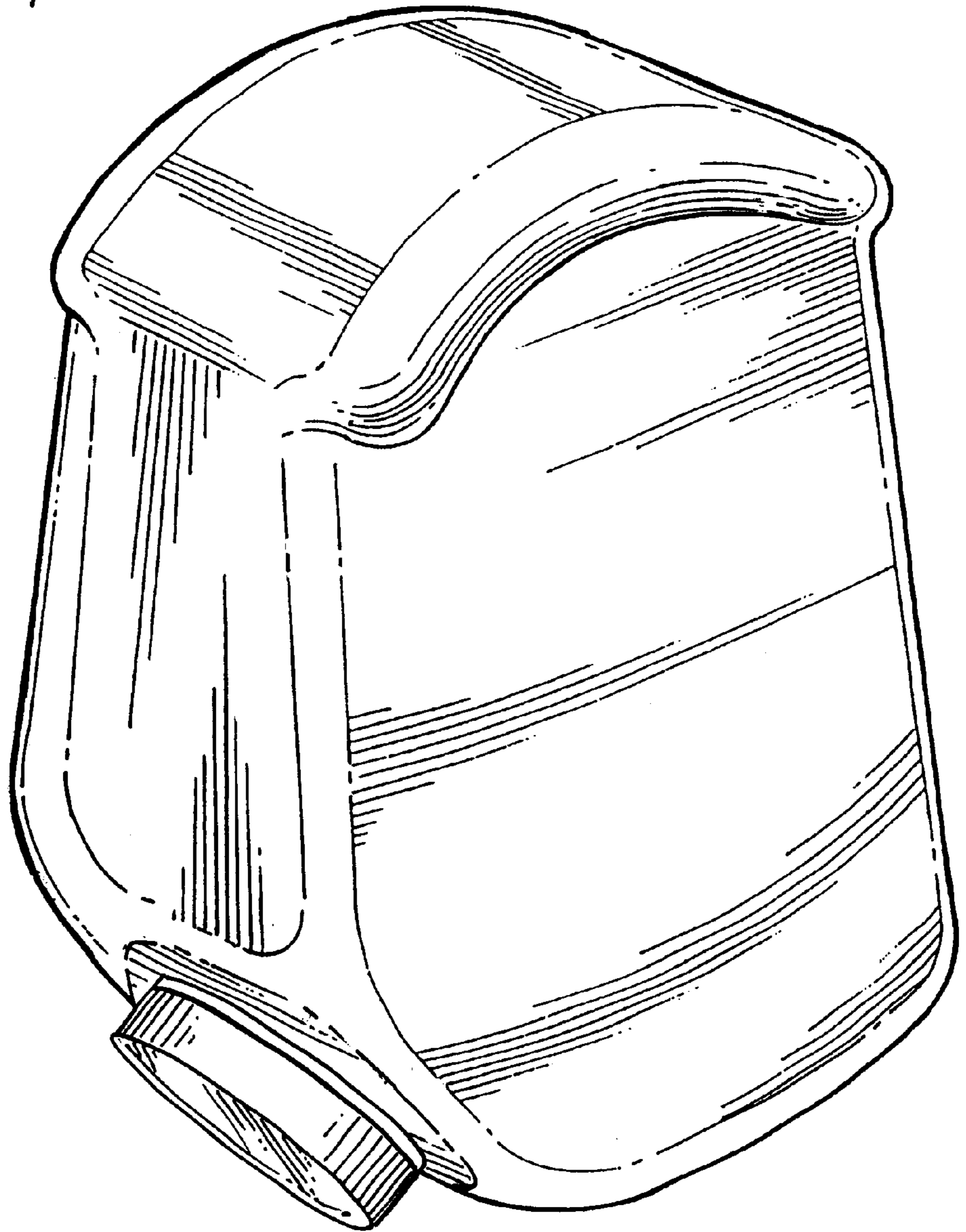

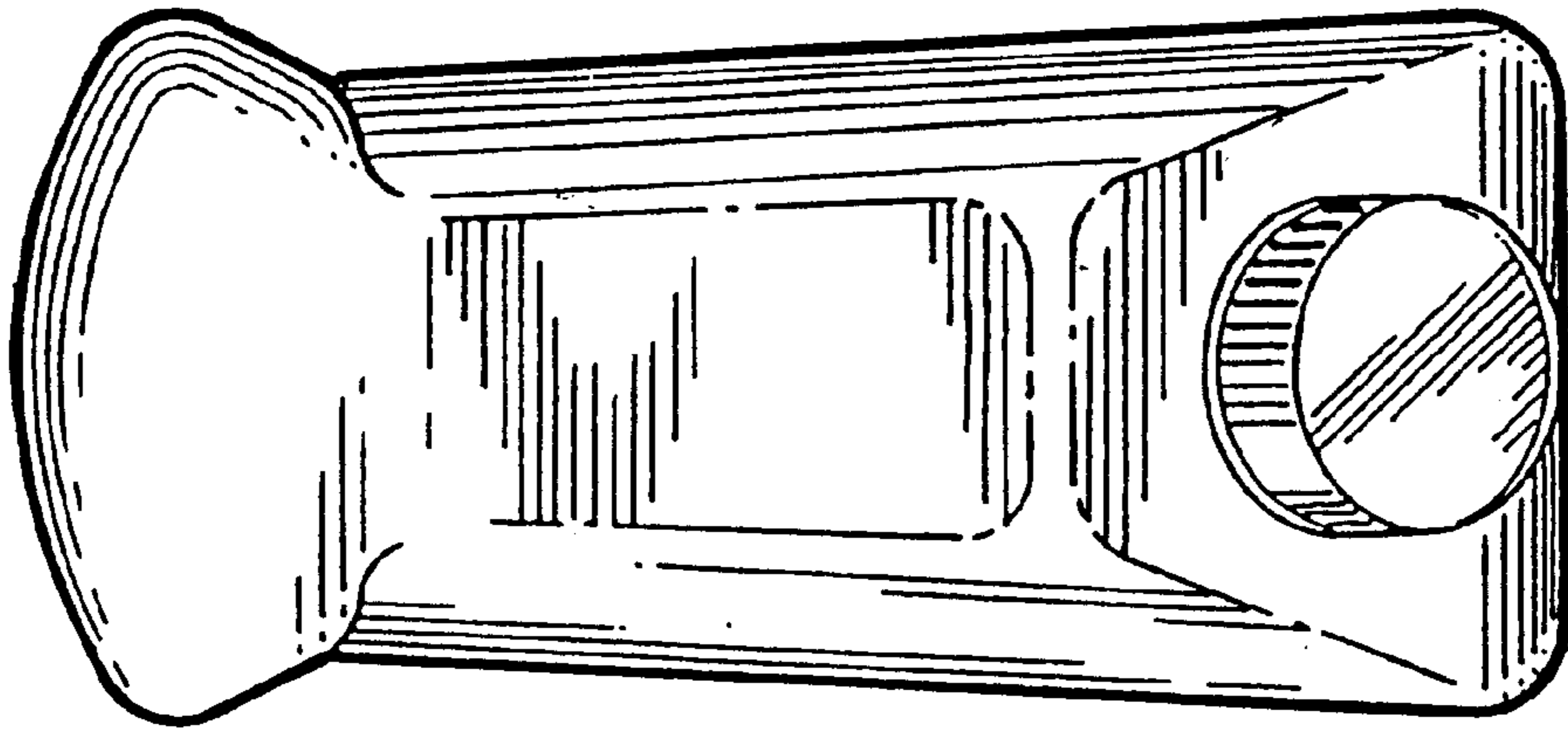

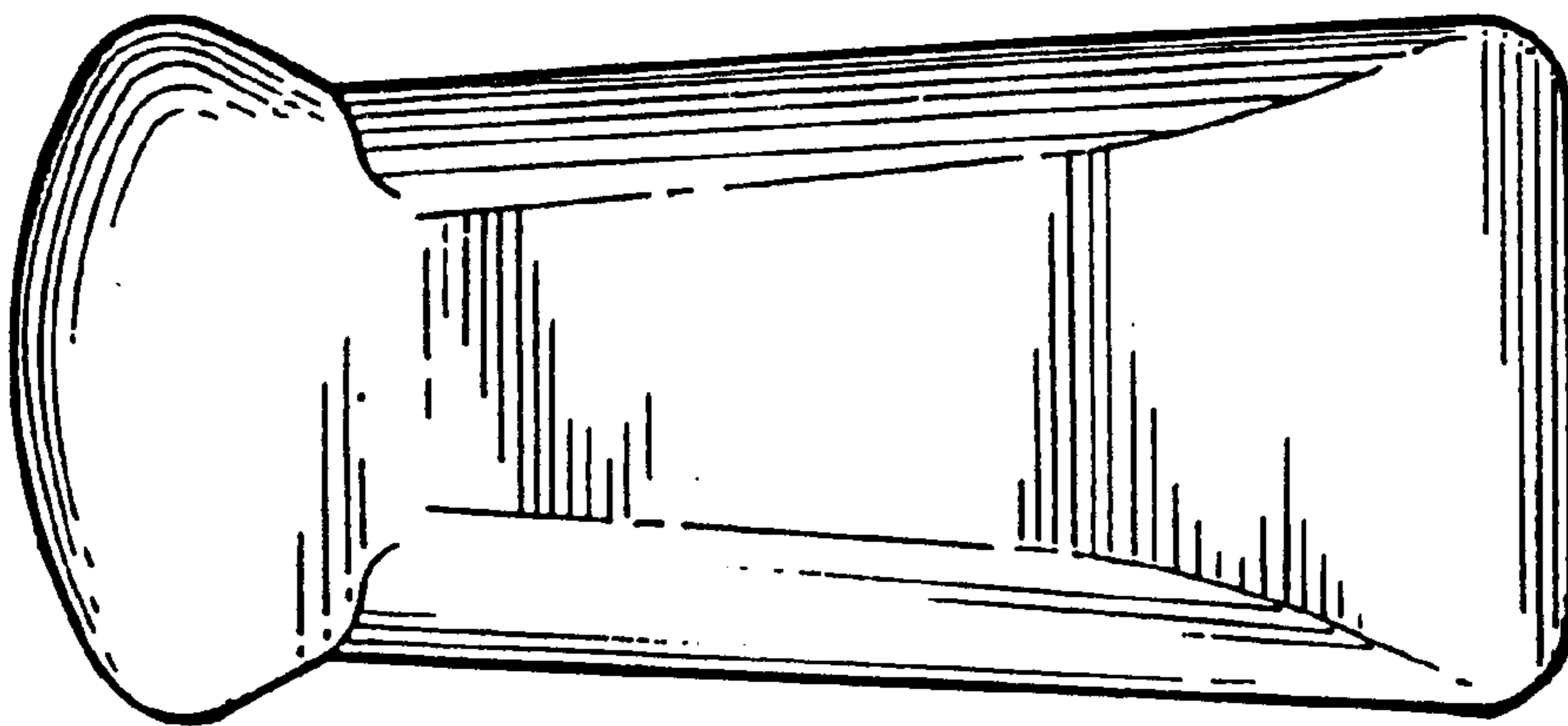

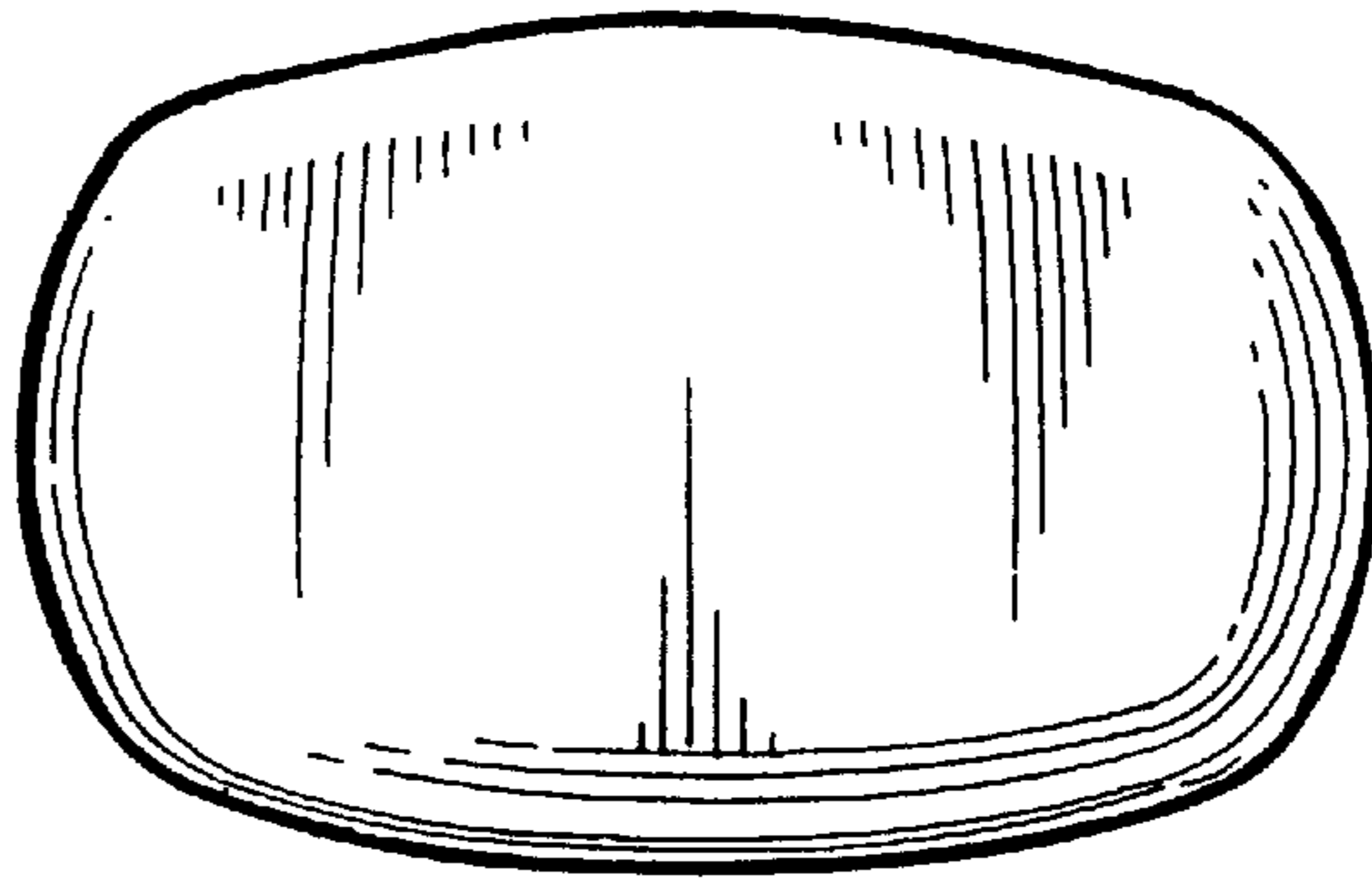

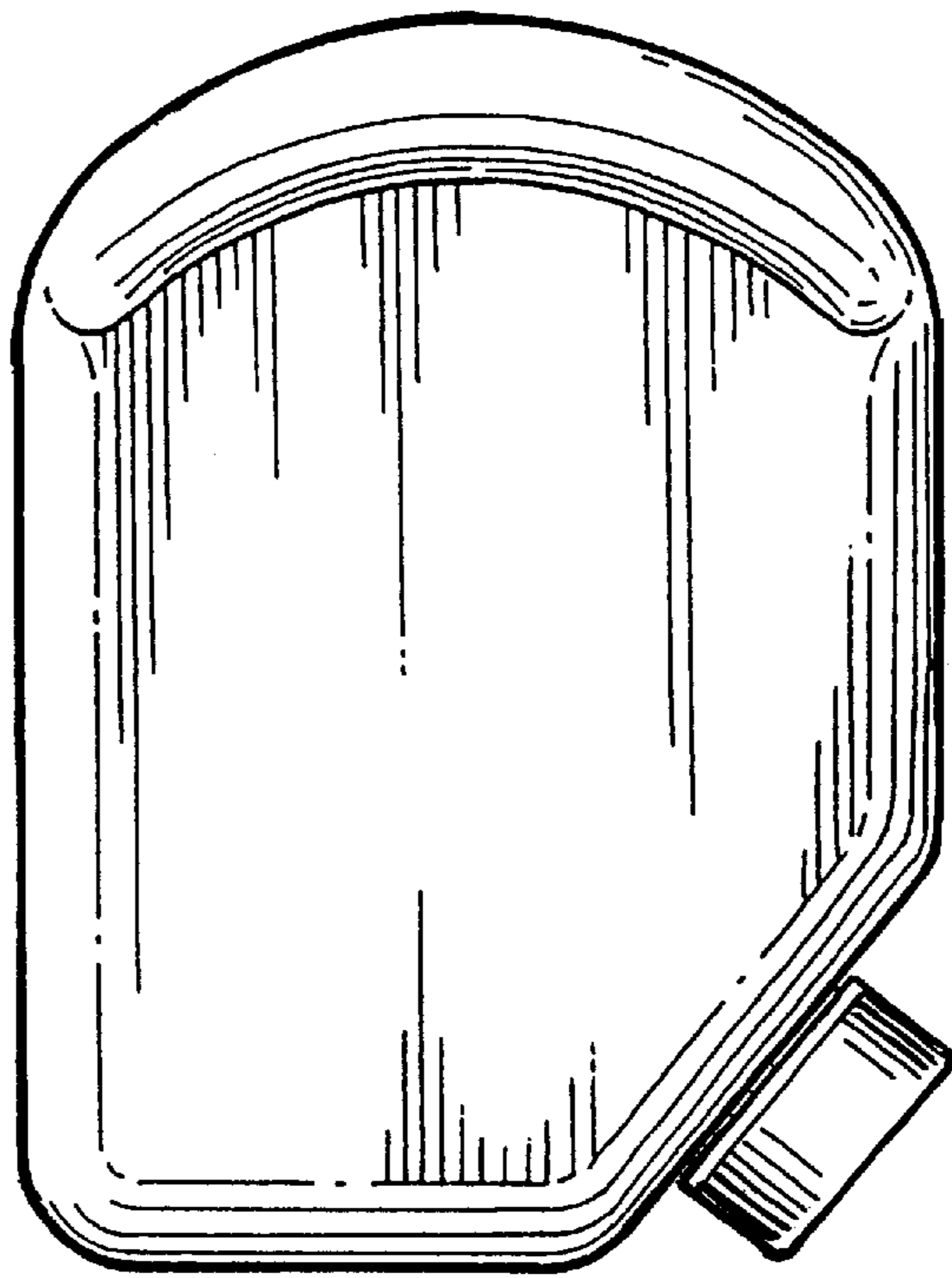
