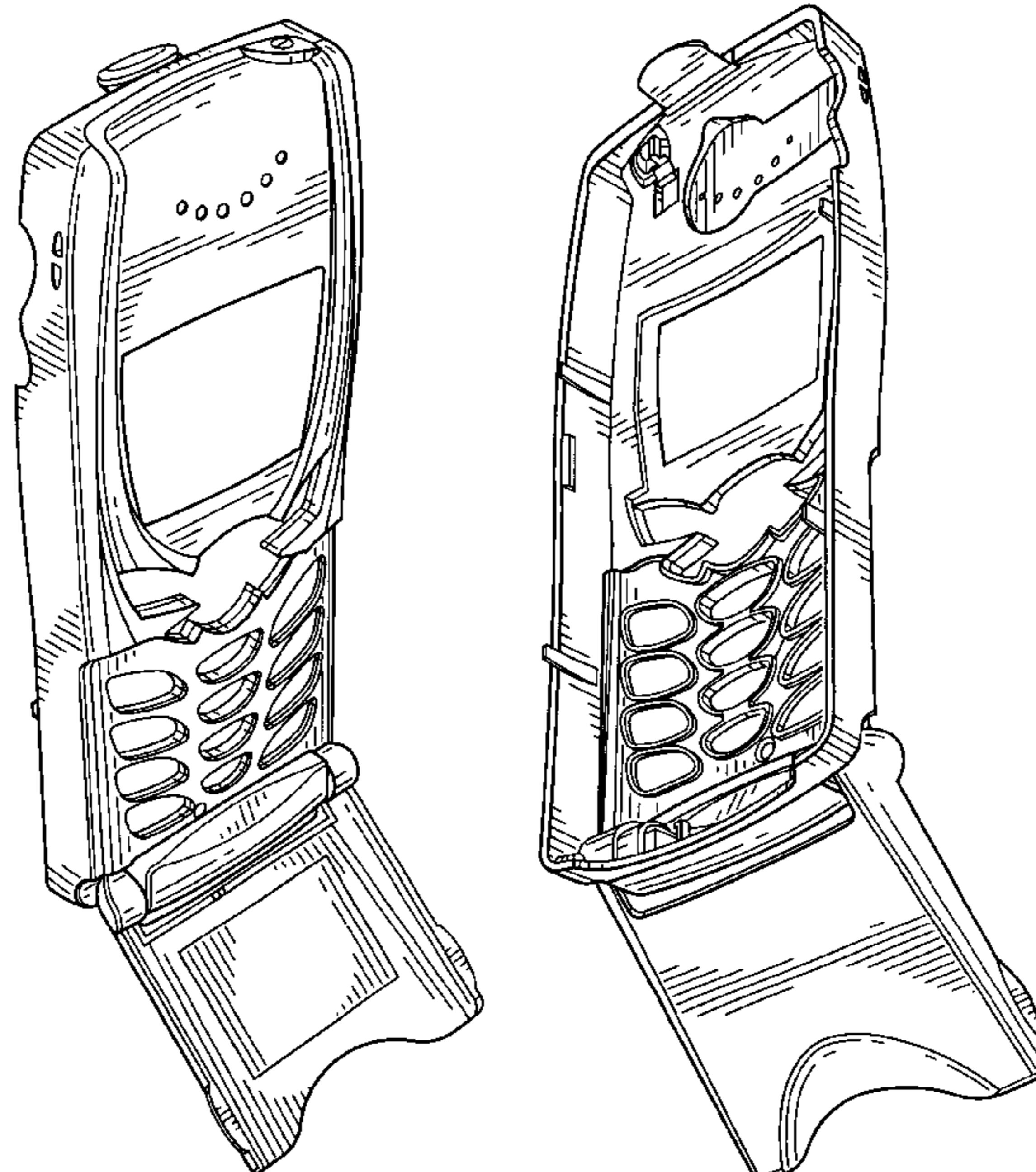
(57) **CLAIM**

The ornamental design for a front cover for a handset, as shown.

**DESCRIPTION**

FIG. 1 is a top plan view of the front cover for a handset; FIG. 2 is a left side view thereof; FIG. 3 is a front view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a perspective front view thereof; FIG. 7 is a rear view thereof; FIG. 8 is a perspective rear view thereof; FIG. 9 is a front view thereof in open position; FIG. 10 is a right side view thereof in open position; FIG. 11 is a perspective front view thereof in open position; and, FIG. 12 is a rear view thereof in open position.

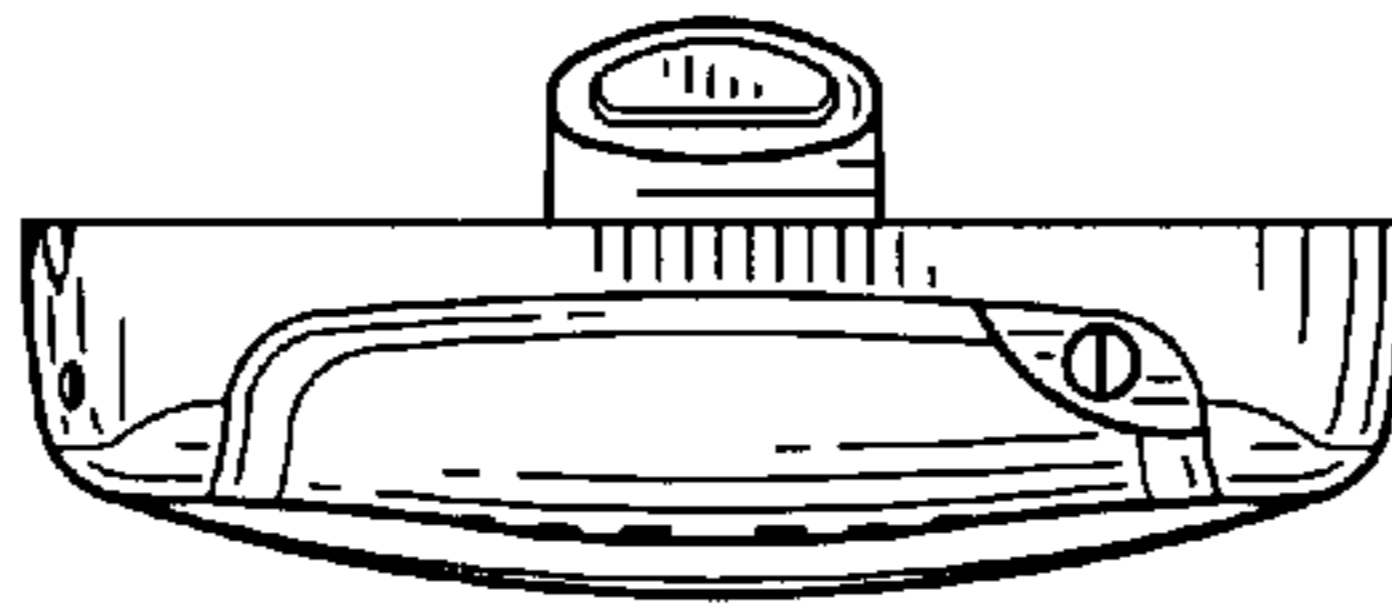

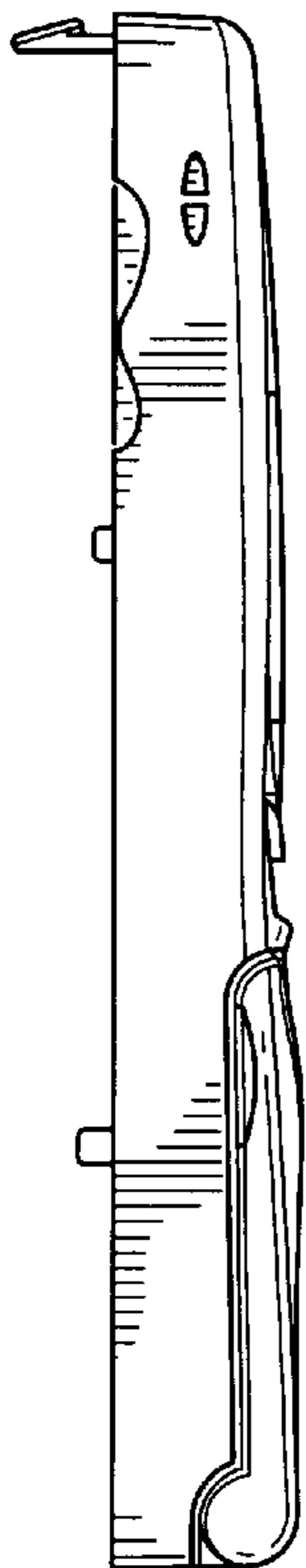

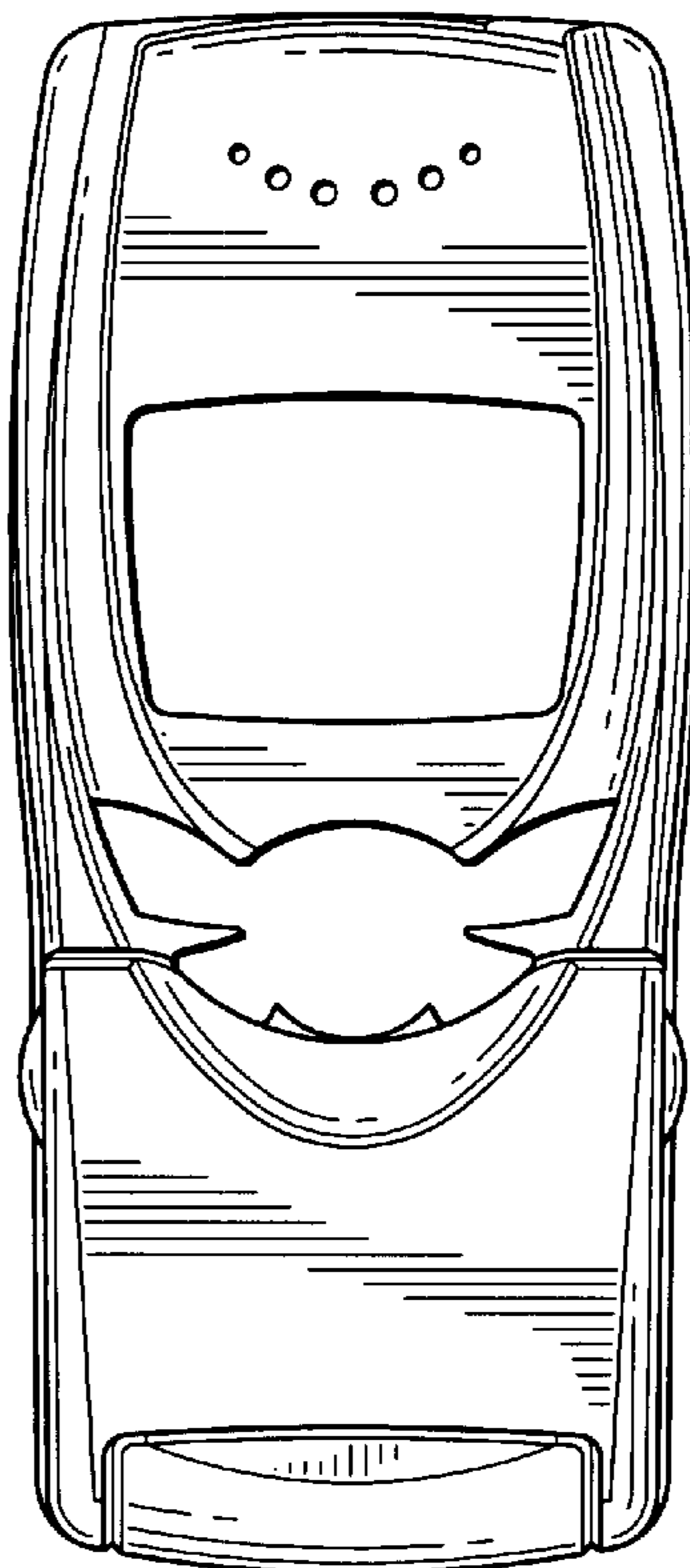

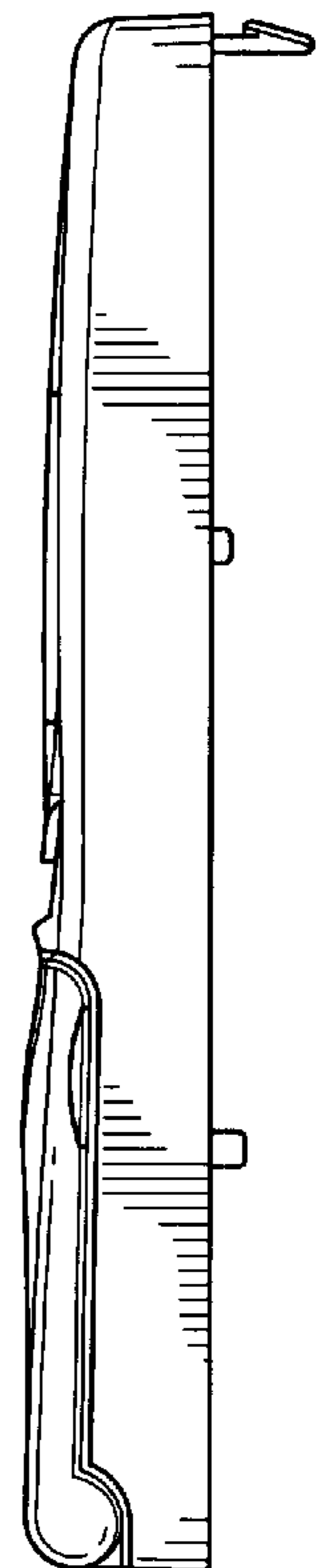

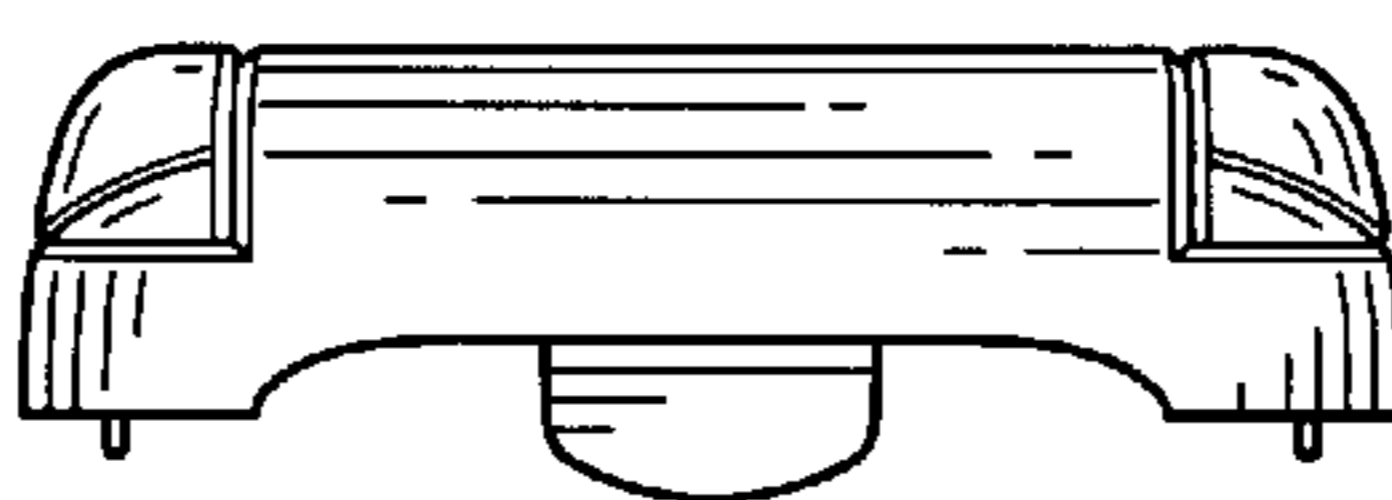

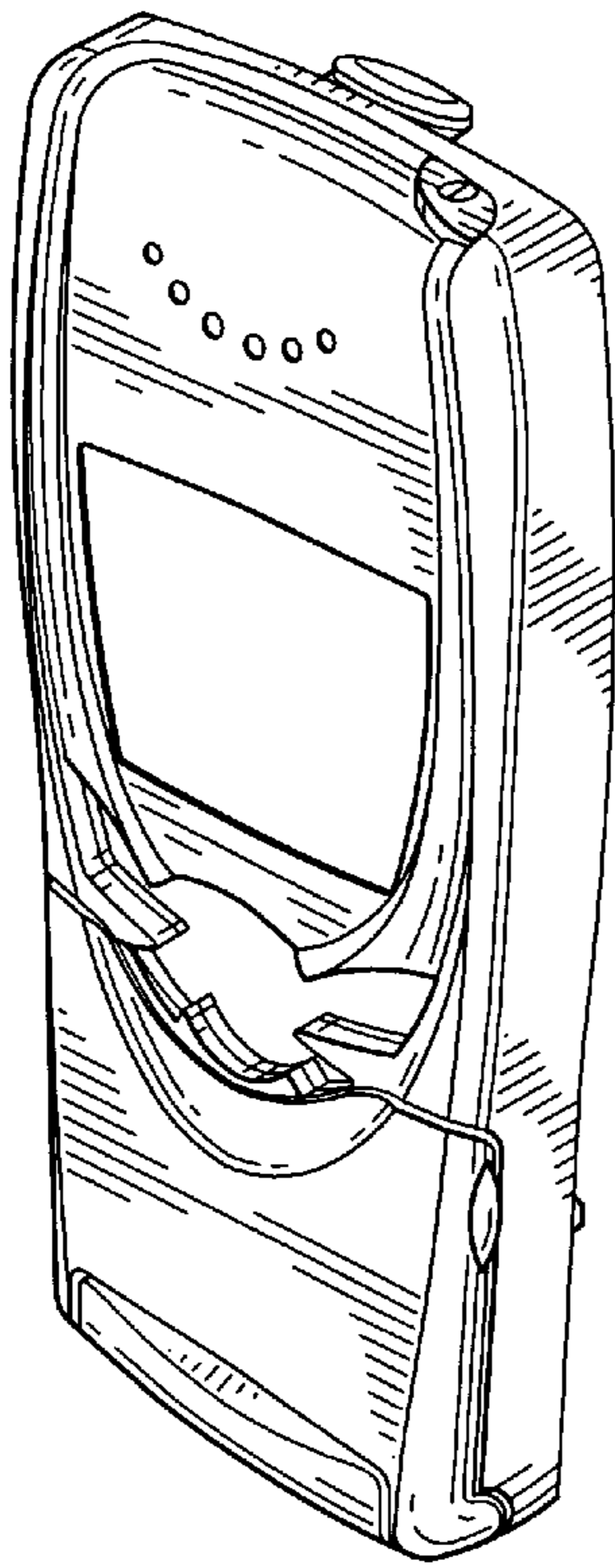

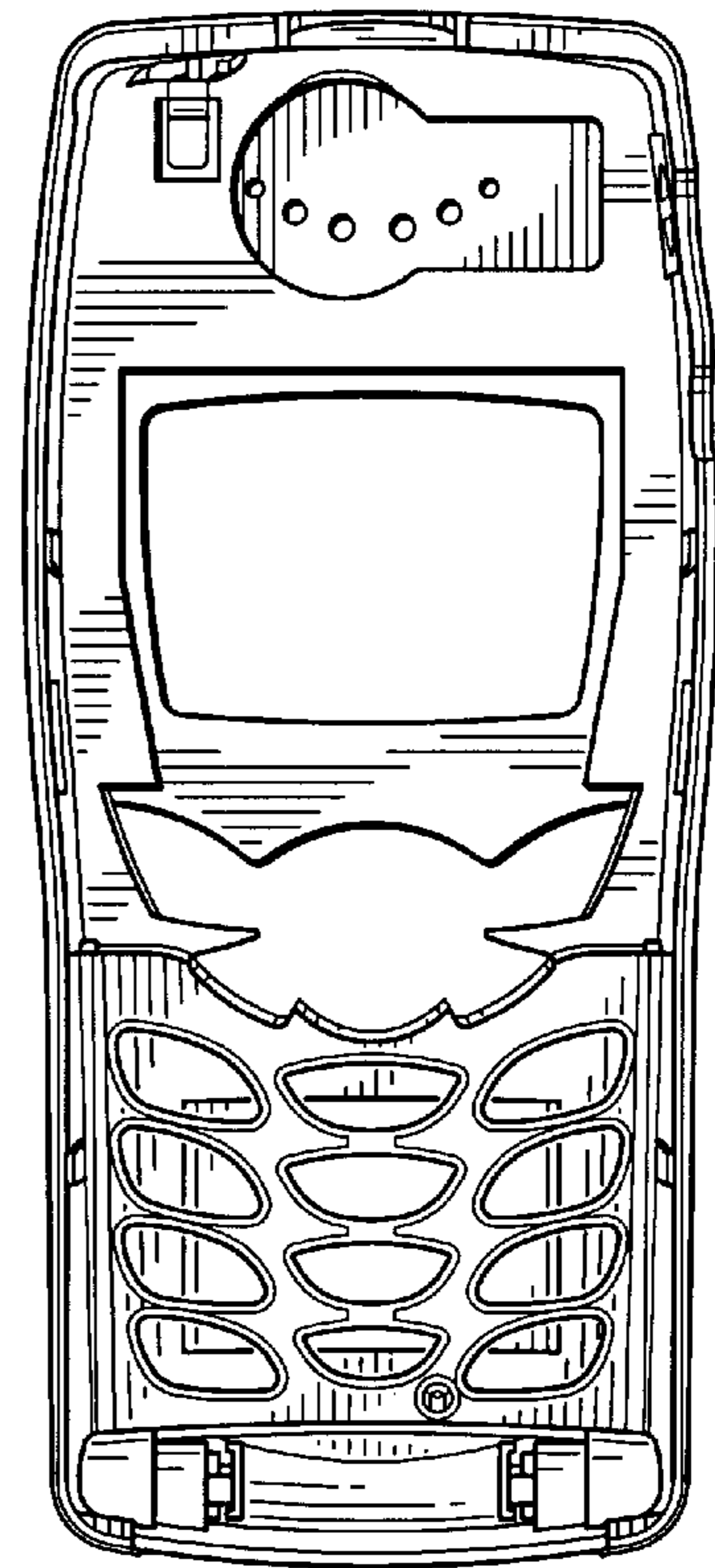

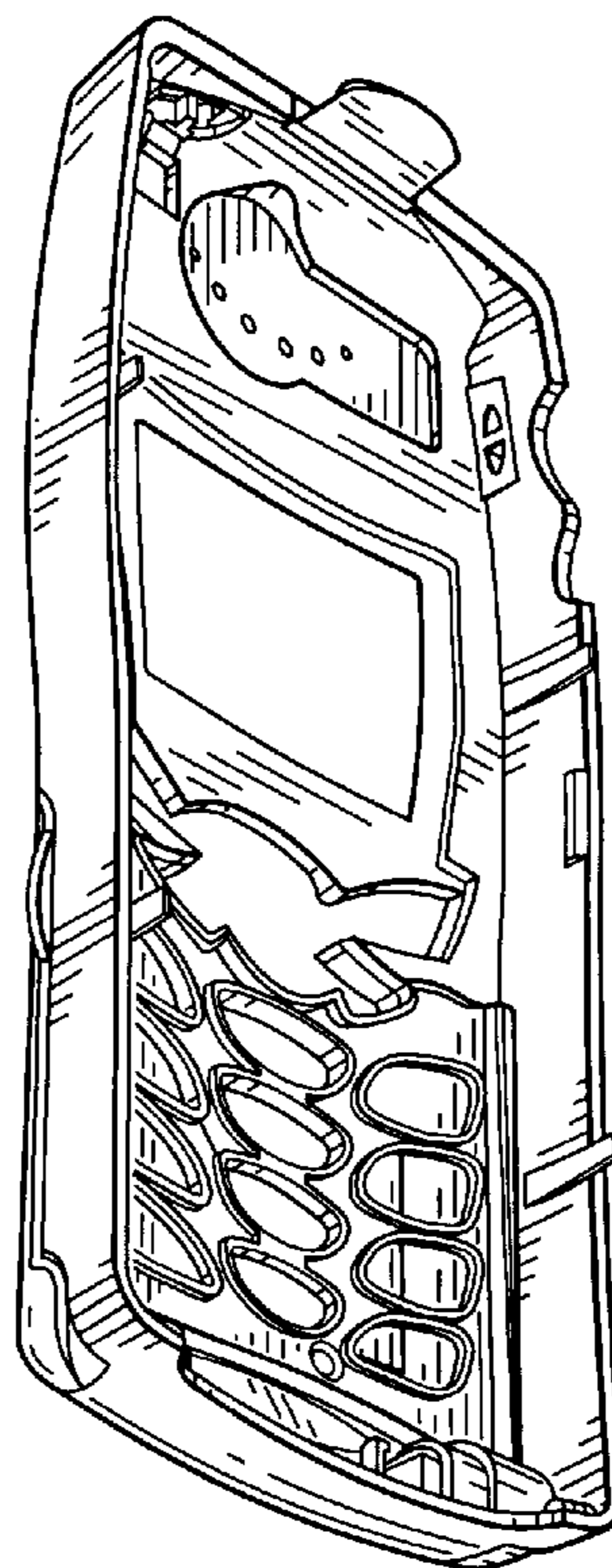

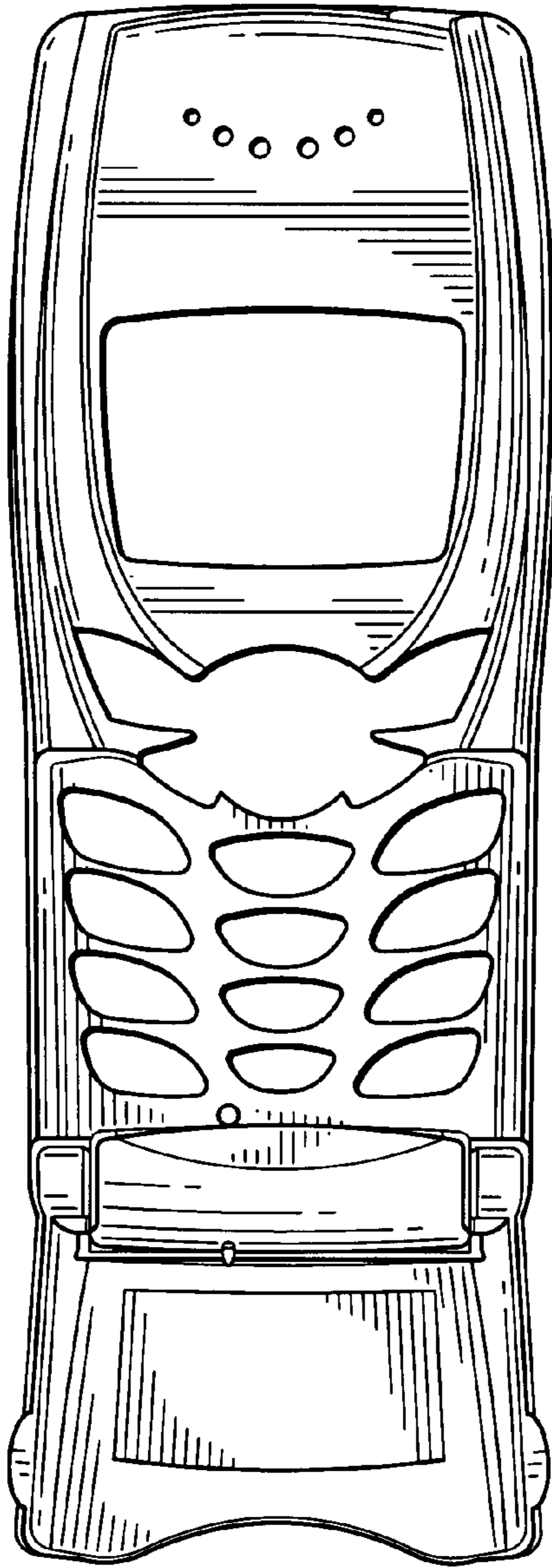

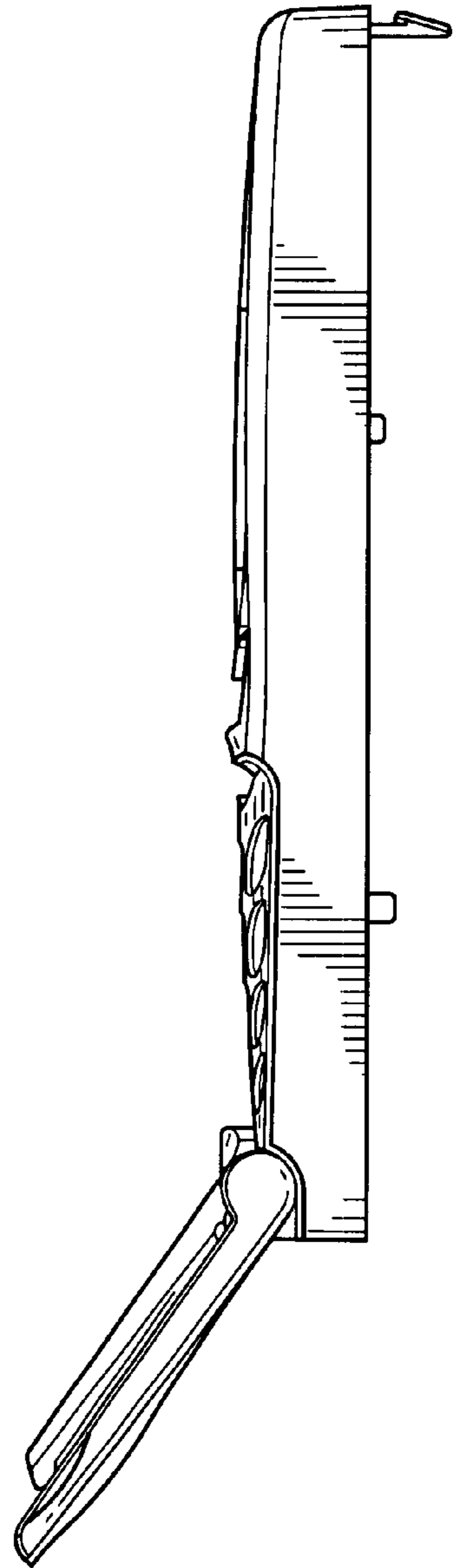

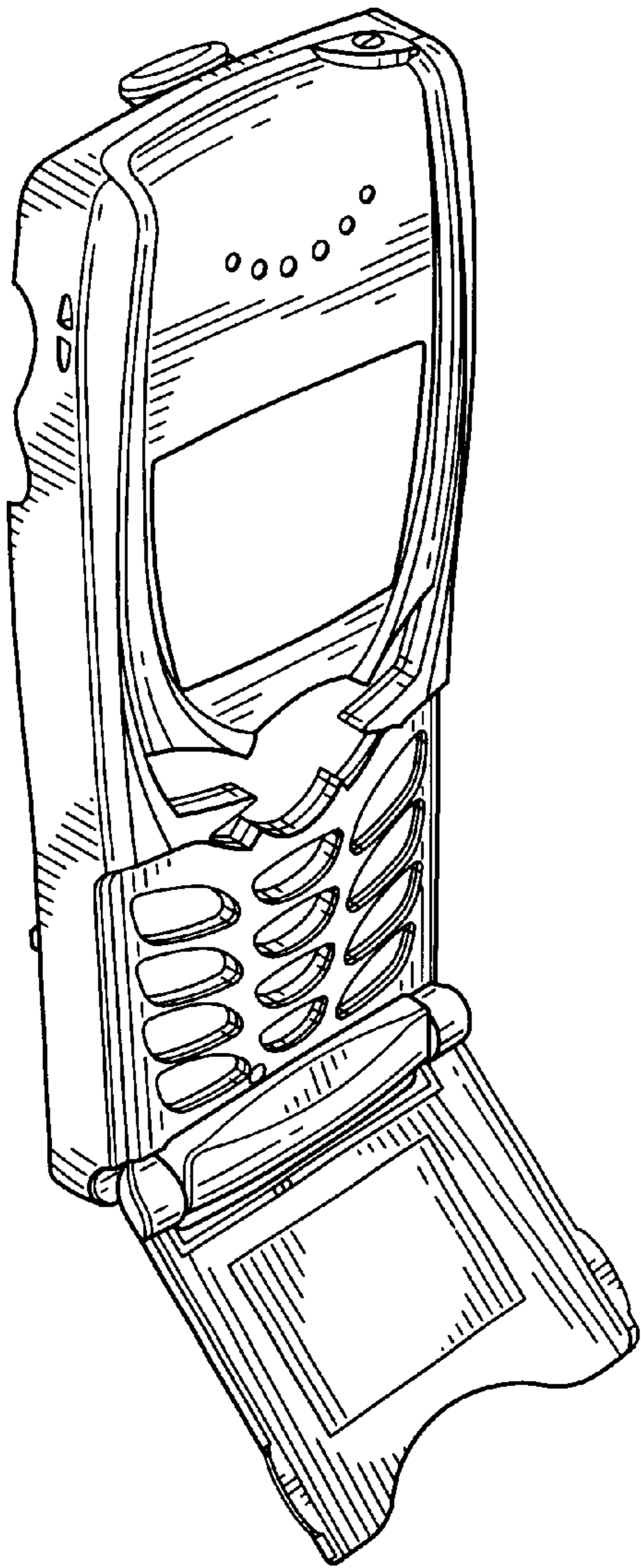

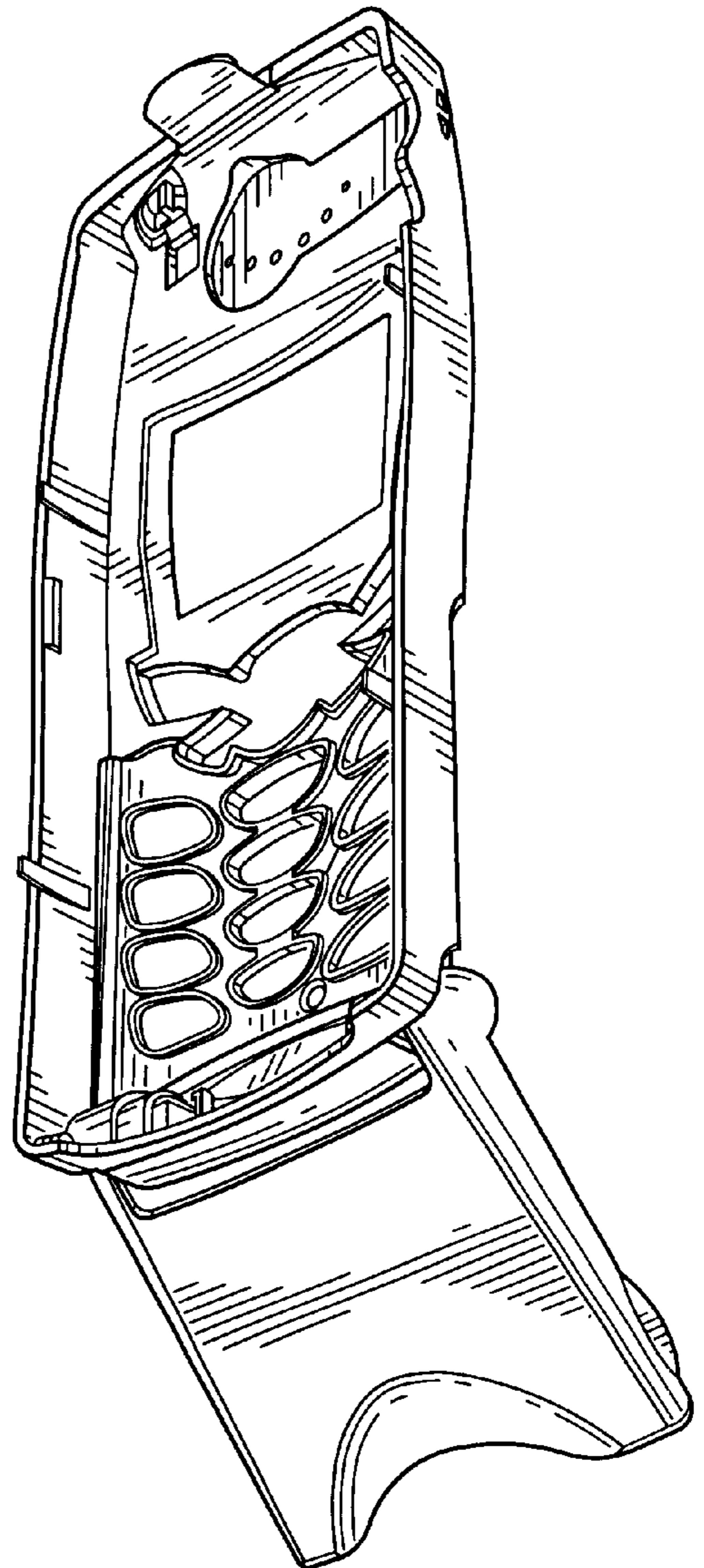
