FIG. 2 is a left side view of a handset according to the invention, the right side view being a mirror image thereof;

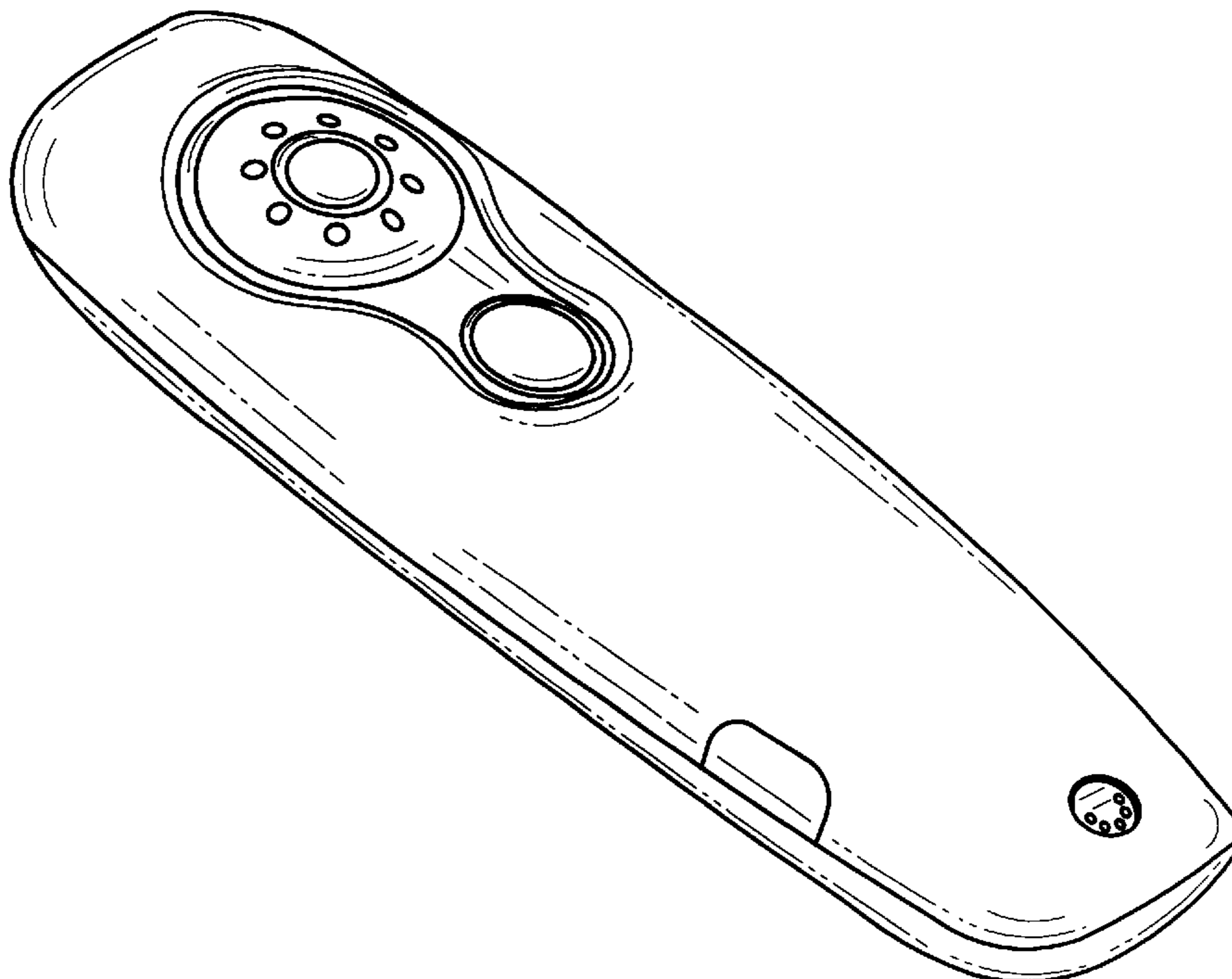
FIG. 3 is a front view of a handset according to the invention;

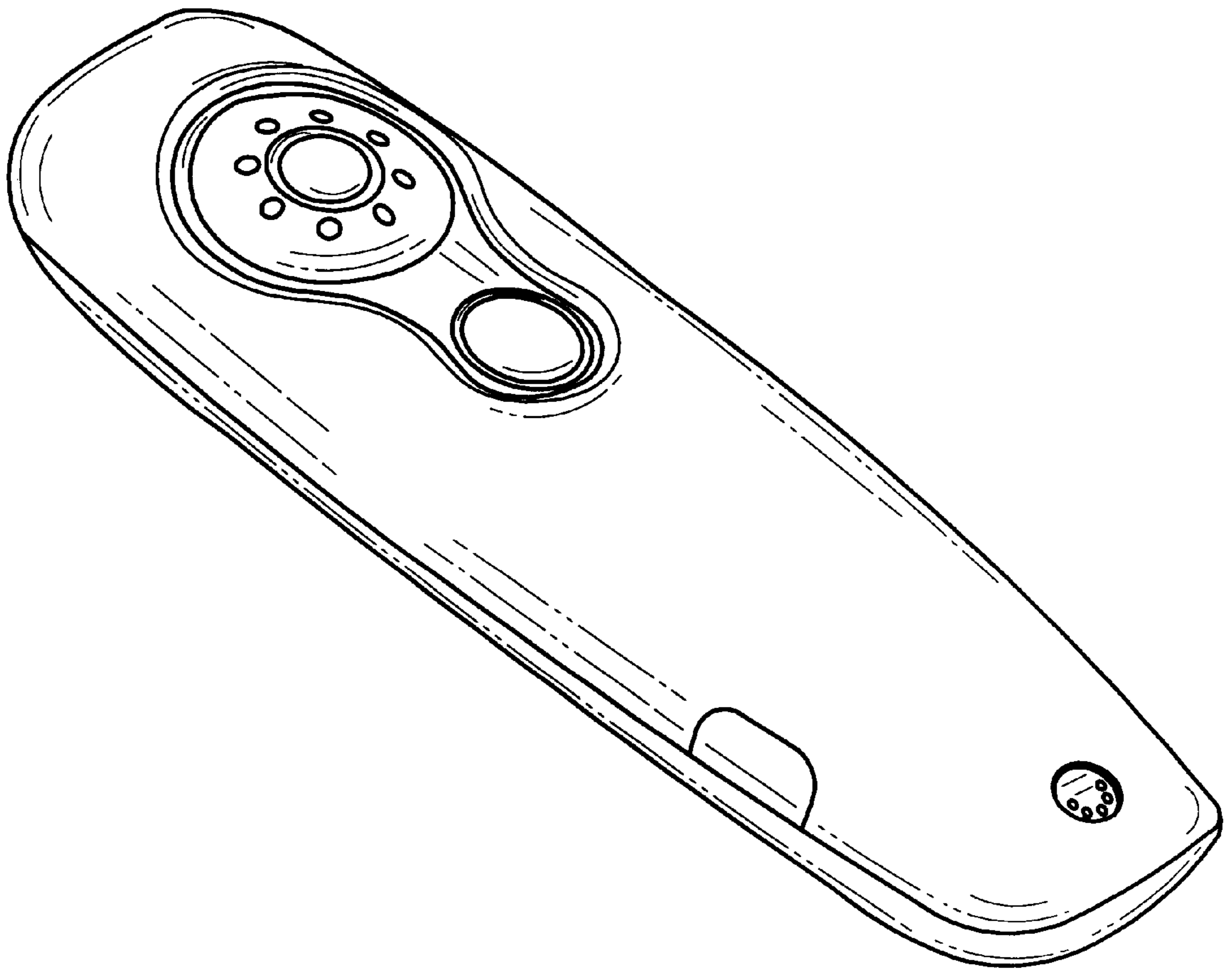
FIG. 4 is a top view of a handset according to the invention;

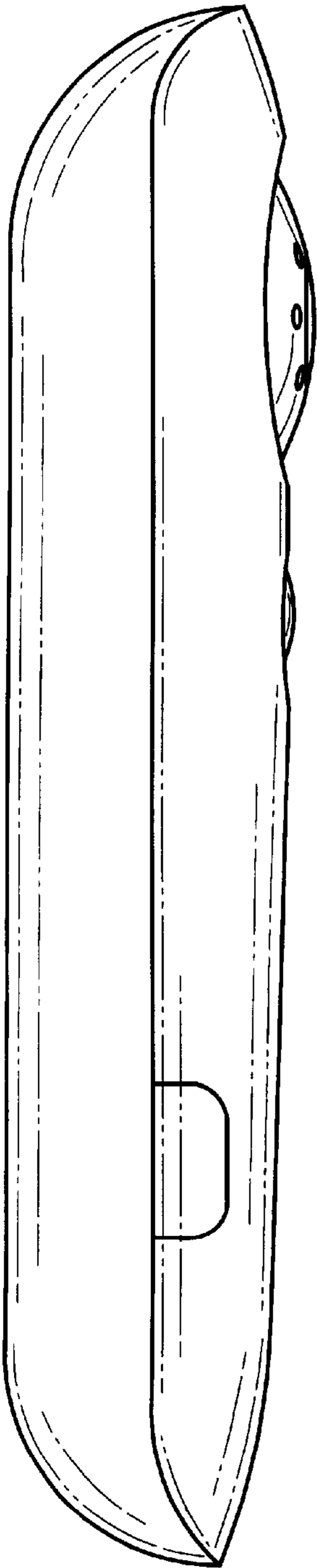

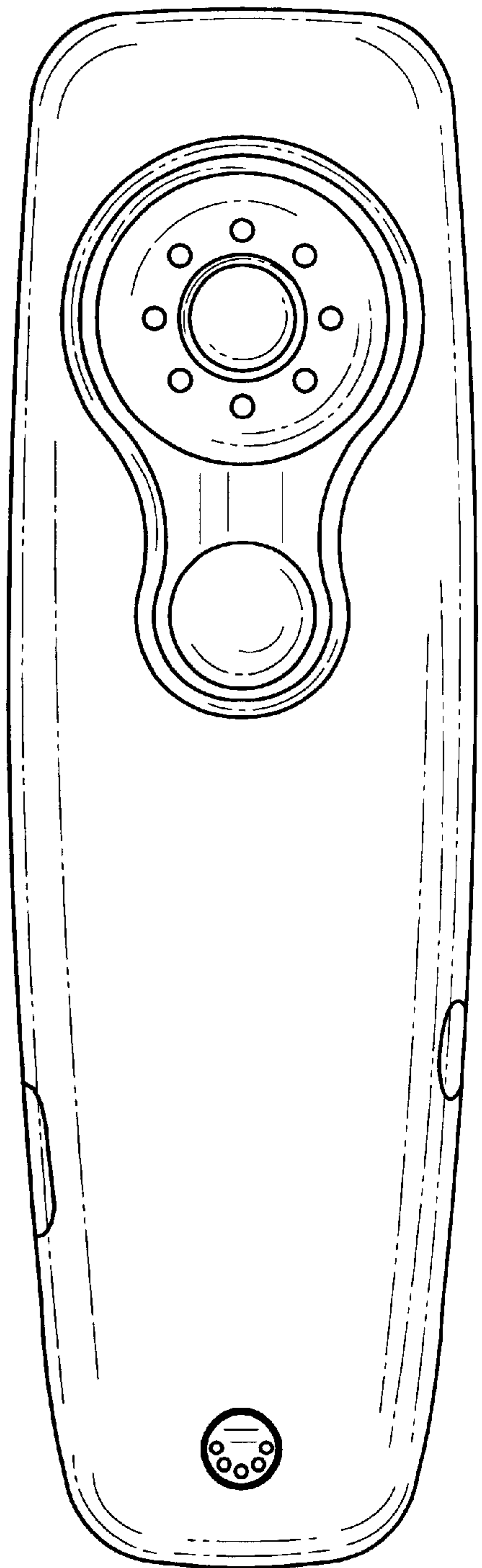
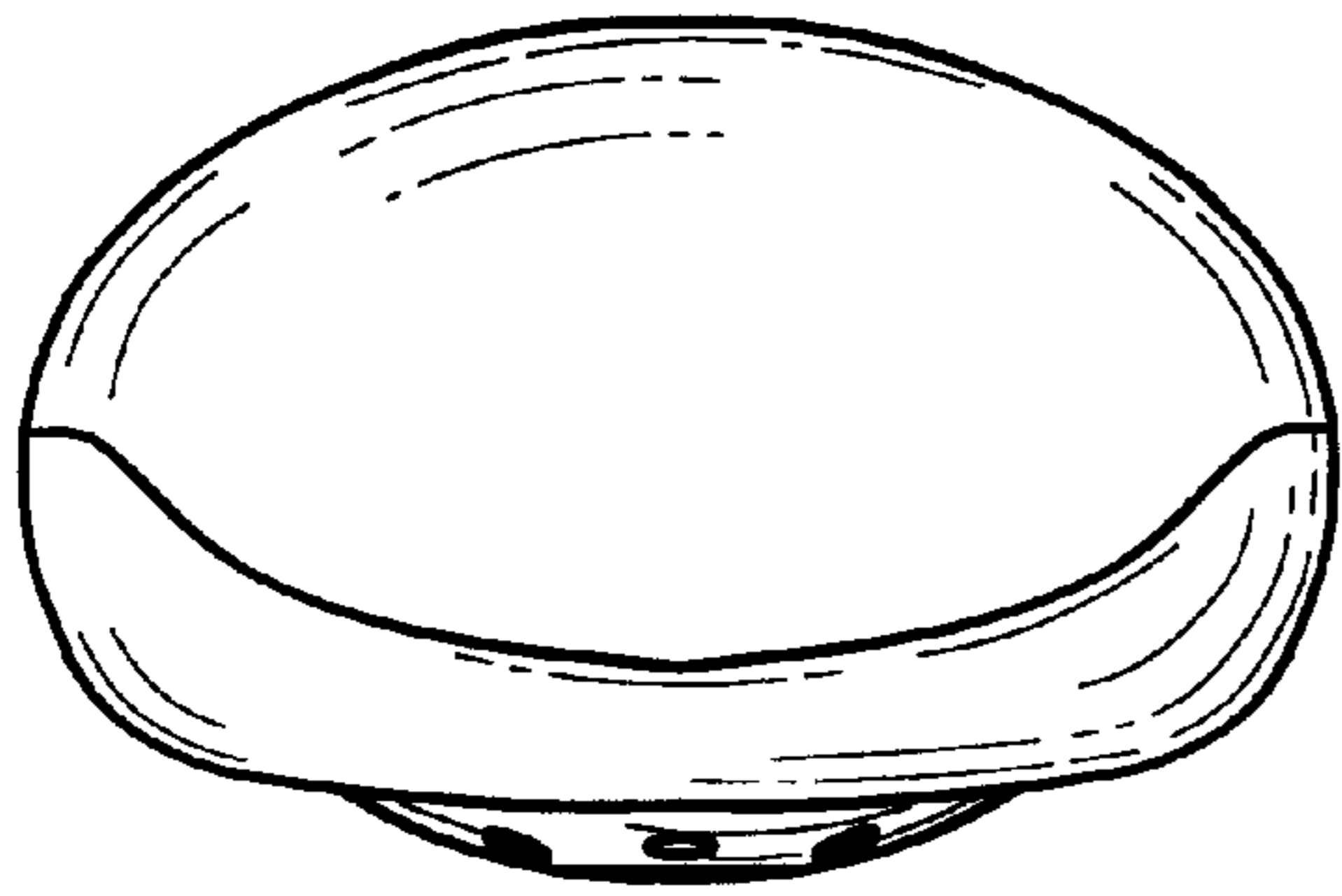
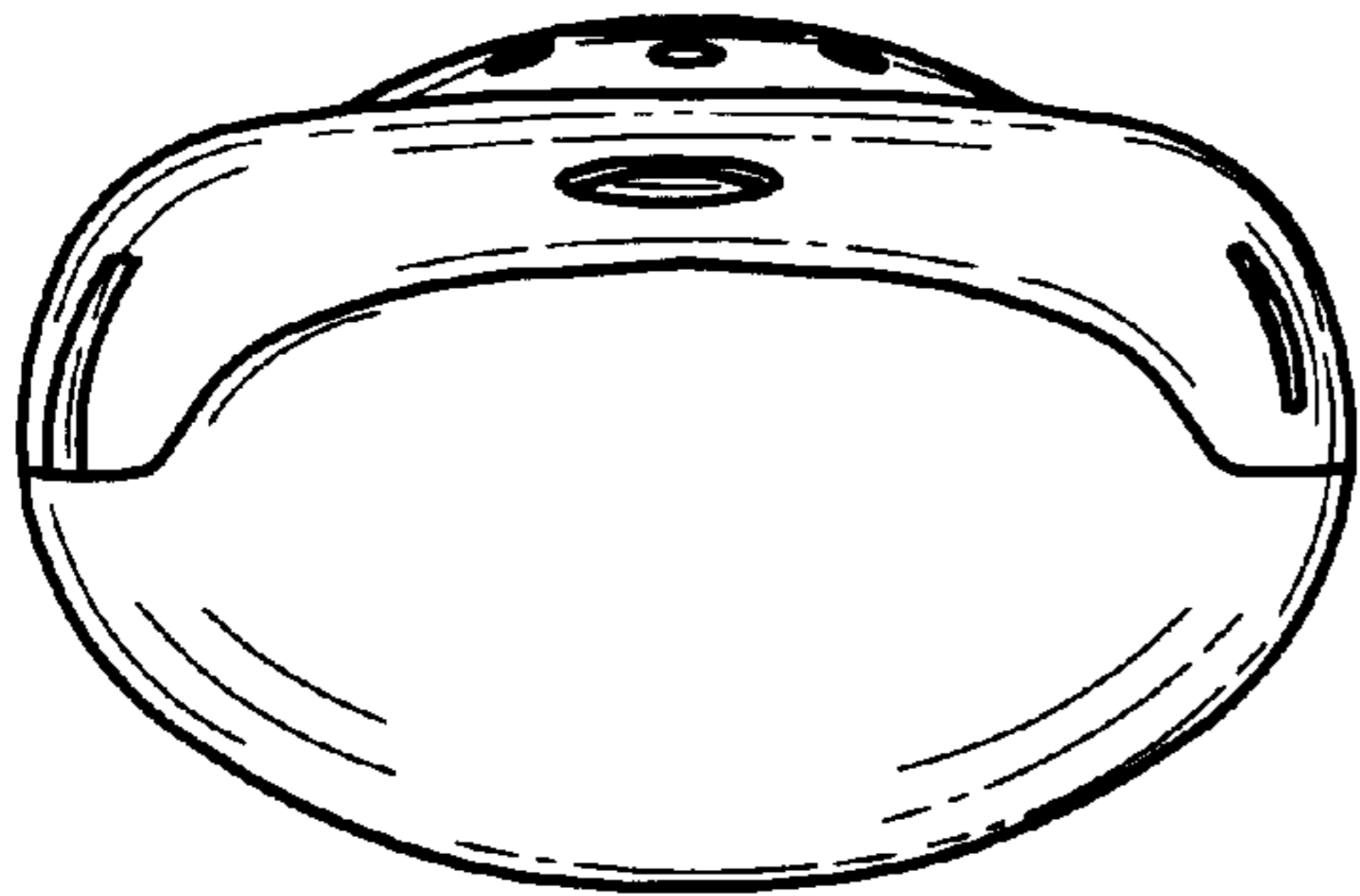


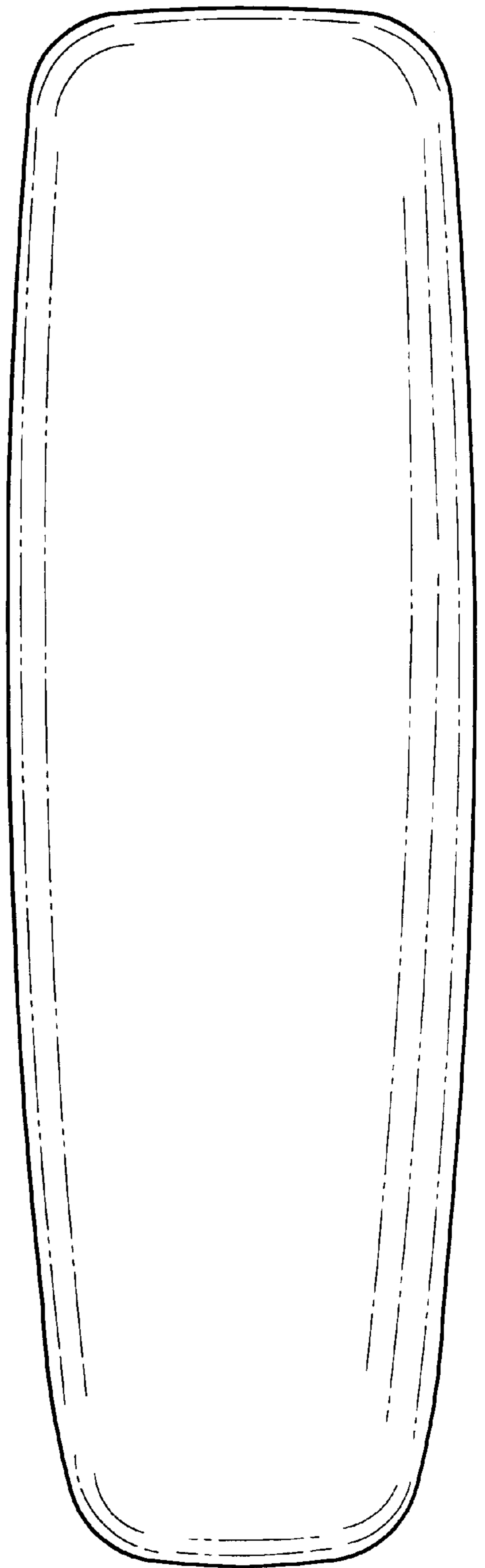
