The ornamental design for a universal miter saw bench, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view showing the support arms fully extended;

FIG. 2 is a top plan view showing the support arms stowed;

FIG. 3 is a bottom plan view thereof;

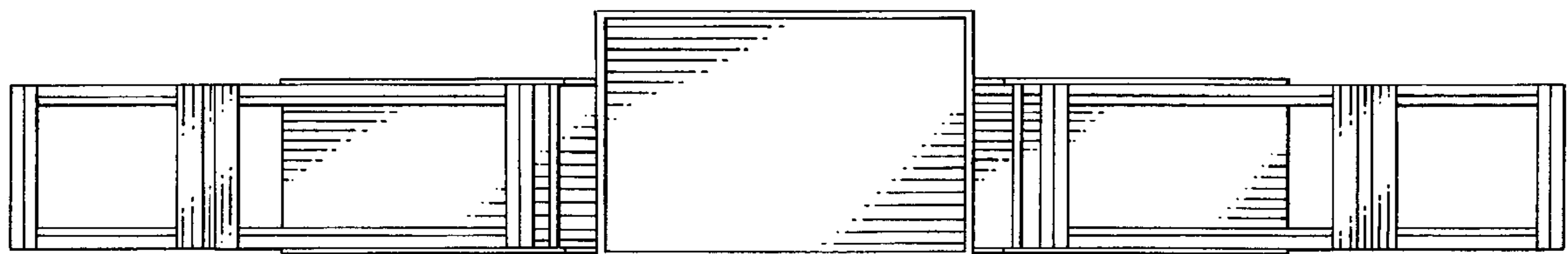
FIG. 4 is a front elevational view showing the support arms fully extended;

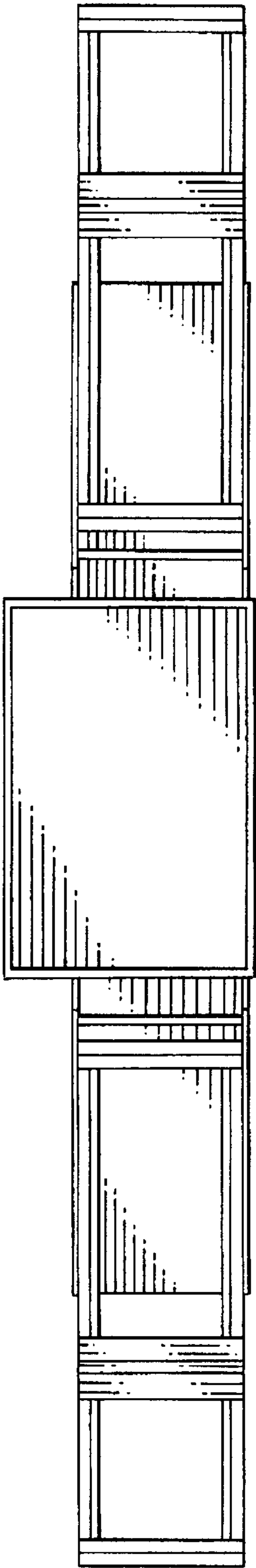

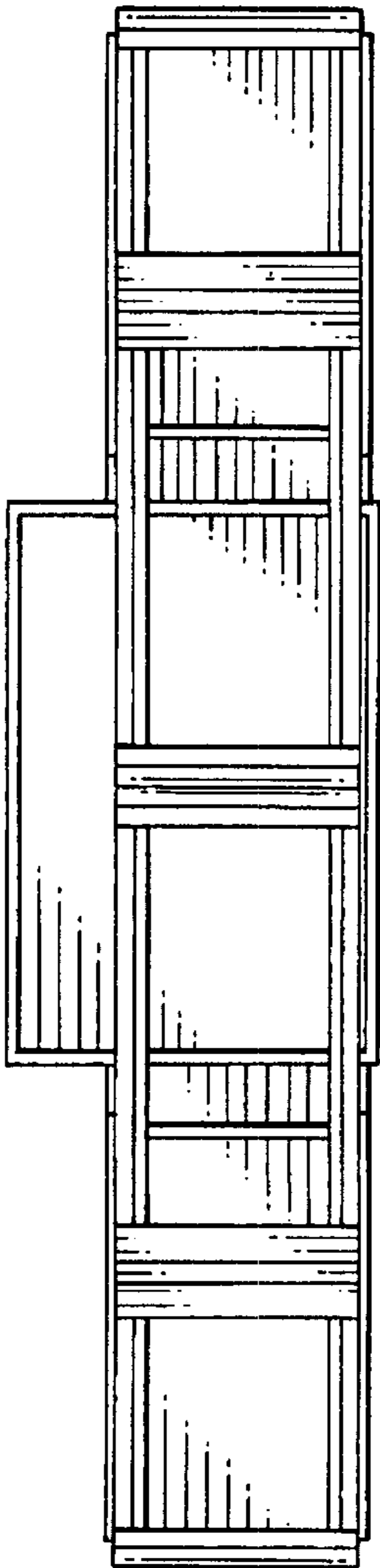

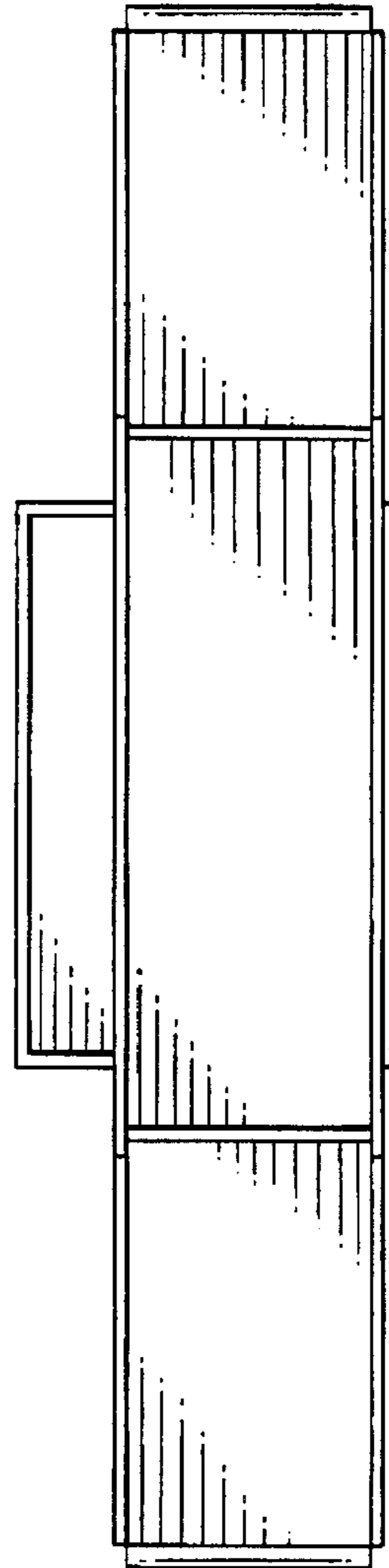

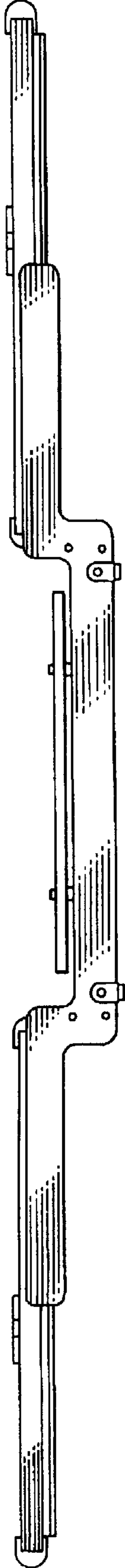

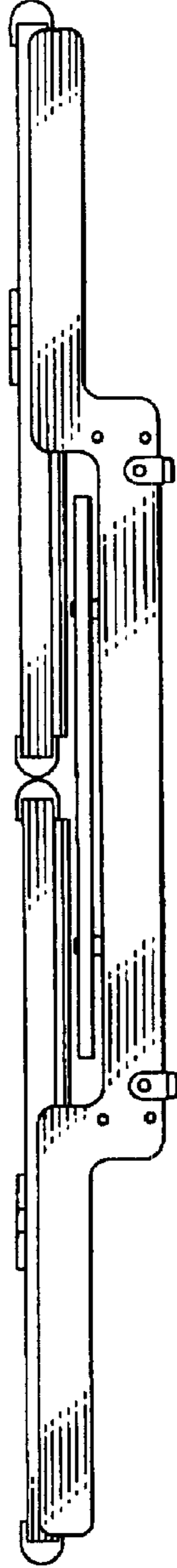

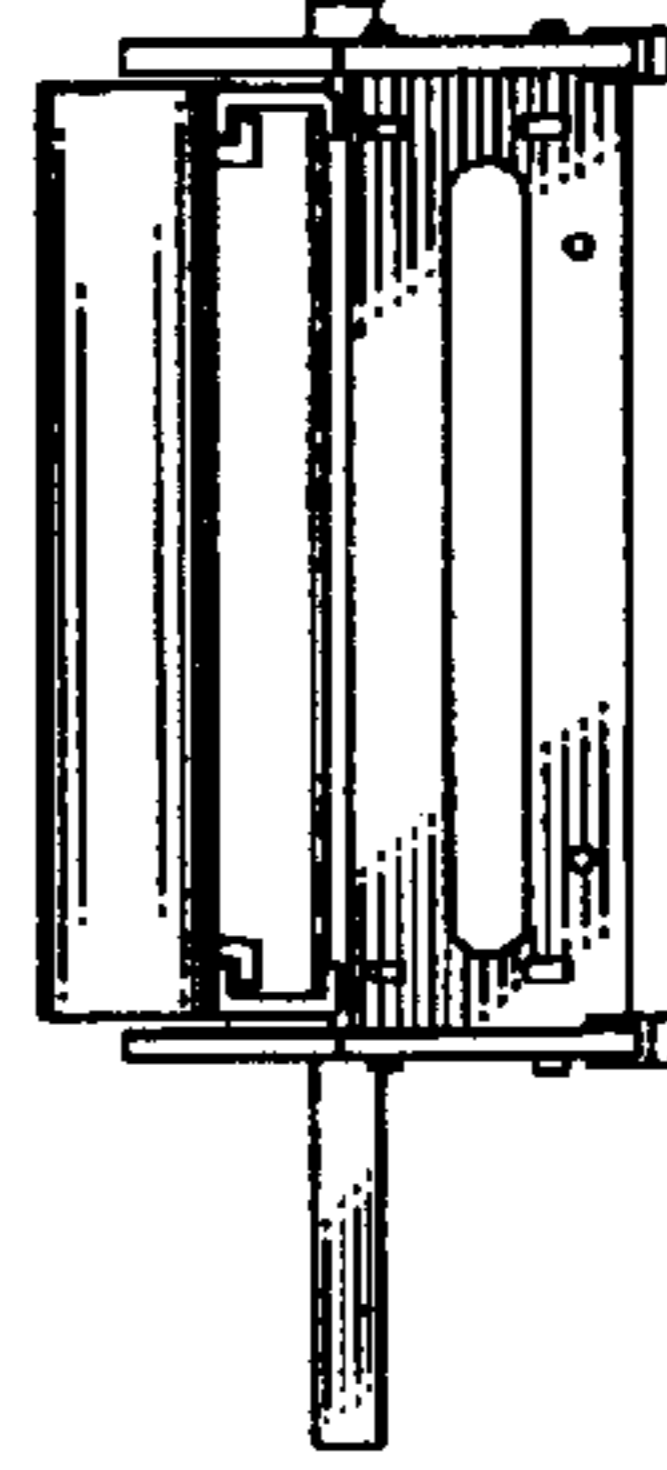

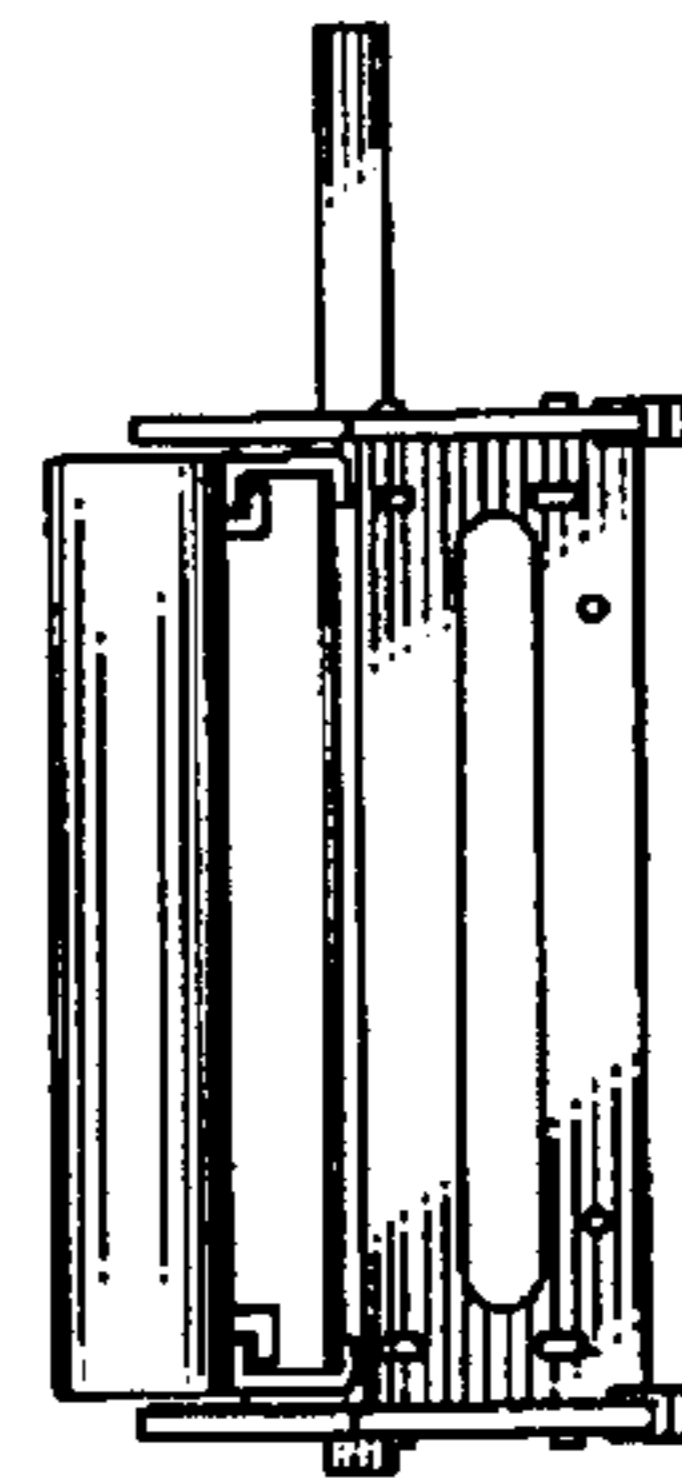
