(57) **CLAIM**

The ornamental design for a plate for a midsection of a gaming device, as shown and described.

DESCRIPTION

FIG. 2 is a front elevational view of the plate for a midsection of a gaming devise of our design;

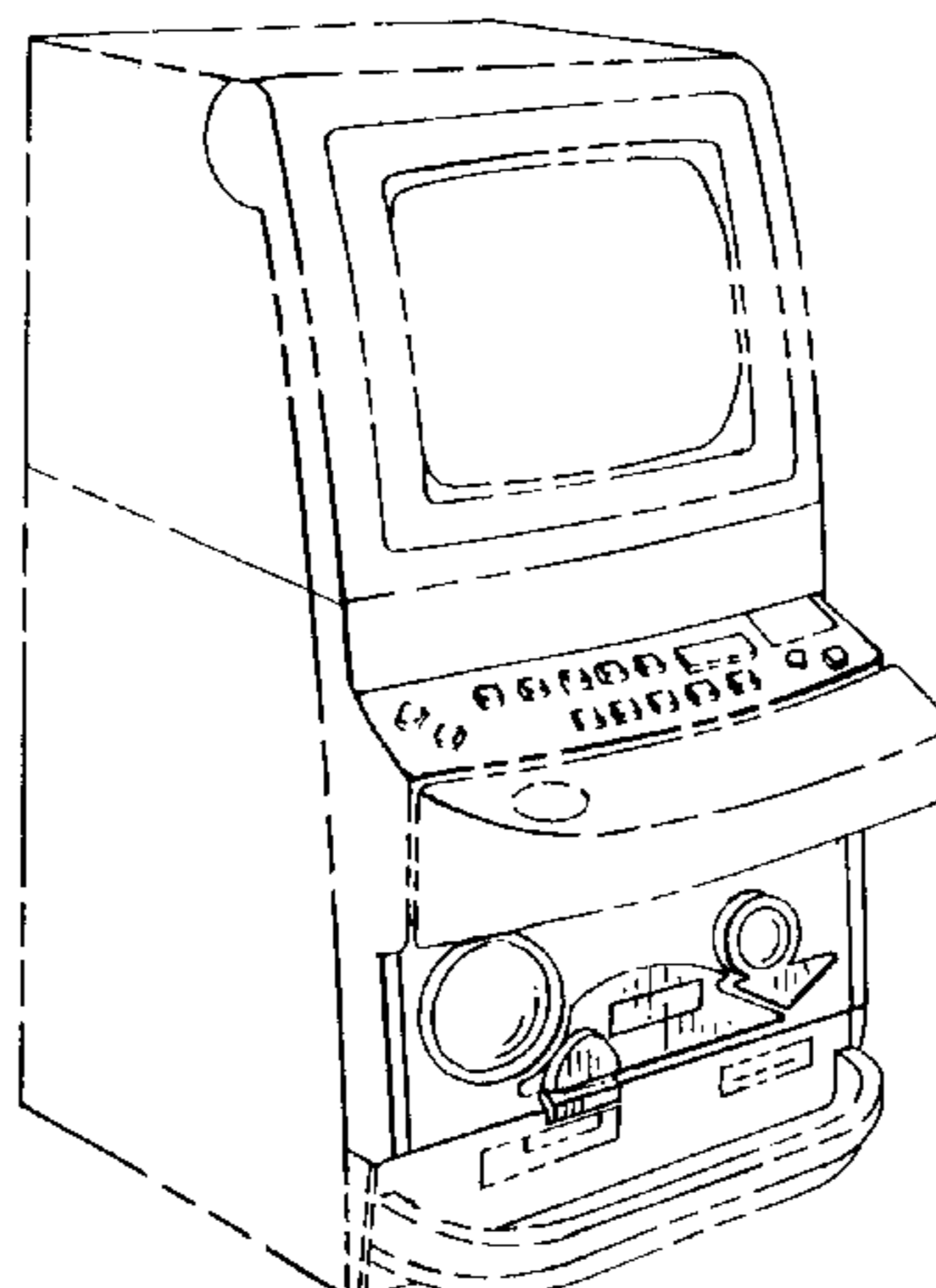
FIG. 3 is a top plan view of the plate for a midsection of a gaming device of our design;

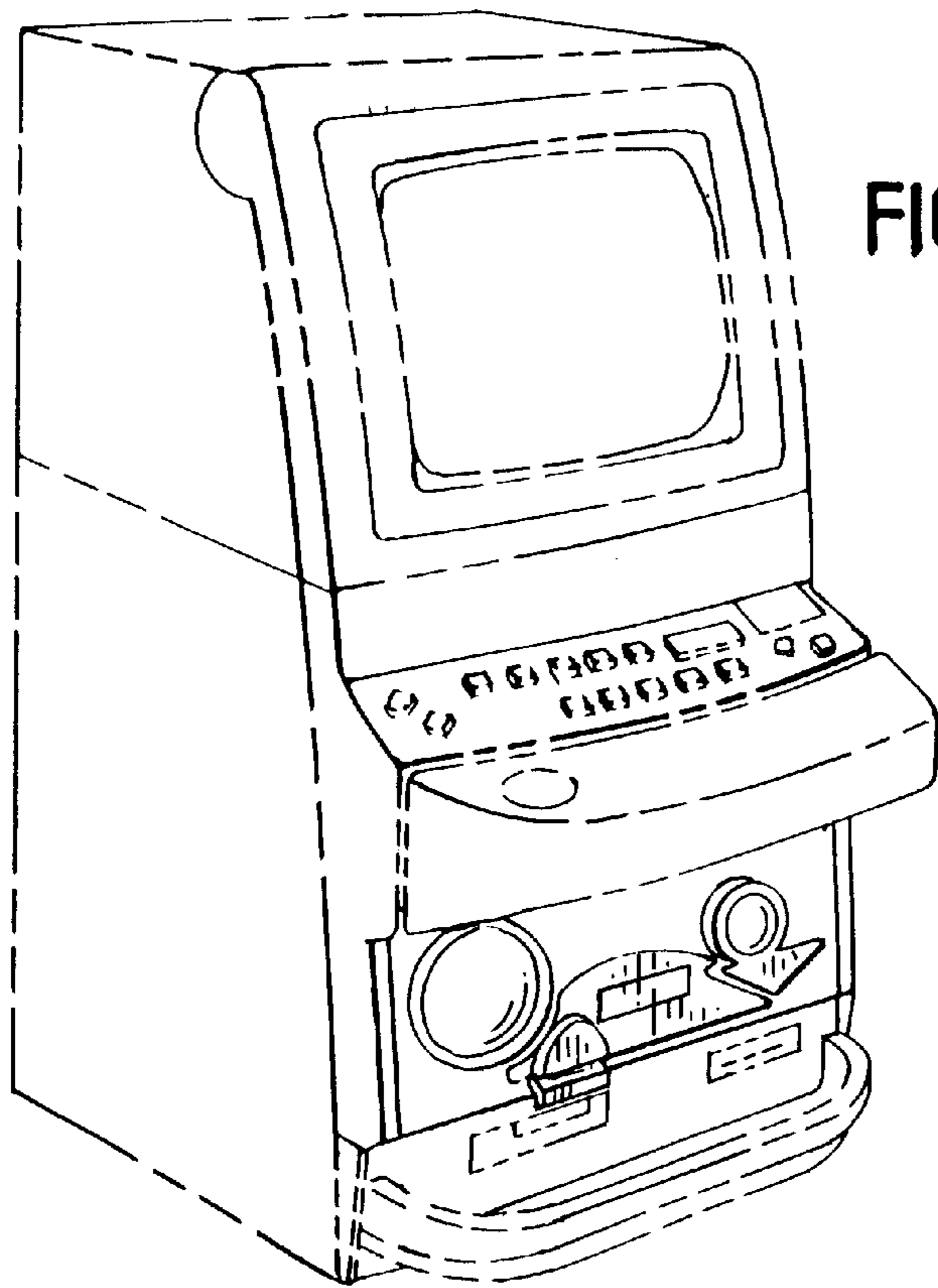

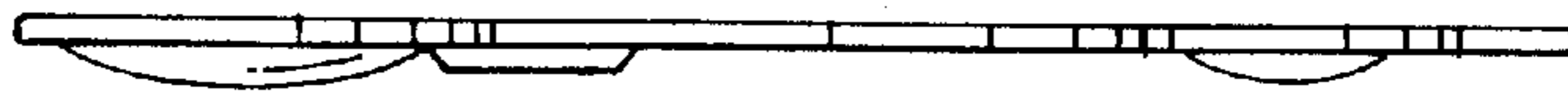

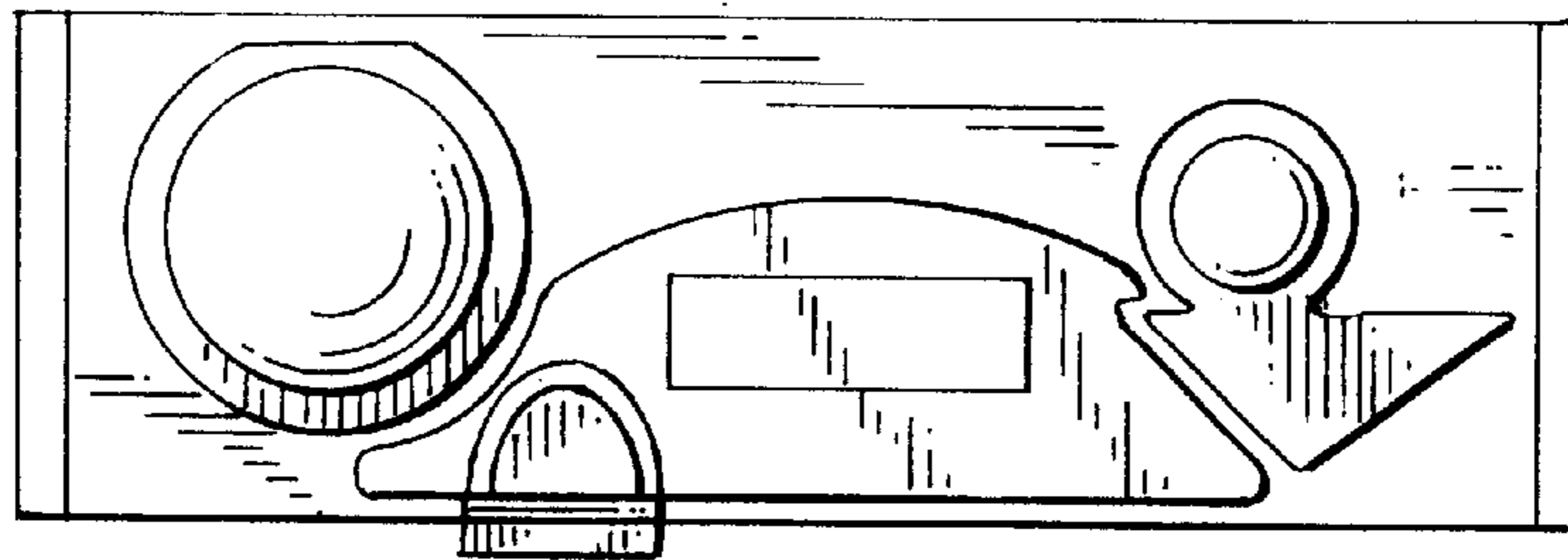

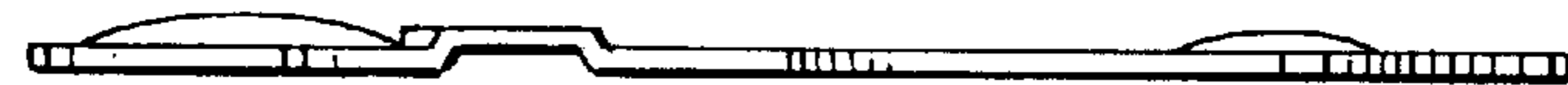
