(57) **CLAIM**

I claim the ornamental design for a weighted swirling streamer snake toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view in an illustrative environment of the weighted swirling streamer snake toy of the present invention, the environment being shown in broken lines for illustrative purposes and thus not forming a part of the claimed design.

FIG. 2 is a top plan view of the weighted swirling streamer snake toy of FIG. 1.

FIG. 3 is a bottom plan view of the weighted swirling streamer snake toy of FIG. 1.

FIG. 4 is a front elevational view of the weighted swirling streamer snake toy of FIG. 1.

FIG. 5 is a rear elevational view of the weighted swirling streamer snake toy of FIG. 1.

FIG. 6 is a right side elevational view of the weighted swirling streamer snake toy of FIG. 1, the left side view being identical to the right side view.

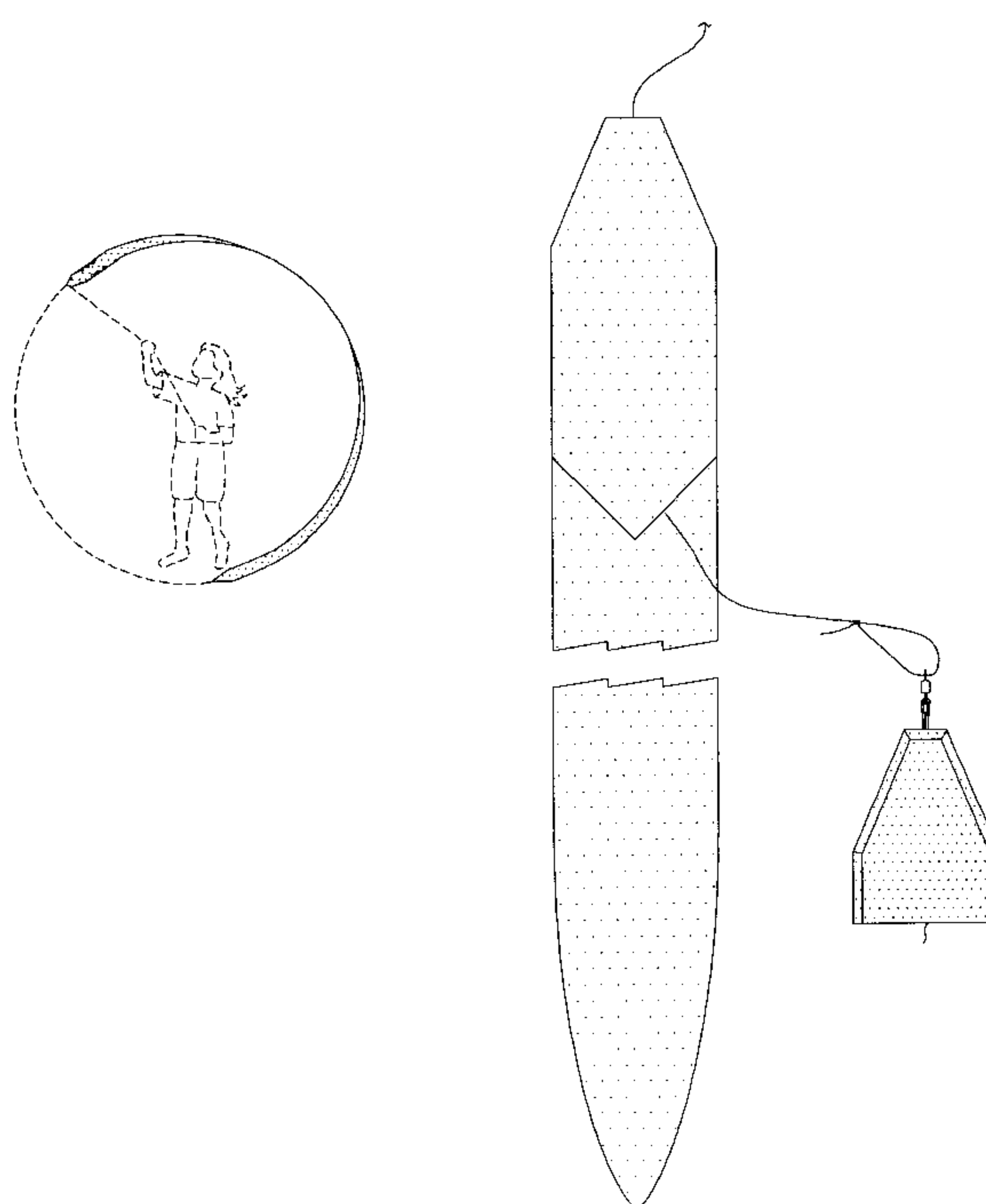
FIG. 7 is a bottom plan view of the weighted swirling streamer snake toy showing a top plan view of the weight removed from the front portion.

FIG. 8 is a front elevational view of the weight of the weighted swirling streamer snake toy of FIG. 7.

FIG. 9 is a rear elevational view of the weight of the weighted swirling streamer snake toy of FIG. 7; and,

FIG. 10 is a left side elevational view of the weight of the weighted swirling streamer snake toy of FIG. 7, the right side view being identical to the left side view.

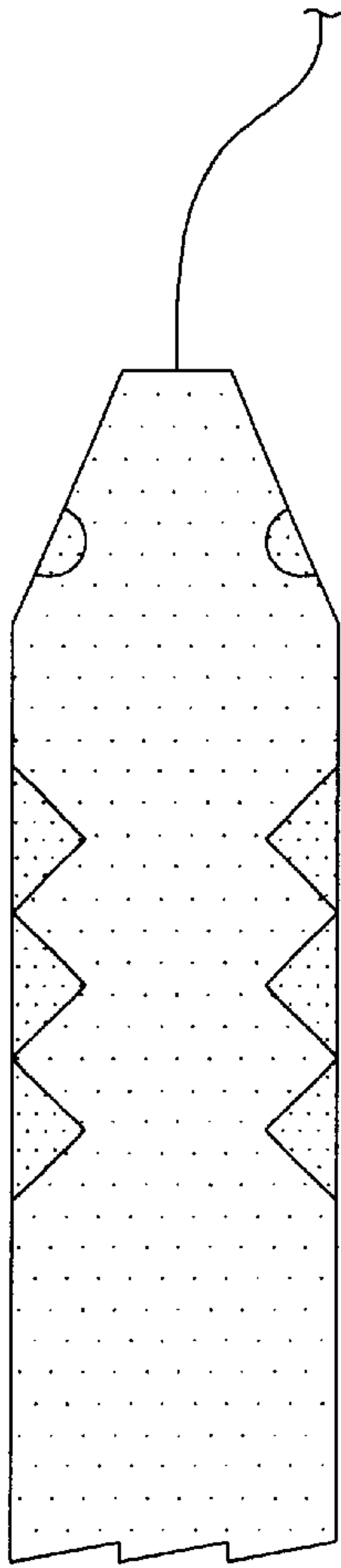

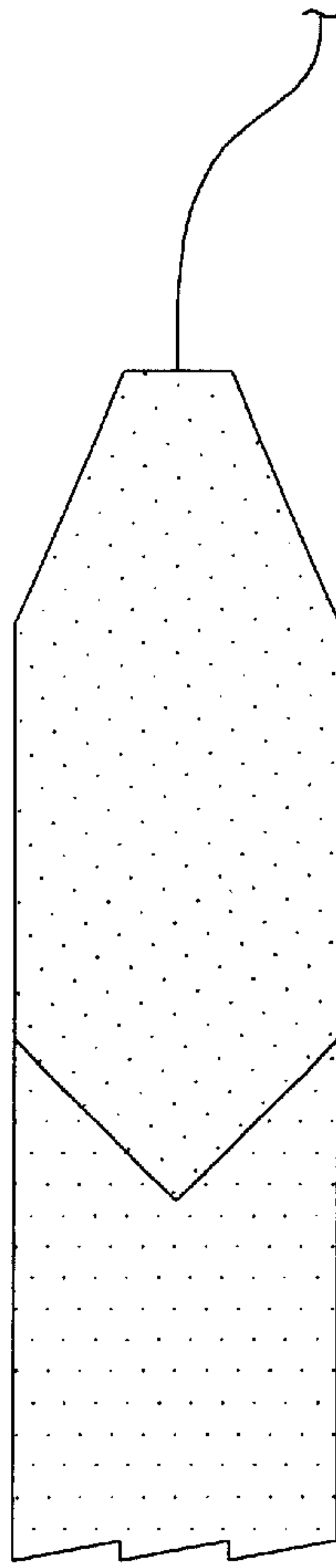

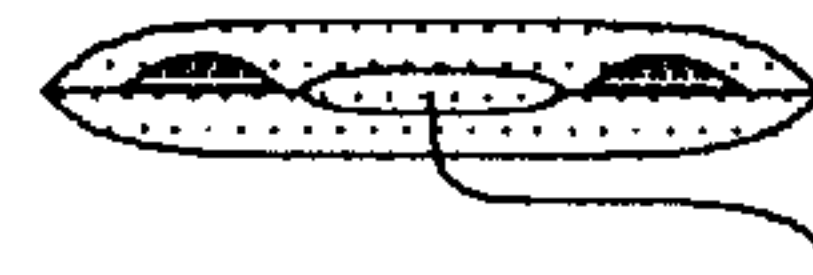
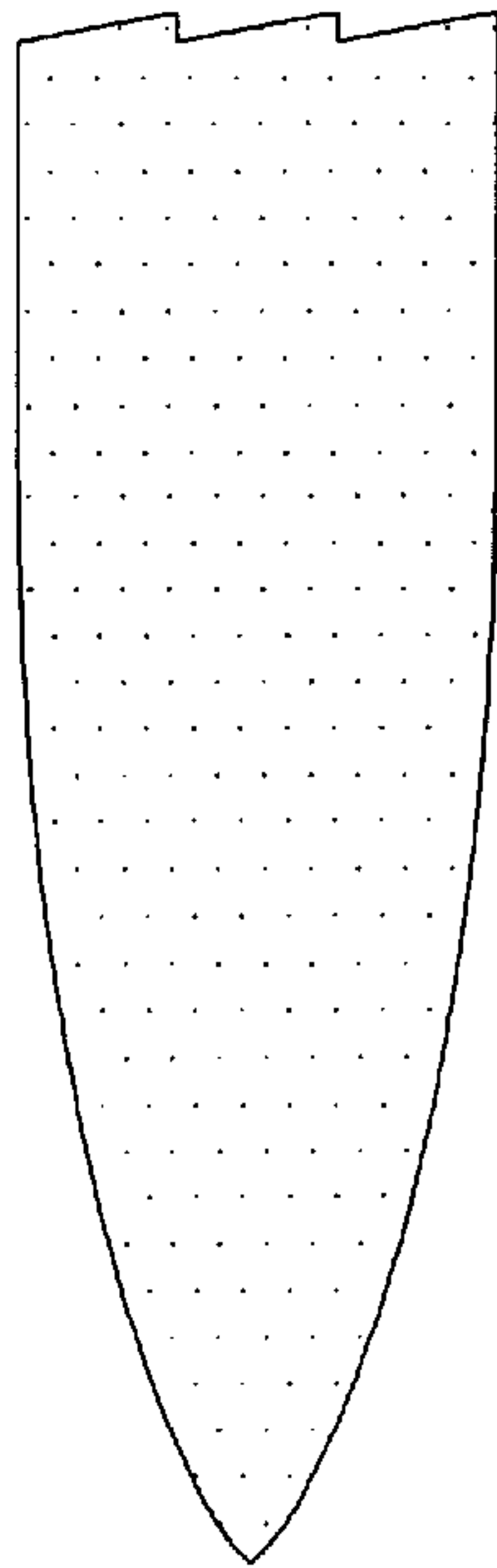
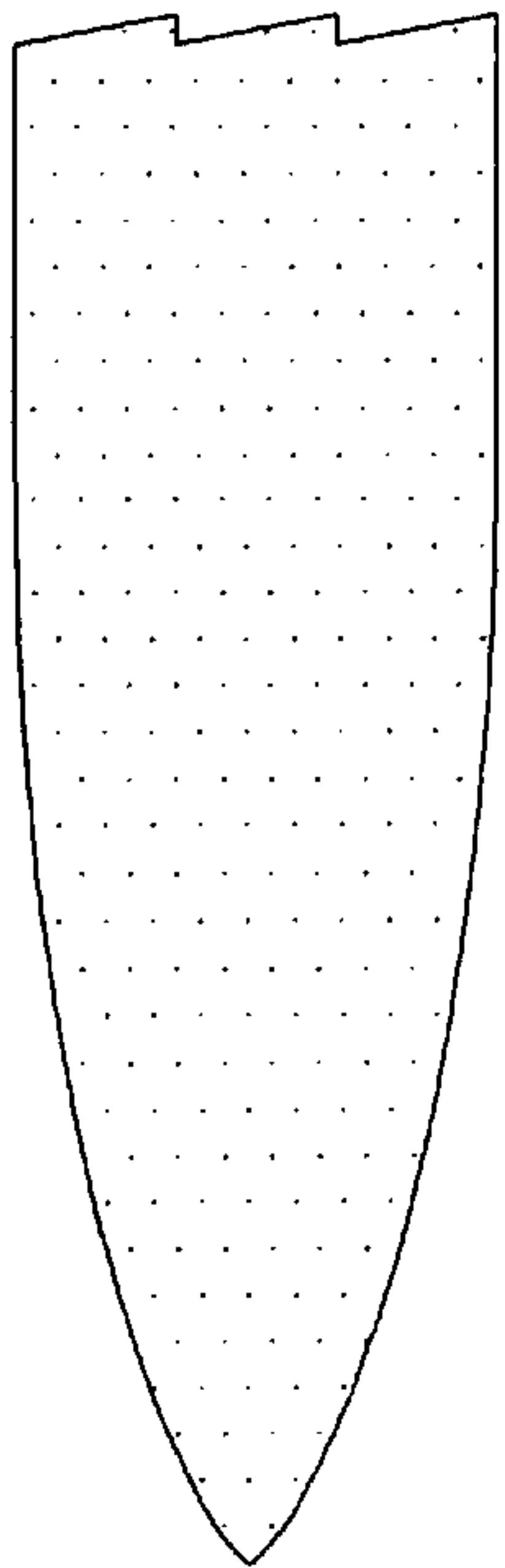

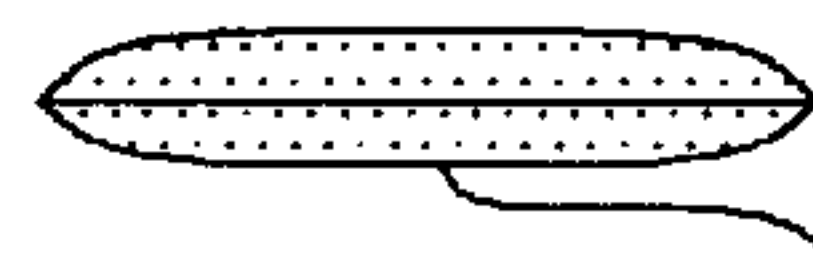

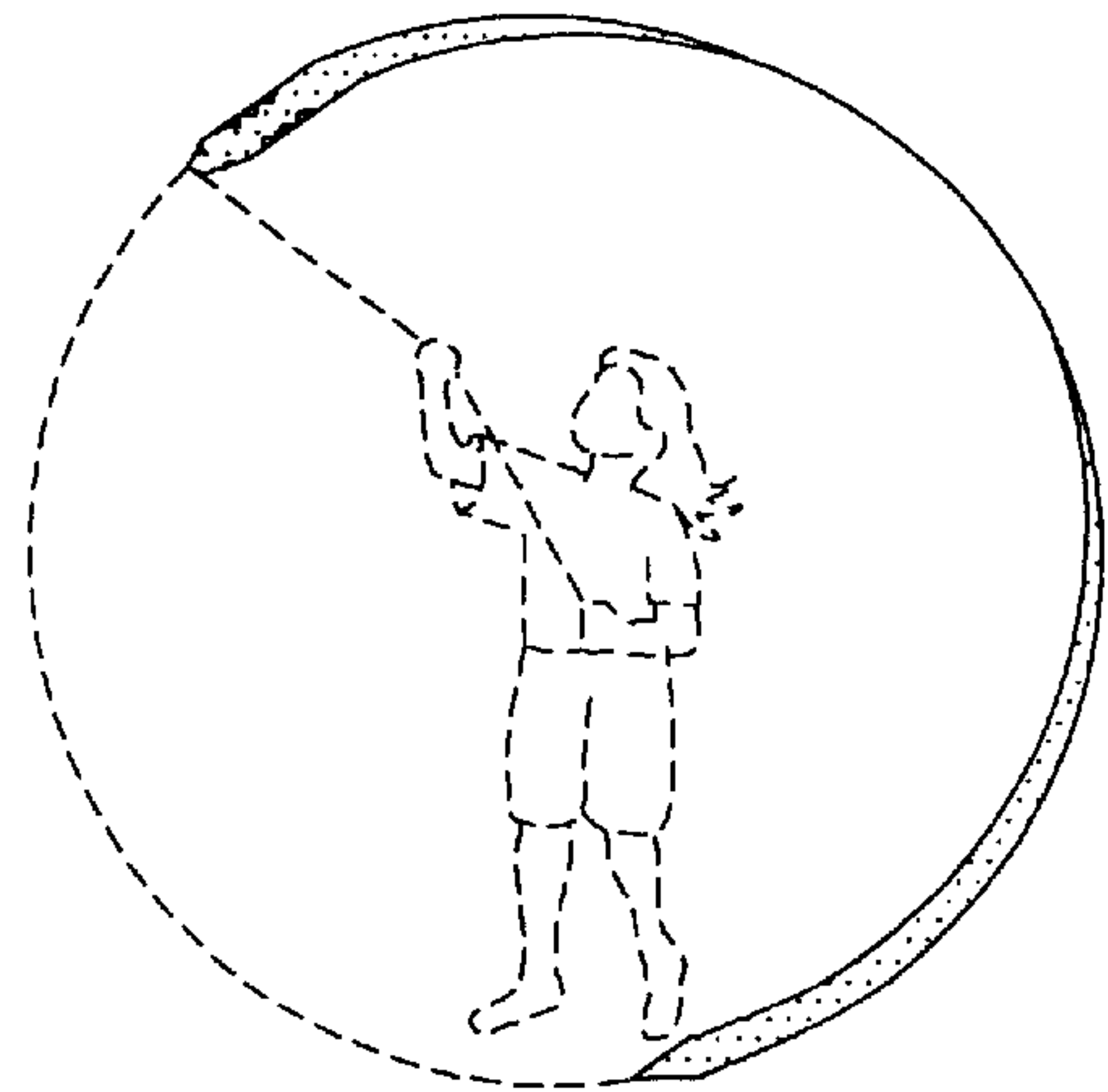

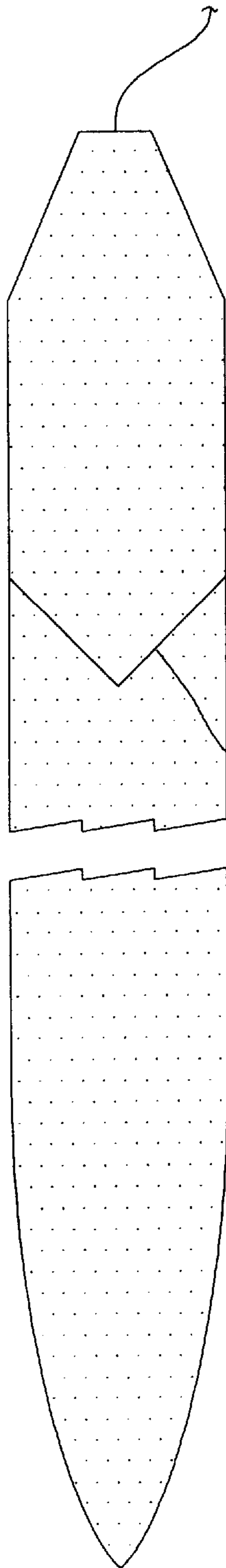
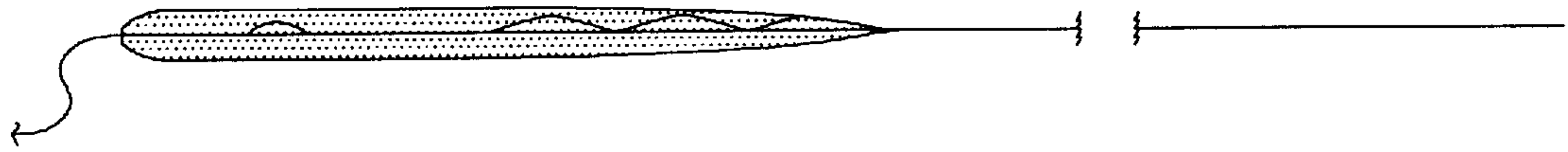

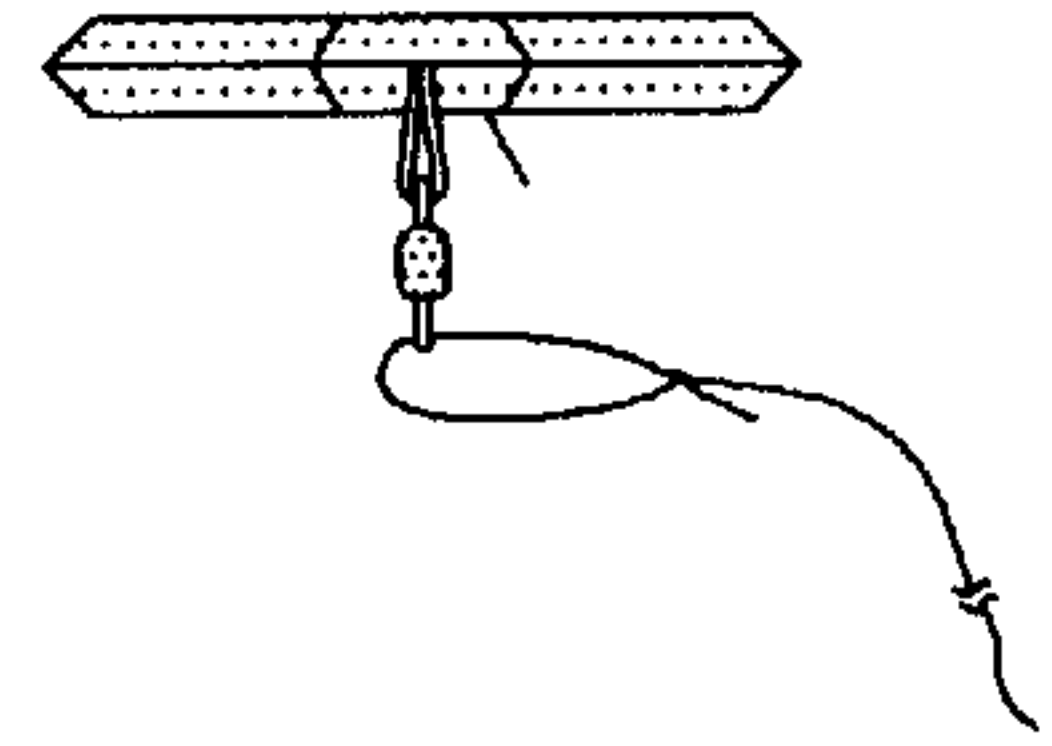

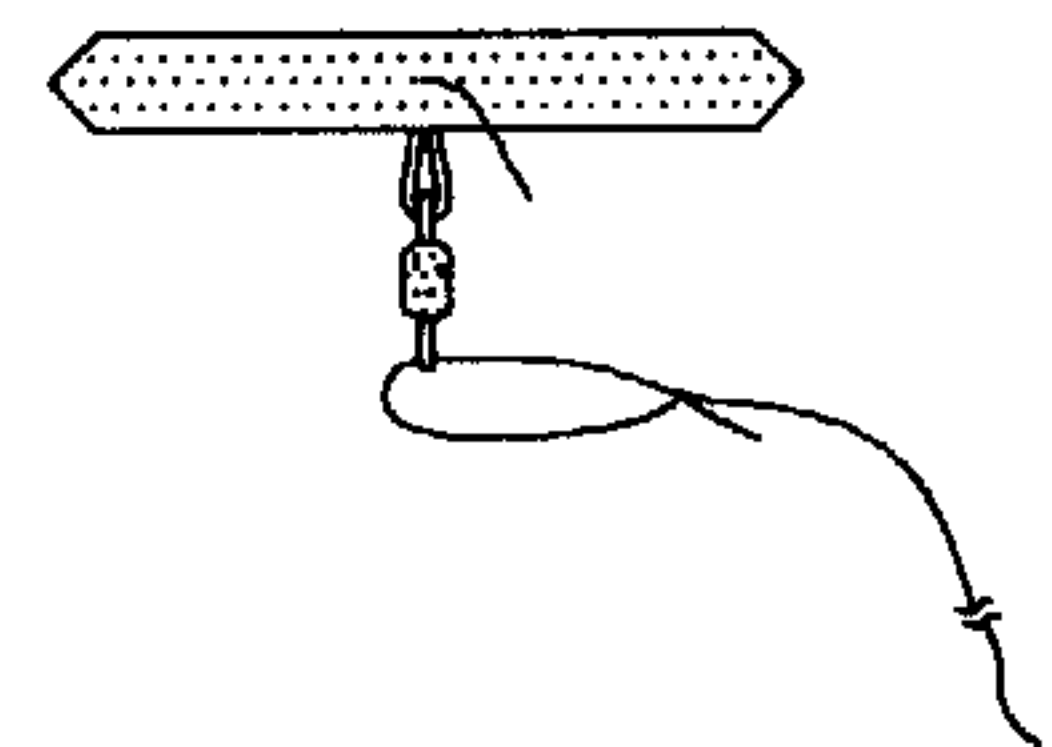

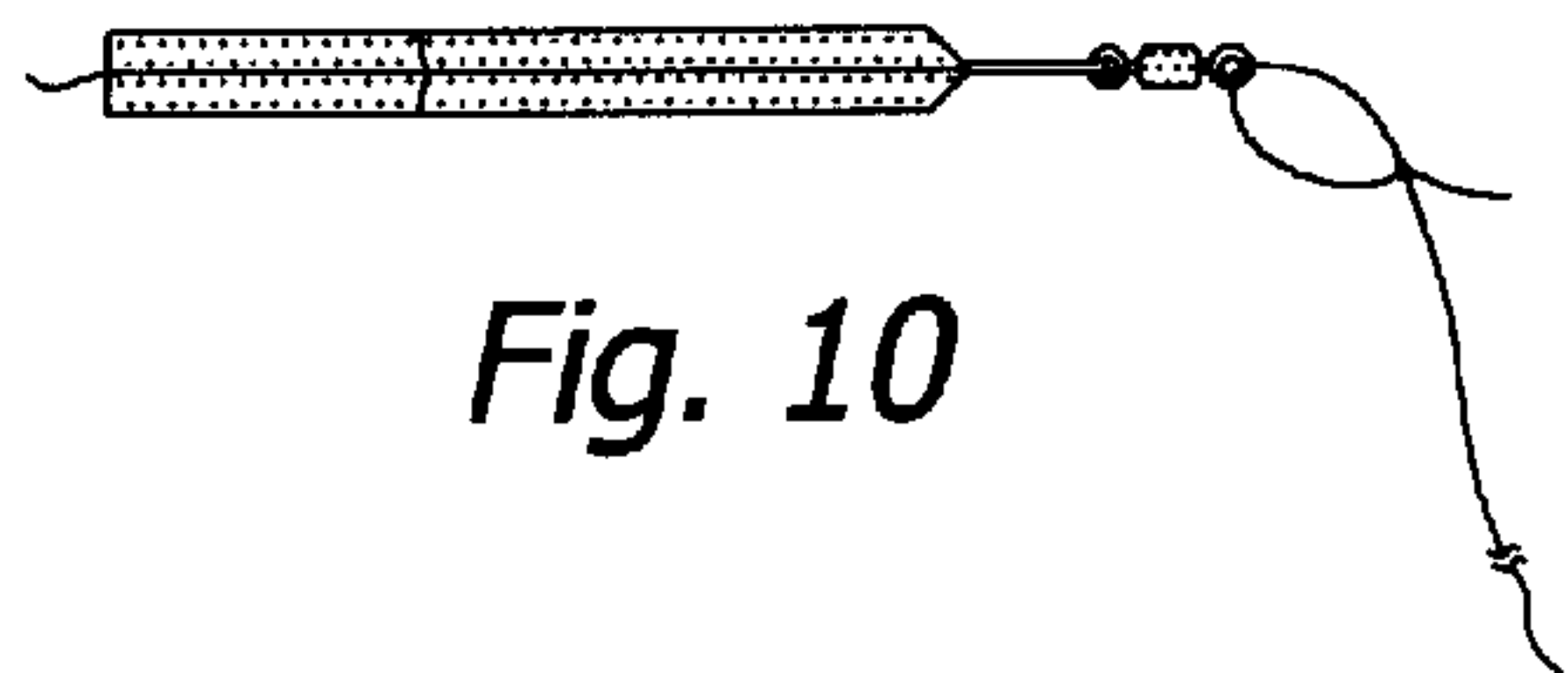
