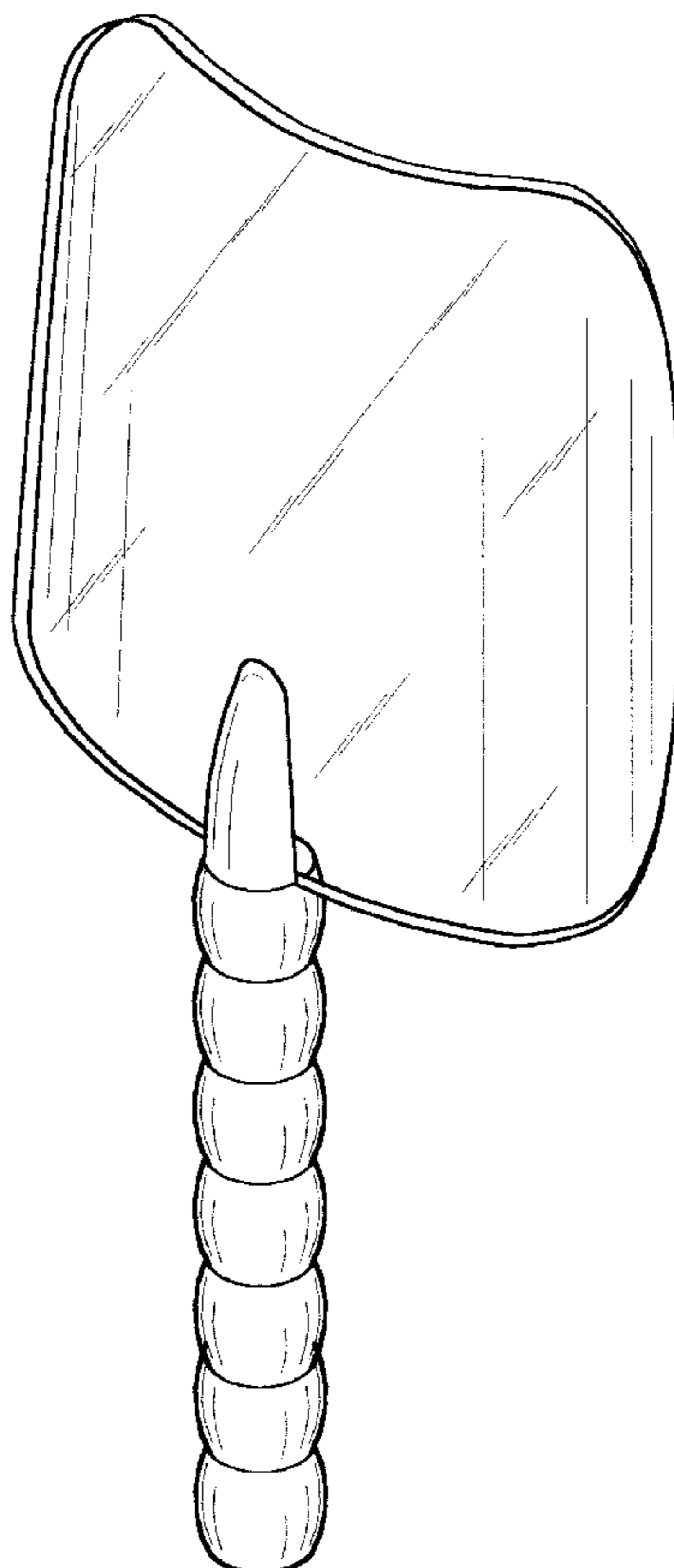
(57) **CLAIM**

The ornamental design for a hairspray face shield, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side, perspective view of the hairspray face shield of the present invention;  
 FIG. 2 is a front elevational view of the hairspray face shield of FIG. 1;  
 FIG. 3 is a rear elevational view of the hairspray face shield of FIG. 1;  
 FIG. 4 is a right side elevational view of the hairspray face shield of FIG. 1, the left view being a mirror image thereof;  
 FIG. 5 is a top plan view of the hairspray face shield of FIG. 1; and,  
 FIG. 6 is a bottom plan view of the hairspray face shield of FIG. 1.

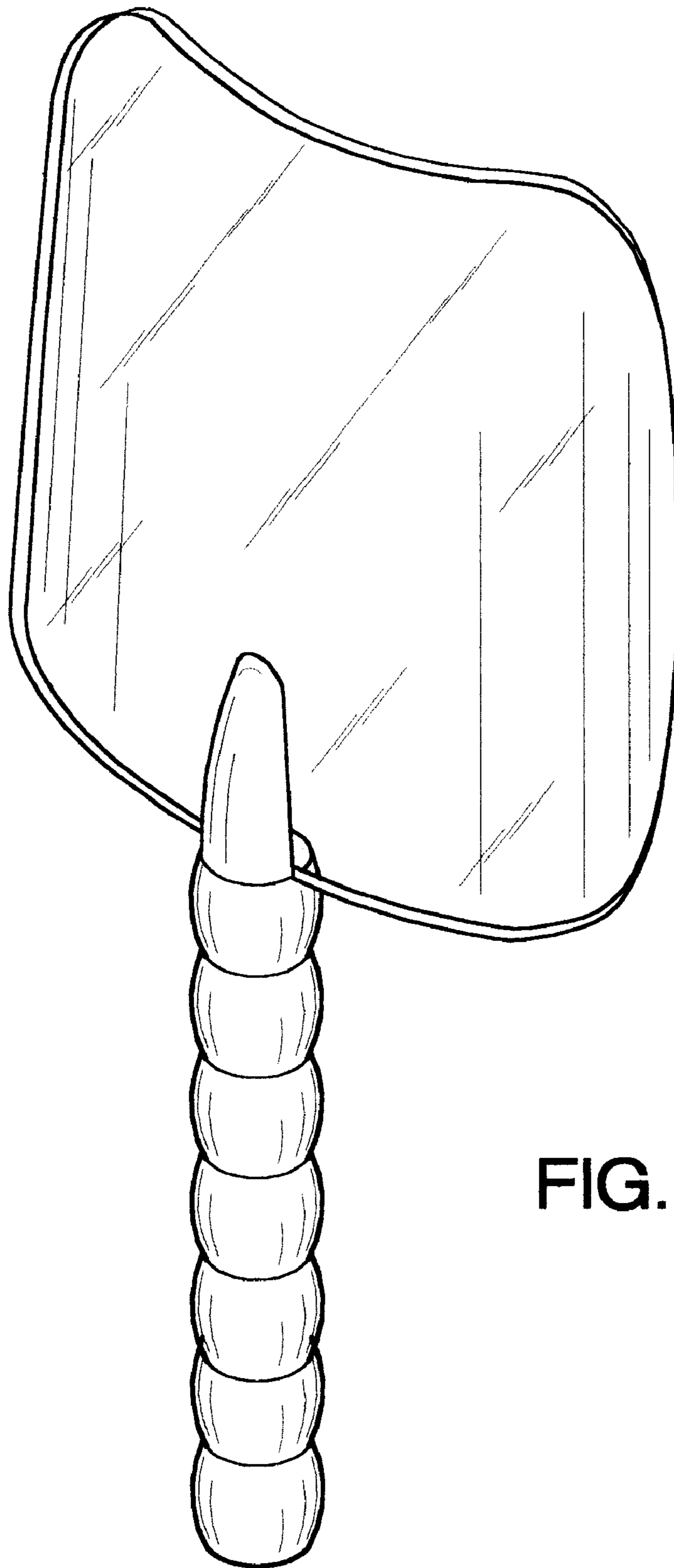

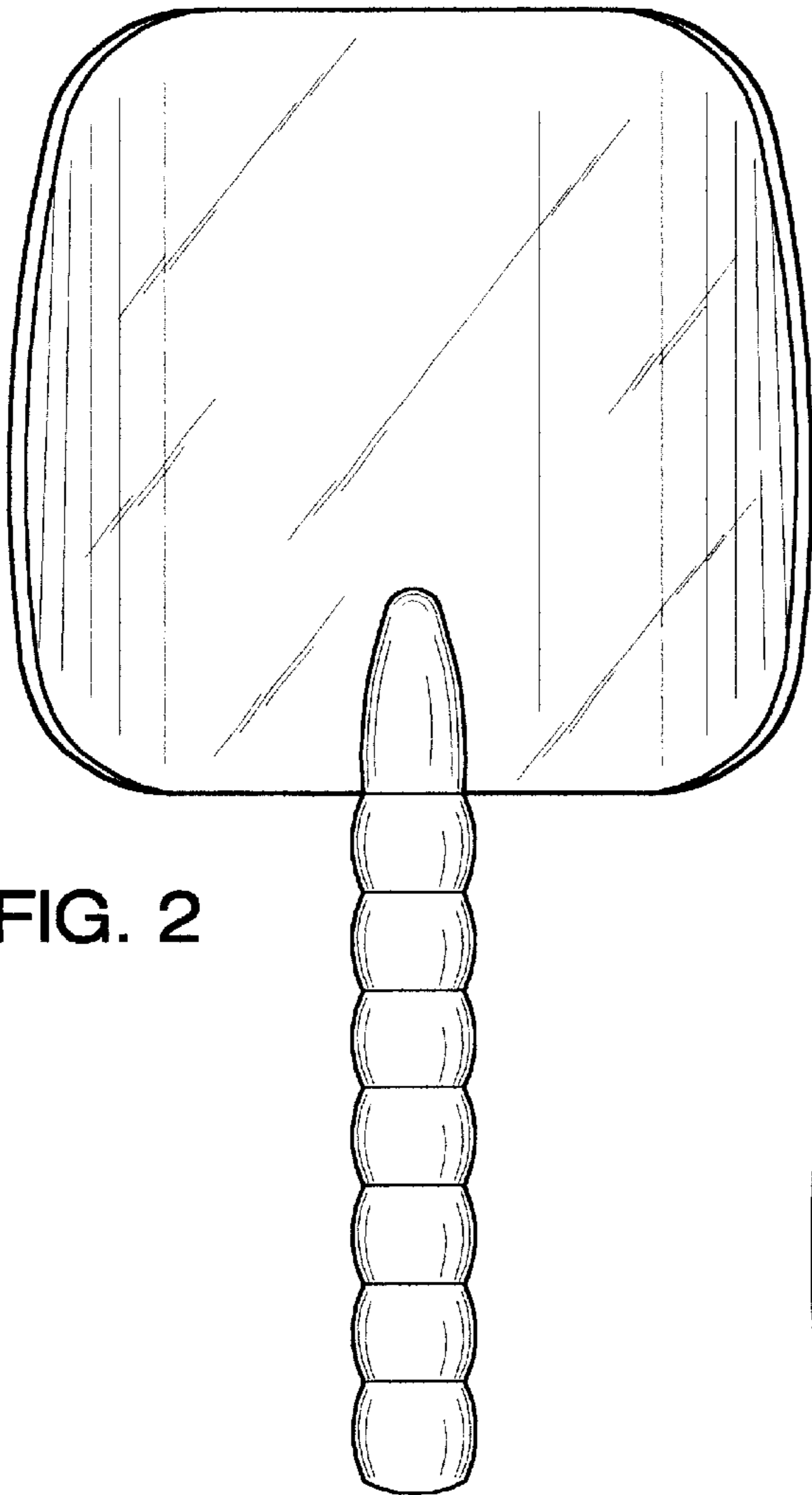

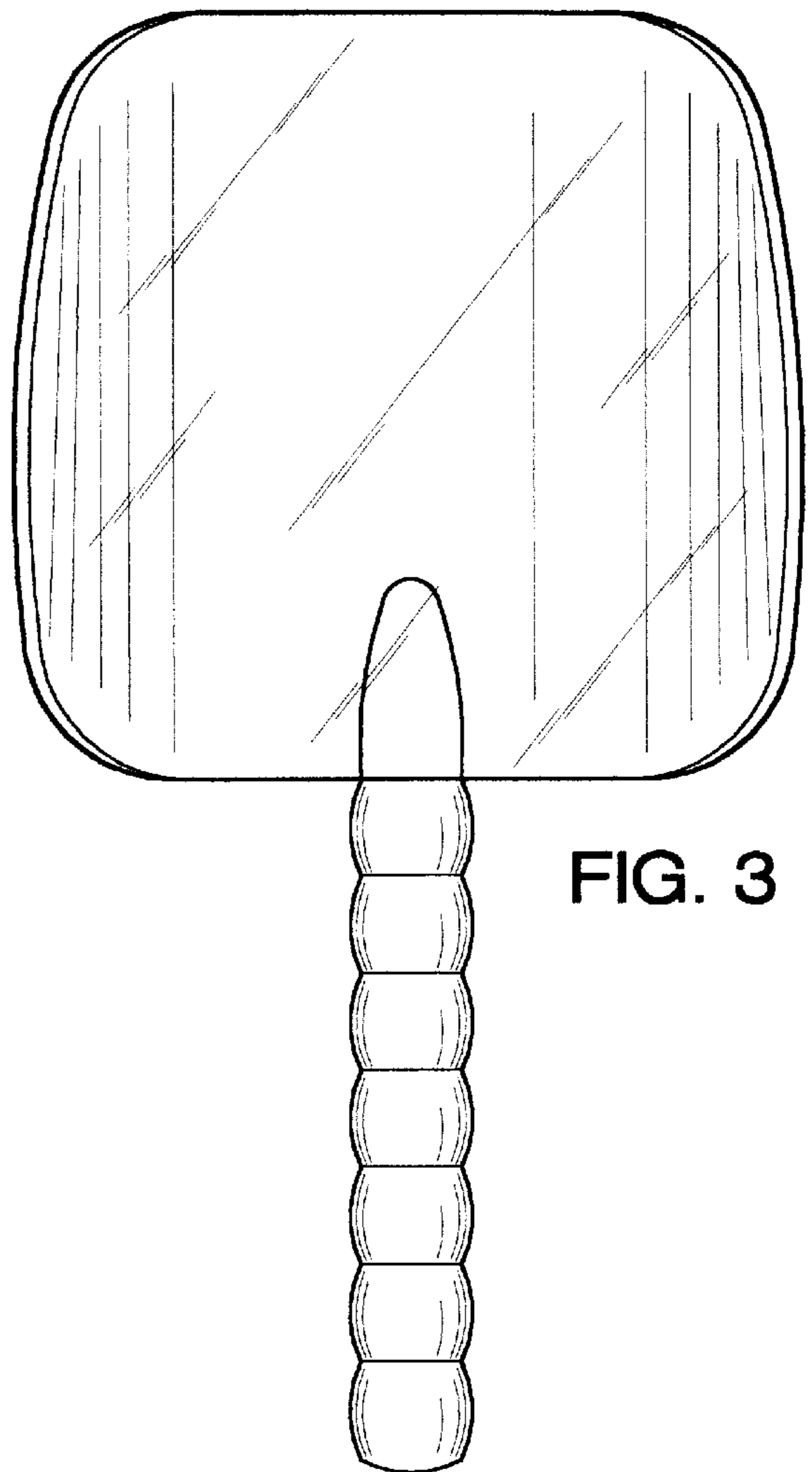

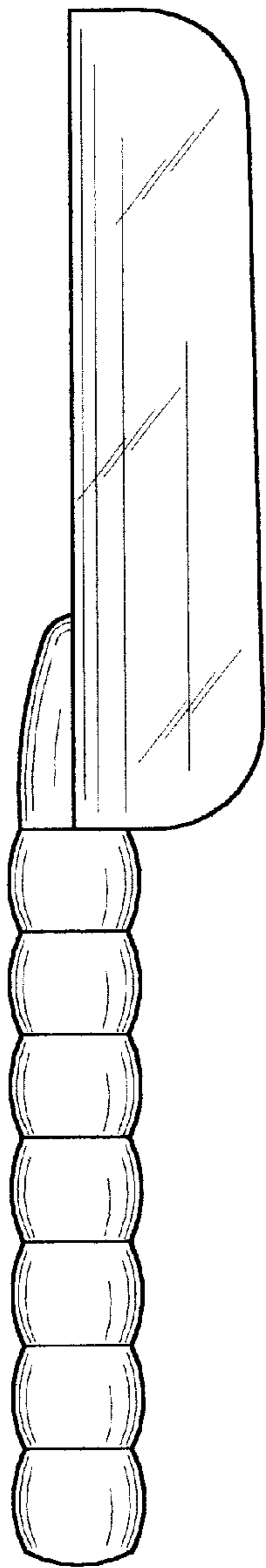

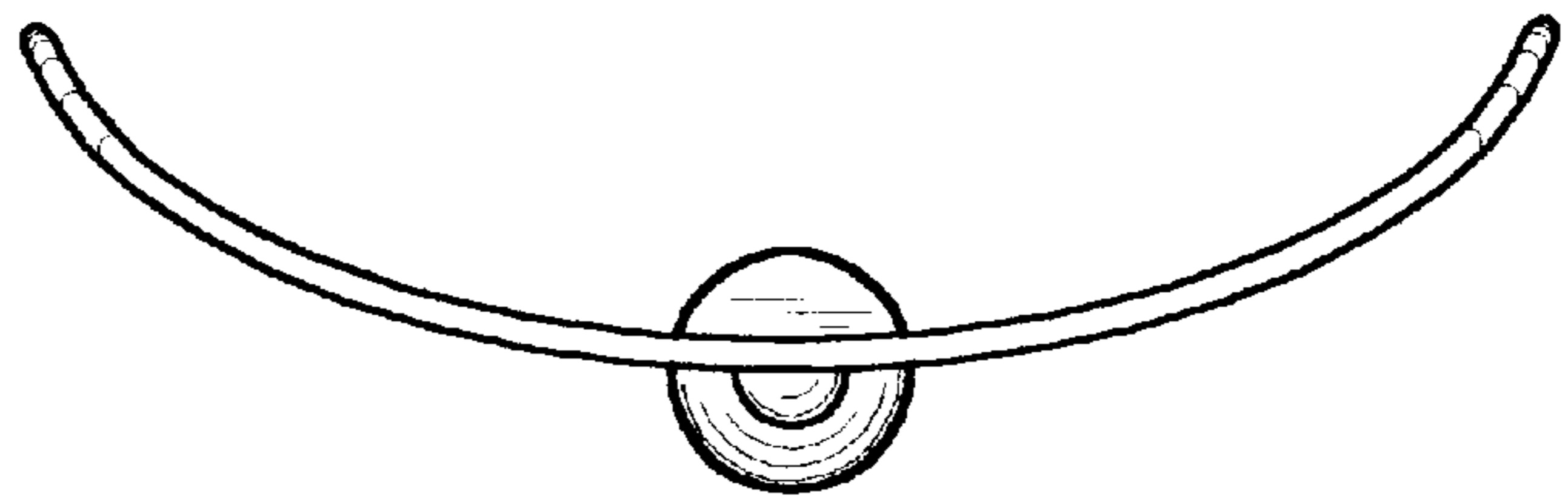

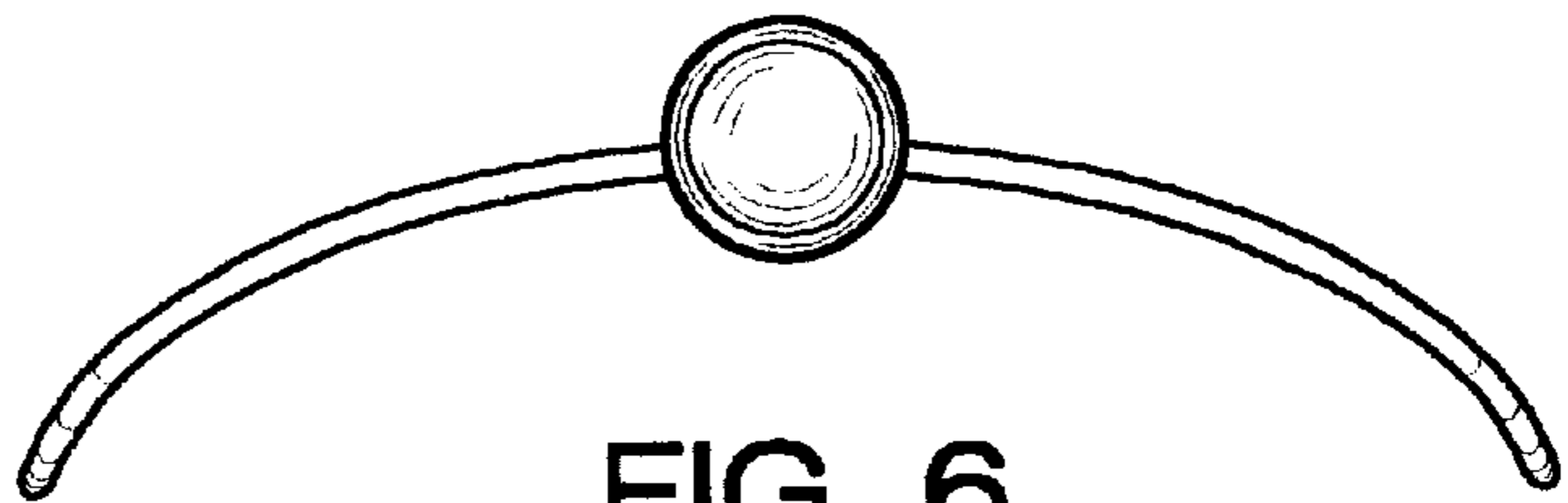
