FIG. 5 is a bottom view of the full length undergarment;

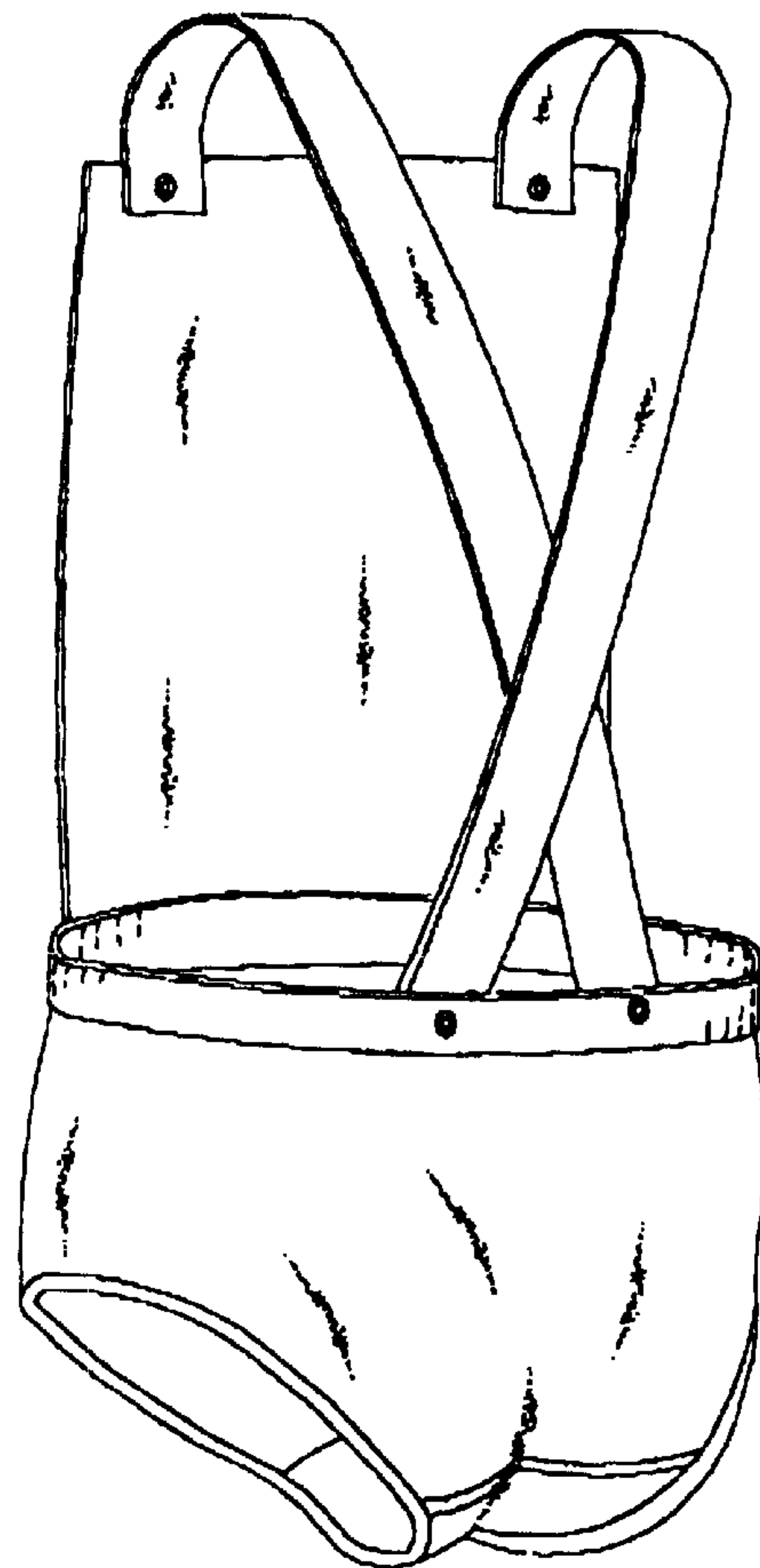
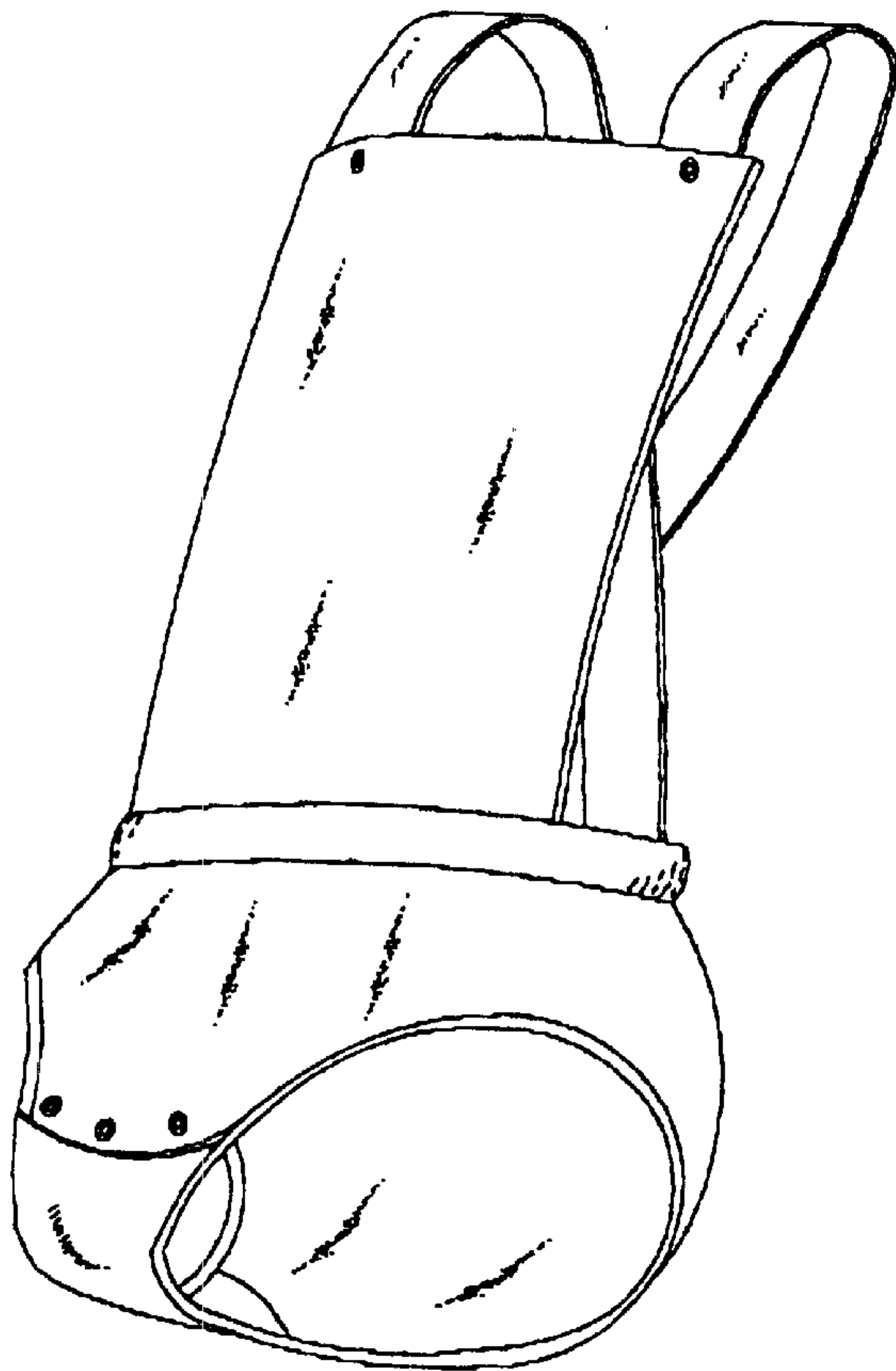
FIG. 6 is a left side view of the full length undergarment;

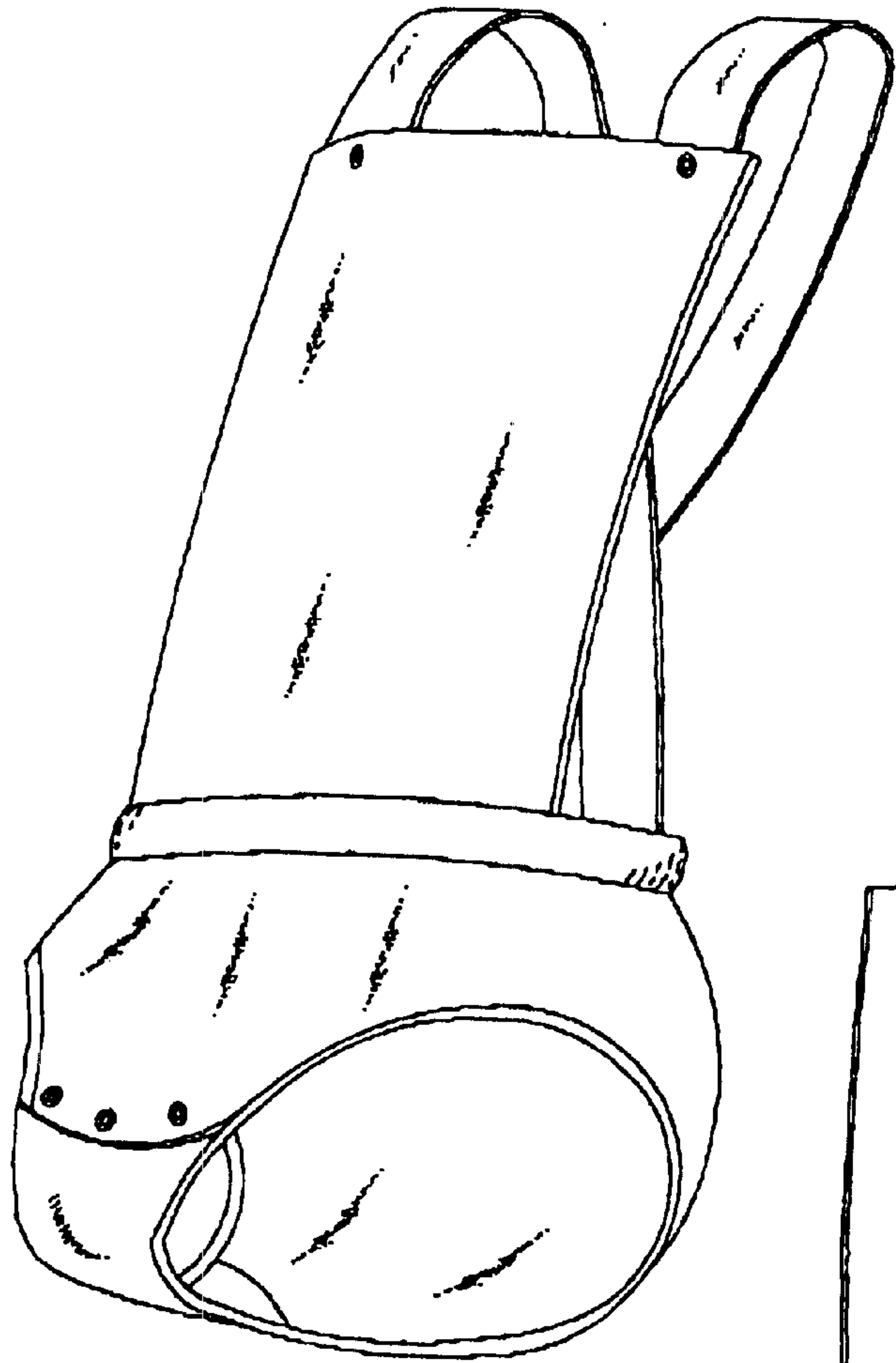

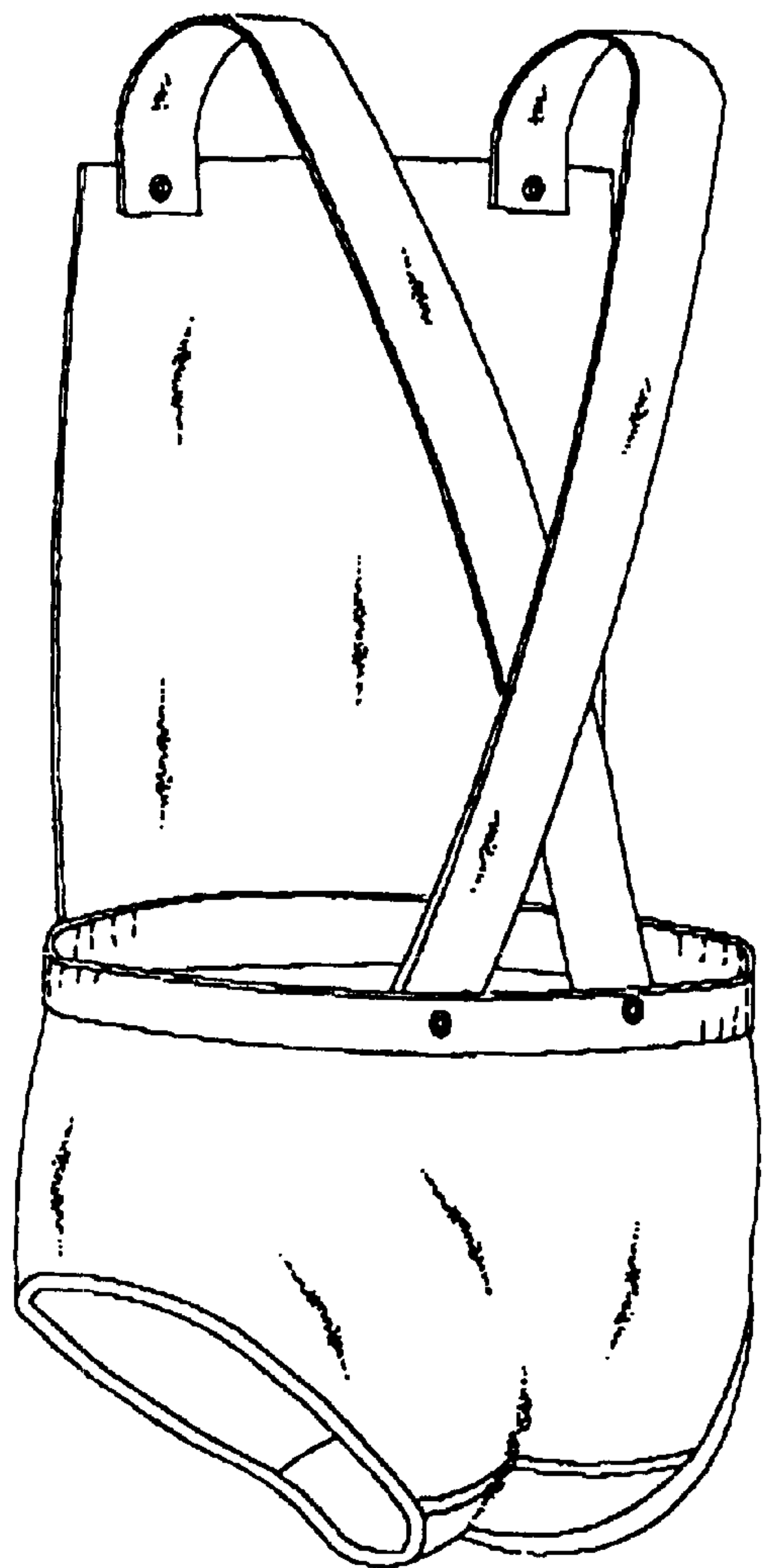

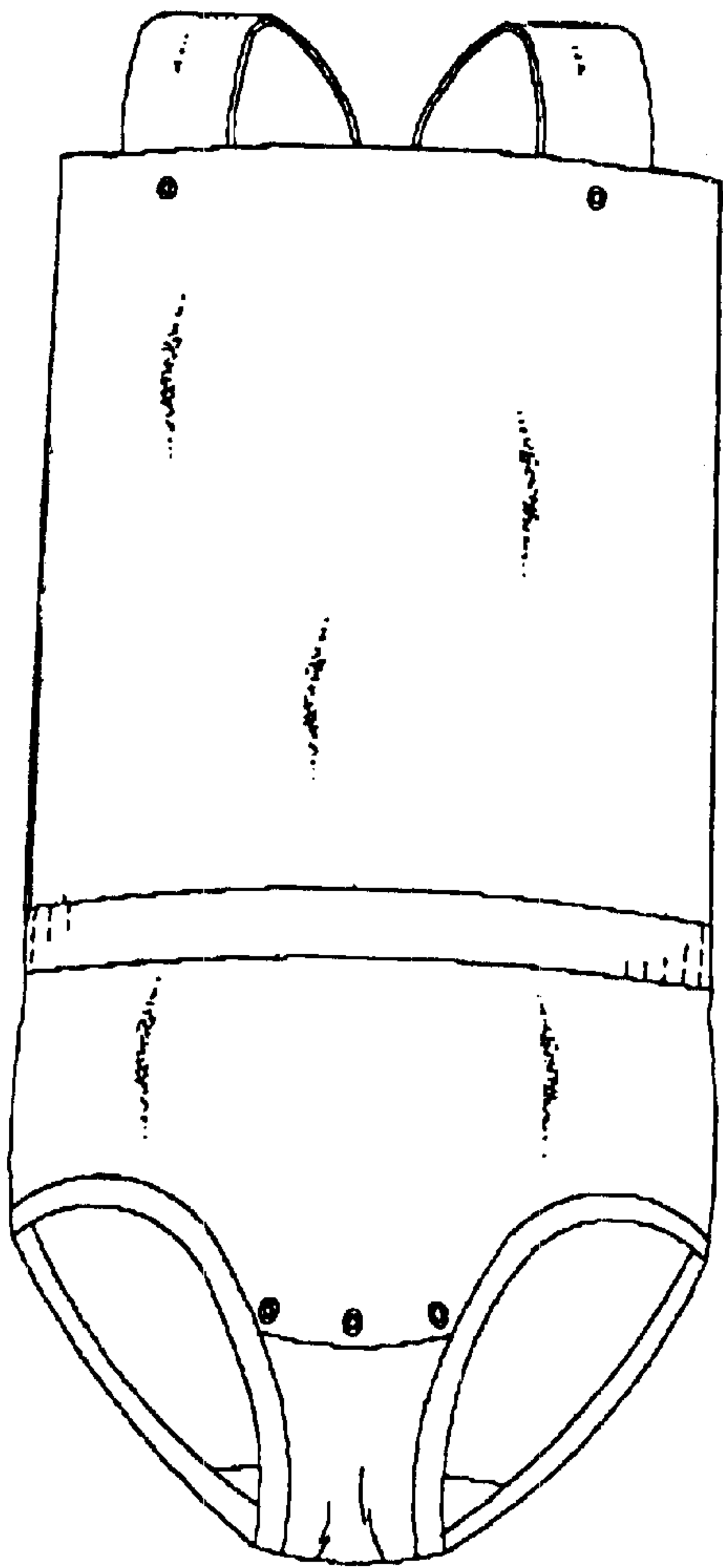

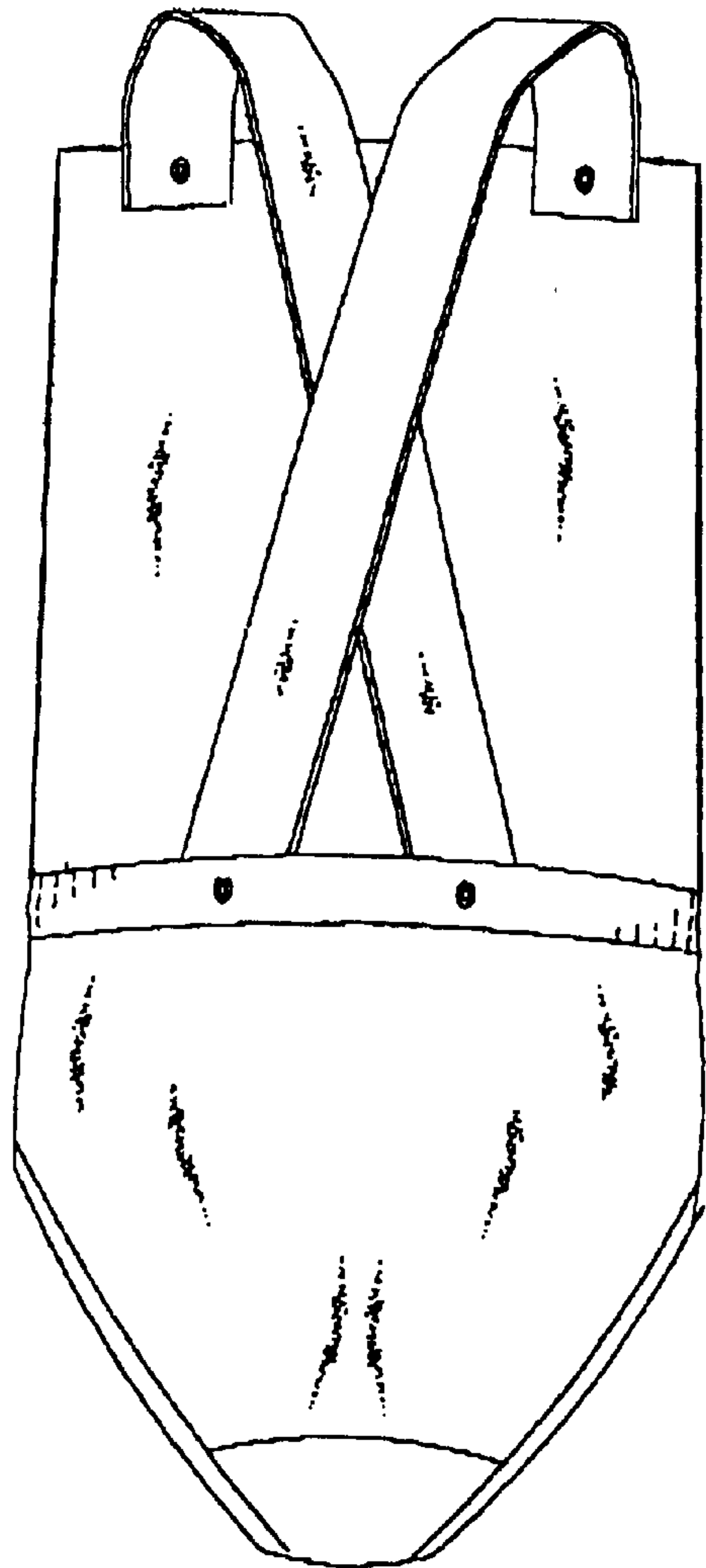

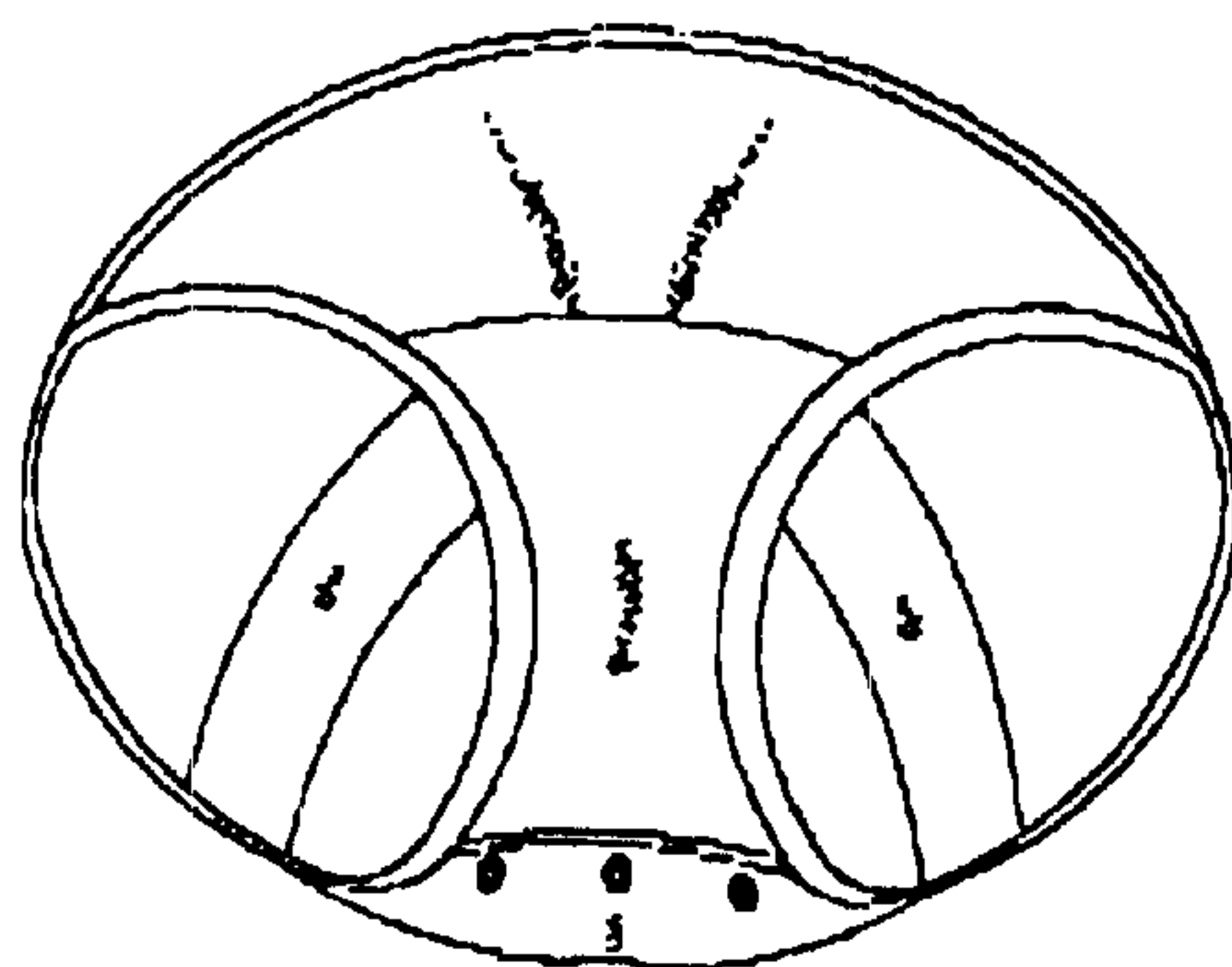

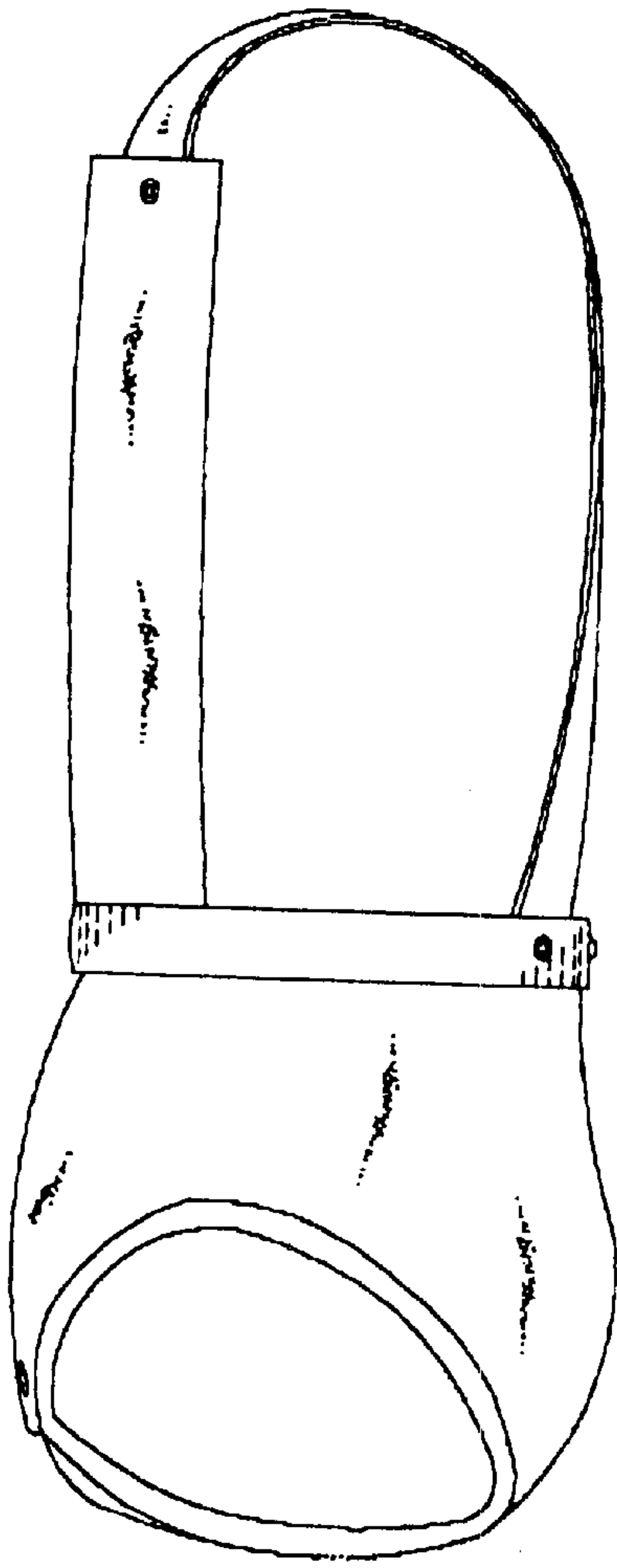

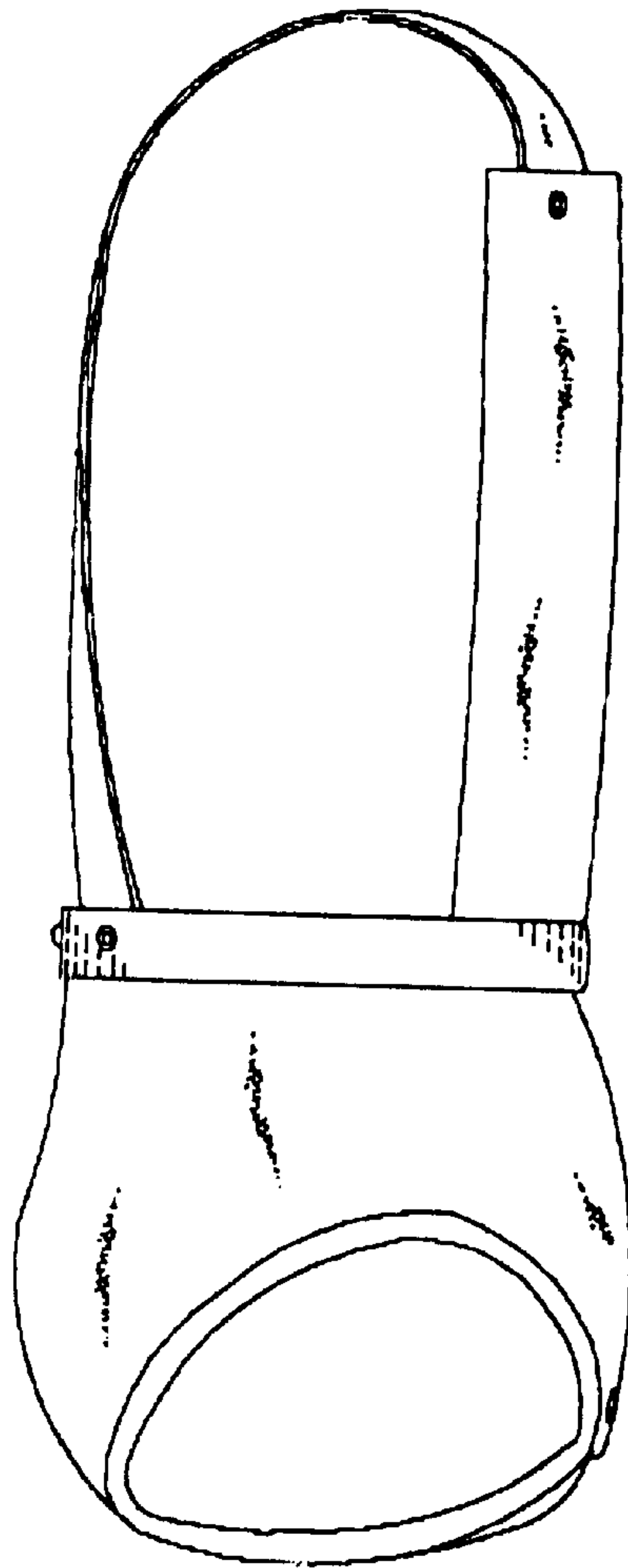

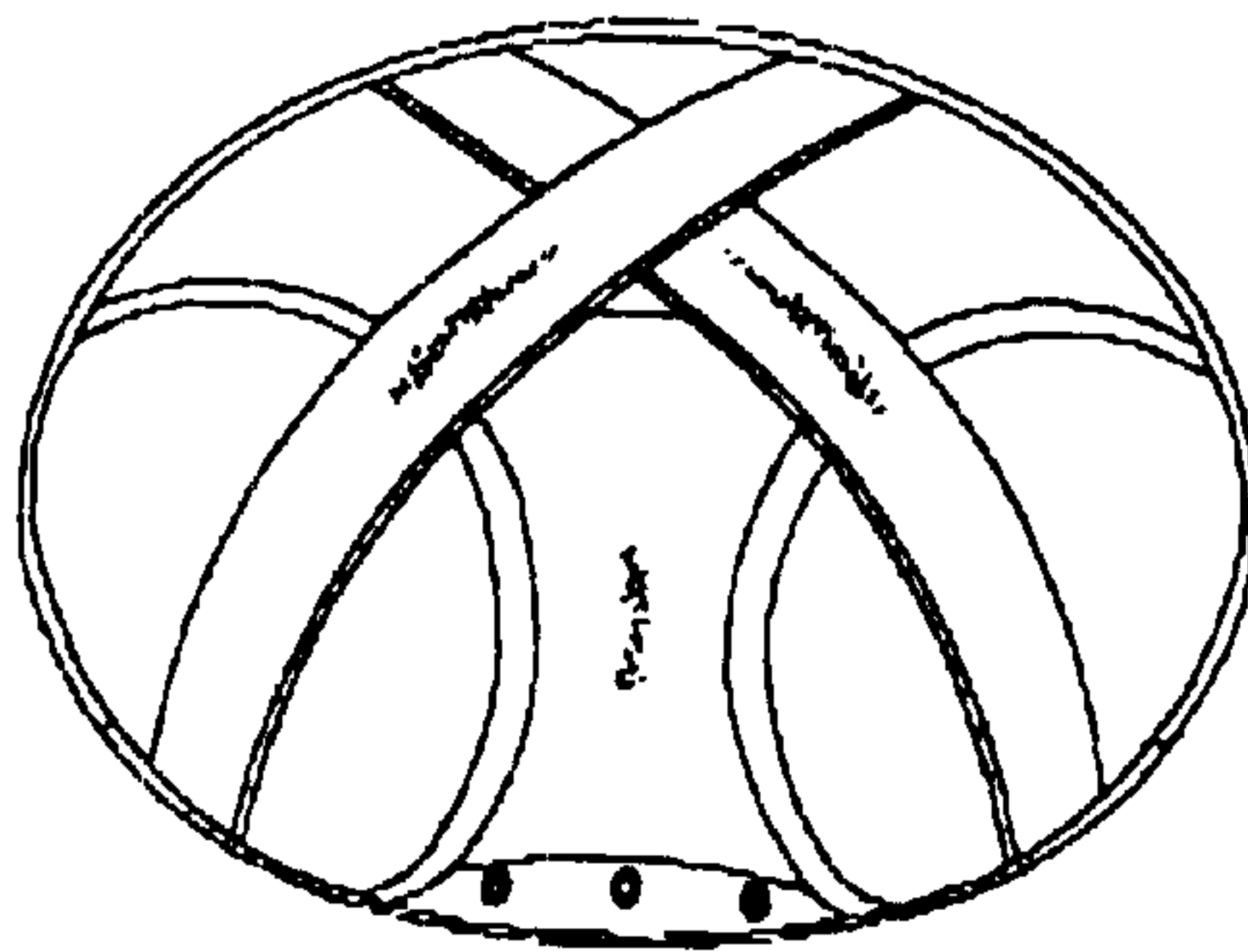
