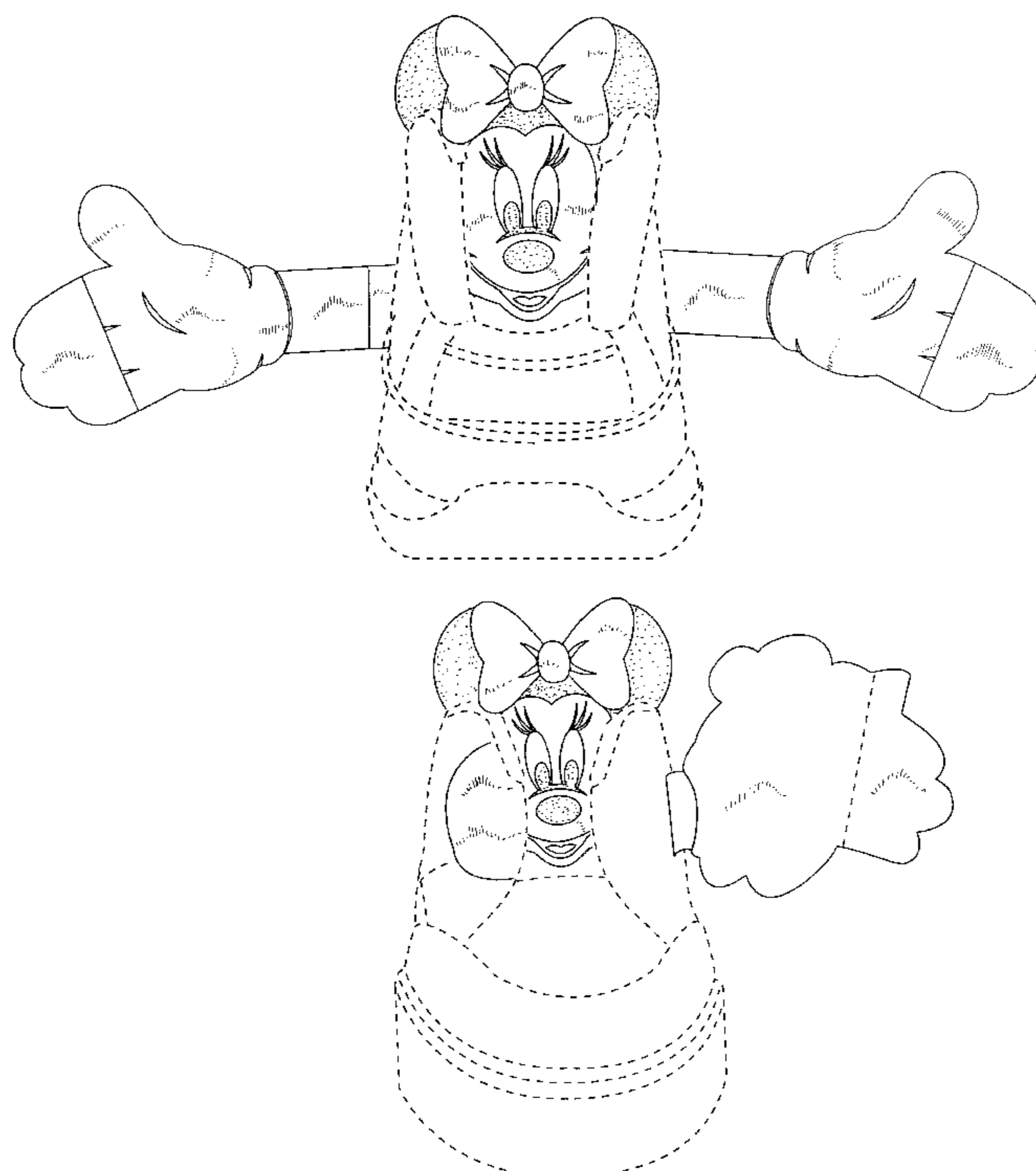
(57) **CLAIM**

I claim the novel design for a shoe, as shown.

DESCRIPTION

FIG. 1 is a right side elevation view of my new design for a shoe;
FIG. 2 is a left side elevation view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a front elevation view thereof with the double flaps extended;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a top plan view thereof, the bottom being unadorned;
FIG. 7 is a top plan view thereof with the double flaps extended;
FIG. 8 is a right side elevation view of another embodiment and my new design for a shoe which is a single flap;
FIG. 9 is a left side elevation view of the embodiment of FIG. 8;
FIG. 10 is a front elevation view of the embodiment of FIG. 8;
FIG. 11 is a front elevation view of the embodiment of FIG. 8 with the single flap extended;
FIG. 12 is a rear elevation view of the embodiment of FIG. 8;
FIG. 13 is a top plan view of the embodiment of FIG. 8; and,
FIG. 14 is a top plan view of the embodiment of FIG. 8 with the single flap extended.

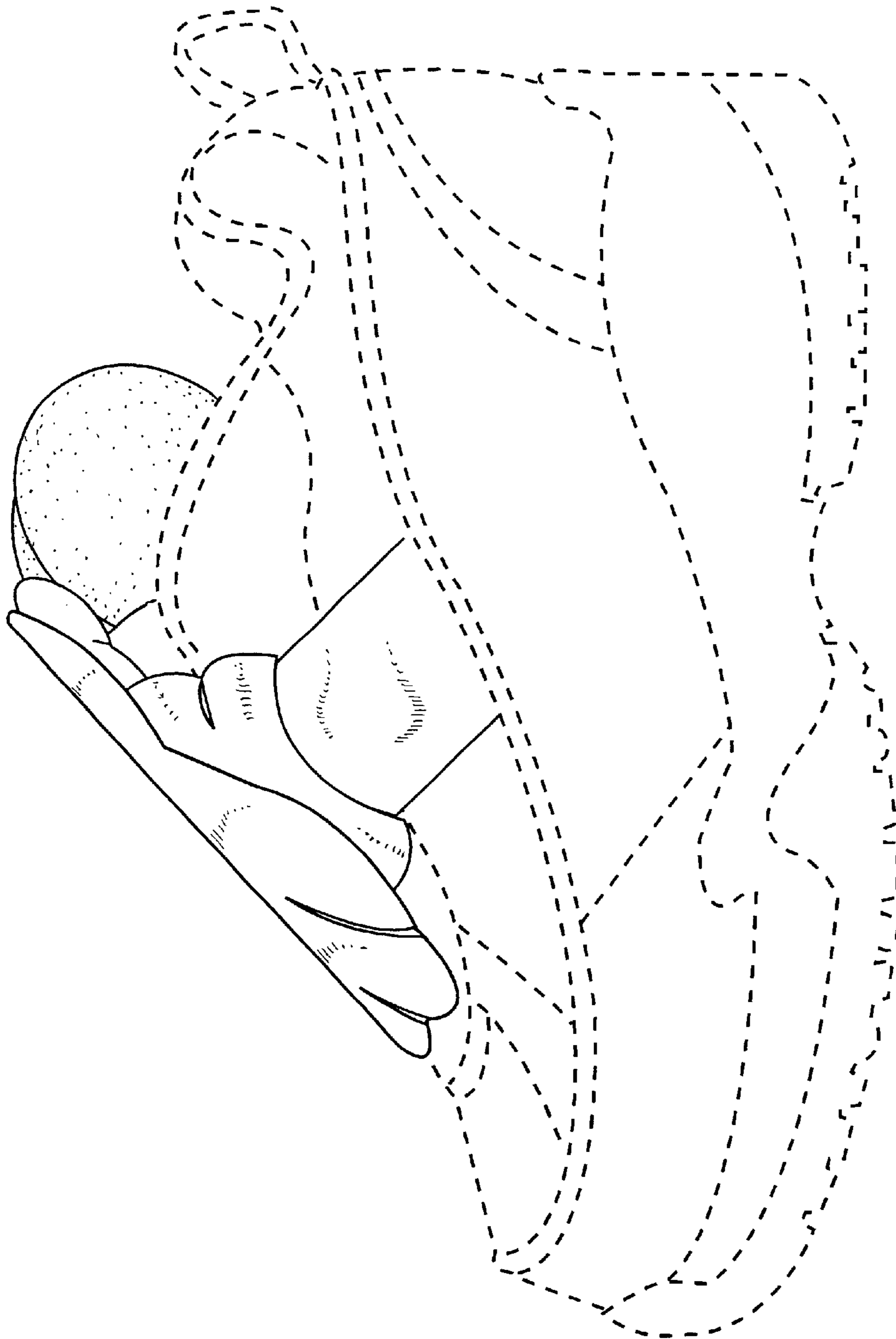

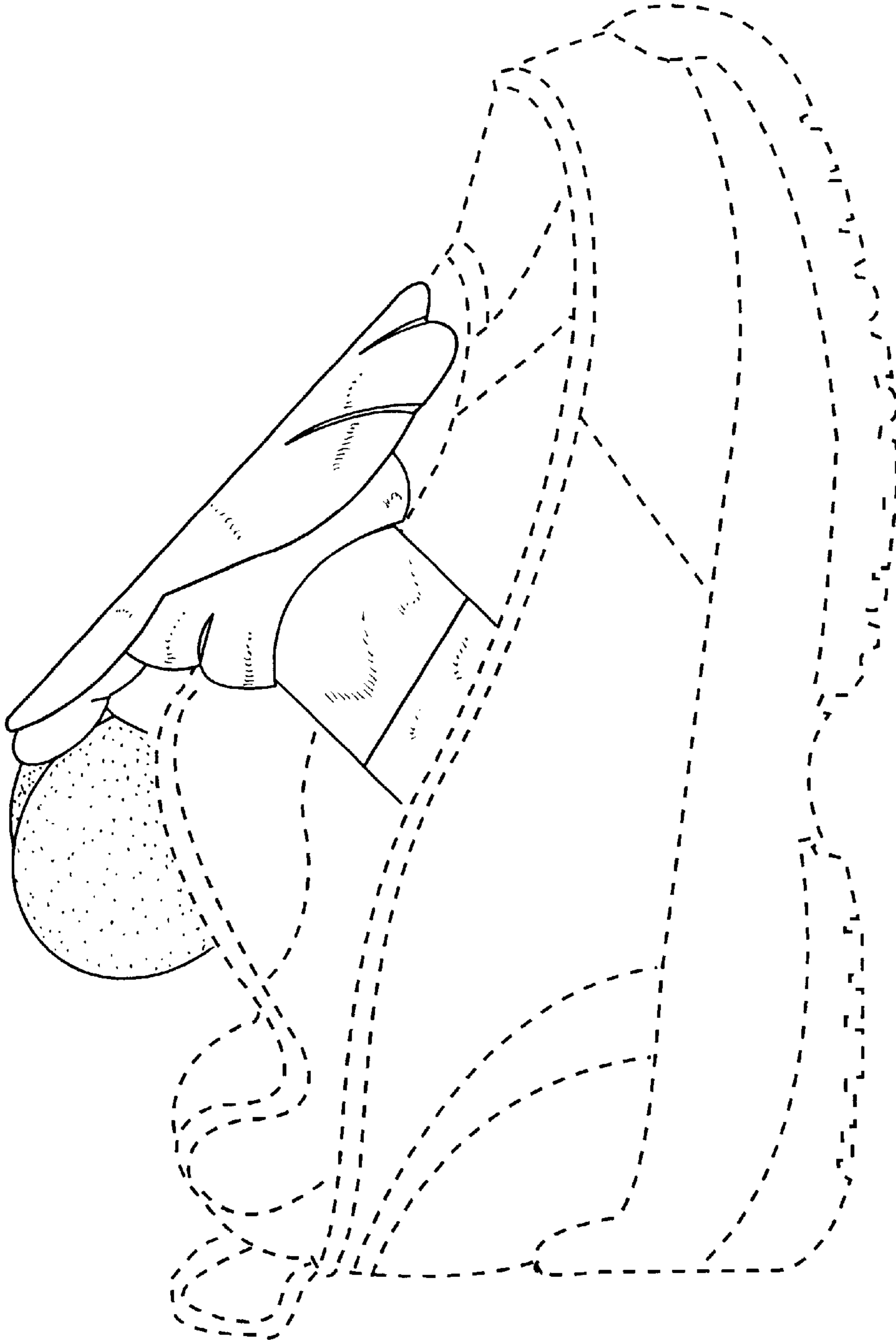

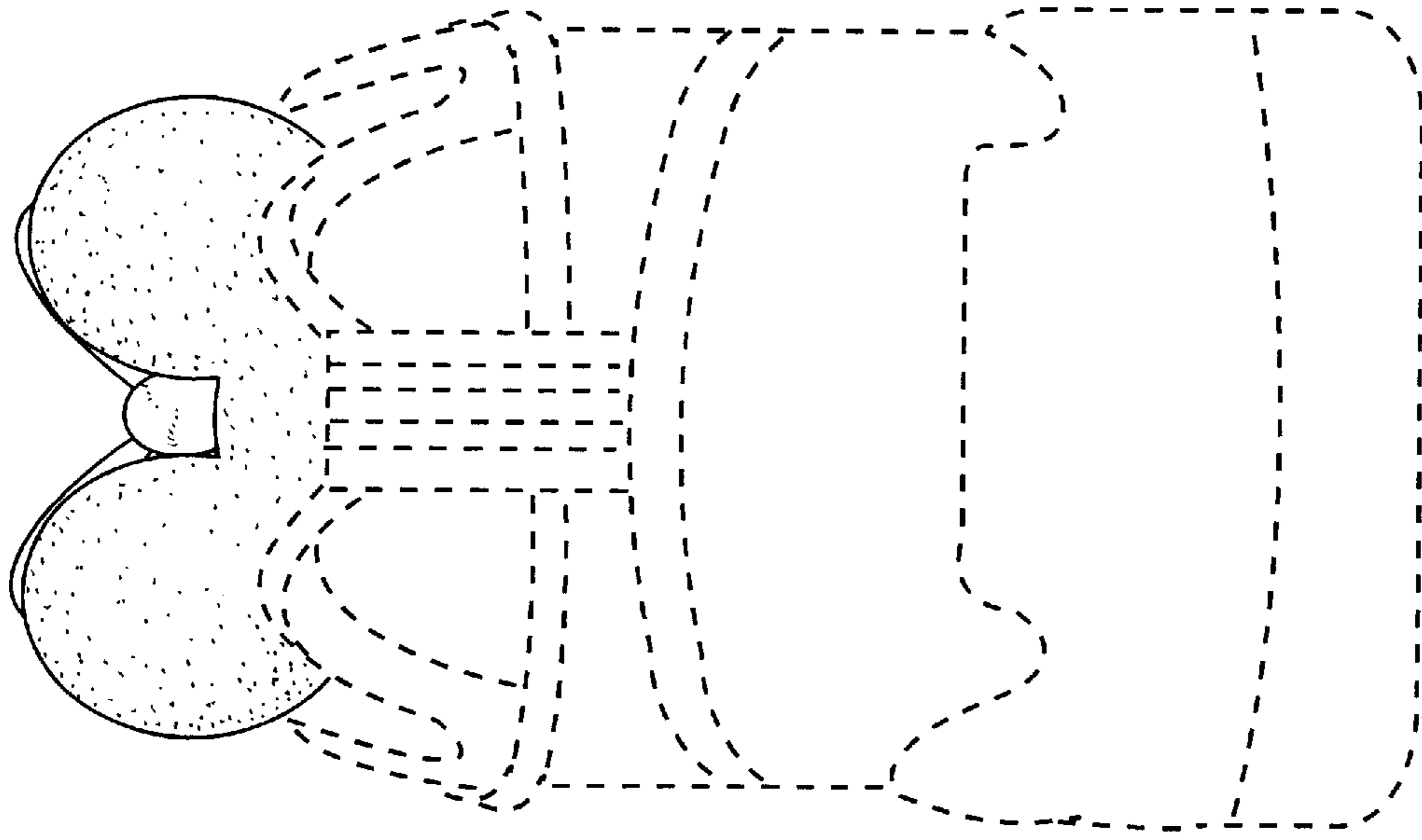

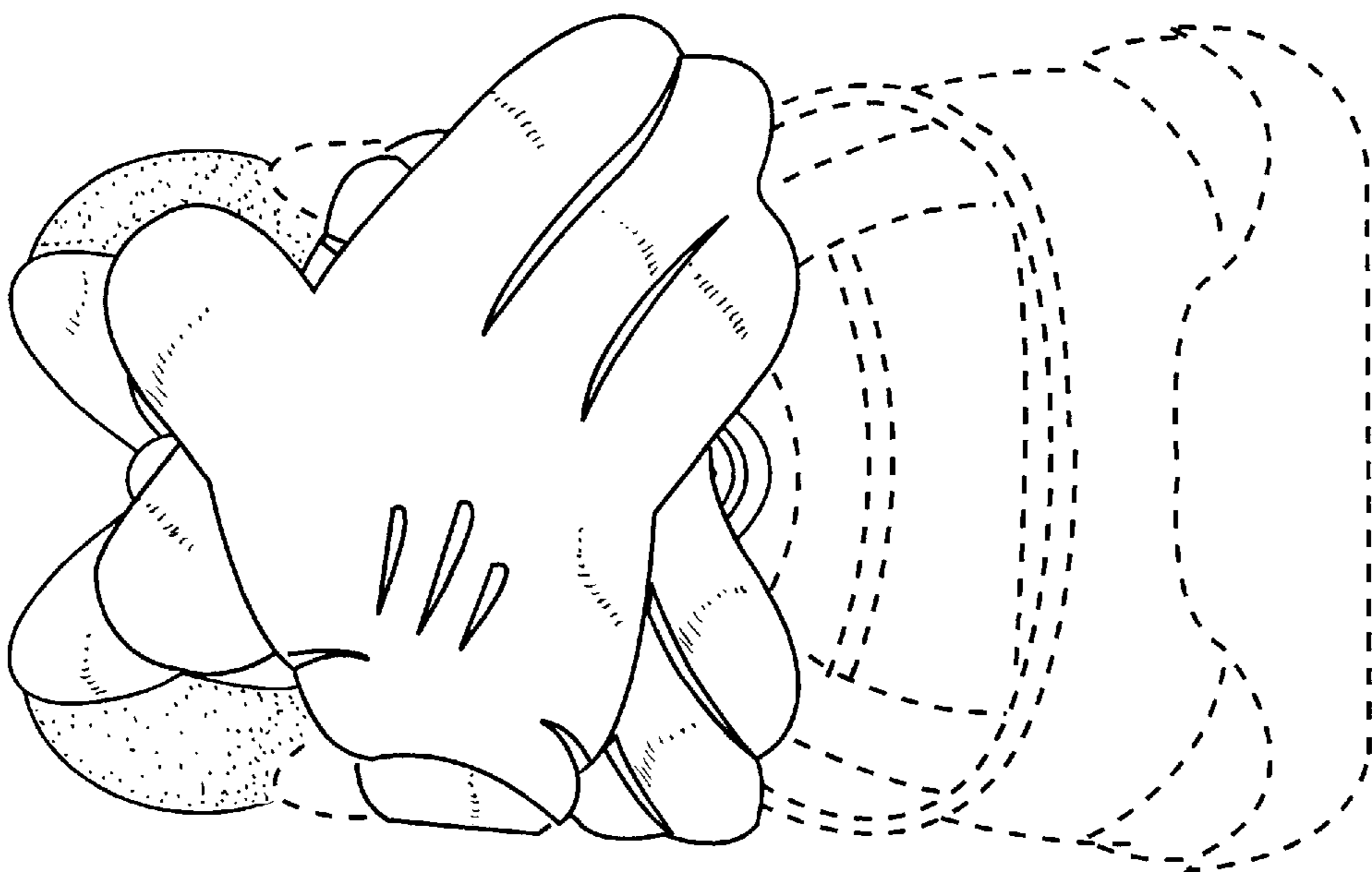

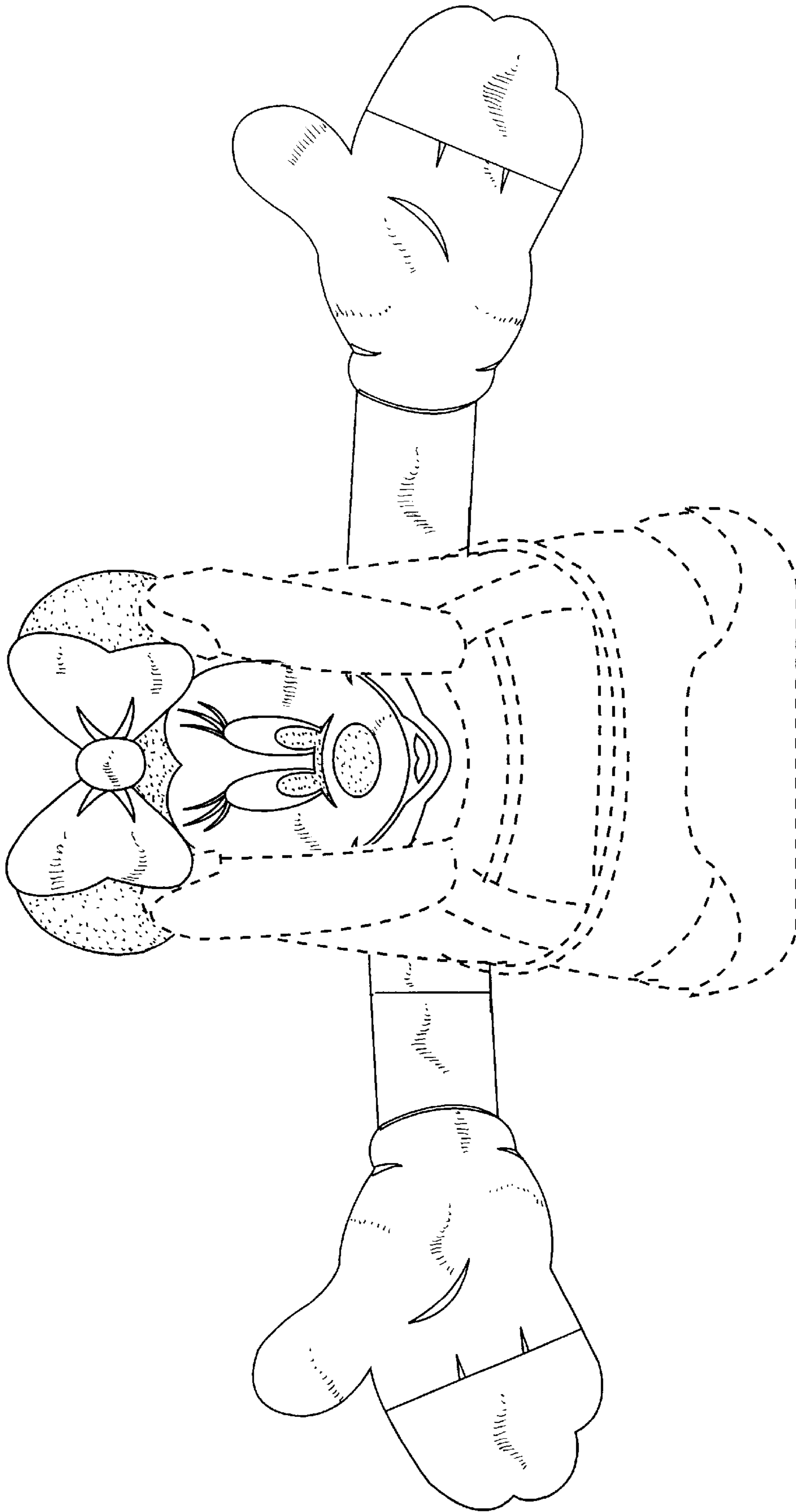

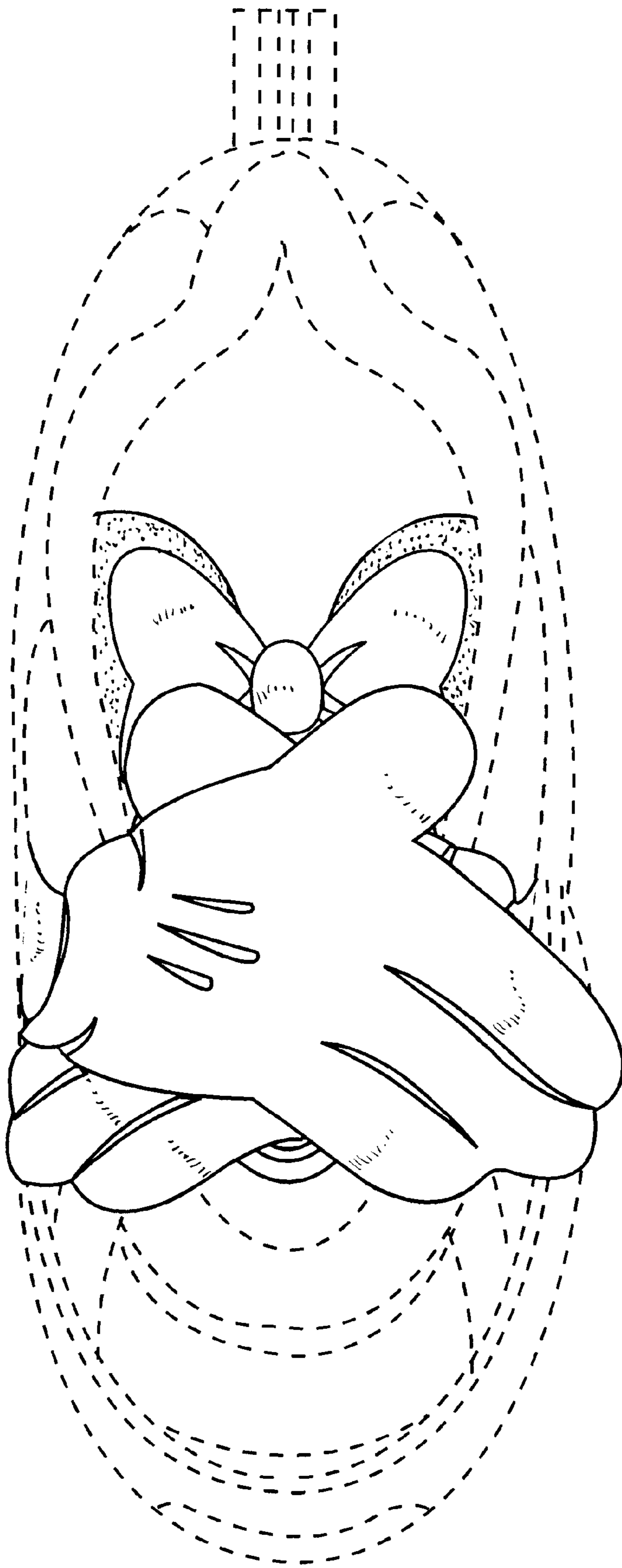

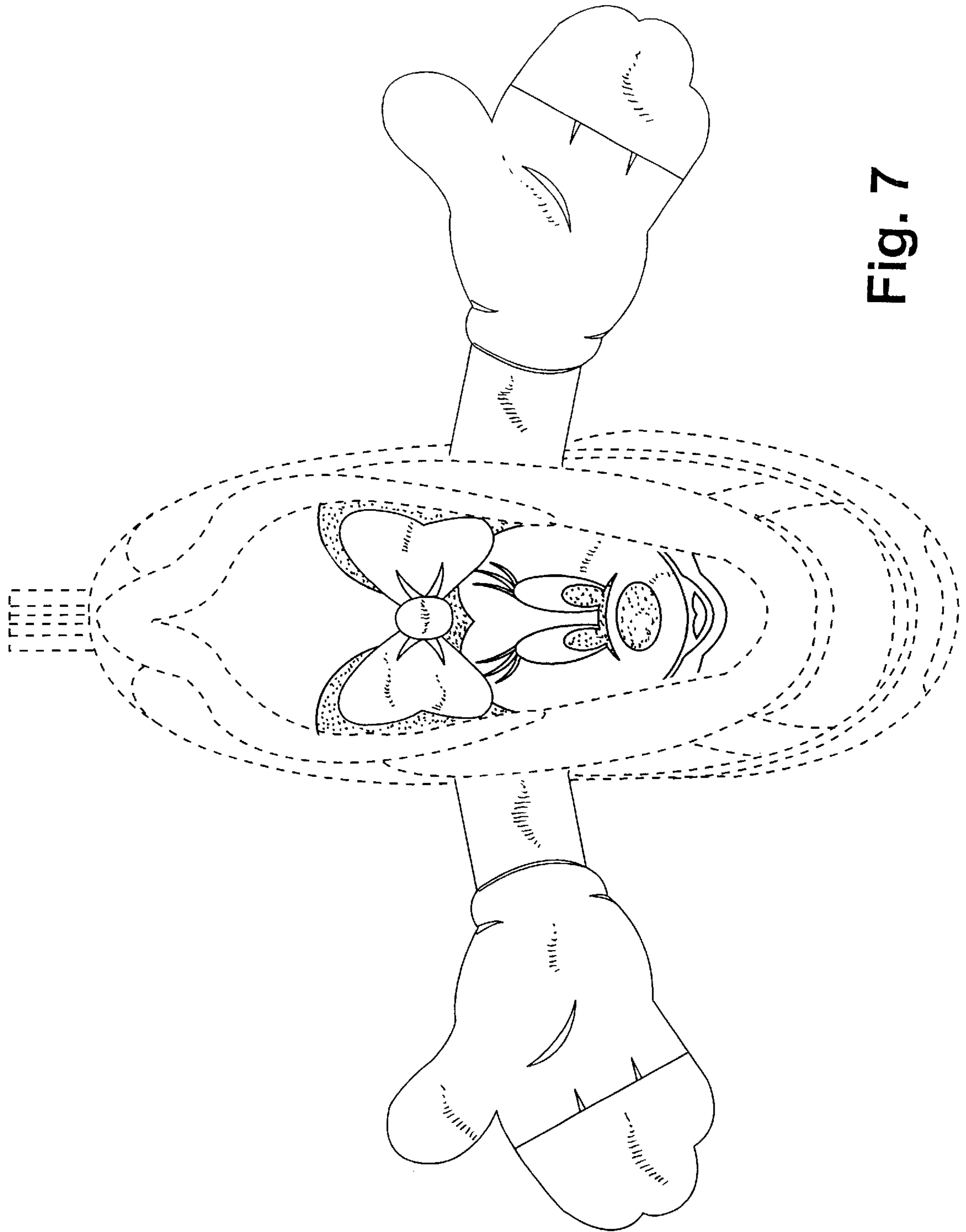

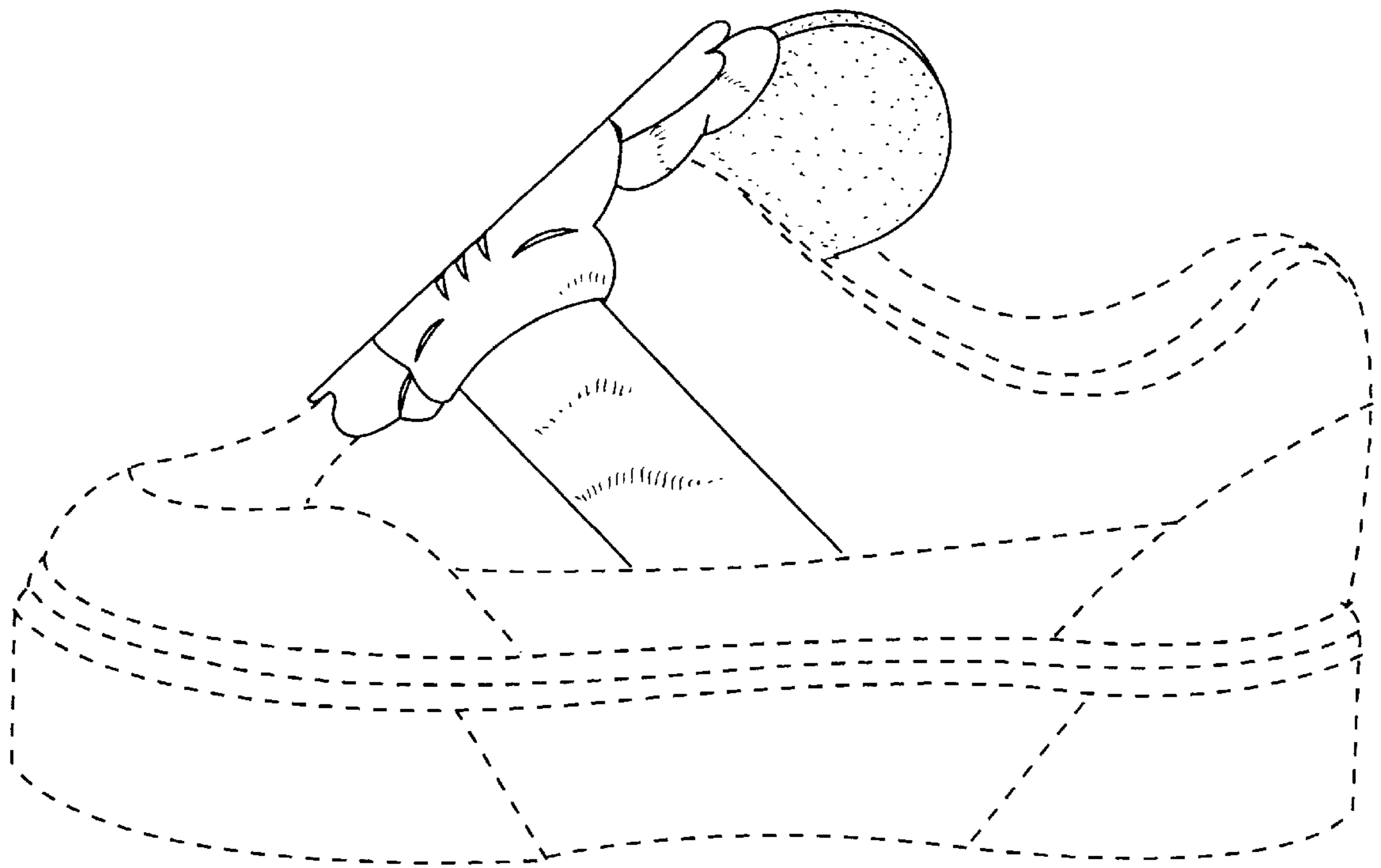

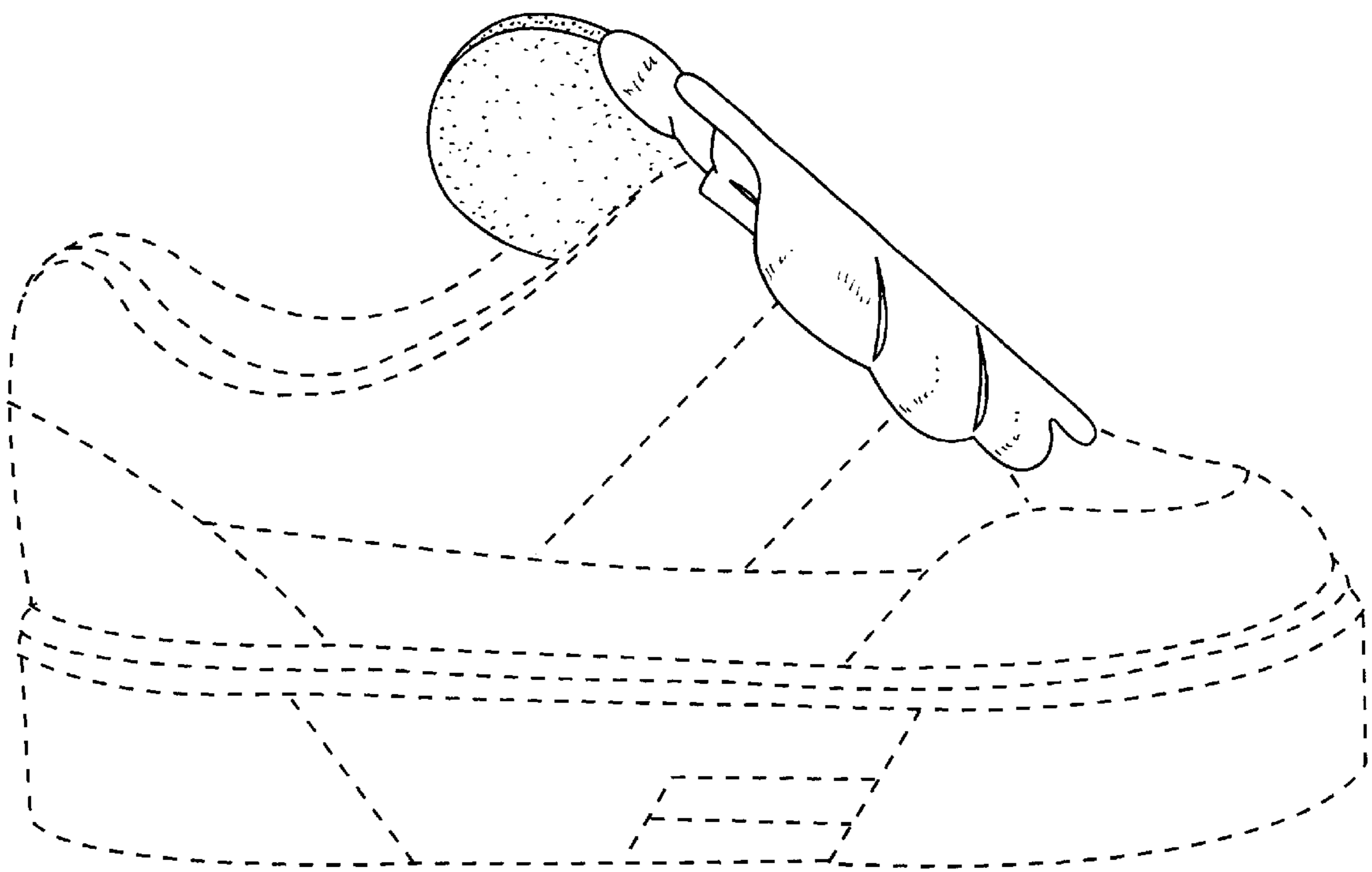

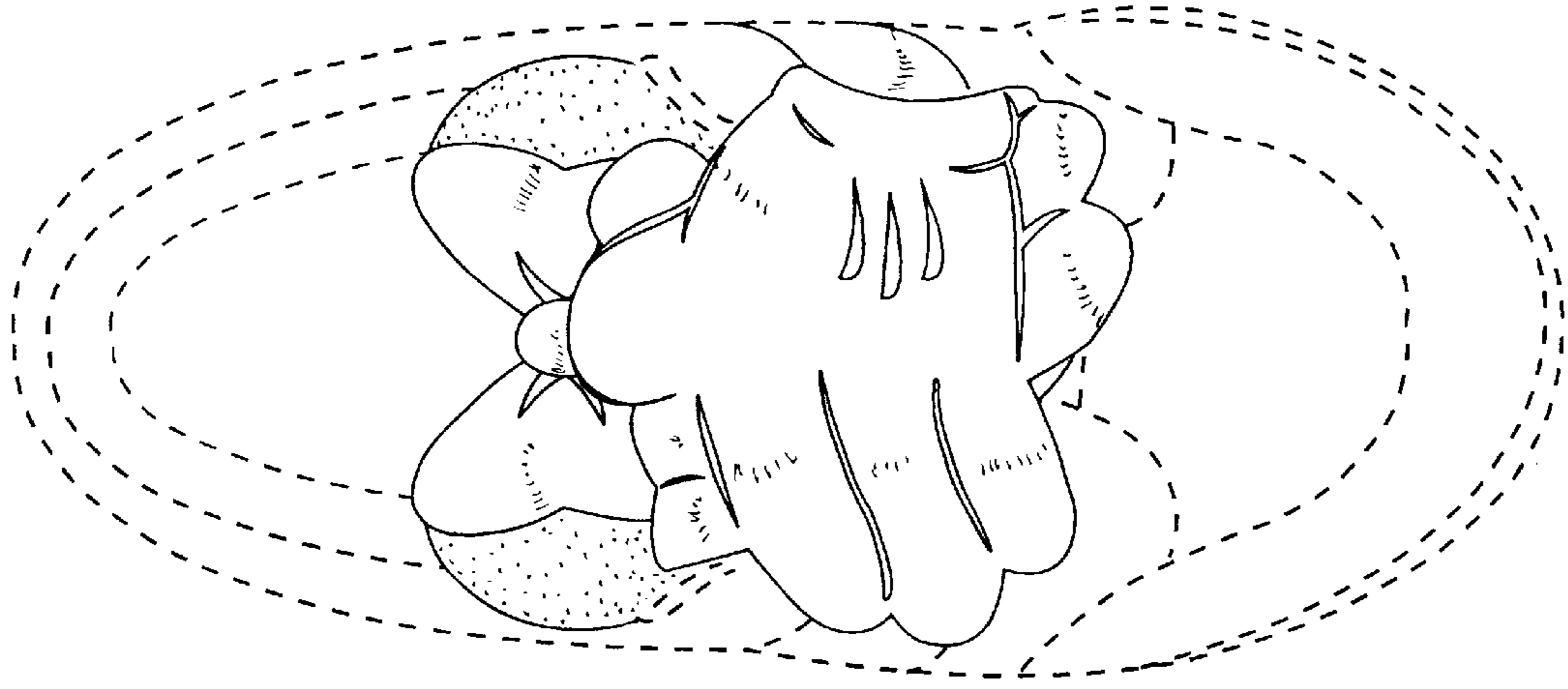

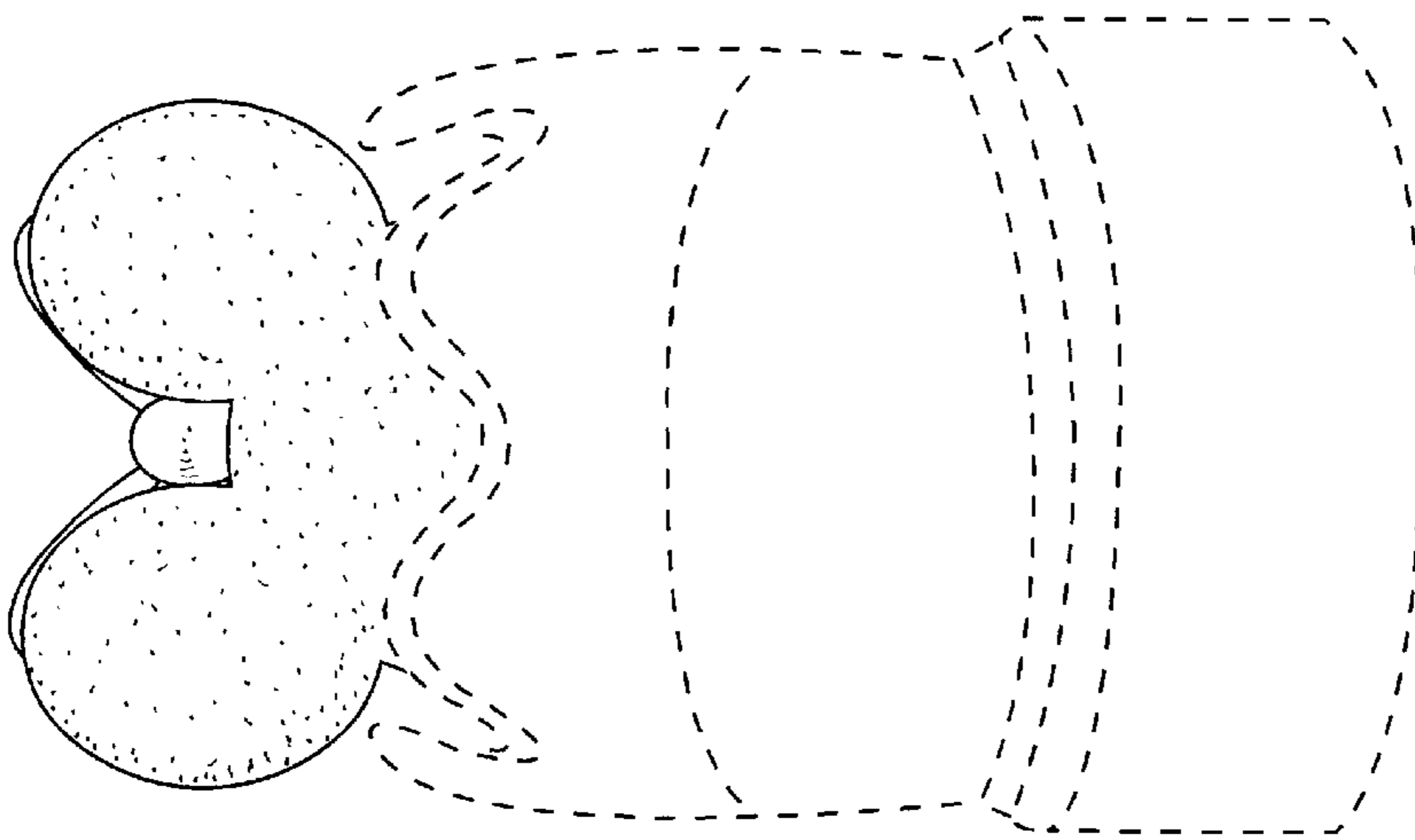

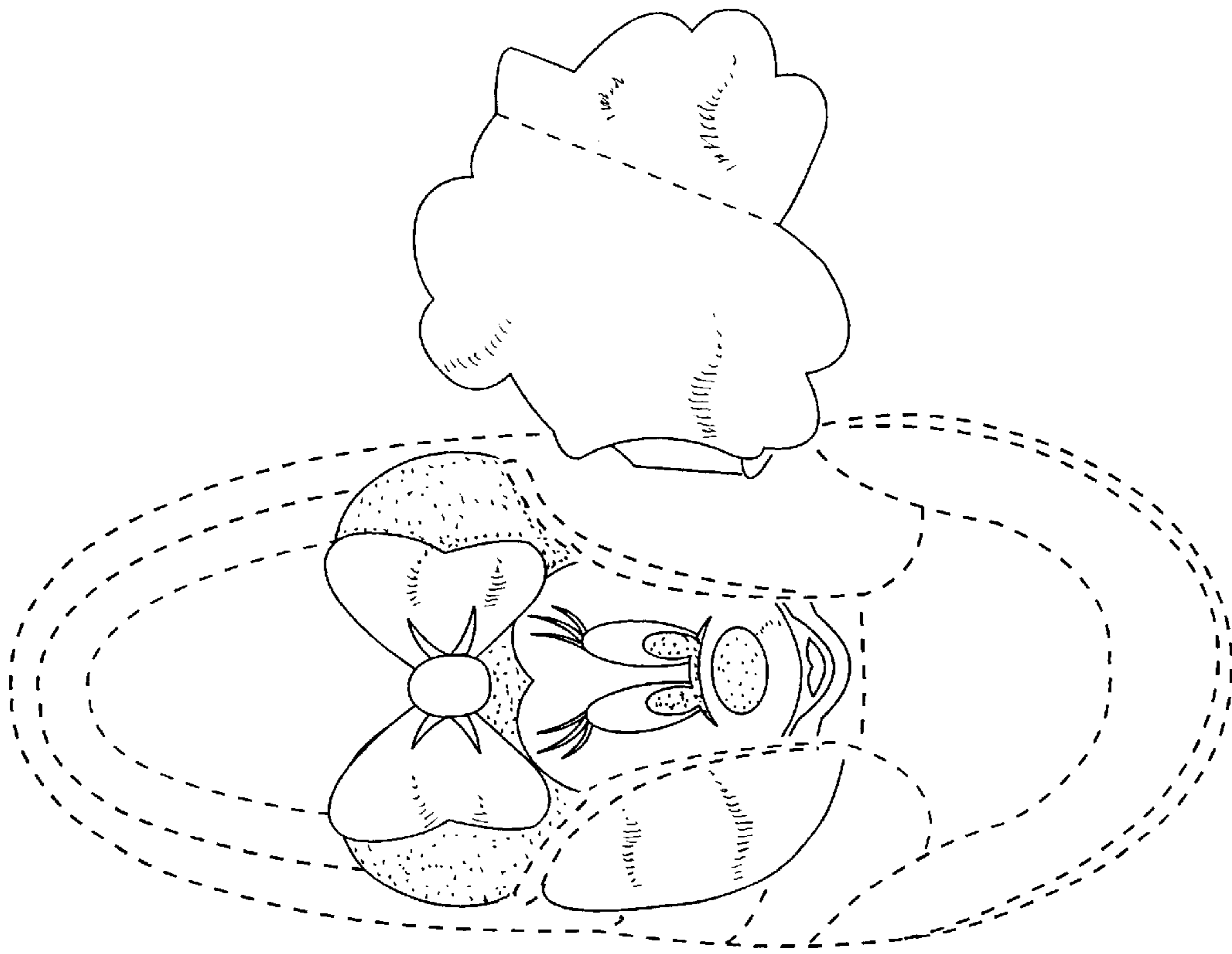
