DESCRIPTION

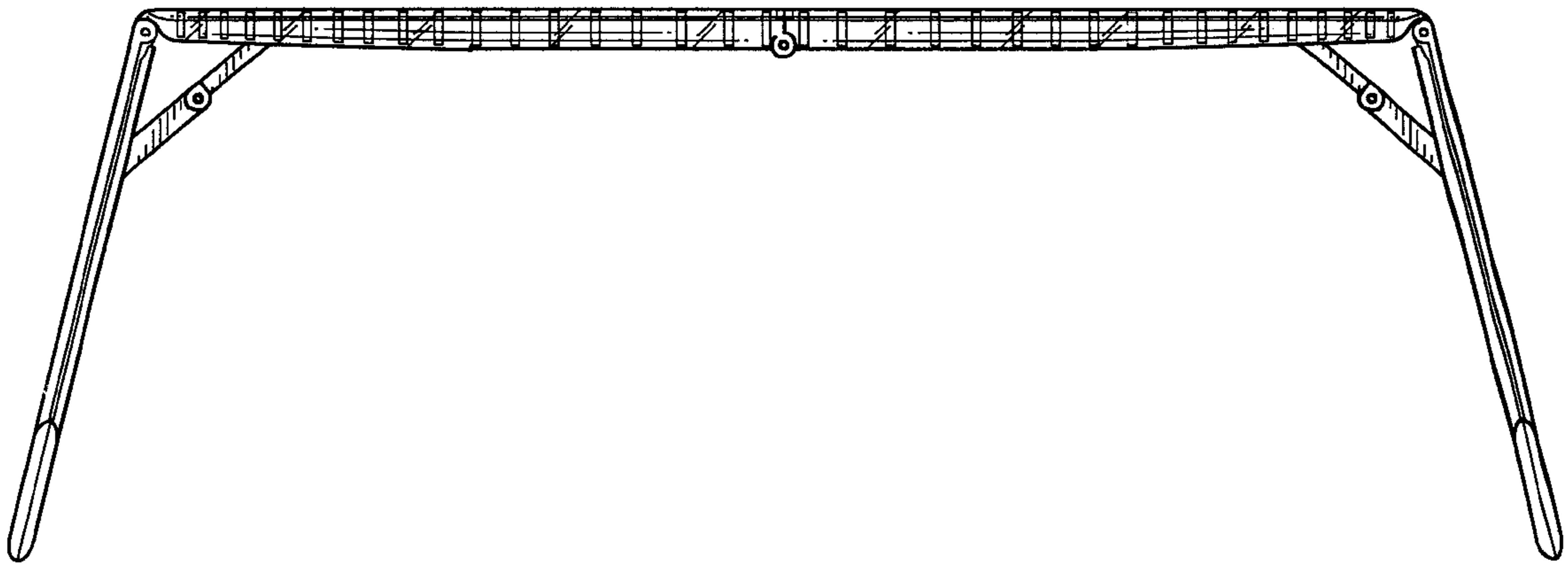
FIG. 1 is a right side view of the portable collapsible translucent laptop computer table in an opened configuration, as it would normally be used, showing my new design with the left side view being identical;

FIG. 2 is a top plan view thereof;

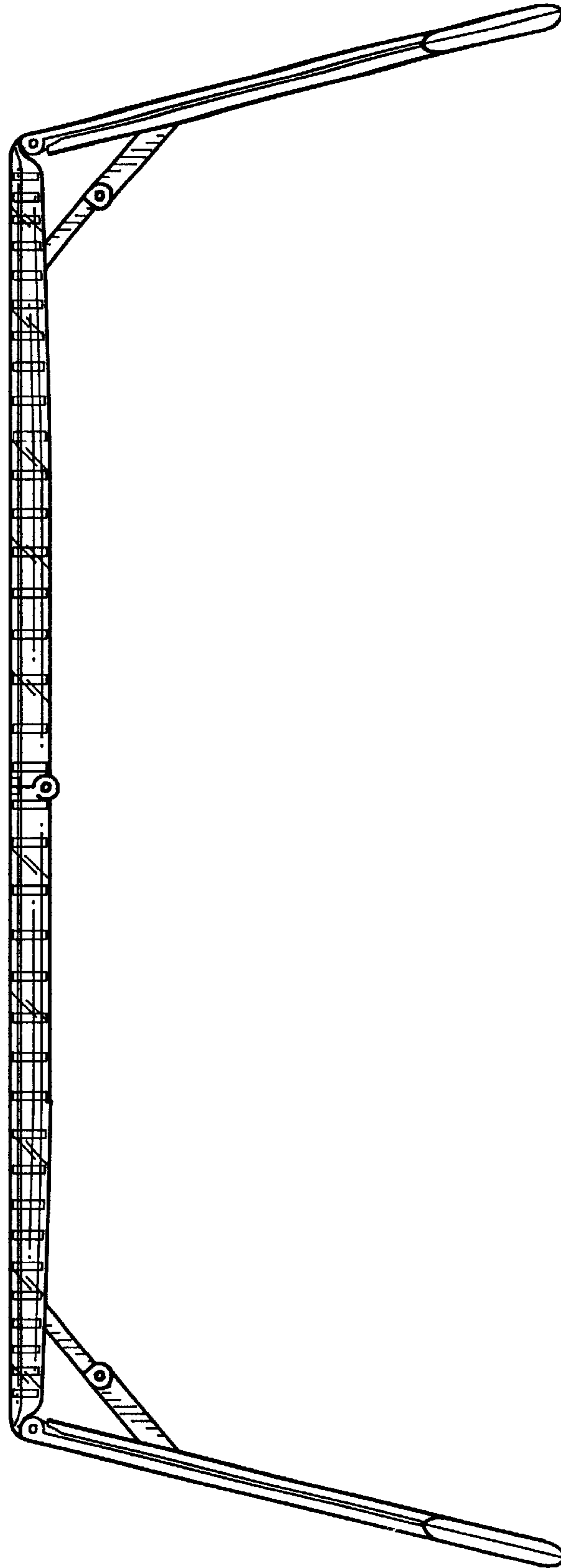

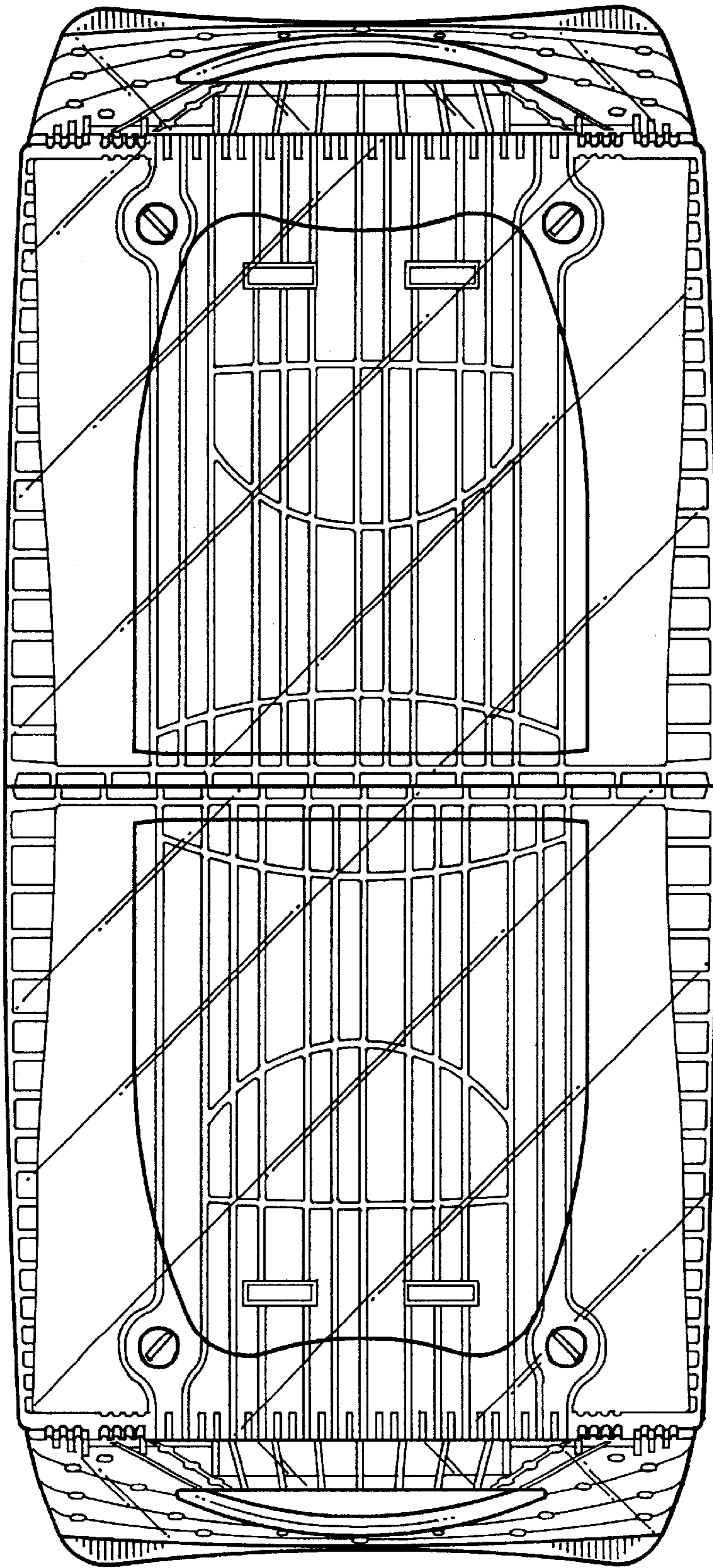

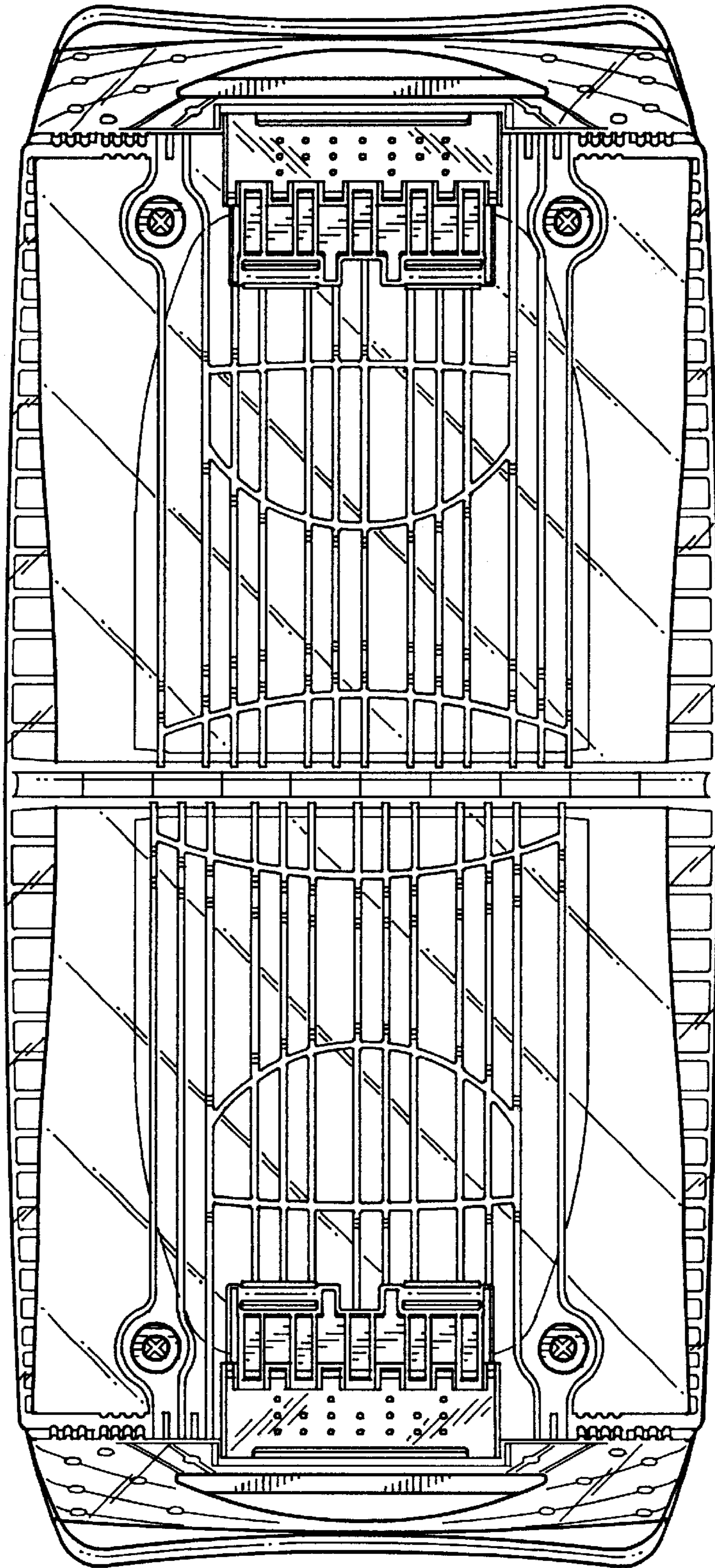

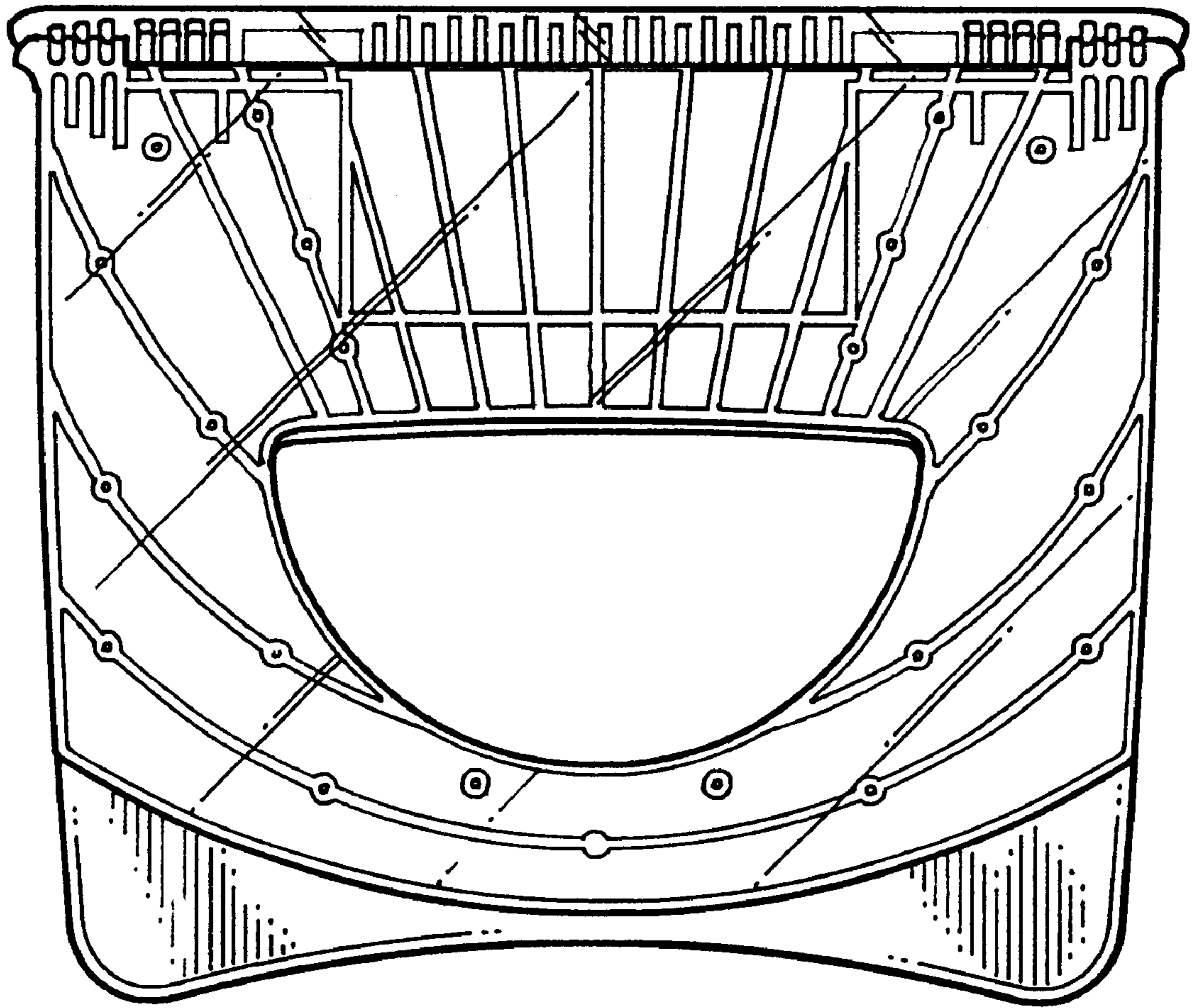
