(57) **CLAIM**

I claim the ornamental design for a furniture, as shown.

DESCRIPTION

FIG. 17 is a rear elevational view of the third embodiment of the furniture unit;

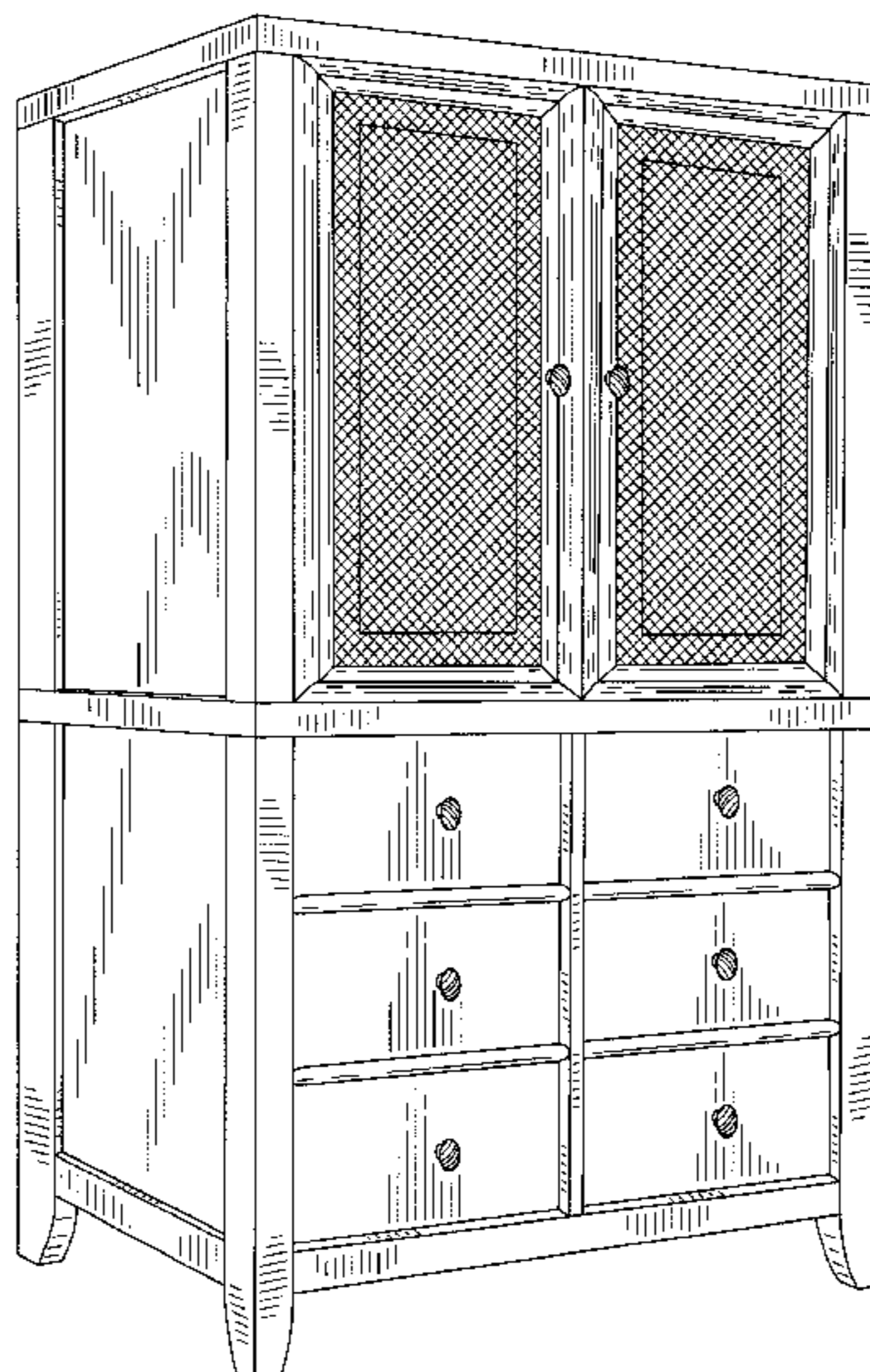
FIG. 18 is a top elevational view of the third embodiment of the furniture unit;

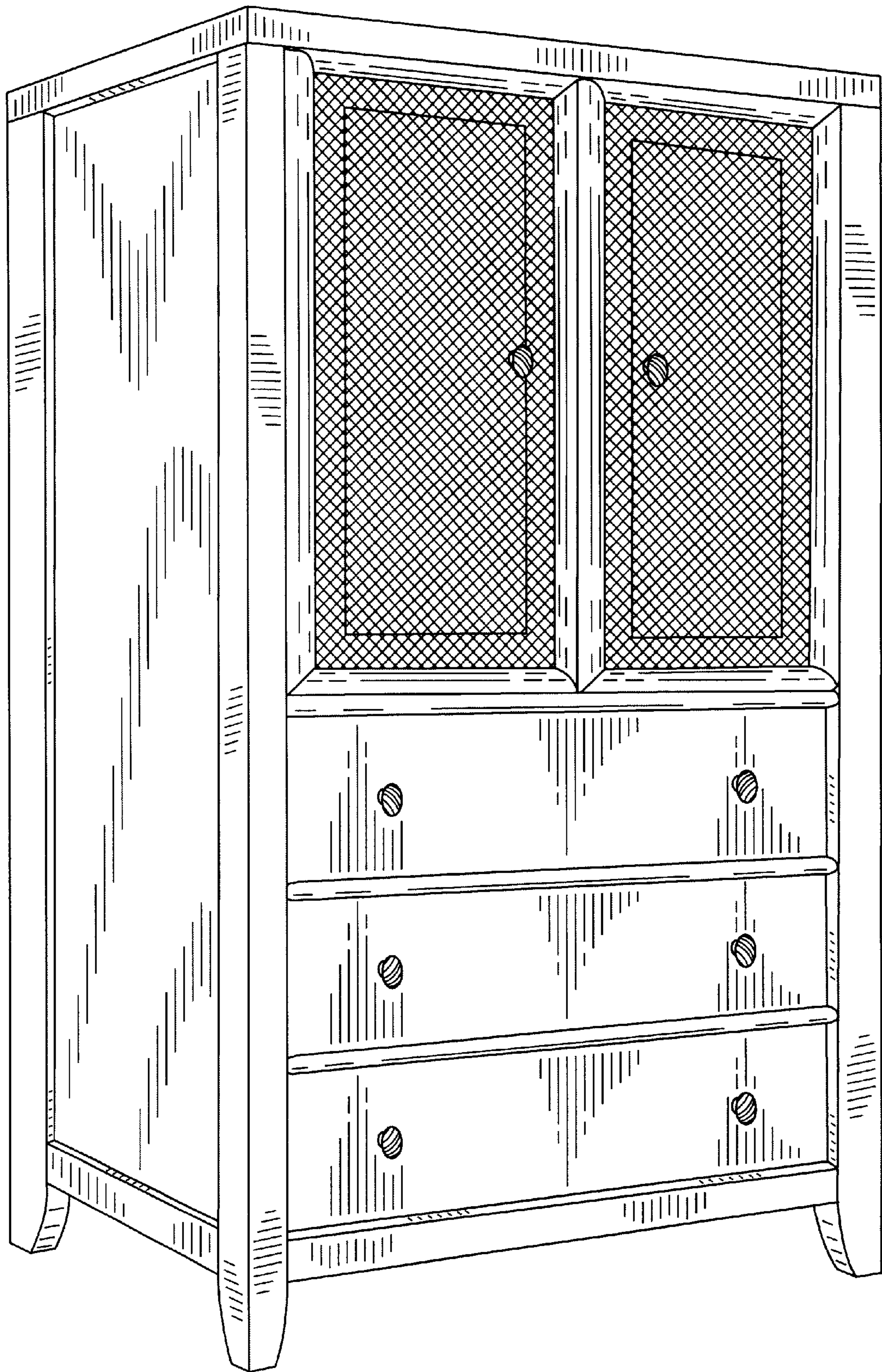

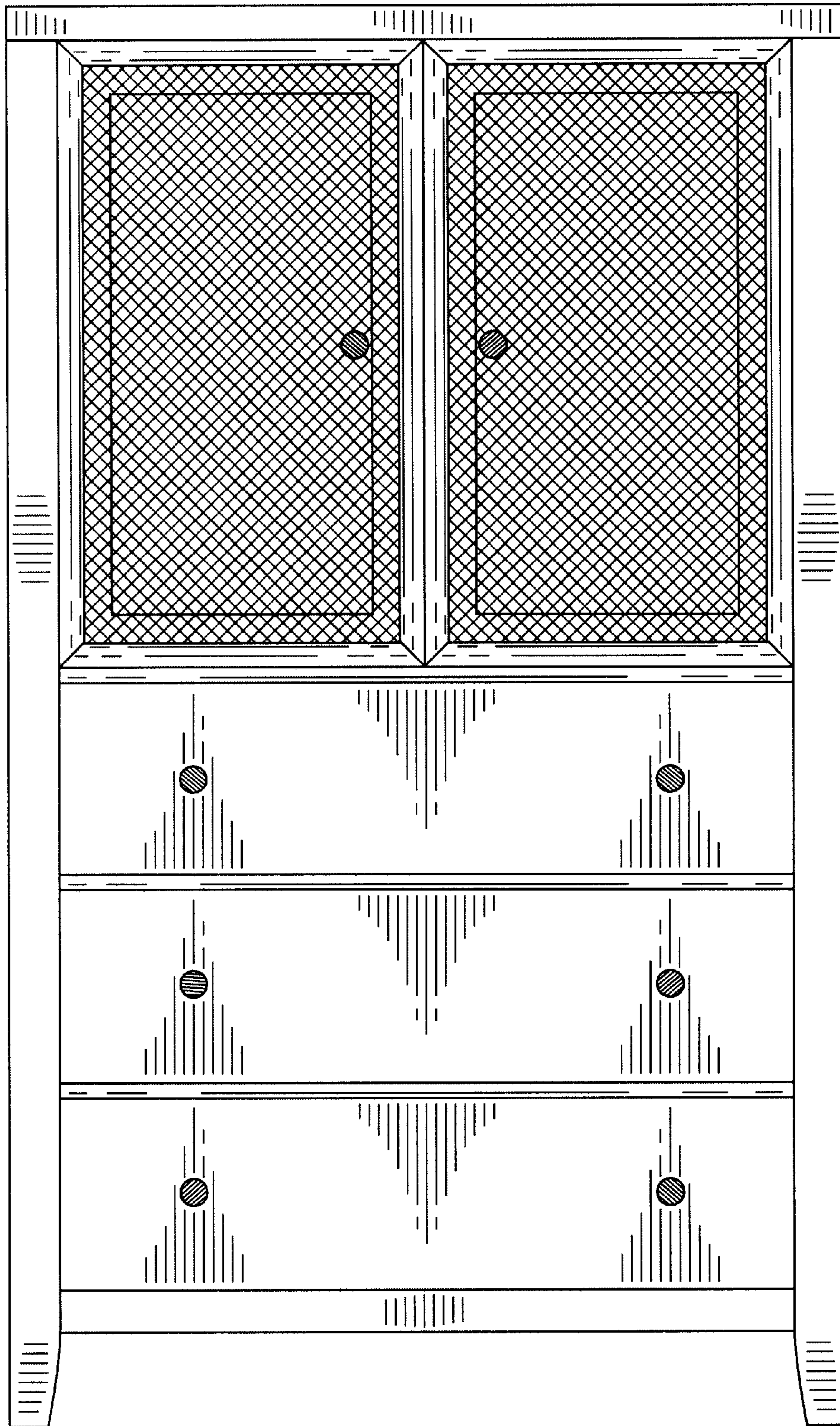

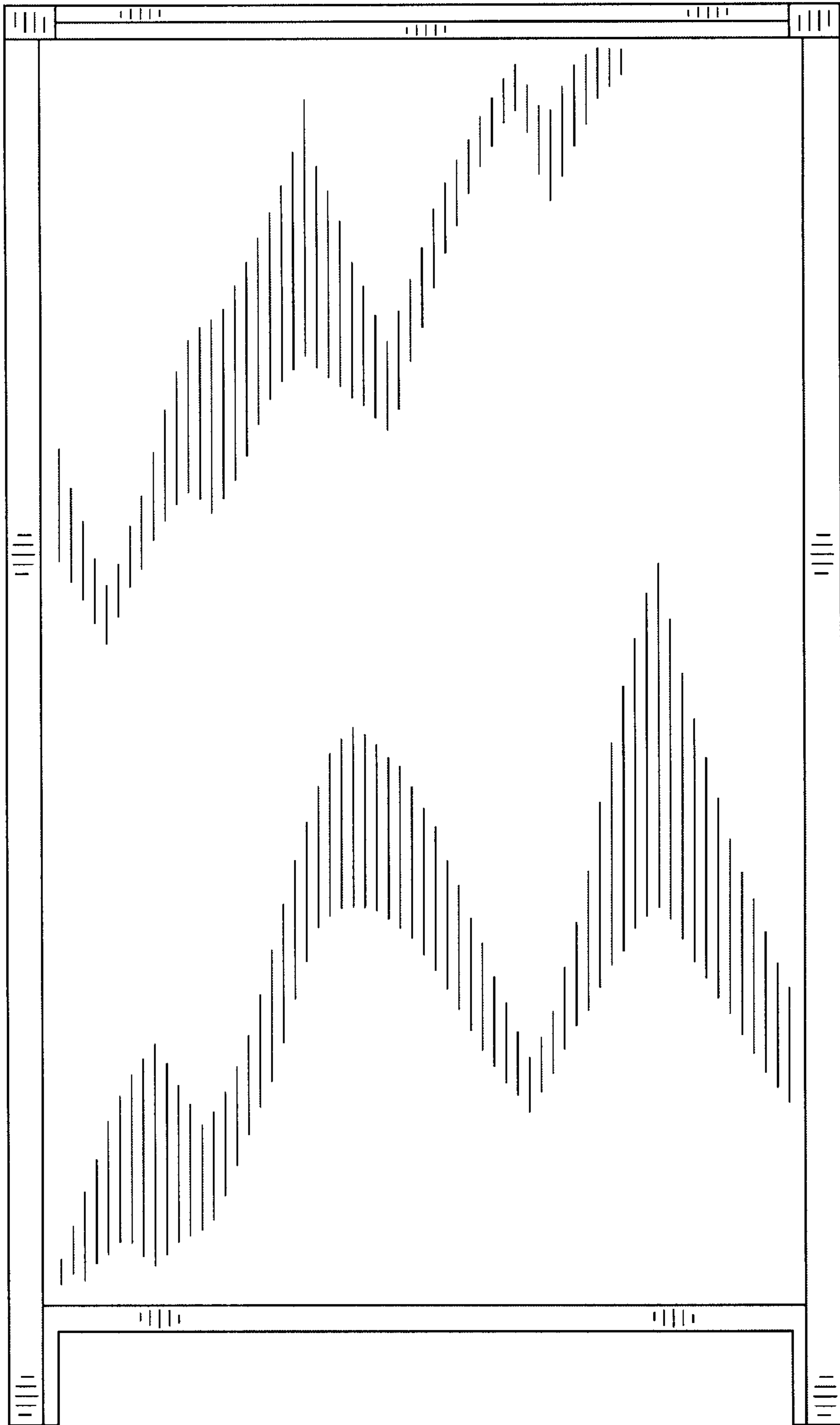

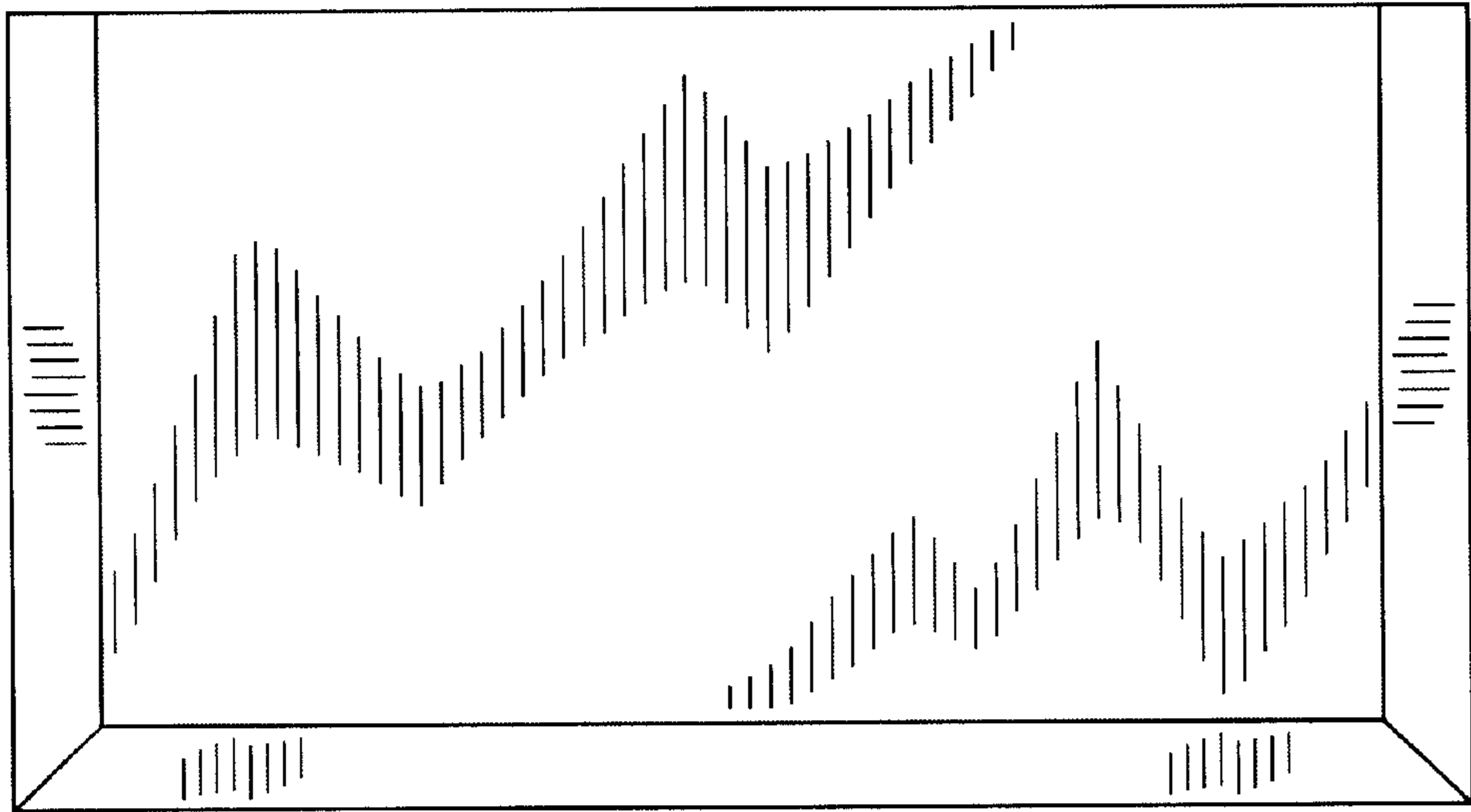

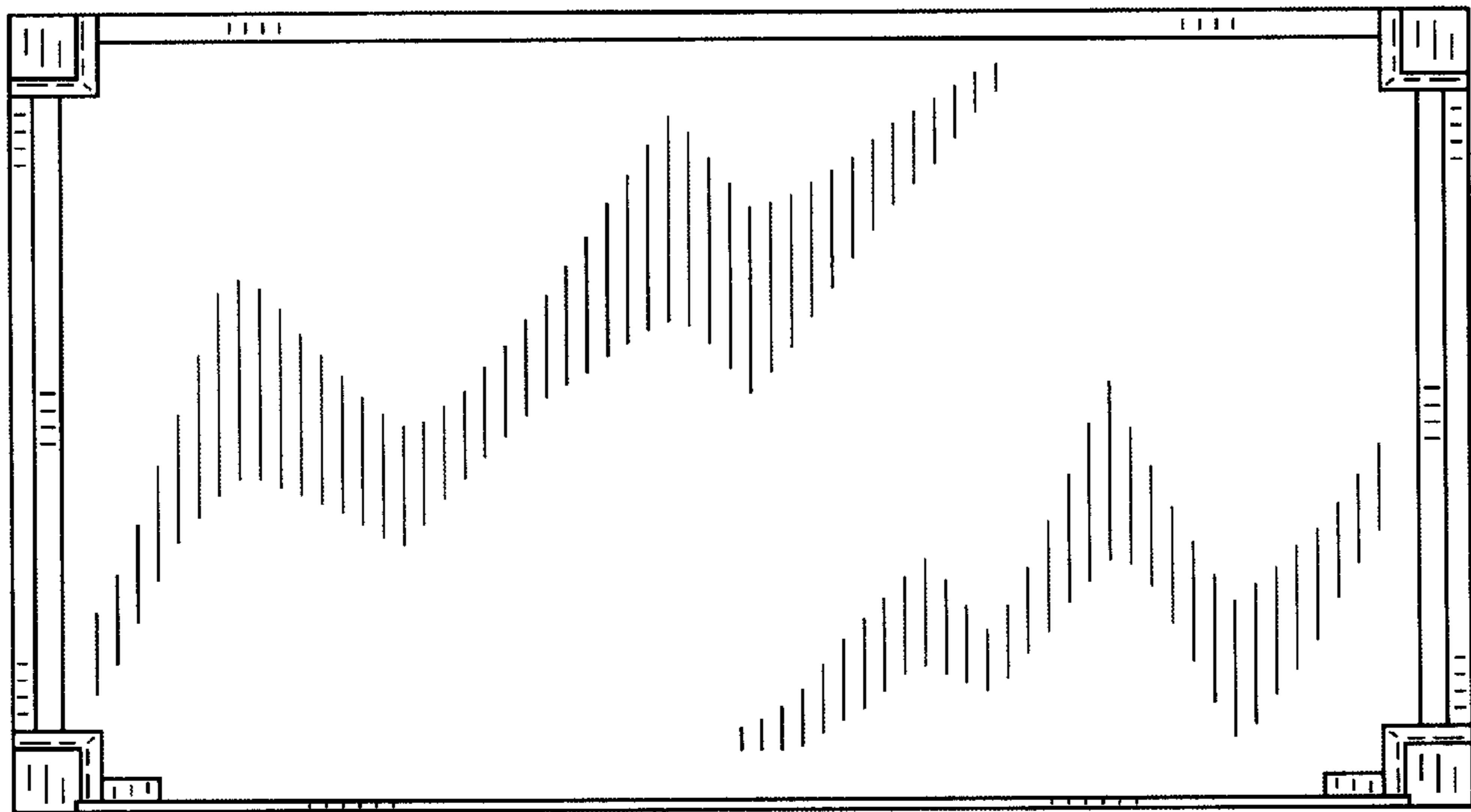

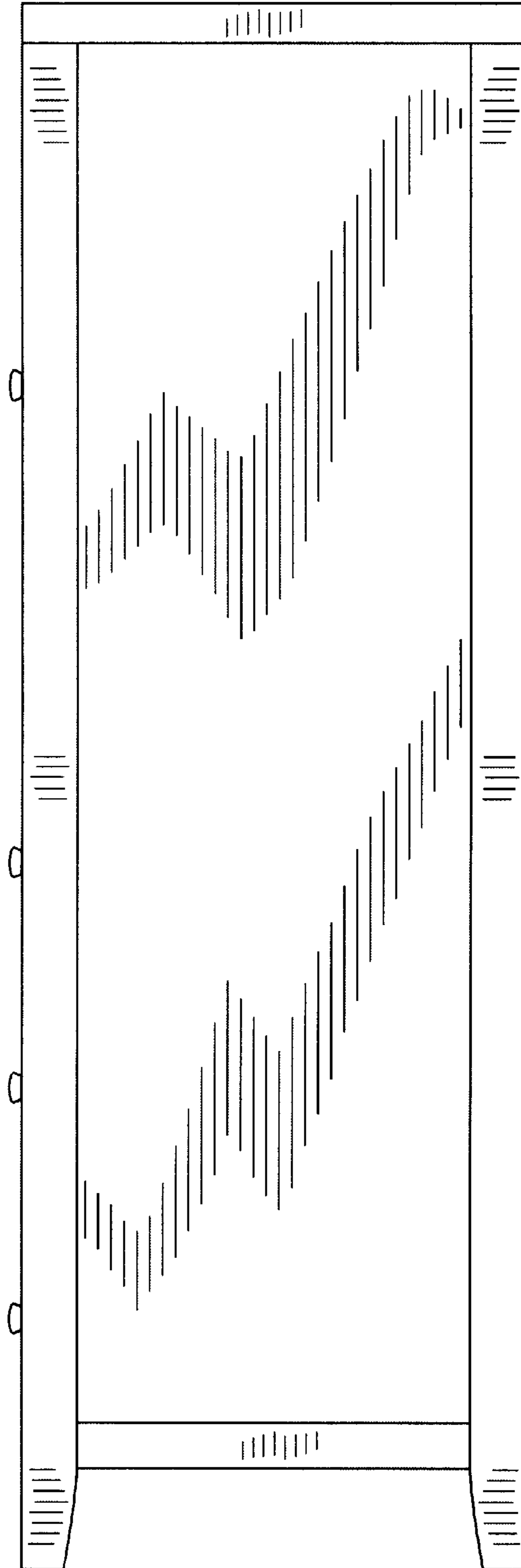

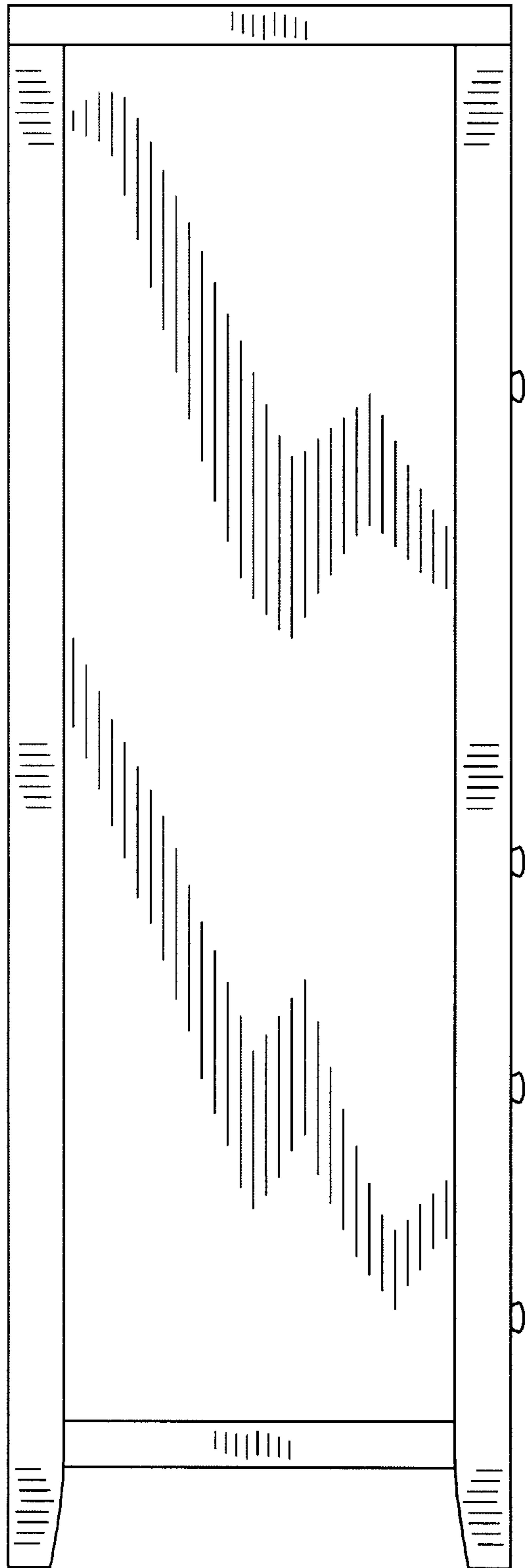

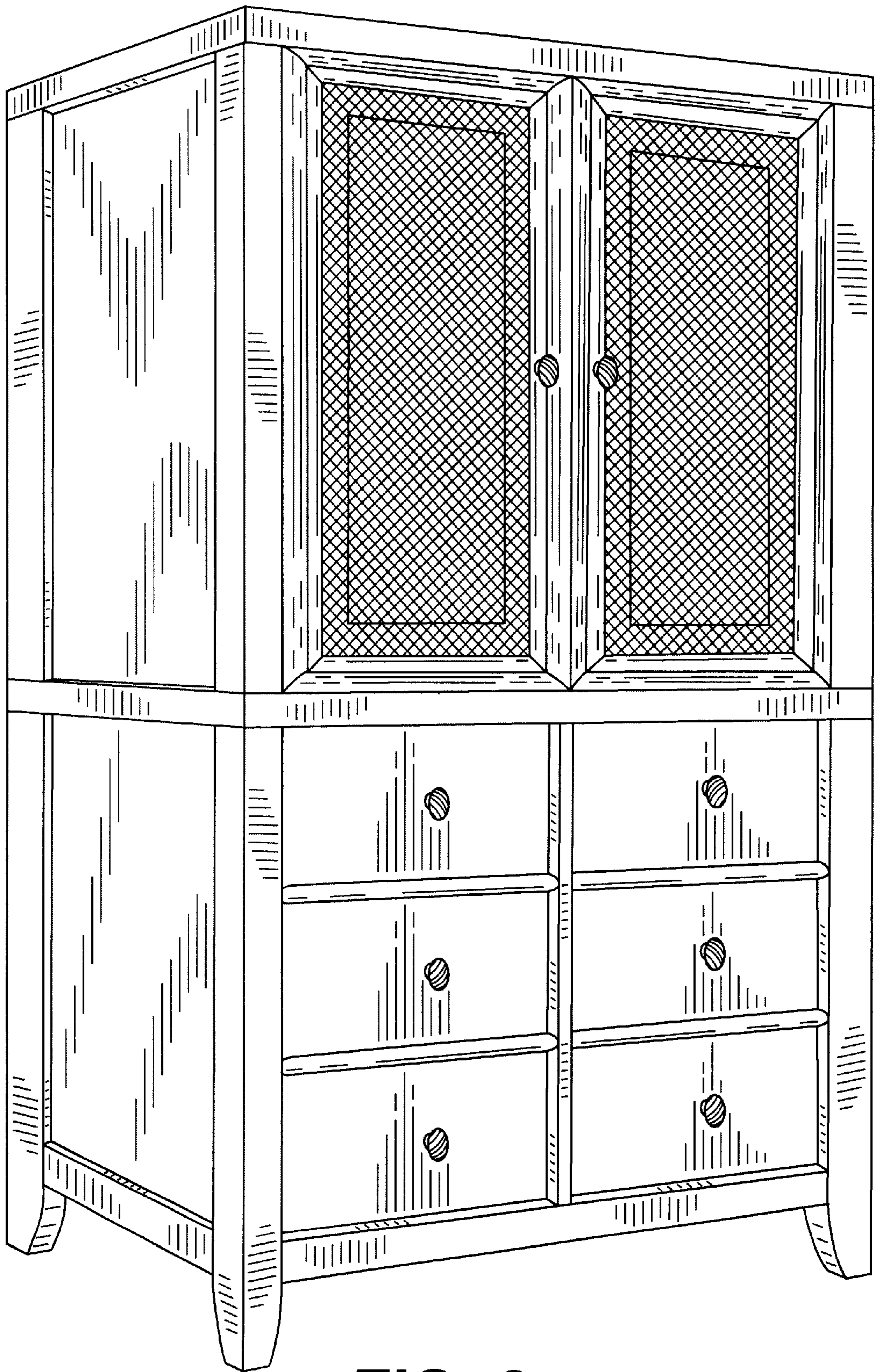

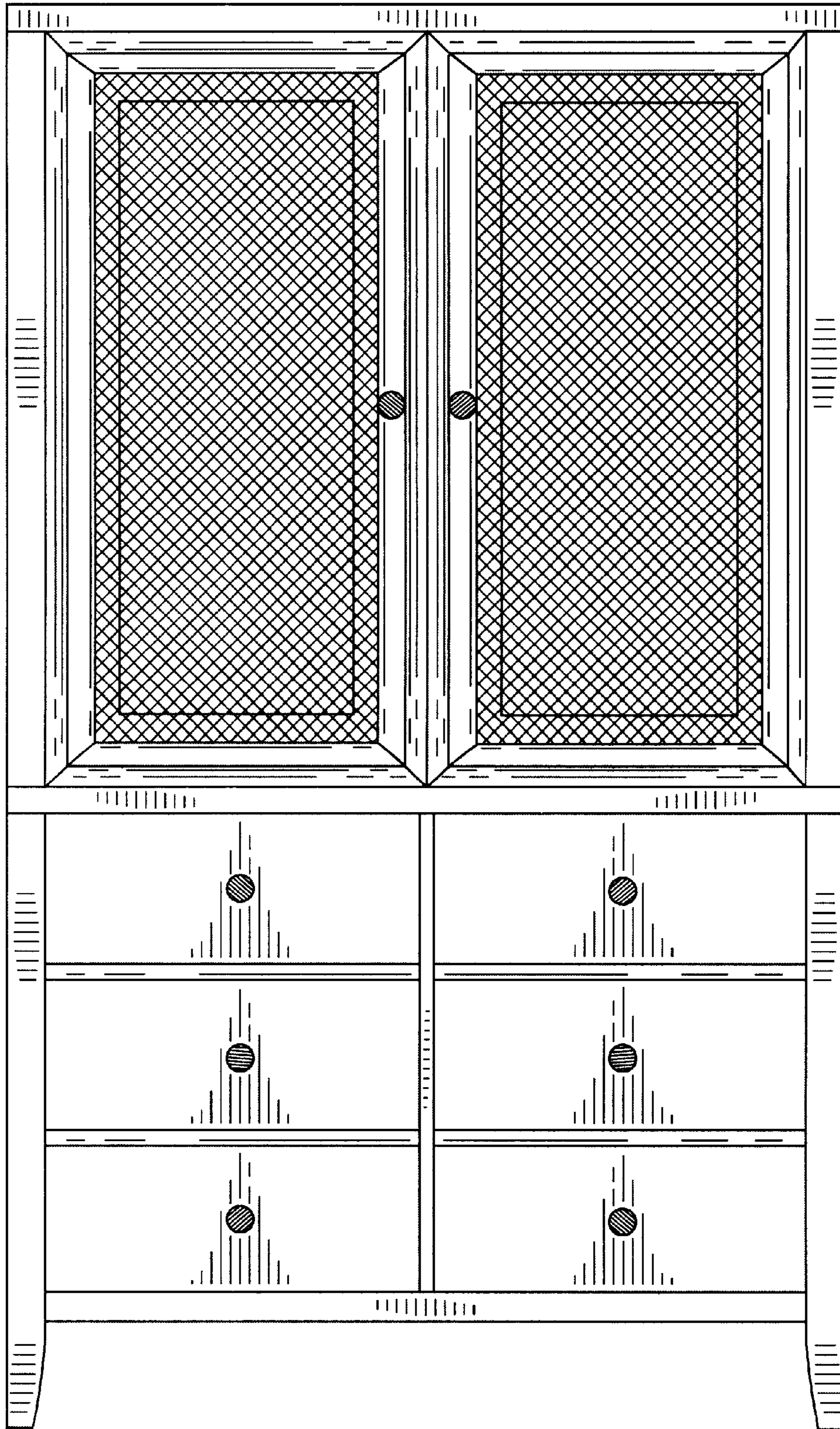

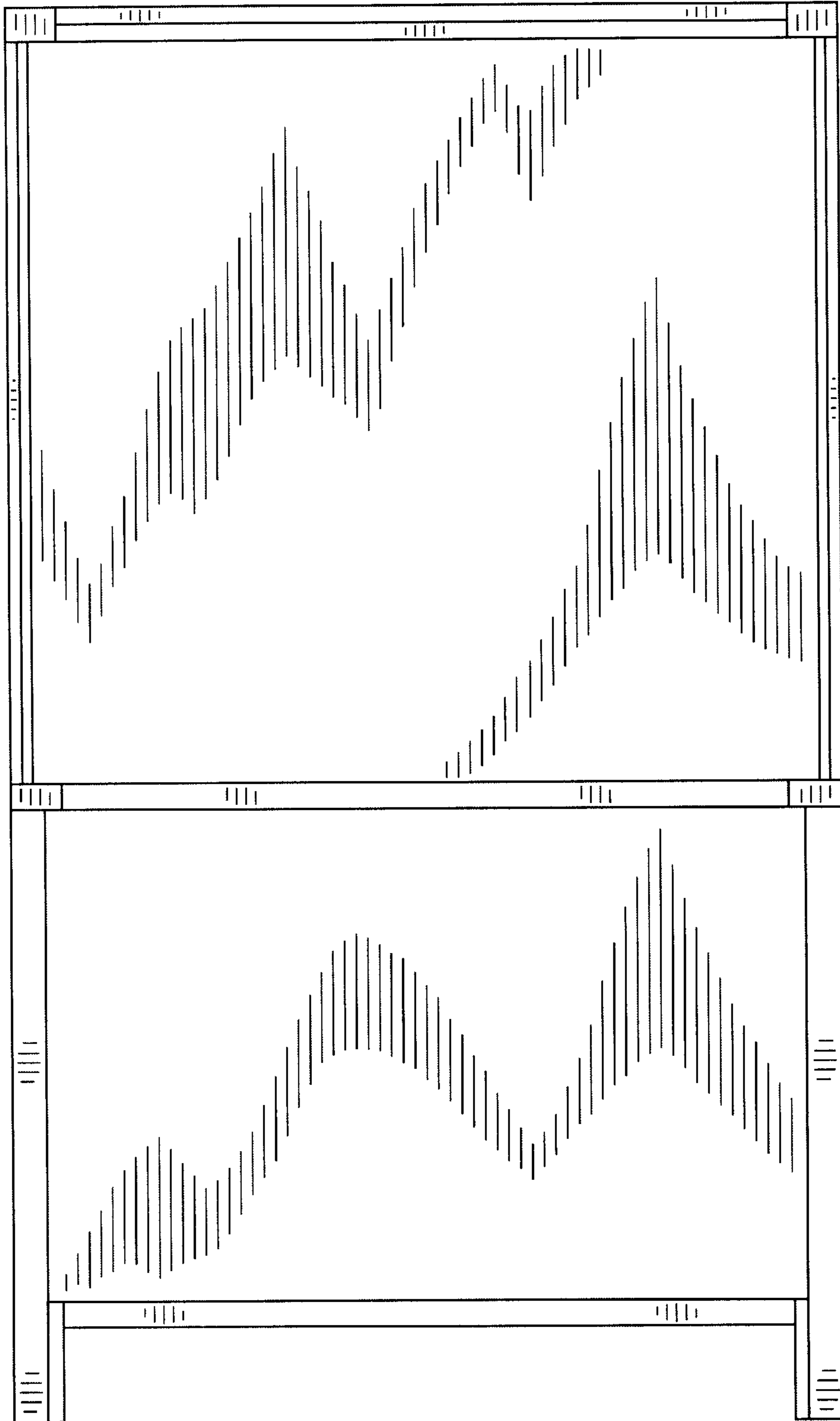

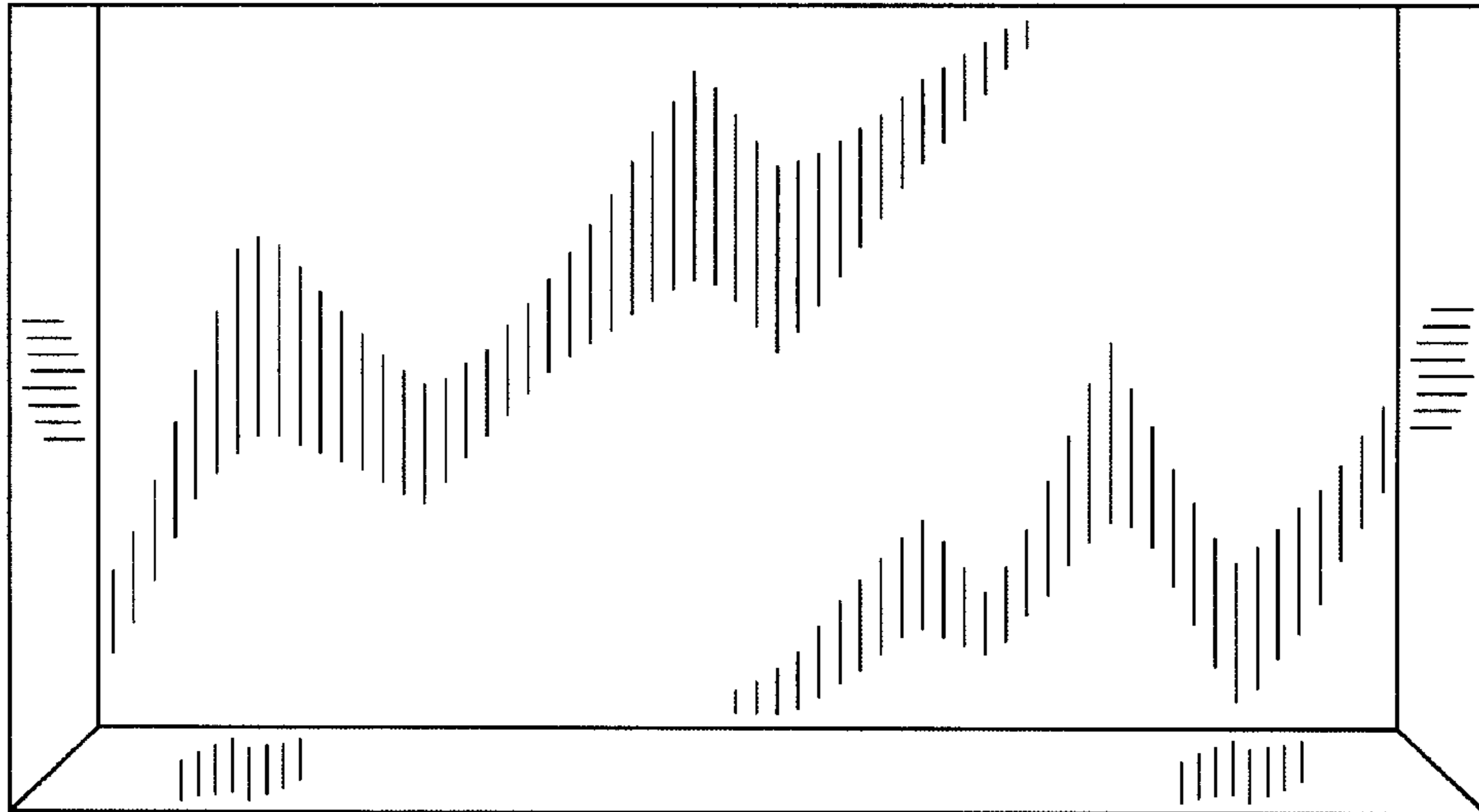

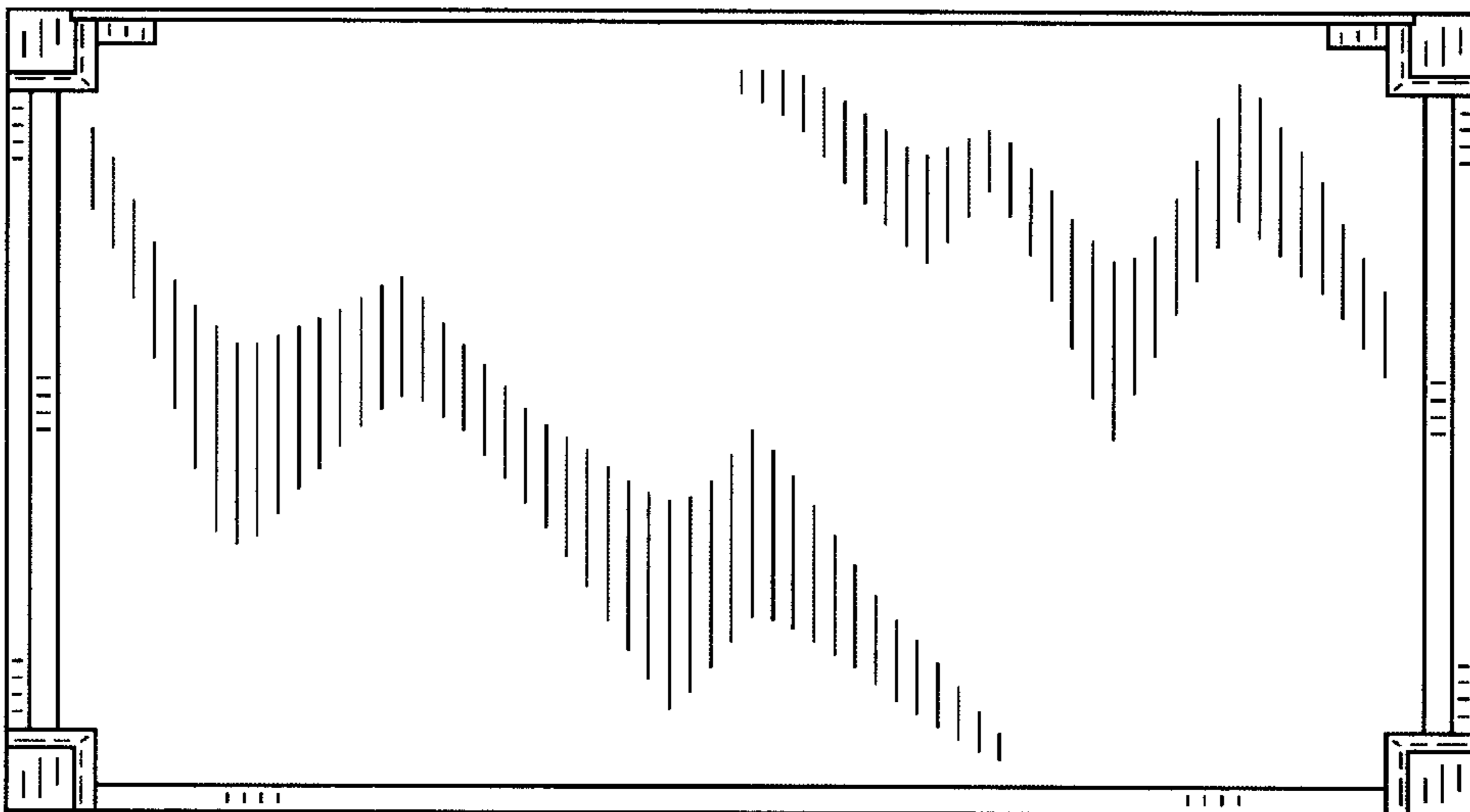

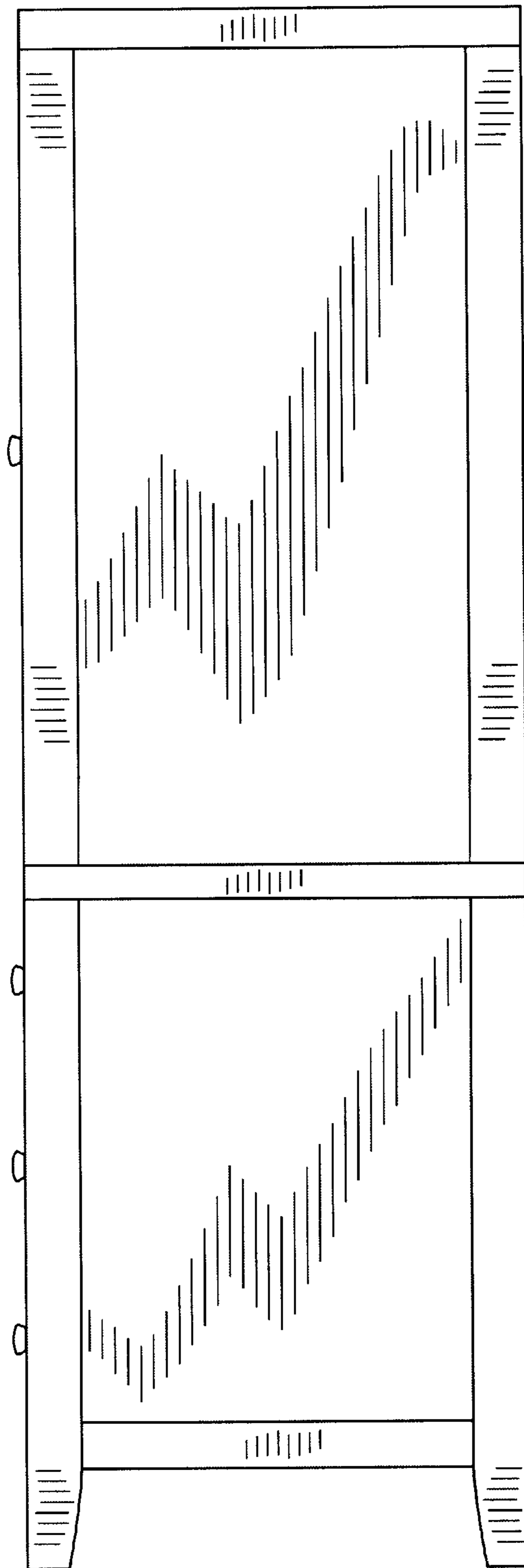

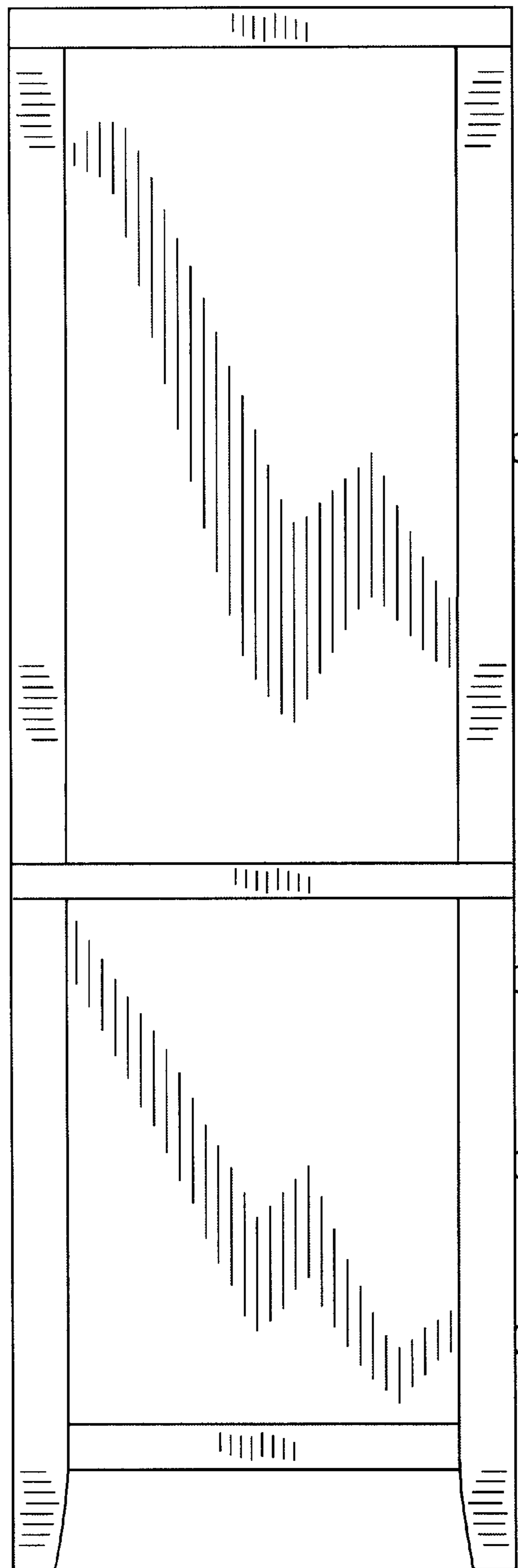

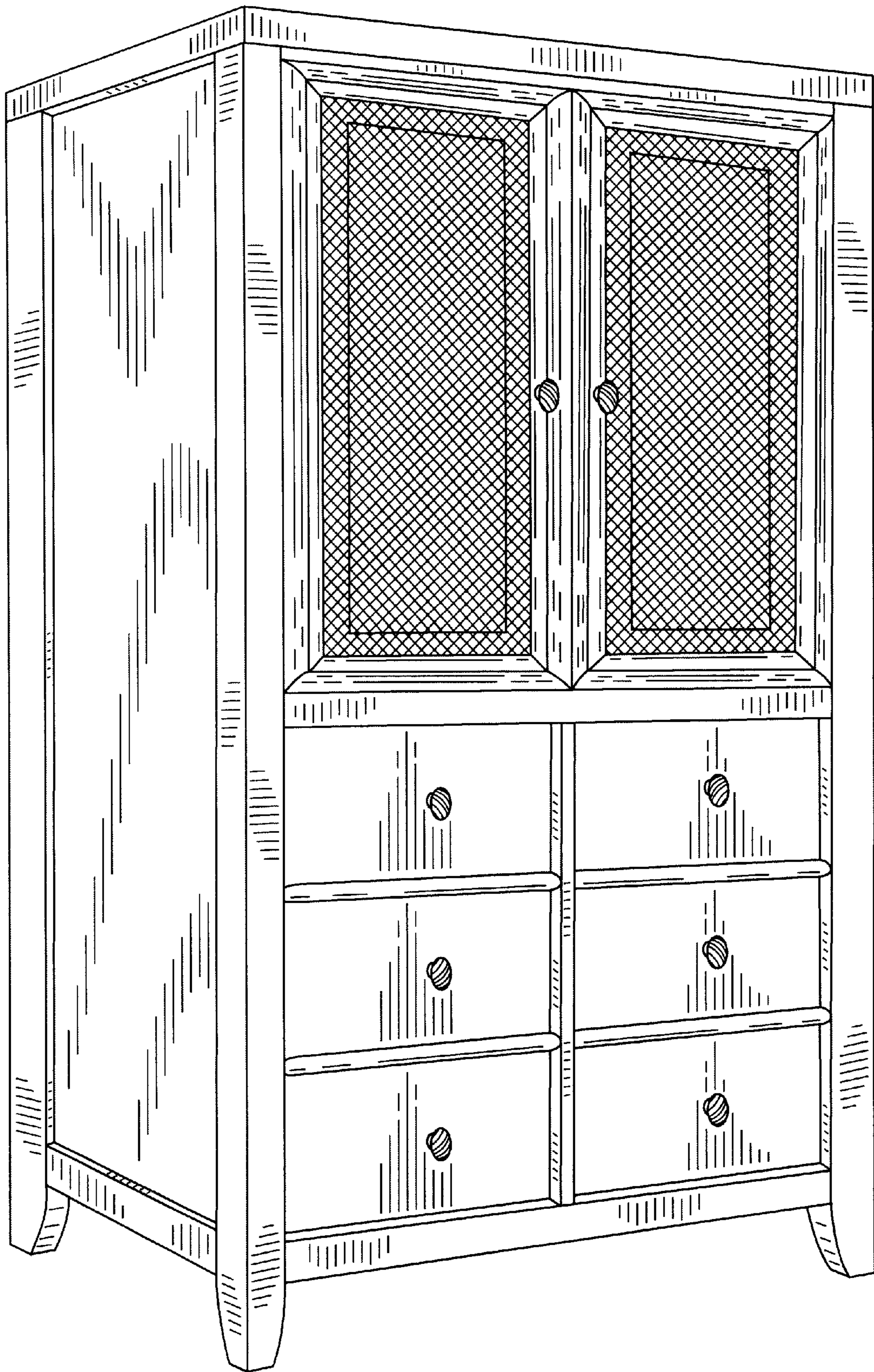

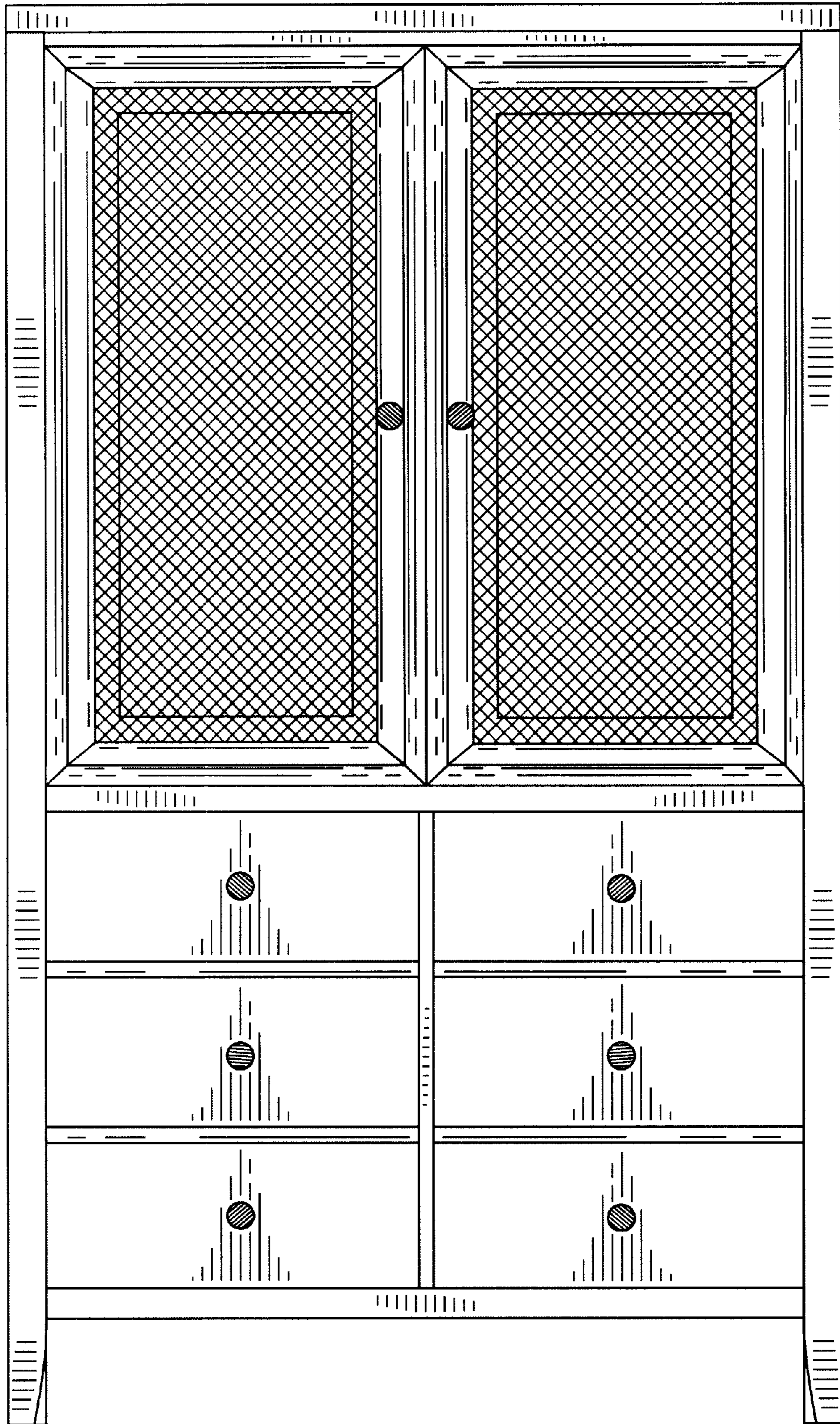

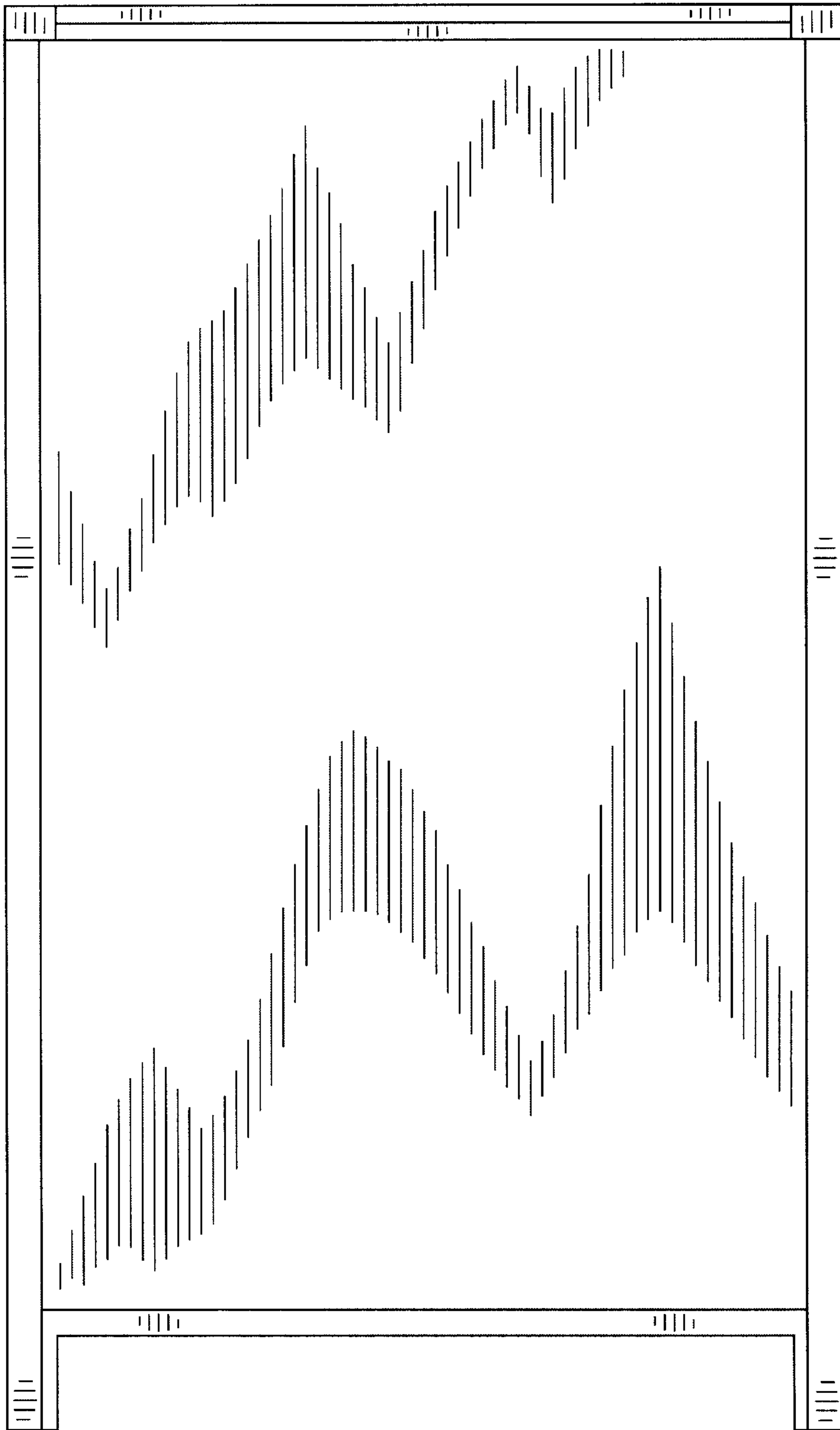

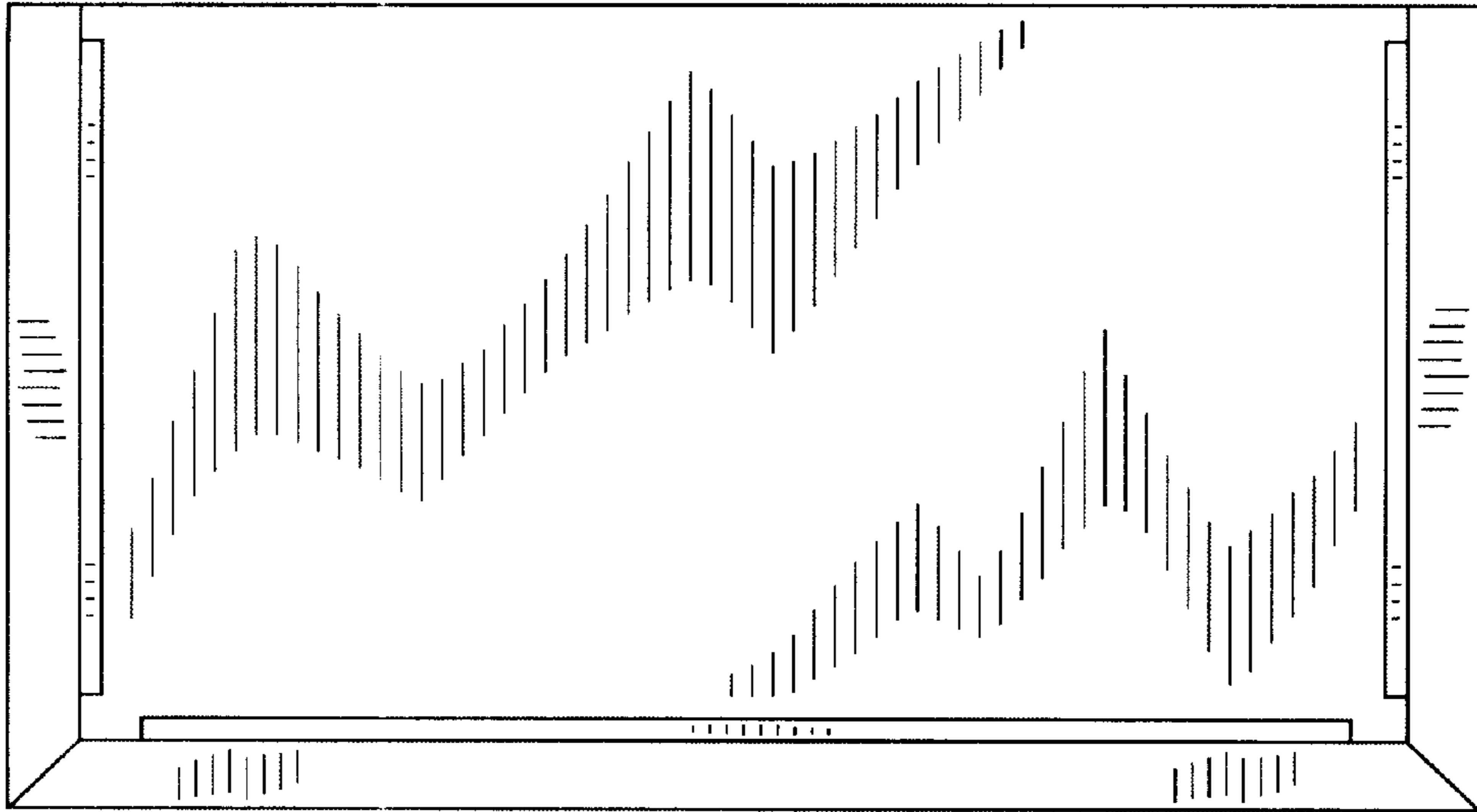

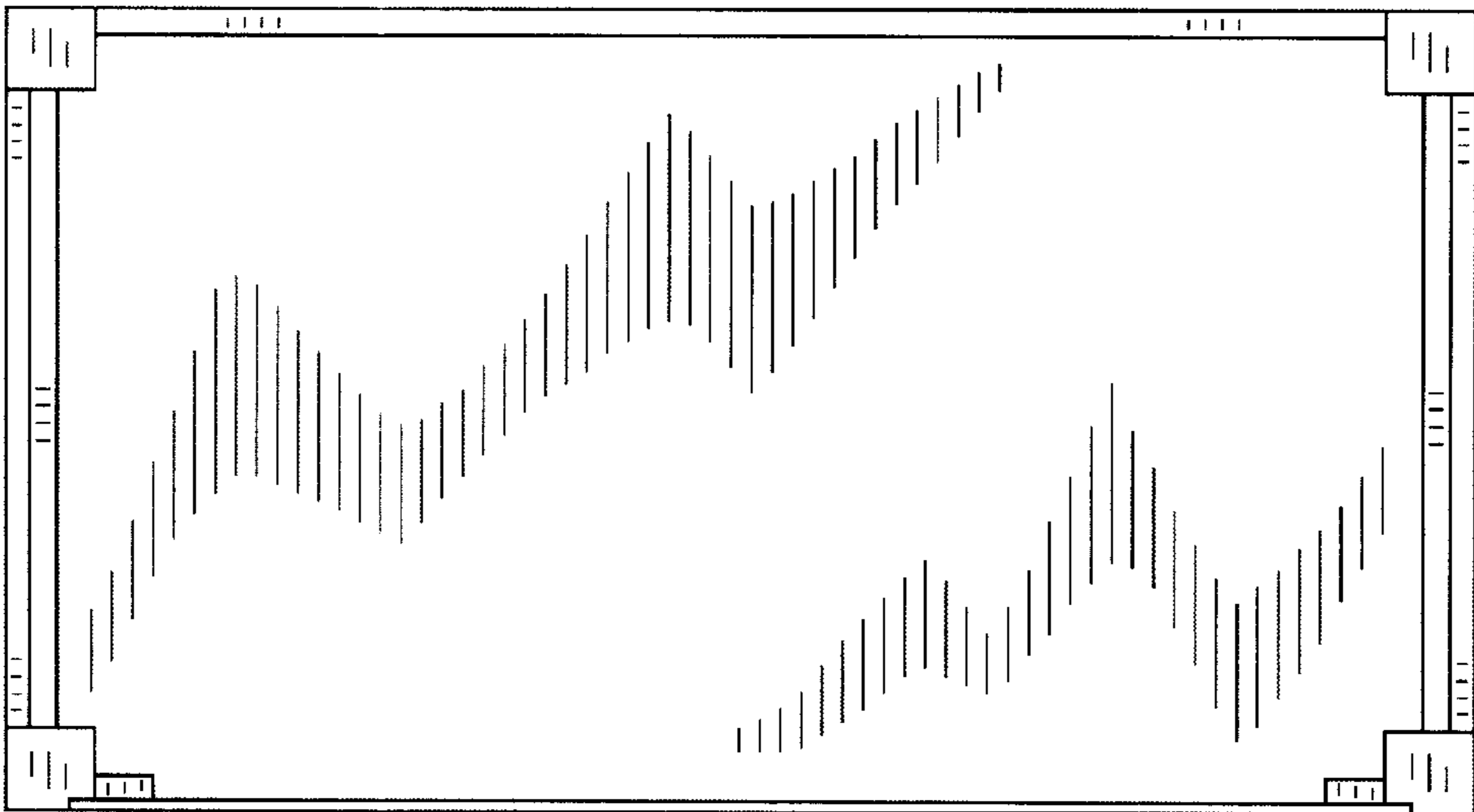

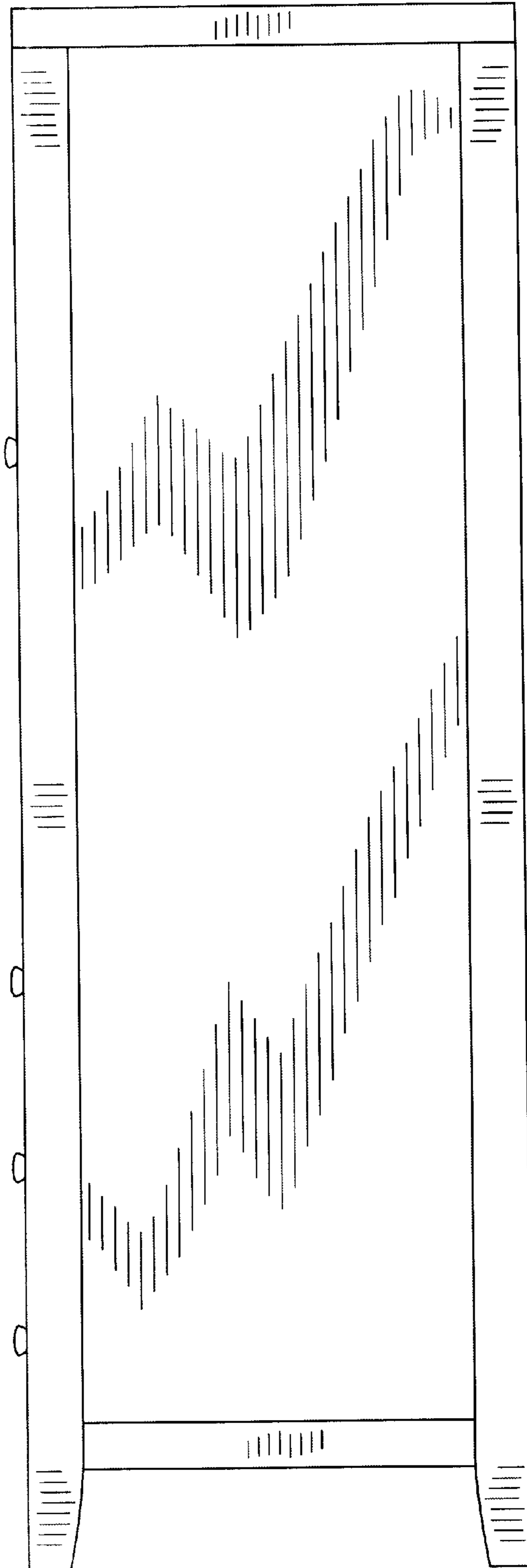

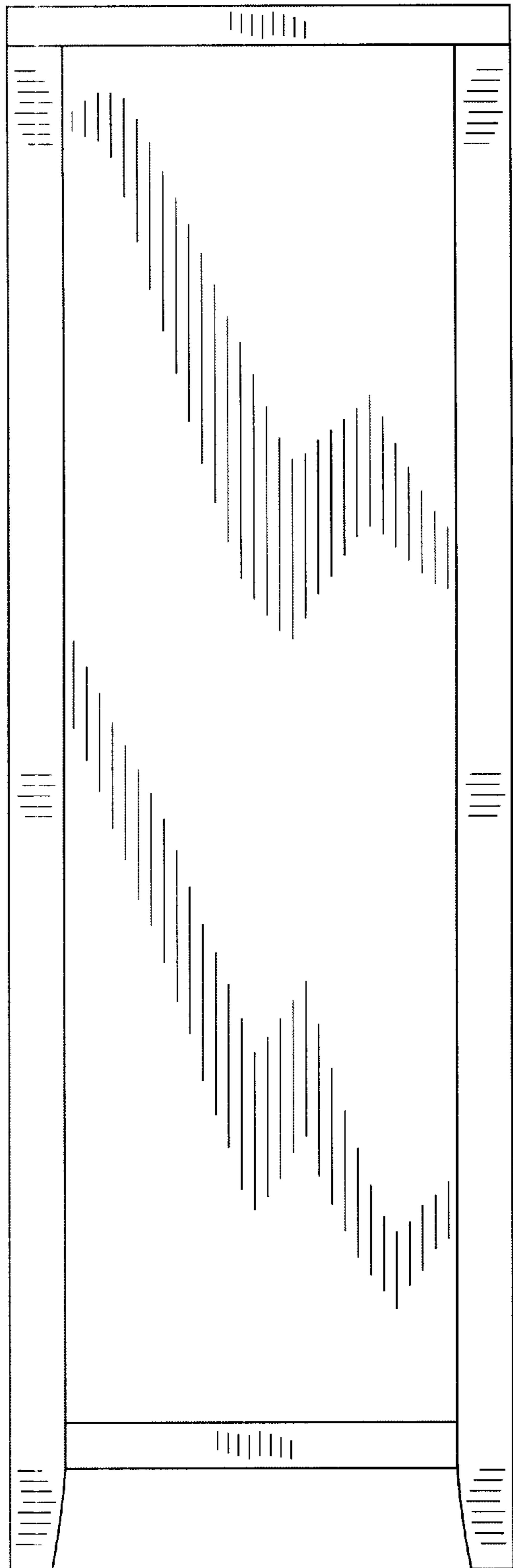
