(57) **CLAIM**

The ornamental design for a pocket knife, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a pocket knife according to the present invention, wherein the broken line portions of the pocket knife are for illustrative purposes only and form no part of the claimed design.

FIG. 2 is a left side view of the pocket knife shown in FIG. 1.

FIG. 3 is a top plan view of the pocket knife shown in FIG. 1.

FIG. 4 is a bottom plan view of the pocket knife shown in FIG. 1.

FIG. 5 is a rear view of the pocket knife shown in FIG. 1.

FIG. 6 is a right side view of an alternative embodiment of the pocket knife shown in FIGS. 1-5, wherein the broken line portions of the pocket knife are for illustrative purposes only and form no part of the claimed design.

FIG. 7 is a left side view of the pocket knife shown in FIG. 6.

FIG. 8 is a top plan view of the pocket knife shown in FIG. 6.

FIG. 9 is a bottom plan view of the pocket knife shown in FIG. 6.

FIG. 10 is a rear view of the pocket knife shown in FIG. 6.

FIG. 11 is a top plan view of an alternative embodiment of the pocket knife shown in FIG. 1.

FIG. 12 is a bottom plan view of an alternative embodiment of the pocket knife shown in FIG. 1.

FIG. 13 is a rear view of an alternative embodiment of the pocket knife shown in FIG. 1.

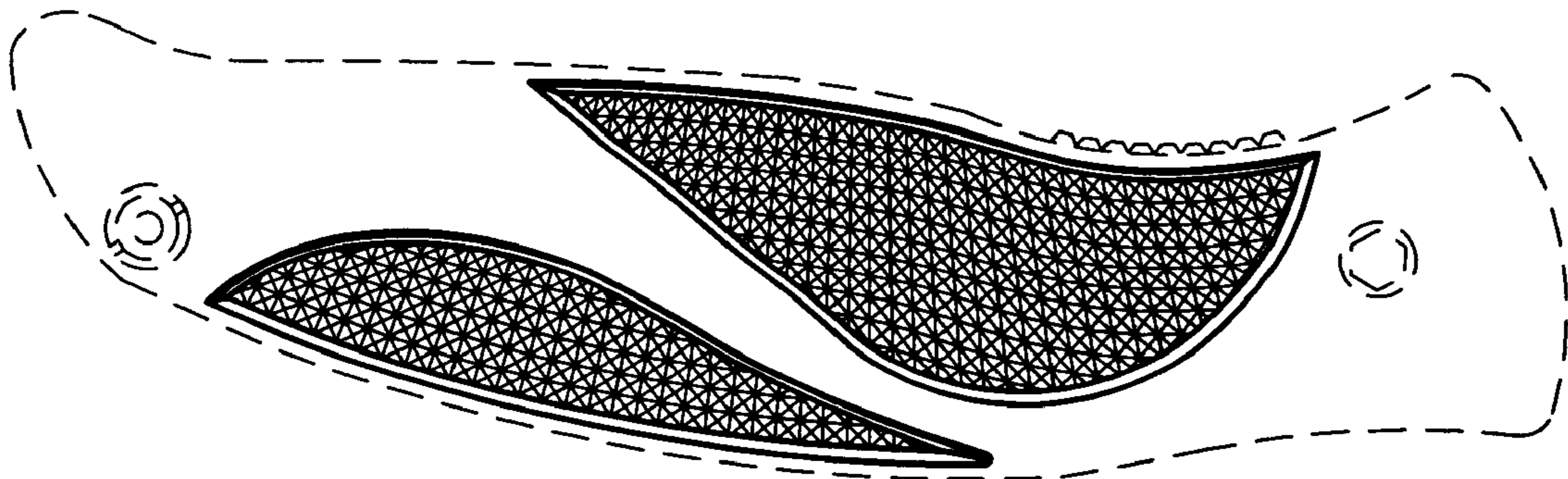
FIG. 14 is a top plan view of an alternative embodiment of the pocket knife shown in FIG. 6.

FIG. 15 is a bottom plan view of an alternative embodiment of the pocket knife shown in FIG. 6; and,

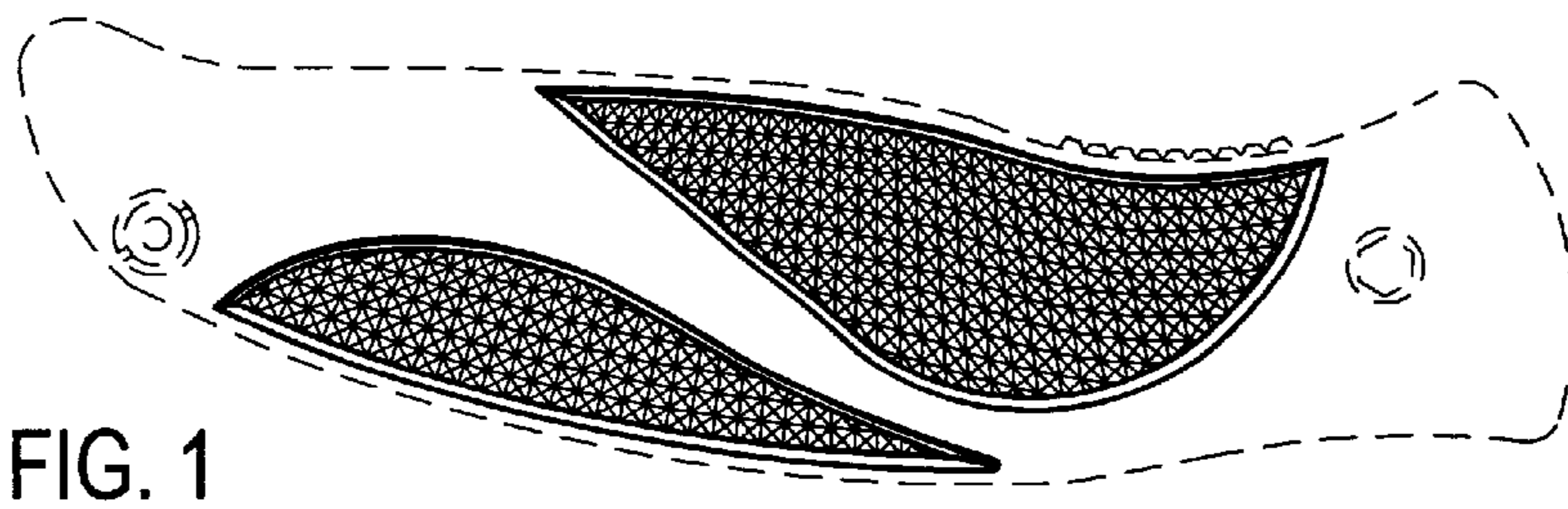

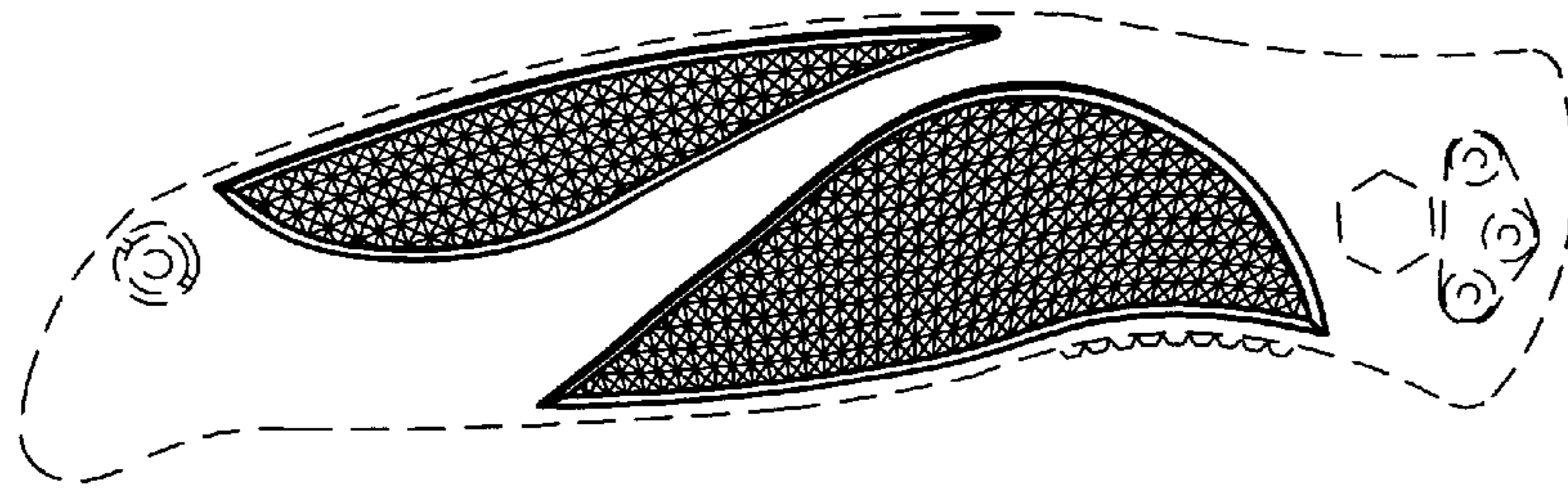

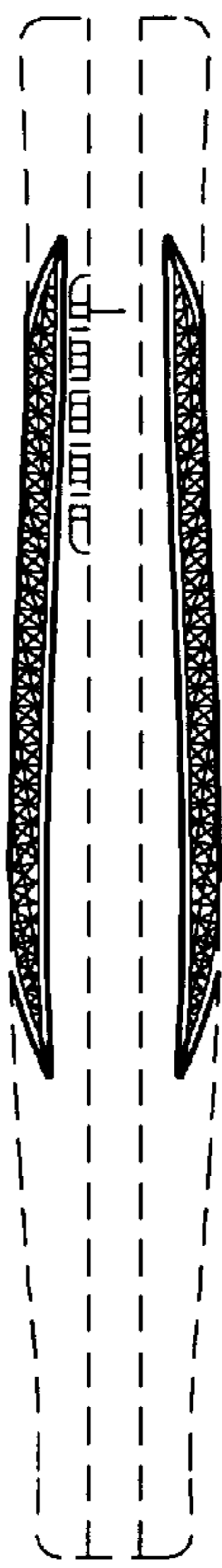

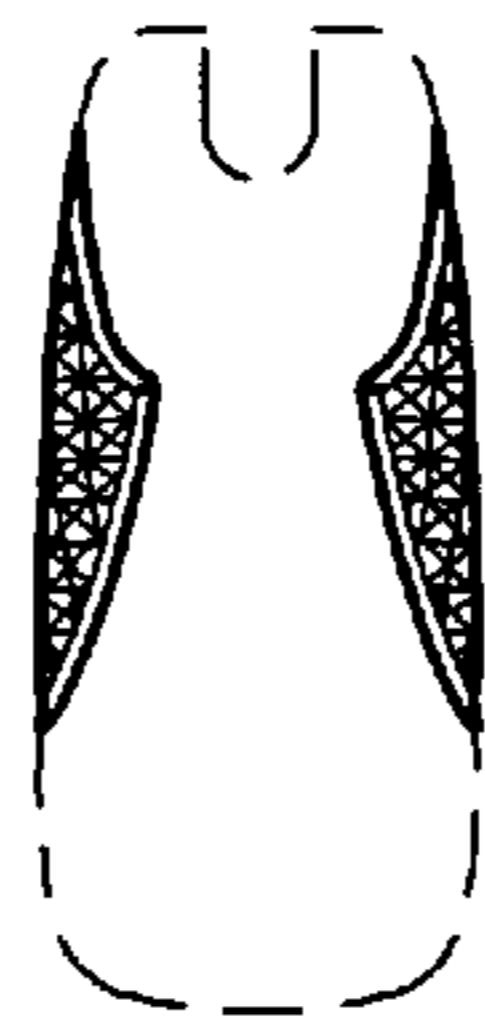

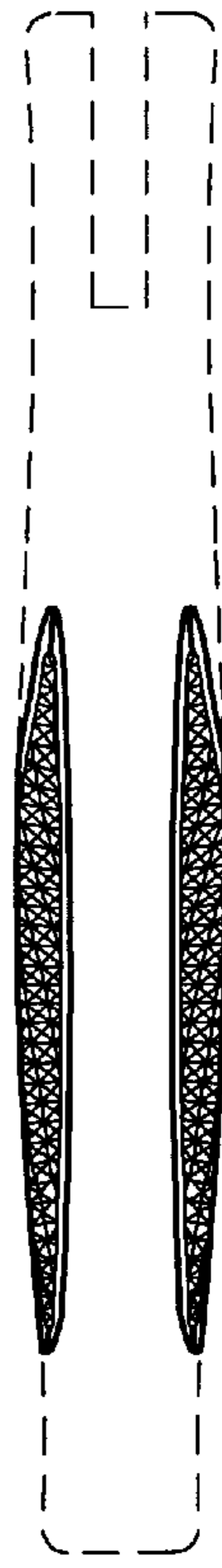

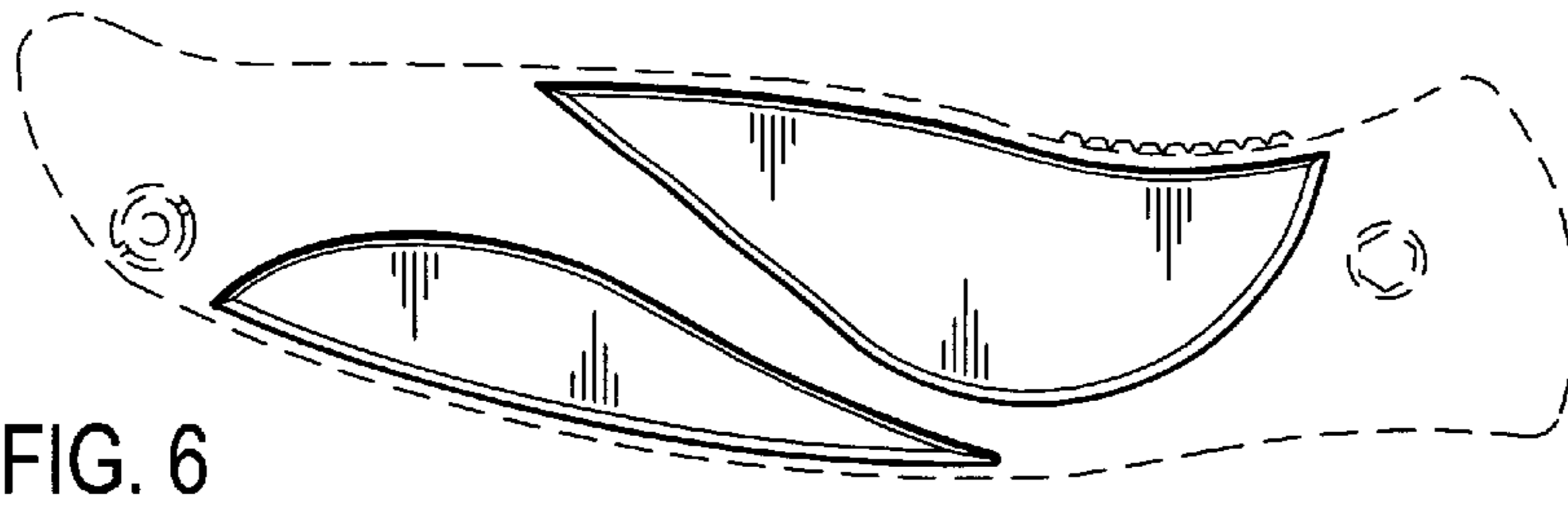

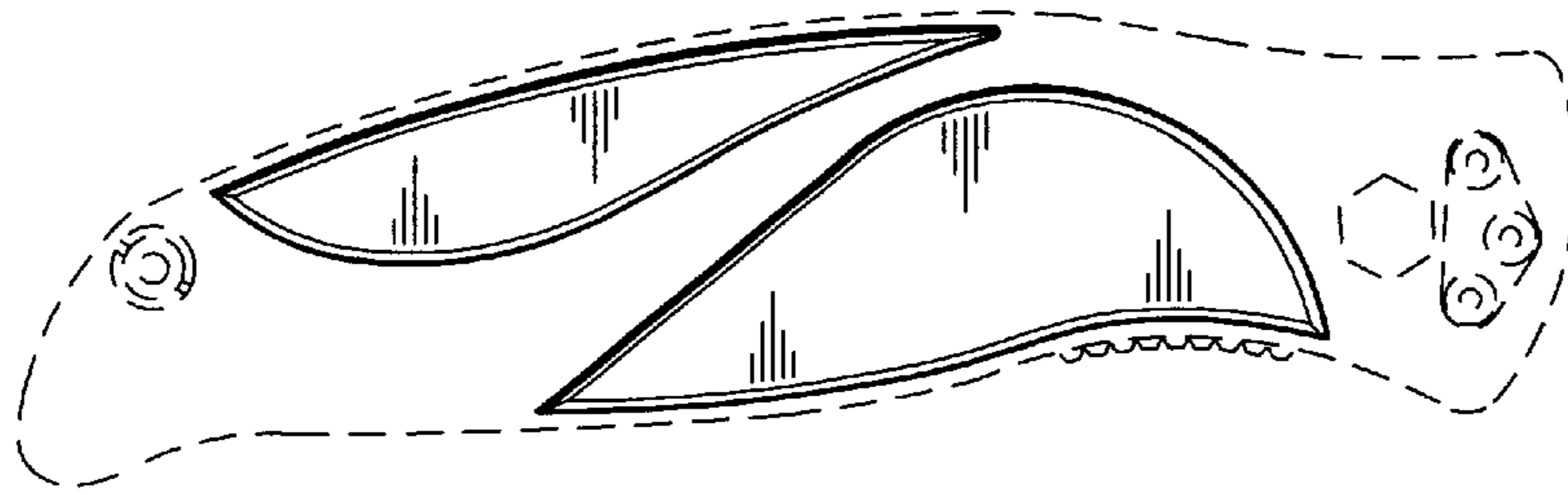

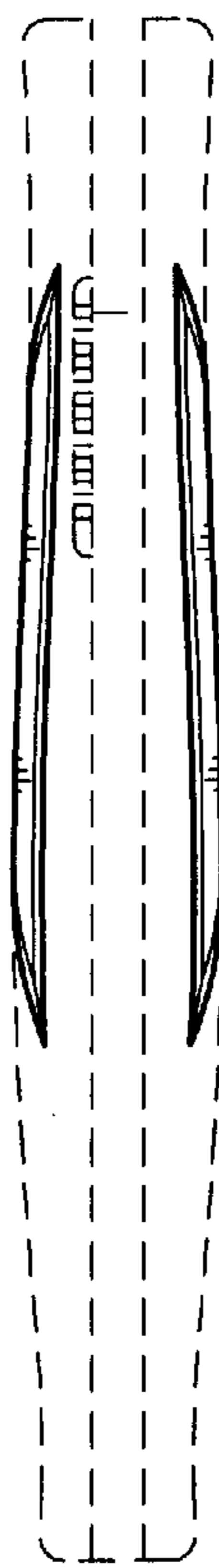

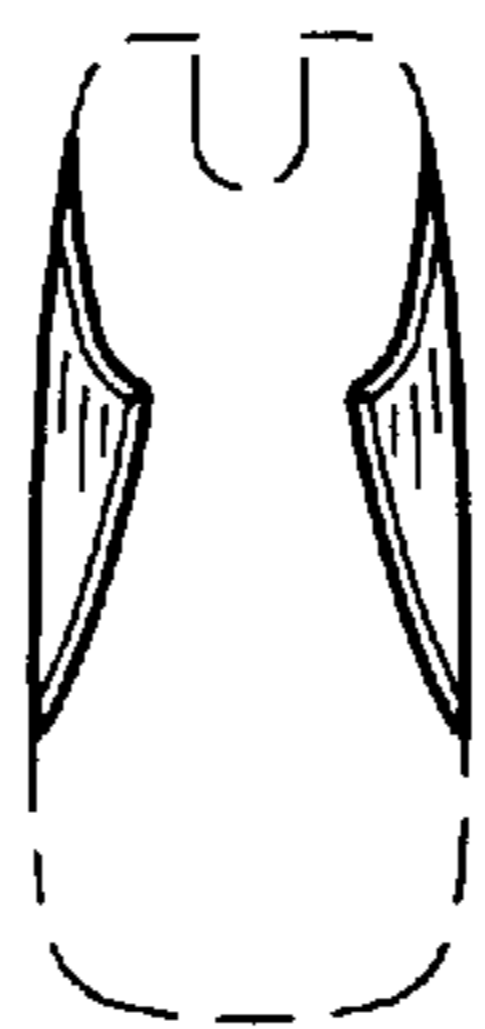

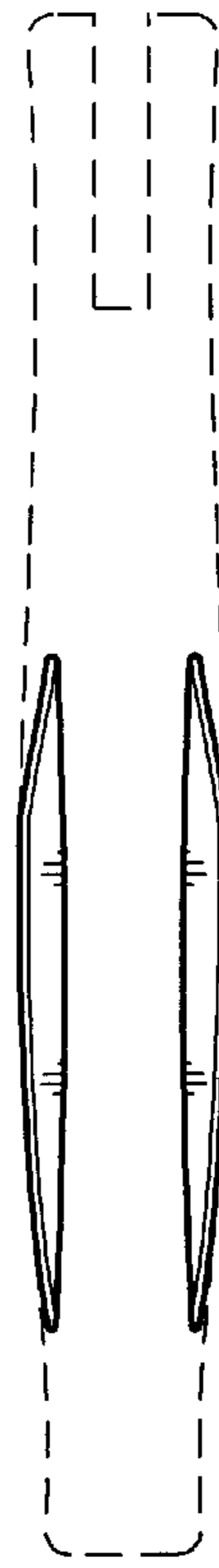

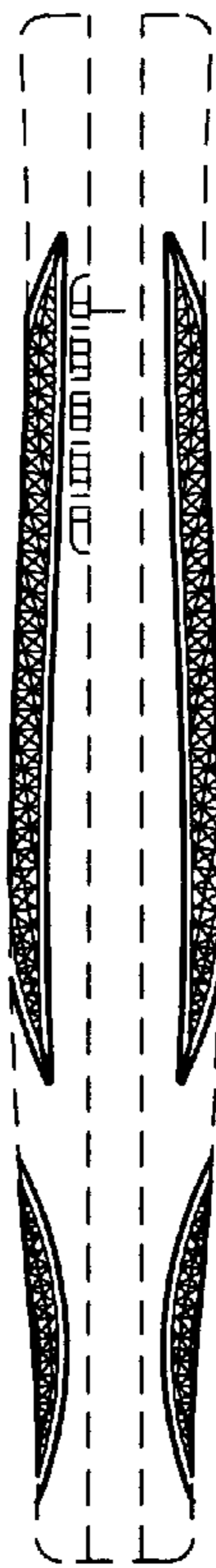

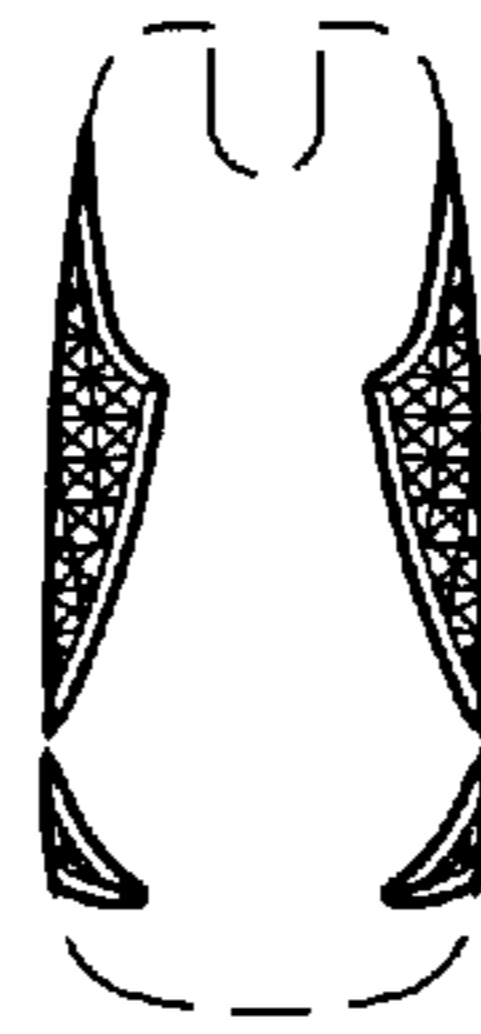

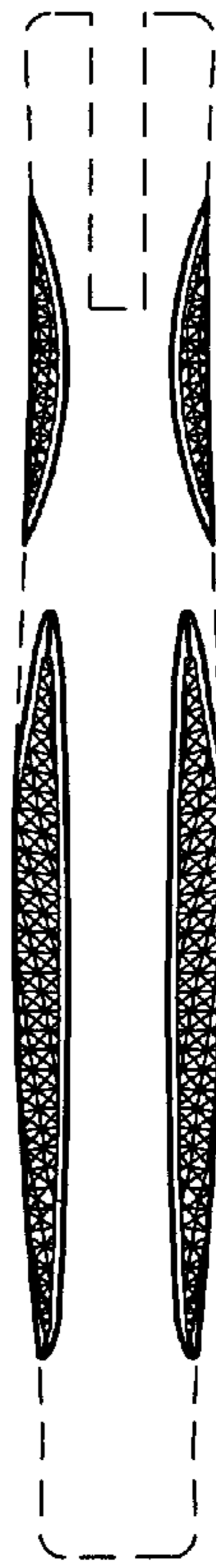

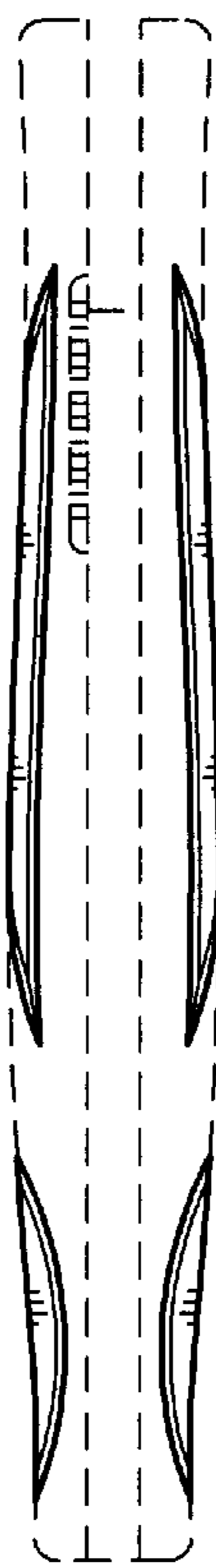
