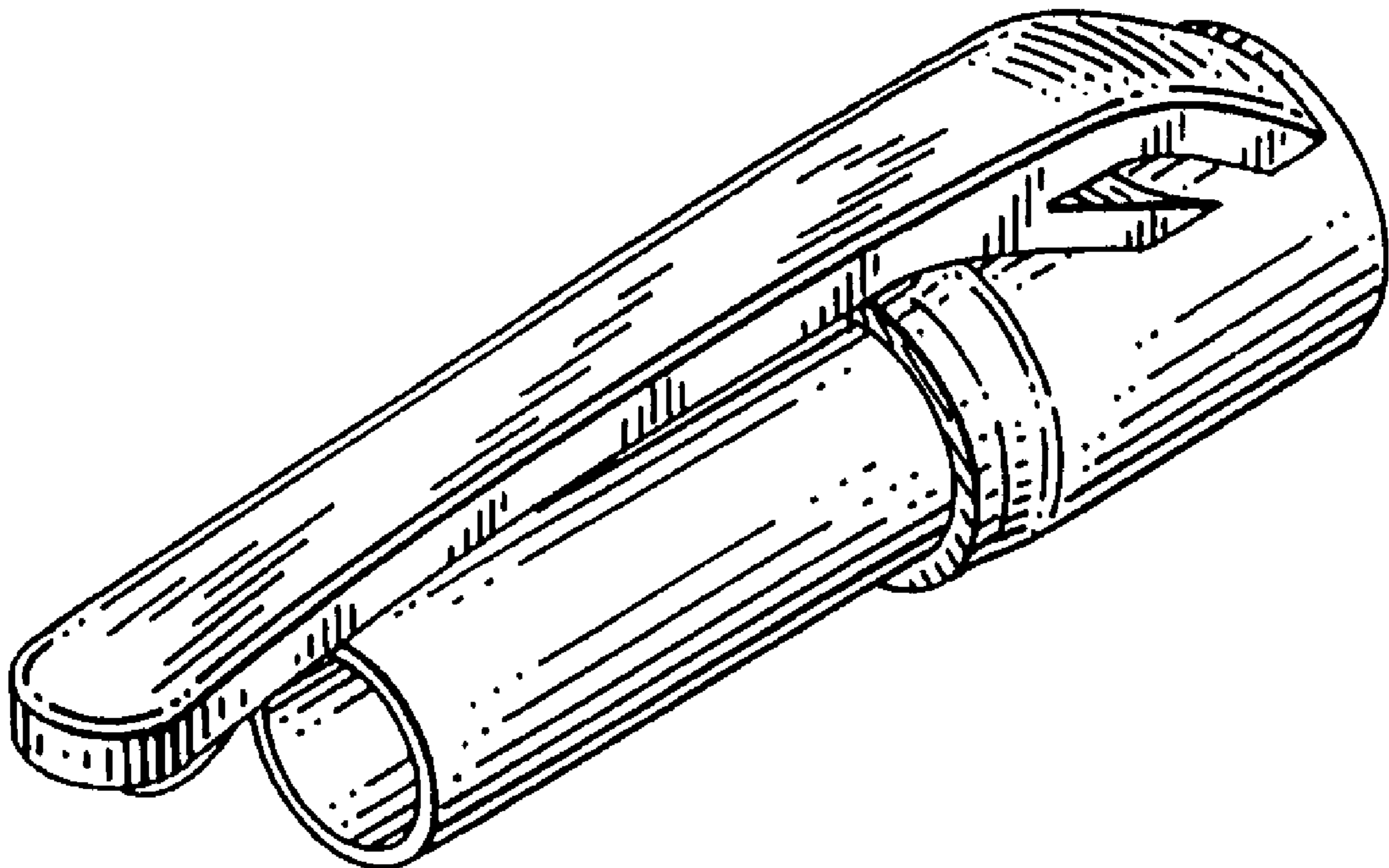
(57) **CLAIM**

The ornamental design for a clip for a writing instrument, as shown and described.

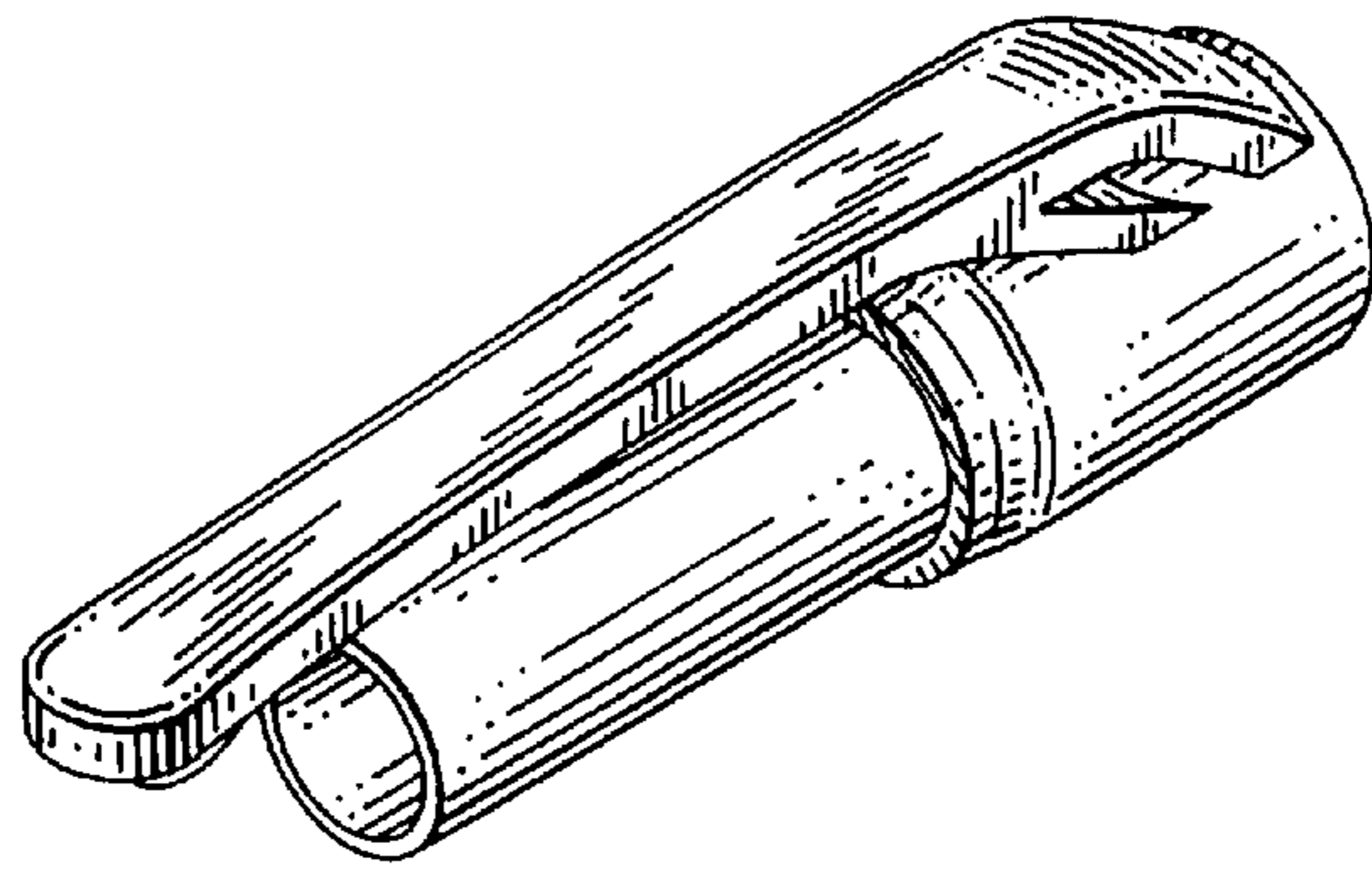
**DESCRIPTION**

 FIG. 6 is a right side elevational view thereof, the left side being the mirror image thereof.

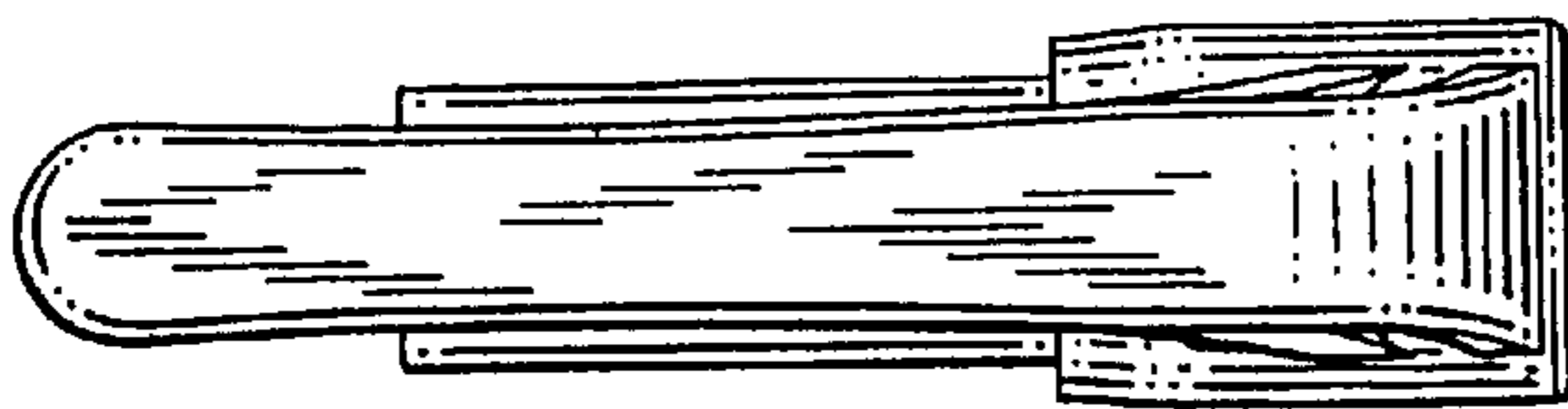

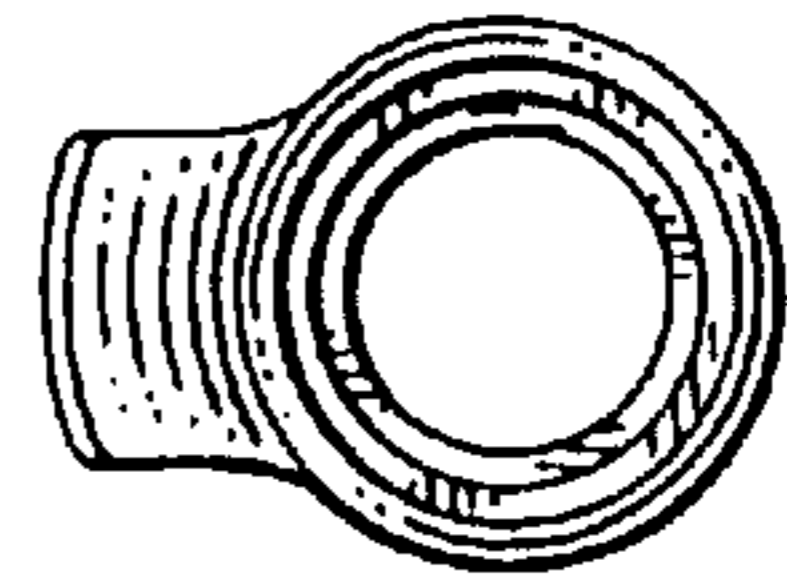

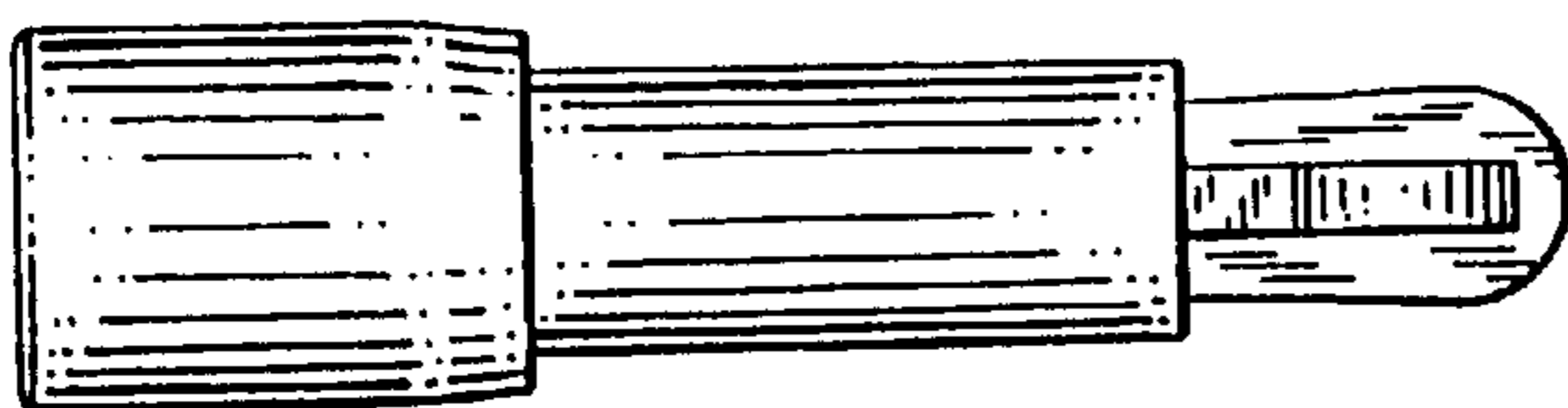

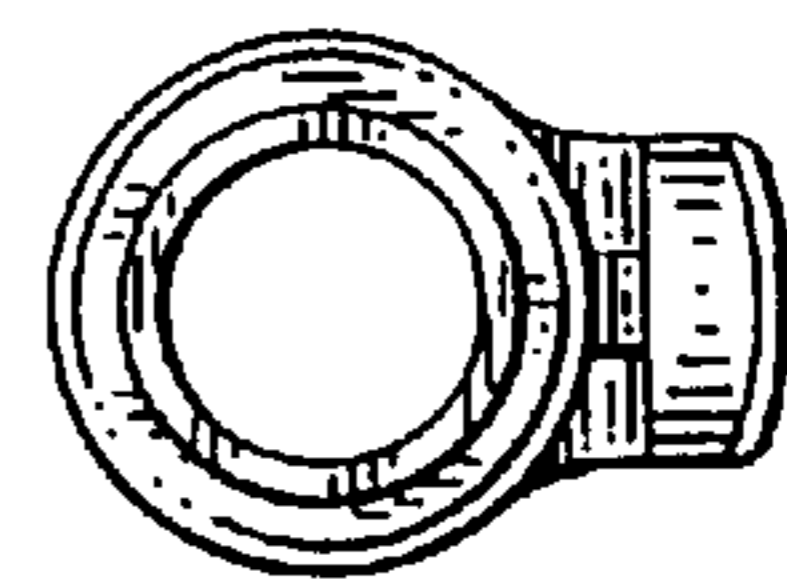
