DESCRIPTION

FIG. 1 is a perspective view of a exterior door with curve to glass in accordance with the present invention;

FIG. 2 is a front elevational view of the exterior door with curve to glass of FIG. 1;

FIG. 3 is a top plan view of the exterior door with curve to glass of FIG. 1;

FIG. 4 is a side elevational view of the exterior door with curve to glass in FIG. 1, the other side being identical;

FIG. 5 is an enlarged fragmentary perspective view illustrating a corner of the exterior door with curve to glass of FIG. 1; and,

FIG. 6 is a view, taken along line 6—6 of FIG. 2.

Neither the bottom nor the back have been illustrated. They are unadorned, shown in broken lines and not part of the design. Only portions of the top and the sides of the door have been illustrated.

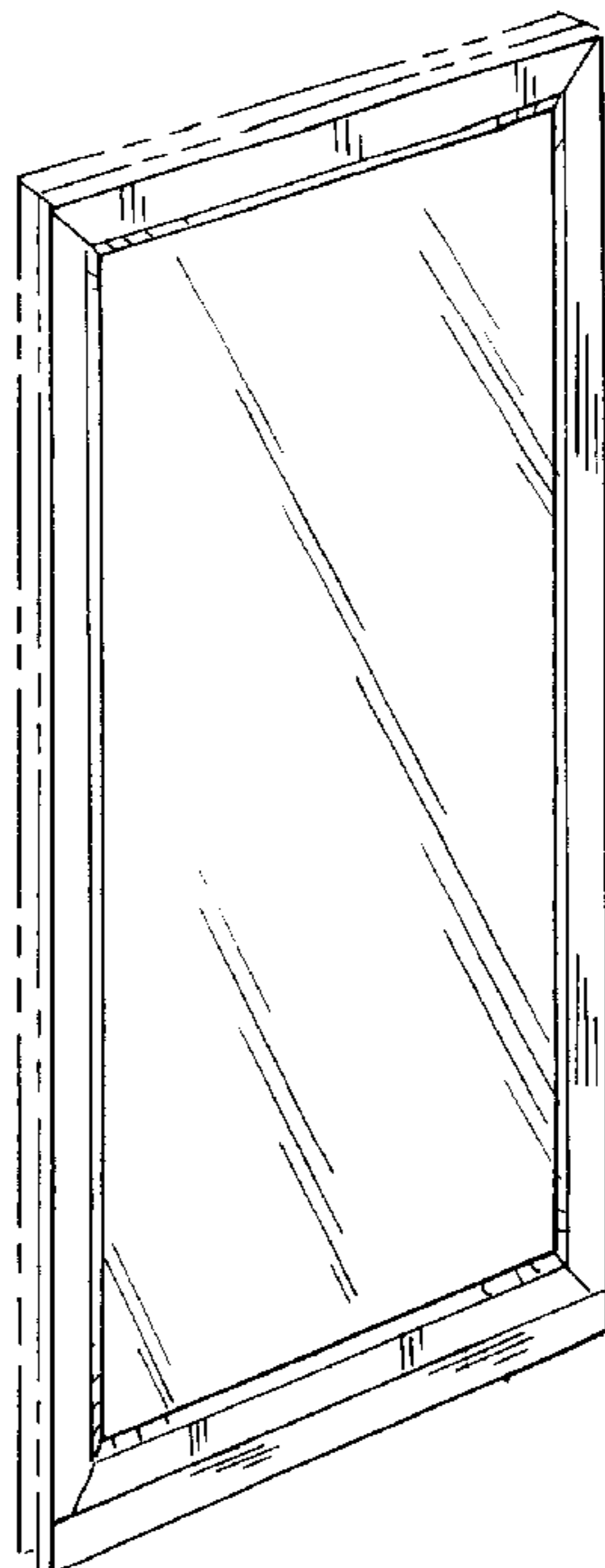

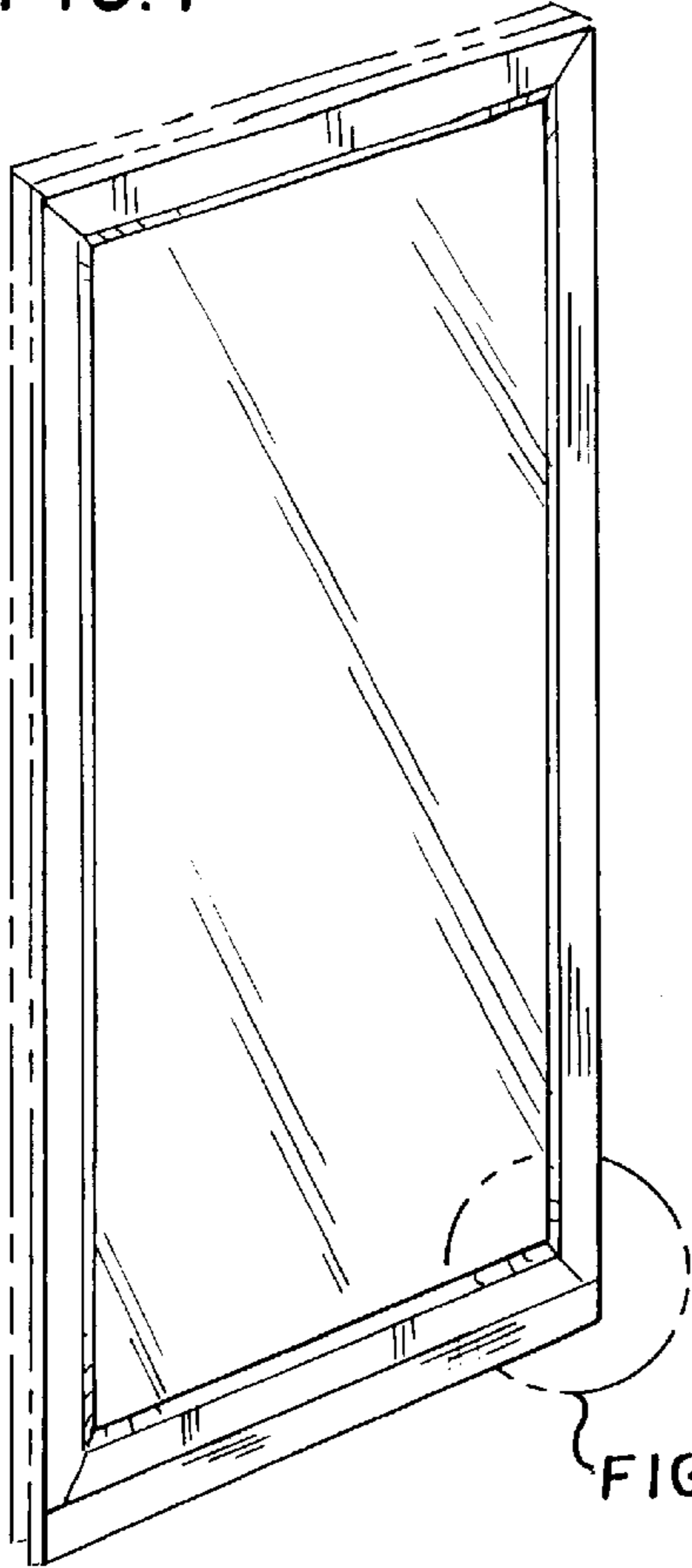

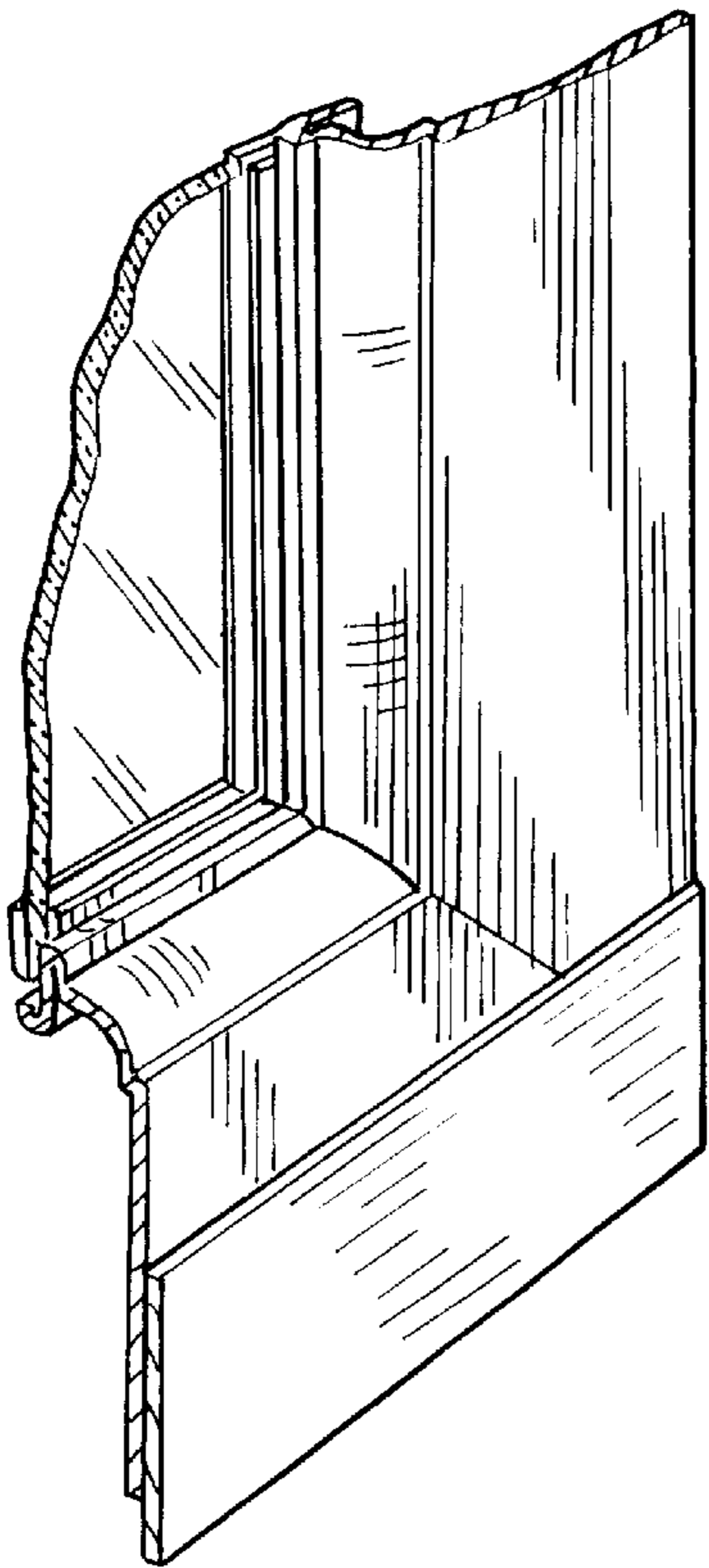
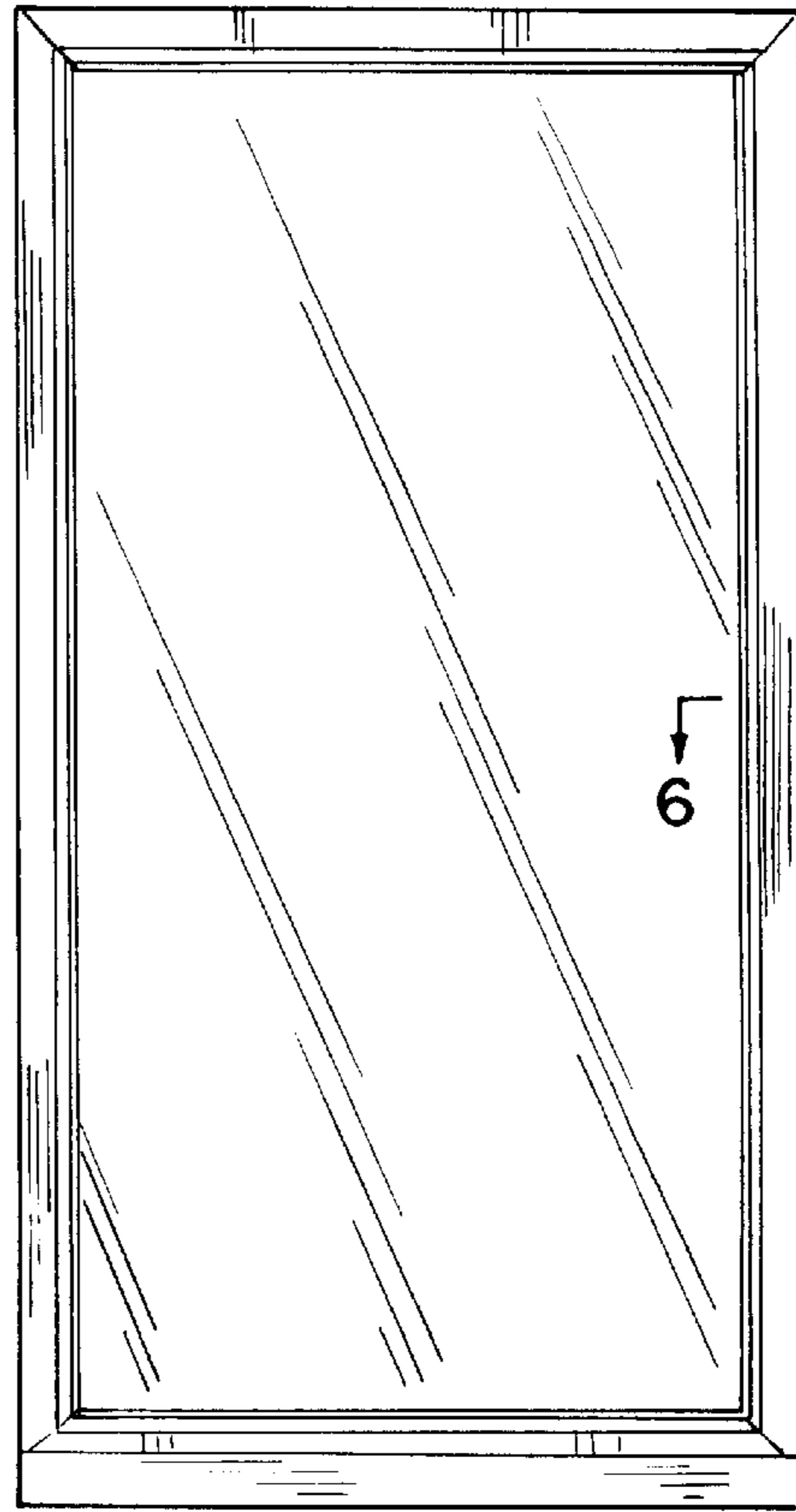

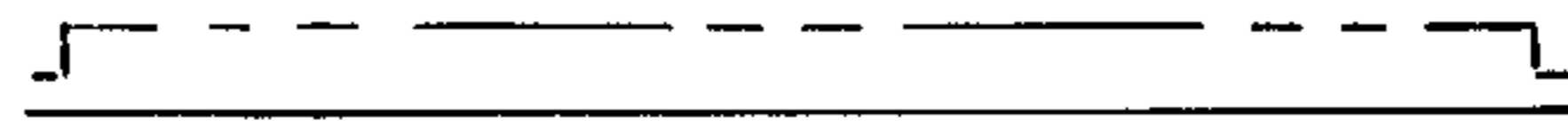
