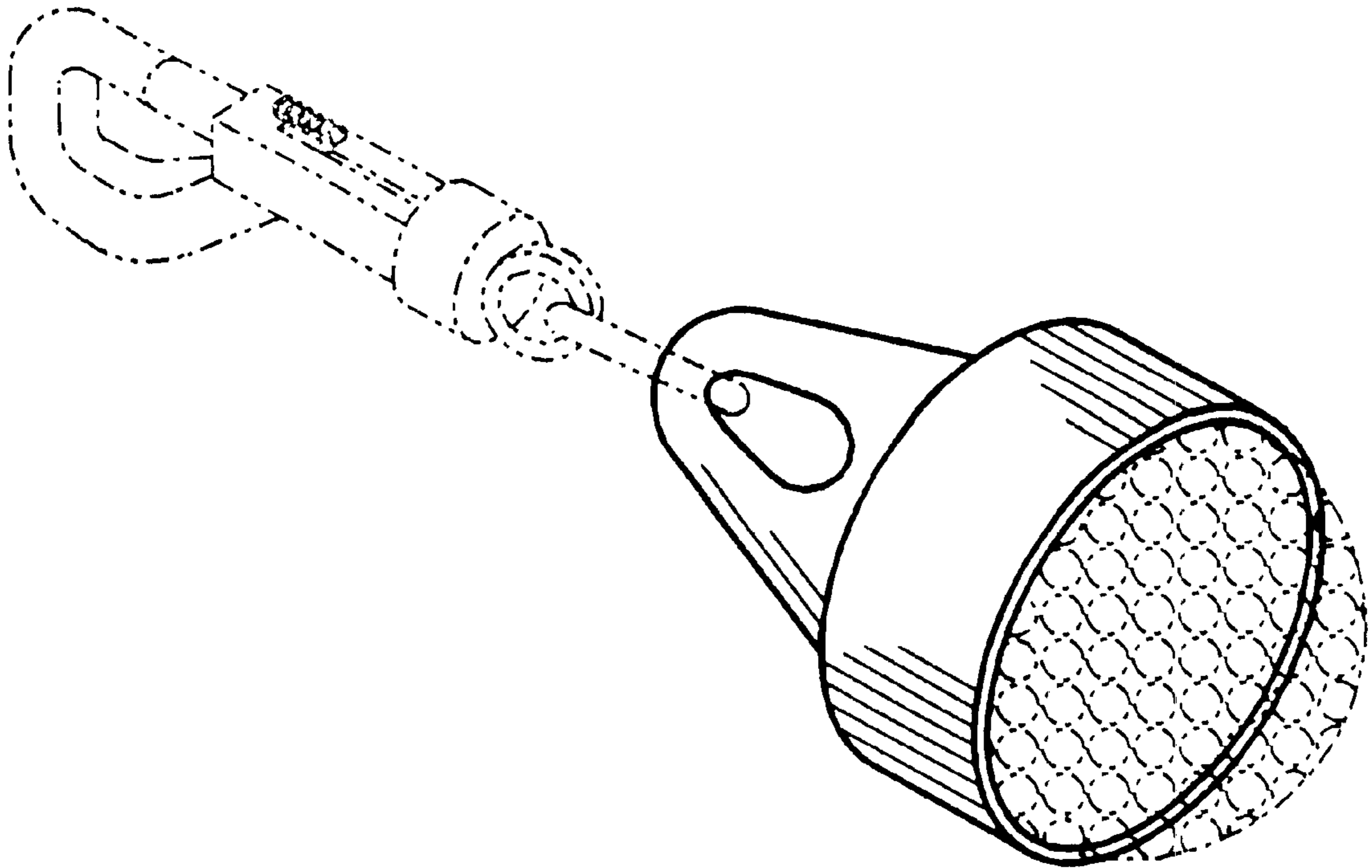
(57) **CLAIM**

The ornamental design for a pendently suspended holder for dispensing a golf ball, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pendently suspended holder for dispensing a golf ball showing my new design; FIG. 2 is a side view thereof, the unshown opposite side being of identical appearance; FIG. 3 is a front view thereof, the unshown rear view being of identical appearance; FIG. 4 is a top view thereof; and, FIG. 5 is a bottom view thereof. The broken line showing of a clip and golf ball is for illustrative purposes only and forms no part of the claimed design.

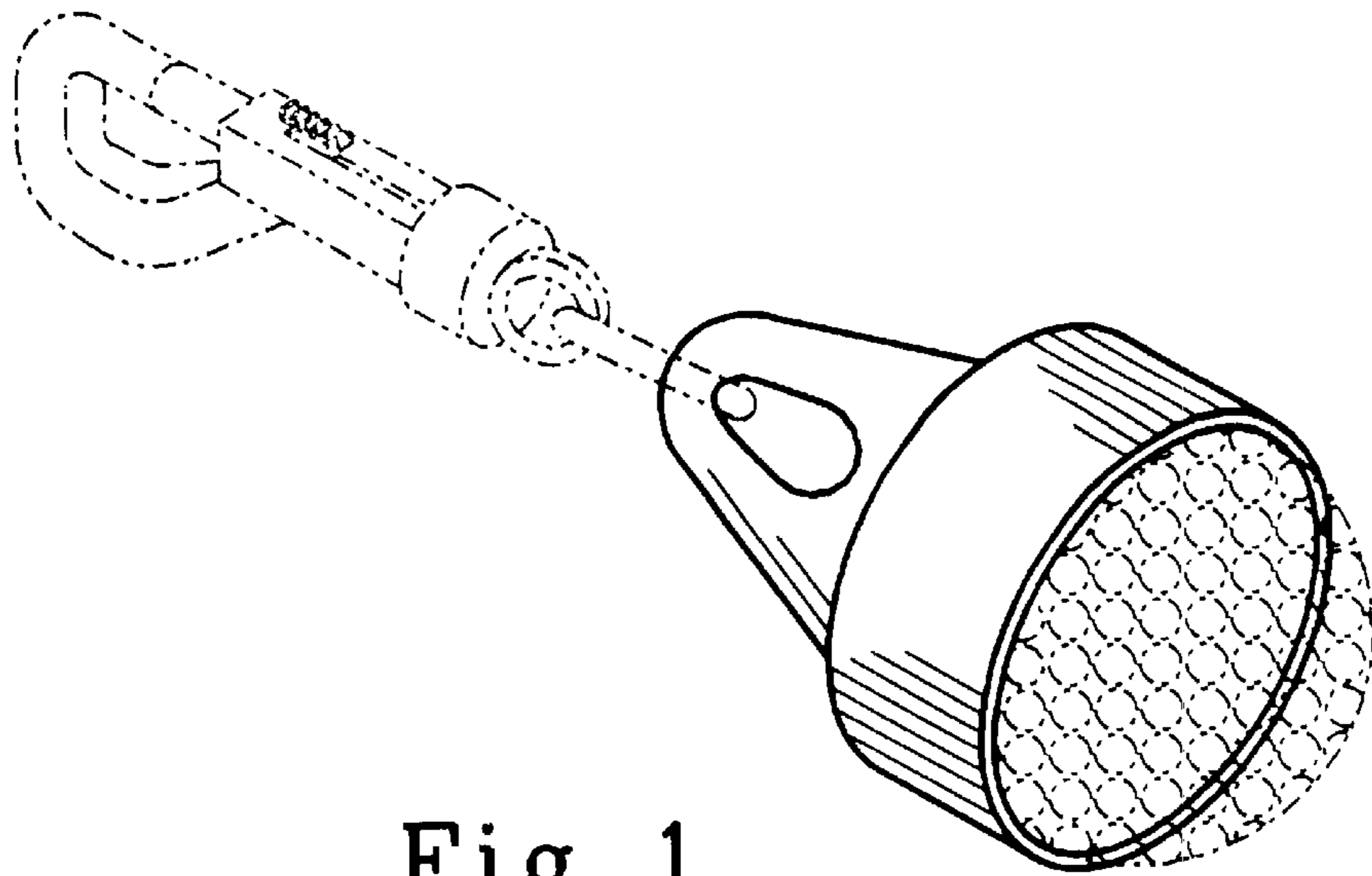

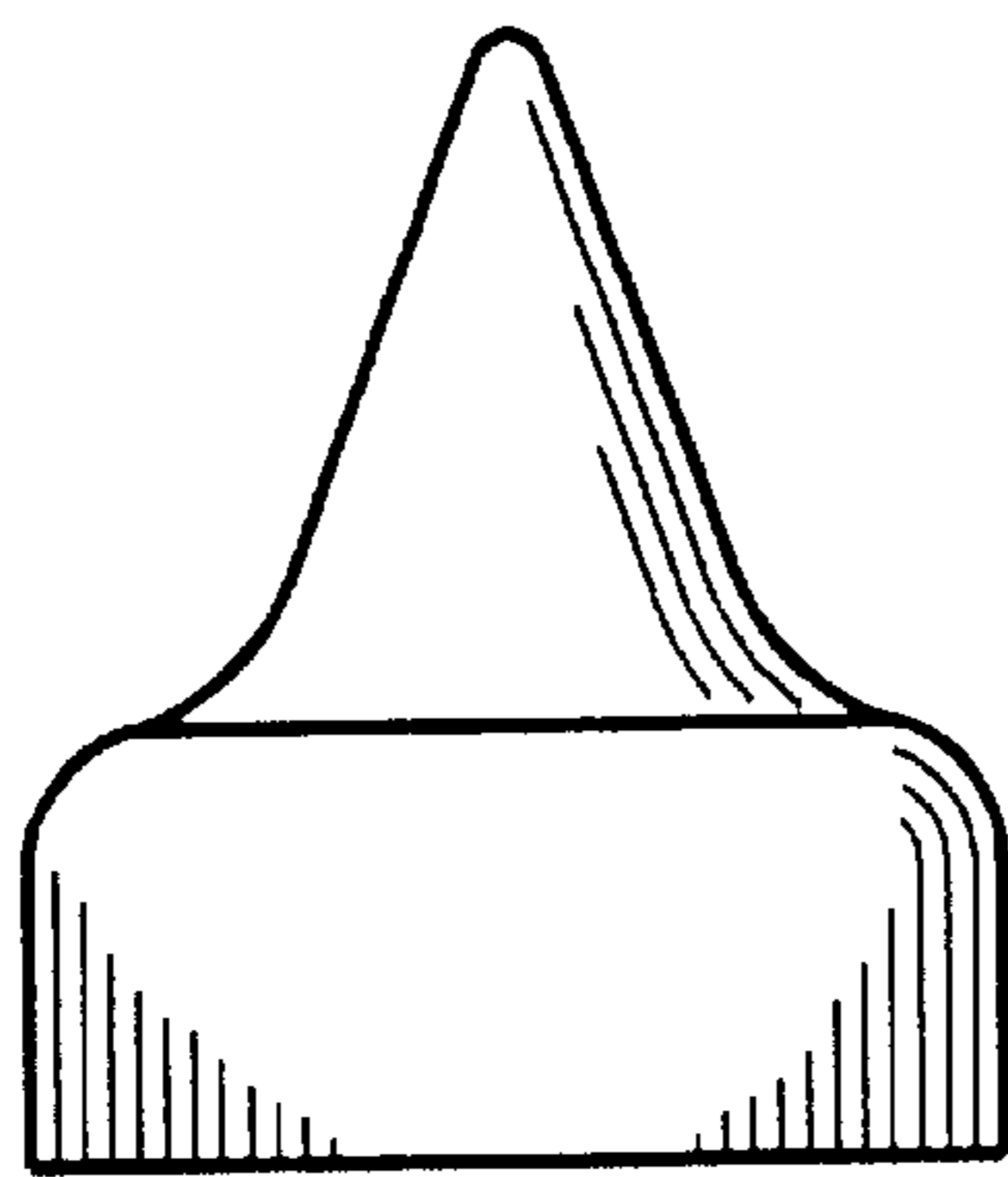

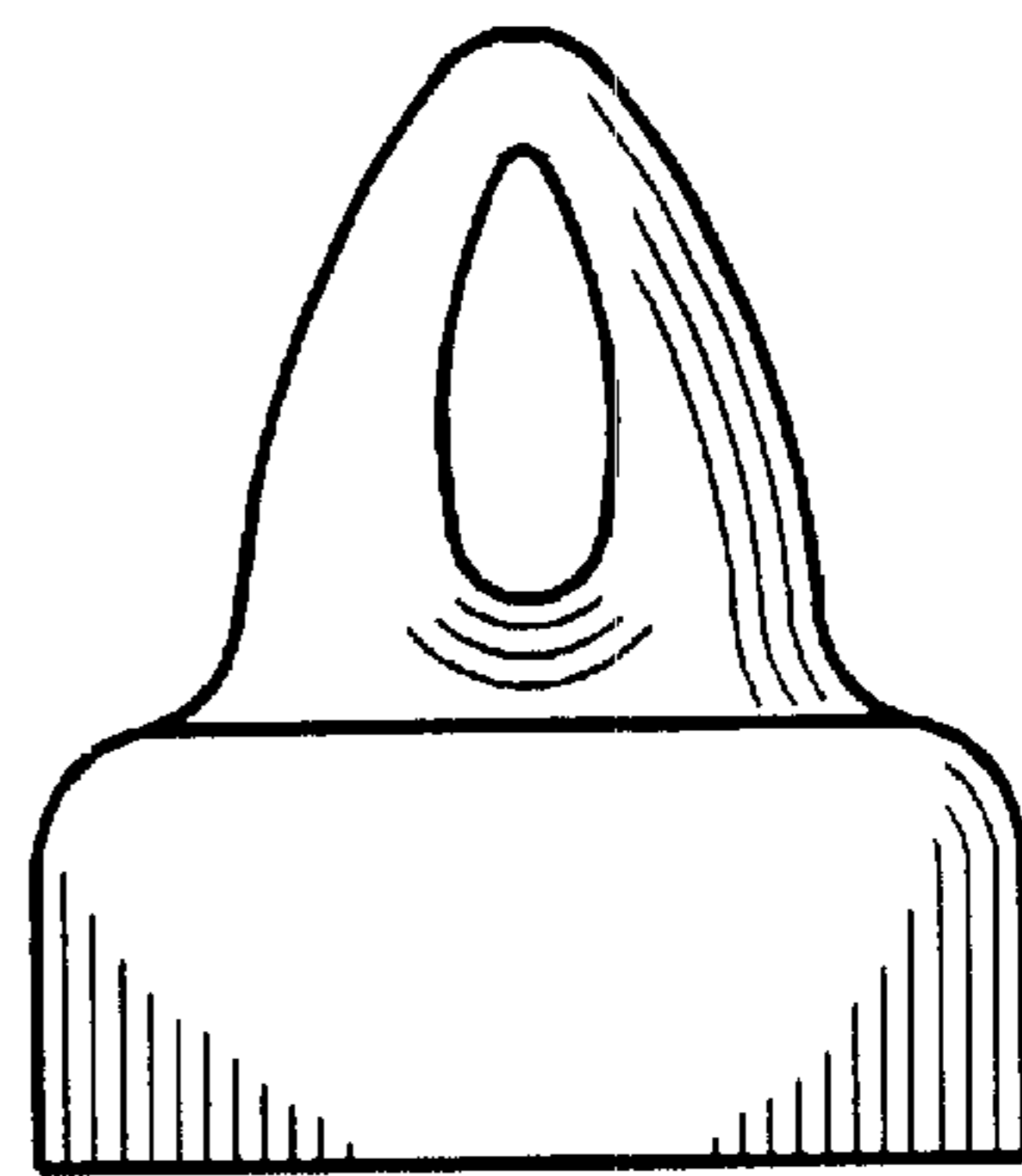

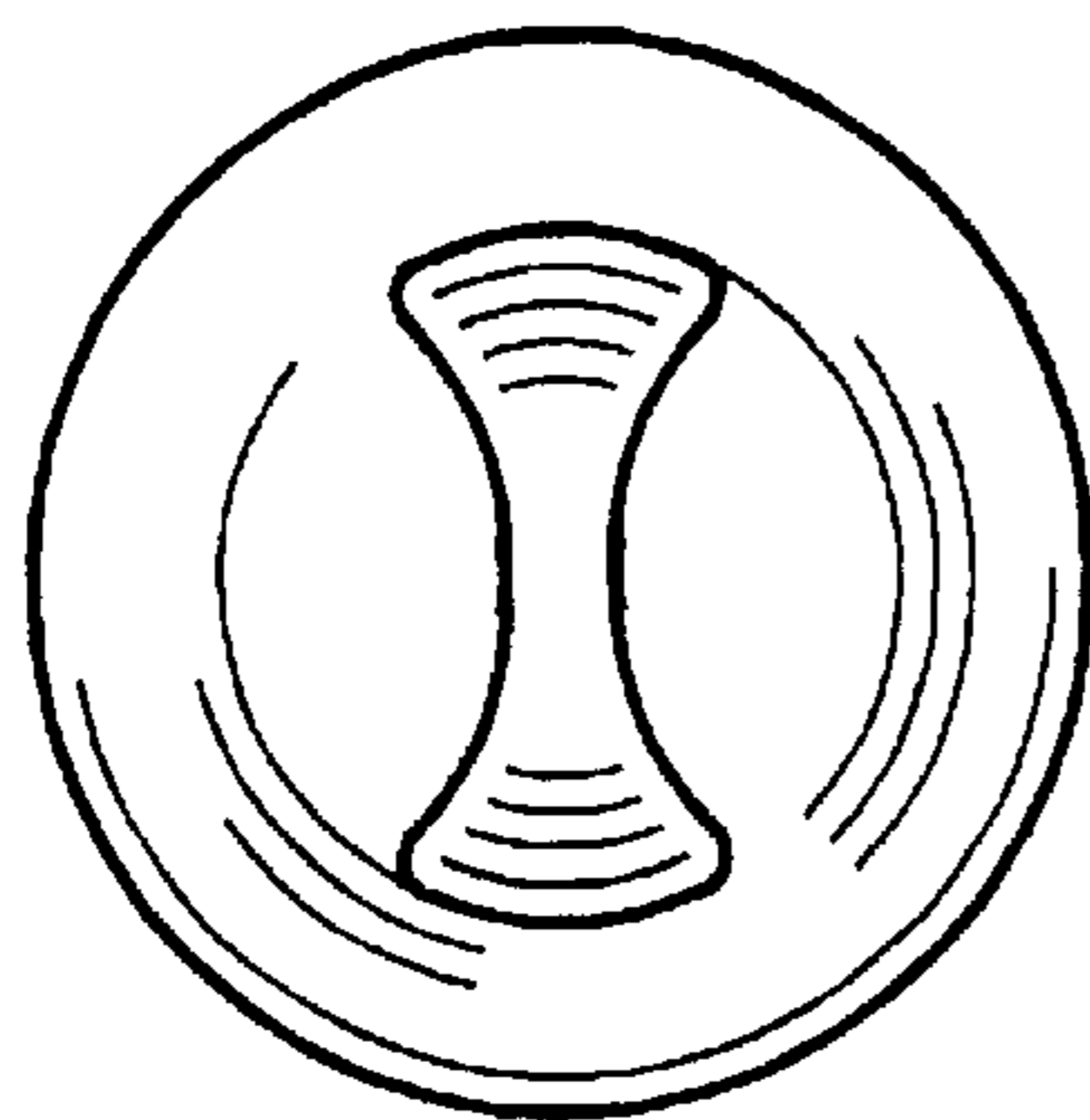

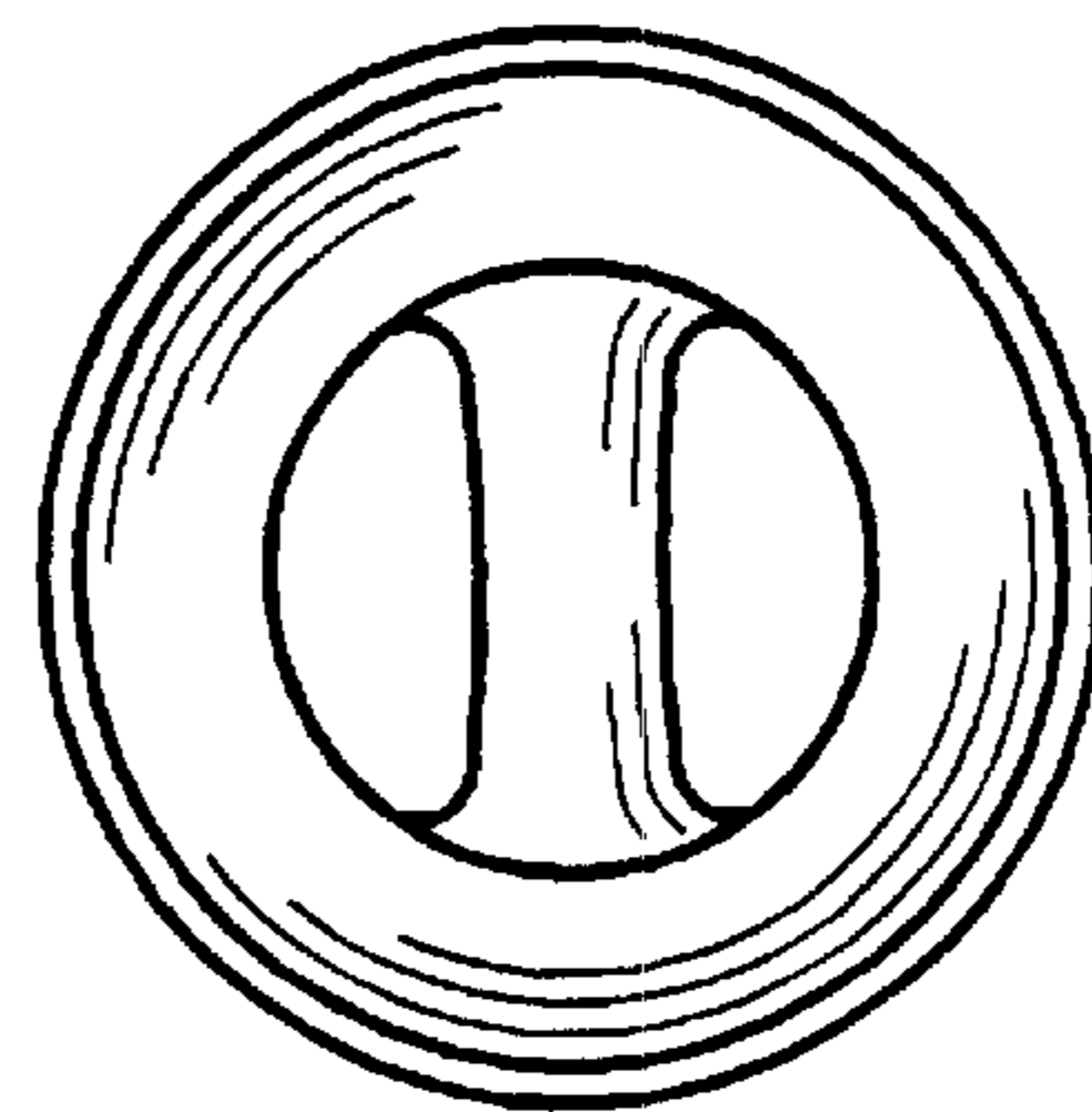
