The ornamental design for a blister pack, as shown.

**DESCRIPTION**

FIG. 1 is a top plan view of a blister back in folded condition showing our new design;

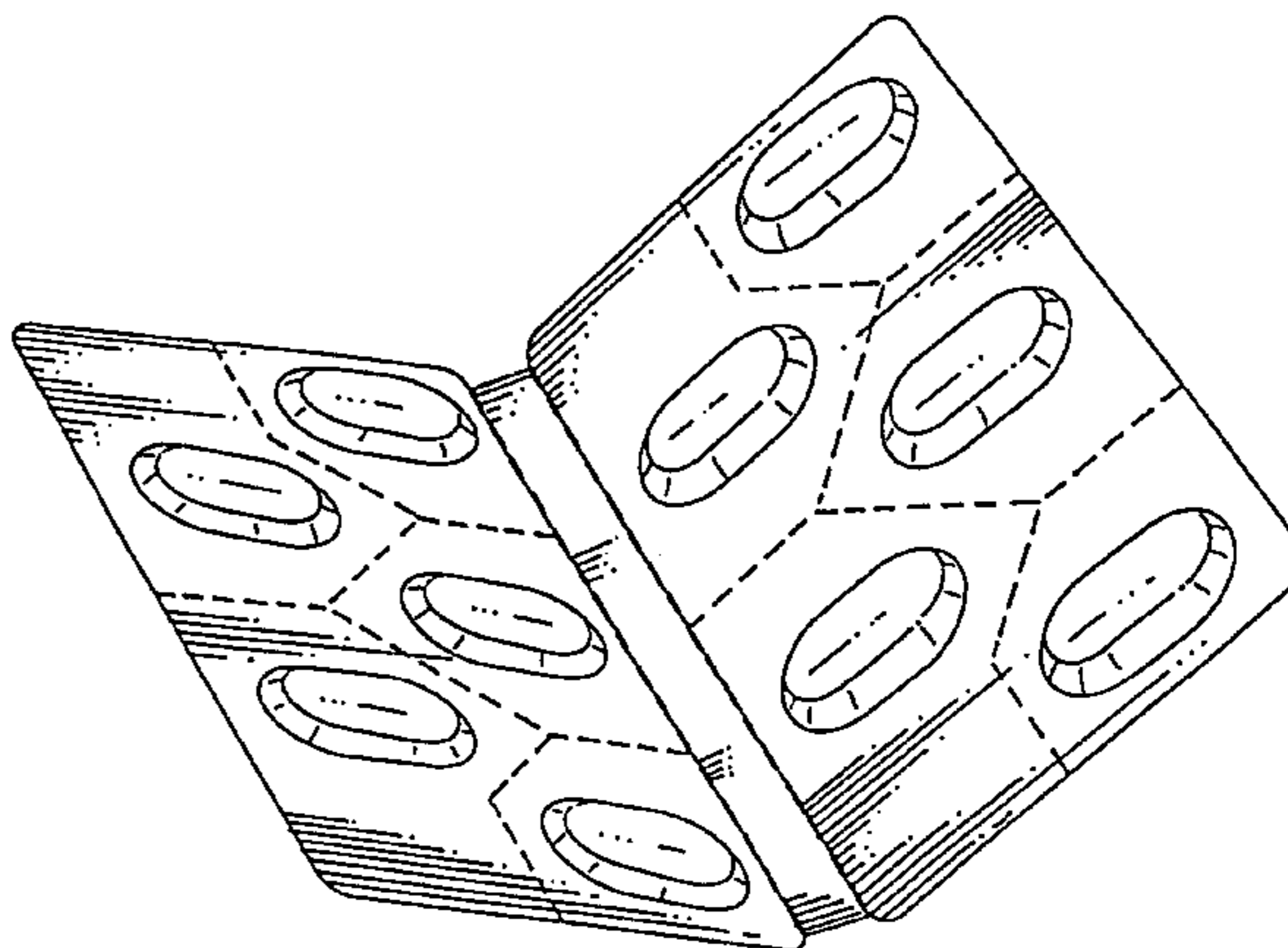
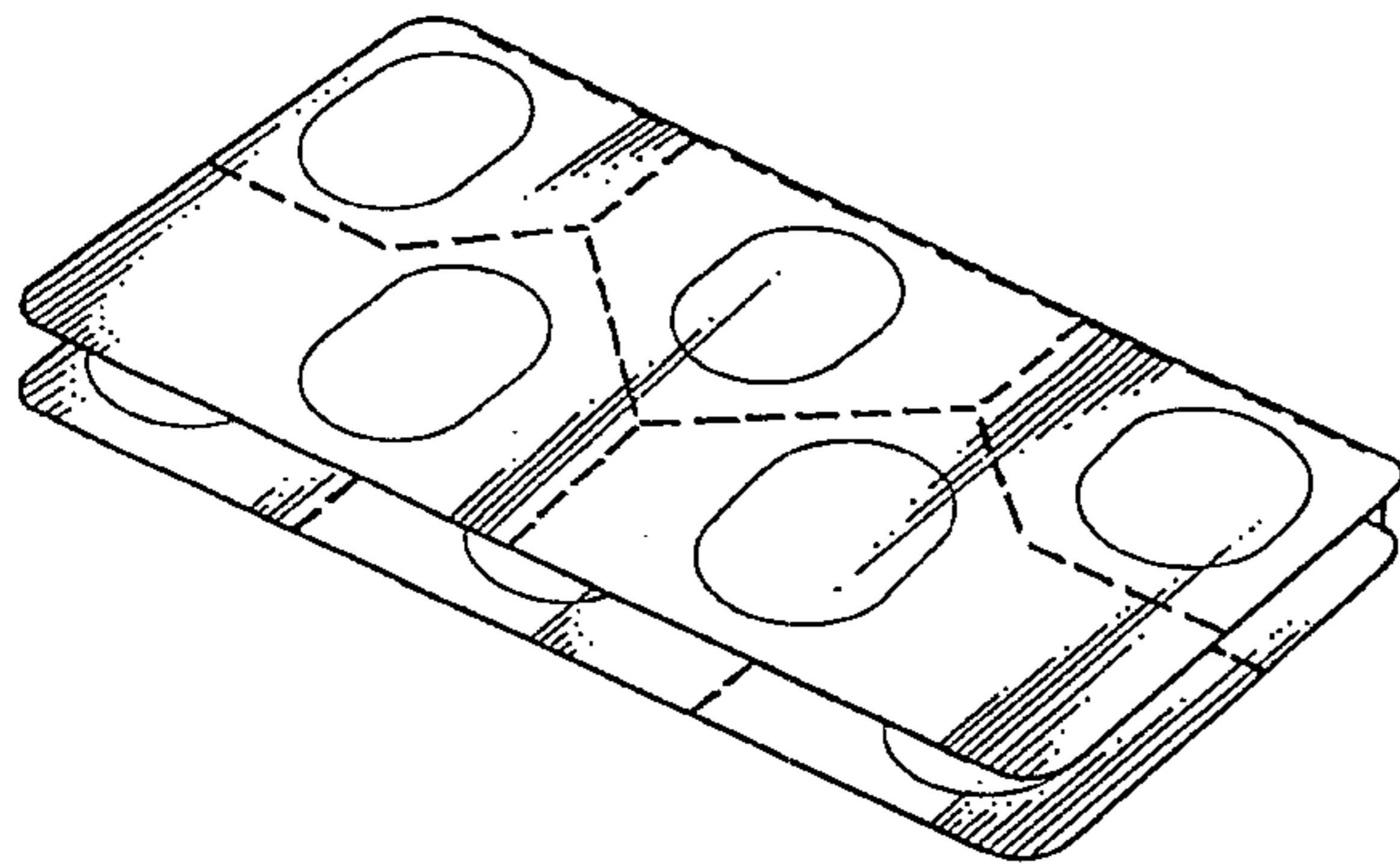

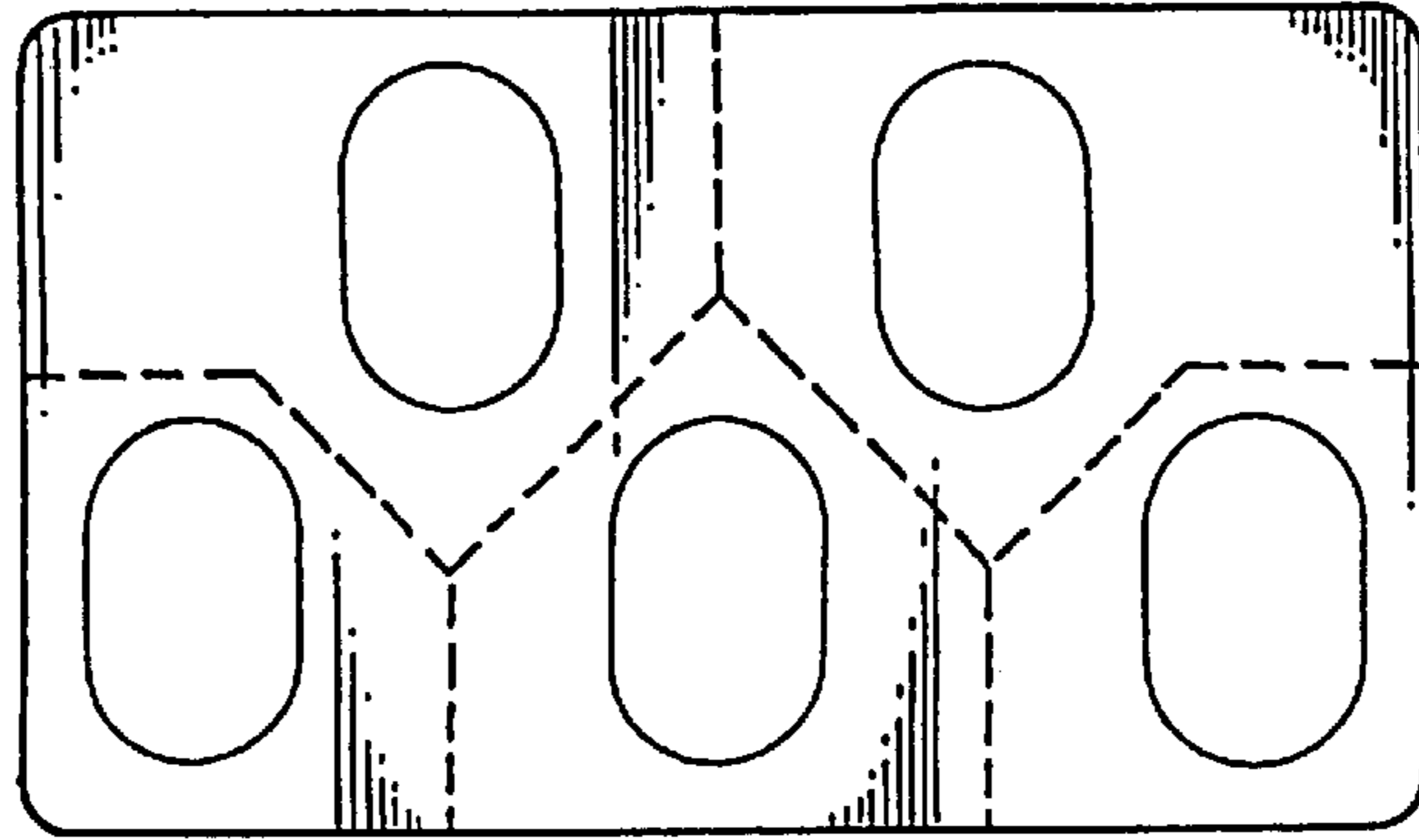

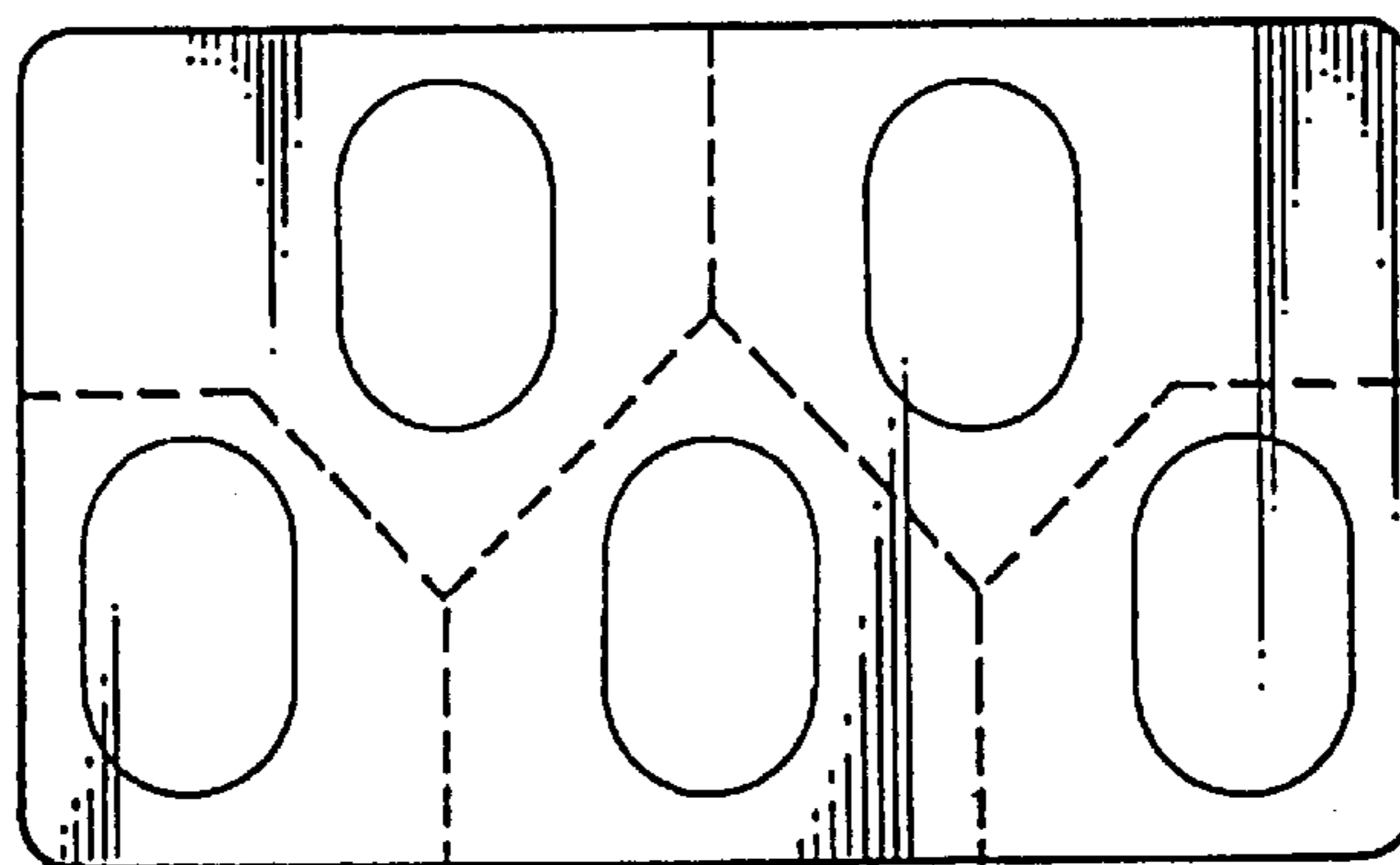

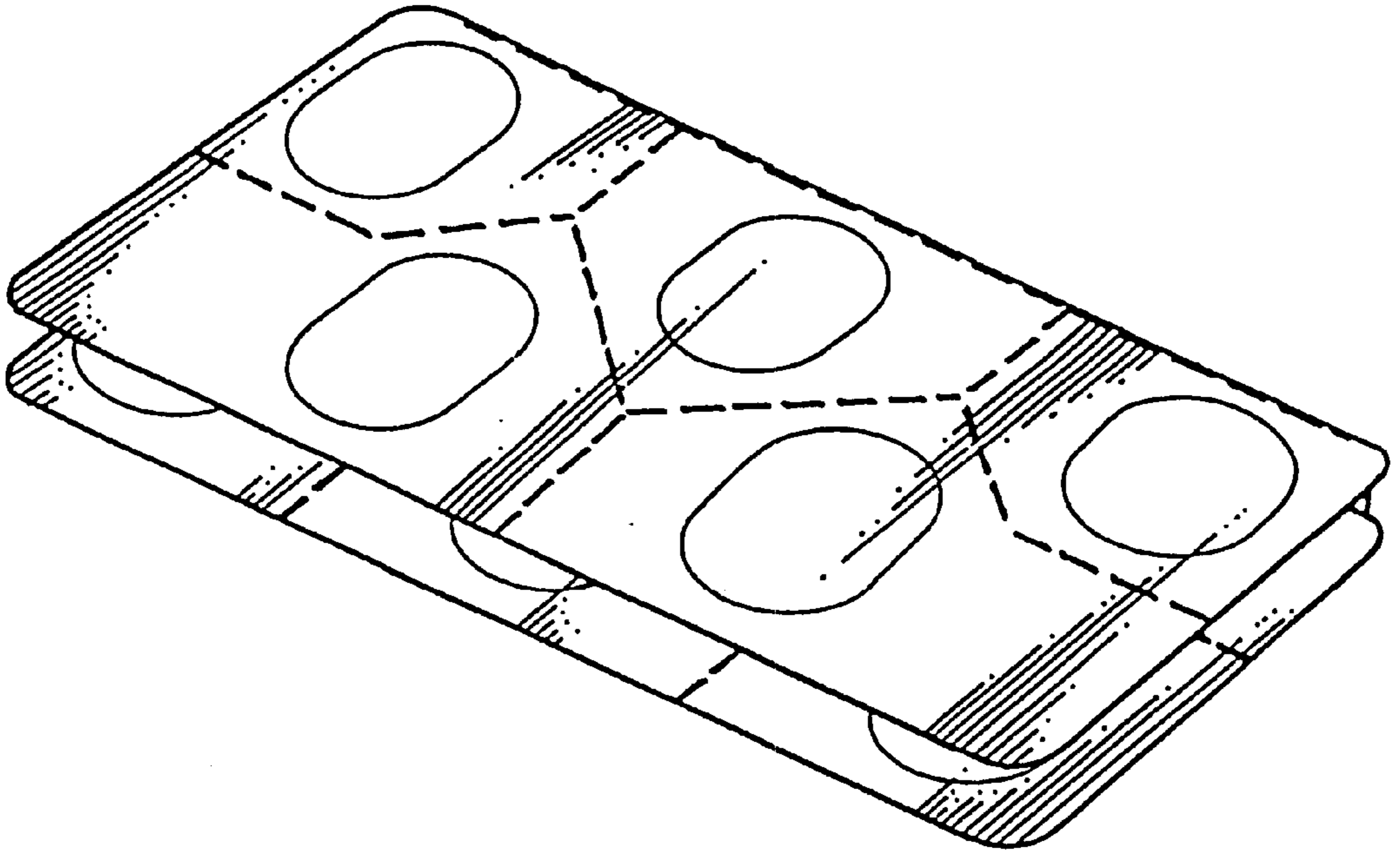

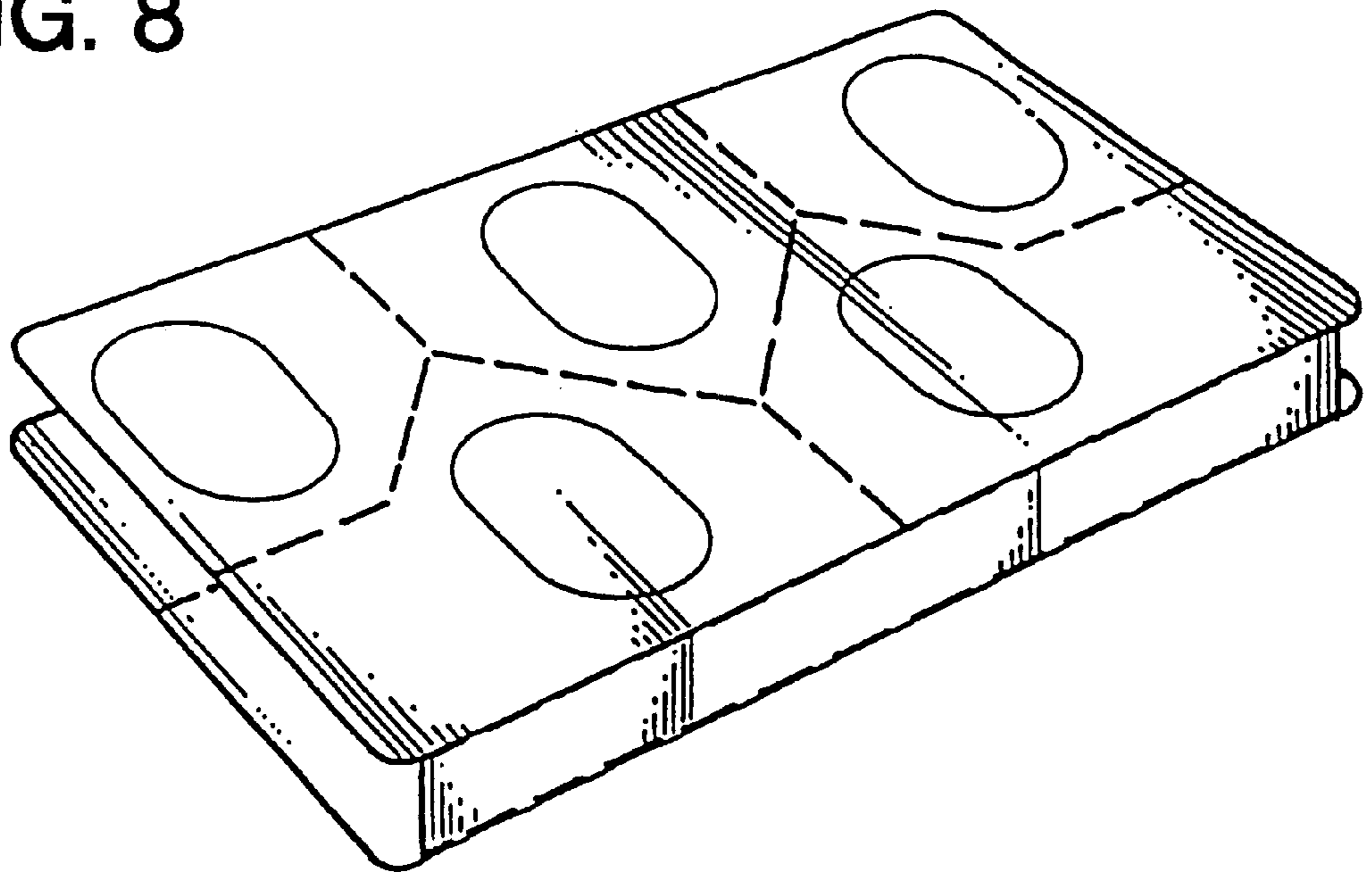

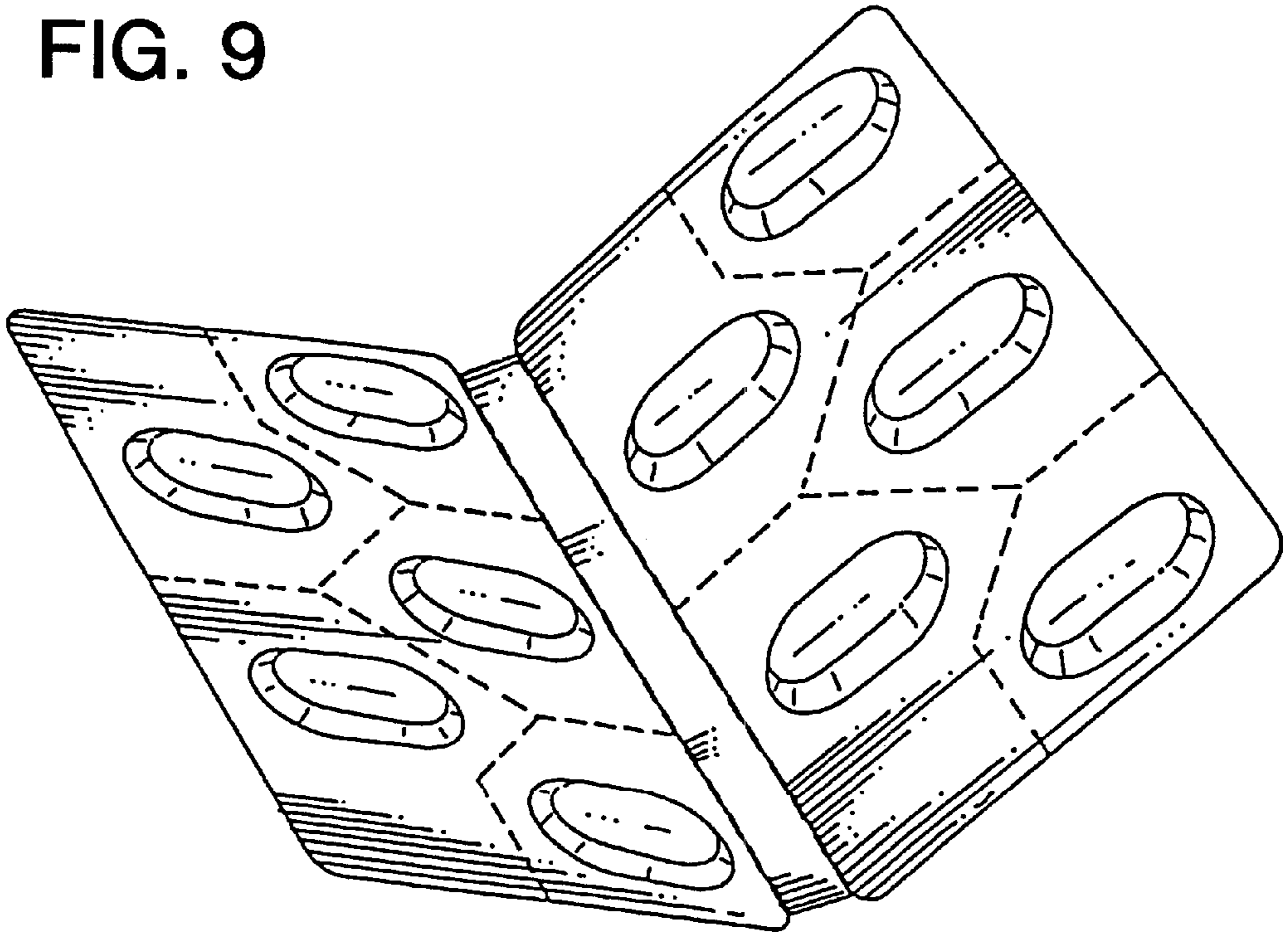
