DESCRIPTION

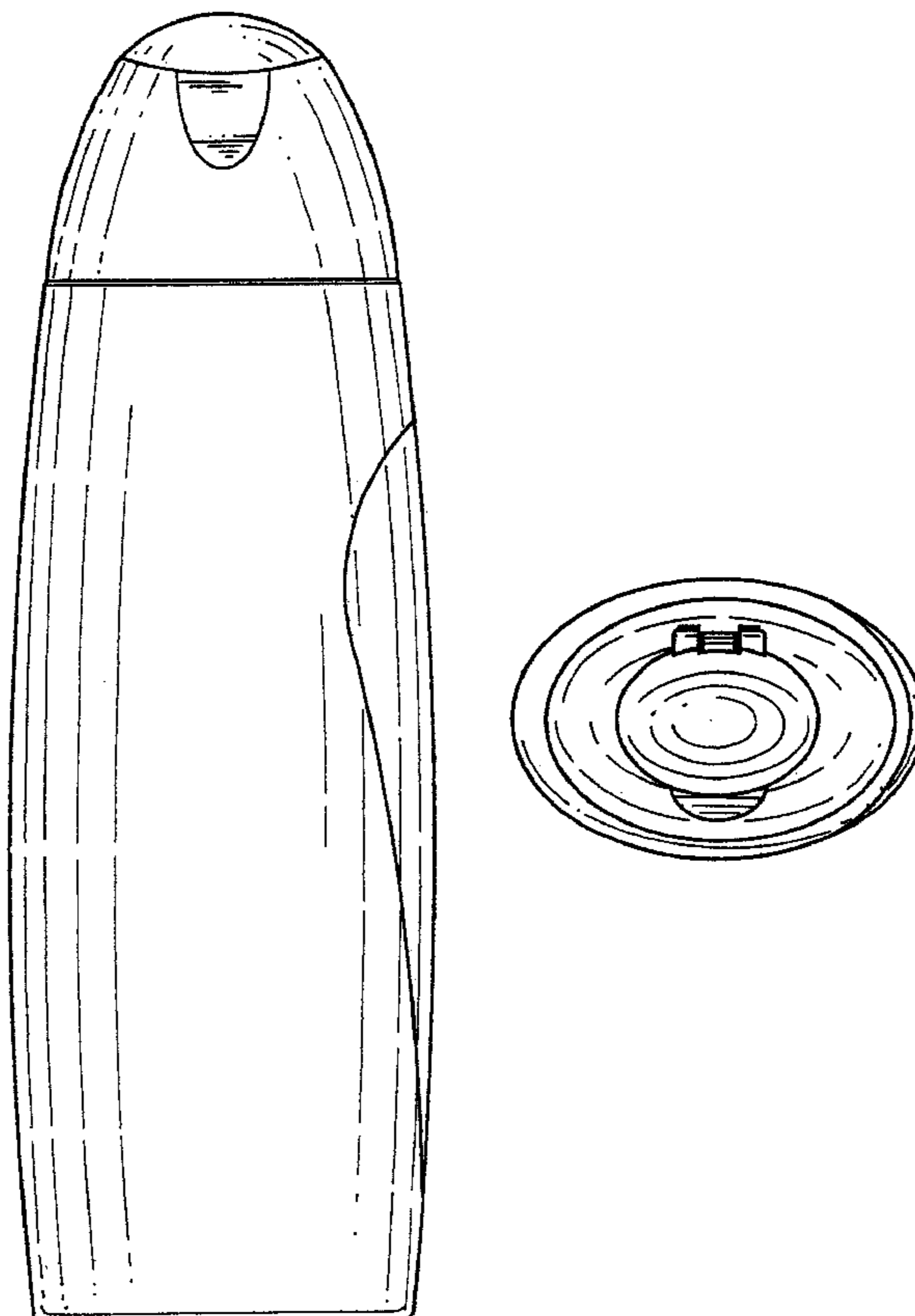
FIG. 1 is a front elevational view of a bottle showing my new design therefore;

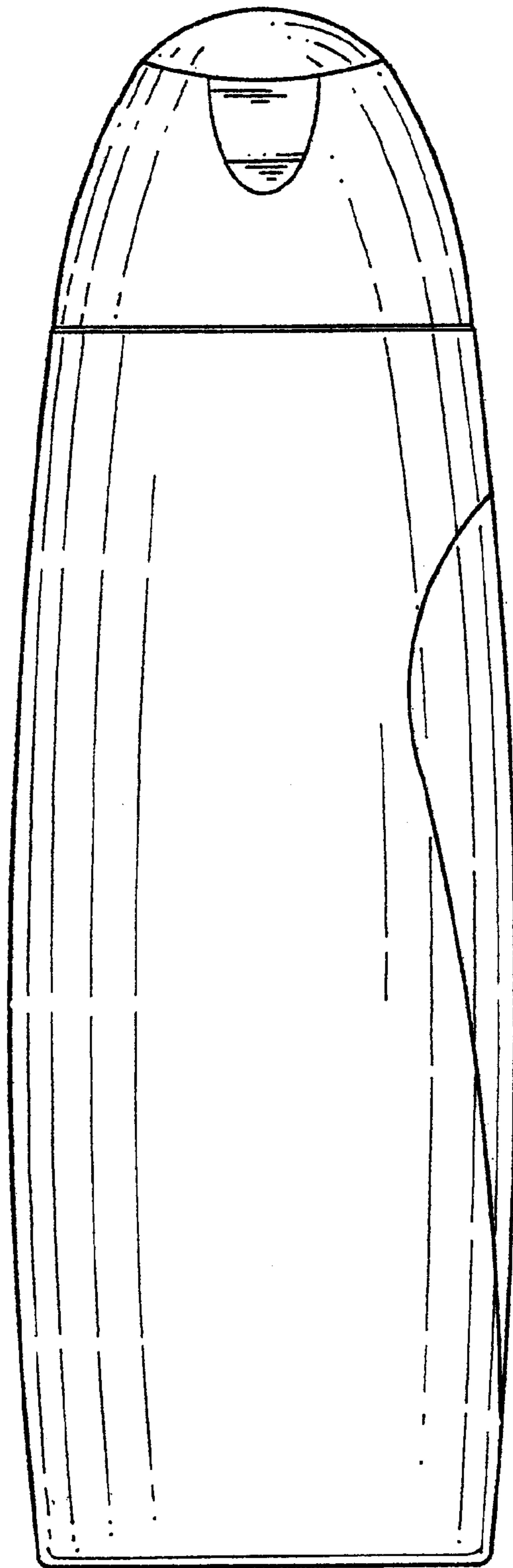

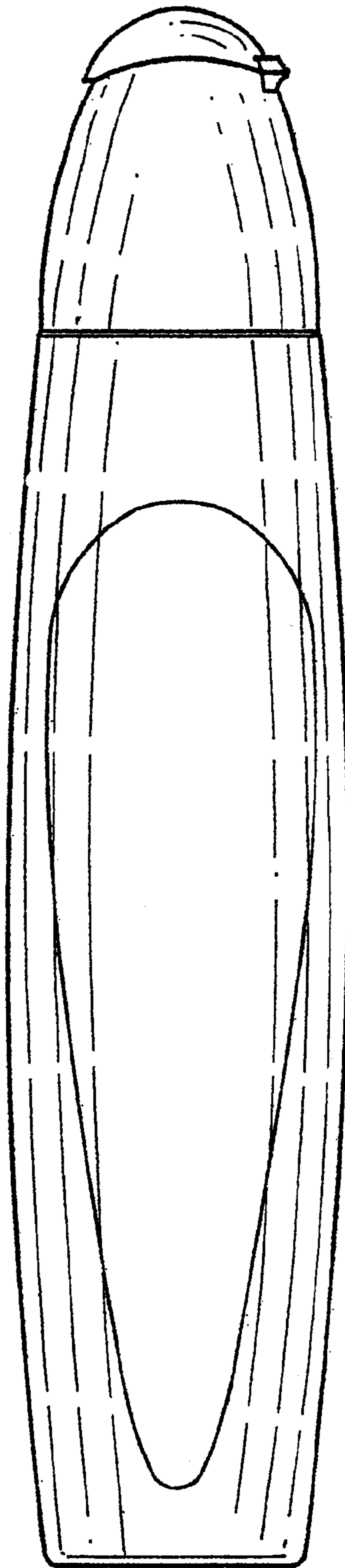

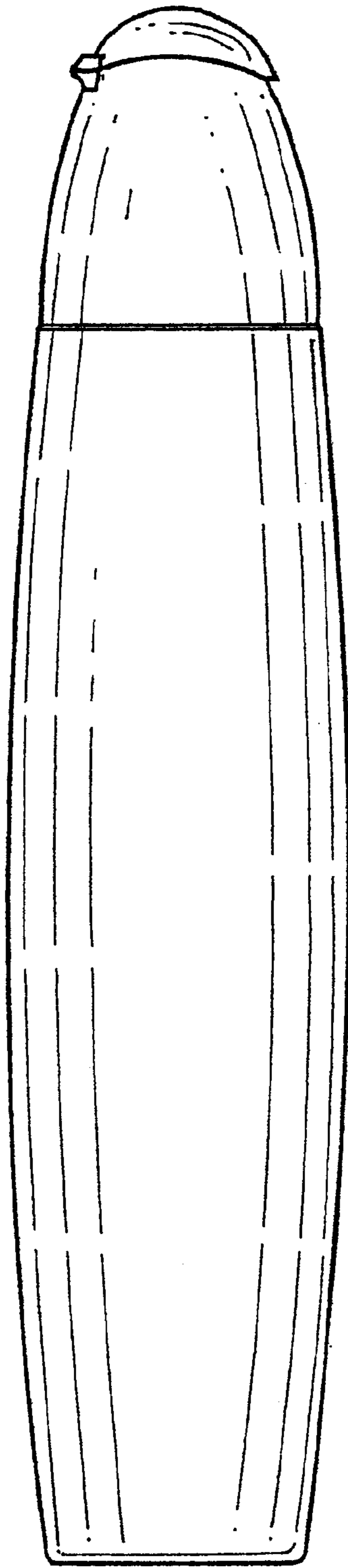

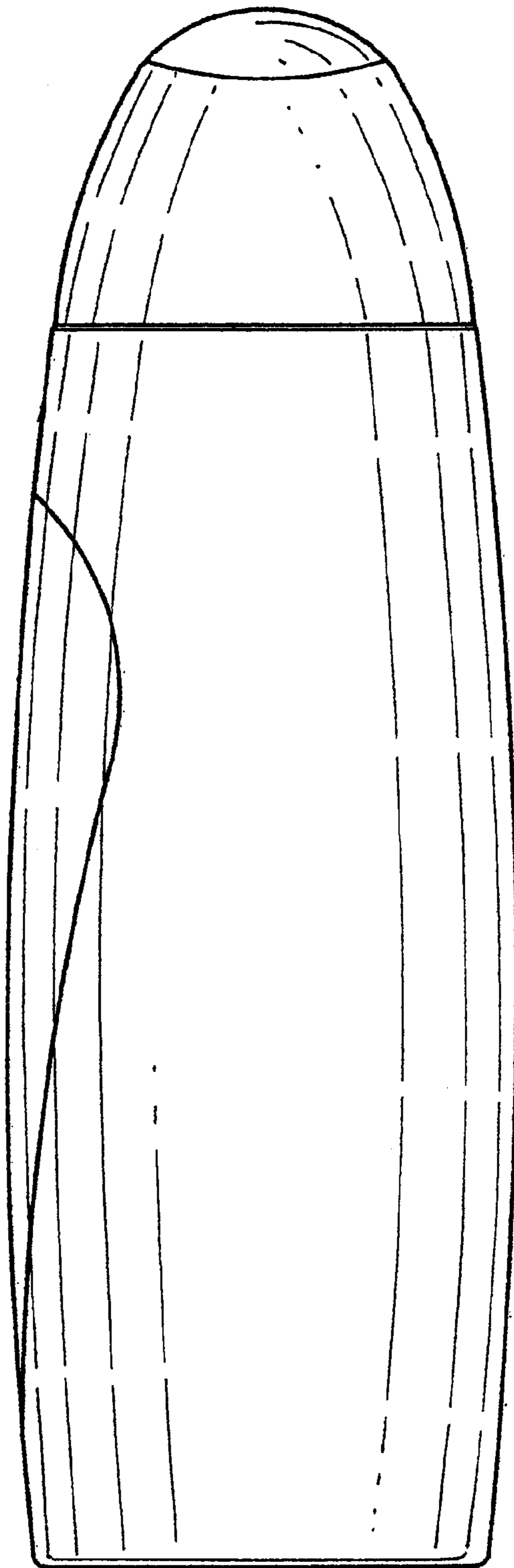

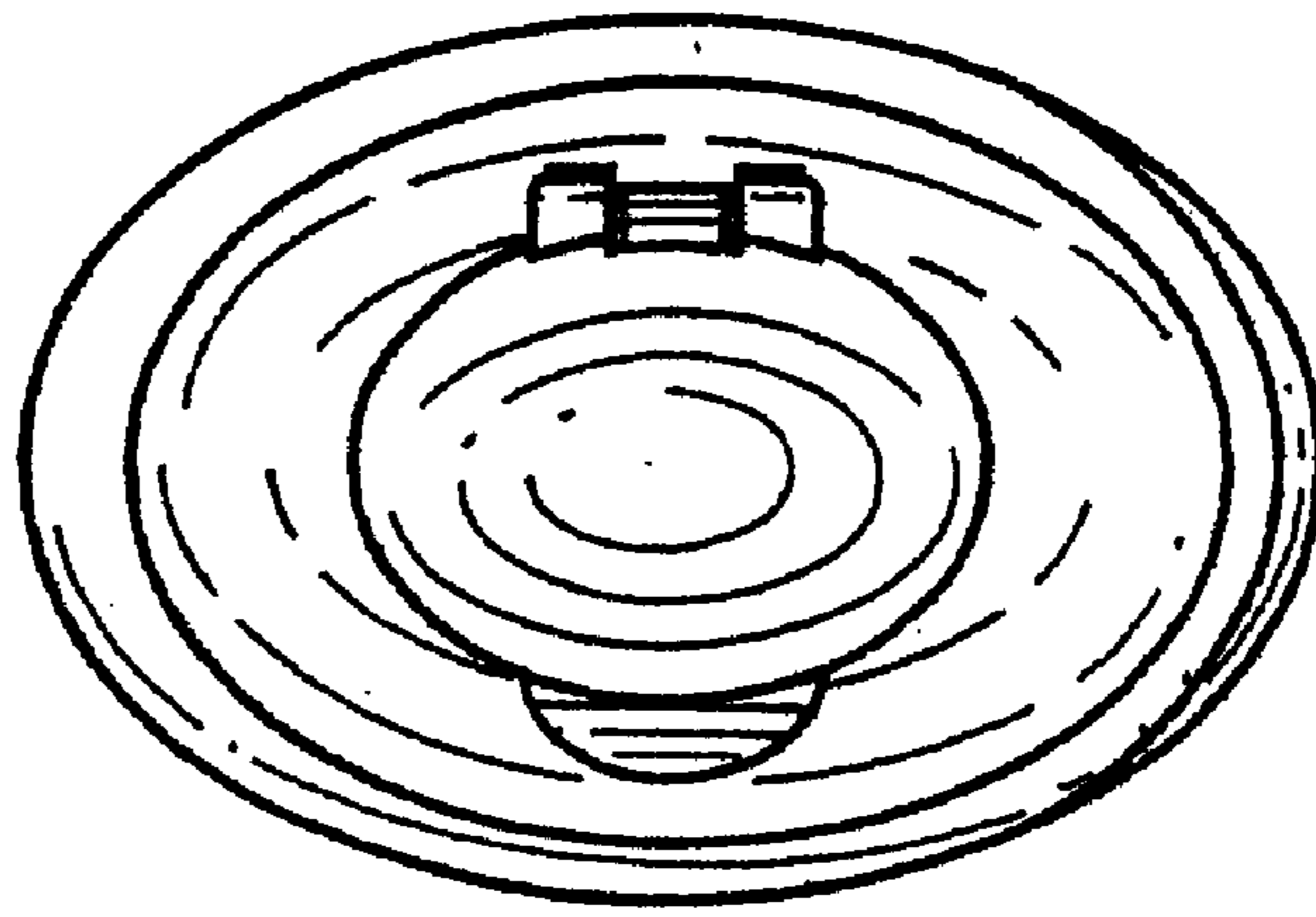

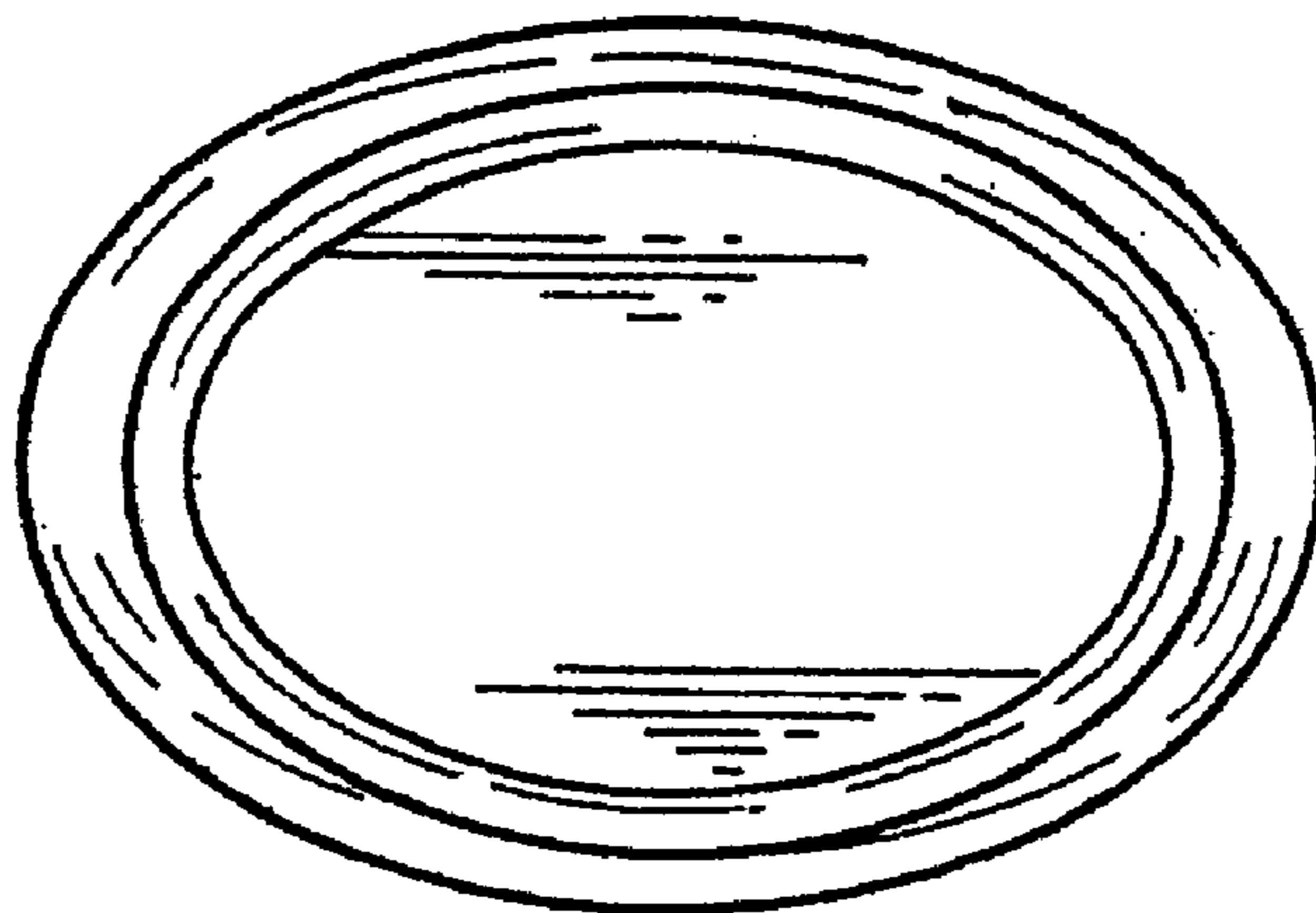
