(57) **CLAIM**

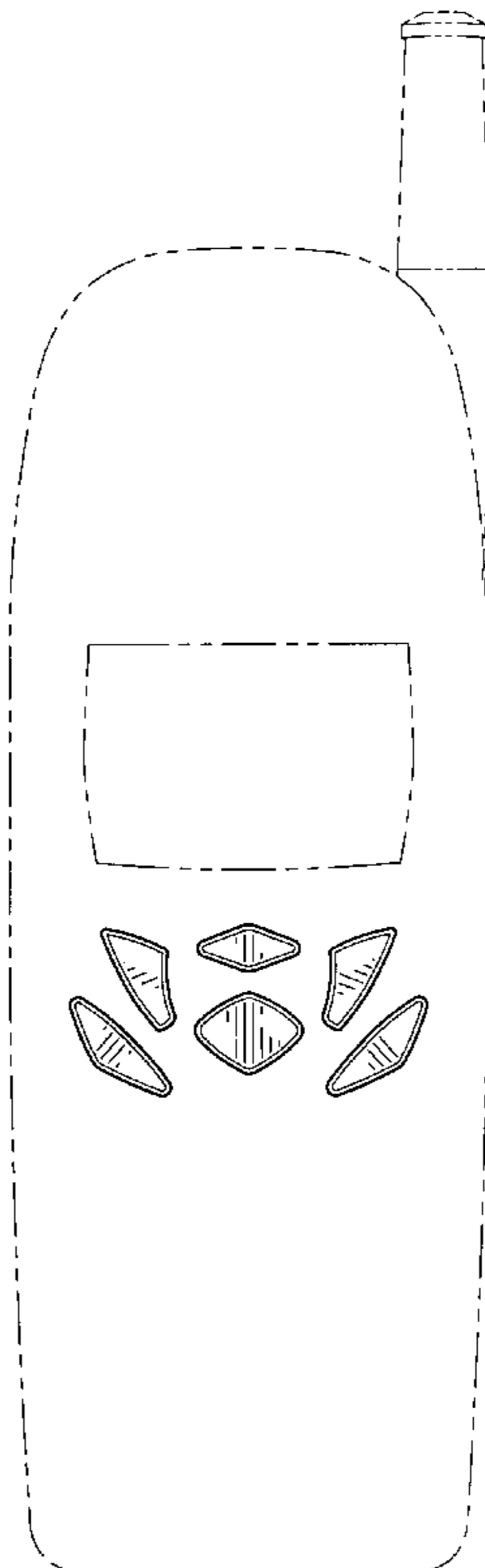
I claim the ornamental design for a key array for a handset,

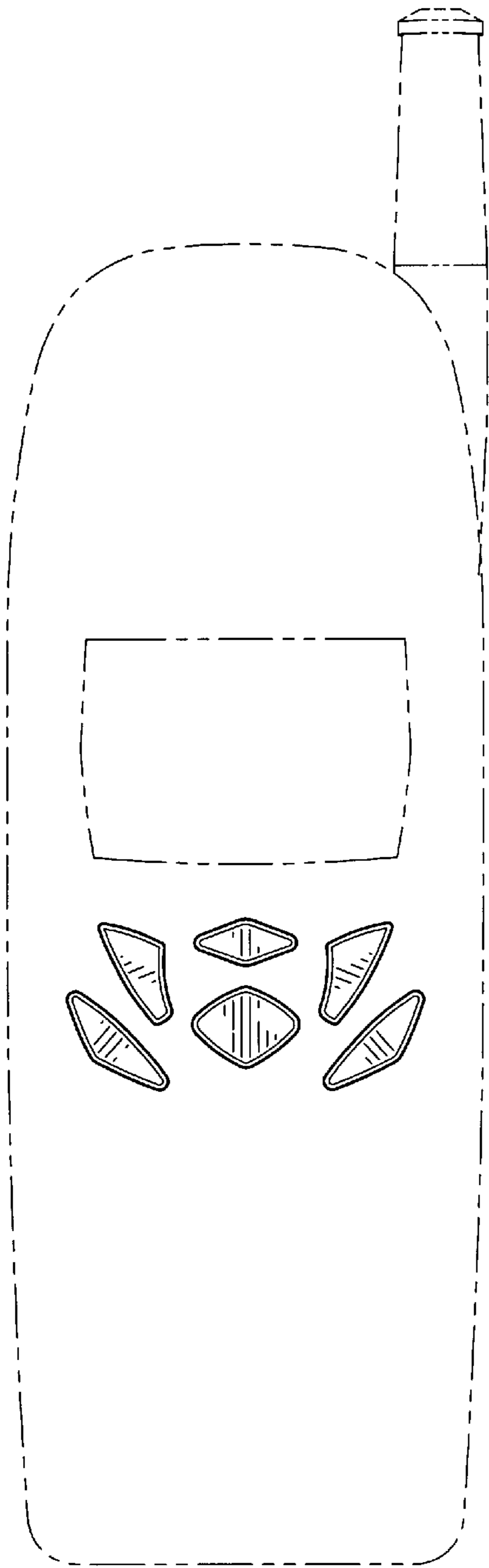

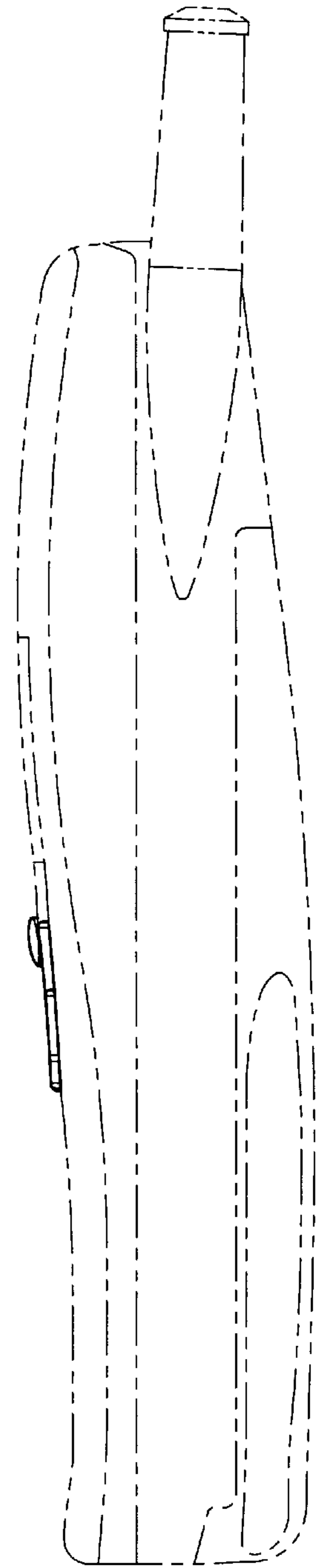

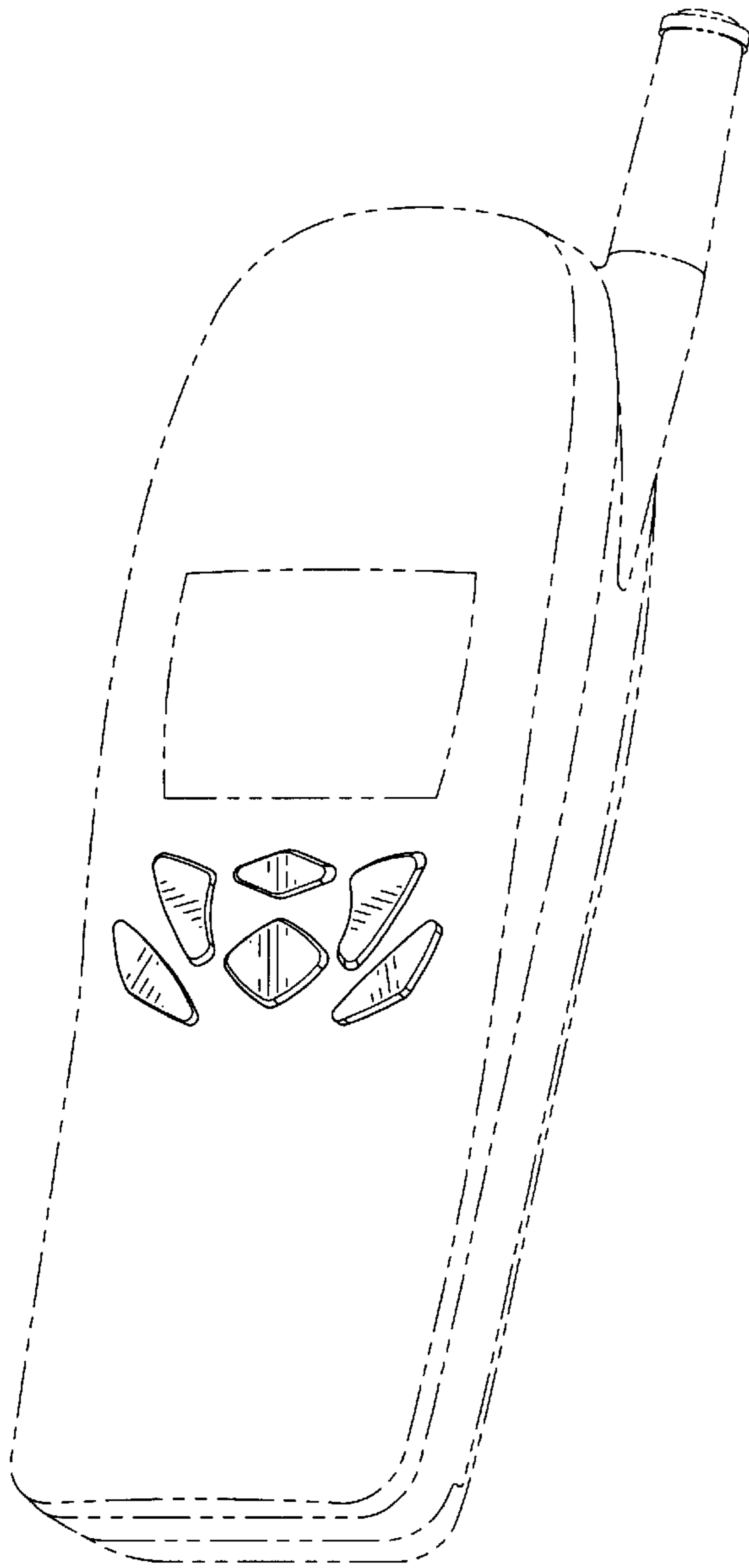

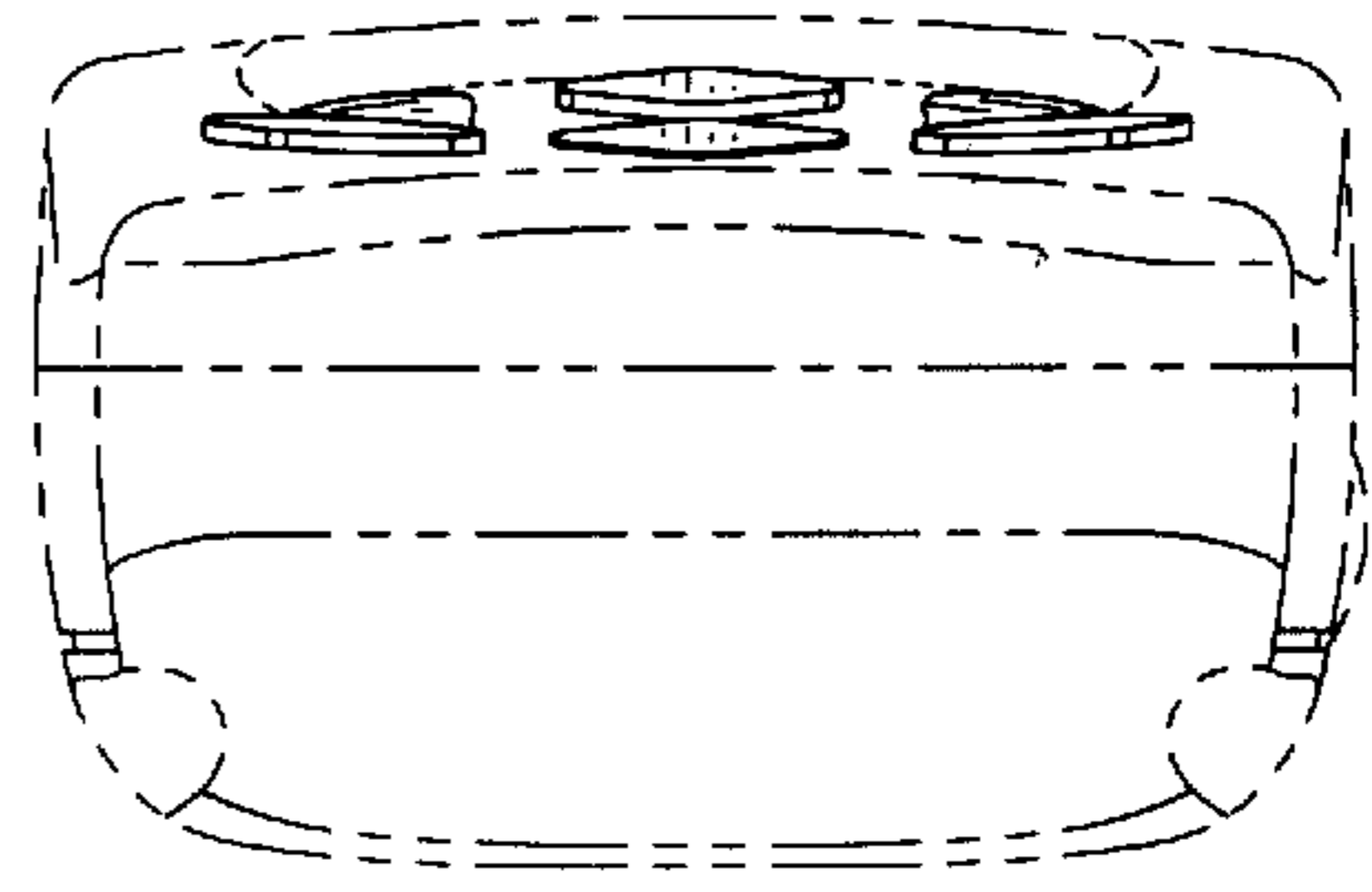

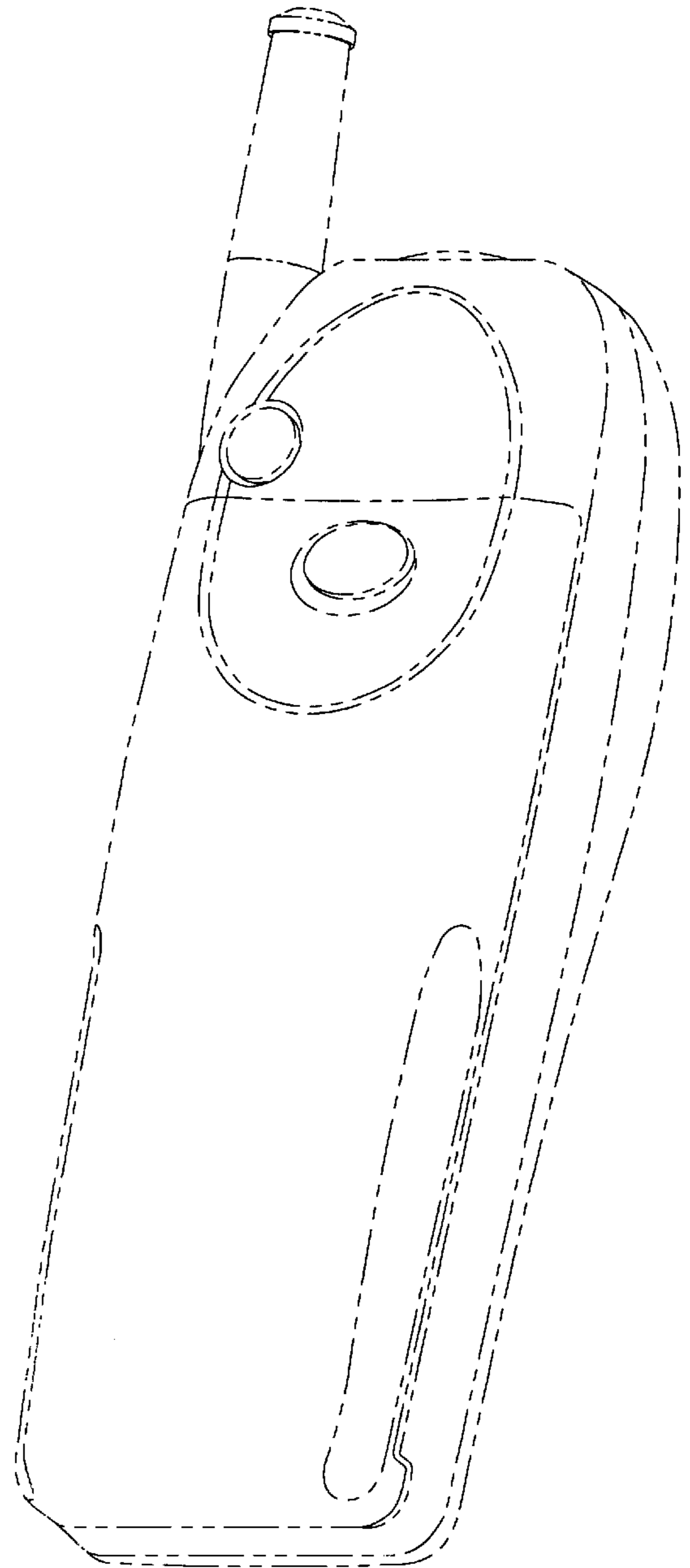
