FIG. 5 is a bottom plan view of the writing instrument of FIG. 1; and,

FIG. 6 is a perspective view of the writing instrument of FIG. 1, with the writing tip being projected.

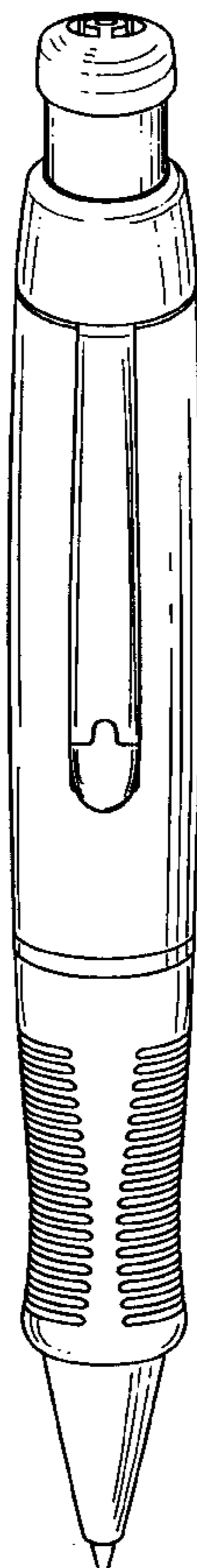

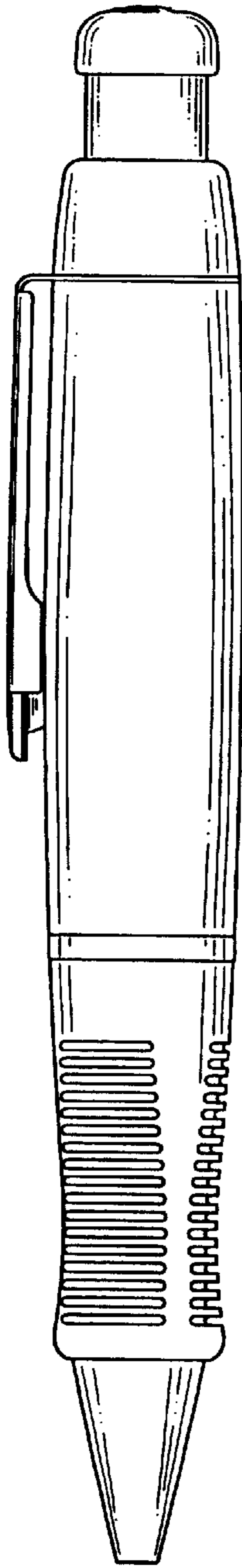

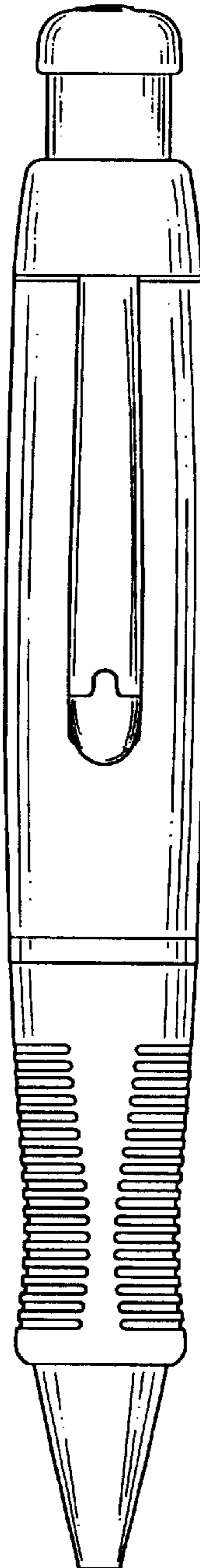

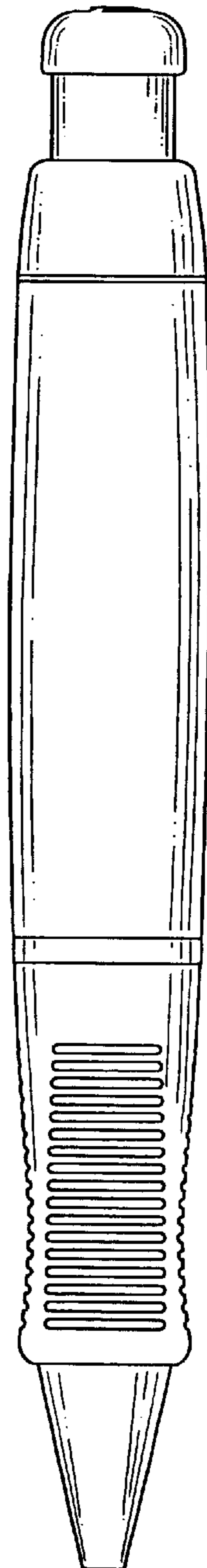

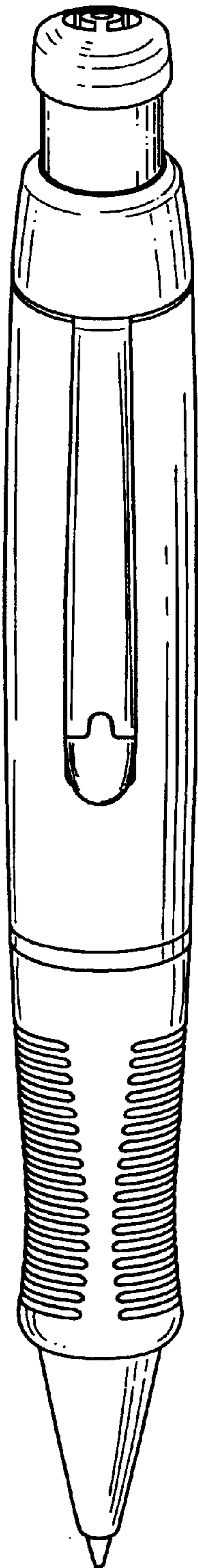

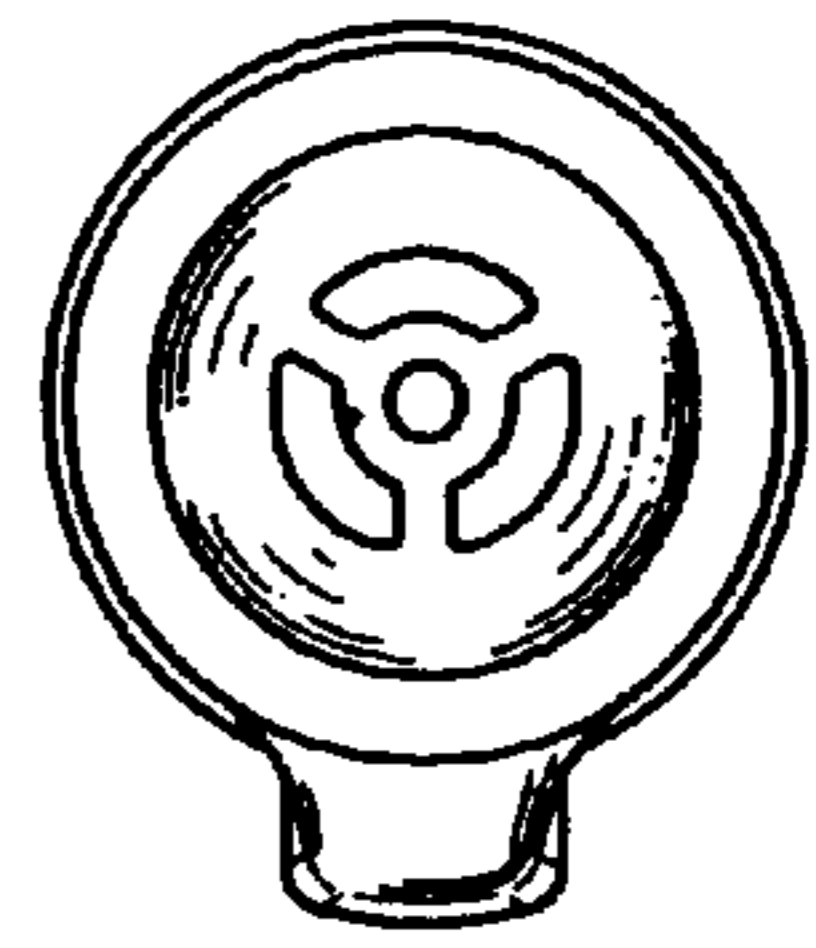
