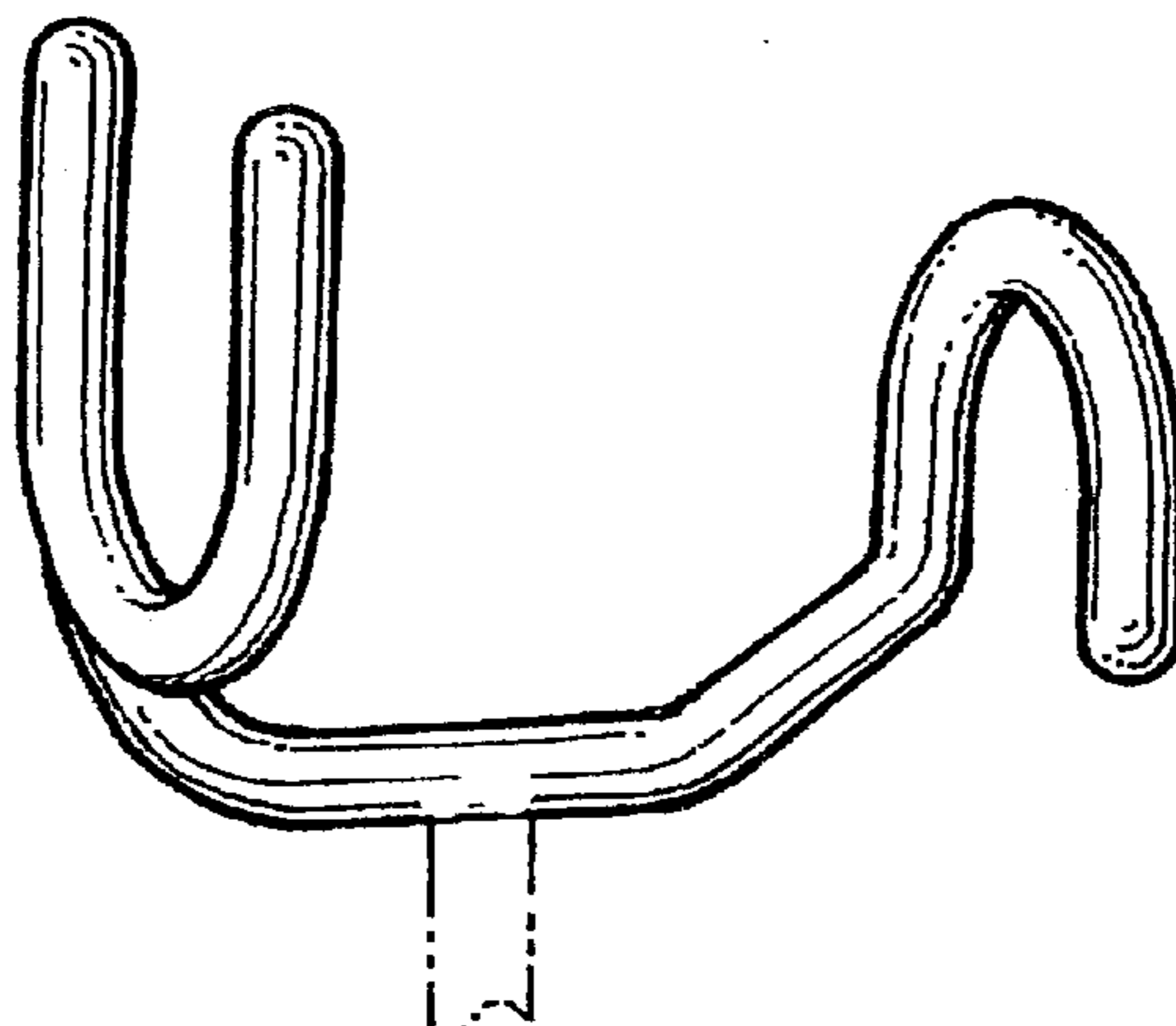
The ornamental design for a wire fishing rod holder, as shown and described.

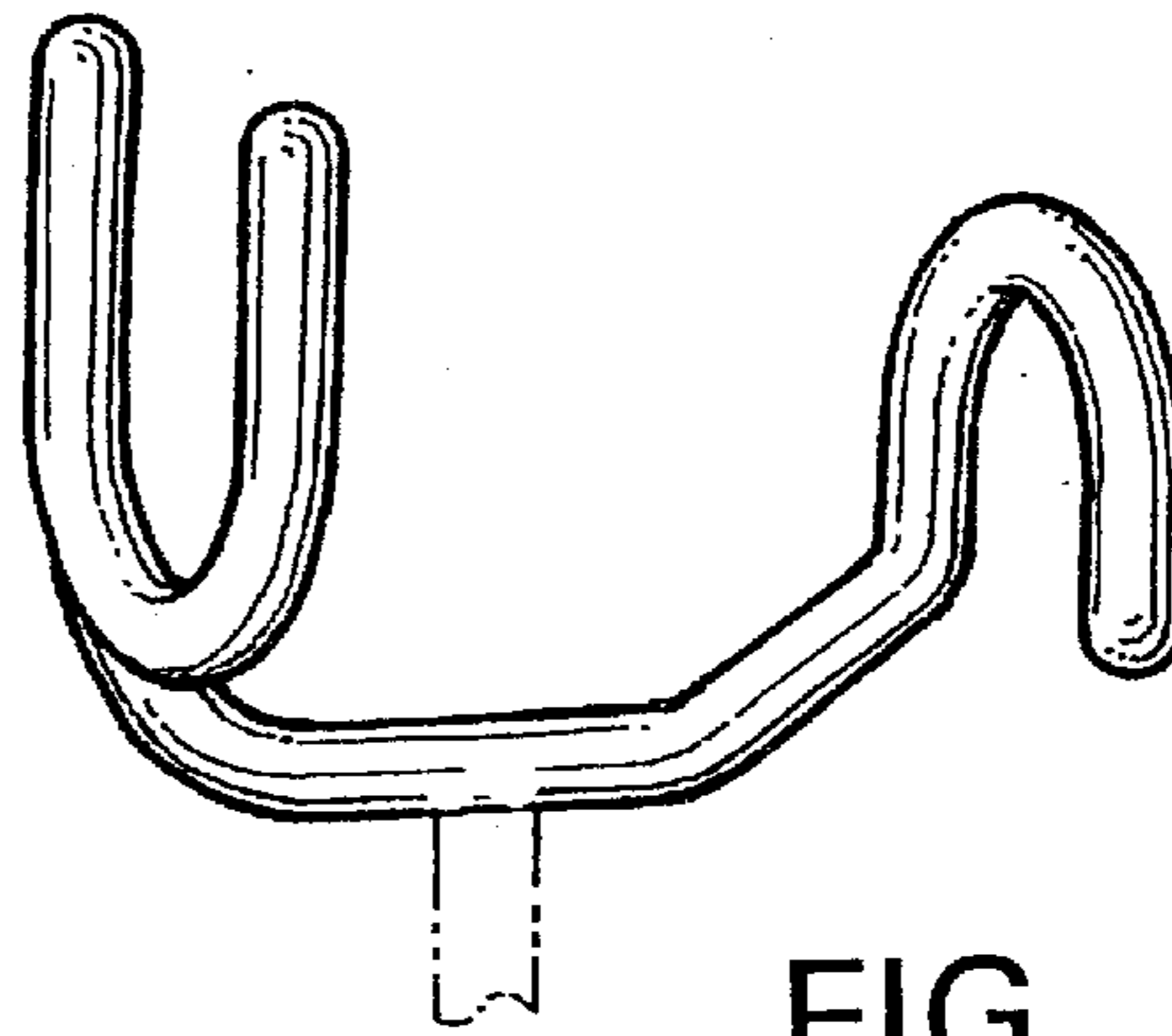

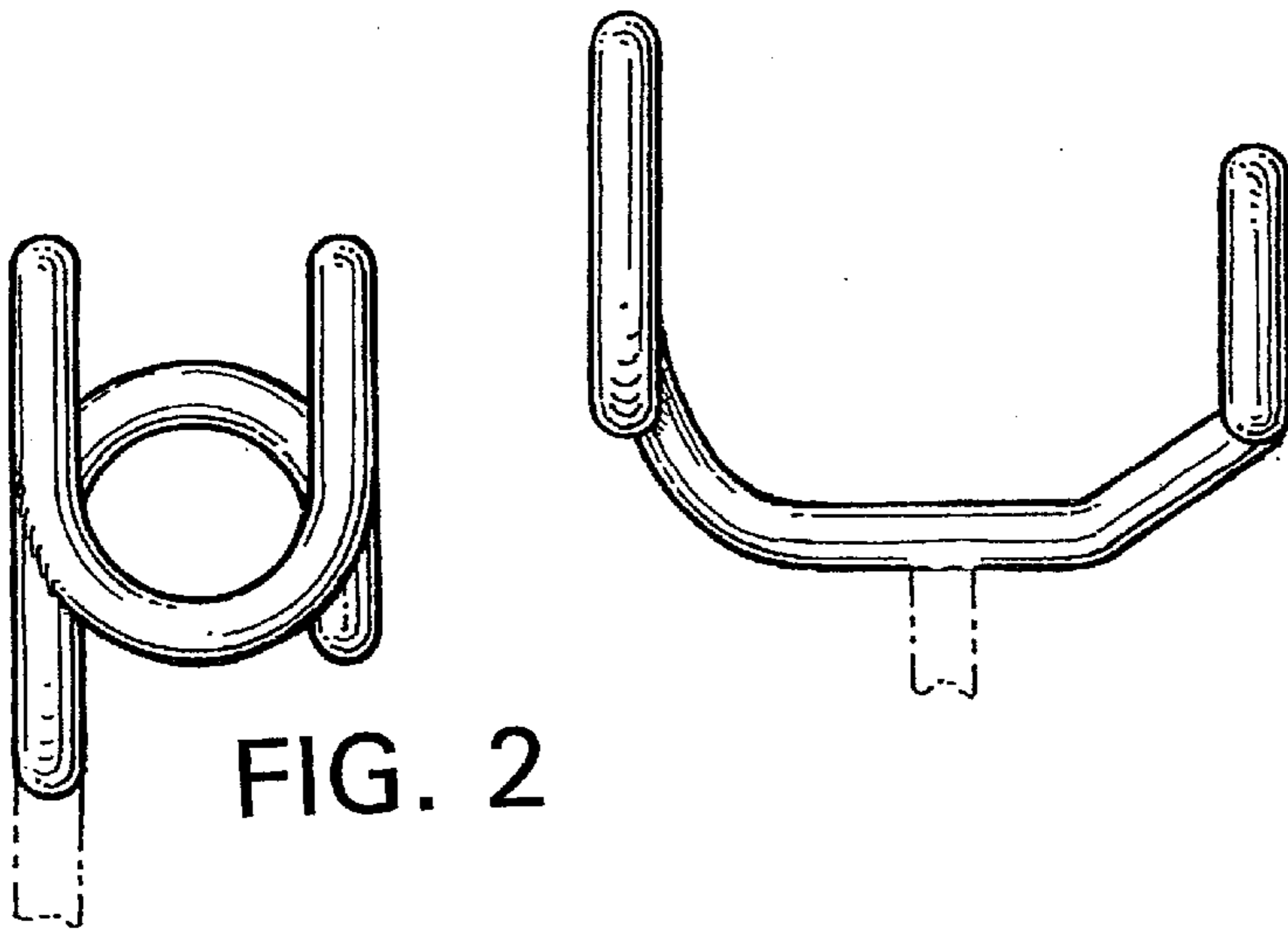

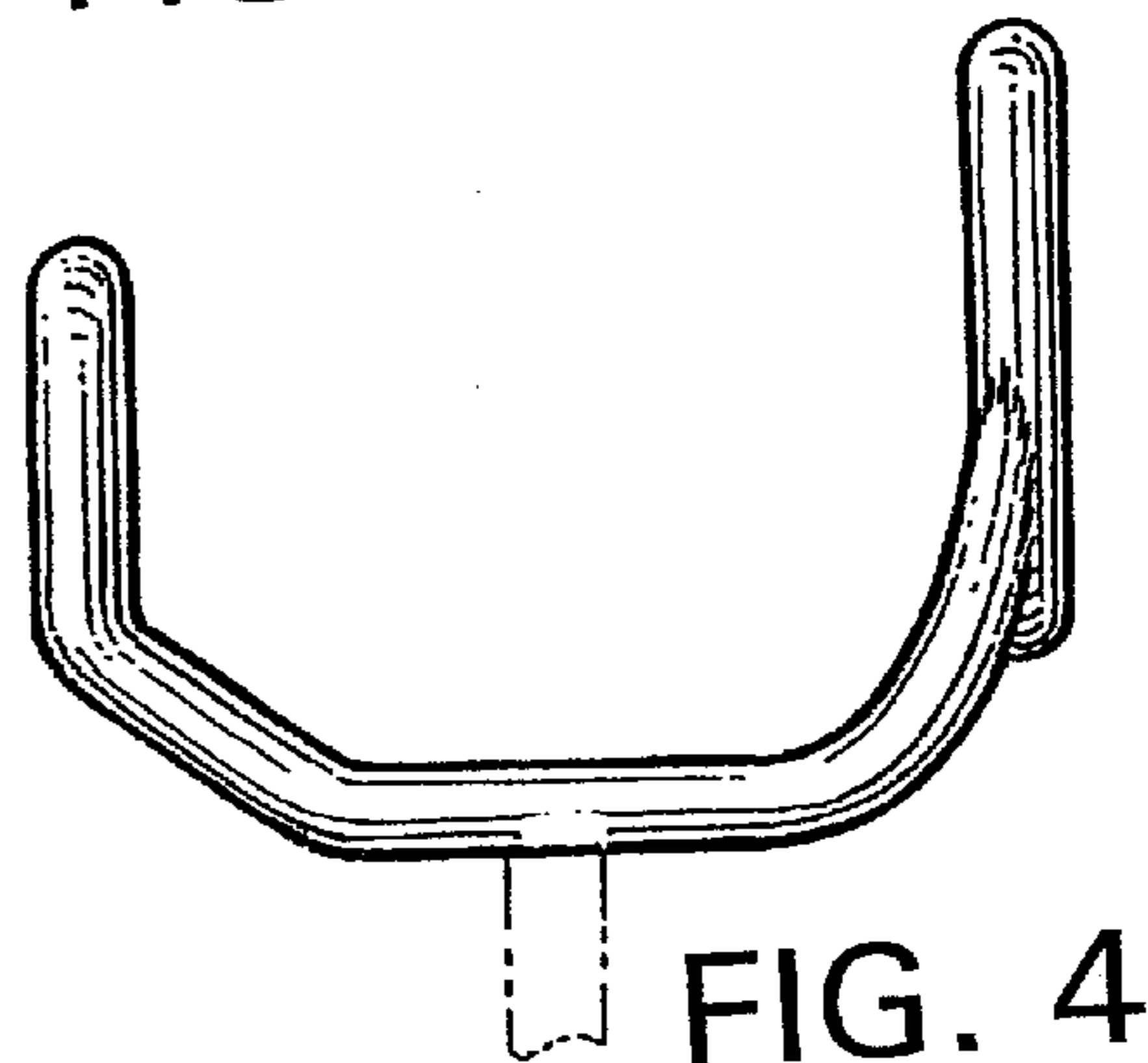

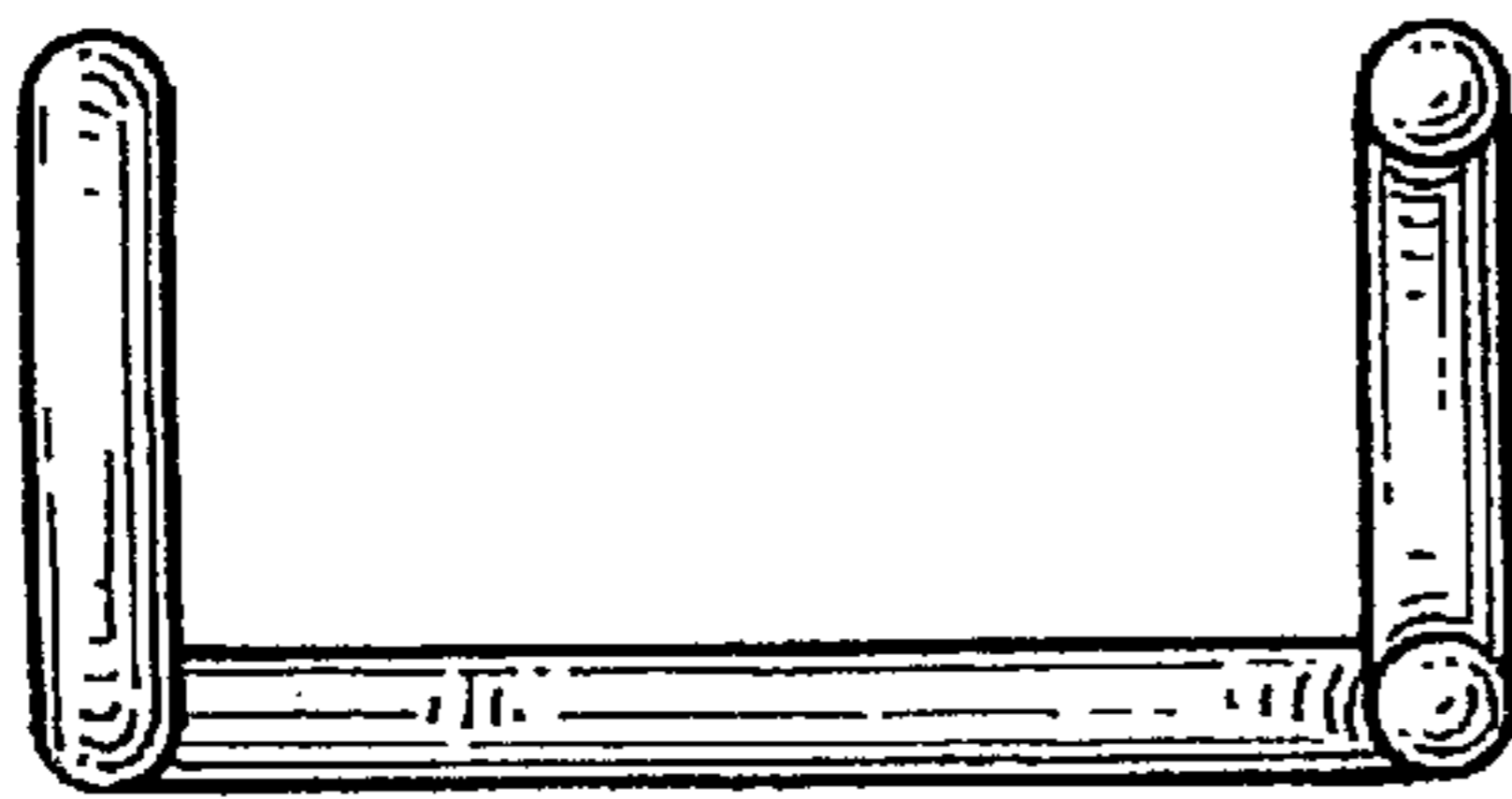

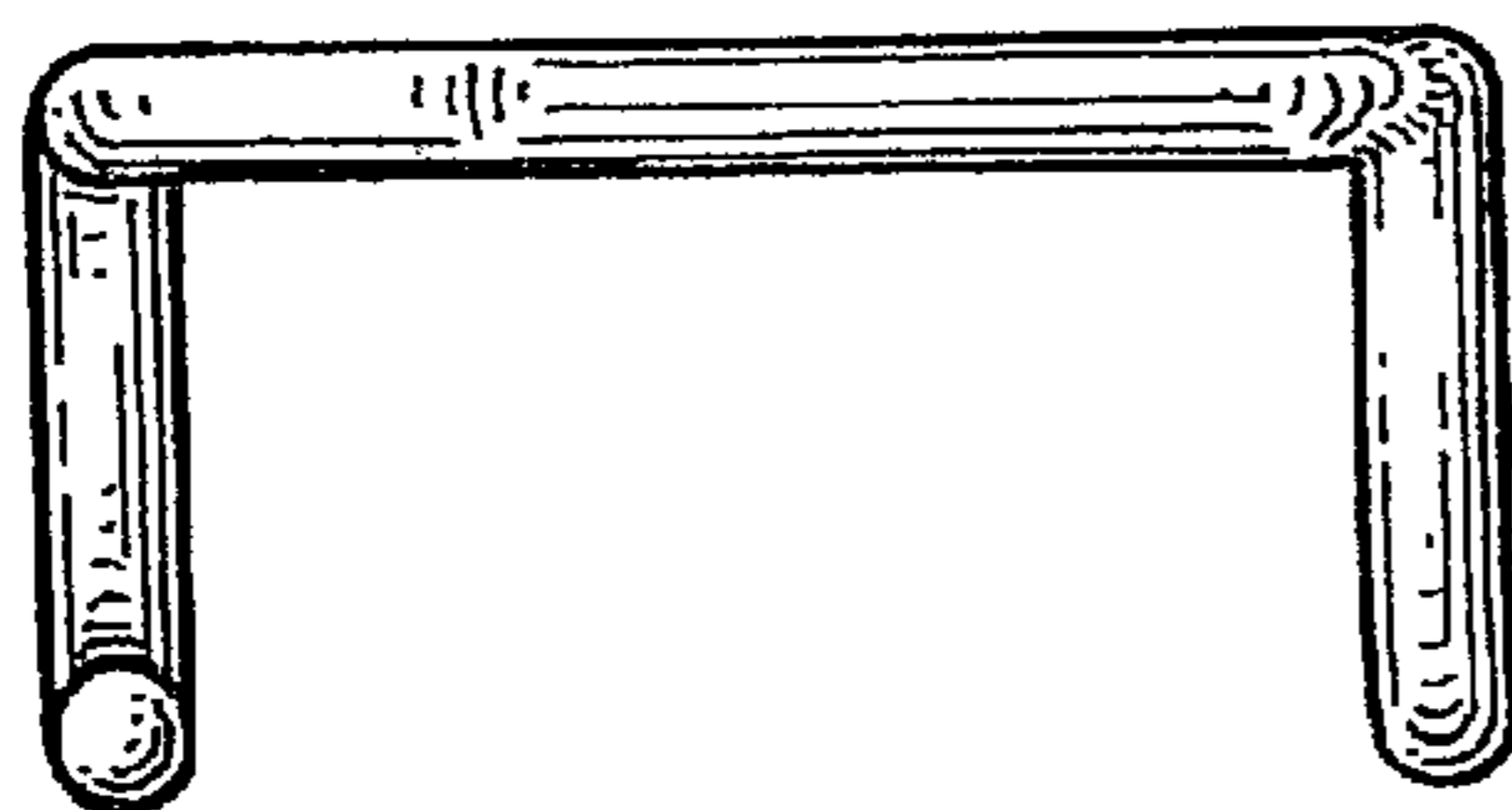

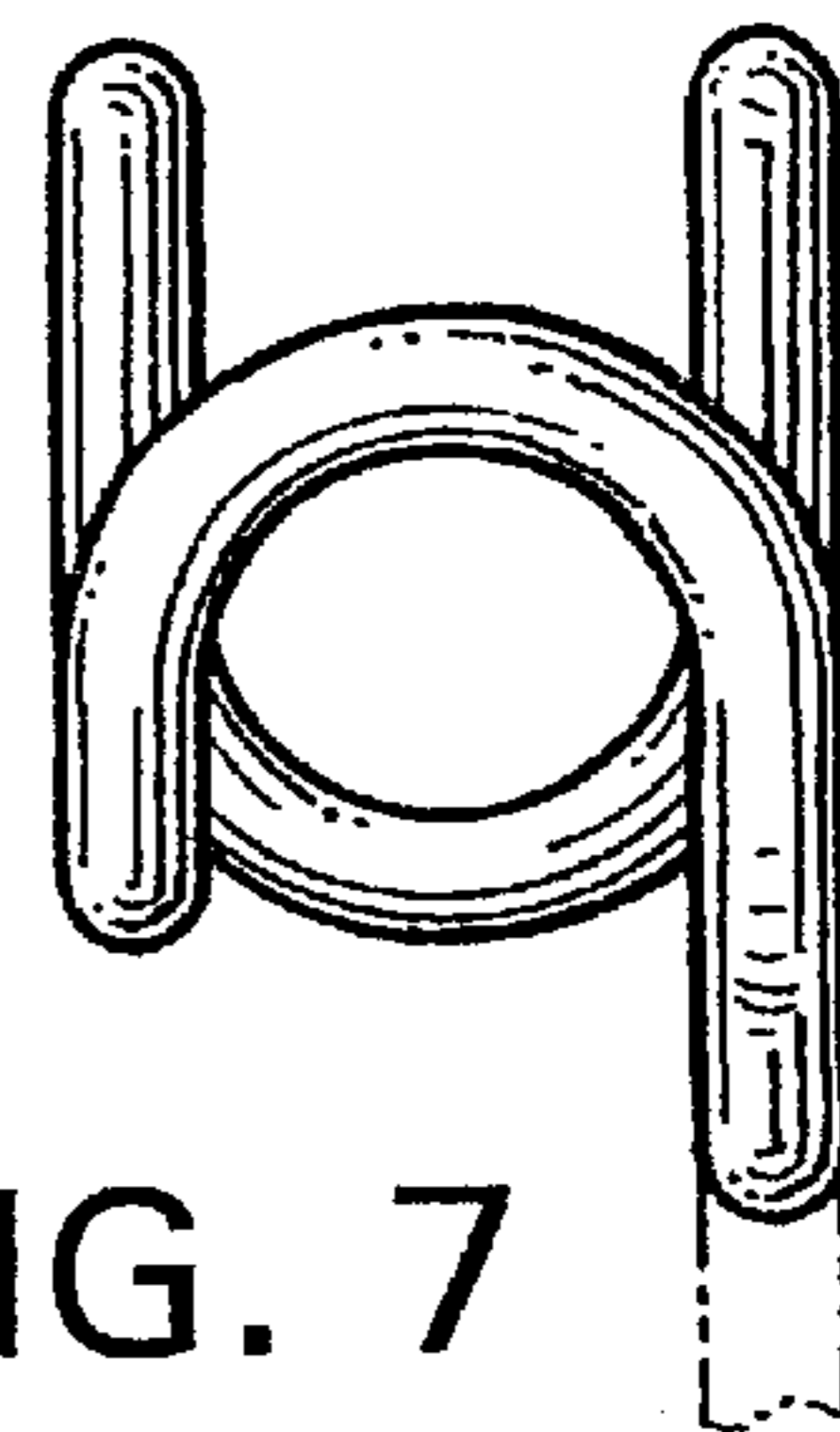
