(57) **CLAIM**

We claim the ornamental design for a formal wear sandal, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view of a first embodiment of a formal wear sandal embodying our new design;

FIG. 2 is a right side perspective view thereof;

FIG. 3 is a front side elevation view thereof;

FIG. 4 is a rear side elevation view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a right side elevation view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a right side perspective view of a second embodiment showing a variation in the sole thereof;

FIG. 10 is a left side perspective view of the second embodiment showing a variation in the sole thereof;

FIG. 11 is a front side elevation view of the second embodiment showing a variation in the sole thereof;

FIG. 12 is a rear side elevation view of the second embodiment showing a variation in the sole thereof;

FIG. 13 is a left side elevation view of the second embodiment showing a variation in the sole thereof;

FIG. 14 is a right side elevation view of the second embodiment showing a variation in the sole thereof;

FIG. 15 is a top plan view of the second embodiment thereof;


FIG. 16 is a bottom plan view of the second embodiment thereof;

FIG. 17 is a right side elevation view of a third embodiment showing a variation in the sole of the second embodiment; and,

FIG. 18 is a left side elevation view of the third embodiment showing a variation in the sole of the second embodiment.

The top and bottom views of the third embodiment correspond to FIGS. 15 and 16 respectively.

The broken away showing of the sole in FIGS. 17 and 18 indicate that the sole is of indeterminate height.




























