The ornamental design for a sole adapted for a golf shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hoe sole showing our new design;

FIG. 2 is a bottom, plan view thereof;

FIG. 3 is a top, plan view thereof;

FIG. 4 is a front, elevational view thereof;

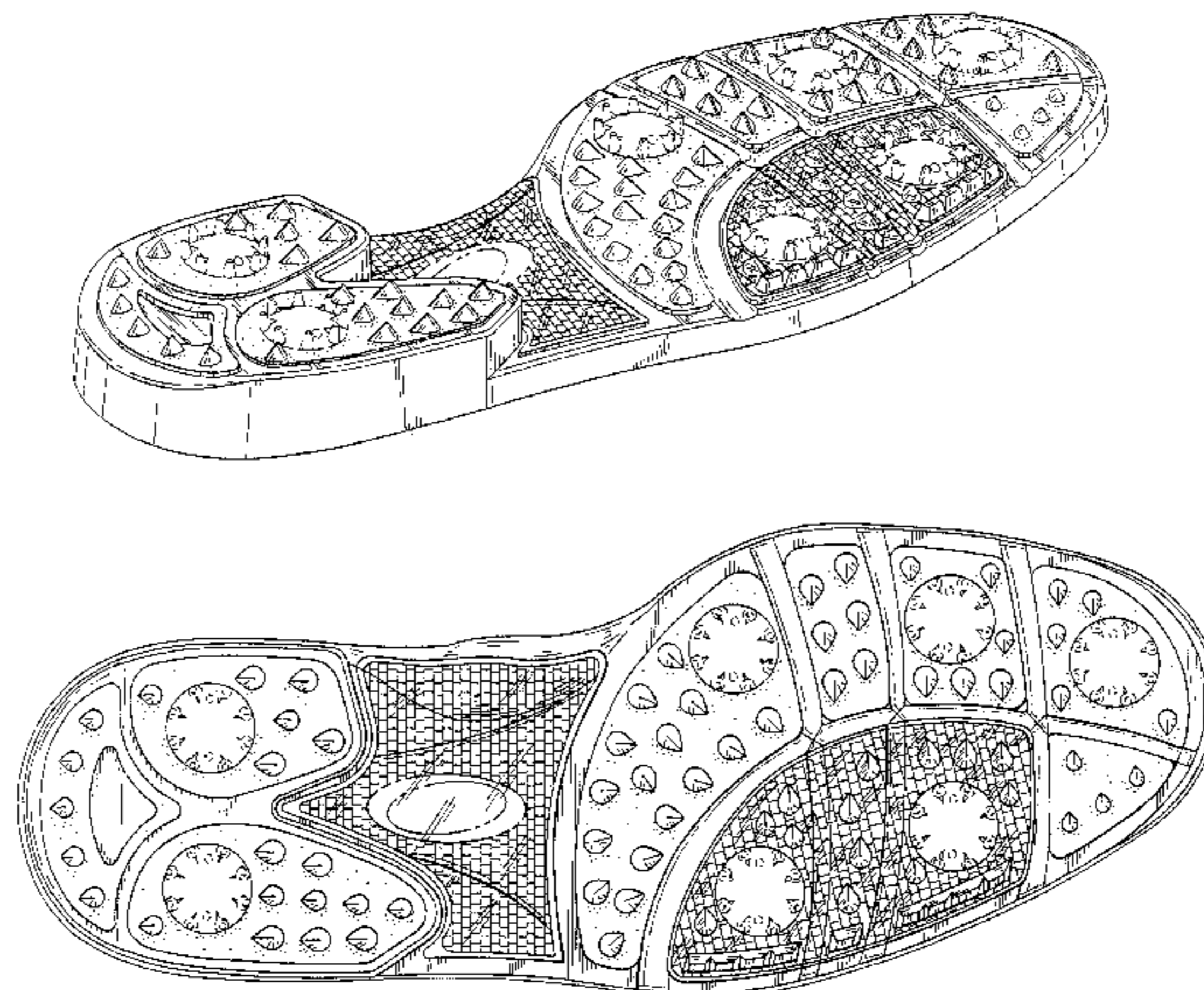
FIG. 5 is a rear, elevational view thereof;

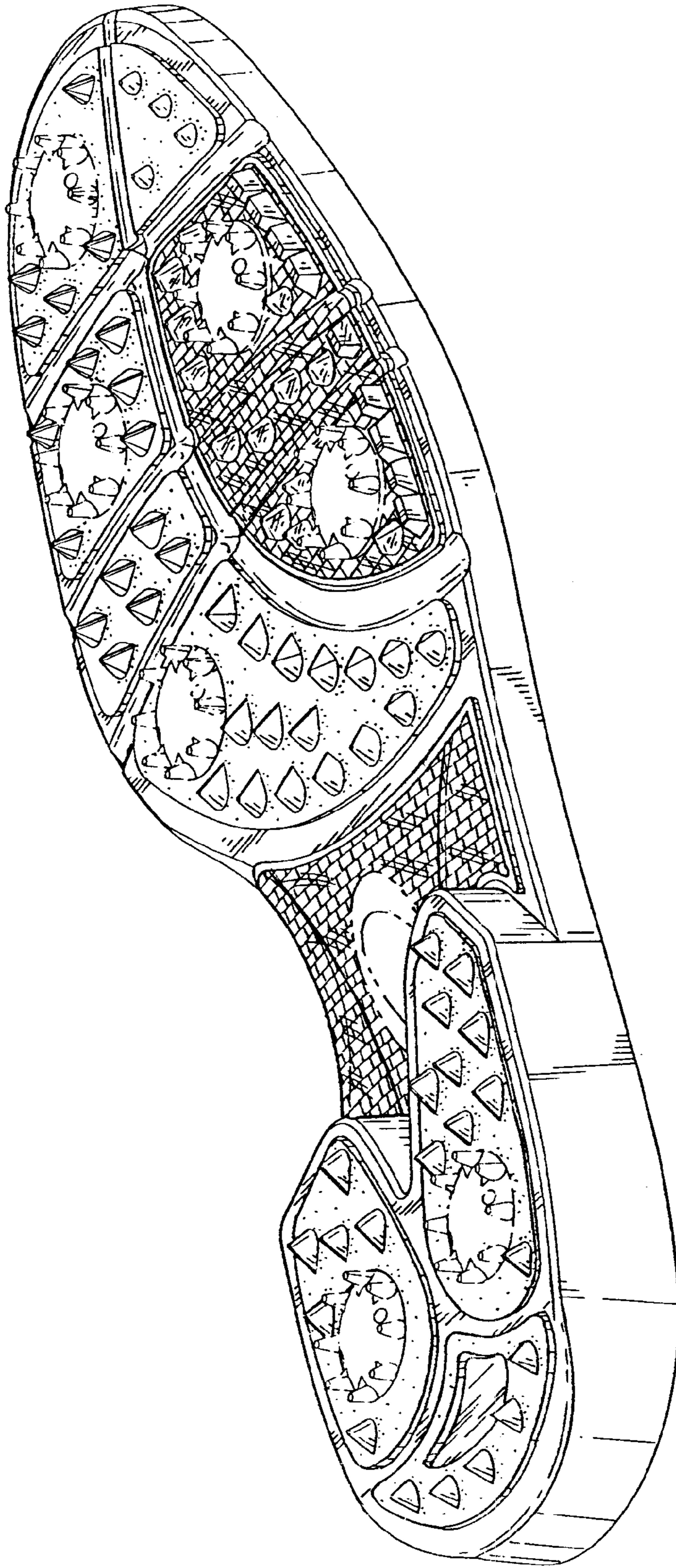

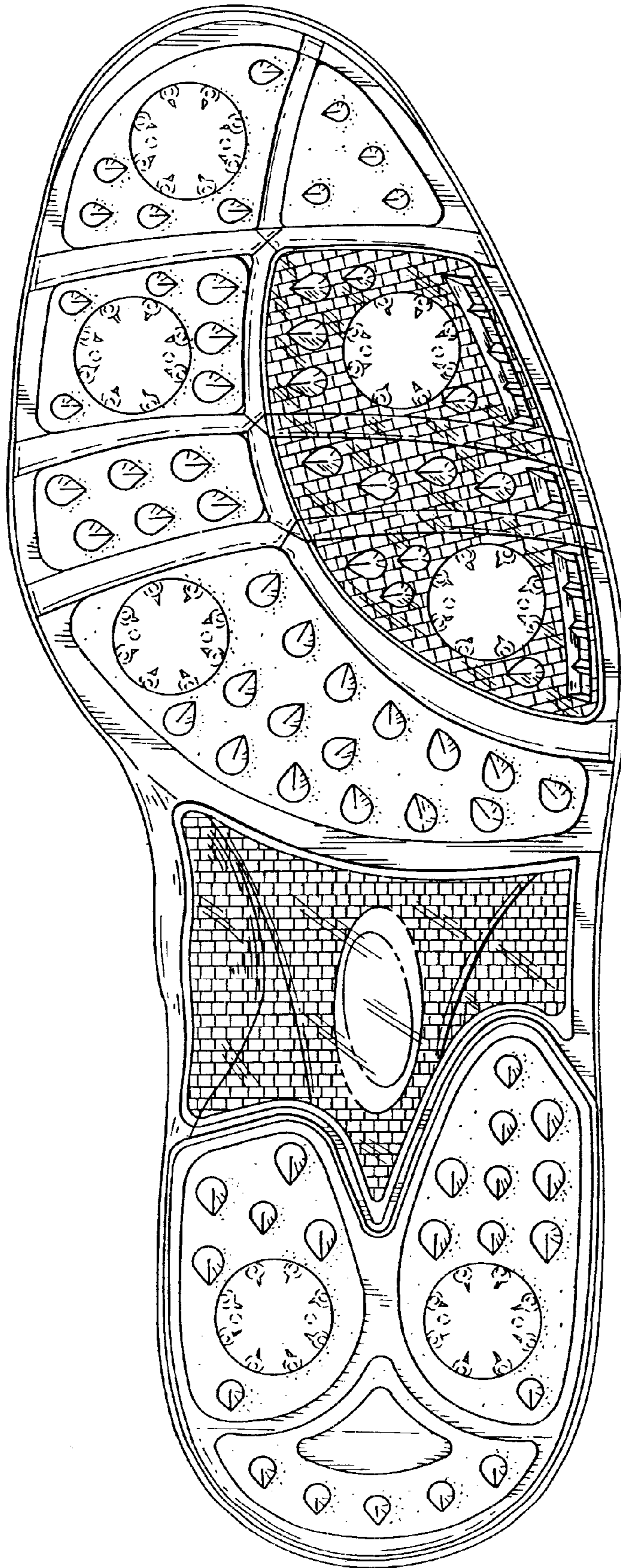

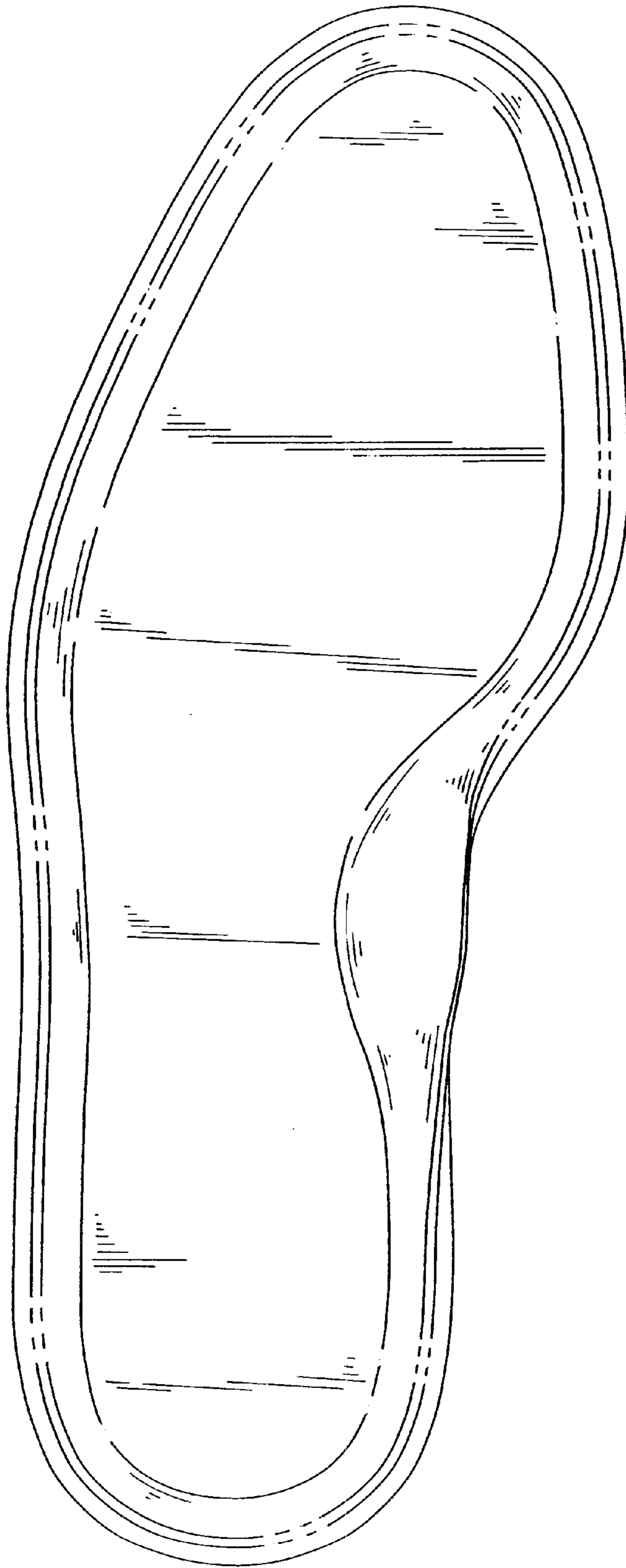

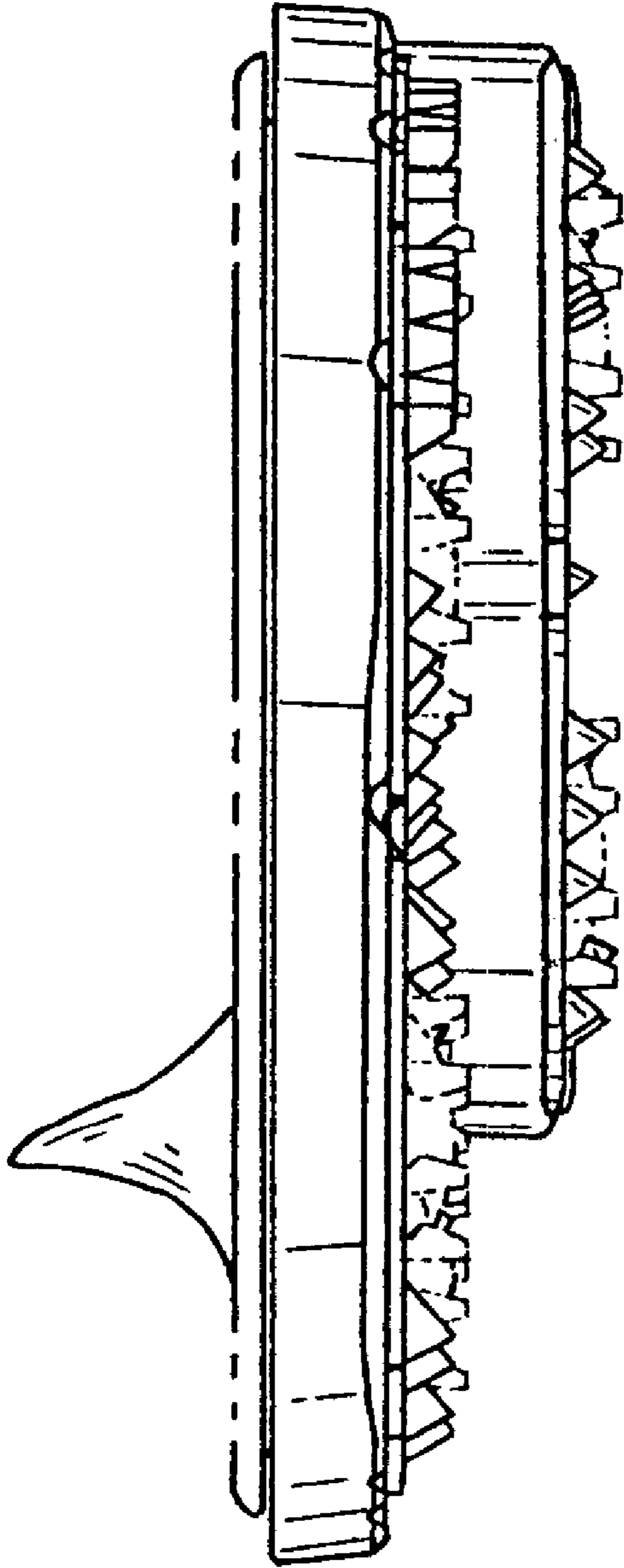

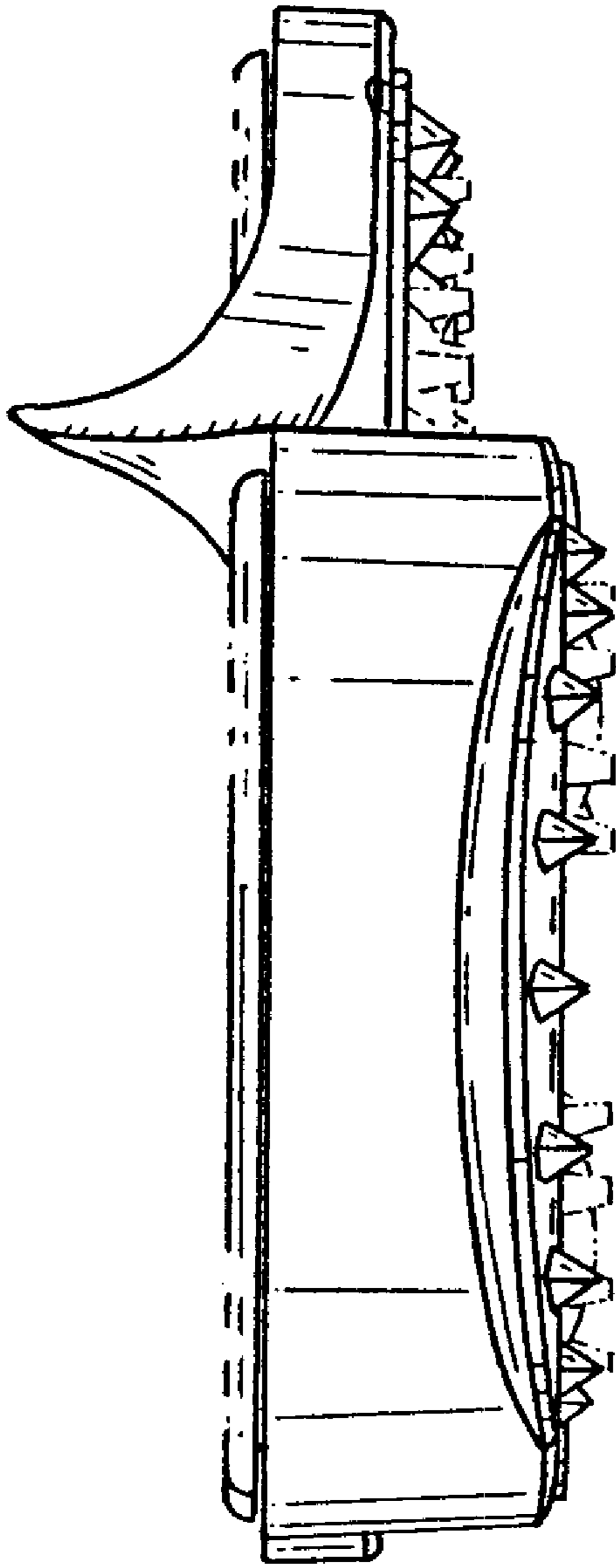

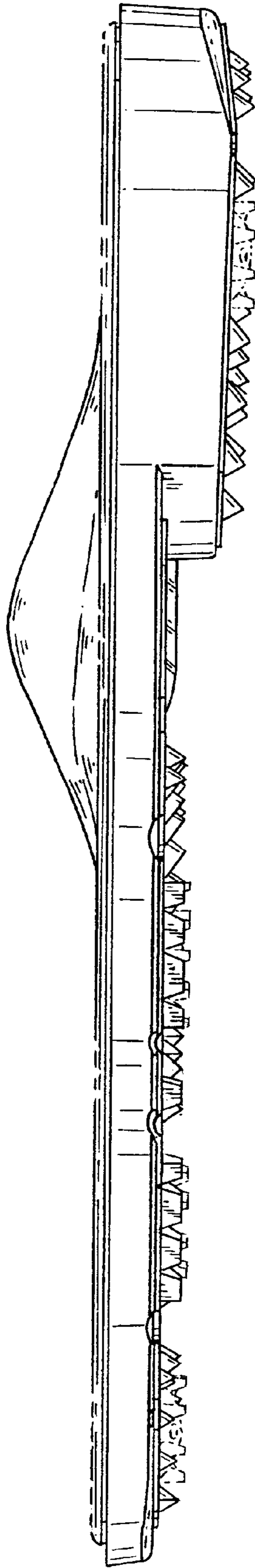

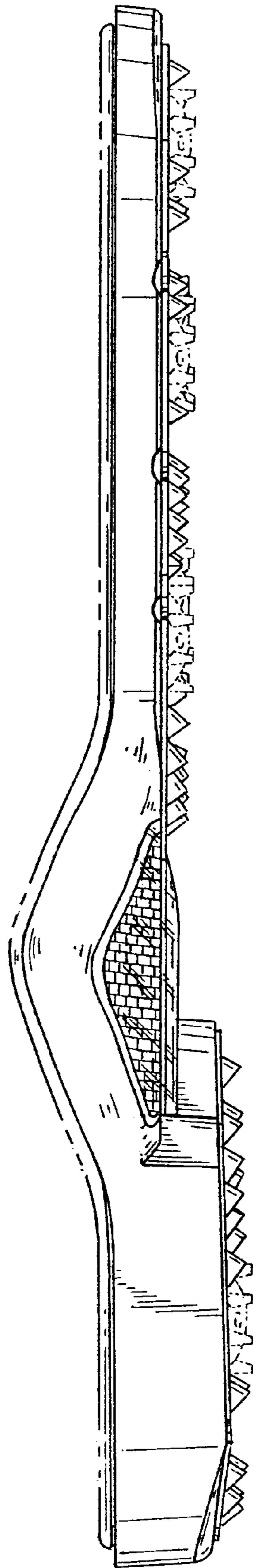
