(57) **CLAIM**

I claim the ornamental design for a container with brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, first side perspective view showing my new design for a container with brush according to a first embodiment;

FIG. 2 is a first side view of the container with brush of FIG. 1;

FIG. 3 is a second side view of the container with brush of FIG. 1;

FIG. 4 is a side view taken from the opposite side of FIG. 2;

FIG. 5 is a side view taken from the opposite side of FIG. 3;

FIG. 6 is a top plan view of the container with brush of FIG. 1;

FIG. 7 is a bottom plan view of the container with brush of FIG. 1;

FIG. 8 is a top, first side perspective view showing my new design for a container with brush according to a second embodiment;

FIG. 9 is a first side view of the container with brush of FIG. 8;

FIG. 10 is a second side view of the container with brush of FIG. 8;

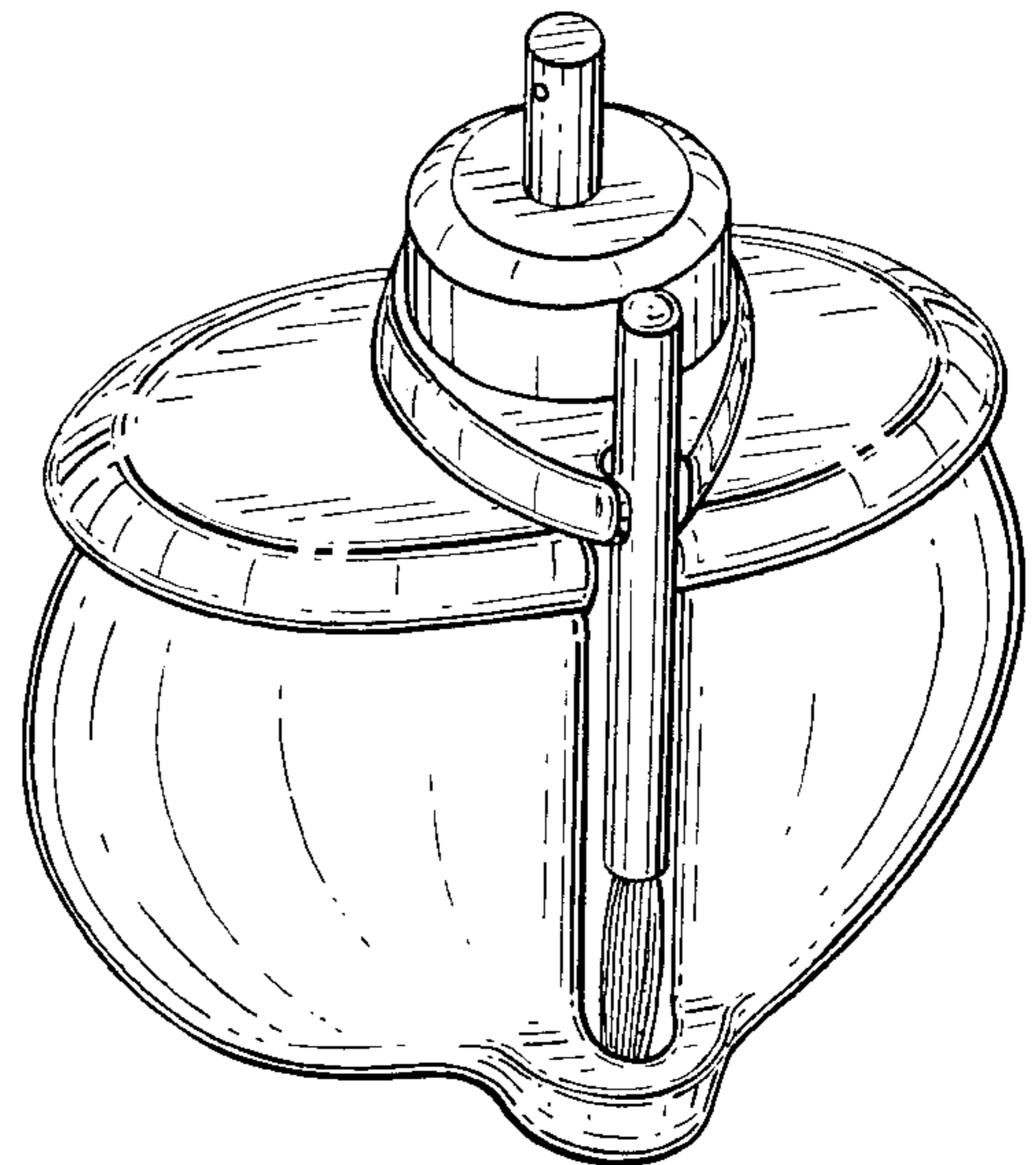
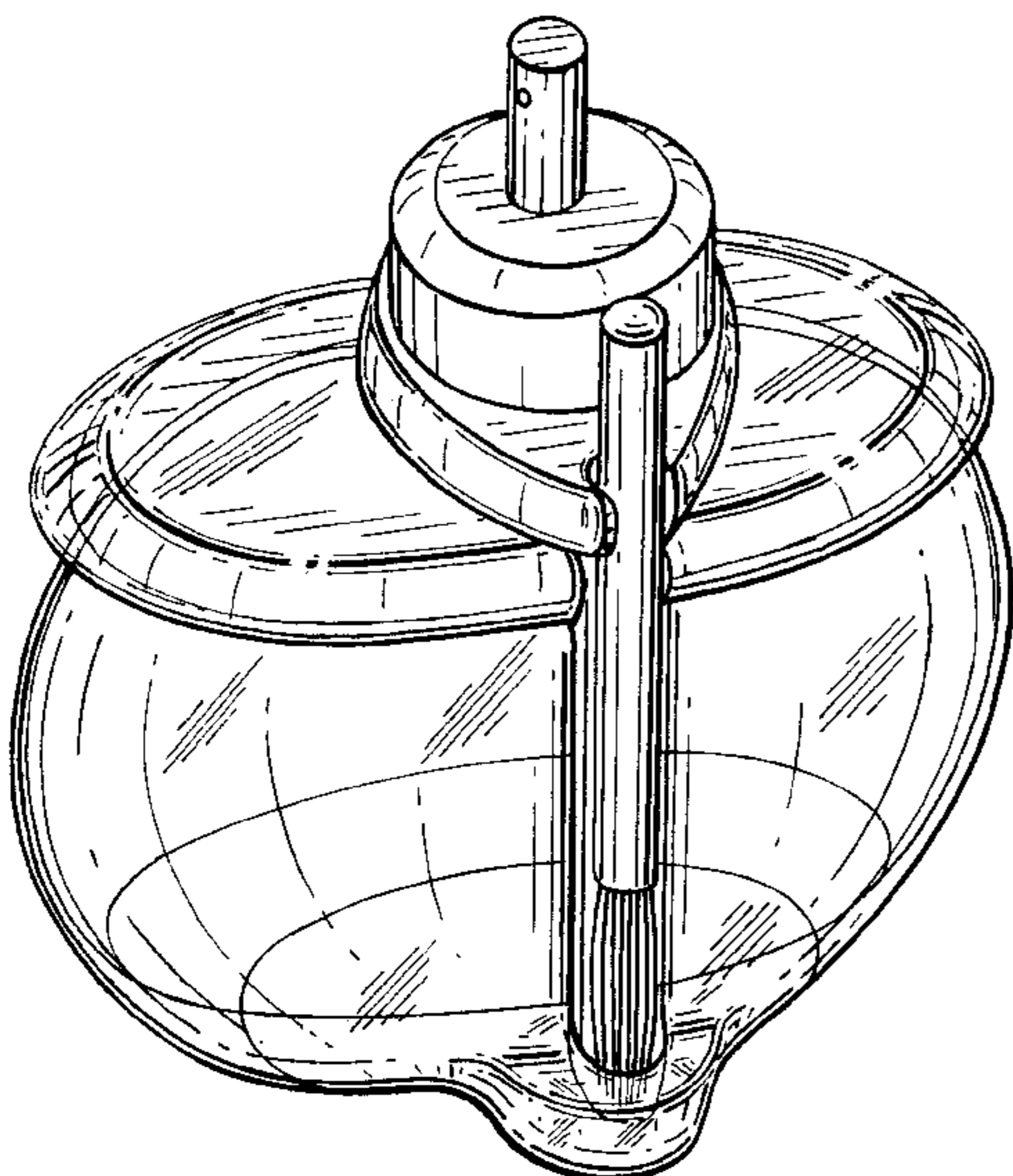
FIG. 11 is a side view taken from the opposite side of FIG. 9;

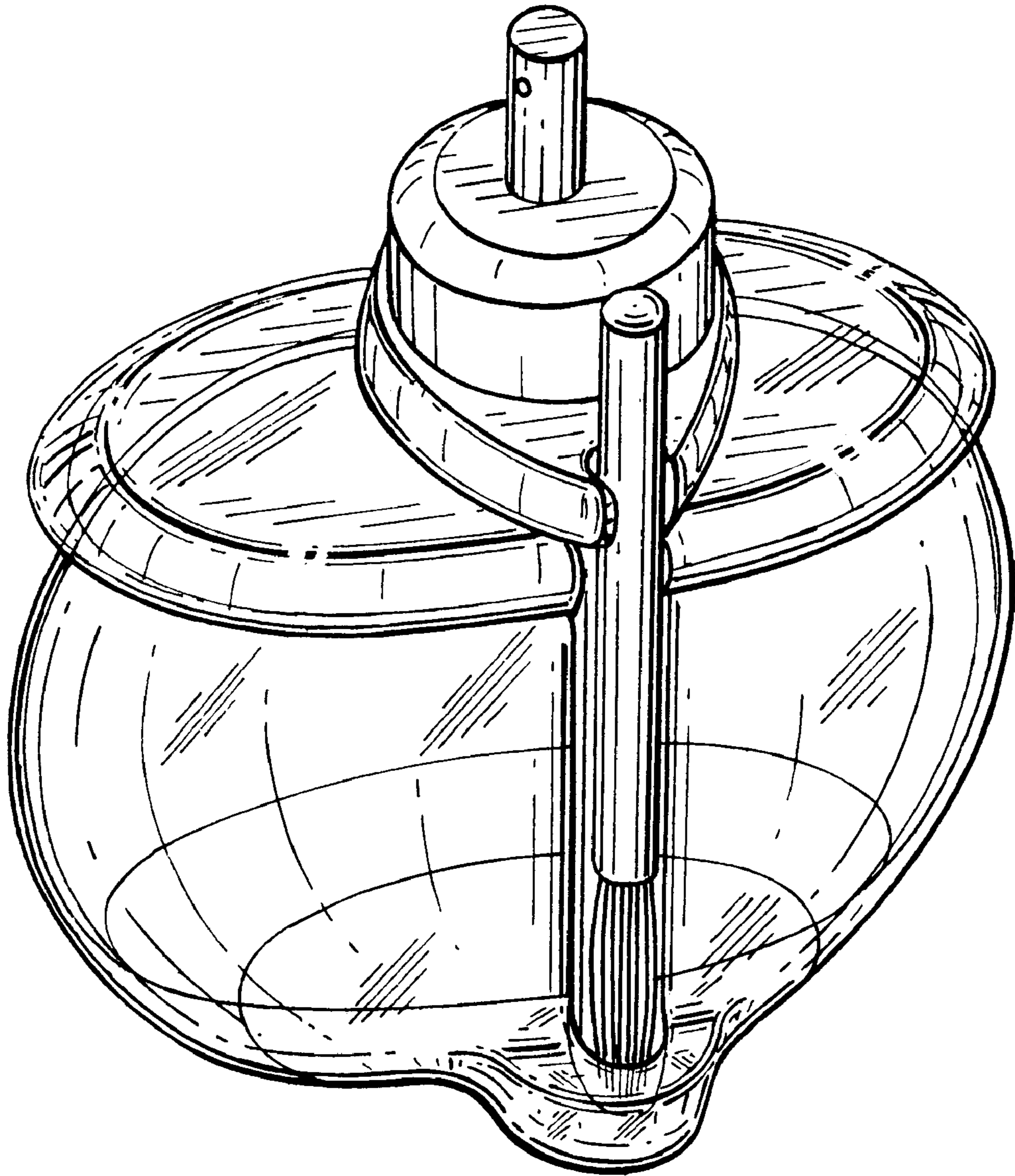

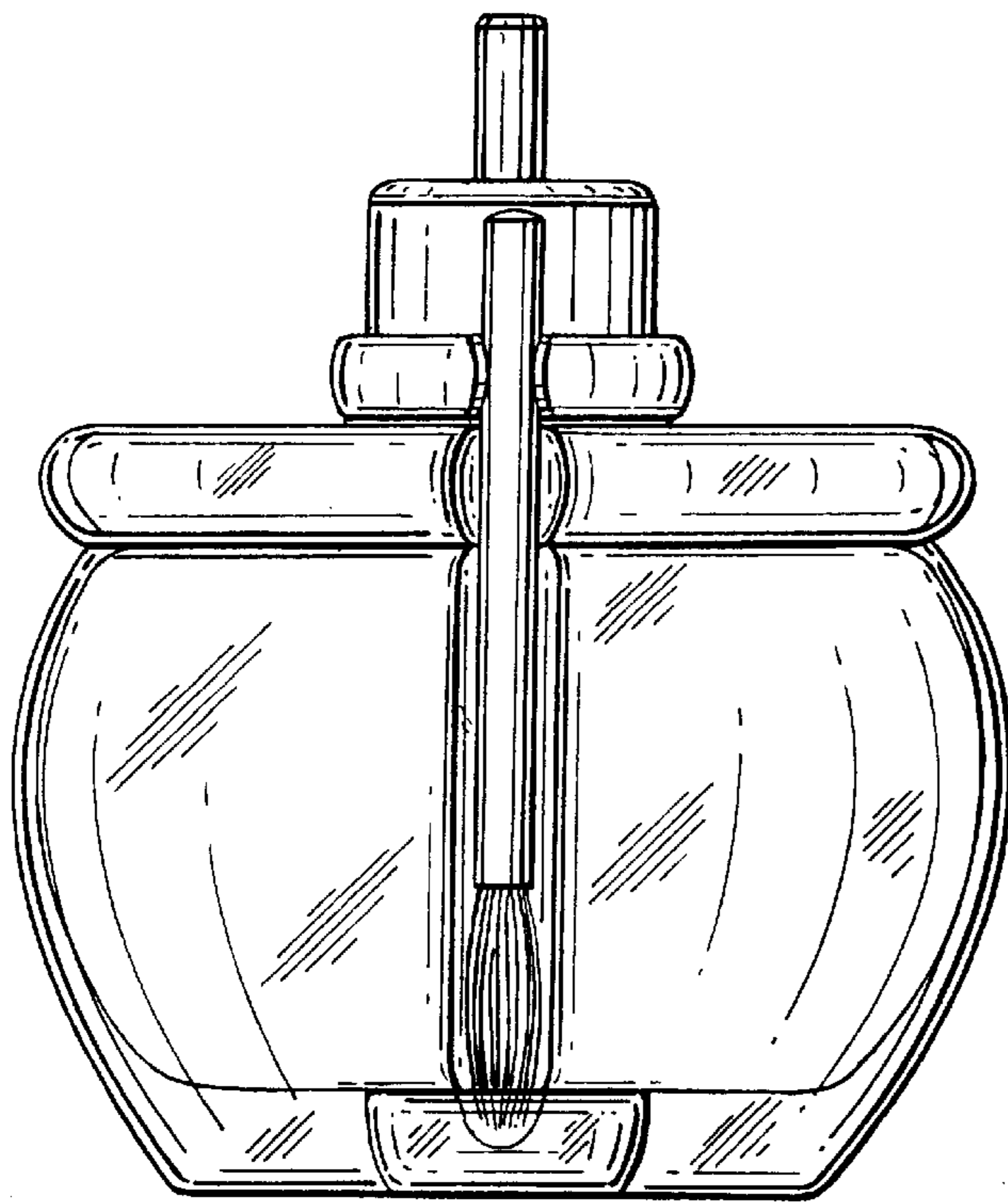

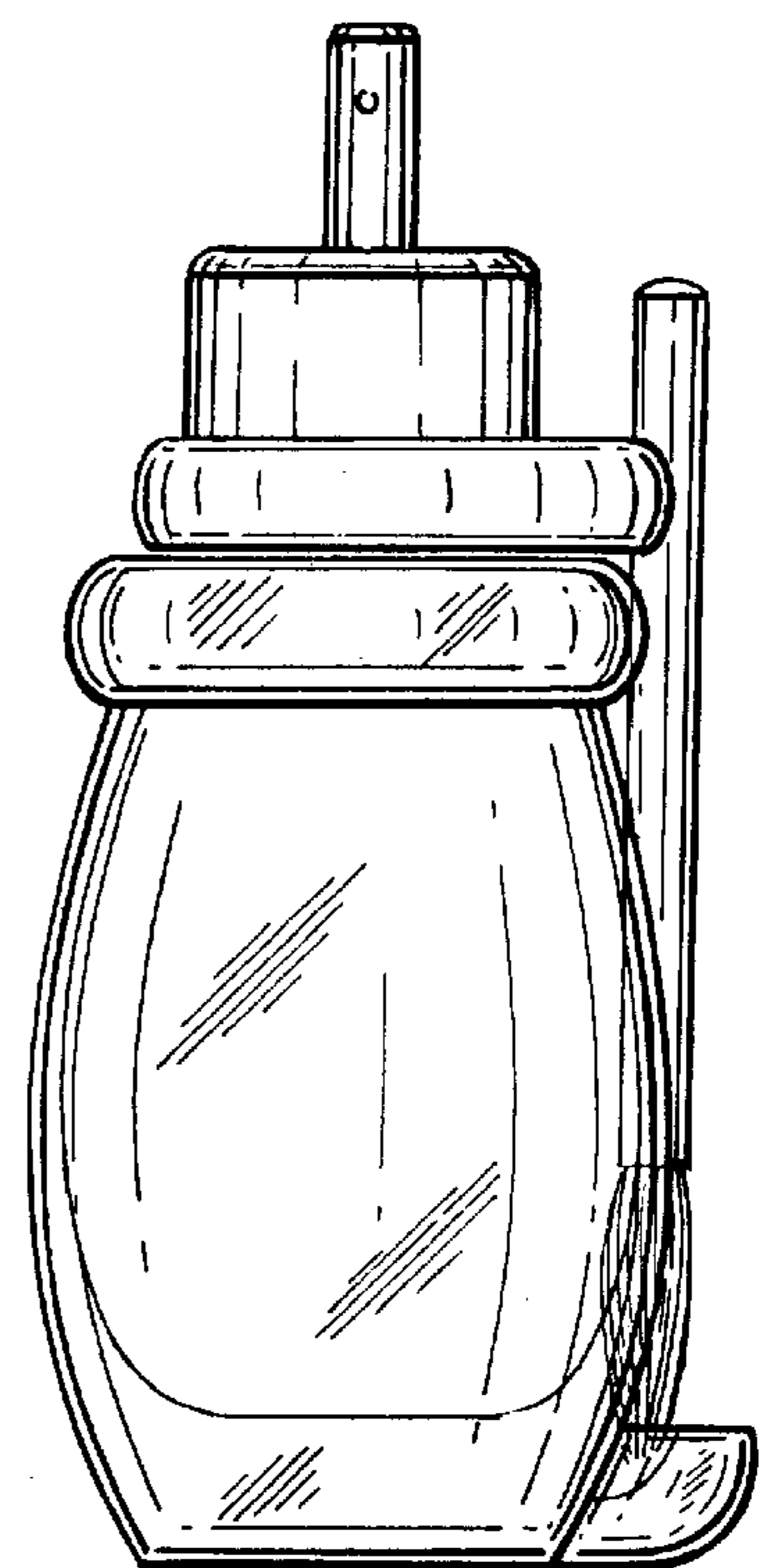

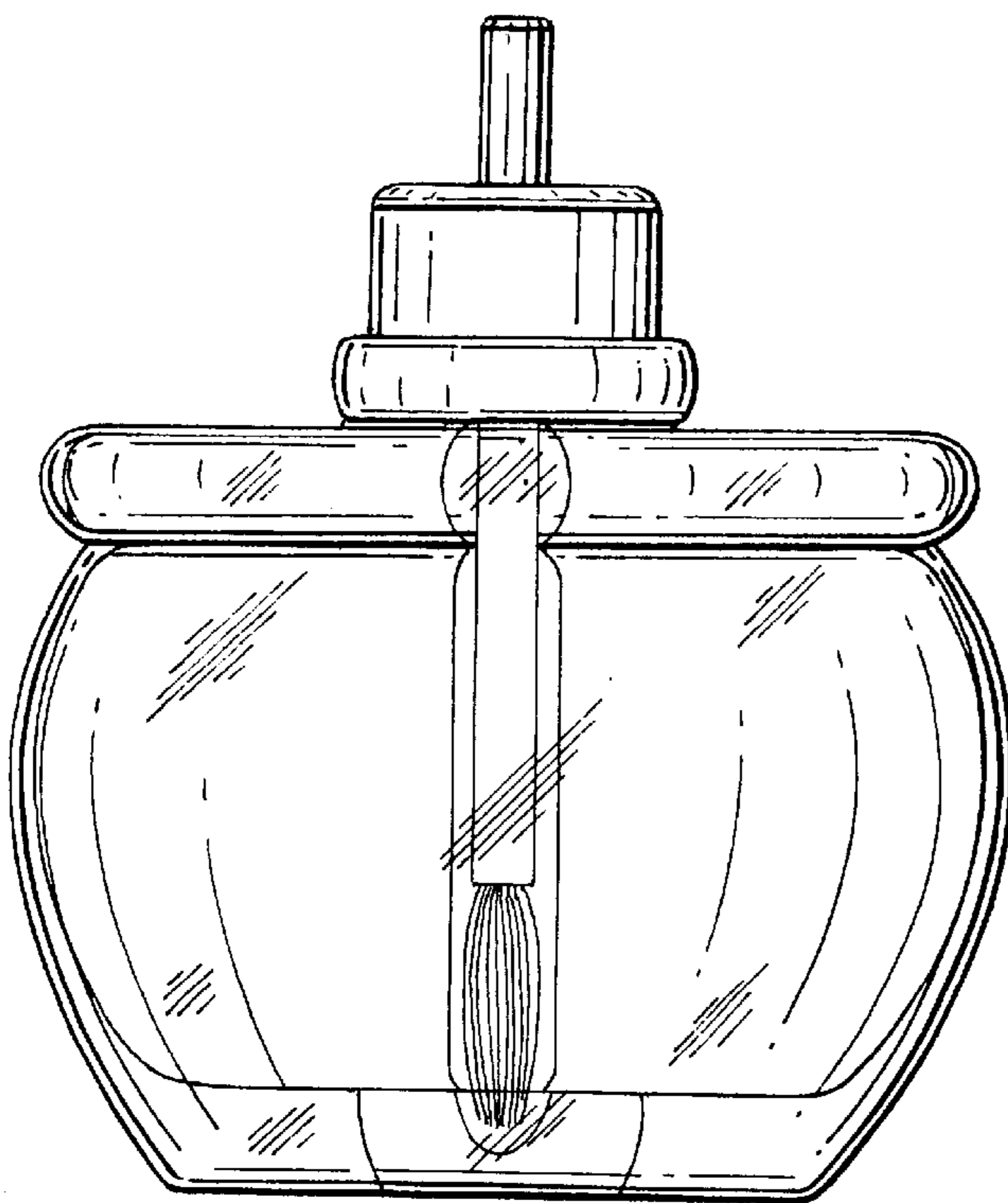

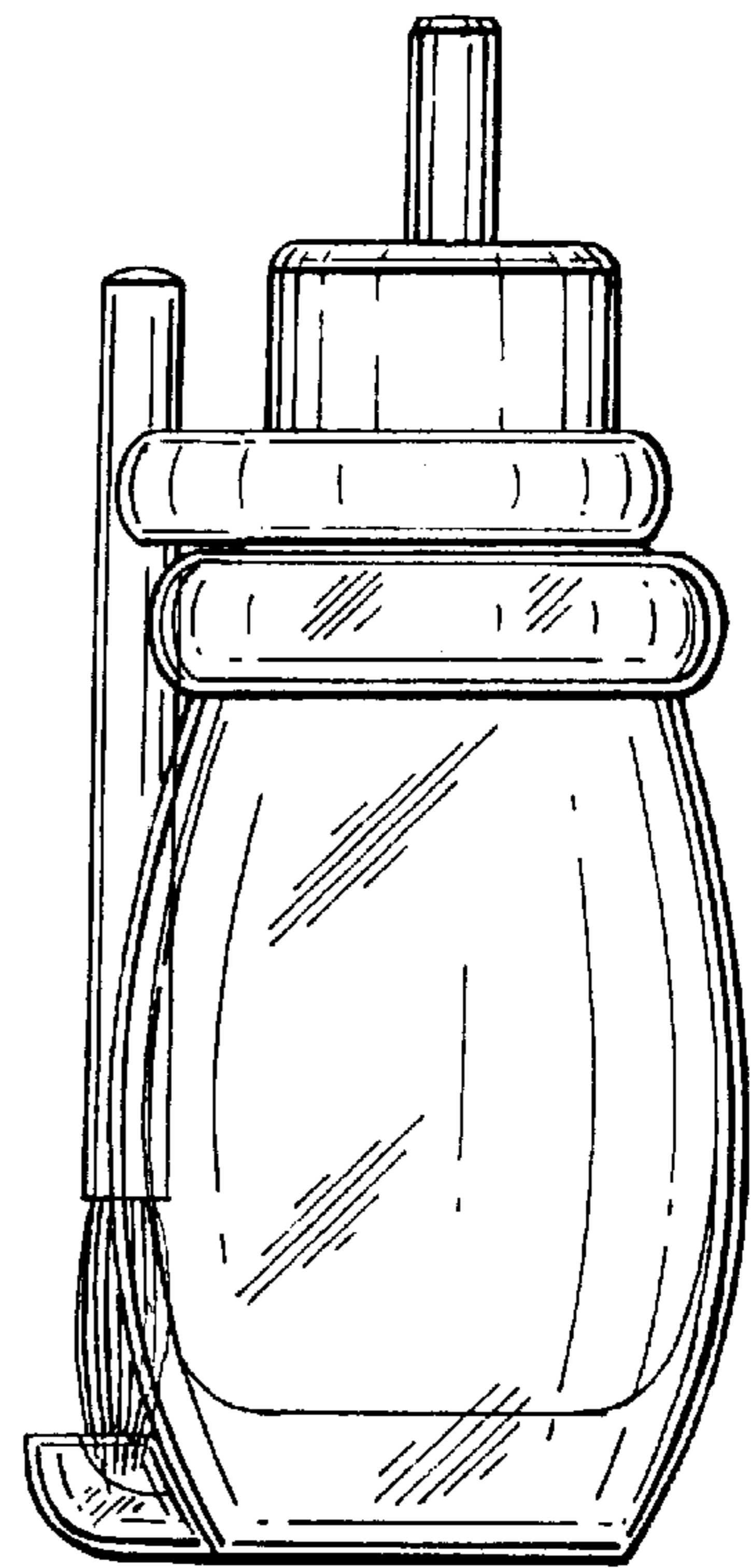

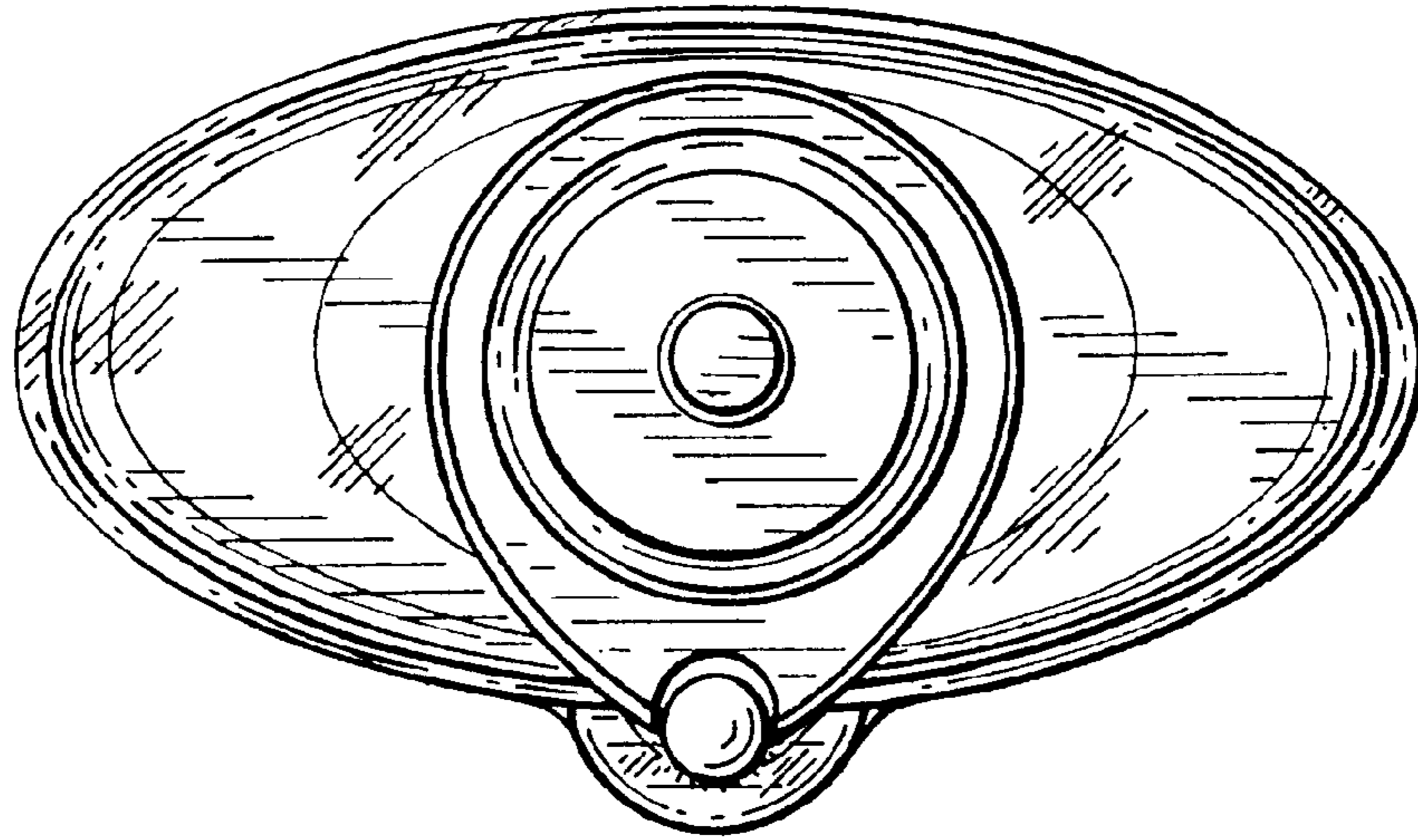

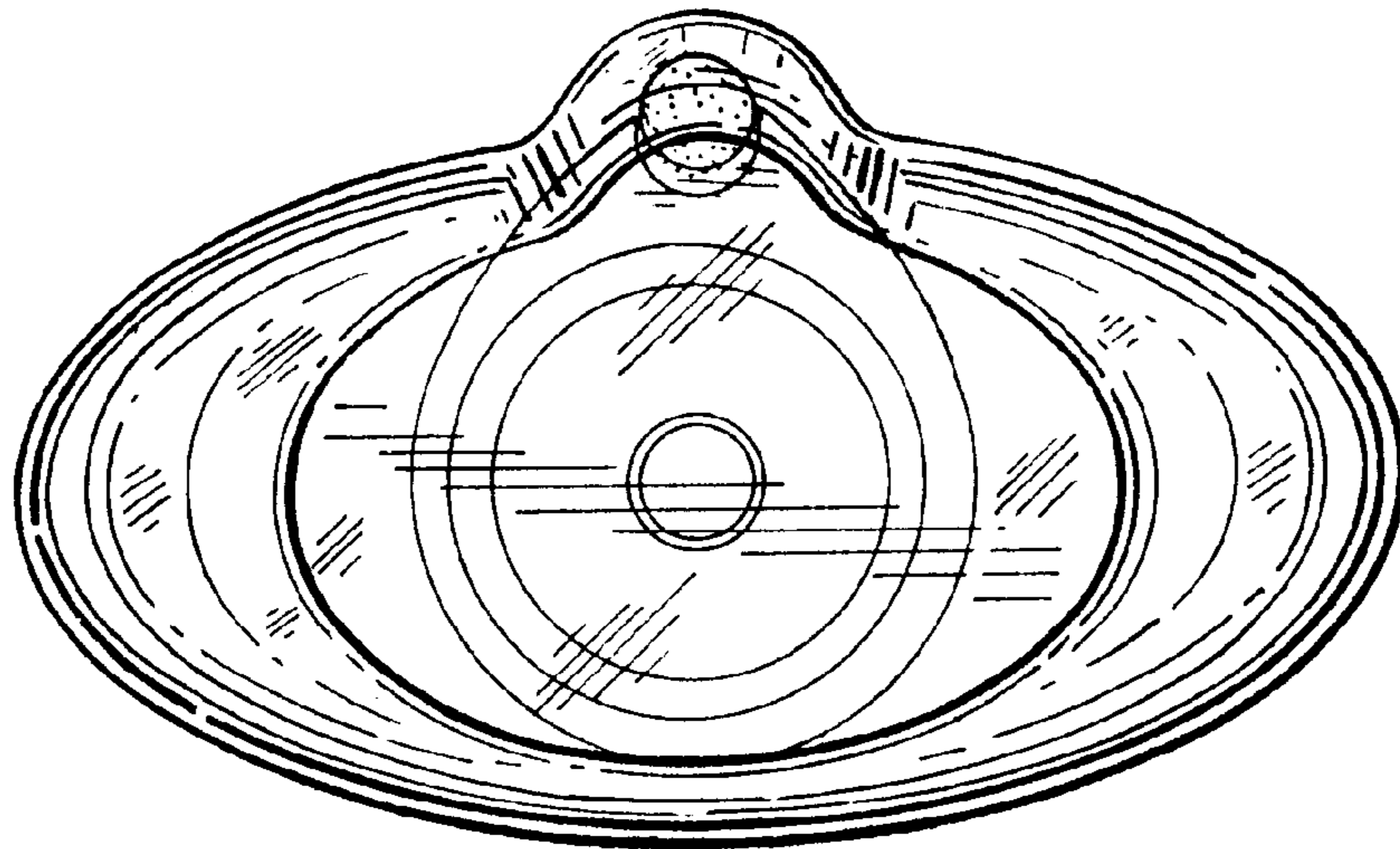

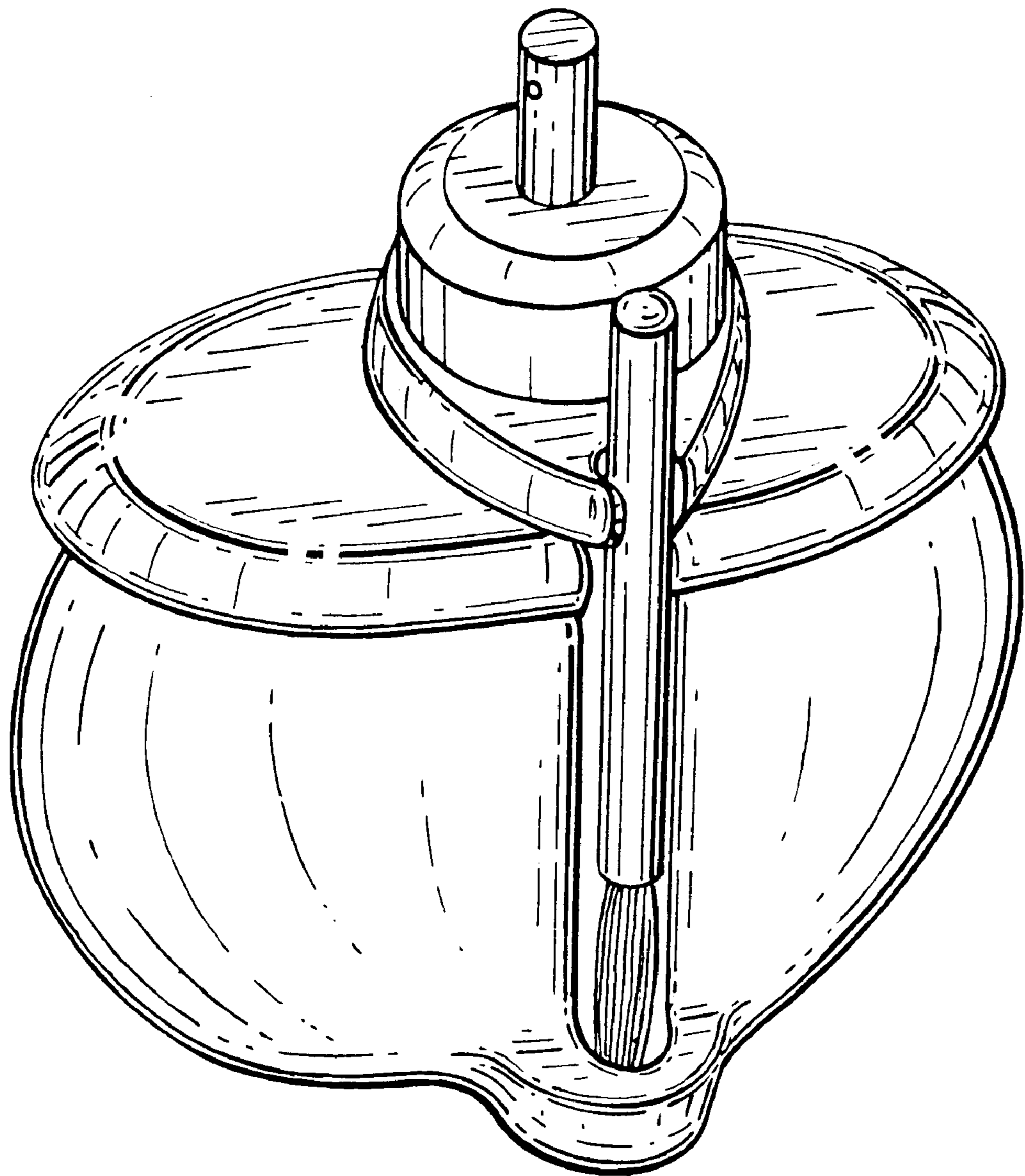

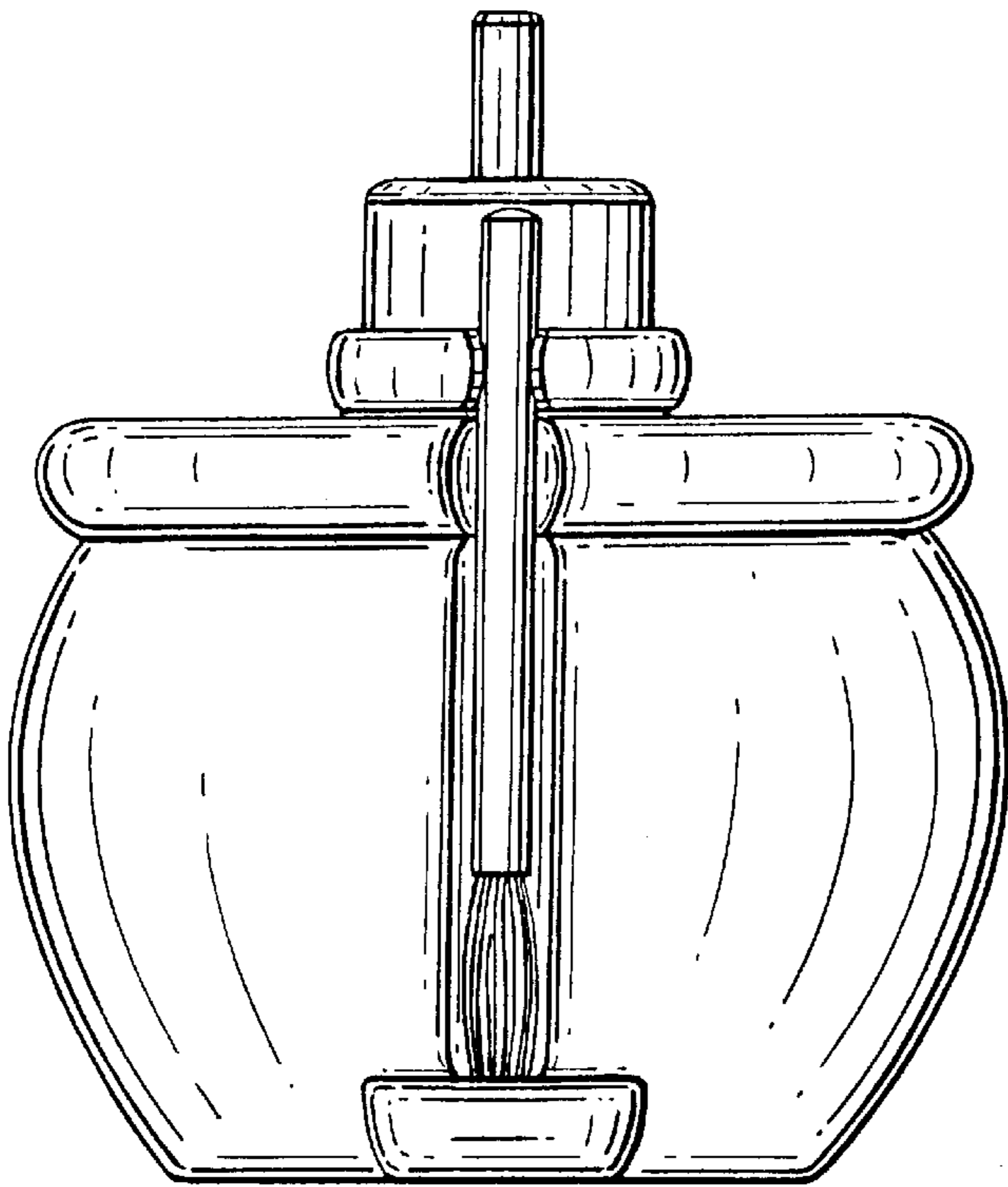

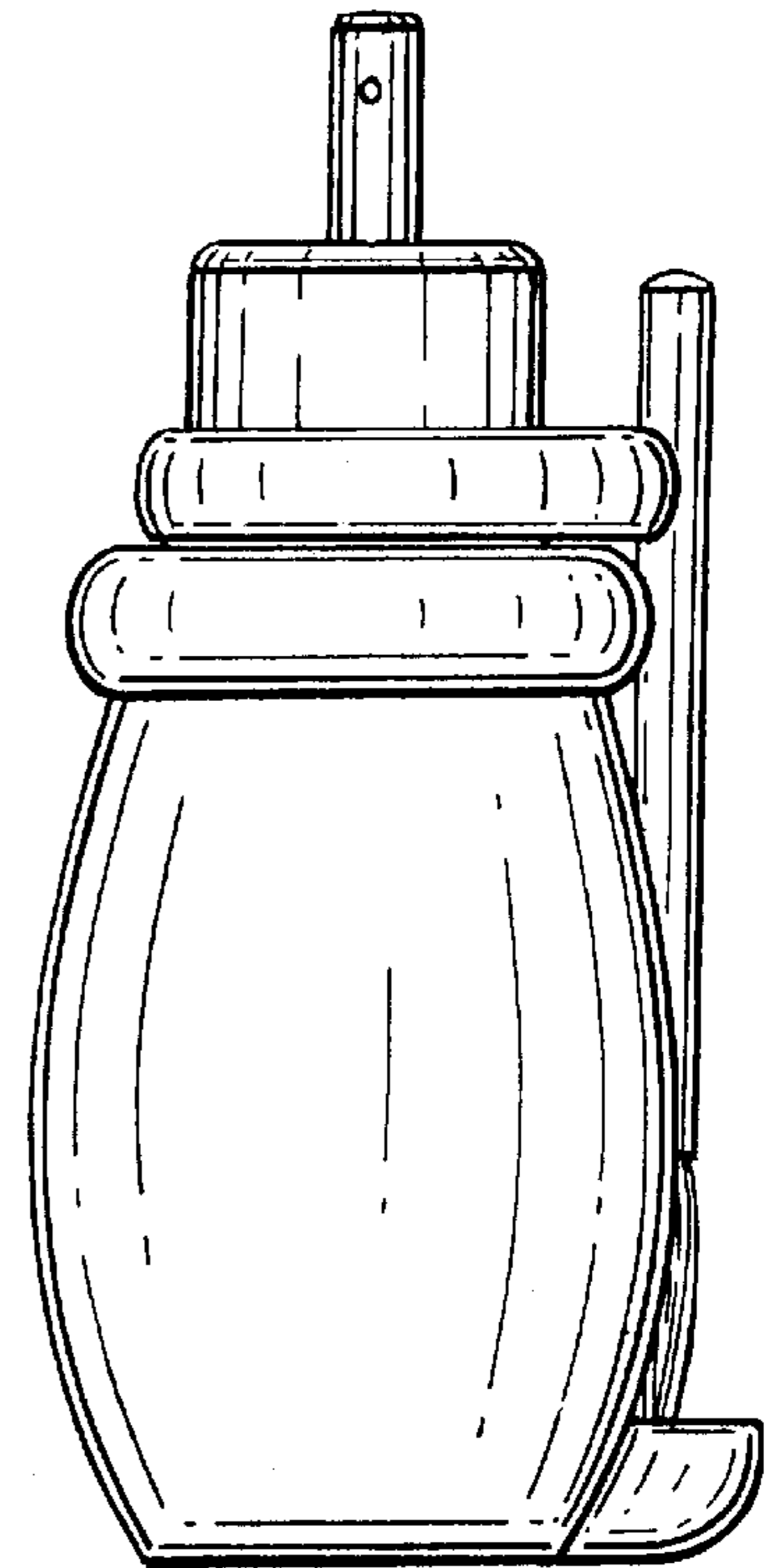

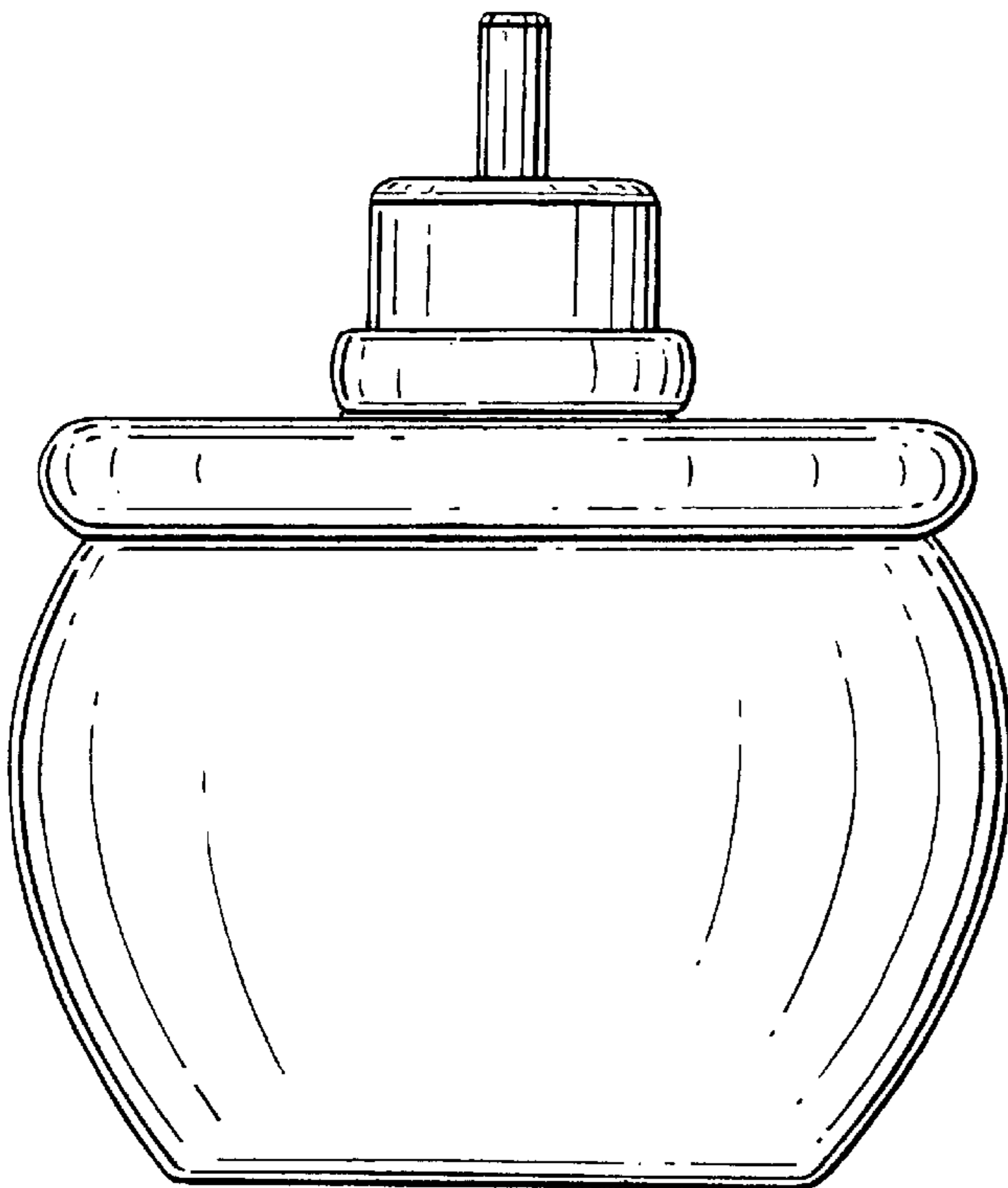

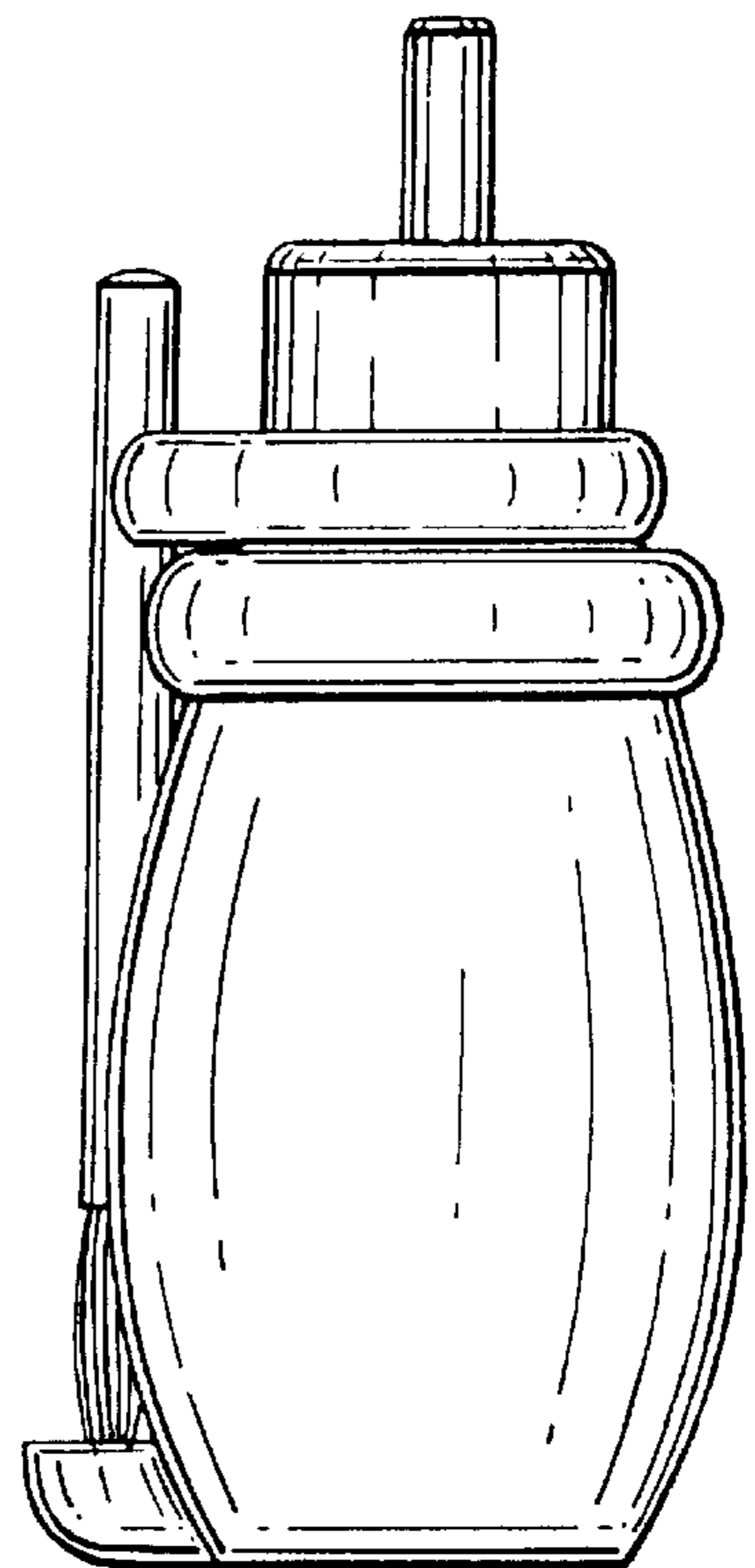

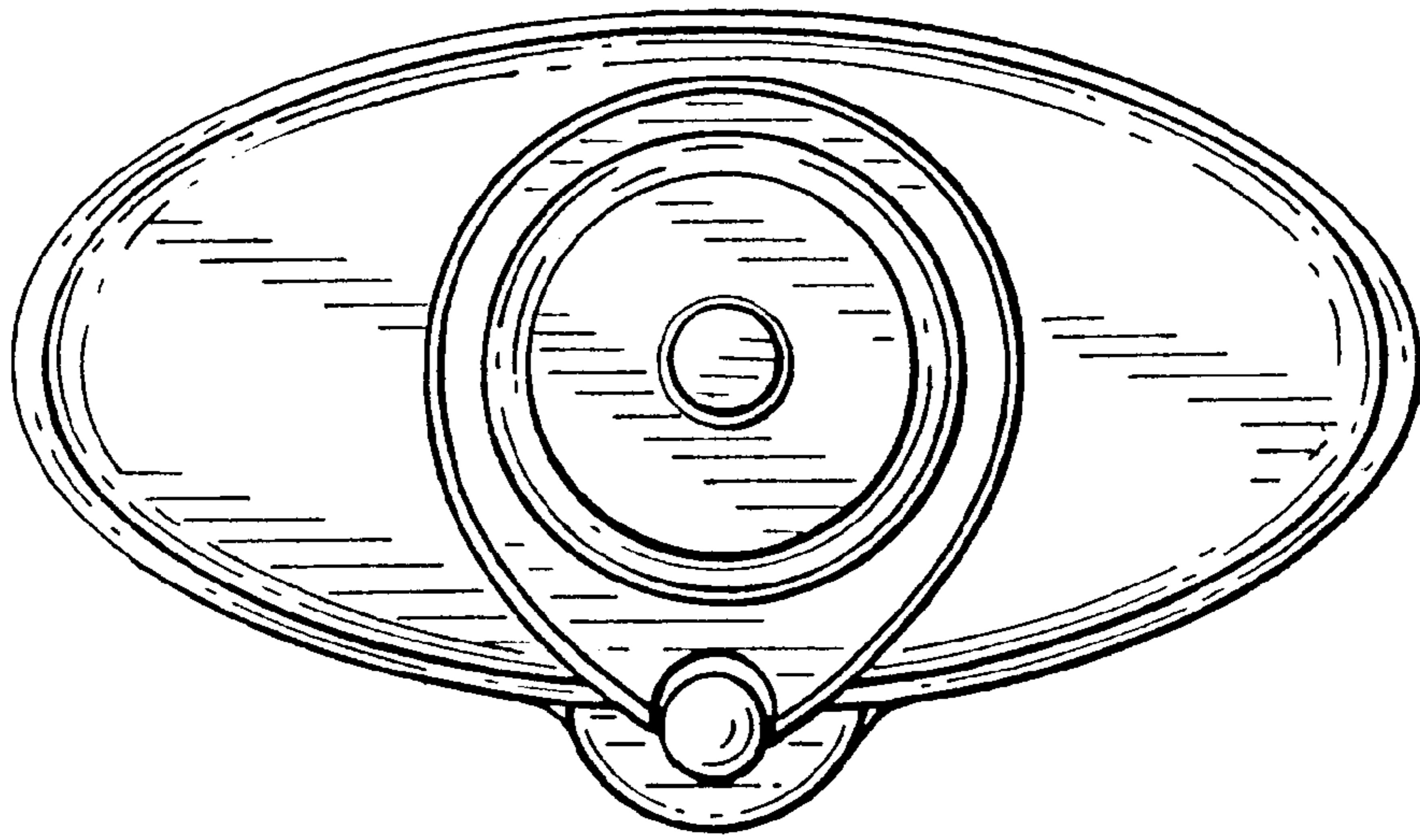

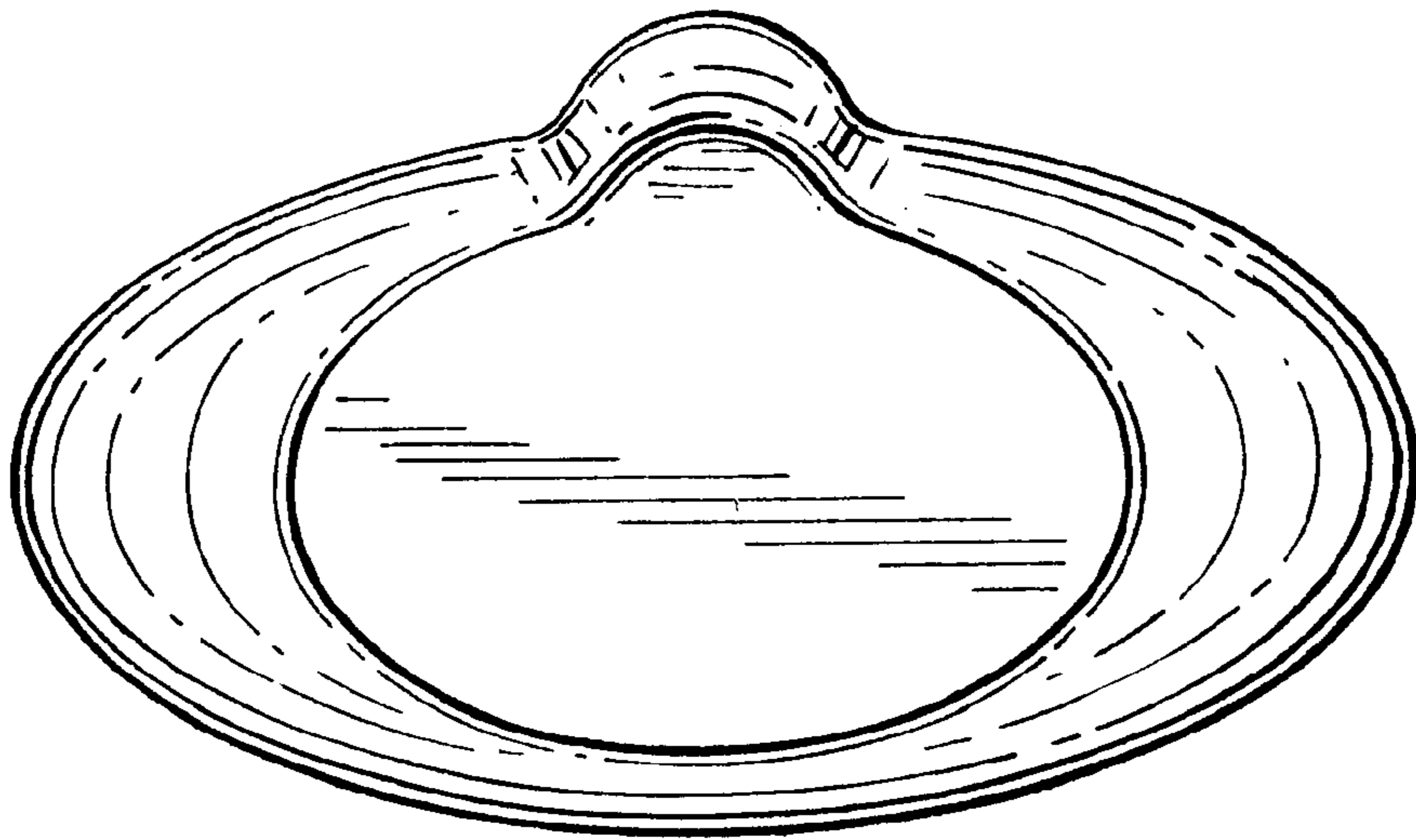
