The ornamental design for beverage mug with slide open lid, as shown and described.

DESCRIPTION

FIG. 1 is a upper right front perspective view of the beverage mug with slide open lid of the invention;

FIG. 3 is a front view of the beverage mug of FIG. 1.

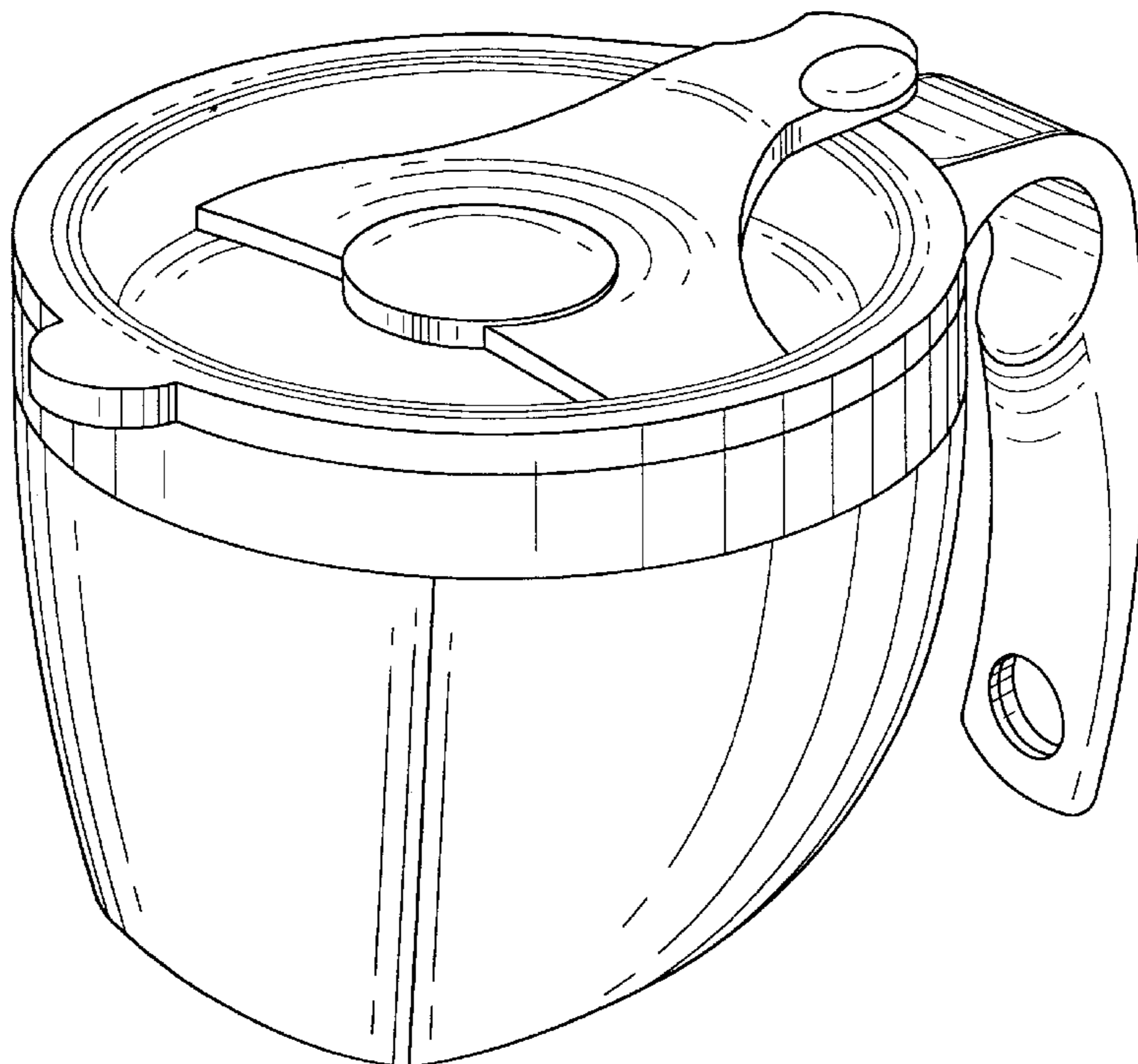
FIG. 4 is a rear view of the beverage mug of FIG. 1.

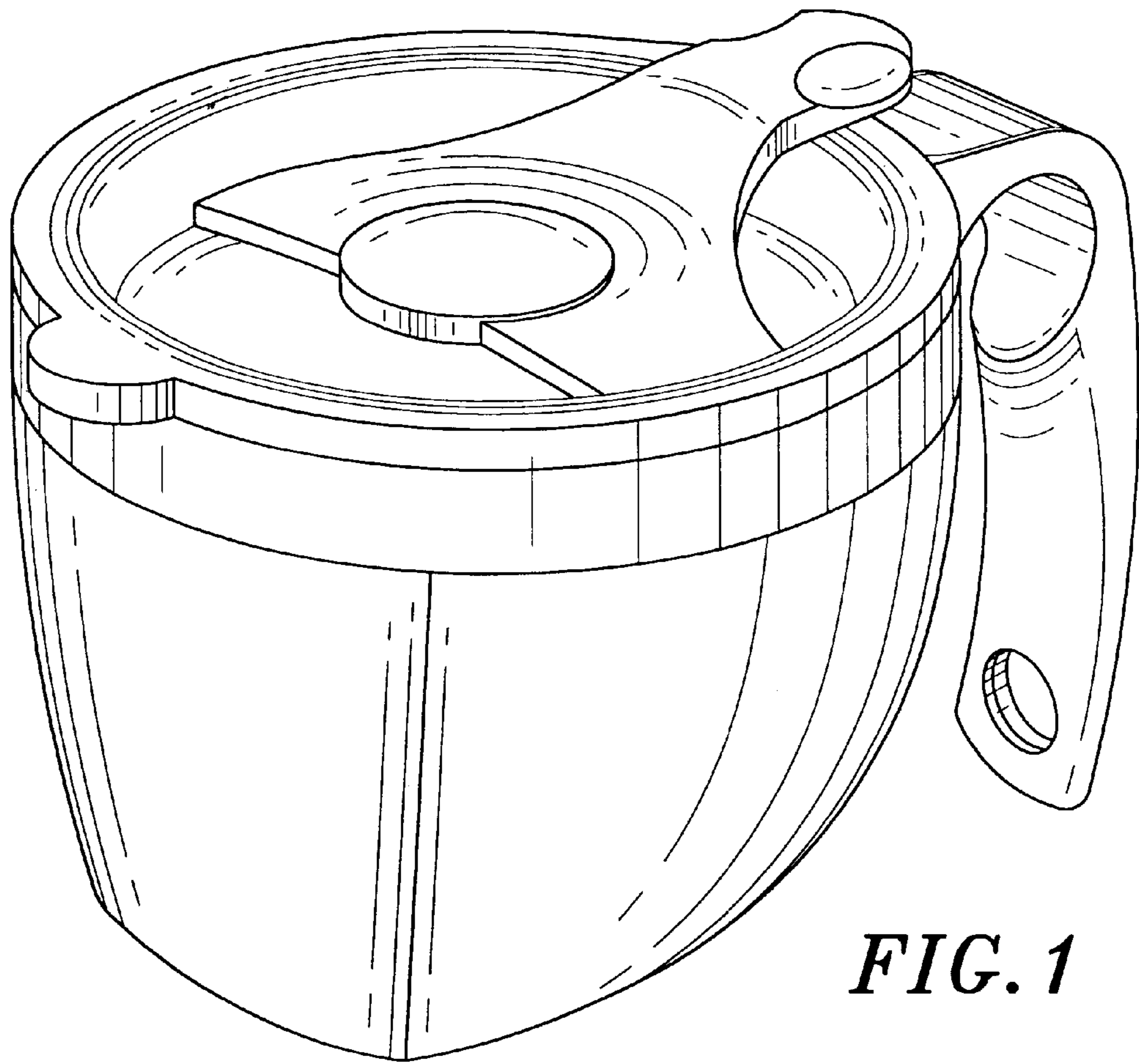

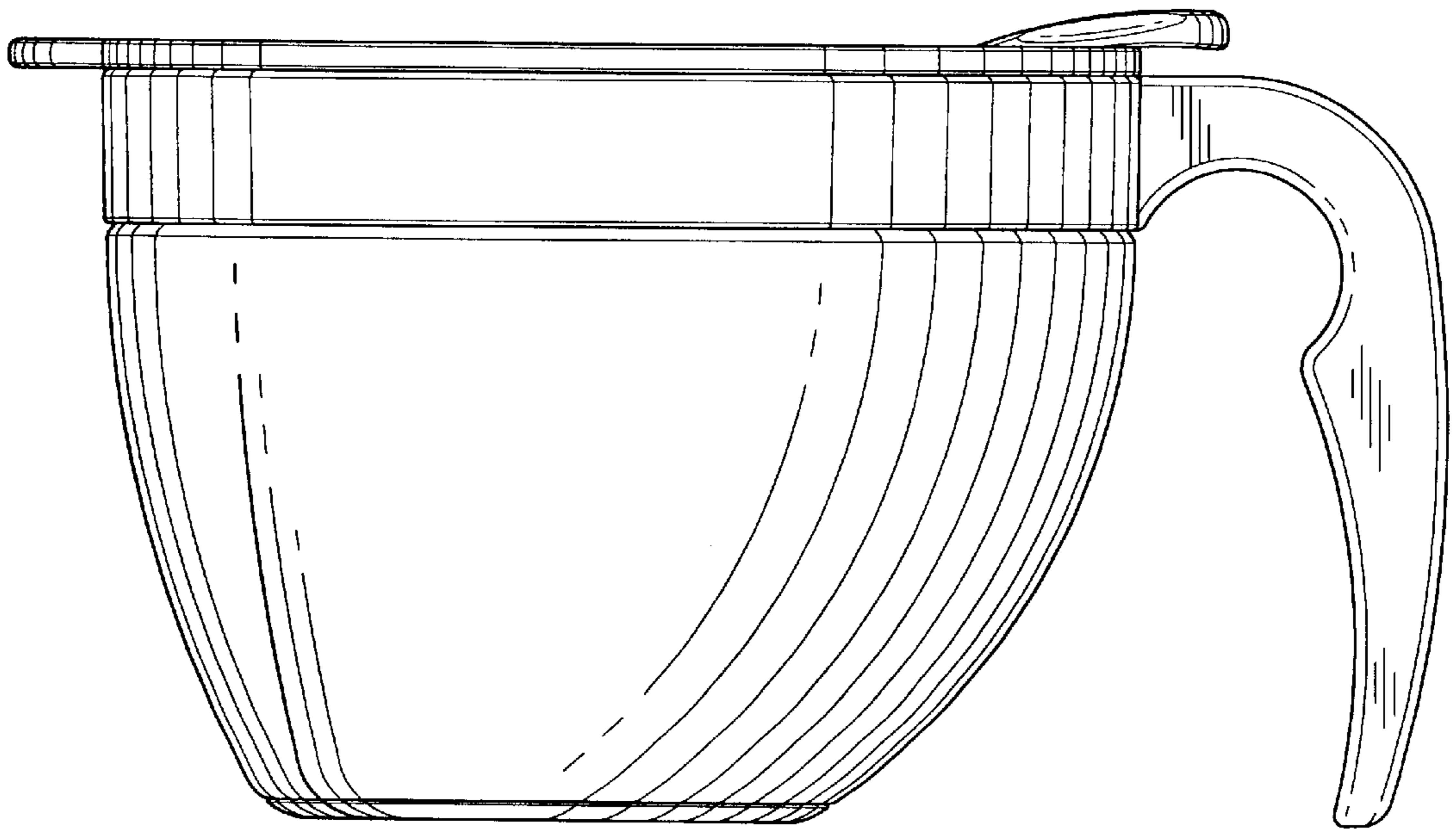

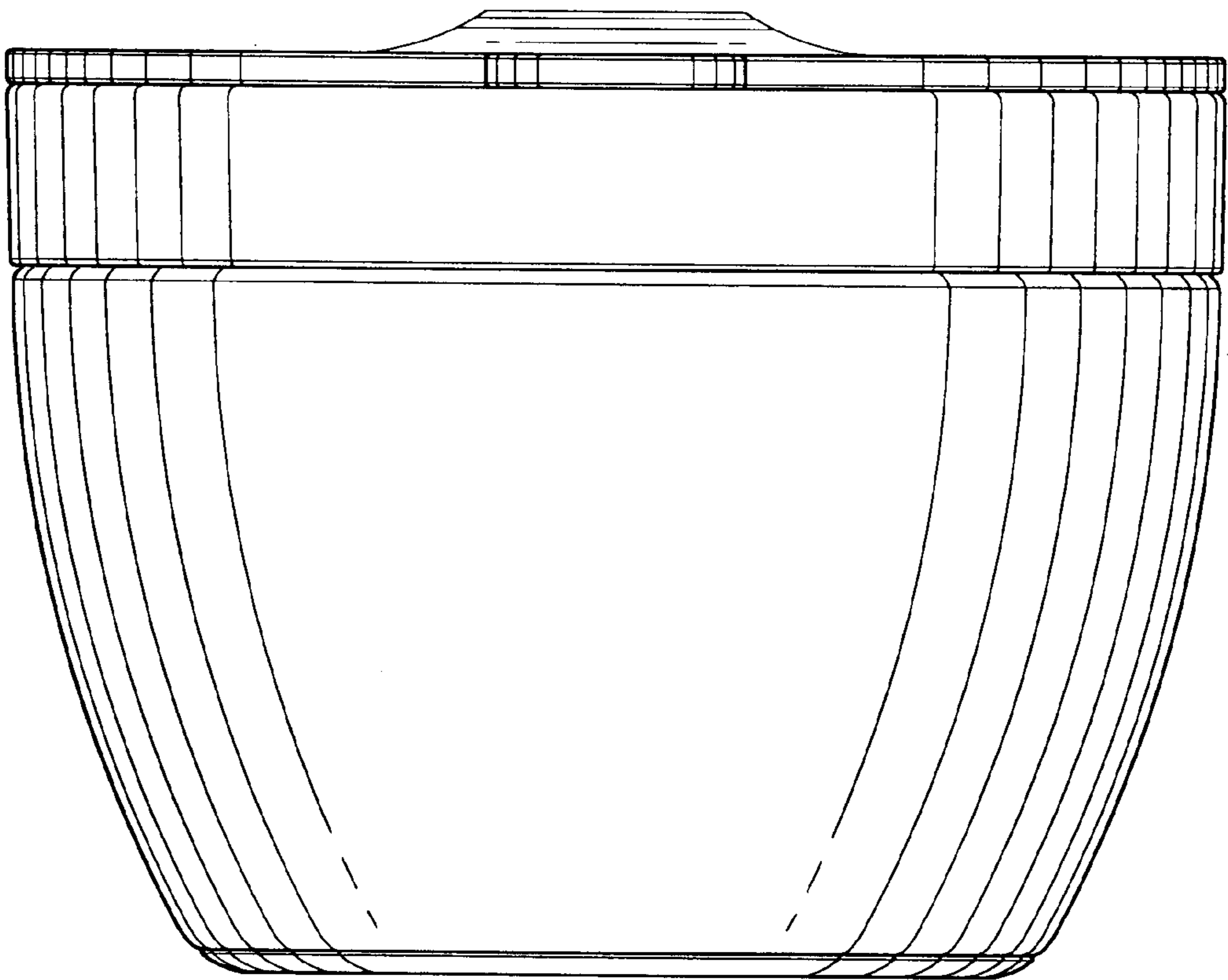

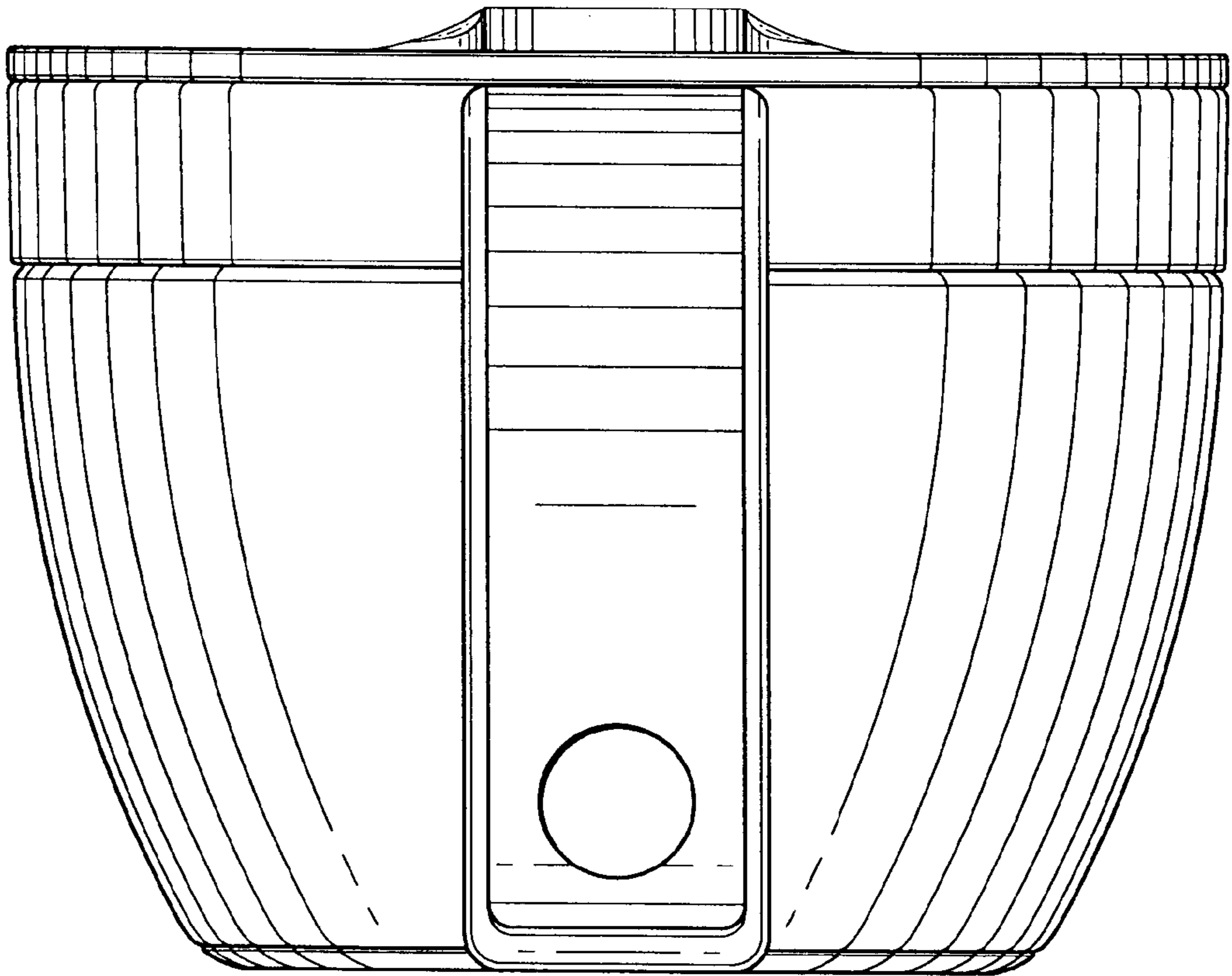
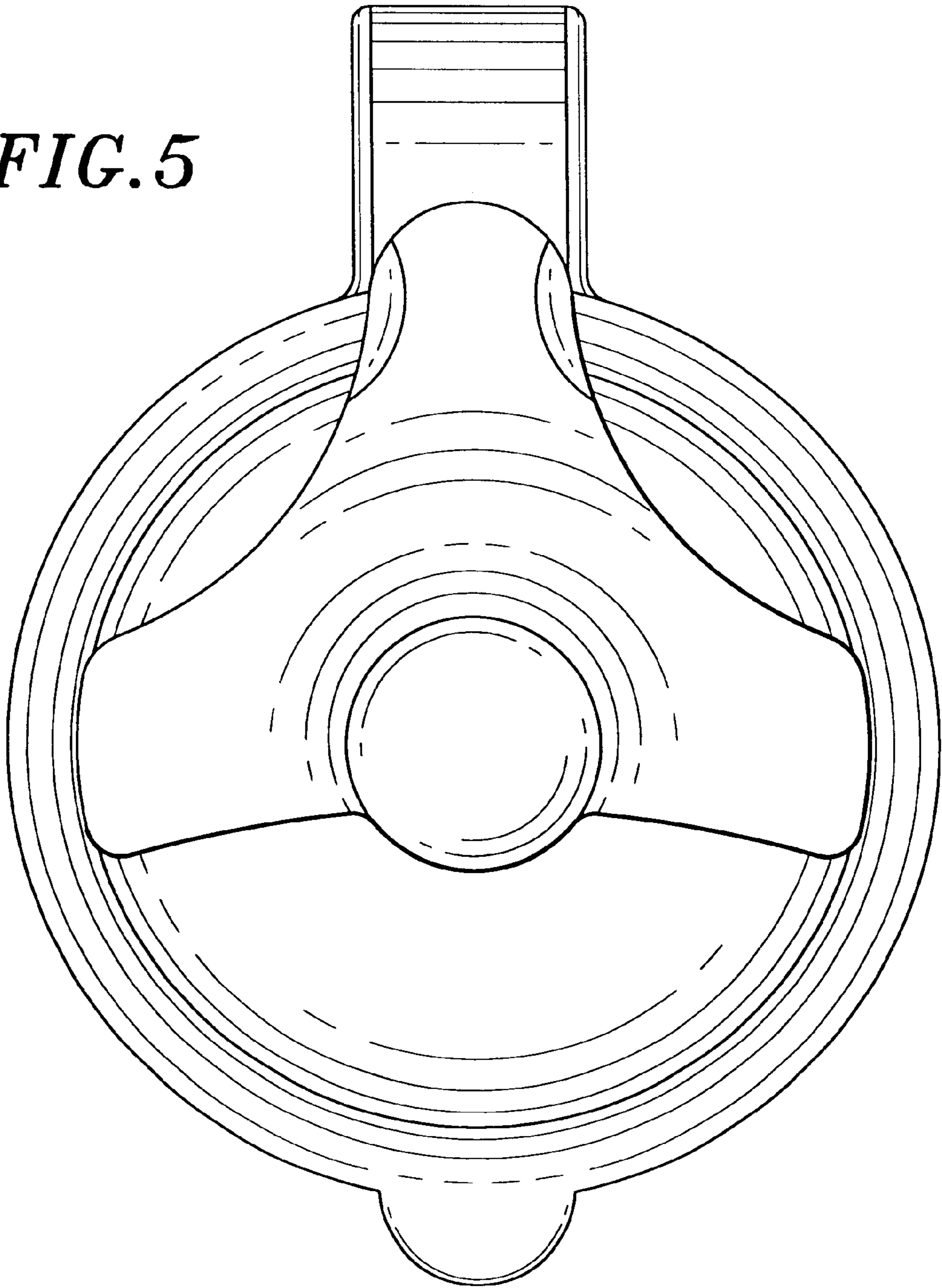

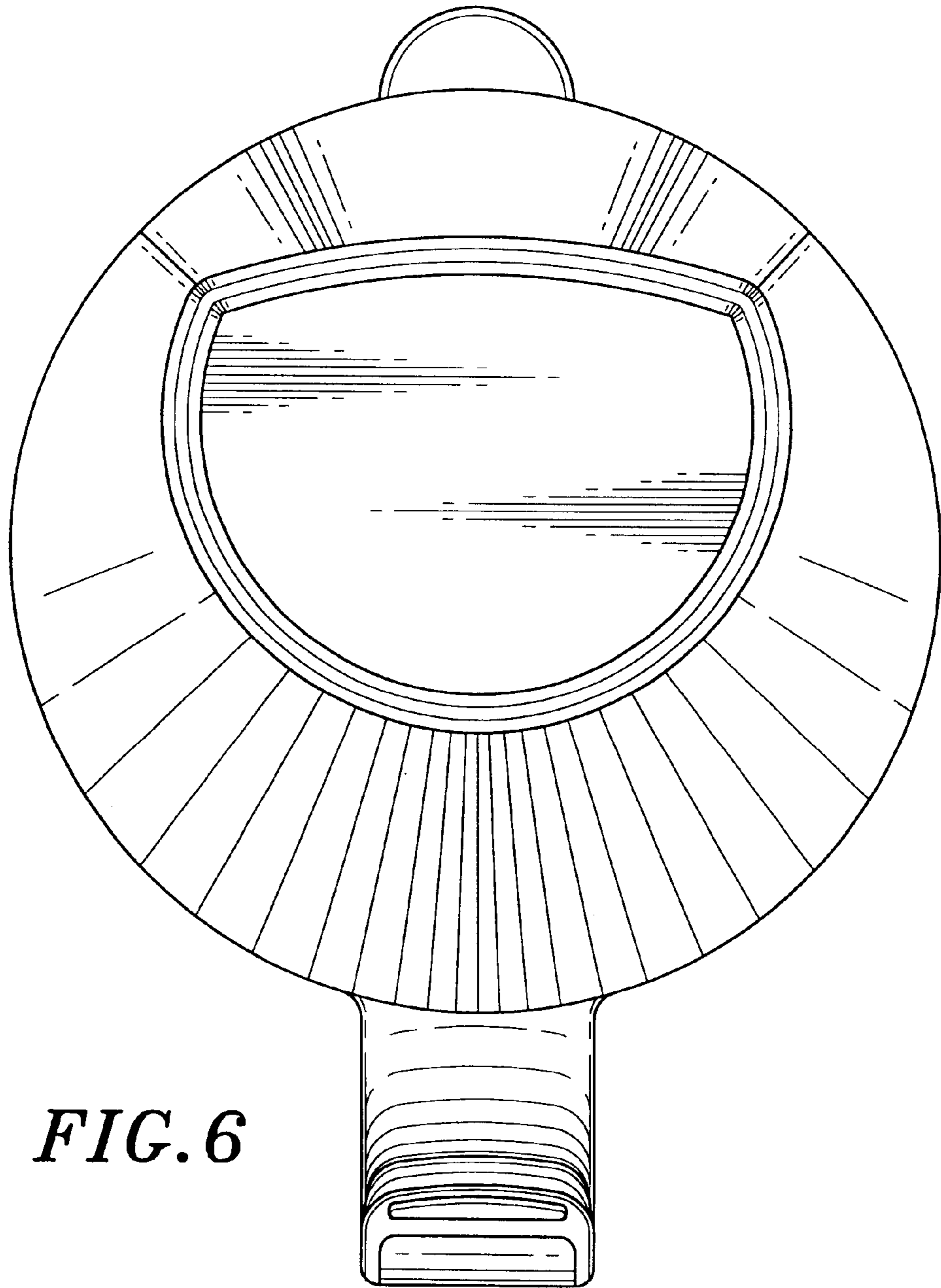
