**DESCRIPTION**

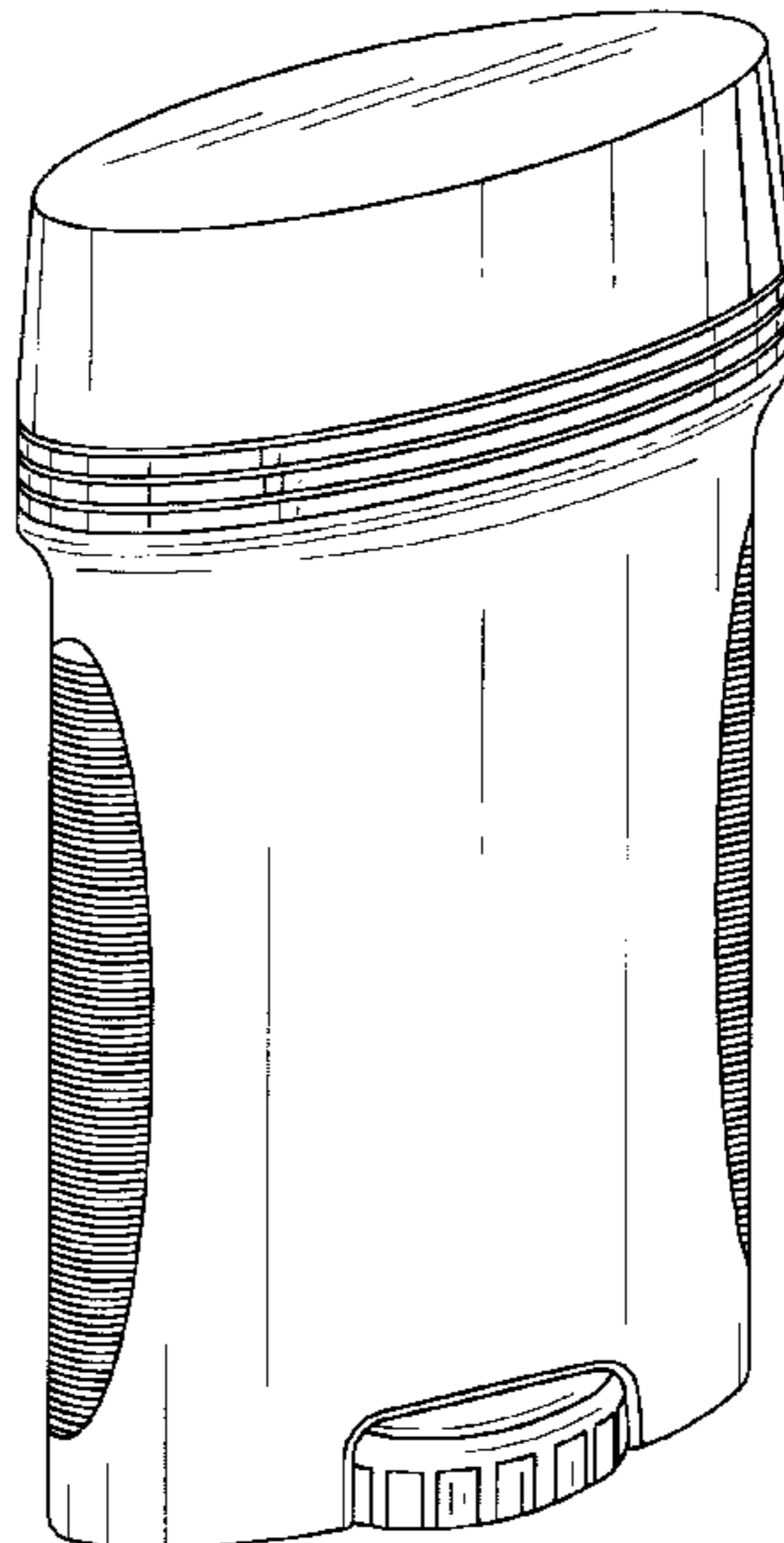
FIG. 1 is a perspective view of the dispenser of my design. FIG. 2 is a right side elevation view thereof; the left side being a mirror image thereof.

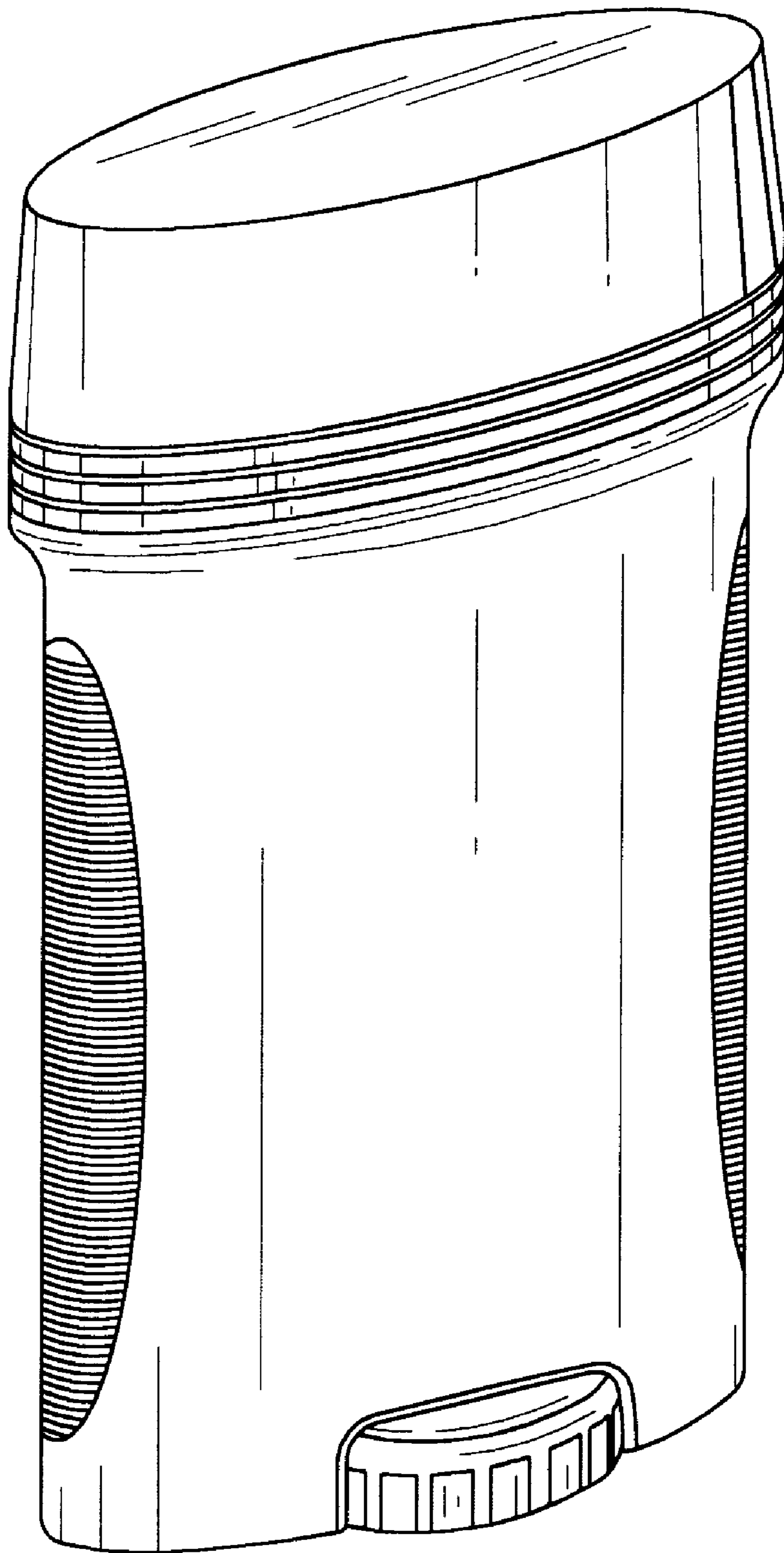
FIG. 3 is a front elevation view thereof, the rear elevation view being a mirror image thereof.

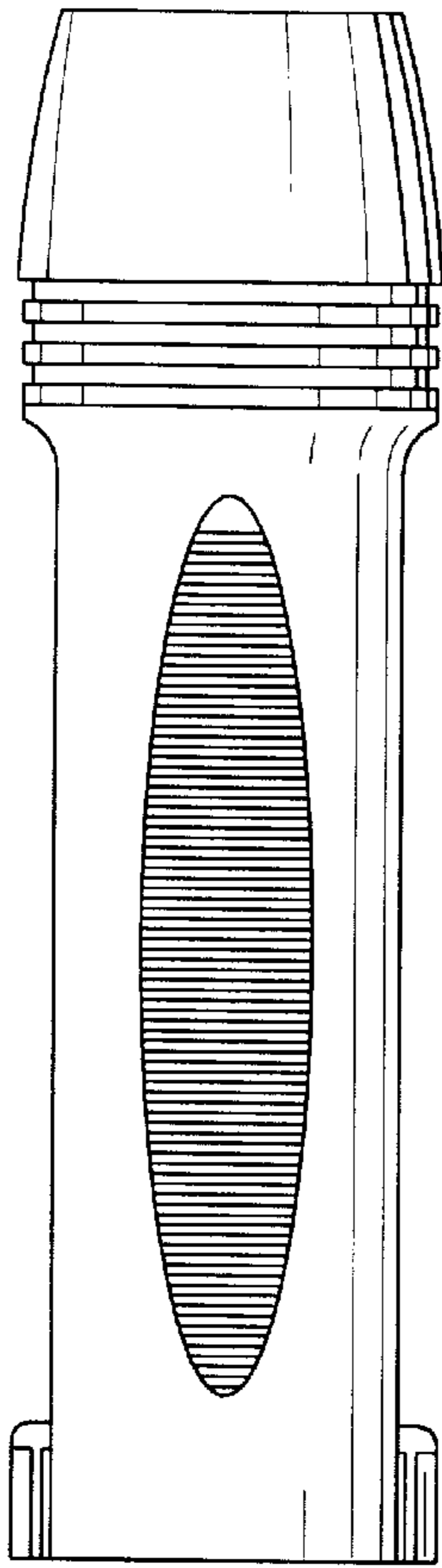

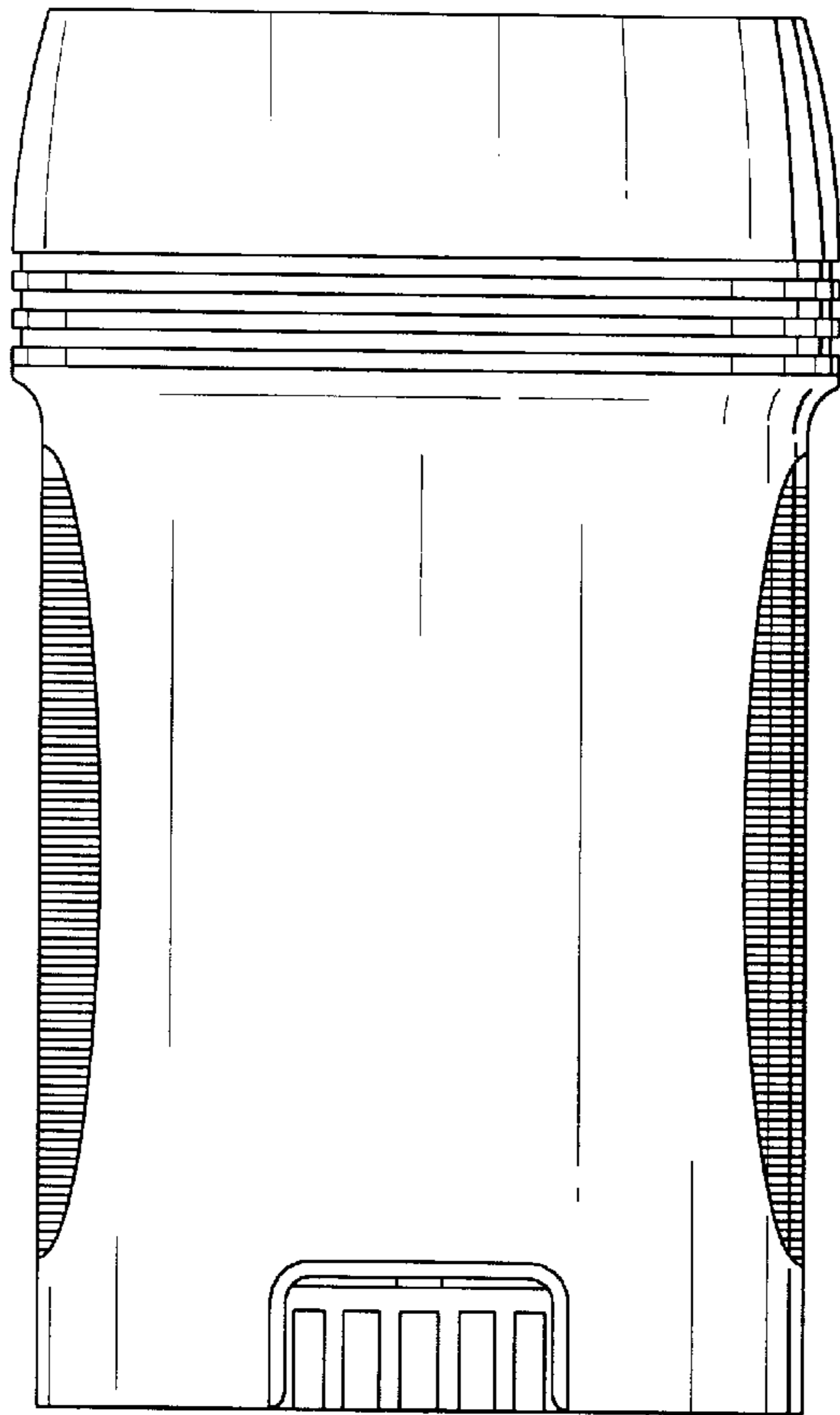

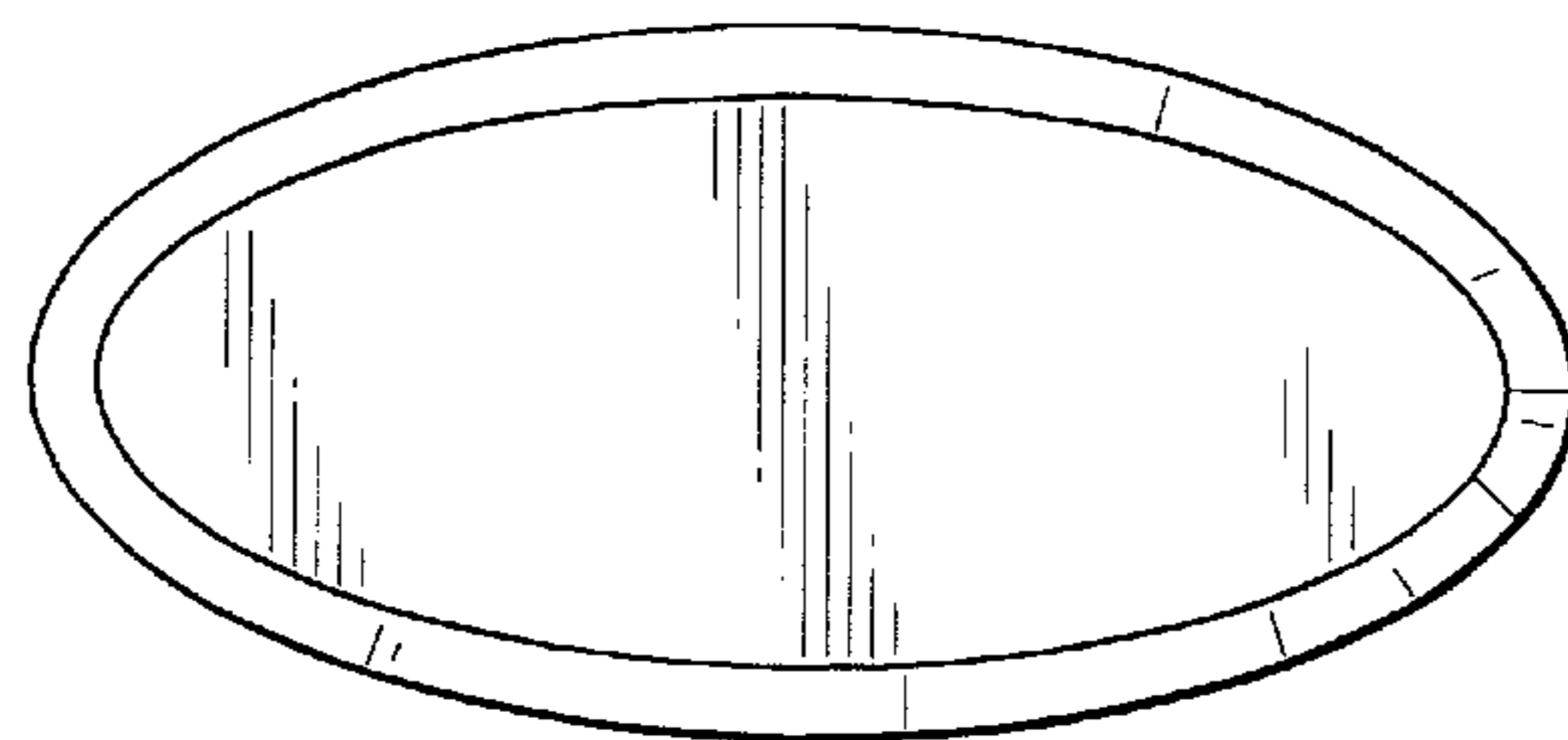

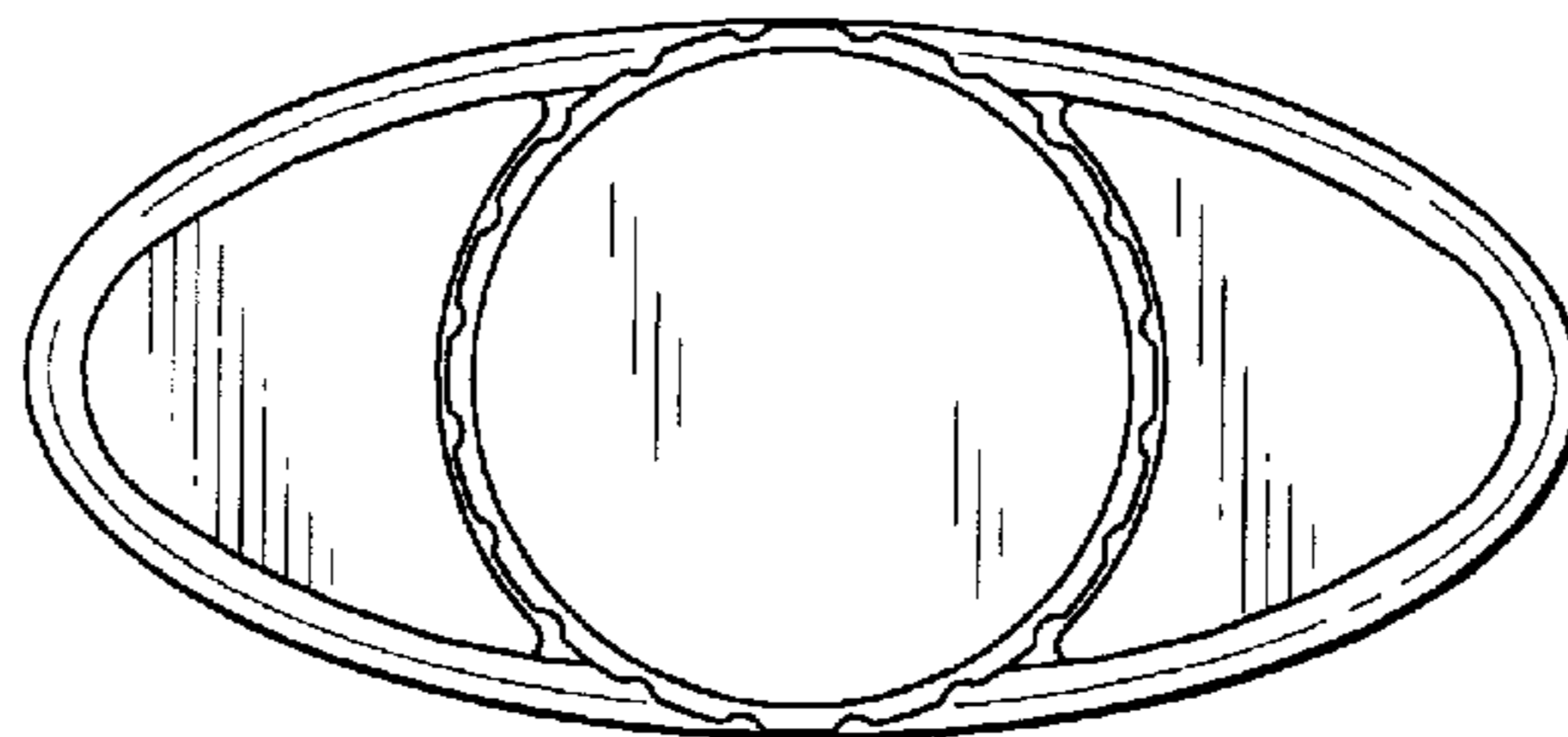
