FIG. 2 is a top plan view showing the new design;

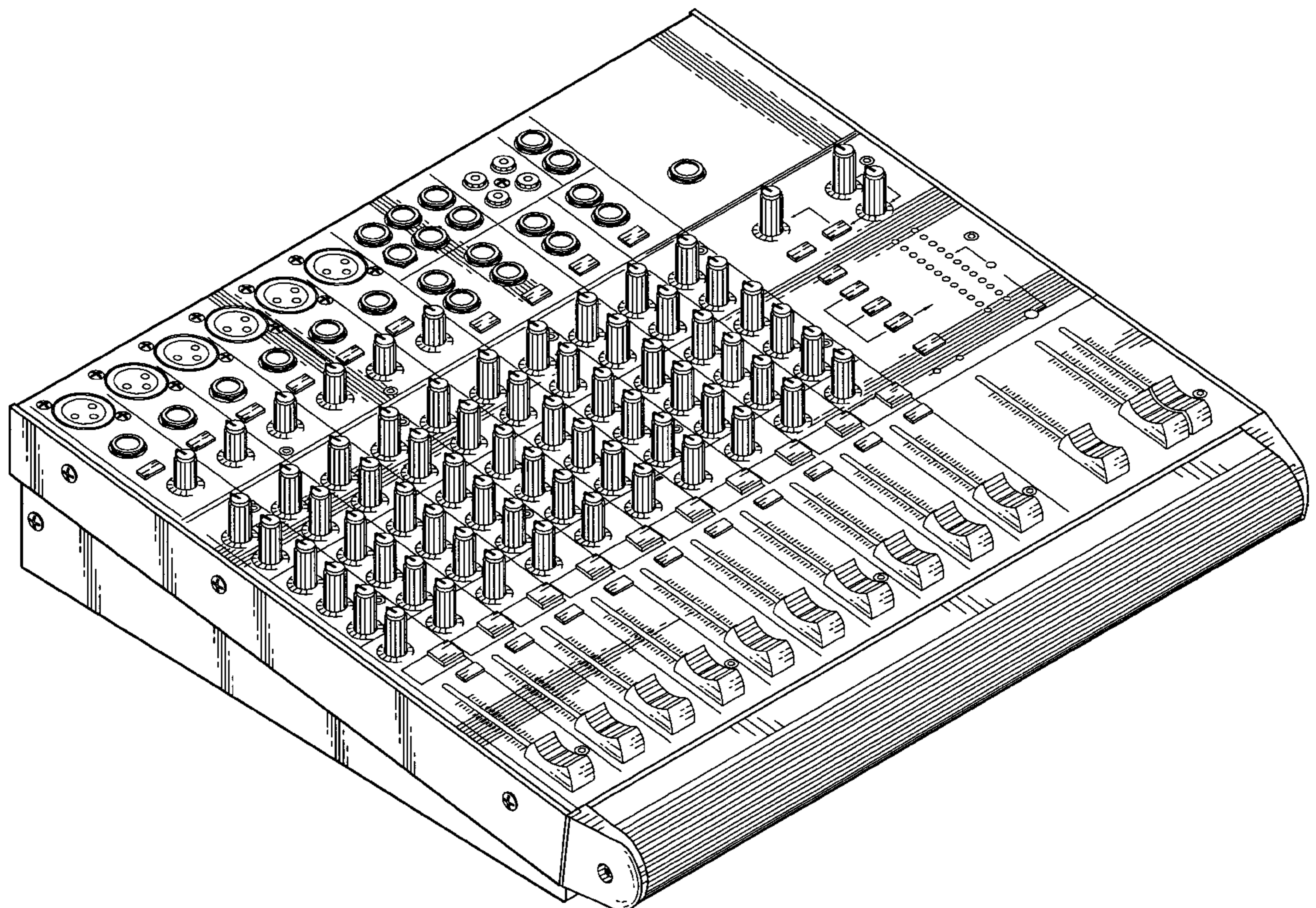
FIG. 3 is a rear elevation view thereof;

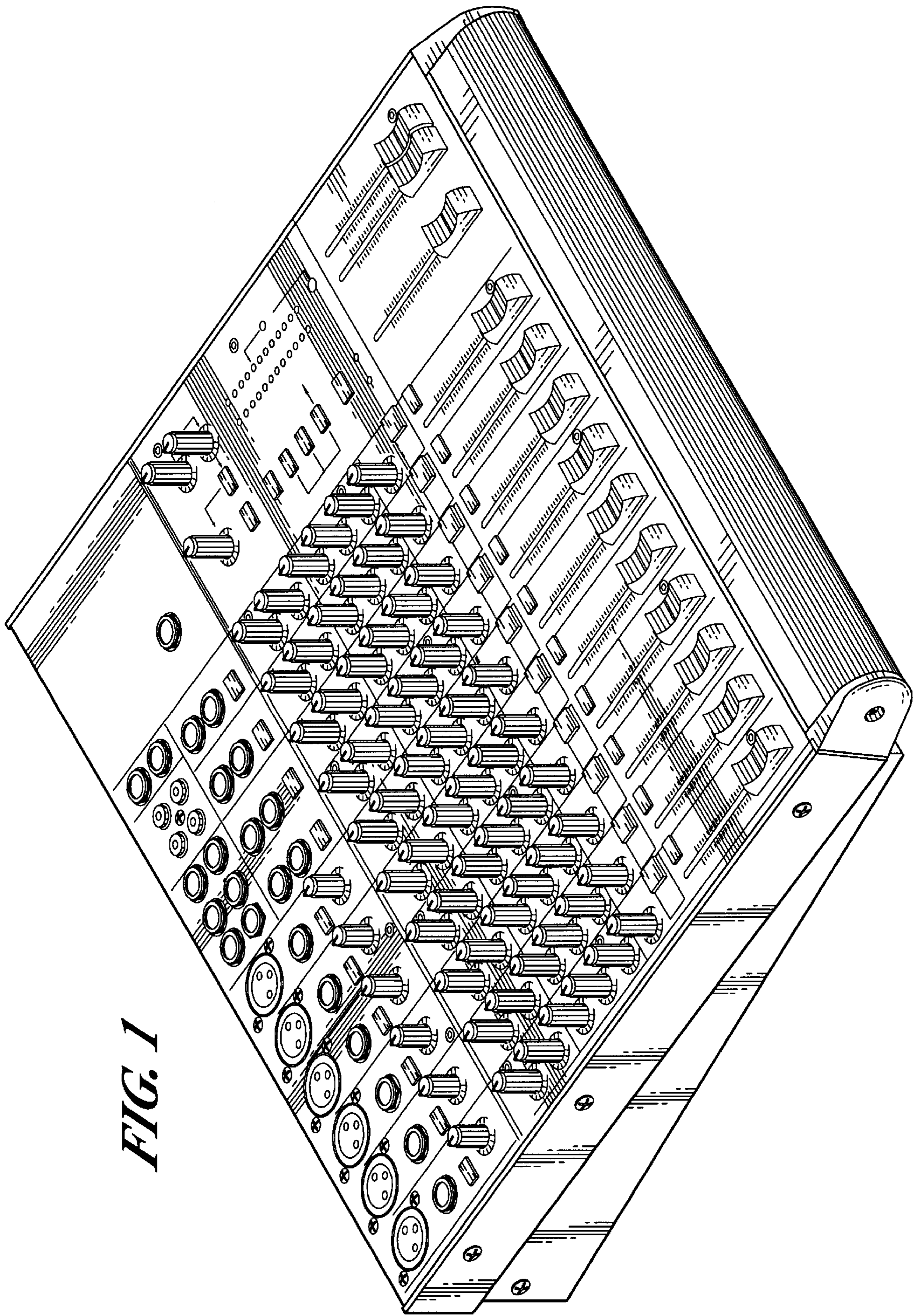

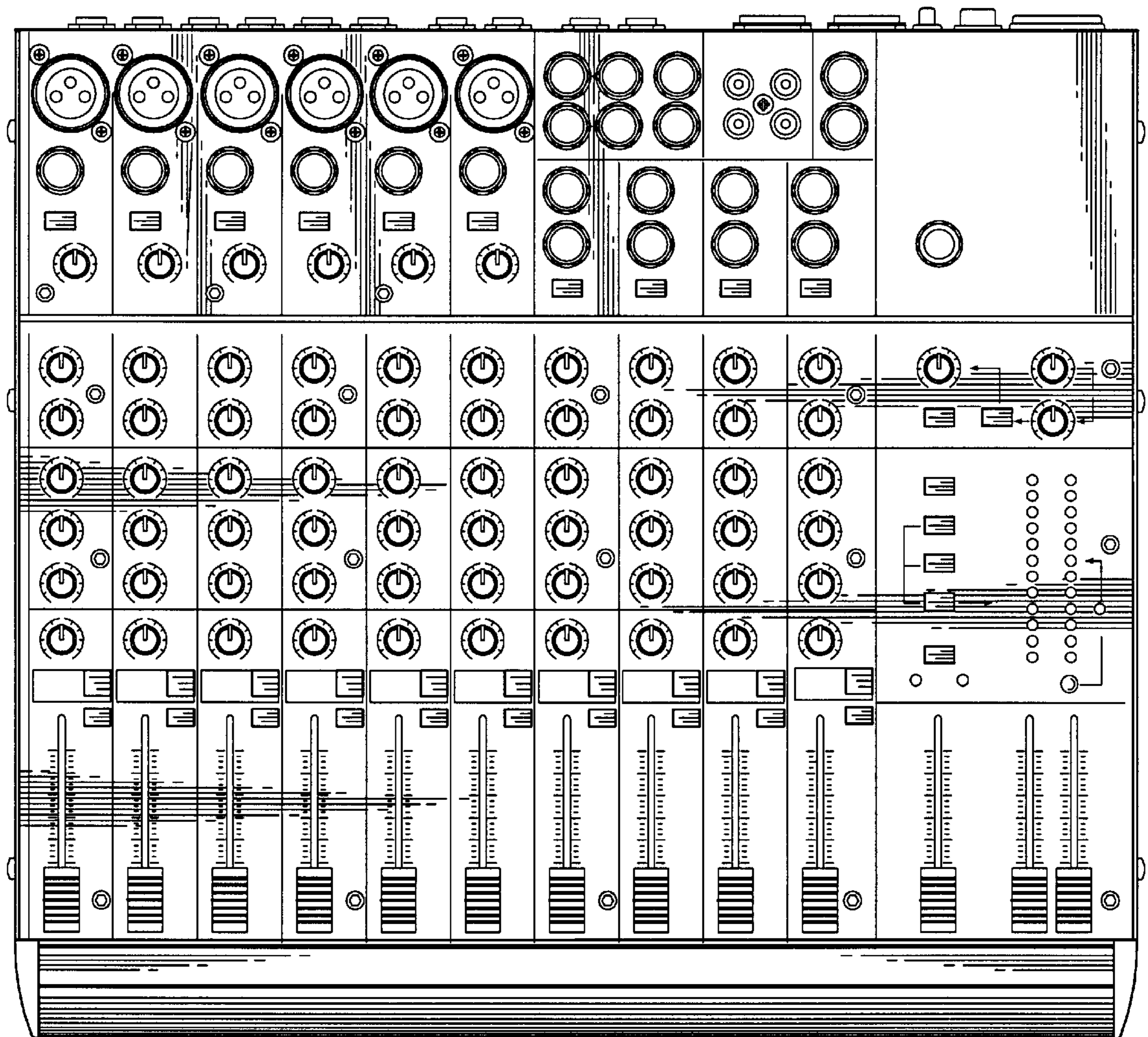

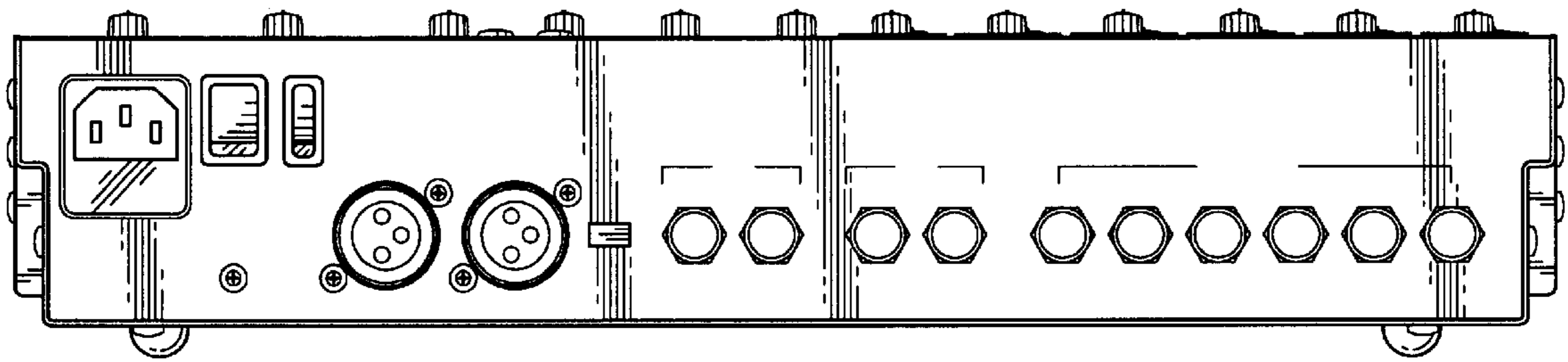

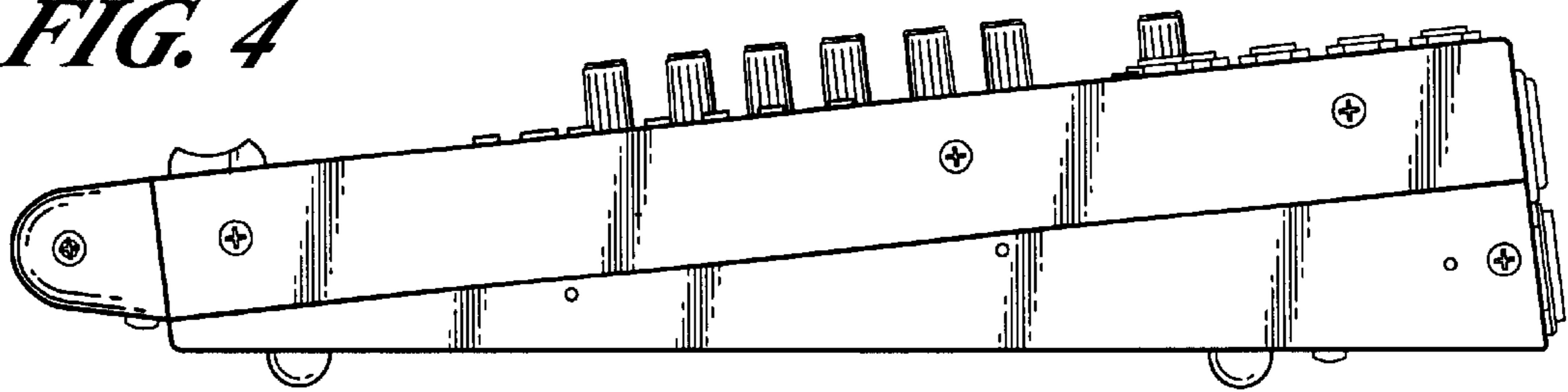

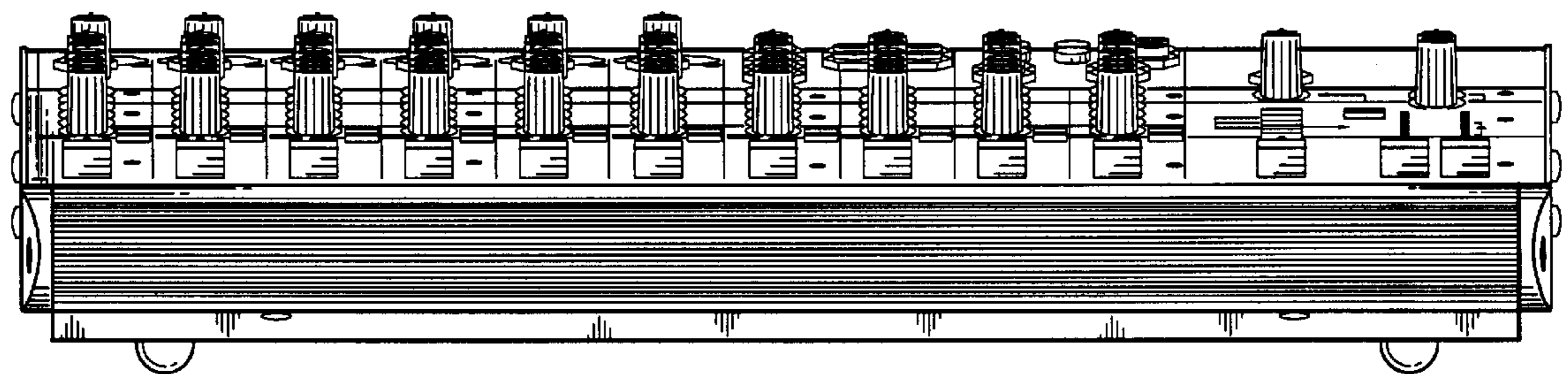
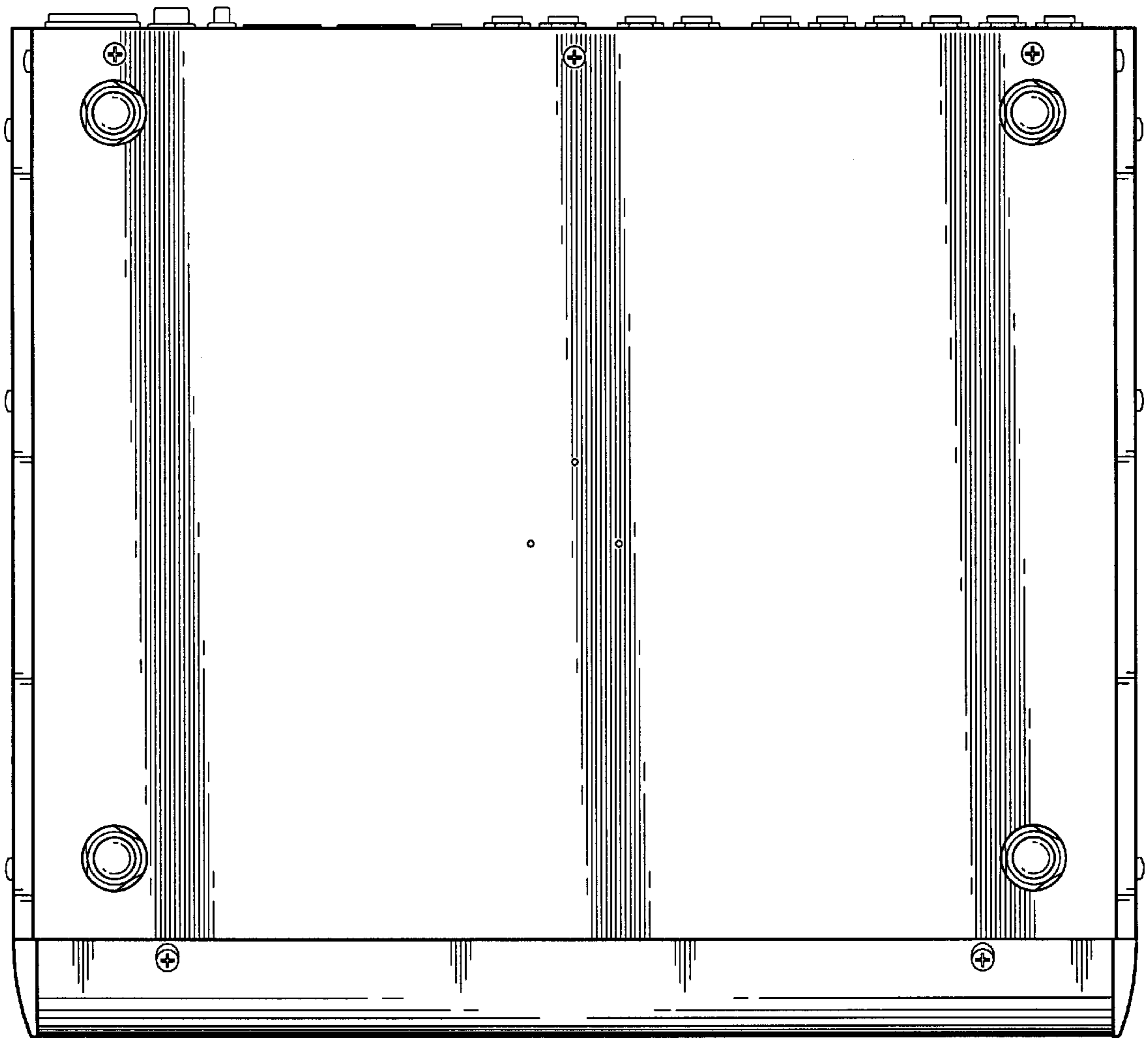
