(57) **CLAIM**

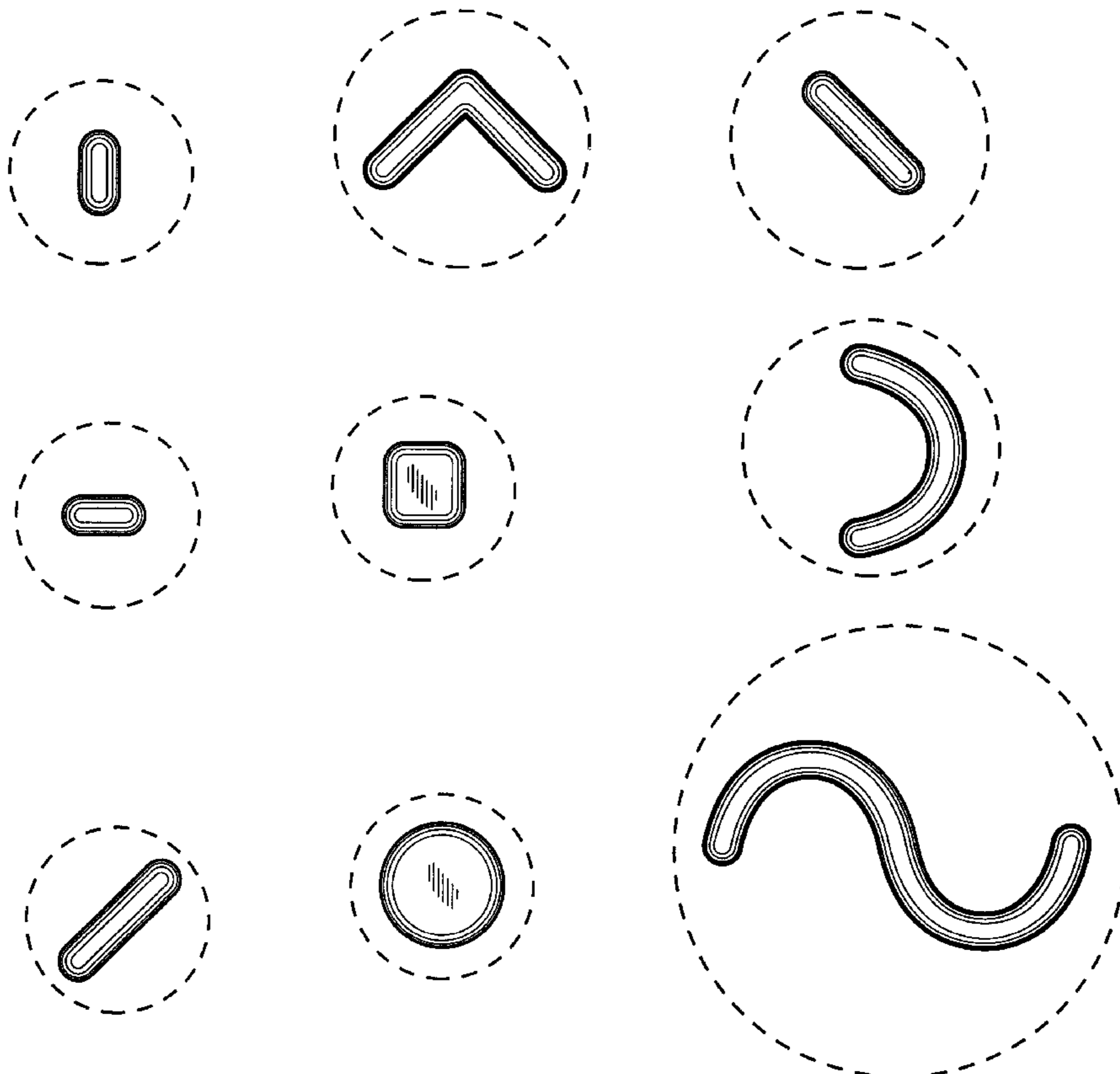
The ornamental design of a set of raised symbol elements, as shown and described.

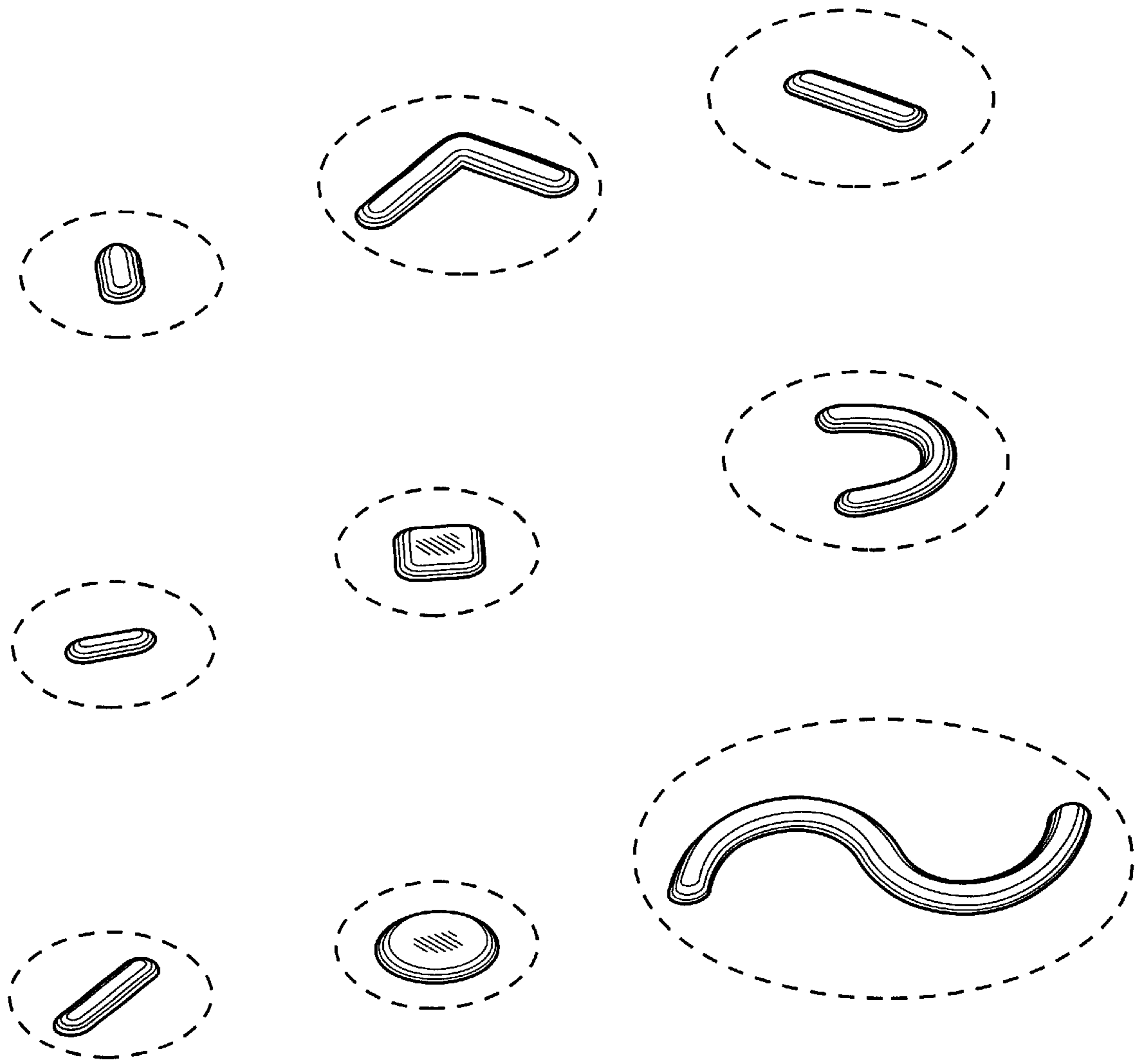
