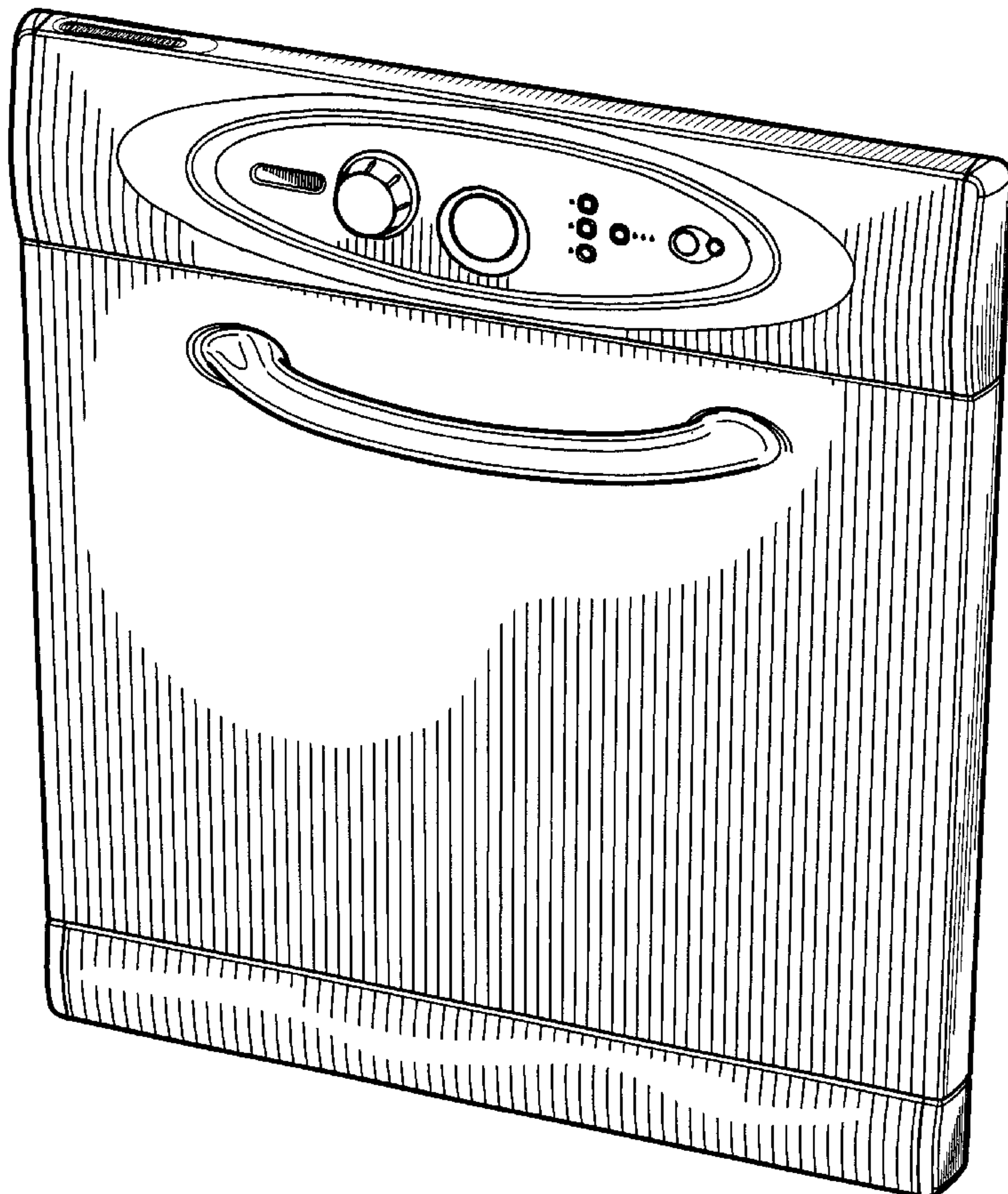
FIG. 1 is a frontal perspective view of the dishwasher front panel showing the new design;

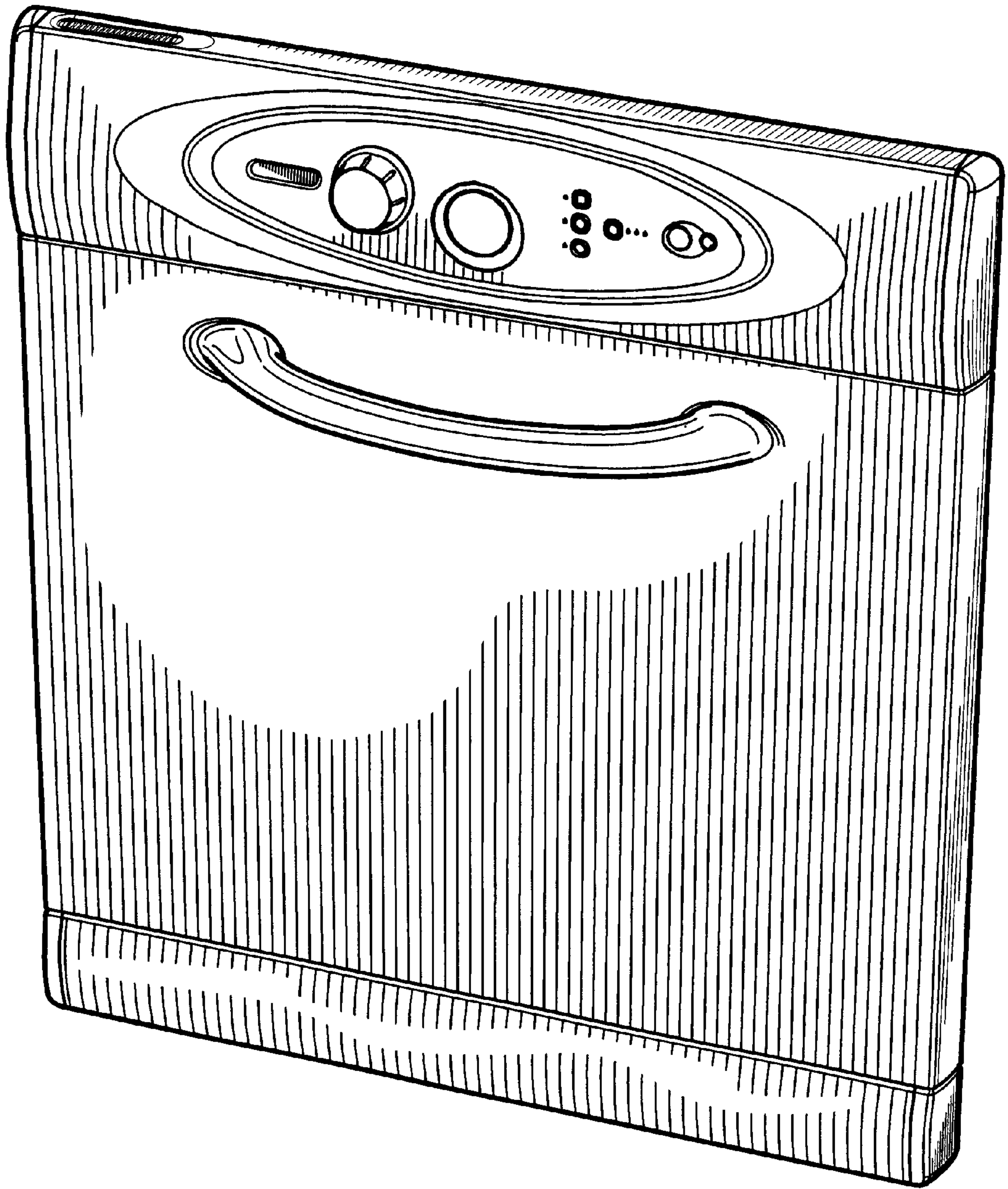

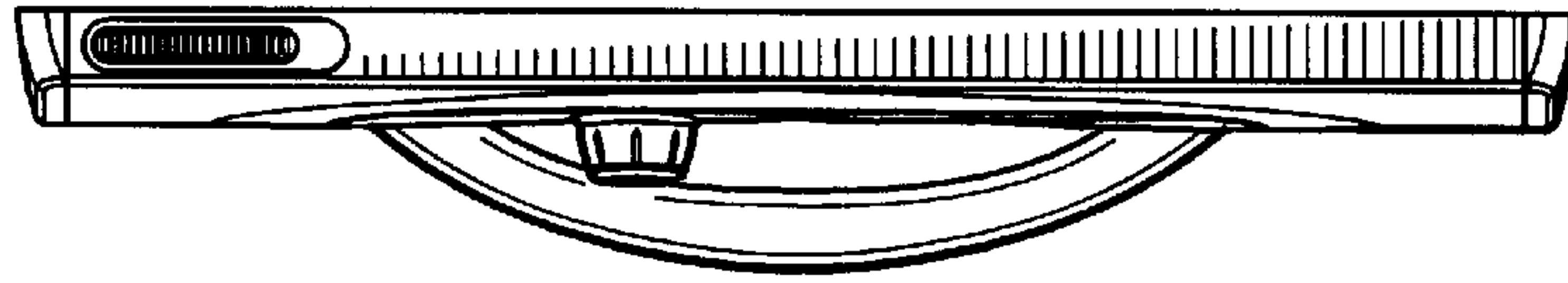

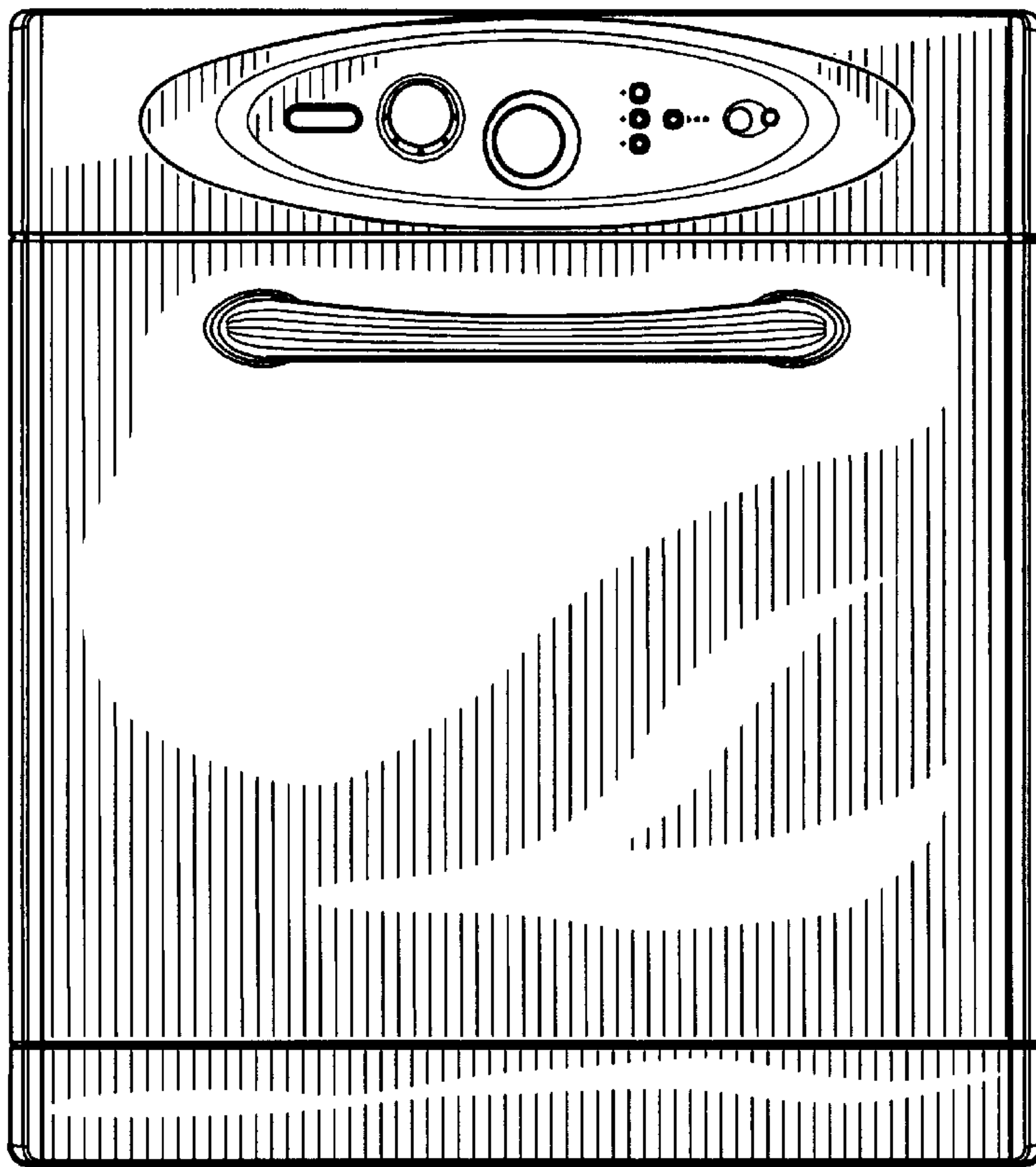

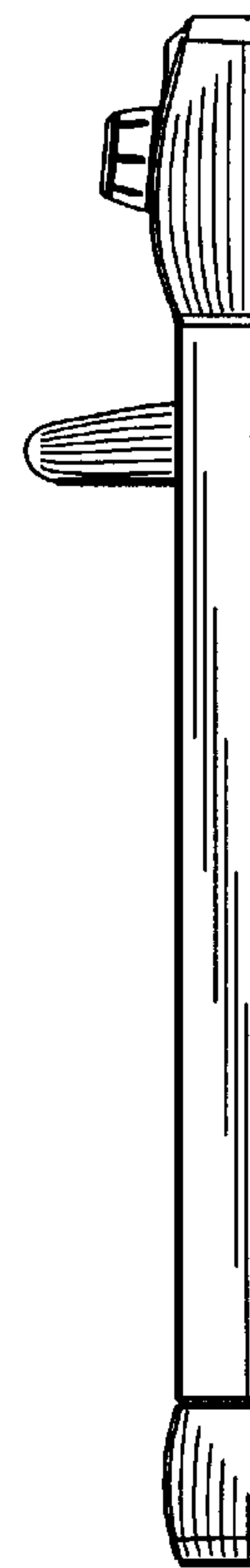
