FIG. 6 is a bottom plan view thereof;

FIG. 7 is an isometric view of a second embodiment which view differs from FIG. 1 only by the broken line showing of side arms; and,

FIG. 8 is an isometric view of the first embodiment which view differs from FIG. 1 only by the broken line showing of a seat structure.

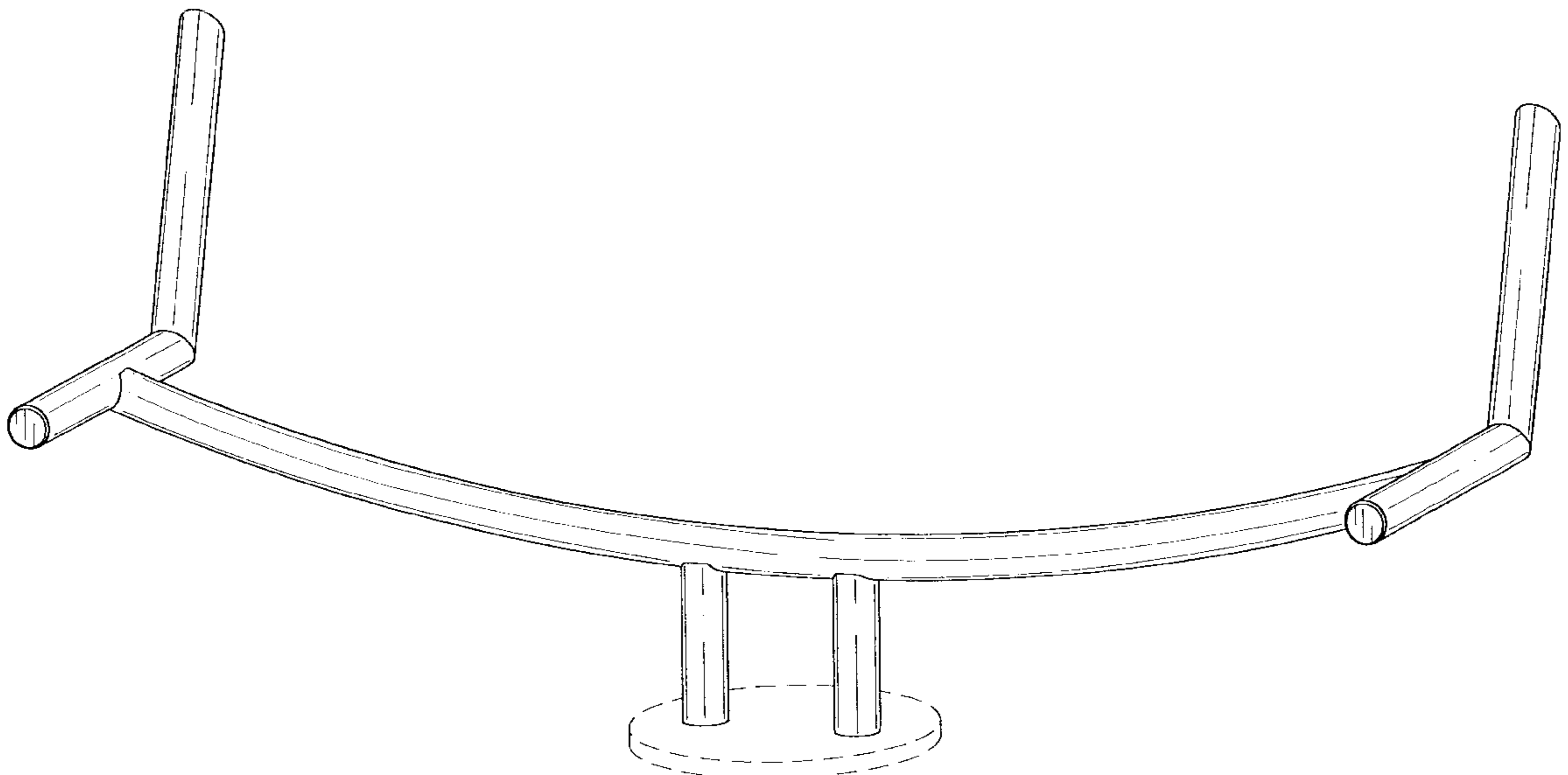

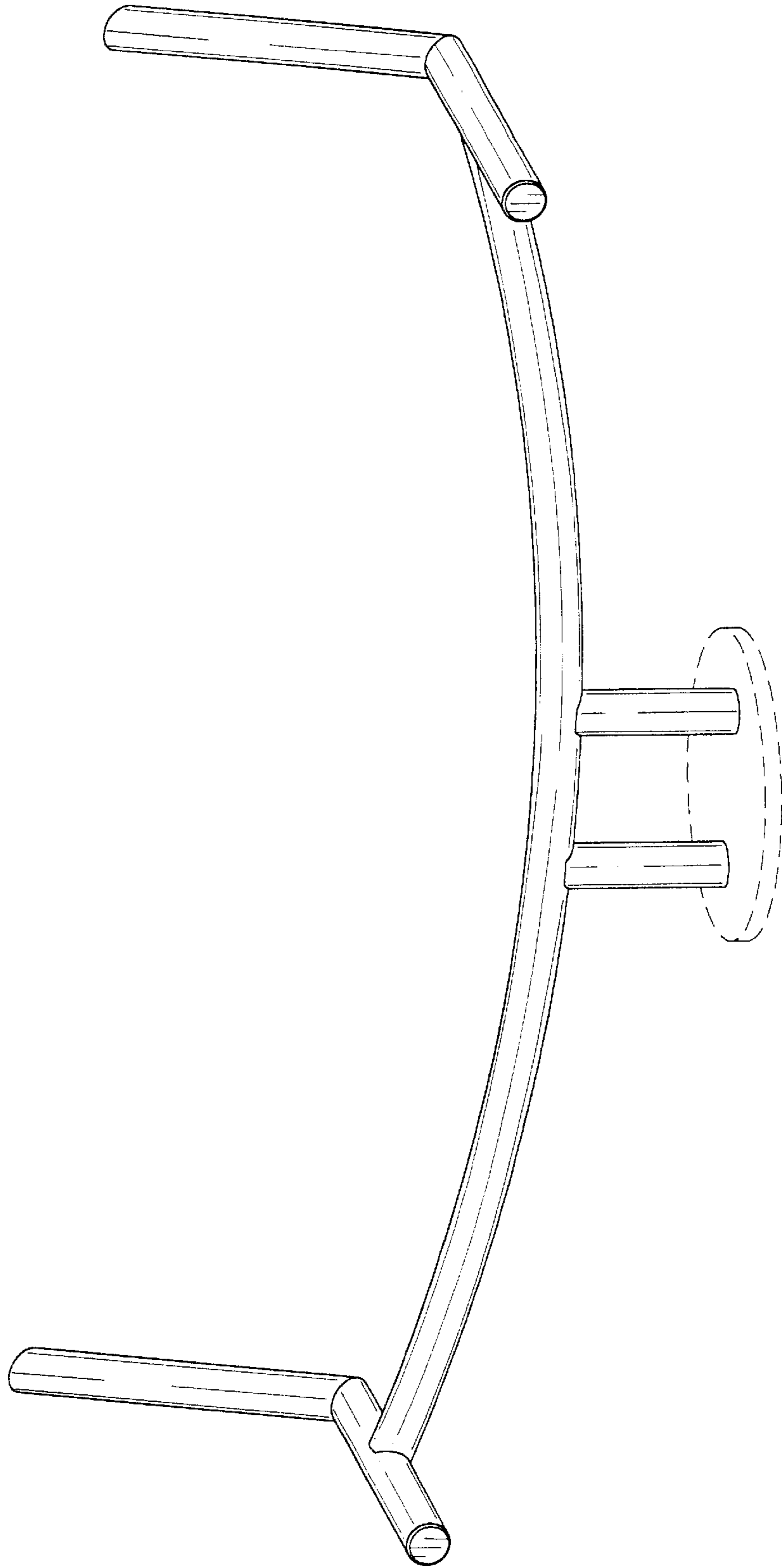

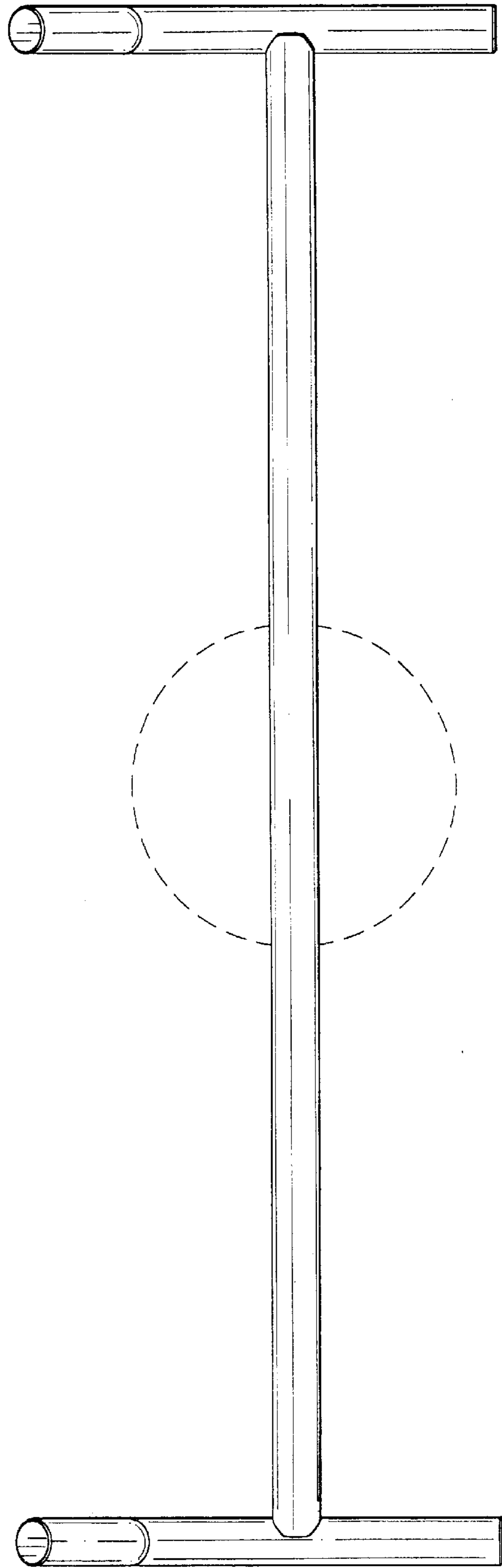
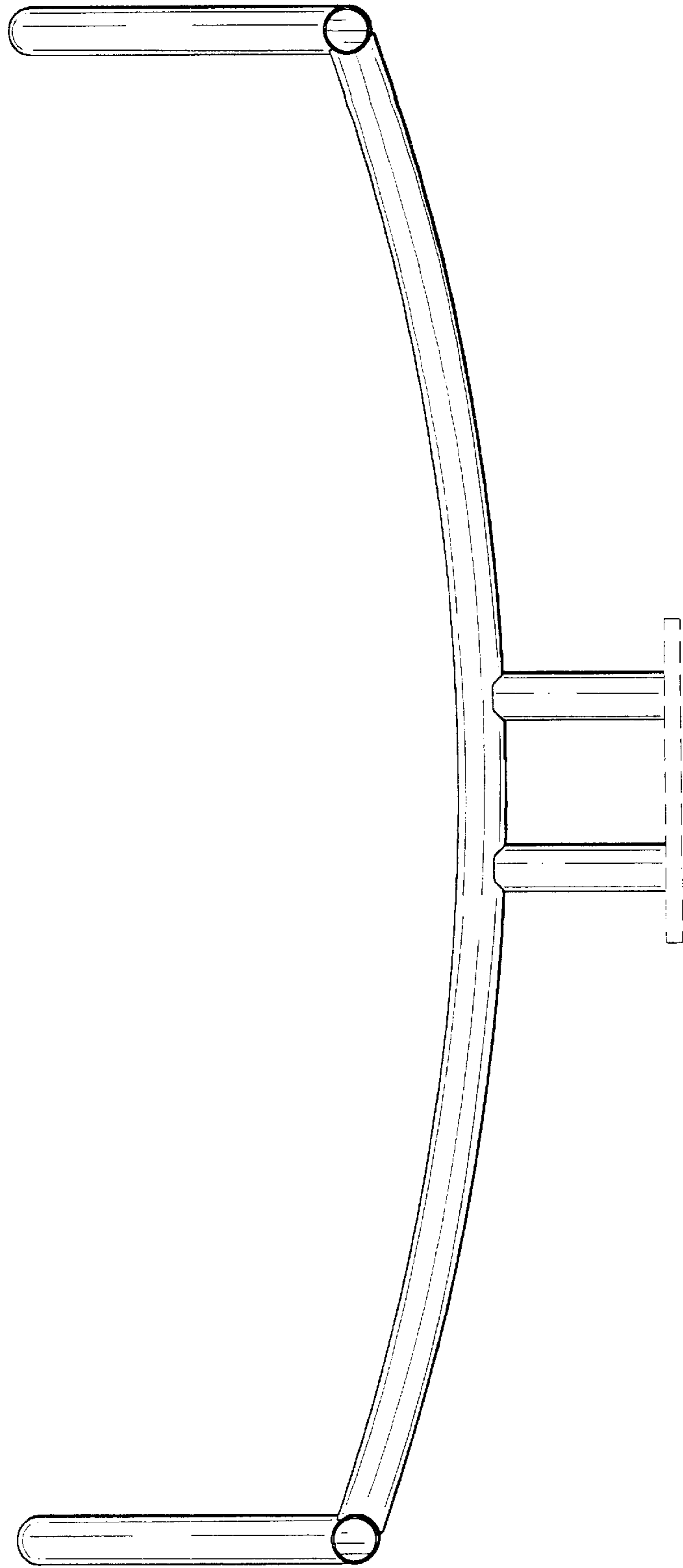

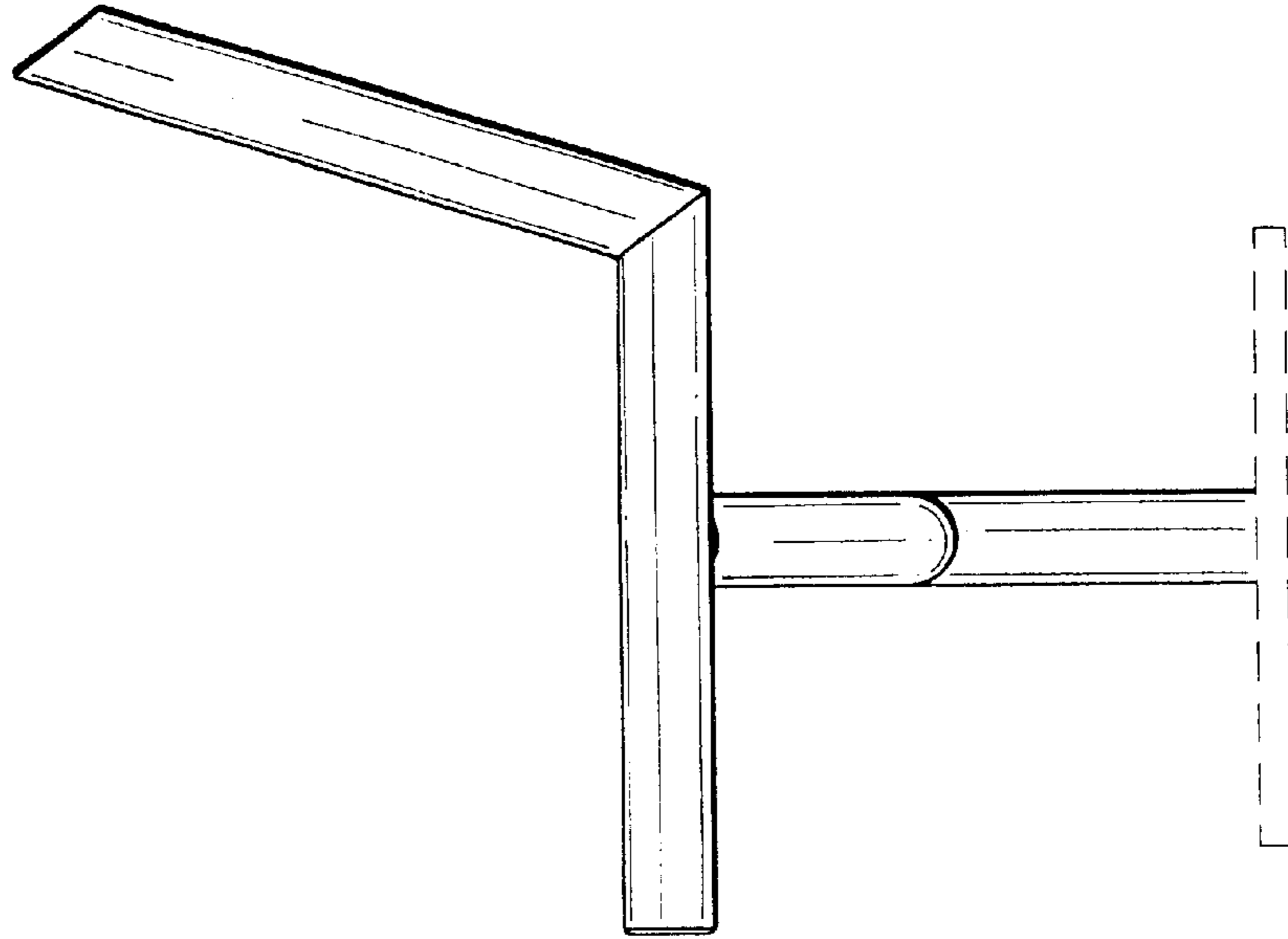

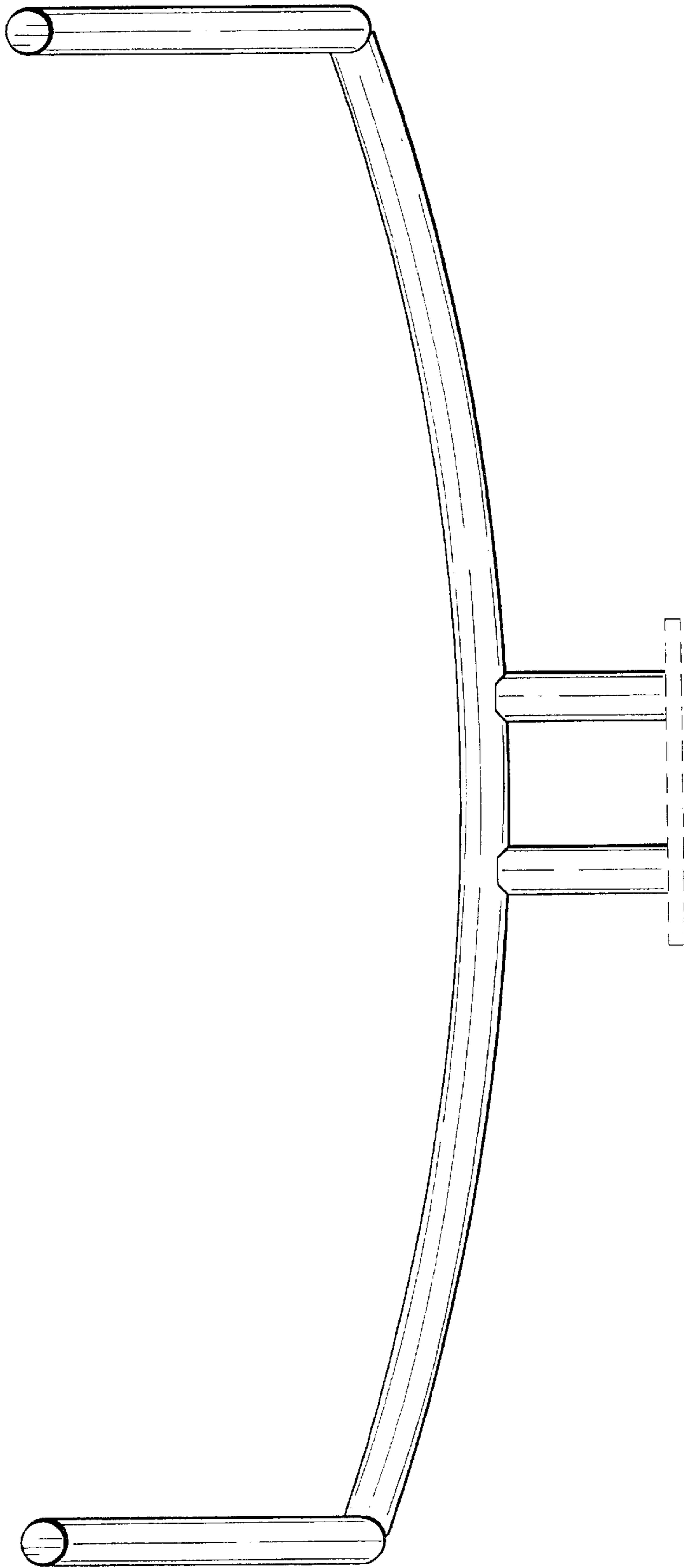

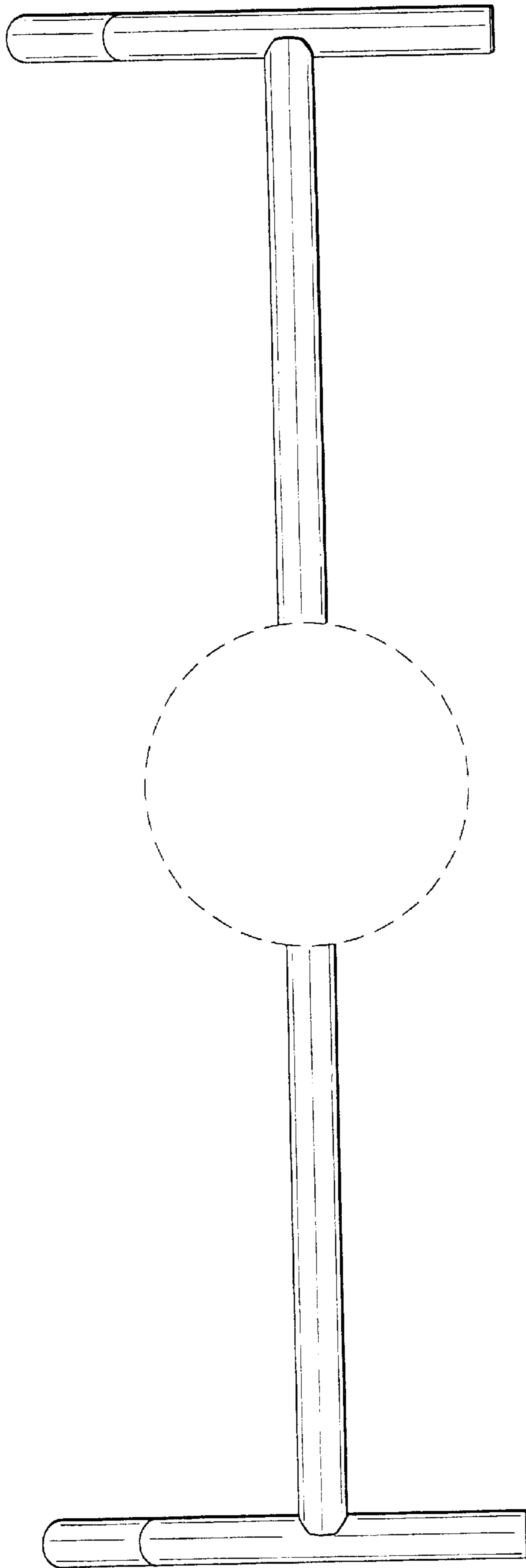

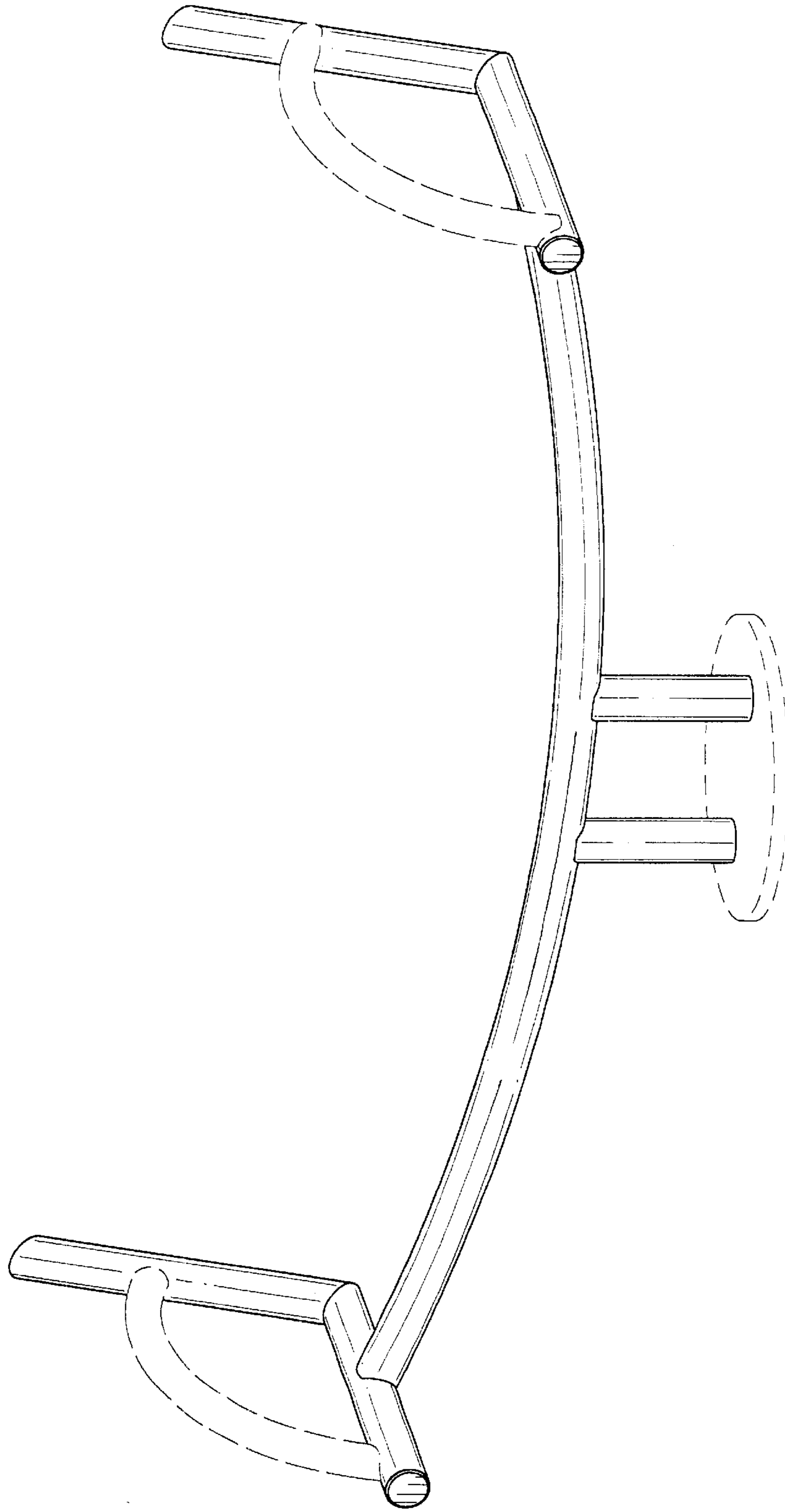

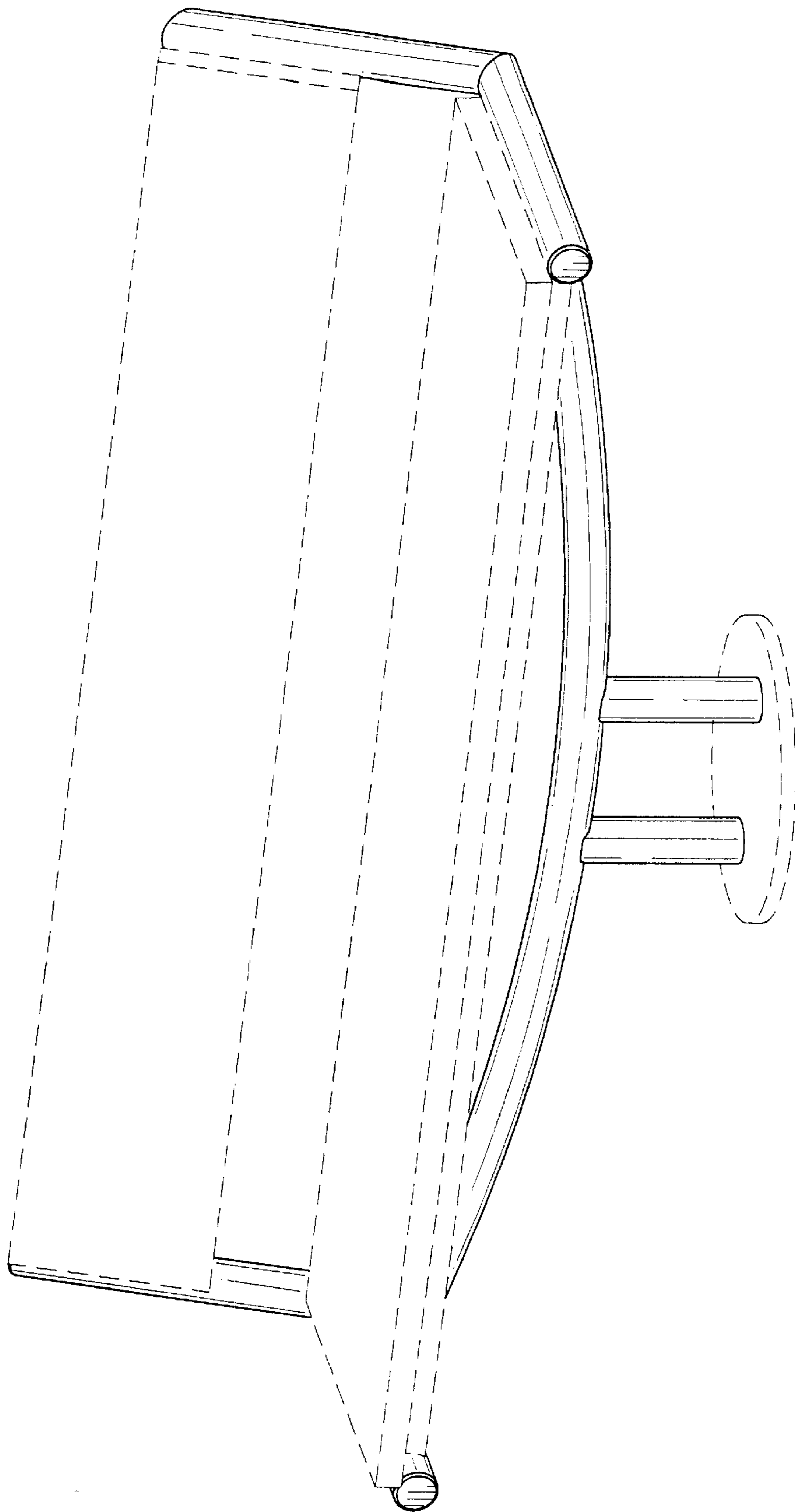
