(57) **CLAIM**

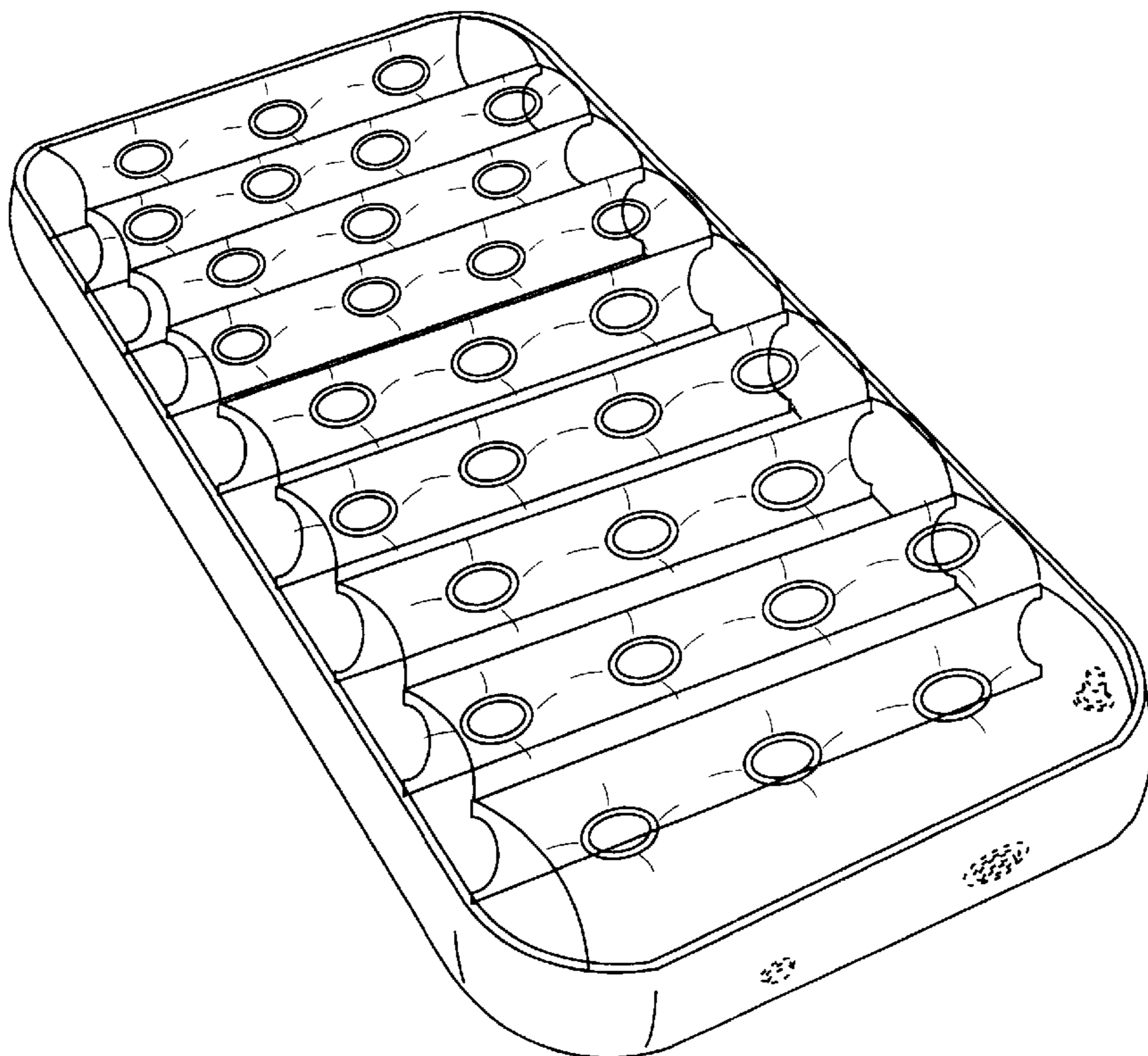
The ornamental design for an inflatable mattress, as shown and described.

DESCRIPTION

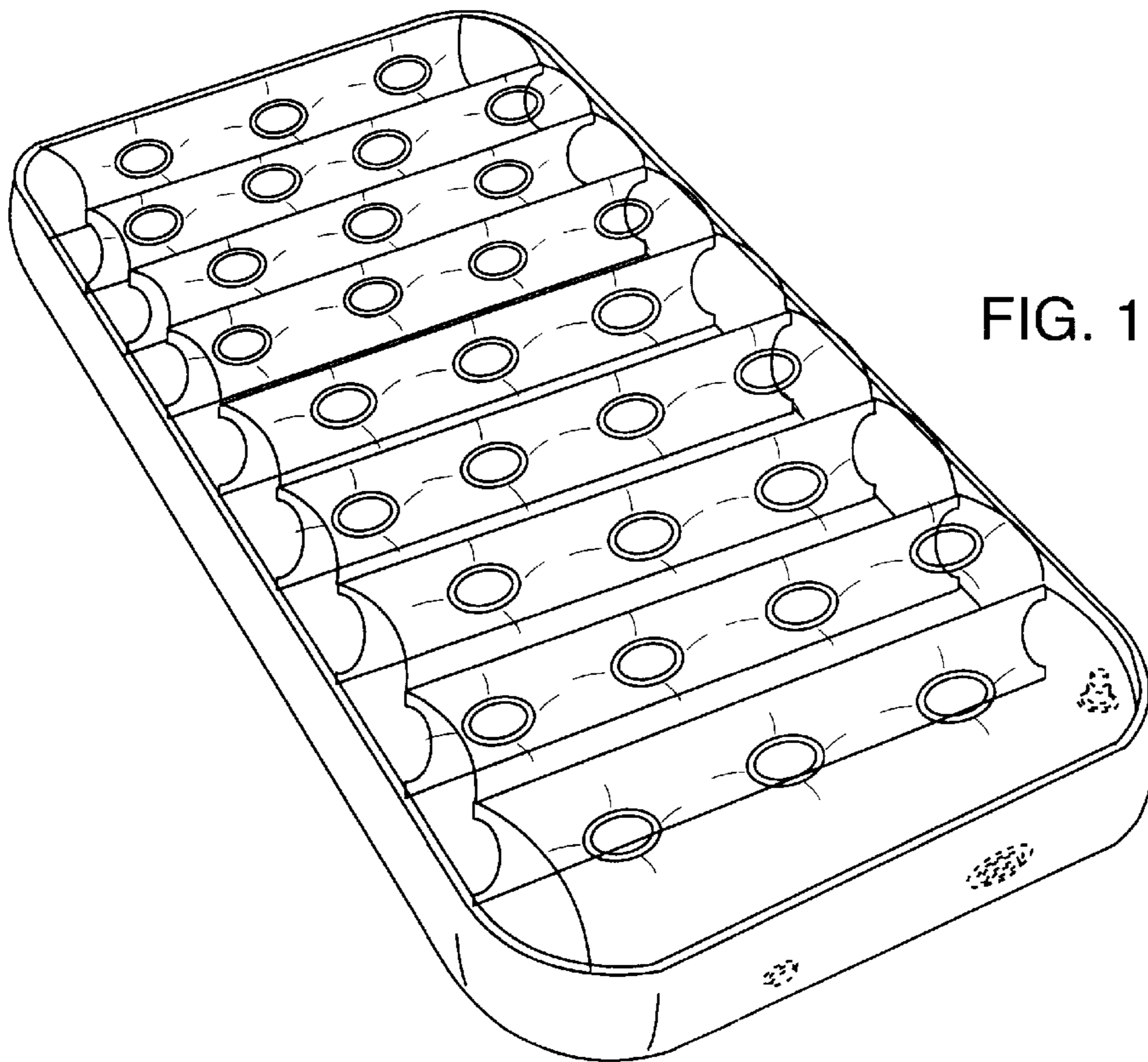

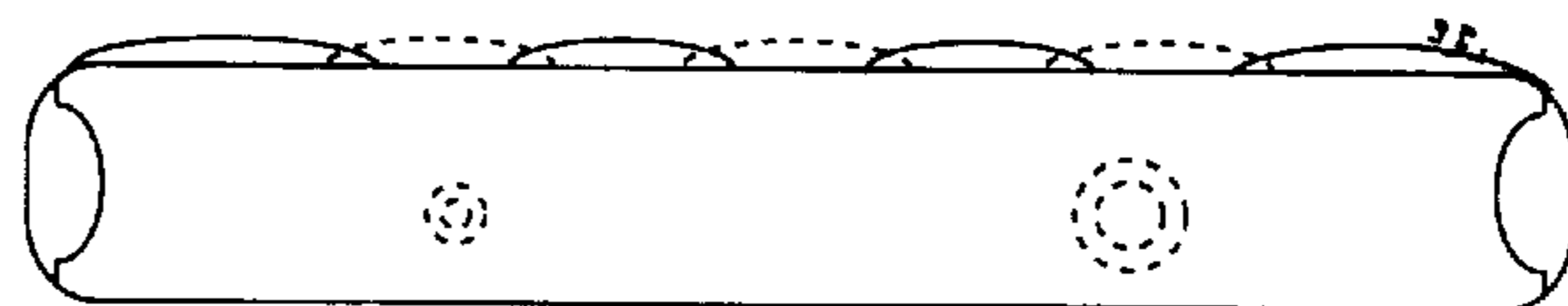

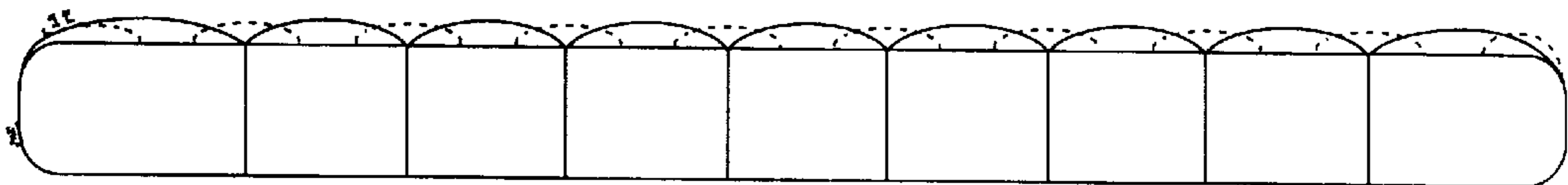
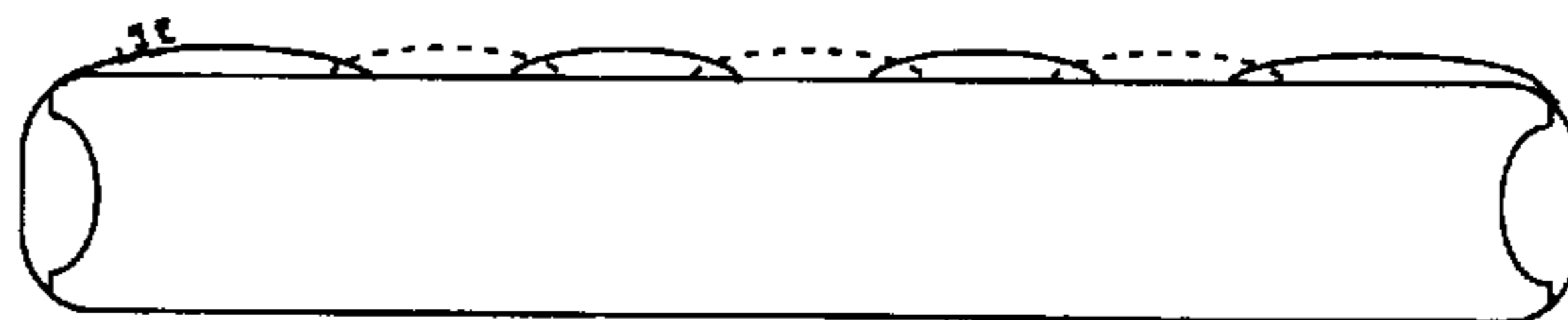

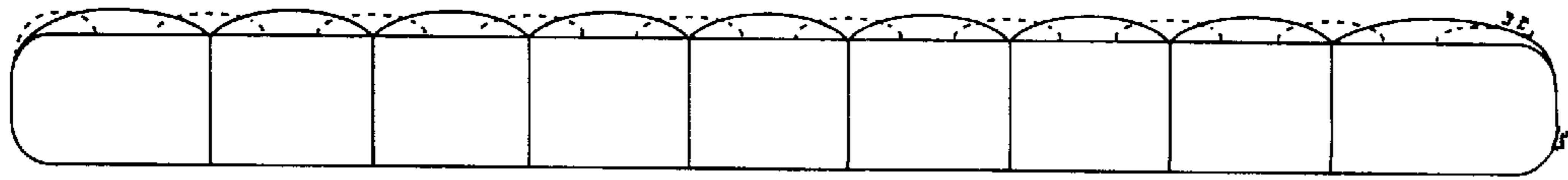

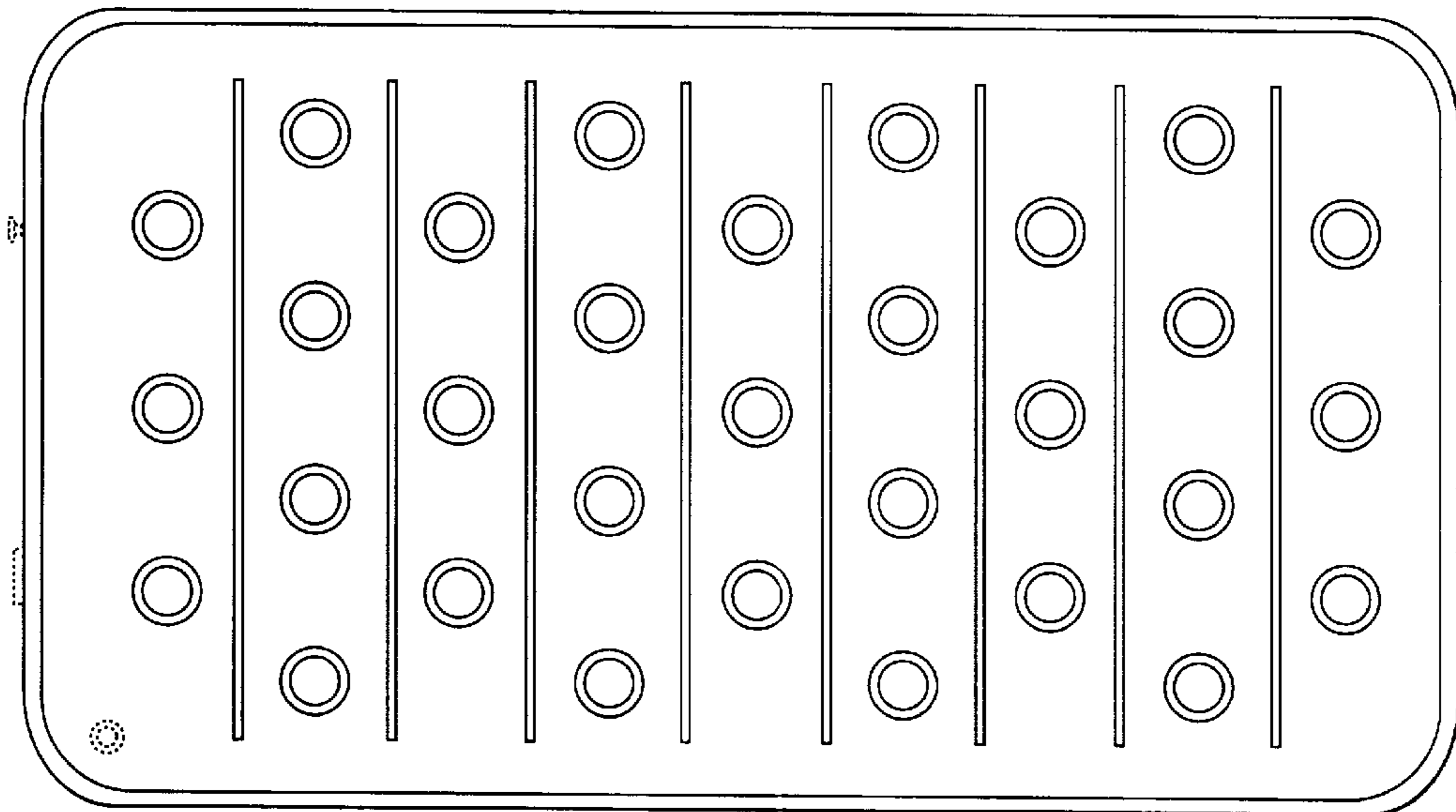

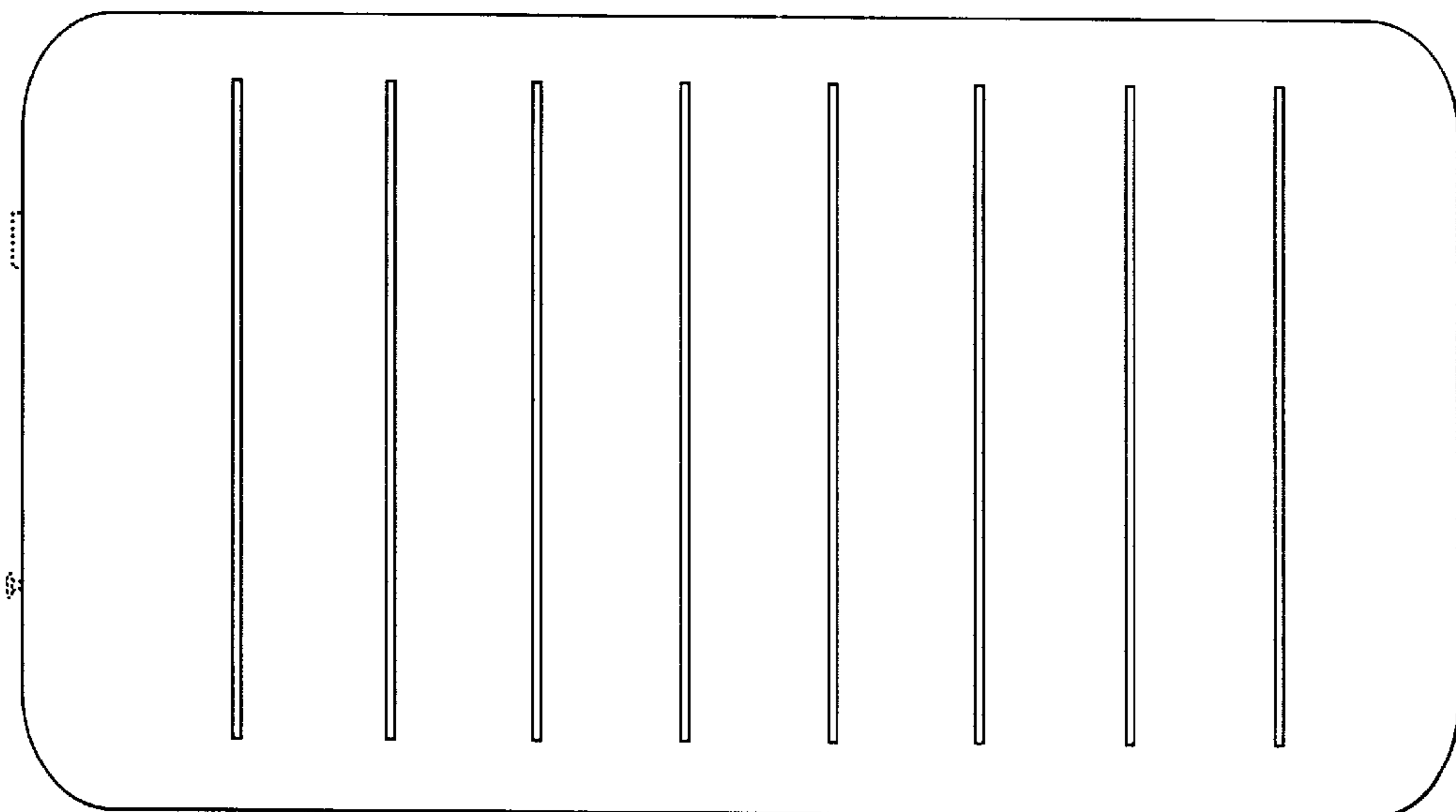
