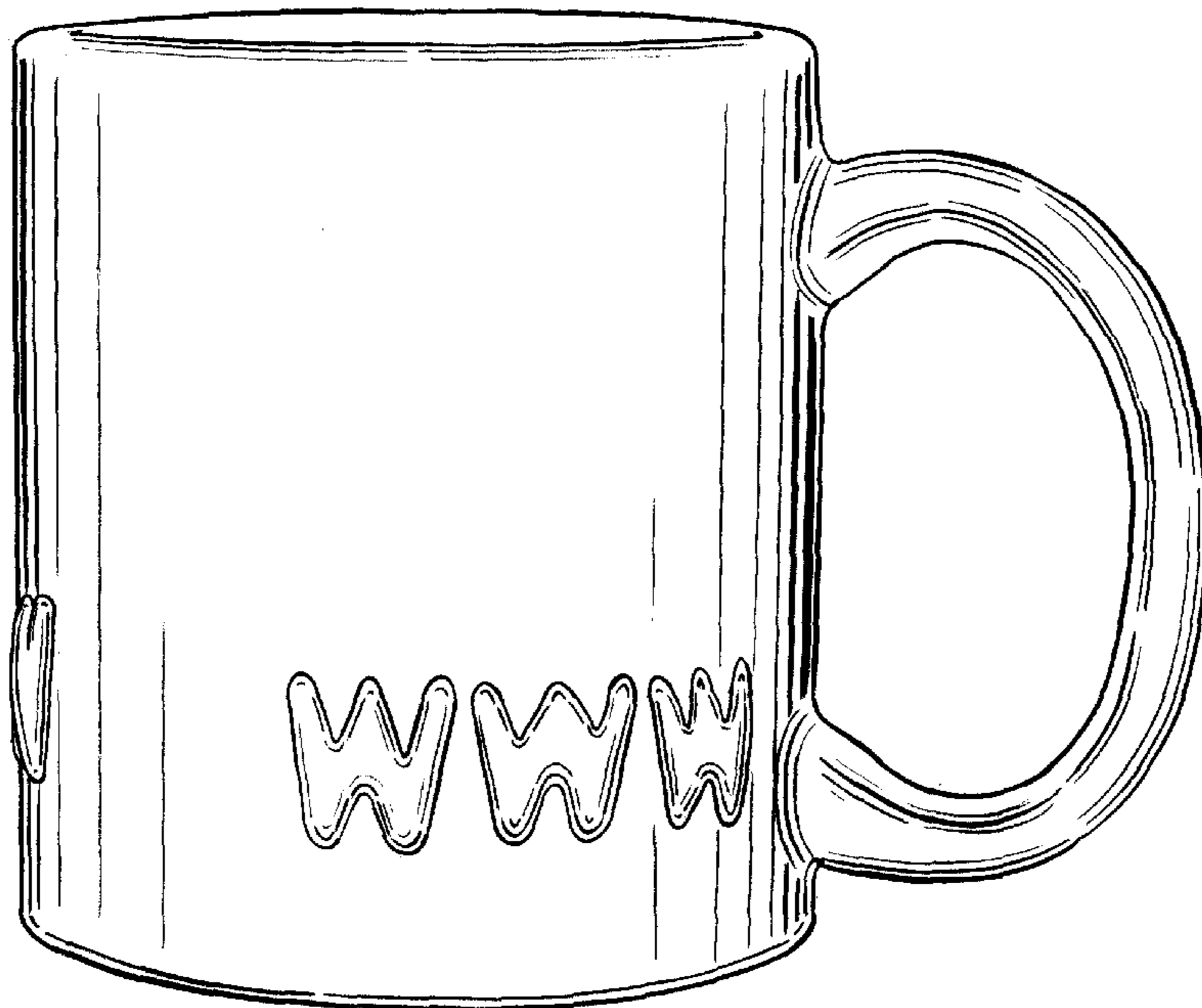

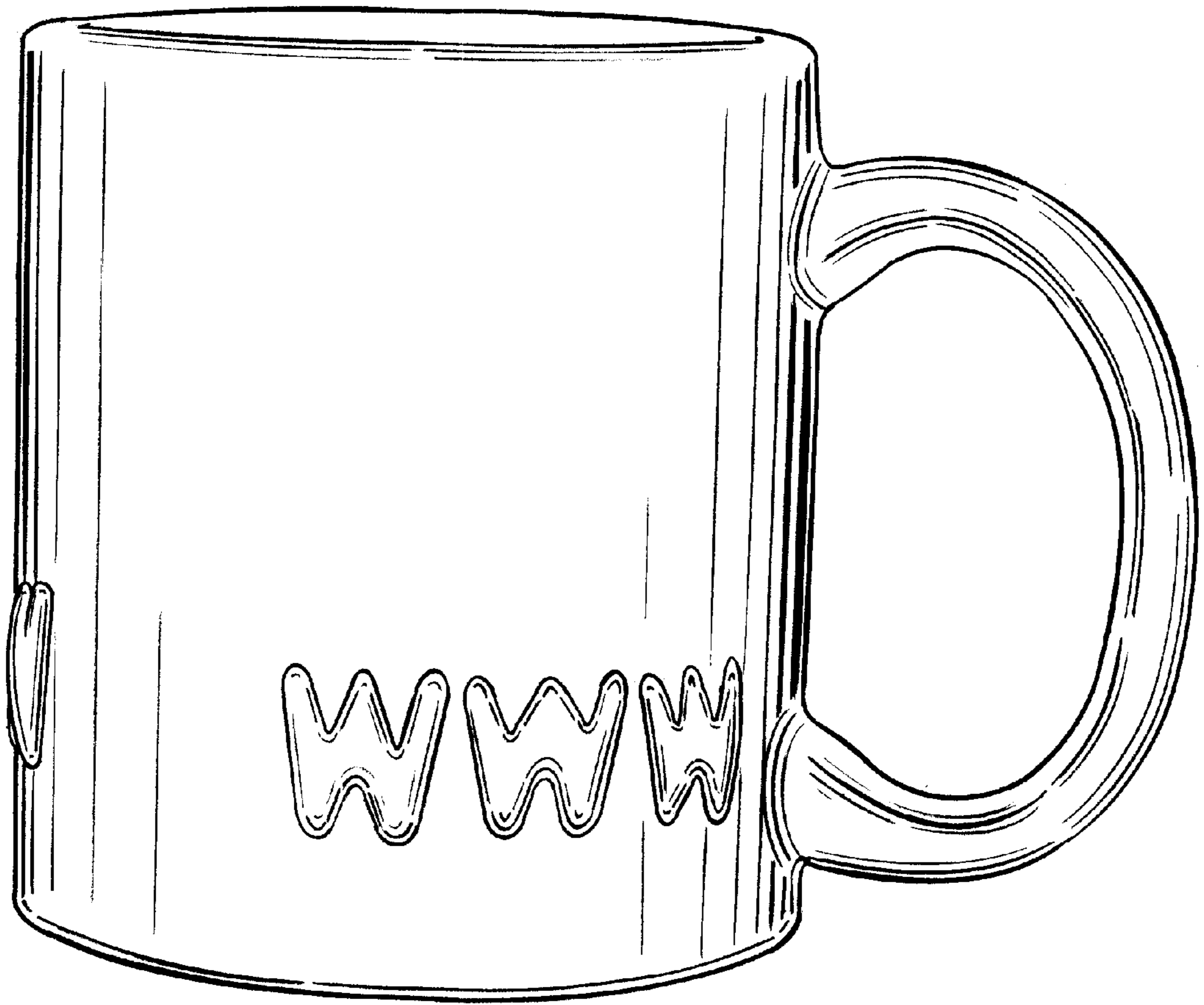
The ornamental design for a mug, as shown and described.

DESCRIPTION

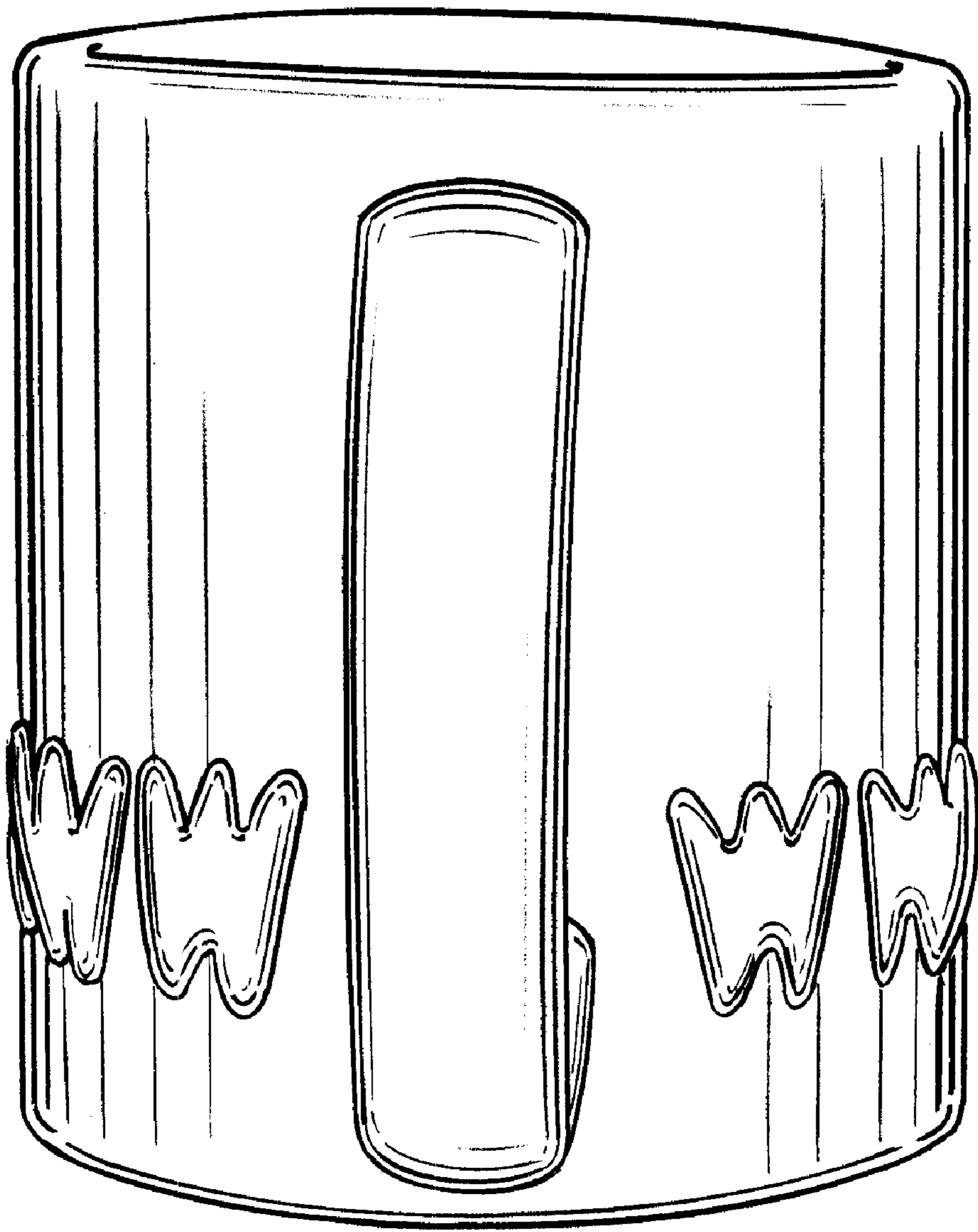
FIG. 1 is a front view in perspective of a mug according to the present design;

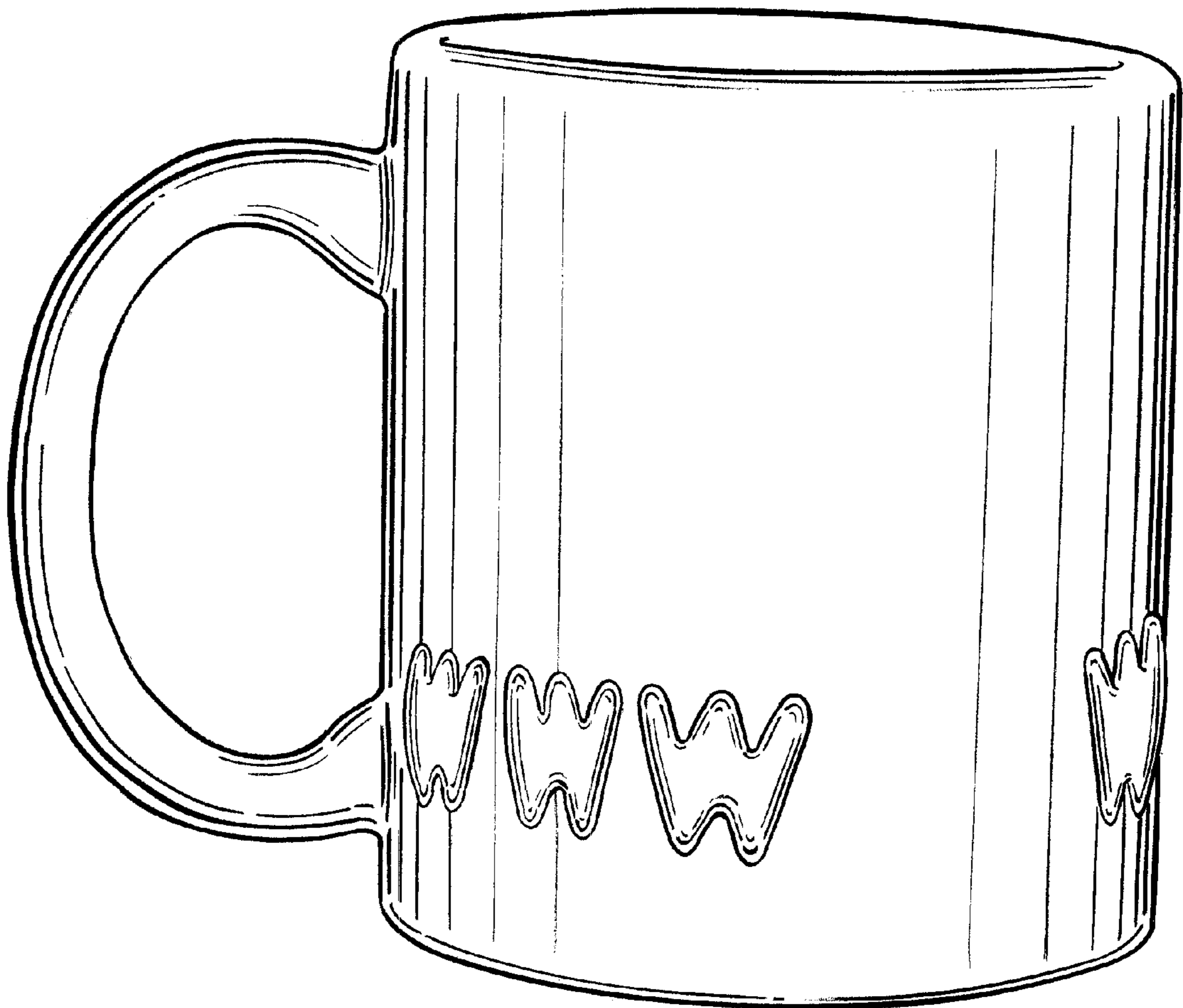




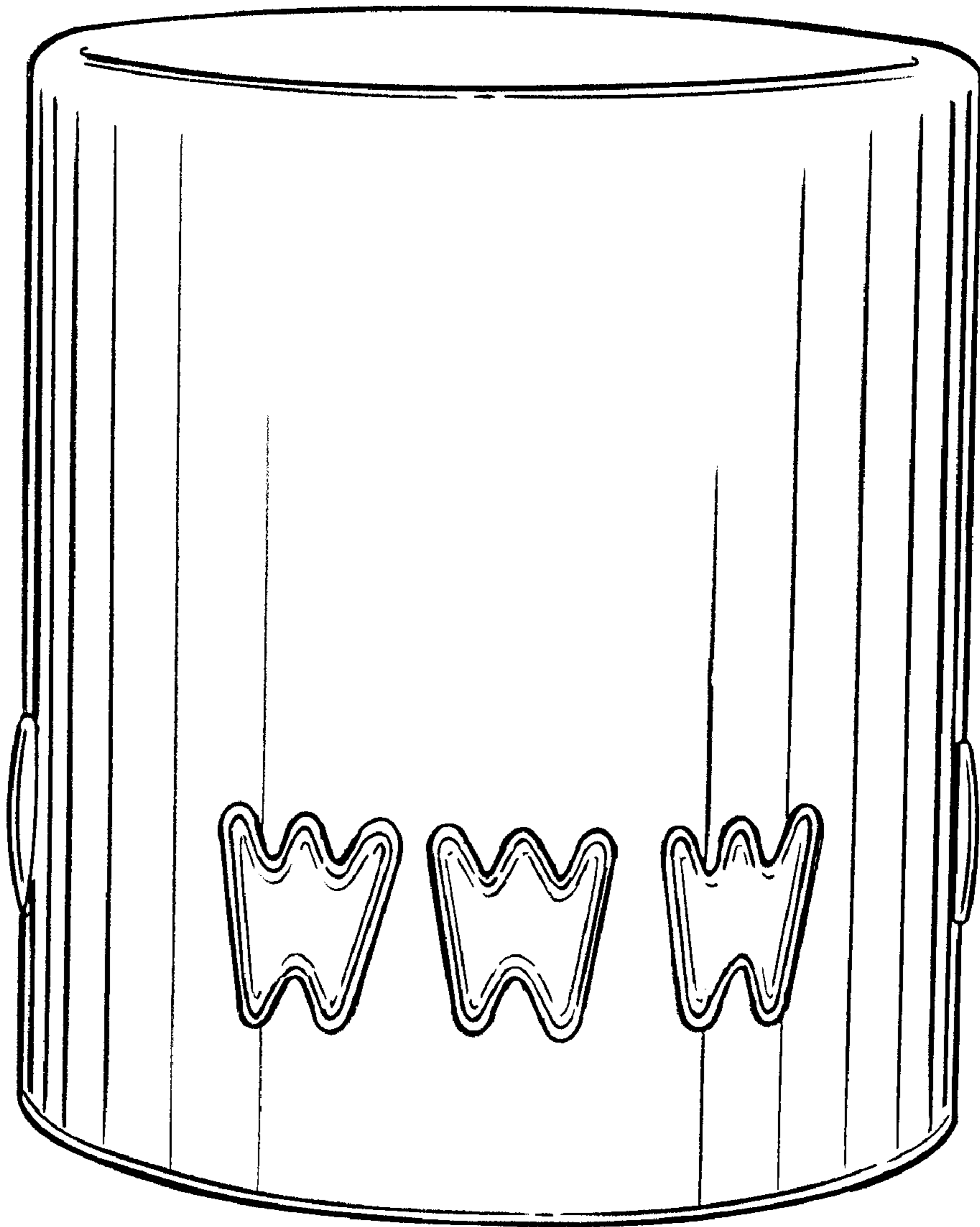

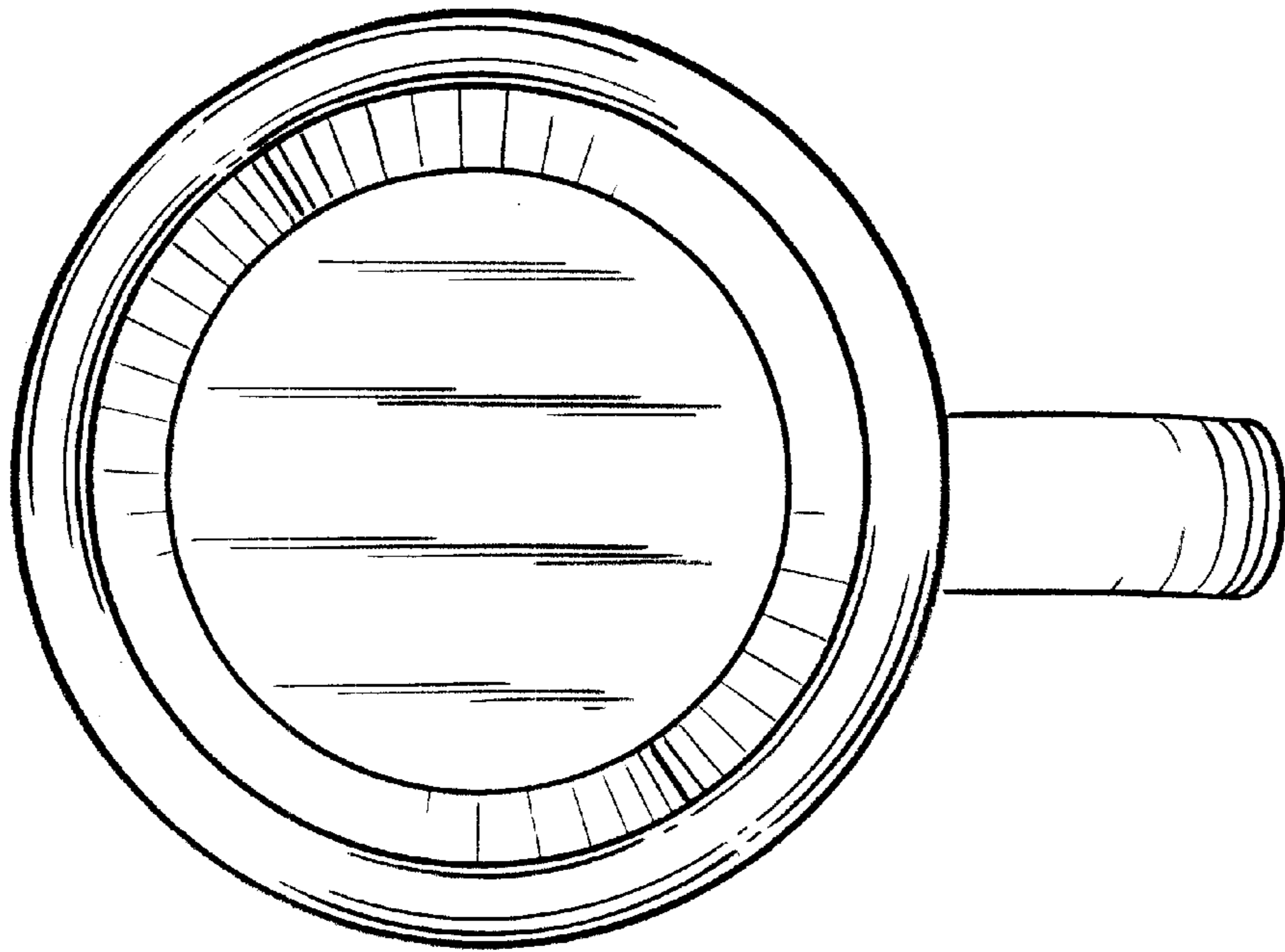

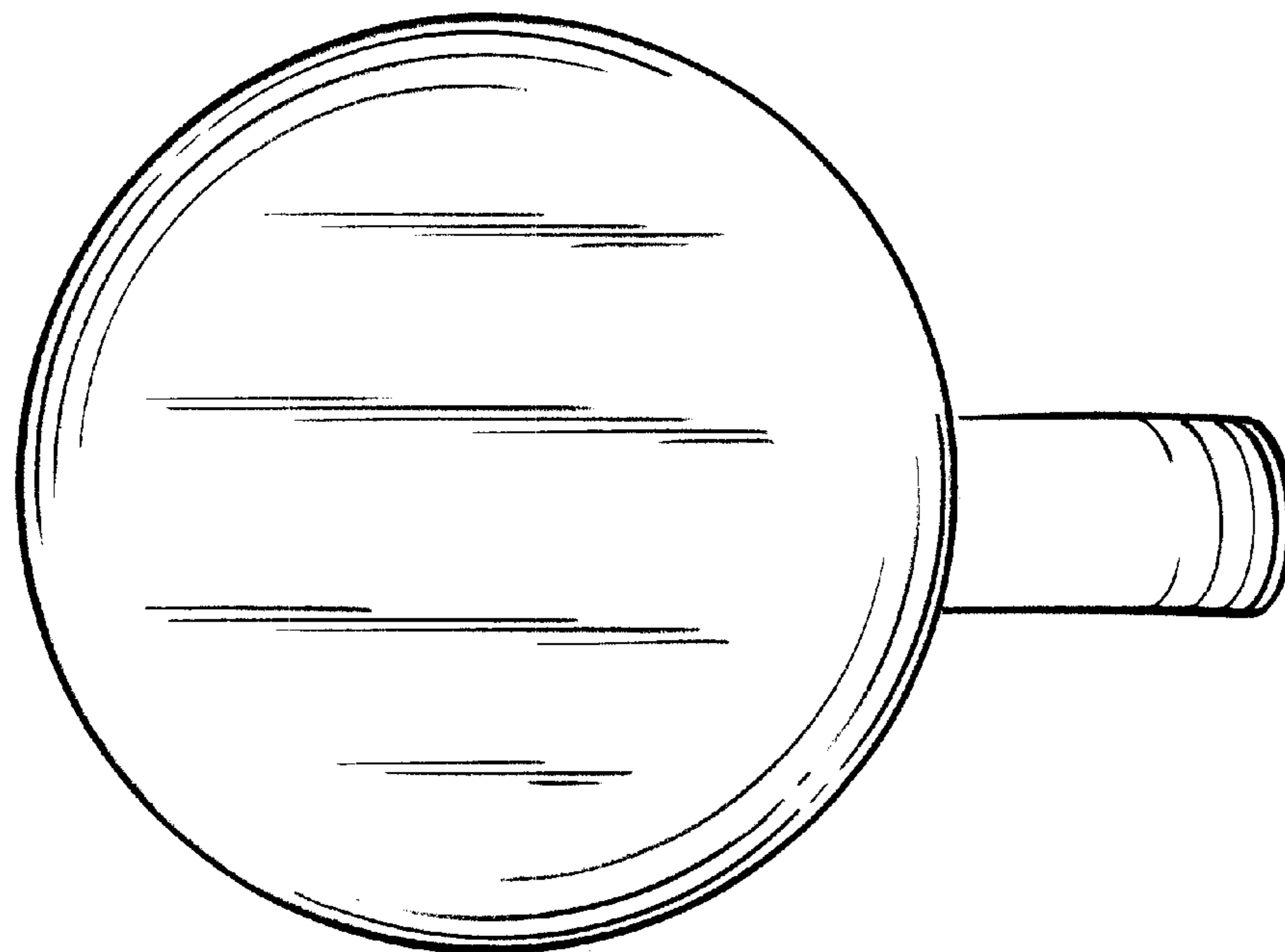
