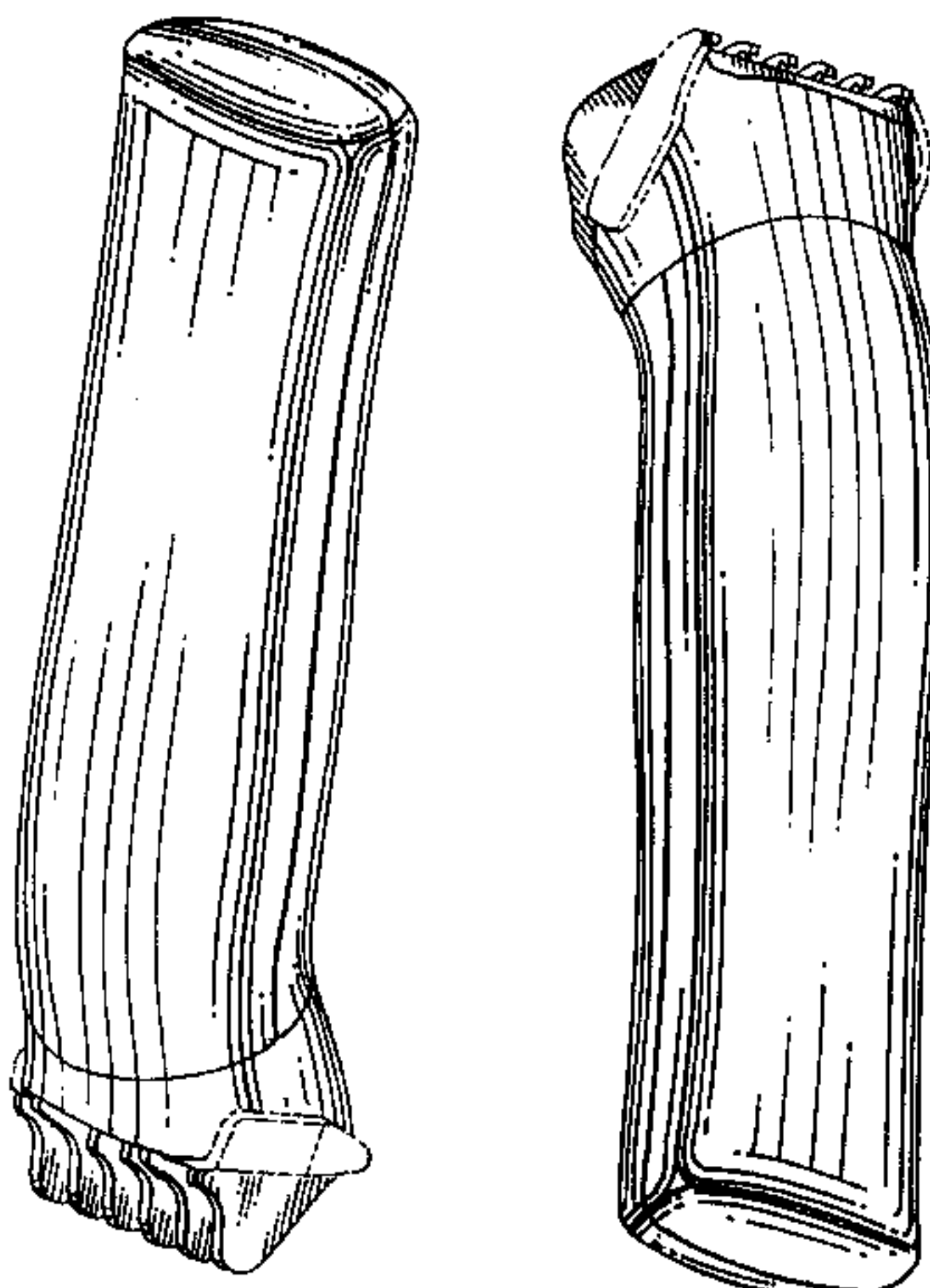

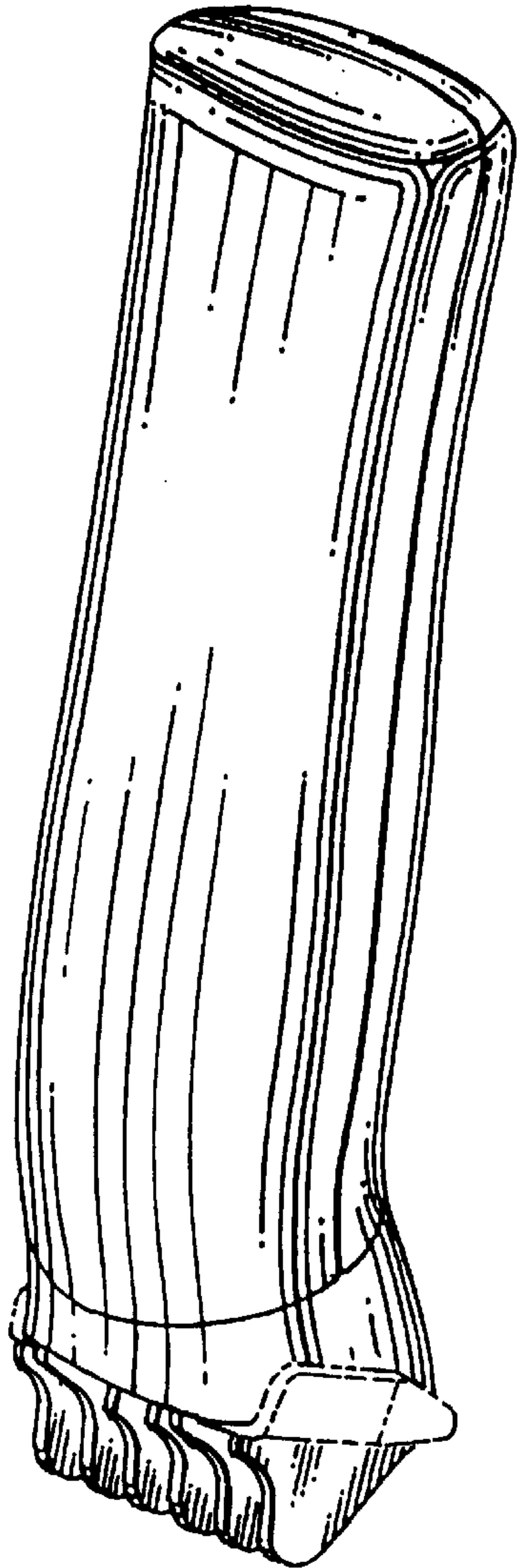

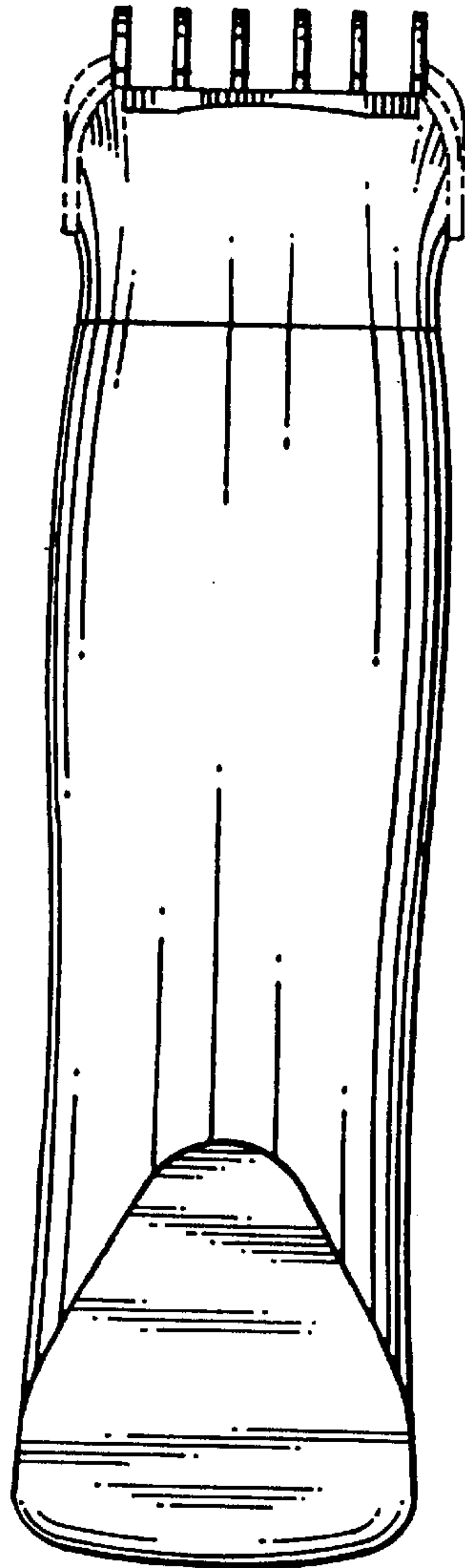

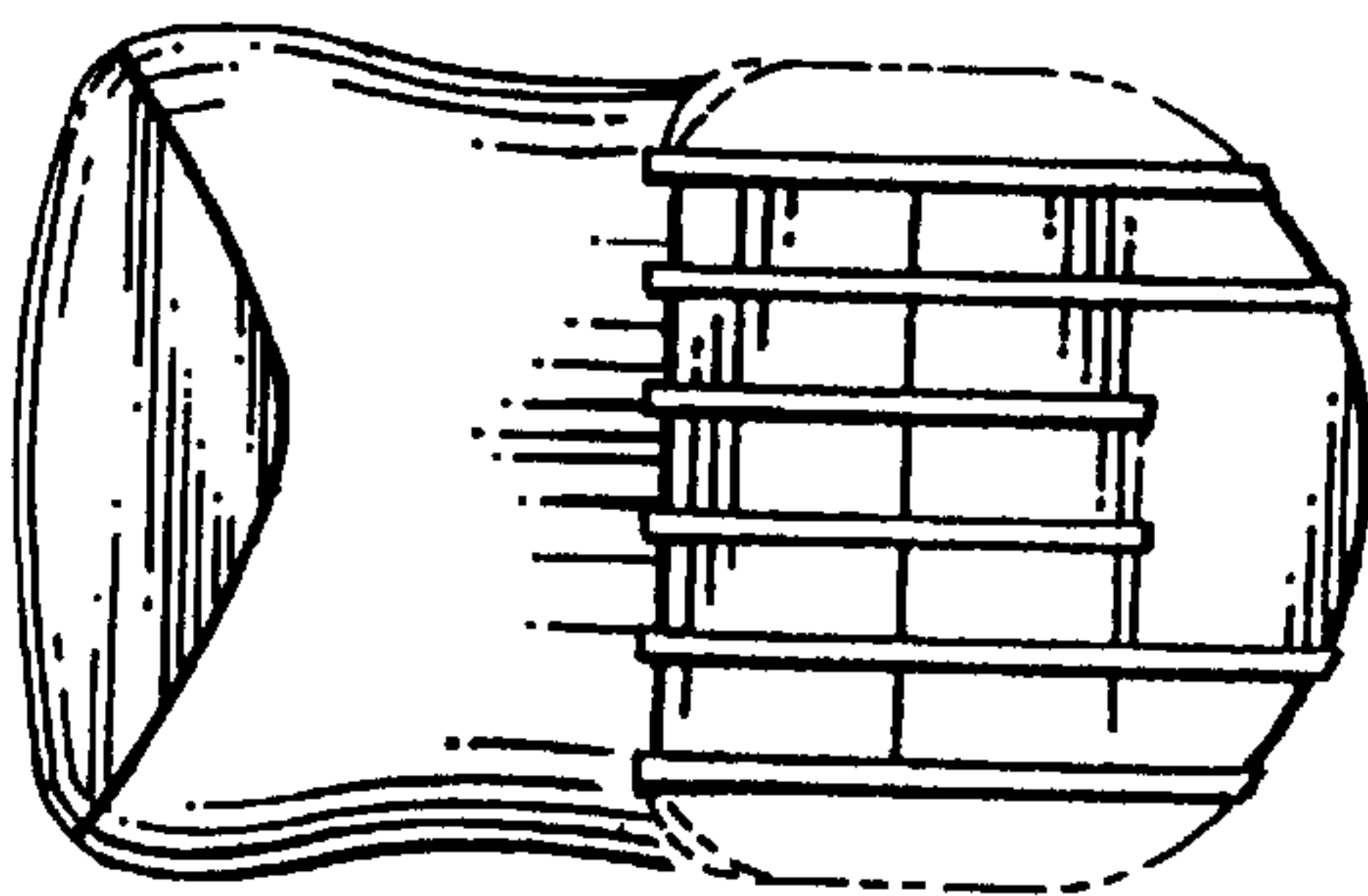

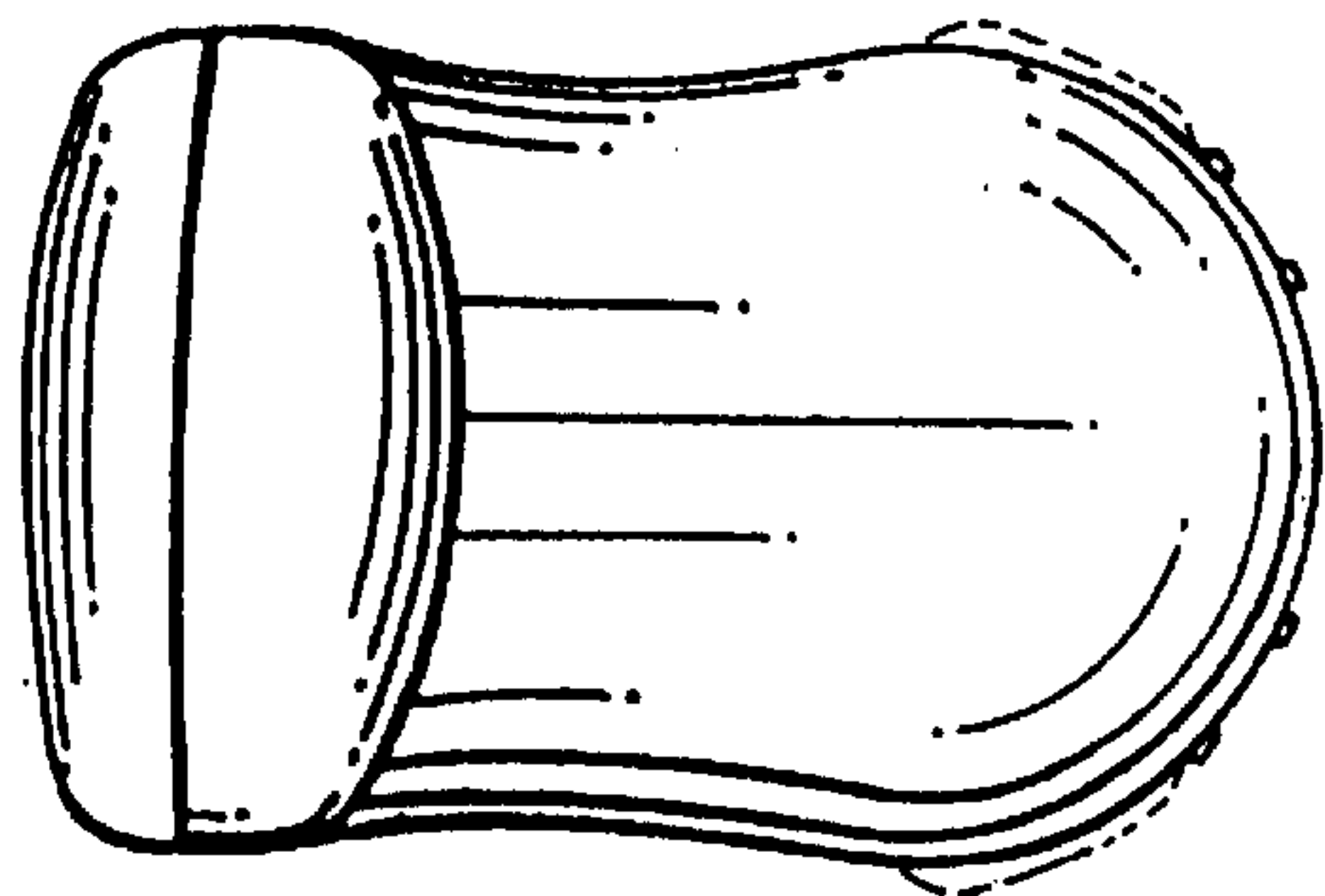

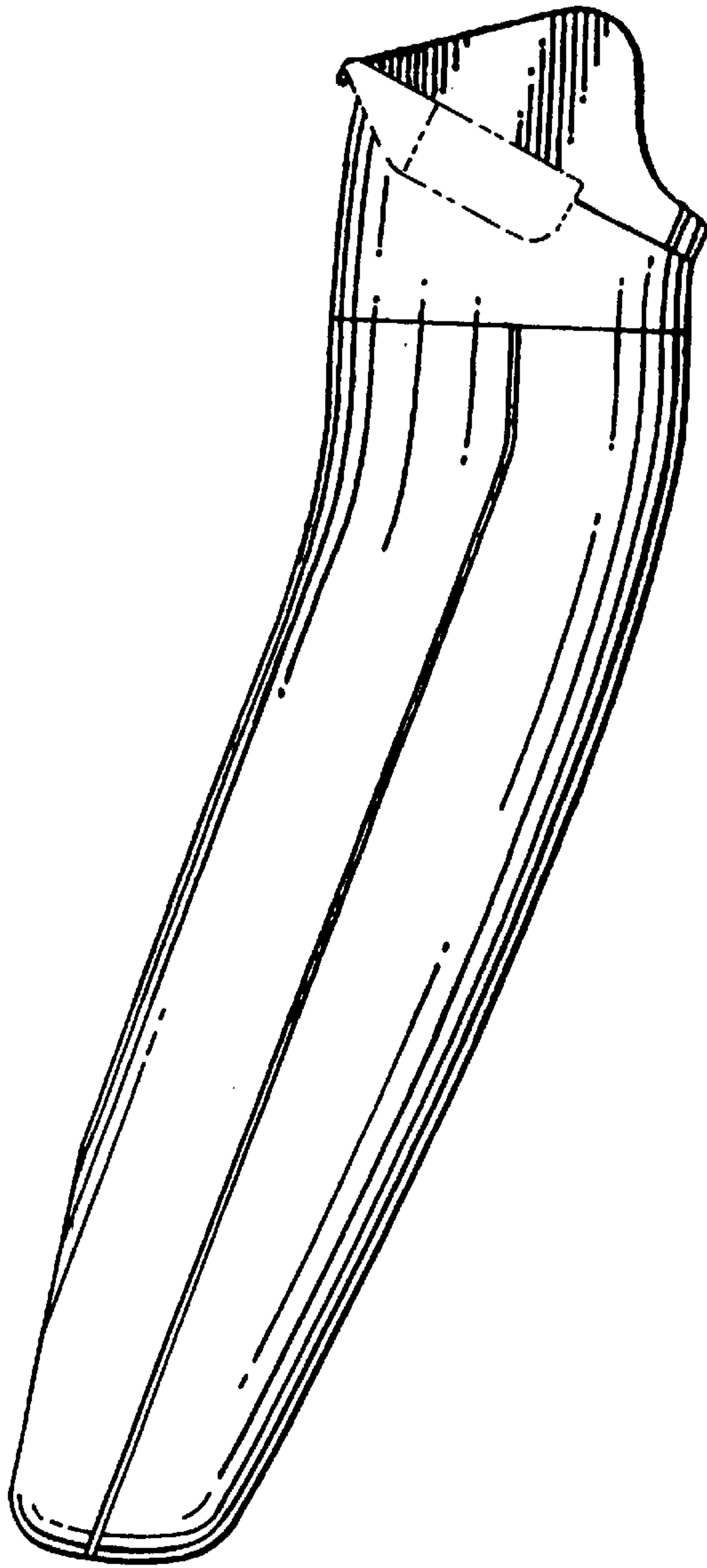

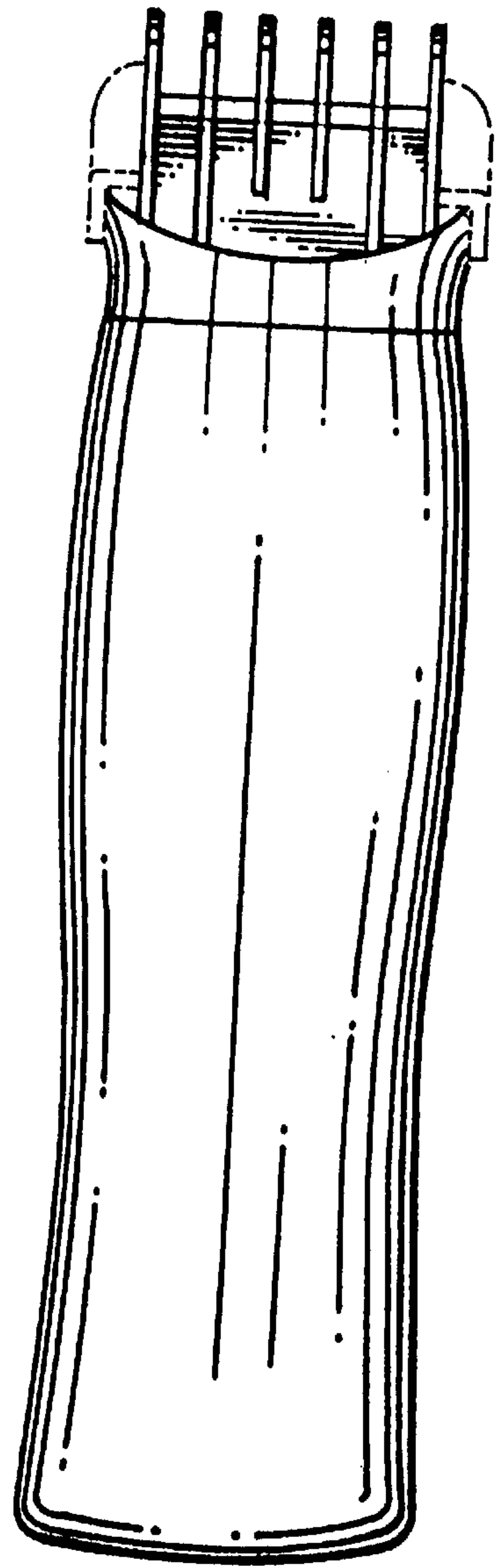

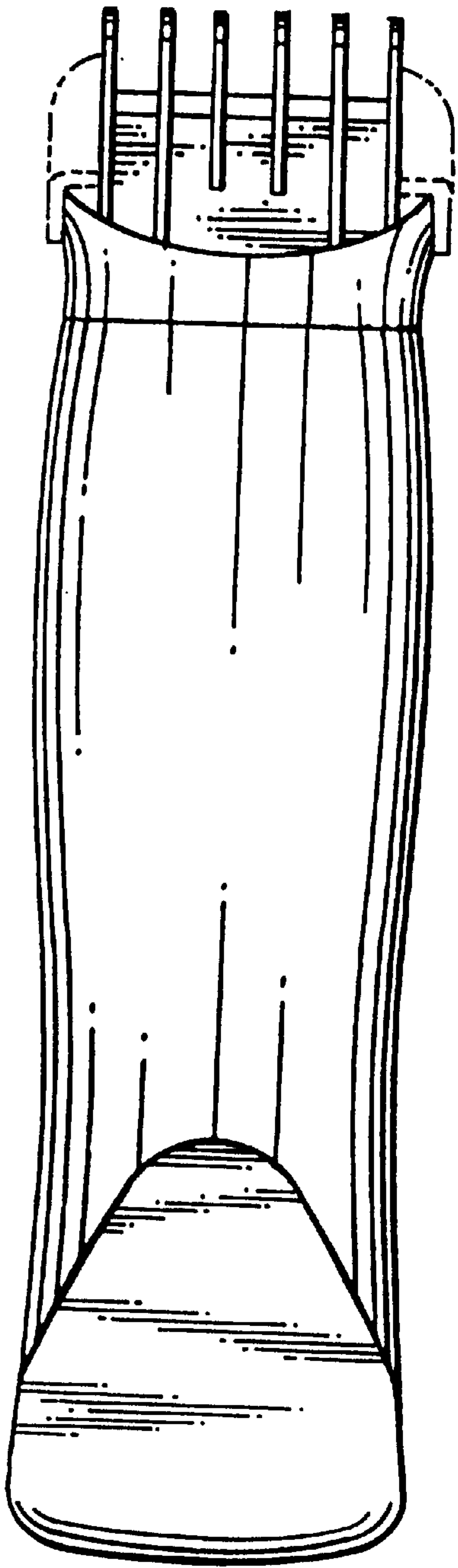

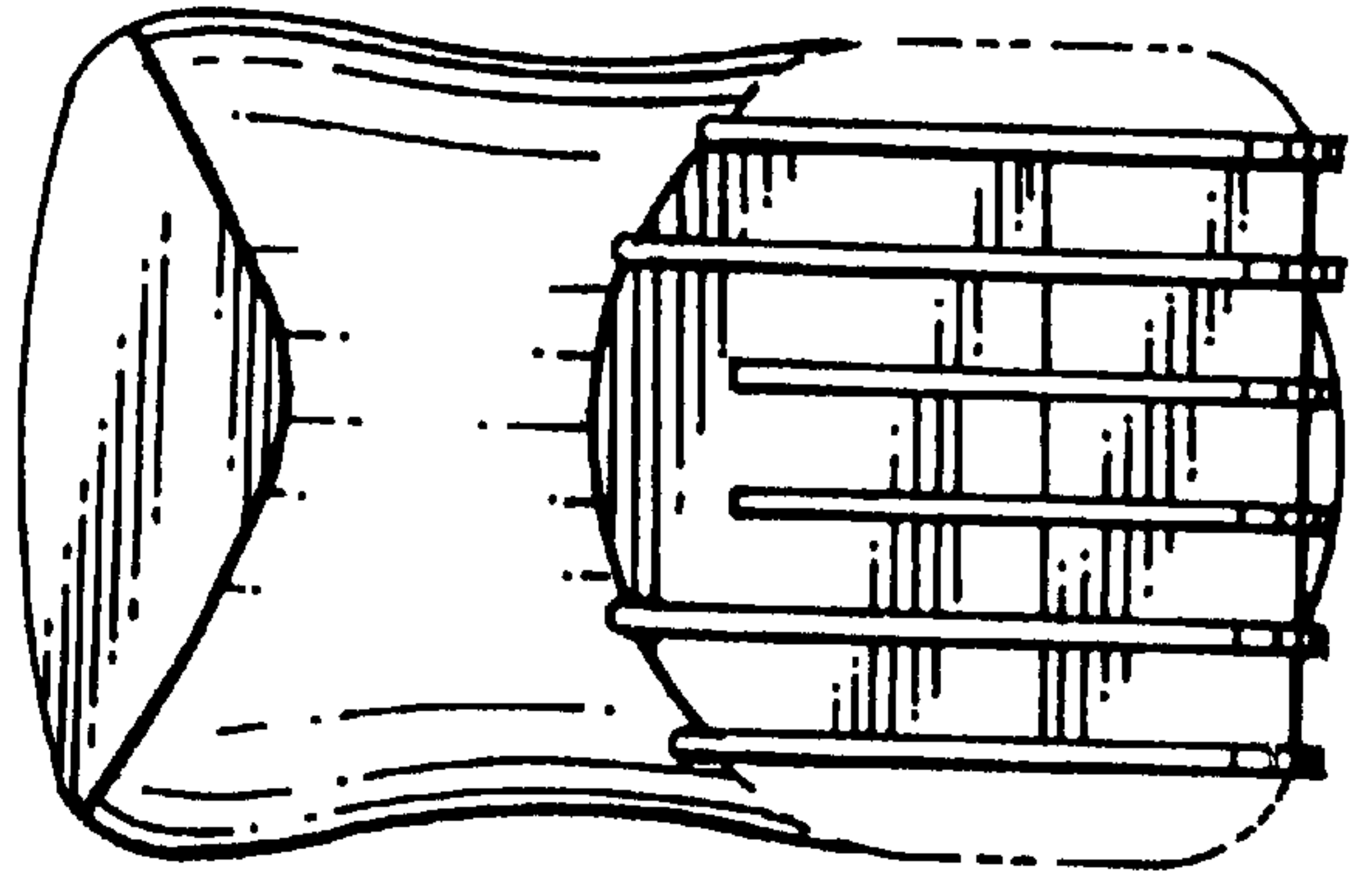

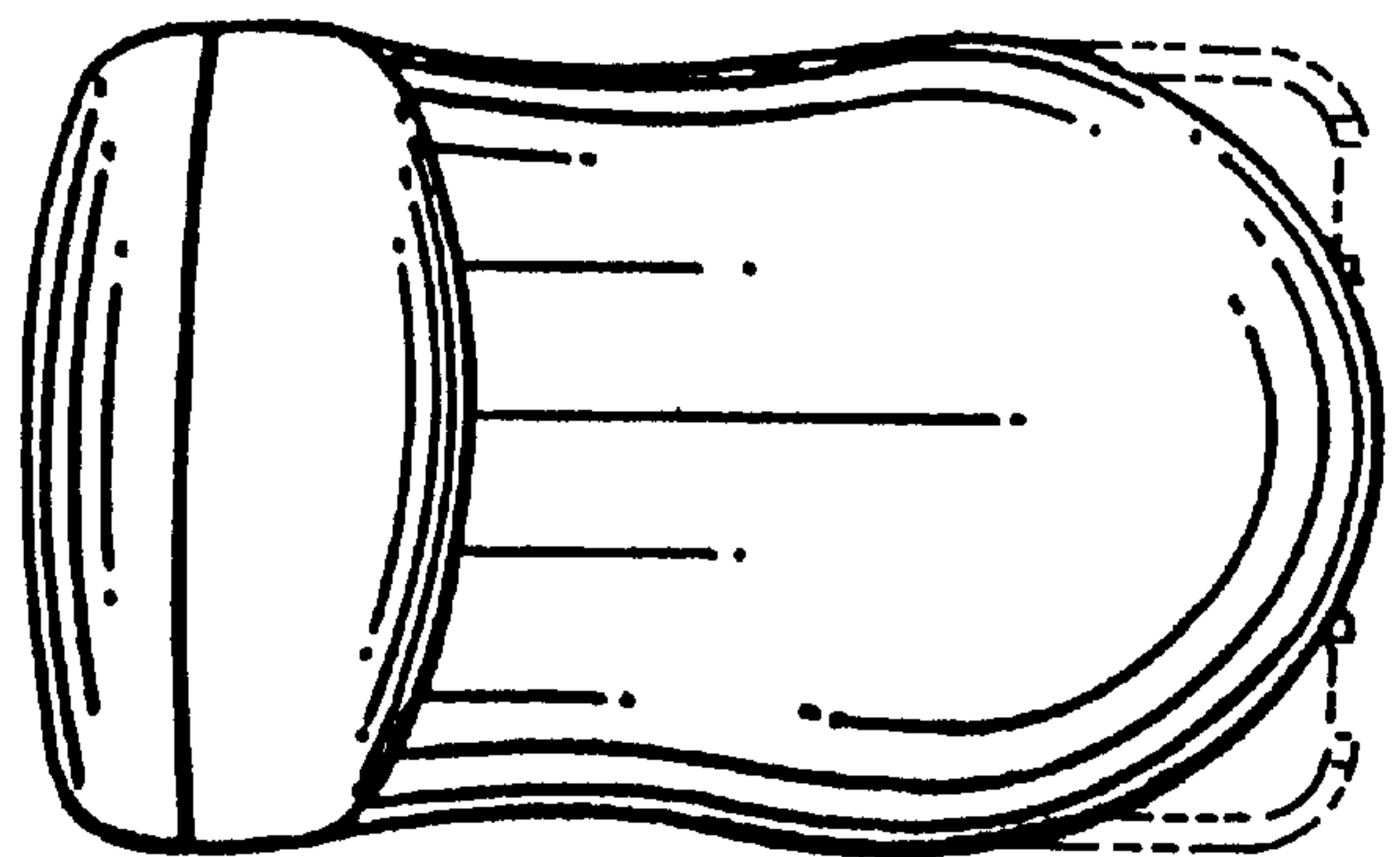

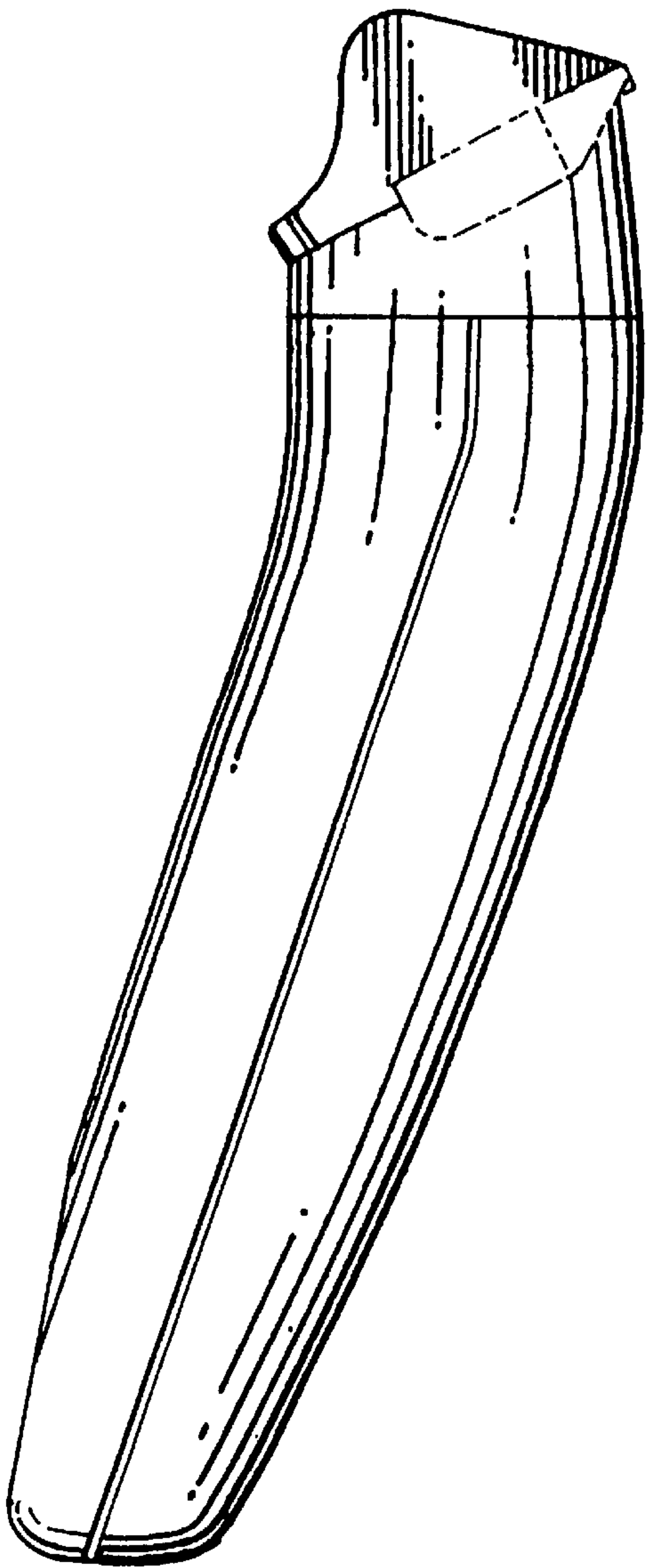

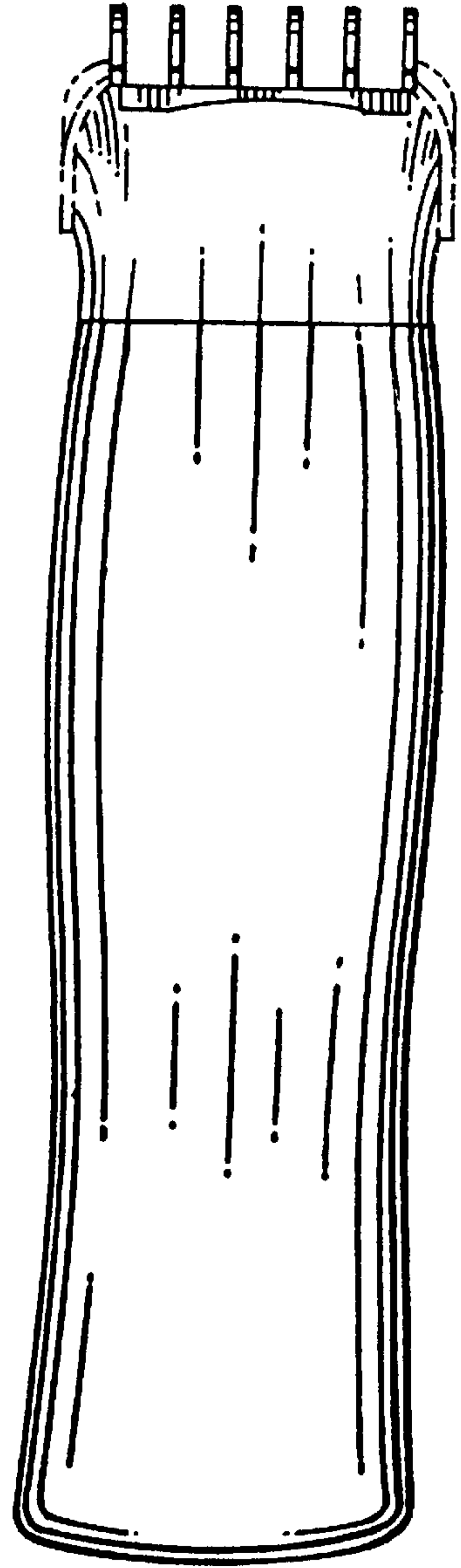

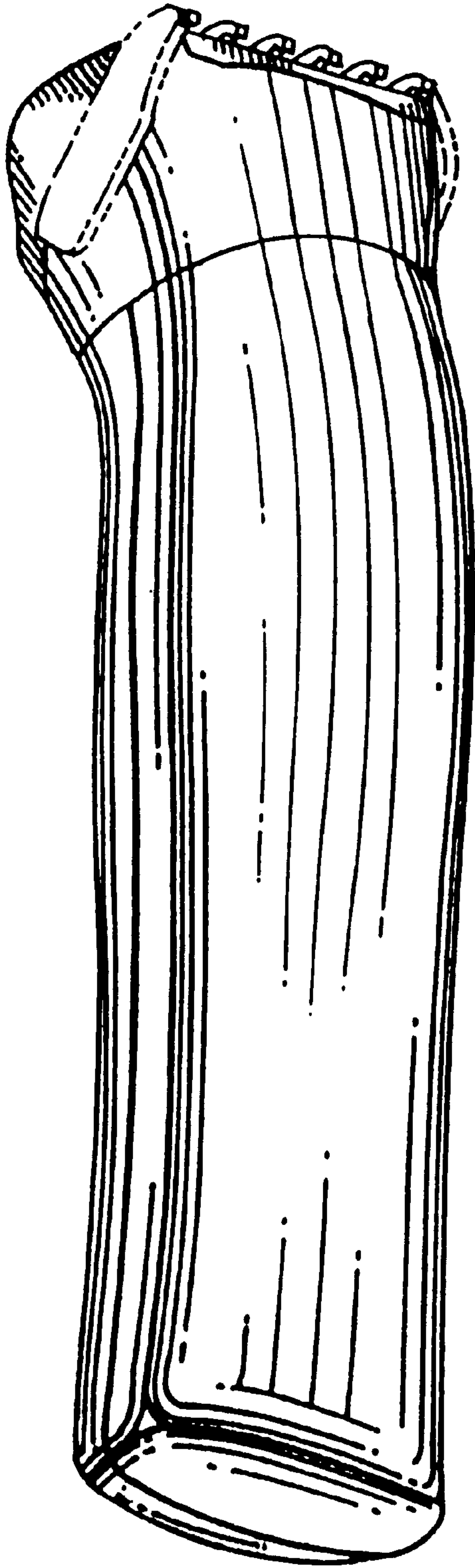

FIG. 11 is a top view of FIG. 7; and,
FIG. 12 is a perspective view of FIG. 7.

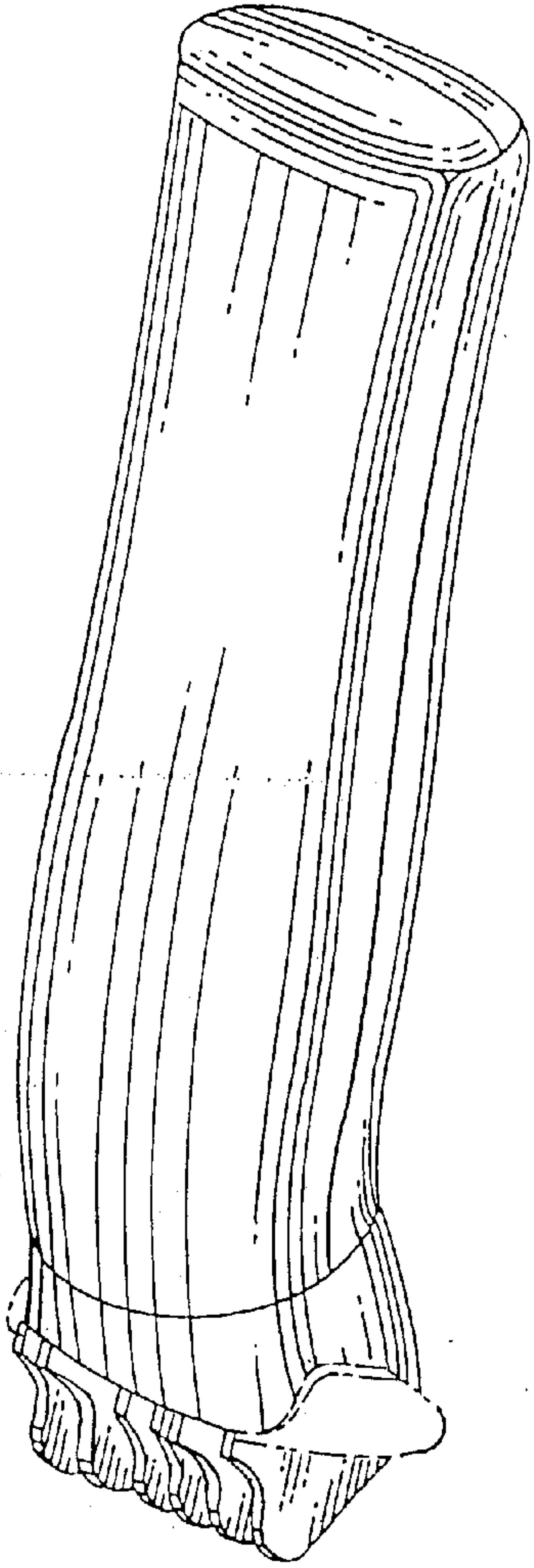

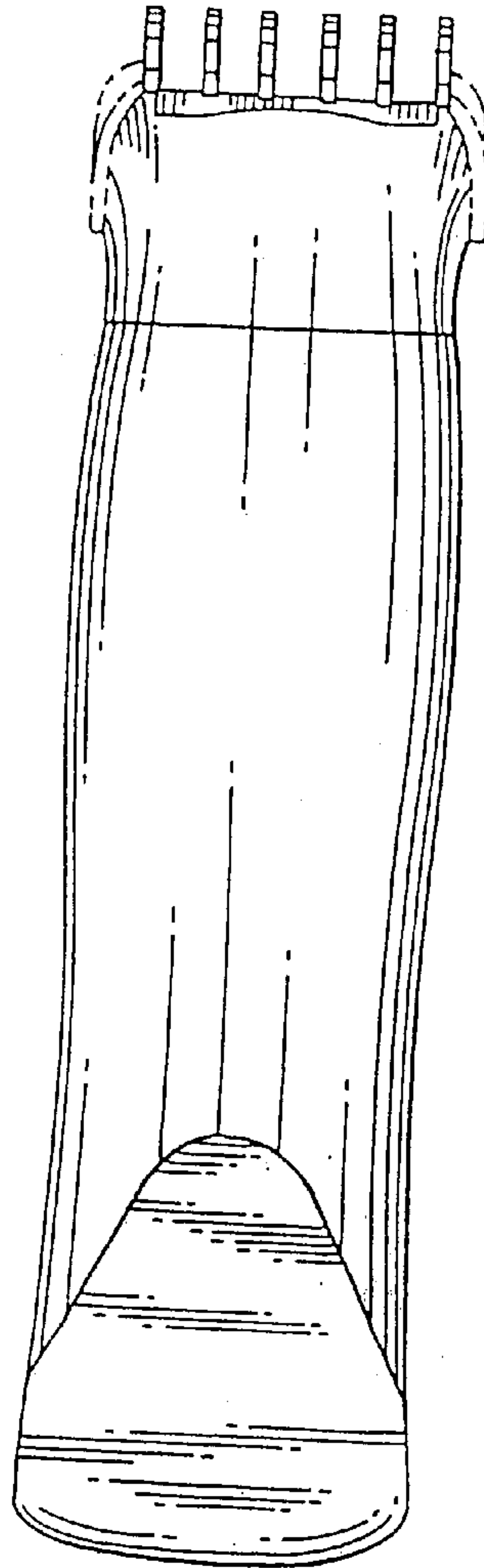

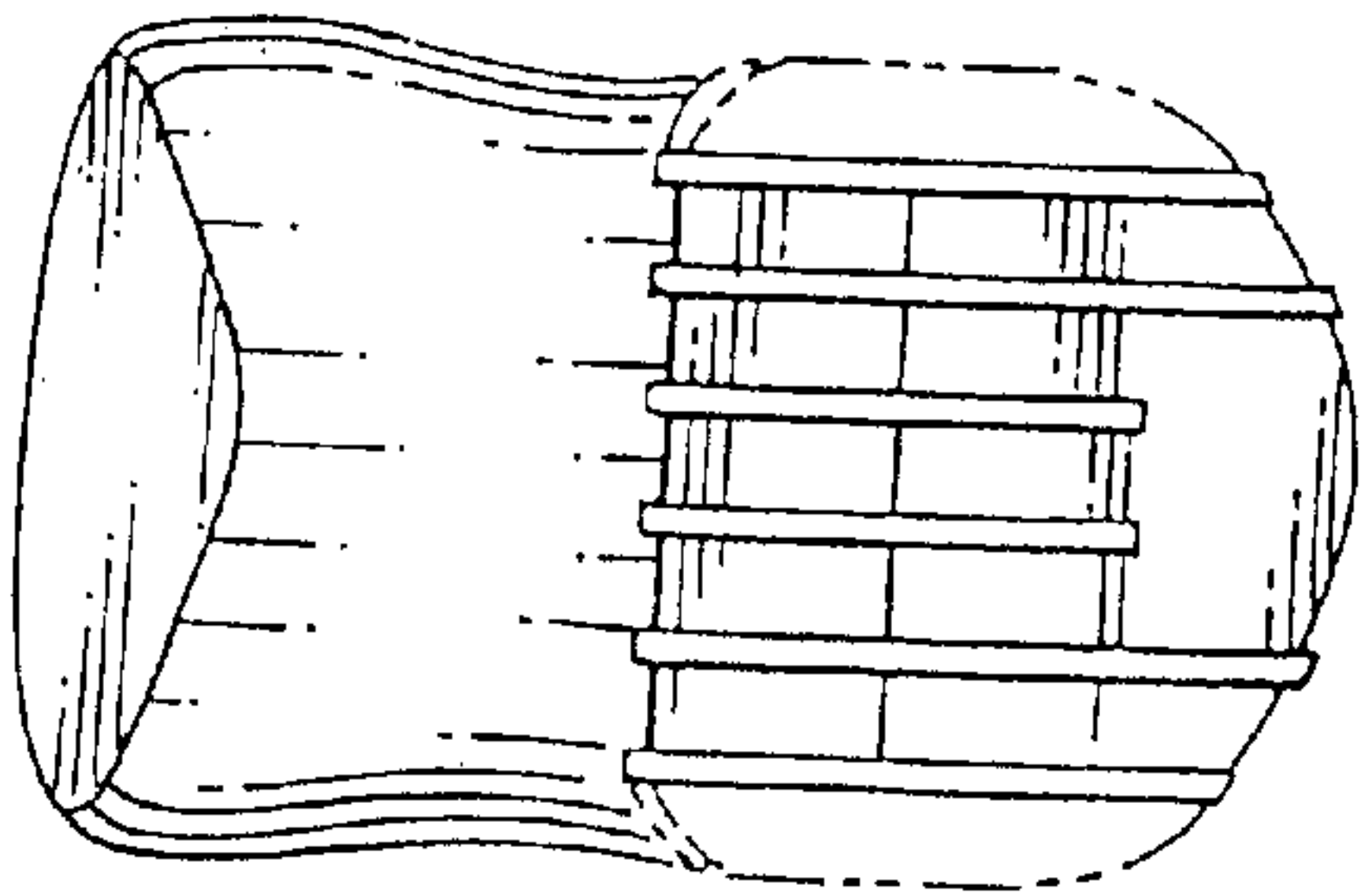

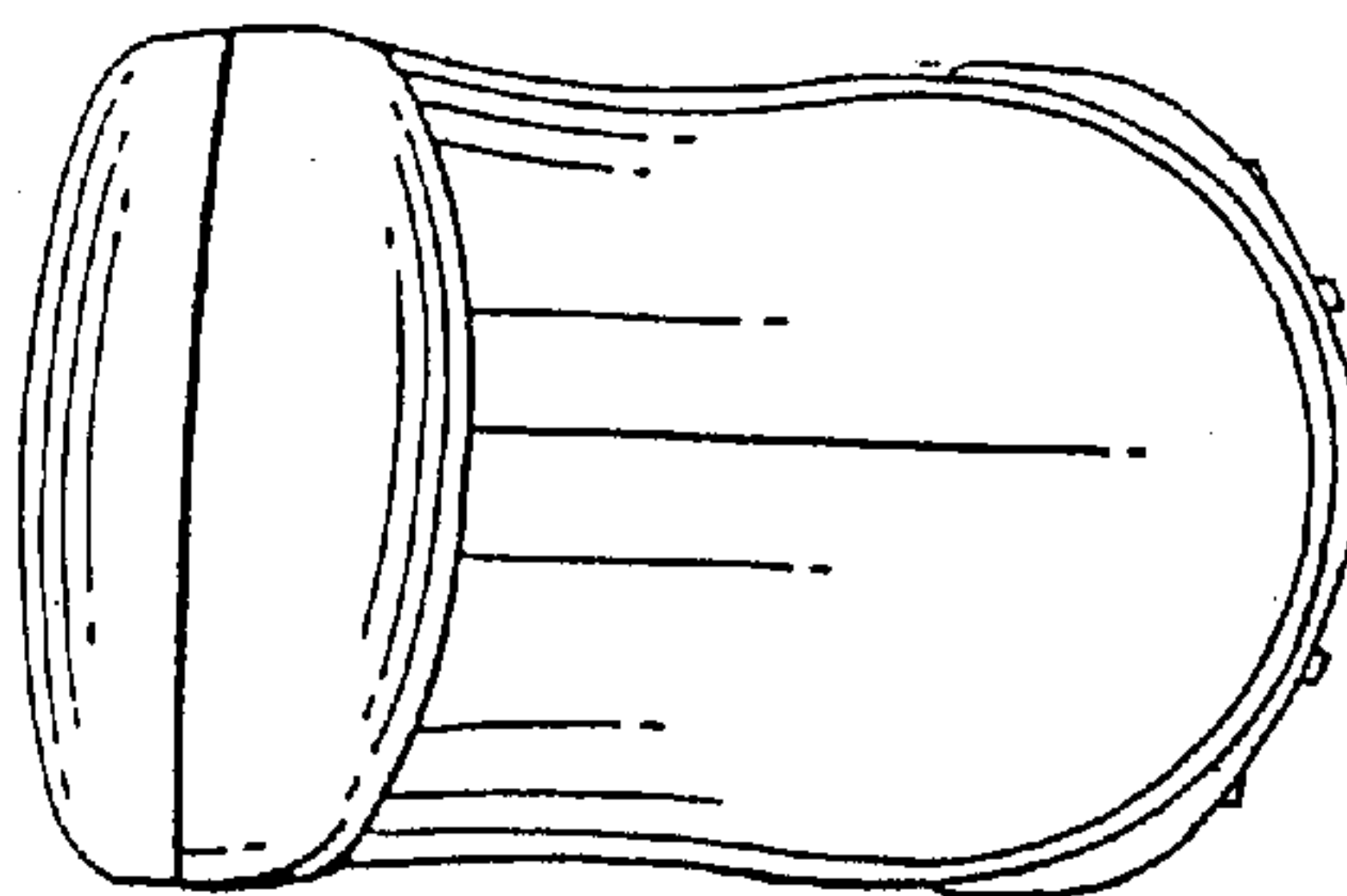

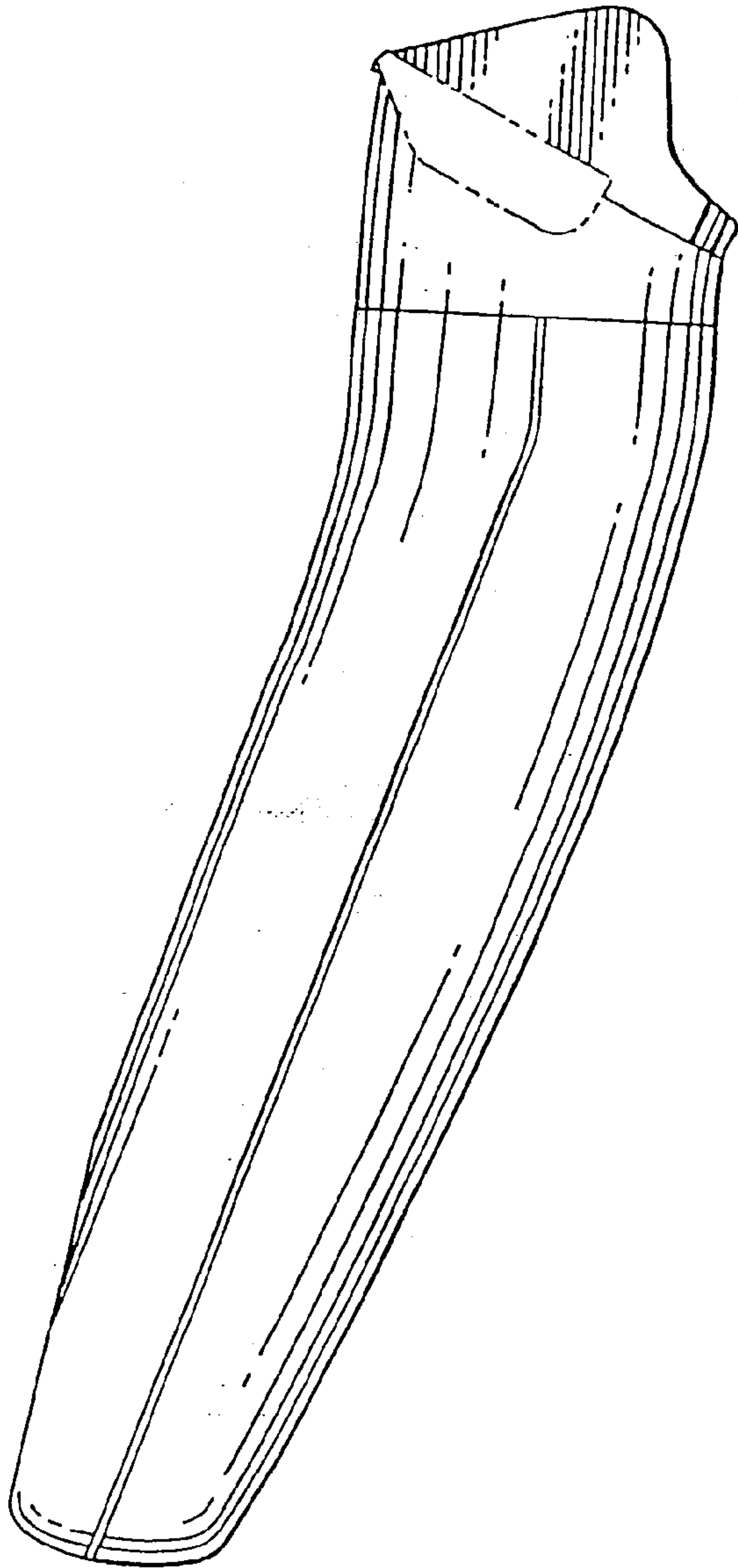

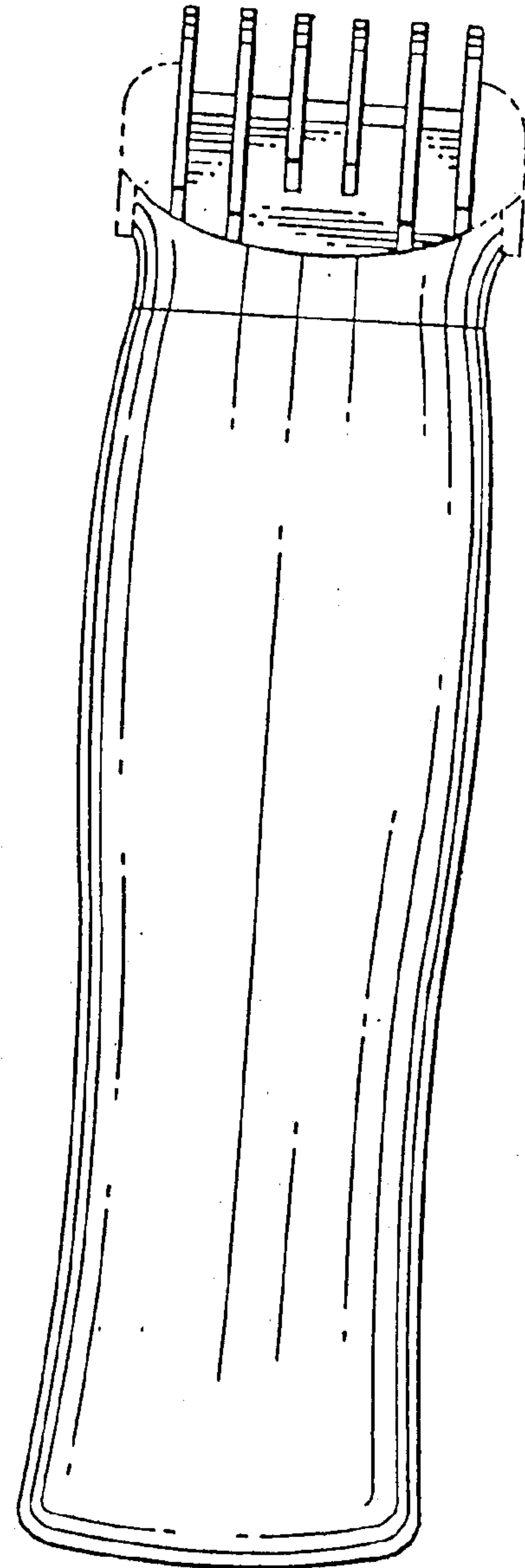

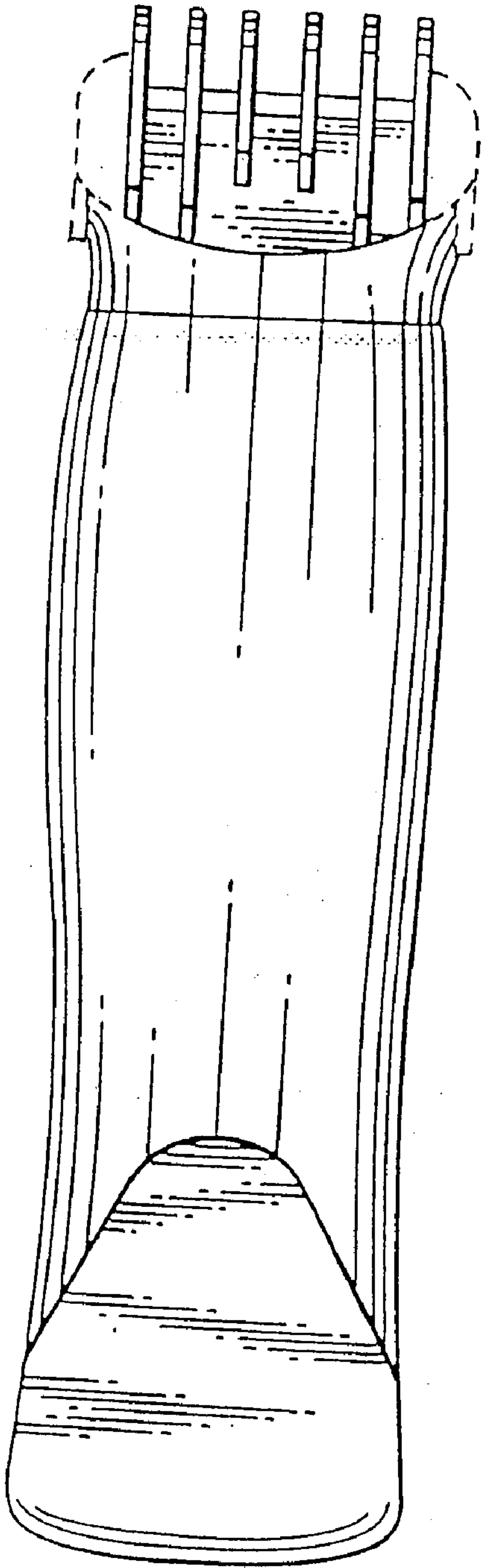

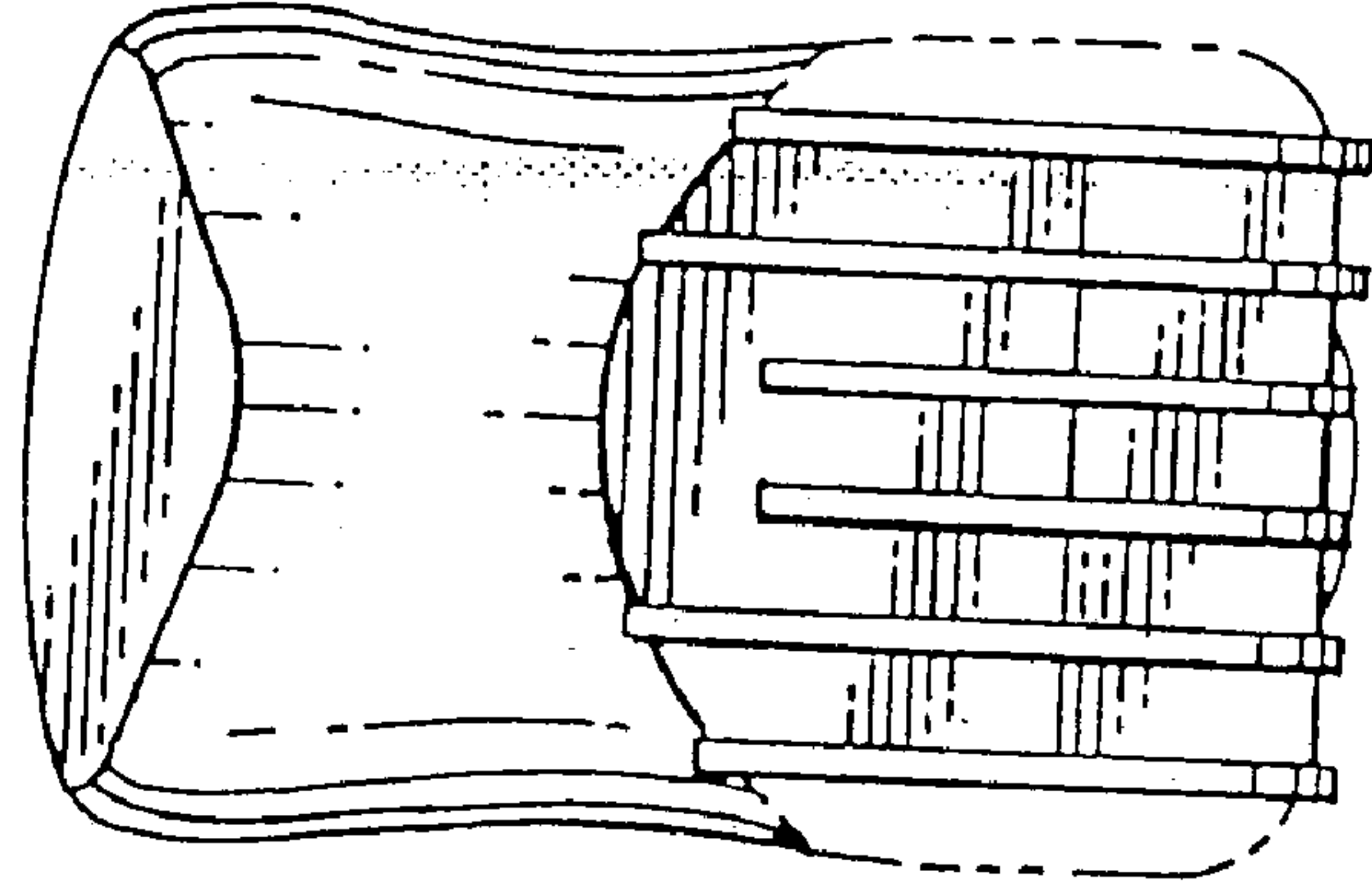

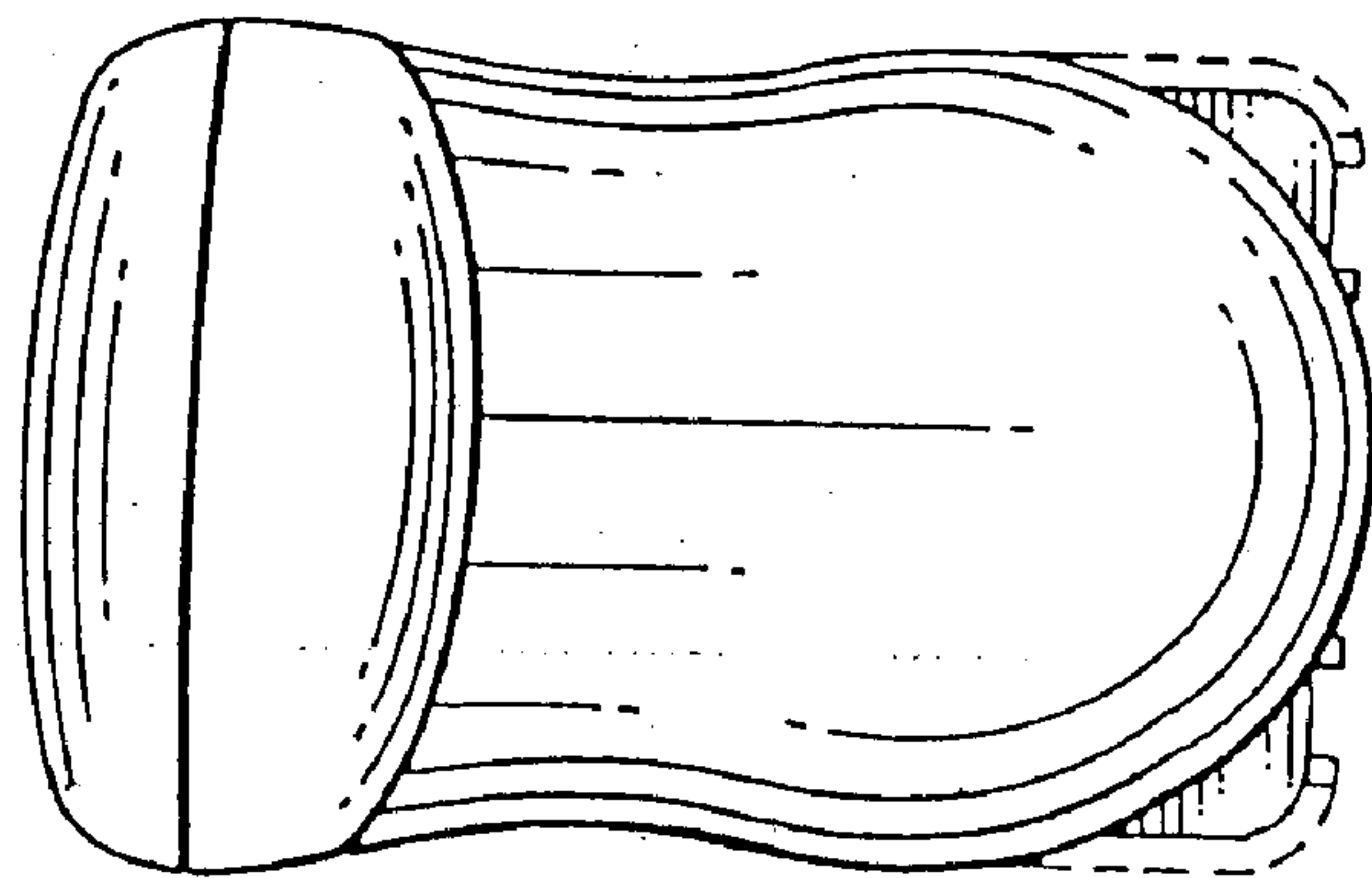

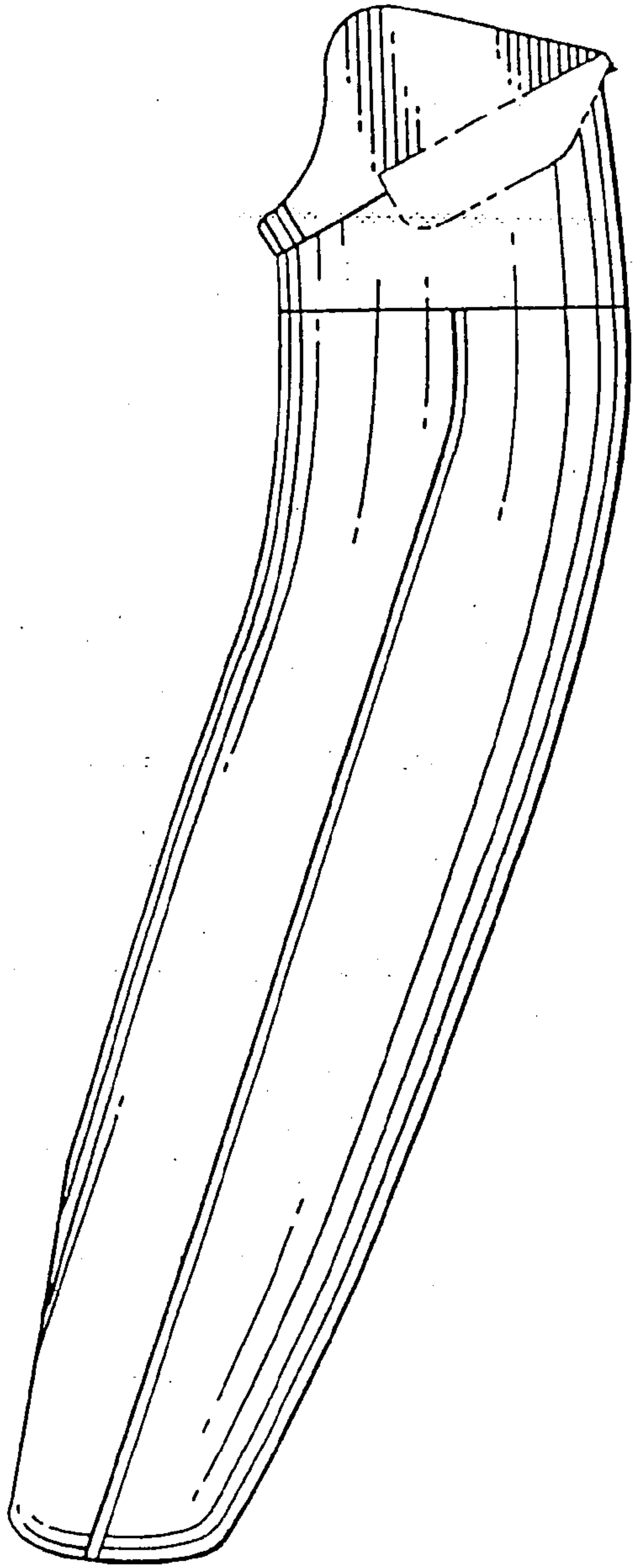

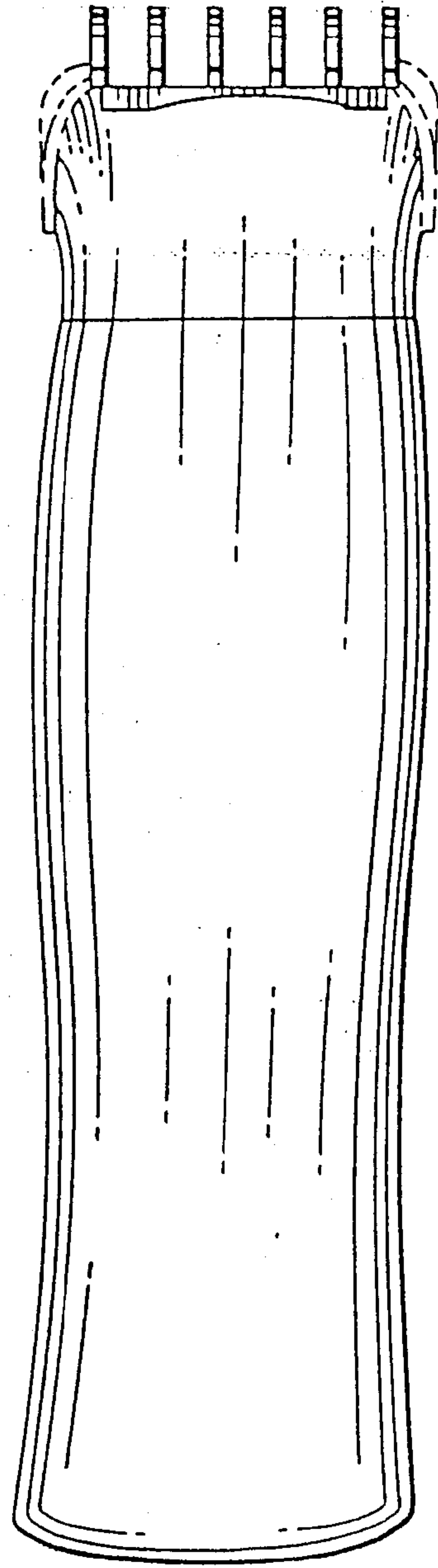
