(57) **CLAIM**

We claim the ornamental design for a medical garment, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a medical garment showing our new design;

FIG. 2 is a right side elevation view thereof;

FIG. 3 is a rear side elevation view thereof;

FIG. 4 is a left side elevation view thereof; and,

FIG. 5 is a front side elevation view thereof, showing various insignia which may be associated with the medical garment.

The broken lines on the surface of the garment throughout the views represent stitching; and the broken lines showing the stars and name tag in FIG. 5 illustrate environmental subject matter which does not form any part of the claimed design;

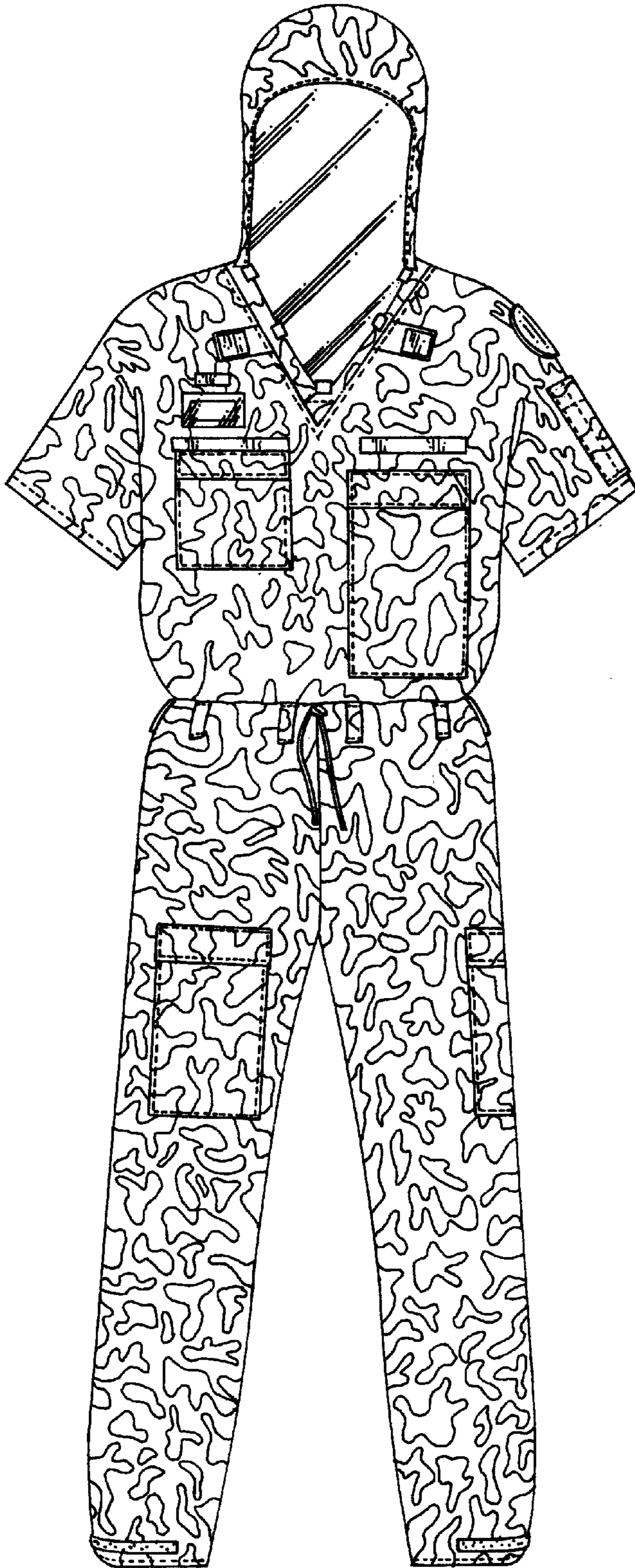

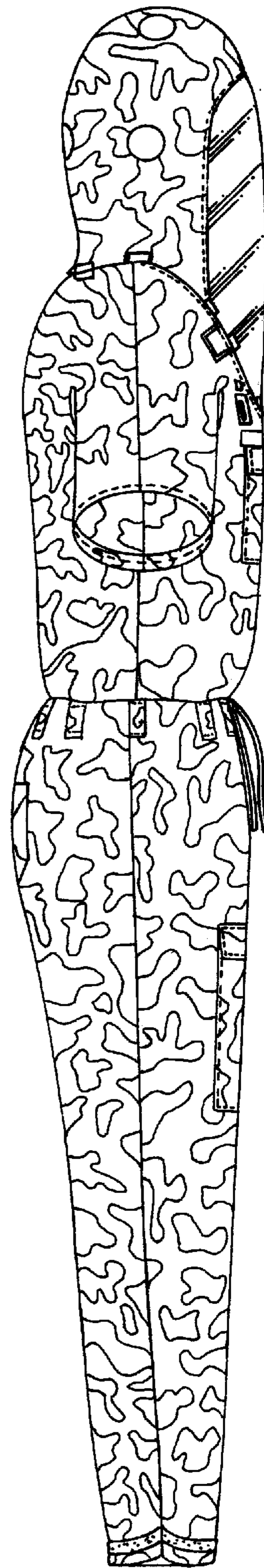
