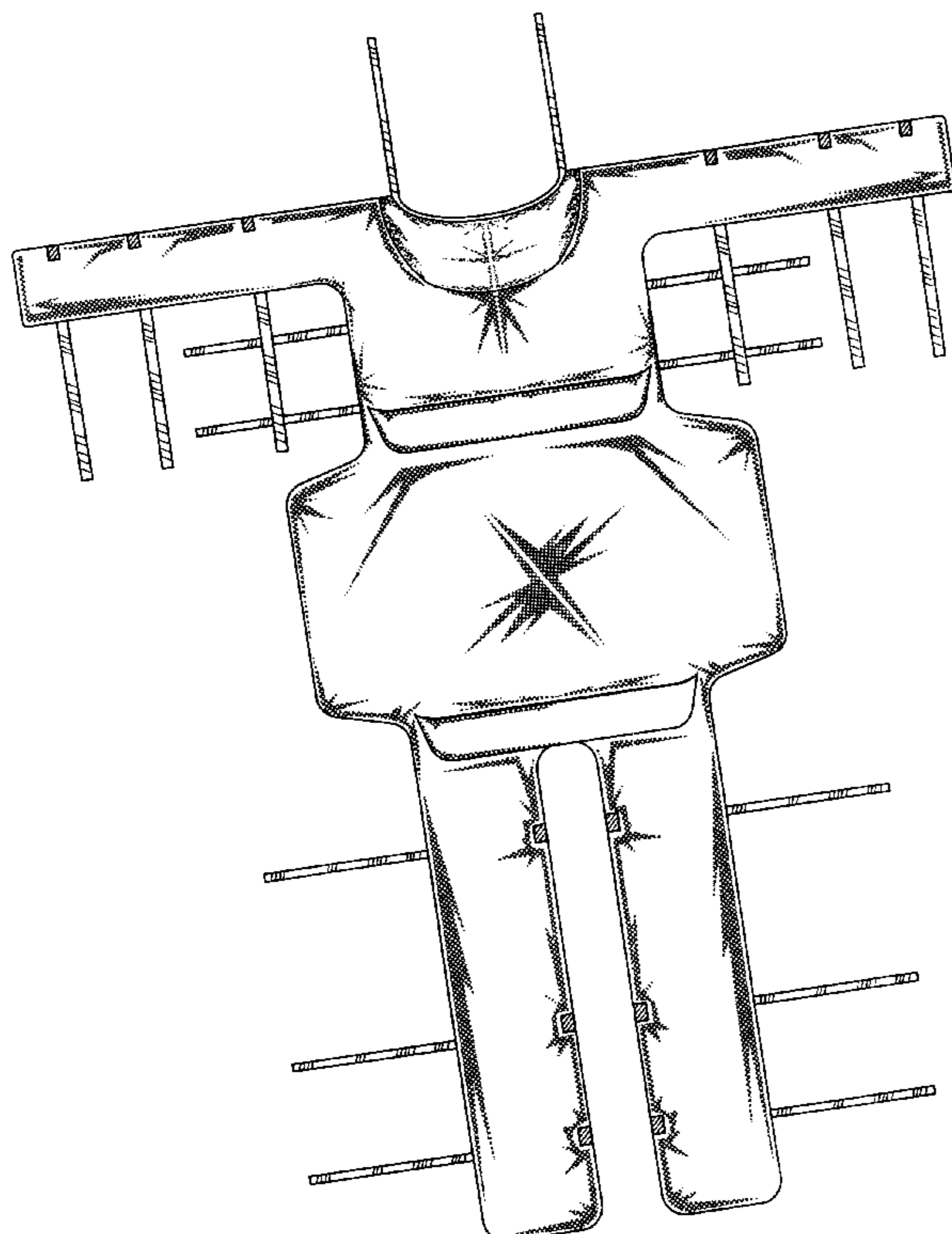
(57) **CLAIM**

The ornamental design for a full body bib, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a full body bib showing my new design, tilted to the left;
 FIG. 2 is a front elevational view shown without a tilt;
 FIG. 3 is a top plan view of FIG. 2;
 FIG. 4 is a bottom plan view of FIG. 2;
 FIG. 5 is a rear elevational view of FIG. 2;
 FIG. 6 is a left side elevational view of FIG. 2, the right side being a mirror image; and,
 FIG. 7 is a perspective view showing the bib in use.
 The broken lines partially showing a human form in FIG. 7 is included to illustrate the use of the invention, and form no part of the claimed design.

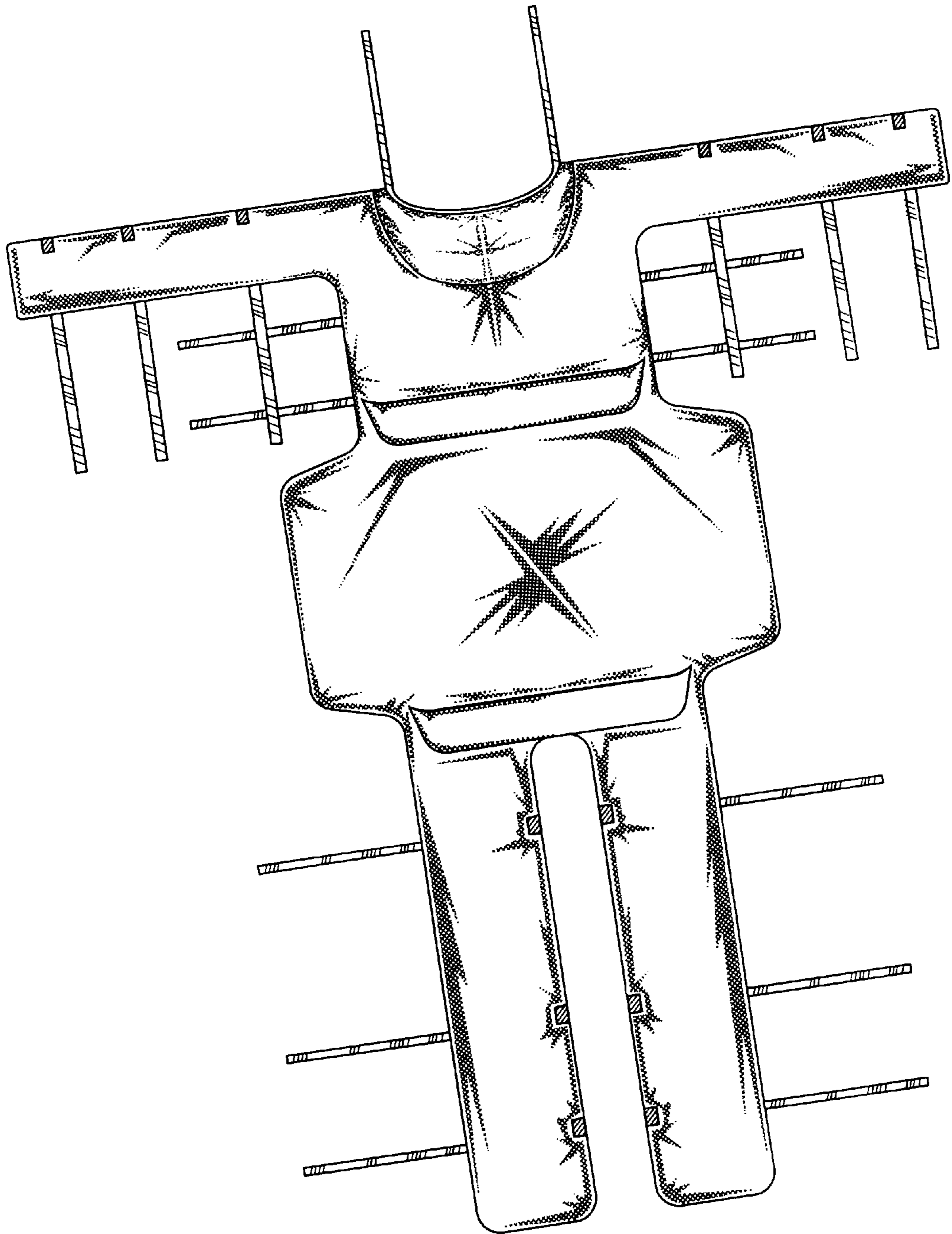

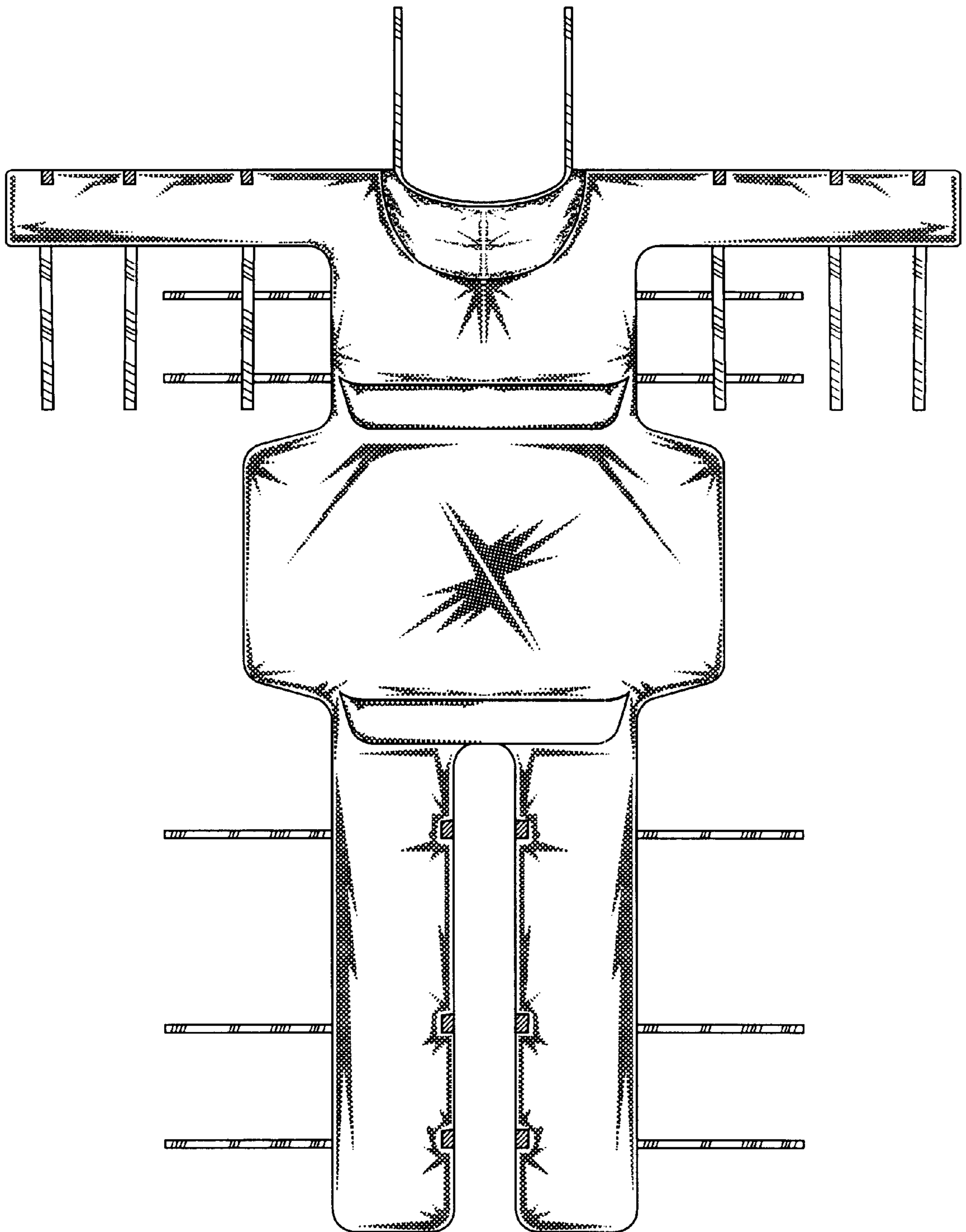

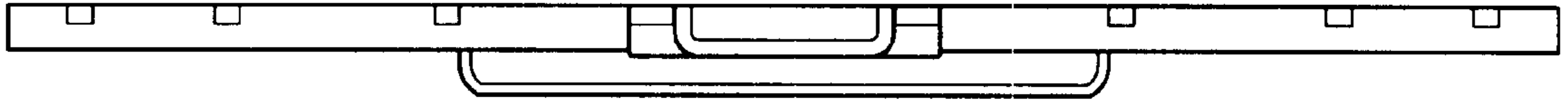

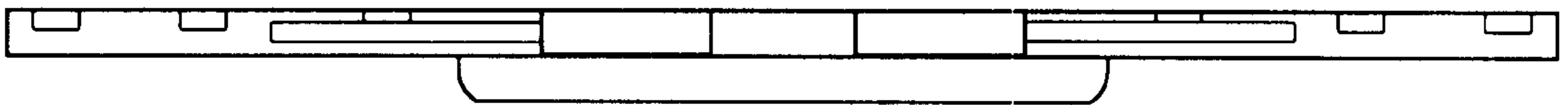

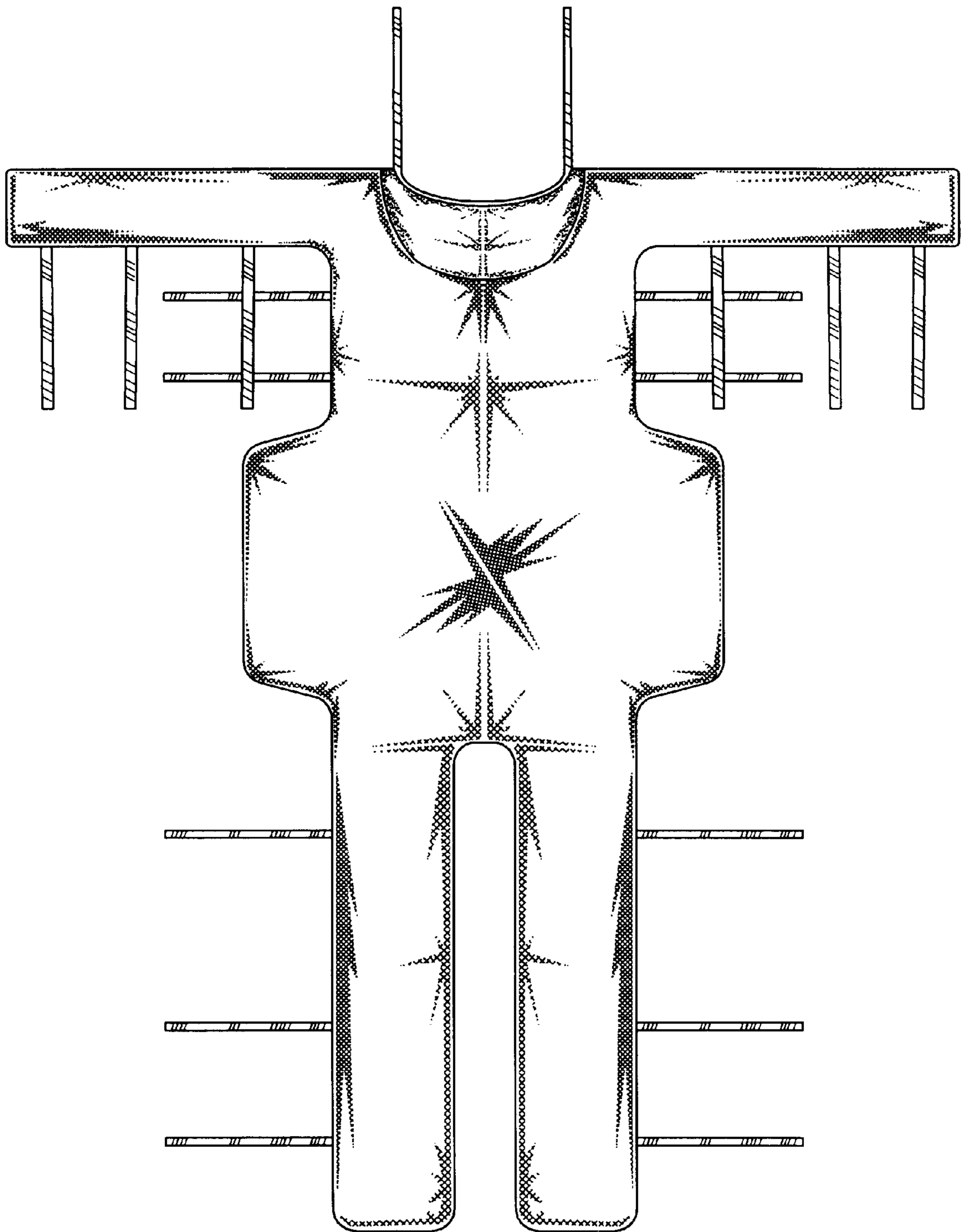

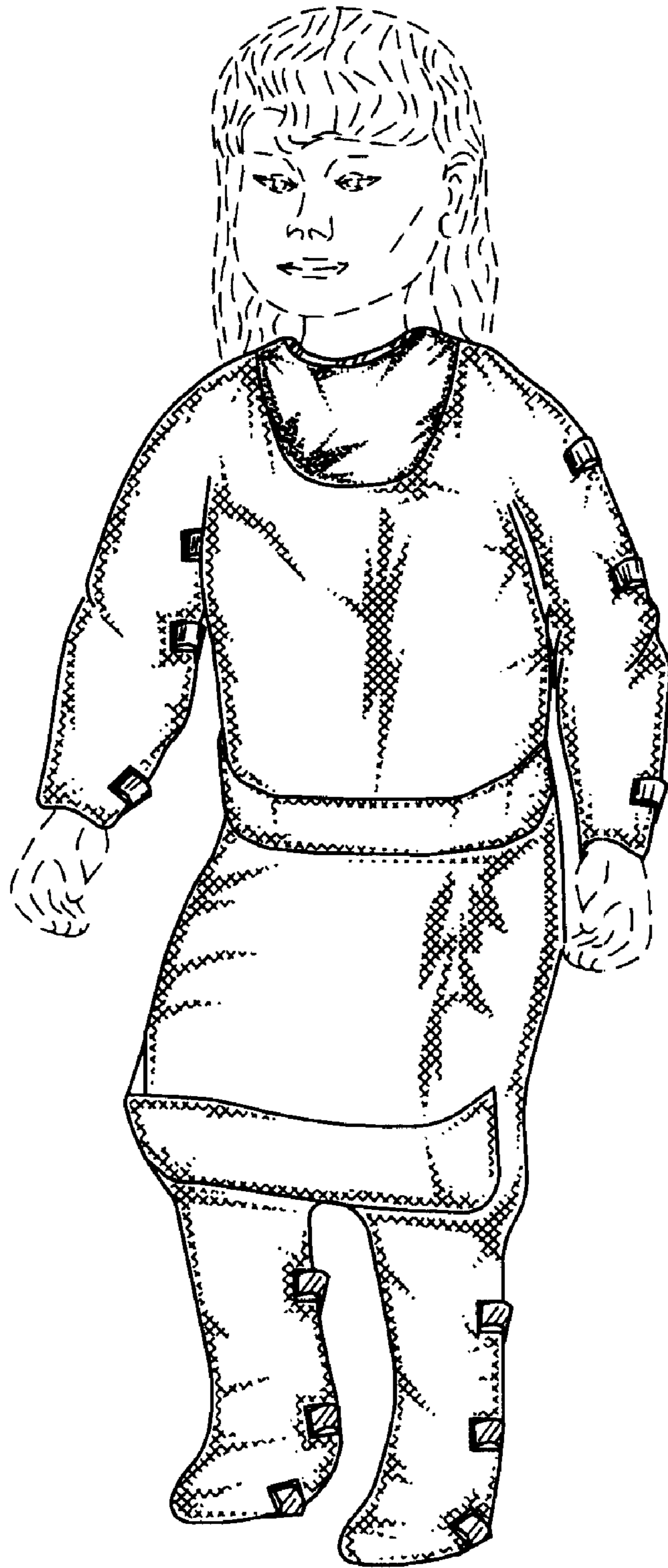
